Speaker Redmond: "State the point."

Washington: "Ah... my point of personal privilege ah... Mr. Speaker, revolves around an article in todays Sun Times, on page 46. It deals with the singing anti E.R.A. group, which was here yesterday. Let me quote, it won't take long. "Last time the E.R.A. opponents came to the Capital, they brought home big loads of bread as Valentine Day reminders of the Legislature. This time they brought a song, the song goes we do not want the E.R.A., it's not the Christian way, our home is run by Dad, we know the E.R.A. is bad. I'll continue with the article, they sang this to the tune of "Down By The River Side", outside of Committee hearings, in which Legislative Staff Members were preparing for several Committee hearings. Speaker Redmond: "Representative Geo-Karis."

Geo-Karis: "Mr. Speaker, and Ladies and Gentlemen of the House. House Resolution Number 86, referes to the tragic... passing of the Honorable Earl Madigan of Lincoln, member of the Logan County Board, and father of Congressman Edward Madigan, of Illinois, from Logan County. Earl Madigan was one of the 18 members of the newly created by satute, Illinois Energy Resources Commission, of which yours truly is the Chairman. On the 30th of January, 1975, when we adjourned the meeting at 5:15, Mr. Madigan was on his home and at 5:40 he slumped in his car, hit a building and was killed. Mr. Madigan has served as a Lincoln City Alderman, as a Chief Deputy in the Logan County Circuit Clerk, since 1940 to 1956, became Circuit Clerk in 1956 and served in that post of 14 years. He was a Charter Member and First Chairman of Executive Committee of the Logan County Young Republicans and also served as Chairman of Logan County Central Committees Executive Committee. In 1970 Mr. Madigan resigned from his County Post to become Technical Advisor and Deputy Clerk in the office of Court of Claims, in Springfield and he left that office in 71 to wage a successful campaign for a seat in the Logan County Board, a position which he held until his



Death. He was a gentleman, always interested in serving the the affairs of his Community, and to this end, he was a Member of Citizens School Committee, the St. Clara's Hospital Fund Drive, Logan County Farm Bureau, Greater Lincoln Area Chamber of Commerce, American Judicature Society, the American Political Science Association, and he was an Eagle, a Moose, a Knight of Columbus and a member of the Ancient Order of Hibernian, he is survived by his beloved wife, Theresa Loobey Madigan; by his two sons, Congressman Edward and Mr. Robert Madigan; his daughter, Sandra Madigan Naiman of Elmhurst, Ah... as Chairman of the Illinois Energy Resource Commission, I would like to say that the loss of Earl Madigan in our Commission is a bad loss, because he was a great person and a dedicated man to his job. At this time Mr. Speaker, I would like to asked that everyone in this House who so choses... be added on to this Resolution in memory of the late Earl Madigan, a Member of the Illinois Energy Resources Commission. And to this Resolution, Representatives Deavers, Lauer and Bradley, join me in this commemorative Resolution on the memory of Earl Madigan."

- Speaker Redmond: "Did the Gentleman from Cook, Representative Lechowicz, desire to be recognized."
- Lechowicz: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House.

  With leave of the House I would like to have the Clerk read, House
  Resolution 97, in memory of ah... John Kluczynski."
- Speaker Redmond: "Leave granted, hearing no objections... leave is granted. Would the Clerk read the Resolution."
- O'Brien: "House Resolution 97: Whereas, this House is deeply saddened to learn of the recent passing of the Honorable John C.

  Kluczynski, Representative in Congress from the 5th District of Illinois; and Whereas, Congressman Kluczynski served his District the People of Illinois, and the citizens of the United States for 12 terms in Congress, and had recently begun his 13th; he served as a member of the Public Works Committee and was Chairman of the newly-created Transportation Subcommittee; and Whereas, As Chairman of the Roads Subcommittee, Congressman Kluczynski was instrumental in the development of the Interstate Highway System in the United



States, and became known as the "Grandfather of the Interstate Highway System", which system has been held responsible for the saving of one life for each mile of highway in each year; and Whereas, He was born and raised in the 5th Congressional District which he served so well, and he has lived there all of his life; he was first elected to the Illinois House of Representatives in 1932 and served there until 1948, when he was elected to the Illinois Senate, from which he resigned in 1949 to run for Congress; and Whereas, He was elected to Congress in 1950, and there completed his 42-year record of outstanding service to the People with 24 years of honorable, selfless and devoted representation of their interests; and Whereas, The Congressman was always known to all of his colleagues as a cheerful, helpful and concerned friend and associate, and the Honorable Carl Albert, Speaker of the United States House of Representatives, remembered him as "one of the most popular men in the House, always in good humor, respected by everybody"; and Whereas, He is survived by his beloved wife, Estelle, and by 2 brothers, Joseph Kluczynski and the Honorable Justice Thomas Kluczynski of the Supreme Court of Illinois; and Whereas, The Gentleman from Chicago always had the interests of the People of his City, State and Nation at heart, and he bent every effort to provide them with the best government possible, and the many public works projects which envisioned and worked ceaselessly to bring about are a monument to the concern which he felt for the safety and welfare of each of his fellow-citizens; therefore be it Resolved, By the House of Representatives of the 79th General Assembly of the State of Illinois, that we join the people of the 5th Congressional District, of the State of Illinois, and of the entire United States in mourning the passing of a great leader, public servant, advocate and friend in the person of the Honorable John C. Kluczynski, Member of Congress from Illinois; and be it further Resolved, that we extend to the family and friends of the late Congressman, and especially to his wife and brothers, our deepest sympathy in their time of bereavement; and that we join them in their feeling of

loss of a great friend and a good counselor; and be it further Resolved, that we recognize that the many great public works which Congressman Kluczynski worked for over so many years are a monument to his concern for the good of his State and his Nation; and be it further Resolved, that a suitable copy of this preamble and resolution be presented to Estelle Kluczynski as a token of the respect and admiration of the House of Representatives of the Illinois General Assembly for her husband."

Speaker Redmond: "Representative Lechowicz."

Lechowicz: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House, this is a Death Resolution for John, the Honorable John Kluczynski, a man who served his Congressional District for twenty-four years.

A man who served, not only the 5th Congressional District, but in turn served the People of Illinois, and the People of the United States in a very creditable mannor, here is a man, who is belovedly known in his own district as "Johnny Klu", a man of the People who in turn, truly representated the best in the political system.

It's with a deep heart, and a great of amount sorrow, that I move that we adopt, House Resolution 97, because in turn, we have lossed a truly great American."

Speaker Redmond: "Representative Giorgi, the Gentleman from Winnebago."
