Section 4, Real Property Taxation. 'a' Except as otherwise provided in this Section, taxes upon real property shall be levied uniformly by valuation ascertained as the General Assembly shall provide by law. 'b' Subject to such limitations as the General Assembly may hereafter prescribe by law, counties with a population of more than 100,000 may classify or to continue to classify real property for purpose of taxation. Any such classification shall be reasonable and assessments shall be uniform within each class. The level of assessment or rate of tax of the highest class in a county shall not exceed two and one-half times the level of assessment or rate of tax of the lowest class in that county. Real property used in farming in a county shall not be assessed at a higher level of assessment than single family residential real property in that county. 'c' Any depreciation in the value of real estate occassioned by a public easement may be deducted in assessing such property. First Reading of the Amendment. House Joint Resolution Constitution Amendment Number 11, Schraeder. Resolved, by the House of Representative of the 79th General Assembly of the State of Illinois, the Senate concurring herein, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least six months after the adoption of this resolution, a proposition to amend Sections 2 and 5 of Article IV of the Constitution to read as follows: Article IV. Section 2. Legislative Composition. 'a' One Senate shall be elected from each Legislative District. In the decade following each decennial redistricting, Senators from odd-numbered districts shall be elected for terms of six years and four years, and Senators from even-numbered districts for terms of four years and six years. Odd-numbered and even-numbered districts shall be distributed substantially equally over the State. 'b' Three Representatives shall be elected from each Legislative District. Immediately following

each decennial redistricting, the General Assembly by law shall divide the Legislative Districts into three groups. Representatives from one group shall be elected for terms of four years, four years and two years; Representatives from the second group, for terms of four years, two years and four years; and Representatives from the third group, for terms of two years, four years and four years. No political party shall limit its nominations to less than two candidates for Representative in any Legislative District. In elections for Representatives, including those for nomination, each elector may cast three votes for one candidate or distribute them equally among no more than three candidates. The candidates highest in votes shall be declared elected. 'c' To be eligible to serve as a member of the General Assembly, a person must be a United States citizen, at least 21 years old, and for the two years preceding his election or appointment a resident of the district which he is to represent. In the general election following a redistricting, a candidate for the General Assembly may be elected from any district which contains a part of the district in which he resided at the time of the redistricting and reelected if a resident of the new district he represents for 18 months prior to reelection. 'd' Within thirty days after a vacancy occurs, it shall be filled by appointment as provided by law. If the vacancy occurs with more than twenty-eight months remaining in the term, the person appointed to fill the vacancy shall serve until the next general election, at which time a person shall be elected to serve for the remainder of the term. If the vacancy occurs with no more than twenty-eight months remaining in the term, the appointment $\frac{1}{2}$ shall be for the remainder of the term. An appointee to fill a vacancy shall be a member of the same political party as the person he succeeds. 'e' No member of the General Assembly shall receive compensation as a public officer or employee from any other governmental entity for time during which he is in attendance as a member of the General Assembly. No member of the General Assembly during the term for which he was elected or appointed shall be appointed to a public office which shall have been created or the compensation for which shall have been increased by the General Assembly during that term. Section 5. Session. 'a' The General Assembly shall convene each year on the second Wednesday of January. The General Assembly shall be a continuous body during the two-year period commencing with the convening of the regular session of each odd-numbered year. 'b' The Governor may convene the General Assembly or the Senate alone in special session by a proclamation stating the purpose of the session; and only business encompassed by such purpose, together with any impeachments or confirmation of appointments shall be transacted. Special sessions of the General Assembly may also be convened by joint proclamation of the presiding officers of both houses, issued as provided by law. 'c' Sessions of each house of the General Assembly and meetings of committees, joint committees and legislative commissions shall be open to the public. Sessions and committee meetings of a house may be closed to the public if two-thirds of the members elected to that house determine that the public interest so requires; and meetings of joint committees and legislative commissions may be so closed if two-thirds of the members elected to each house so determine. Schedule: This amendment applies to the redistricting of 1981 and subsequent decennial redistricting and to the nomination and election of Senators and Representatives in 1982 and thereafter. First Reading of the Resolution."
