Clerk Selcke: "House Joint Resolution Constitutional Amendment #42, Klosak. Resolved by the House of Representative, 79th General Assembly, State of Illinois, the Senate concurring herein, that there shall be submitted to the electors of this State for adoption or rejection at the general election next occurring at least six months after the adoption of this Resolution of proposition to amend Sections 2 and 3 of Article IV of the Constitution to read as follows: Article IV, the Legislature. Section 2, Legislative Composition. (a) One Senator shall be elected from each Legislative District. Immediately following each decennial redistricting, the General Assembly by law shall divide the Legislative Districts as equally as possible into three groups. Senators from one group shall be elected for terms of four years, four years and two years; Senators from the second group, for terms of four years, two years and four years; and Senators from the third group, for terms of two years, four years and four years. The Legislative Districts in each group shall be distributed substantially equally over the State. (b) Each Legislative District shall be divided into two Representative Districts. One Representative shall be elcted from each Representative District for a term of two years. (c) To be eligible to serve as a Member of the General Assembly, a person must be a United States citizen, at least 21 years old, and for the two years preceding his election or appointment a resident of the district which he is to represent. In the general election following



a redistricting, a candidate for the General Assembly may be elected from any Legislative or Representative District which contains a part of the Legislative or Representative District respectively in which he resided at the time of the redistricting and re-elected if a resident of the new district he represents for 18 months prior to reelection. (d) Within thirty days after a vacancy occurs, it shall be filled by appointment as provided by law. If the vacancy is in a Senatorial office with more than twenty-eighh months remaining in the term, the appointed Senator shall serve until the next general election, at which time a Senator shall be elected to serve for the remainder of the term. If the vacancy is in a Representative office or in any other Senatorial office, the appointment shall be for the remainder of the term. An appointee to fill a vacancy shall be a member of the same political party as the person he succeeds. (e) No Member of the General Assembly shall receive compensation as a public officer or employee from any other governmental entity for time during which he is in attendance as a Member of the General Assembly. No Member of the General Assembly during the term for which he is elected or appointed shall be appointed to a public office which shall have been created for the compensation for which shall have been increased by the General Assembly during that term. Section 3, Legislative Redistricting. (a) Legislative and Representative Districts respectfully shall be compact, contiguous and substantially equal in population. (b) In the year following each Federal decennial census year, the General Assembly by law shall redistrict the Legislative and Representative Districts. If no redistricting plan becomes effective by June 30 of that year, a Legislative Redistricting Commission shall be constituted not later than July 10. The Commission shall consist of eight members, no more than four of whom shall be members of the same political party. The Speaker and Minority Leader of the House of Representatives shall appoint to the Commission one Representative and one person who is not a Member of the General Assembly. The President and the Minority Leader of the Senate shall each appoint to the Commission one Senator and one person who is not a Member of the General Assembly. The Members shall be certified to the Secretary of State by the appointing



authorities. A vacancy on the Commission shall be filled within five days by authority that made the original appointment. A Chairman and Vice Chairman shall be chosen by a majority of all Members of the Commission. Not later than August 10, the Commission shall file with the Secretary of State a redistricting plan approved by at least five Members. If the Commission fails to file an approved redistricting plan, the Supreme Court shall submit the names of two persons, not of the same political party, to the Secretary of State not later than September 1. Not later than September 5, the Secretary of State publicly shall draw by random selection the name of one of the two persons to serve as the ninth Member of the Commission. No later than October 5, the Commission shall file with the Secretary of State a redistricting plan approved by at least five Members. An approved redistricting plan filed with the Secretary of State shall be presumed valid, shall have the force and effect of law and shall be published promptly by the Secretary of State. The Supreme Court shall have original and exclusive jurisdiction over actions concerning redistricting the House and the Senate, which shall be initiated in the name of the People of State by the Attorney General. Schedule, this Amendment to the Constitution if approved by the electors at the general election of November, 1976, becomes effective January 1 of the year following the next Federal decennial census year.
