Speaker Redmond: "Roll call for attendance. Messages from the Senate."

- Speaker Redmond: "Any discussion? All in favor of the adoption of the amendment say aye, opposed no, the ayes have it and the amendment is adopted. Third Reading. Are there any further amendments? 634, Representative DiPrima."
- Jack O'Brien: "House Bill 634. DiPrima. A Bill for an Act to amend the
 Illinois Pension Code. Second Reading of the Bill. No Committee Amendments."
- Speaker Redmond: "Any amendments from the floor? Third Reading. 645, Representative Griesheimer."
- Jack O'Brien: "House Bill 645. Griesheimer. A Bill for an Act to amend the Snow Mobile Registration and Safety Act. Second Reading of the Bill.

- Griesheimer: "Mr. Chairman, Ladies and Gentlemen of the House, Committee

 Amendment No. 1 is really the thrust of the entire bill. A...this

 sets up a comprehensive program for educating ...a...and instructing

 minors between the ages of 12 and 16 in the safe handling of snowmobiles .

 It has been endorsed by the Department of Conservation. A...the

 amendment...a...is really the whole purpose of the bill. However,

I point out that the basic bill also provides for the abolition of the use of snowmobiles by children under the age of 10 years. Between the ages of 10 and 12, they can operate a snowmobile with their parents, guardian, or a person appointed by their parent or guardian who is of the age of 16 years of age or older...a...although, that last feature has to be changed by floor amendment. I move its adoption."

- Speaker Redmond: "Any discussion? The Gentleman moves the adoption of Committee Amendment No. 1 to House Bill 645. All in favor of the adoption of the amendment, say aye. Opposed, no, the ayes have it, the amendment is adopted. Any further amendments?"
- Jack O'Brien: "Floor Amendment 2. Griesheimer. Amends House Bill 645 as amended in Section 5-3 and so forth."
- Griesheimer: "Mr. Chairman, Amendment No. 2 is an amendment that has been suggested by the State Patrol. They wanted to be sure that the Safety Certificate issued to a minor was not interpreted as a motor vehicle license and wanted it very clear in the bill that a minor could not operate a snowmobile on or across the highway, and I agreed with this amendment and I would move its adoption."

Speaker Redmond: "Representative Griesheimer."

A..Ladies and Gentlemen of the House, the third amendment on this bill merely changes the age of a person who may be appointed by a parent to accompany a minor in the use of a snow-mobile. The original bill provided for 18 years of age, it was pointed out to me that a 16 year old may have a motor vehicle license so it made better sense to establish the age of 16, so it merely amends down the age of .a...supervisory...a...adult recreation from 18 to 16, I would move for its adoption."
- Speaker Redmond: "Any discussion? The Gentleman has moved the adoption of Amendment No. 3 to House Bill 645. All in favor indicate by saying aye, opposed, no, the ayes have it, the amendment is adopted. Any further

amendments? Third Reading. 646."

Jack O'Brien: "House Bill 646. Griesheimer. A Bill for an Act to amend the Boat Registration Safety Act. Second Reading of the Bill. One Committee Amendment. Amends House Bill 646 on page I by inserting after line 25, the following and so forth."

Speaker Redmond: "Representative Griesheimer."

Griesheimer: "Thank you Mr. Speaker. Ladies and Gentlemen of the House,
Amendment No. 1, which is a Committee Amendment to House Bill 646 is
identical to House....er...to the amendment to the prior bill. This bill
which creates a safety program..a...for minors between the ages of 12 and
16 in the operation of motor boats...a...failed to put in the actual safety
program and we had to place that on amendment, it was just an error in the
draftsmanship of the bill. I would urge its amend...a...its adoption."

Speaker Redmond: "Any discussion? The question is on the adoption of the amendment. Those in favor vote aye...a...indicate by saying aye, opposed no, the ayes have it, the amendment is adopted. Any further amendments? Third Reading. 654? Representative Brummet on the floor?"

Jack O'Brien: "House Bill 654. Brummet. A Bill for an Act in relation to payment of coal rights. Second Reading of the Bill."

Speaker Redmond: "Representative Brummet."

Jack O'Brien: "Committee Amendment No. 1. Amends House Bill 654 on page 1 by striking lines 16, 17, and 18, and so forth."

Speaker Redmond: "Representative Brummet."

Brummet: "Yes, I...these...these were adopted in committee."

Speaker Redmond: "Do you move the adoption of Amendment No. 1 to House Bill 654?"

Brummet: "Right."

Speaker Redmond: "All in favor indicate by saying aye, opposed no, the ayes have it, the amendment is adopted. Any further amendments?"

Jack O'Brien: "Committee Amendment No. 2. Amends House Bill 654 on page 2, line

Speaker Redmond: "Representative Brummet."

Brummet: "I move the adoption of Amendment No. 2."

Speaker Redmond: "The Gentleman has moved the adoption of Amendment No. 2 to

House Bill 654. Those in favor indicate by saying aye. Opposed, no,

the ayes have it, the amendment is adopted. Are there any further amendments?"

Jack O'Brien: "Committee Amendment No. 3. Amends House Bill 654 on page 1 by striking line 19 and inserting in lieu thereof and so forth."

Speaker Redmond: "Representative Brummet."

Brummet: "I move the adoption of Amendment No. 3."

Speaker Redmond: "The Gentleman has moved the adoption of Amendment No. 3 to

ayes have it, the amendment is adopted. Are there any further amendments?"

- Jack O'Brien: "No."
- Speaker Redmond: "Third Reading. House Bill 486. Representative Williams."

Speaker Redmond: "Representative McGrew on the amendment." Representative Willer. Representative Willer? House Bill 804. There's an amendment proposed by Representative McGrew. Take it out of the record. House Bill 818. Representative Washington."

Jack O'Brien: "House Bill 818. Washington. A Bill for amend the Illinois Small Businesses Purchasing Act. Second Reading of the Bill. No. Committee Amendments."

Speaker Redmond: "Any amendments from the floor?"

Jack O'Brien: "No."

Speaker Redmond: "Third Reading. 876. Palmer."

Jack O'Brien: "House Bill 876. Palmer. A Bill for an Act to amend the Illinois Pension Code. Second...Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any amendments from the floor?"

- Speaker Redmond: "Any amendments from the floor? Third Reading. 1051.

 Terzich. Representative Terzich?"
- Jack O'Brien: "House Bill 1051. Terzich. A Bill for an Act creating the Law Revision Commission. Second Reading of the Bill. No Committee Amendments."
- Speaker Redmond: "Any amendments from the floor? Third Reading. 1069."

The...a...what's happened is that these statutes are in effect in the Pension Code for all police and firemen in the State except State employees and this bill and the amendment makes it effective to the State employees."
- Speaker Redmond: "Any discussion? The question is on the adoption of Amendment No. 1 to House Bill 1069. All in favor vote aye...a...indicate by saying aye, those opposed no, the ayes have it, the amendment is adopted. Any further amendments?"

Speaker Redmond: "Representative Deuster."

- Deuster: "Mr. Speaker, this is a Committee Amendment which makes a minor change in the Bill, but an important one. It changes the word from 'aboard' to 'on deck'. This is a boating safety measure requiring children to wear coast guard approved personal floatation devices ah... on water crafts ah... underway and its ah... the Coast Guard suggests ah... and the ah... the outdoor boating clubs suggests the refinement in language to say 'on deck' instead of 'aboard'. I move the adoption of Amendment #1."
- Speaker Redmond: "Any disucssion? The question is on the adoption of Amendment #1 to House Bill 13. All in favor indicate by saying 'aye', opposed 'no', the 'ayes' have it and the amendment is adopted. Any further amendments?"
- Jack O'Brien: "Committee Amendment #2. Amends House Bill 13 on page 1,
 line 1, and in the title by deleting Section 1 nad so forth."

 Speaker Redmond: "Representative Deuster."
- Deuster: "Committee Amendment #2 was suggested by the Department of Conservation and it does incorporate the coast guard definitions of personal floatation devices and I urge the adoption of Amendment #2.

 It is a Committee Amendment."
- Speaker Redmond: "Any discussion? Representative Hart. I would like to make an announcement that the T.V. cameras have requested permission and very shortly they will be filming the House Chamber. Representative Hart."
- Hart: "What is the penalty for violation of this ah.. amendment to the law?"

 Deuster: "I have momentarily forgotten now. I have to check it, but it's

 ah....."

Hart: "Well, could you find out before you call it on Third Reading?"
Deuster: "I will do that, Representative Hart. I'm sorry I didn't
 have that on hand."

Hart: "Thank you."

Speaker Redmond: "Any further discussion? The question is on the adoption on Amendment #2 to House Bill...... Representative Deuster."

Deuster: "Just for Representative Hart, ah...as long as he brought the subject up, the answer to that question is ah... there could be a fine from \$10 to \$100."

Speaker Redmond: "The question is on the adoption of Amendment #2 to House Bill 13. All in favor of the adoption indicate by saying 'aye', opposed 'no' and the 'ayes' have it and the amendment is adopted.

Any further amendments? Third Reading. House Bill 14."

Jack O'Brien: "House Bill 14, Deuster. A Bill for an Act to amend the Boating Registration and Safety Act. Second Reading of the Bill.

Two Committee Amendments. Amendment #1, amends House Bill 14...."

Speaker Redmond: "Representative Deuster."

Deuster: "Amendment #1 again, is a Committee Amendment and it reflects a suggestion by the Coast Guard in this Bill, which is a part of a series on boating safety. There is a specification as to where a capacity plate shall be on the boat and the amendment specifies that it would be on the rear half of the hull. That's just so there is flexibility in where it can be because of the variations in boat designs. The second part of Amendment #1 defines the term 'wake' and ah... again this is a term that is used throughout the boating safety laws and it is good to have a definition. I ah... urge the adoption of Amendment #1."

Speaker Redmond: "Any discussion? Representative Yourell."

Yourell: "Yes, will the gentleman yield for a question?"

Speaker Redmond: "He indicates that he will."

Yourell: "Don, on this plate that you want to place on the hull of the boat, ah... are you changing the manufacturor's ... way of doing it?"

Deuster: "It's a little hard to hear, but I thought you said is ah... is there much of a change in the existing law and the ah....the capacity plate ah.. I believe ah... as you know, it already part of the law

- and the ah... the change is ah...., and I might read the language because each vessel required to have a capacity plate ah.. will have the recommended number of persons ah... and the weight capacity on there affixed to each side and the amendment would say, 'on the rear half of the hull..."
- Hart: "The point I'm trying to get ah.., Don, is as the hull comes from the manufacturer to the dealer, the capacity plate is affixed somewhere around that hull. Now are you saying that this plate has to be placed in a specific position on the hull, as the hull leaves the factory?"
- Deuster: "Oh, oh... yes. I make no change in the capacity plate, which is a plate. This has to do with the ah... a number, which is like the identification number. It is not a plate, but it is a number. It's something that's separate from the capacity plate."
- Hart: "Does it have to do with ah.. something ah...identifying the capacity number along side the registration number on both sides of the hull ah... on the bow?"
- Deuster: "No, that's the reason for this is it will be on the rear half. It won't be where the number is and the moast Guard has suggested this so there would be no confusion with the registration number and the capacity number."
- Hart: "Well, on every hull, as it is delivered from the factory there is a identification plate and on that plate there is a wet weight, dry weight and a total capacity weight as to the number... as to the number of pounds that that hull can safely carry. Now are you adding numbers of people?"
- Deuster: "Not to the plate, but as to be identified by a number on the side. Now I might say that we could discuss this and maybe if you want a clarification we could either take this back or hold it on Second Reading ah... after we put on the Committee Amendments, which ah.... would you like to do that?"
- Hart: "Well, I would just say this, Don. I don't think that you can place a capacity number as it relates to individuals on a hull because we're talking about apples and oranges. There may be ten individuals who weigh 70 pounds apiece and you've only got 700.

 Pounds and you may five 200 pound individuals that weigh 1,000.

So if you're talking about the number of people, as it relates to the total capacity of that ah... hull can safely carry, I don't think that that ah....that's really ah.... getting to the problem. Do you want to hold that?"

Deuster: "I would like to hold that and talk about it, but I would like to put on the Committee Amendments and then we can change that later. I think, Mr. Speaker, that we are the point of a adopting Committee Amendment #1."

Speaker Redmond: "Any further discussion? The question is on the adoption of Committee Amendment #1 to House Bill 14. All in favor of the adoption signify by saying 'aye', opposed 'no', the 'ayes' have it and the amendment is adopted. Any further amendments? Third Reading. House Bill 15. Pardon me, I've been advised that we have another amendment."

Deuster: "Mr. Speaker...."

Jack O'Brien: "Committee Amendment #2, amends House Bill #14 on page 1
 by deleting line 3 and so forth."

Speaker Redmond: "Representative Deuster."

Deuster: "Mr. Speaker, this is the second Committee Amendment and amoung other things included in this Bill is the proposal that the Implied Concent Law, which applies to motorists ah... on the highways... would be applied to ah... motorists ah... or boaters under this Bill.

Ah... Amendment #2 simply reflects the suggestion of the Department of Conservation ah.. as to a change in the language ah... and it's a long amendment, ah... 10 pages, but we can discuss that on Third Reading, but it's a refinement of the language that's already in the Bill with respect to implied concent."

- Speaker Redmond: "Any discussion? The question is on the adoption of Amendment #2 to House Bill 14. All in favor of the adoption signify by saying 'aye', opposed 'no', the ayes' have it and the amendment is adopted. Any further amendments? No further amendments. Third Reading. House Bill 15."
- Jack O'Brien: "House Bill 15, Deuster. A Bill for an Act to amend the Boat Registration and Safety Act. Second Reading of the Bill.

 One Committee Amendment. Amends House Bill 15 on page 1, line 14

 after 'department' and so forth."

Speaker Redmond: "Representative Deuster on the amendment."

Deuster: "This is a Committee Amendment #1. One of the provisions in House Bill 15 is that there shall be a no wake ah... speed within 100 feet of public docks, rafts, piers, and so forth and ah... the amendment makes an exception for boats that are towing water skiers. This is the same as the Wisconsin law and I had overlooked it, but that's one part of the amendment; to make the exception for waterskiers who are comming to designated pick-up or drop areas. The second part of the Amendment #1, the Committee Amendment, ah.... relates to ah.... the requirement that there be a no wake speed on small lakes and it provides that that may be waived by either the Department of Conservation or, as in the amendment, any local authority with jurisdiction over the lake."

Speaker Redmond: "Any discussion? The gentleman moves the adoption of Amendment #1 to House Bill 15. All those in favor of the adoption indicate by saying 'aye', opposed 'no', the 'ayes' have it and the amendment is adopted. Any further amendments? No further amendments. Third Reading. House Bill 141. Oh, pardon me, 148. House Bill 148, Representative Porter."

Jack O'Brien: "House Bill 148....."

Speaker Redmond: "Take it out of the record. 156, Representative Porter.

Out of the record. 438, Representative Birchler."

Jack O'Brien: "House Bill 438, Birchler. A Bill for an Act to amend the School Code. Second Reading of the Bill. One Committee Amendment.

Amends House Bill 438 on page 1 by deleting lines 33 and 34 and so forth."

Speaker Redmond: "Representative Birchler on the amendment."

Birchler: "Take it out of the record and I'll come back to it."

Speaker Redmond: "Take it out of the record. 493, Representative Bradley."

Jack O'Brien: "House Bill 493, Bradley. A Bill for an Act to amend the School Code. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any amendments from the floor? Third Reading. 500, Representative Polk."

Jack O'Brien: "House Bill 500, Polk. A Bill for an Act relating to obscene material in outdoor theaters. Second Reading of the Bill.

One Committee Amendment. Amends House Bill 500 by deleting page 3 all language in lines 28 through 33."

Speaker Redmond: "Representative Polk."

- Polk: "Yes, ah... this ah... lines out five lines, from 28 to 33, which were inadvertently put in there. The ah... the lines 28 to 33 make reference to indoor theaters. This Bill has nothing to do with indoor theaters. The Committee brought this to our attention. We ah... we ah... brought the amendment forward in Committee and it was accepted and I move for ah... the acceptance of Committee Amendment #1."
- Speaker Redmond: "Any discussion? The gentleman has moved the adoption of Committee Amendment #1 to House Bill 500. All in favor indicate by saying 'aye', opposed 'no'. Any further amendments? No further amendments. Third Reading. 554."
- Jack O'Brien: "House Bill 554, LaFleur. A Bill for an Act to amend the Illinois Municipal Code. Second Reading of the Bill. One Committee Amendment. Amends House Bill 554 on page 2 by inserting immediately after line 21 the following and so forth."

Speaker Redmond: "Representative LaFleur."

- LaFleur: "Mr. Speaker, I move for the adoption of Committee Amendment #1 to House Bill 554."
- Speaker Redmond: "The gentleman has moved the adoption of Amendment #1 to House Bill 554. All in favor of the adoption indicate by saying 'aye', opposed 'no', the 'ayes' have it and the amendment is adopted. Any further amendments?"

Speaker Redmond: "Representative LaFleur."

- LaFleur: "Mr. Speaker, I move for the adoption of Amendment #2. It does exactly what the Clerk has read. It's short. It takes the referendum requirement of 10% and reduces it to 5% and I move for the adoption."
- Speaker Redmond: "Any discussion? The gentleman has moved for the adoption of Amendment #2 to House Bill 554. All in favor indicate by saying 'aye', opposed 'no' and the 'ayes' have it and the amendment is adopted. Any further amendments? No further amendments. Third Reading. 438."

Jack O'Brien: "House Bill 438, Birchler. A Bill for an Act to amend the School Code. Second Reading of the Bill. One Committee Amendment. Amends House Bill 438 on page 1 by deleting lines 33 and 34 and so forth."

Speaker Redmond: "Representative Birchler."

- Birchler: "Thank you, Mr. Speaker. The Committee Amendment states that the Regional Superintendent shall assist the school boards in devising a plan for the maintenance of school building within the region. That was the change. I move for the adoption of that amendment."
- Speaker Redmond: "Any discussion on the amendment? The gentleman has moved the adoption of Amendment #1 to House Bill 438. All in favor of the adoption indicate by saying 'aye', opposed 'no' and the amendment is adopted. Any further amendments? Third Reading. 573, Representative Giglio."
- Speaker Redmond: "Any amendments from the floor? Third Reading. 583."

 Jack O'Brien: "House Bill 583, Leinenweber. A Bill for an Act to amend an Act in relation to alcoholic liquors. Second Reading of the Bill. Two Committee Amendments. Amendment #1, amends House Bill 583 by deleting on page 2 line 8 through 13 and on page 2 and so forth."

 Speaker Redmond: "Representative Leinenweber."
- Leinenweber: "Thank you, Mr. Speaker. Amendment #1 ah... was put on by the request of the Liquor Distributors and the Retail Liquor Dealers and at the behest of the Committee. Basically it restores the Bill to the law the way it was with the exception that it now permits a winemaker to make up to 20,000 gallons per year from grapes grown by land he owns and ah.... or land he leases and it permits him to sell up to 5,000 gallons per year at the site of the winery."
- Speaker Redmond: "Any discussion? The gentleman has moved the adoption of Amendment #1 to House Bill 583. All those in favor indicate by saying 'aye', opposed 'no' and the 'ayes' have it and the amendment is adopted. Any further amendments?"

- Jack O'Brien: "Amendment #2, amends House Bill 583 on page 1, line 15
 by deleting 'Class 5, First Class Winemaker' and so forth."
- Speaker Redmond: "Representative Leinenweber."
- Leinenweber: "Thank you, Mr. Speaker. Amendment #2 eliminates the two classes of winemakers. It makes only one class of winemakers and also it makes clear that a winemaker may also hold a wine manufacturers license."
- Speaker Redmond: "Any discussion? The gentleman has moved the adoption of Amendment #2 to House Bill 583. Those in favor indicate by saying 'aye', opposed 'no', the 'ayes' have it and the amendment is adopted. Any further amendments? No further amendments. Third Reading. 612, Representative Shea."
- Jack O'Brien: "House Bill 612. A Bill for an Act creating the Illinois

Jack O'Brien: "House Bill 616, Madigan. A Bill for an Act to regulate

Real Estate Appraisers. Second Reading of the Bill. One Committee

Amendment. Amends House Bill 616 on page 1 by deleting lines 20

through 24 and so forth."

Speaker Redmond: "Representative Madigan."

Madigan: "Mr. Speaker and Members of the House, Committee Amendment #1 provides an additional.... accepted to the applicability to the Bill.... provides that appraisals of single family detached homes will not be included within the provisions of the Bill. I move the adoption of Committee Amendment #1."

Speaker Redmond: "Representative Skinner."

Skinner: "Mr. Speaker, I have no objection to Committee Amendment #1, but unfortunately I am amiss at having not made it down to the Reference Bureau to draft some amendments ah... to this fairly atrocious Bill to make it somewhat better. I wonder if after the adoption of this amendment, if the Sponsor would be willing to take it out of the record until I have a chance to get them drafted?"

Madigan: "No, I won't."

Speaker Redmond: He indicates that he will not."

Skinner: "That he has no objection?"

Madigan: "I'm not going to take it out of the record."

Skinner: "You mean your actually going to let this miserable Bill get to Third Reading after getting out of Committee on only a one vote margin, without putting it into better shape than it is now?"

Madigan: "It is in excellent shape."

Speaker Redmond: "Any further discussion? The question is on the adoption of Amendment #1 to House Bill 616. All in favor indicate by saying 'aye', opposed 'no', the 'ayes' have it and the amendment is adopted.

ah... under the education system. It restricts it to \$100 per year

school ah... within the State of Illiniois and I ah... move for the

Speaker Redmond: "Any amendments from the floor? Third Reading. On the order of House Bills, Second Reading appears House Bill 315,
Representative Palmer. 366, Representative Hirschfeld. 600,
Representative Grotberg. 141, Representative Porter. Take that one out of the record. 555, Representative Hudson. Is Representative Hudson on the floor? 533, McPartlin. Representative Washington,
574. Representative Washington."

Washington: "Would you hold that on Second Reading, Mr. Speaker? I would like to make an announcement if I may at this time?"

Speaker Redmond: "You may."

Washington: "I want to call your attention to today's calendar on page 24.

It lists the Judiciary I Committee as meeting today and that is in error. Judiciary I meets tomorrow morning in Room C-1 at 8:00.

So disregard todays posting on Judiciary I."

Speaker Redmond: "Thank you. I think the calendar is in error. It shows Representative Willer as being Sponsor. Ah.... 804."

Jack O'Brien: "House Bill 804, Borchers. A Bill for an Act designating a state insect. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any amendments from the floor?"

Jack O'Brien: "Floor Amendment #1, McGrew. Amends House Bill 804 on page 1,
line 1 by deleting 'designating' and inserting in lieu thereof 'in

Speaker Redmond: "Representative McGrew."

McGrew: "Thank you, Mr. Speaker. Ah.... I've got a little problem here.

When you called this last time, I was having an amendment drafted that ah... is somewhat of a change here. I was wondering ah.... what would be the posture of that amendment? I filed it immediately upon coming up and I really prefer it to Amendment #1."

- Speaker Redmond: "Is it printed? The one comming up? It's not back from the printer."
- McGrew: "It's not back from the printer yet? Well, what is the posture if I tabled Amendment #1 then, ah... will the Bill remain on Second Reading?"
- Speaker Redmond: "Well, it ah.... probably not. You could ask the Sponsor to hold it. It would be a matter of courtesy between you two."

McGrew: "Will the Sponsor hold the Bill on Second Reading?"

Speaker Redmond: "He indicates that he he doesn't desire to do that."

McGrew: "Well, then I would move for the adoption of Amendment #1."

Speaker Redmond: "Discussion?"

McGrew: "Amendment #1 to House Bill 804 amends the Act providing for a state insect to do exactly what has always been done in the past in securing a state bird, a state tree, and a state flower and that is simply having the Illinois Office of Education provide a statewide referendum amoung all of our school children, K through 12 to vote upon various alternatives and the General Assembly would then act upon the recommendation of the school children and I would move for its adoption."

Speaker Redmond: "Any discussion? Representative Grotberg."

Grotberg: "Yes, I would object to that amendment, Mr. Speaker. I think we should leave this Bill intact with the Monarch Butterfly as the state insect because it seems to be the only insect in the State of Illinois that has the brains enough to go to South America while the General Assembly is in Session."

Speaker Redmond: "The gentleman is out of order. Representative Borchers."

Borchers: "Mr. Speaker and fellow Members, I request that the amendment be defeated. As the Committee knows, the children that did this did a wonderful job of it. Even the Daily News congratulated them on the way that they handled their lobbying. I think all we're doing is postponing something that ah... these children worked hard to

achieve. It might be a year or two years. It might open us up to all sorts of other letters. I just feel this is going too far. We should defeat this amendment and go ahead and send it on."

Speaker Redmond: "Representative Lucco."

Lucco: "Mr. Speaker and Members of the House, I rise in support of the amendment. I think this is to be an insect that represents the entire state and no of any locale and I think that Mr. ah.... Representative McGrew's idea, which we have been doing in the past, to allow the children in the schools throughout the state to decide through the various educational set-ups through the state office and then make a recommendation to the State Legislature, that should be approved. So I move that the amendment be supported."

Speaker Redmond: "Representative Simms."

Simms: "If the Sponsor of the amendment will yield for a question?

Representative McGrew, what would be the cost of your amendment
for the State Board to ah... institute ah... this type of ah....
a program? Is there any cost figures involved?"

McGrew: "There would not be any cost whatsoever to the State Board of Elections."

Simms: "No, State Board of Education."

McGrew: "There would be a minimal cost to provide information on each of the various alternatives, which would probably be one mailing to each school district in the State of Illinois. We have about 1200 school districts and that's at \$.10 apiece so it would be about \$124.00."

Simms: "Well, Mr. Speaker, in addressing myself to the amendment, it seems that ah... it seems that if we are going to start passing amendments like this and mandating more types of programs for the State Board of Education ah... it's not just simply mailing a \$.10 stamped envelope ah... with the necessary forms, etc. This takes a great deal of time and effort by the State Board of Education when they should be addressing themselves to more important problems. Let's fact it; it's going to take staff to analyze the results of that type of ah... program and I would suggest that his program is not a timely amendment. Representative Borchers has put

a great deal of time in this legislation and if the Gentleman thinks that there should be a separate type of a program for a.a...discussion throughout the State of Illinois on this, he should have introduced his own legislation and accompanying bill to provide the necessary funds for the State Board. So I would feel that this Amendment should be defeated and the bill should be...a...remain the same."

Speaker Redmond: "Representative Matijevich."

Matijevich: "Mr. Speaker and Ladies and Gentlemen of the House. I want to tell you, I've been here a while, but I never saw anybody do a better job in the committee than those third graders on House Bill 804. You know when it came up, I told Webber Borchers, I'd probably vote against that Monarch Butterfly, I didn't think the legislature should spend all the time on naming a...an...an insect, the State insect, and I said if C. L. McCormick were on here, it'd probably be the mosquito, and there's some that probably think the ant is the strongest insect there is. But I'll tell you, when I heard those kids in committee do such a good job. They put a little skit on for us and I'll tell you, I wouldn't have the heart to send this back defeated in any way to send it amended in any form. Let's get it out in the shape that it's in and let's defeat Amendment No. I to House Bill 804. The kids just did a terrific job, Webber, send that back to the teachers and all the students, they did a hell of a job."

Speaker Redmond: "Representative Duester."

Duester: "Well, Mr. Speaker, very briefly, we have a State tree that is
the Oak Tree; we have a State bird that is a Cardinal; we have a
State flower that is the Violet, and a State mineral that is
fluoride. On none of those occasions did we have a State-wide referendum
to make a decision on what it ought to be. I think that we ought to
proceed in the same way that Representative Borcher's is suggesting with
the insect, and that is make the decision for ourselves and I urge the
defeat of this mischievious amendment."

Speaker Redmond: "Are you ready for the question? The Gentleman has moved the adoption of Amendment No. 1 to House Bill 804. The question is shall Amendment No. 1 to House Bill 804 be adopted? Those in favor vote yes, those opposed vote no. Have all voted who wished? Representative McGrew to explain his vote."

McGrew: "I beg very much to differ from the information of the last speaker.

I suggest he check on some information before he spouts out to be an

expert. On all three, the State tree, sir, I was the elementary principal when we voted on that and that was the reason when I came down here I sponsored the bill to do so. As far as the Violet becomming the State flower, we followed the same procedure. When we selected the State bird to be the Cardinal, we followed the same procedure as this bill recommends. Now I have nothing against the Monarch, it's a beautiful insect. In fact, next to Webber Borchers himself, its the second most beautiful insect in the State. Now the point is that what happened in Decatur, Illinois was a great example for children around the State to become involved in the political process. Undoubtedly, they held a referendum in their class. Undoubtedly, the most popular kid in that class supported the Monarch. Now, that's fine, its well and good, but that does not mean that the entire State of Illinois, should we adopt a Monarch as an insect simply because the most popular kid in that class supported it in the class poll. All I'm saying is let's let the entire children of the State of Illinois have a voice in this. If they select a Monarch, I'll be more than happy to co-sponsor or sponsor that particular legislation. I think this is a drastic deviation from the way we have always done it and a very very poor procedure. Next we'll start looking for a State animal, a State mammal, a State...I don't know, well, we'll probably run out of things. We can certainly go through all the kingdom and parlors and classes and orders and families and species and get something. So I recommend an aye vote."

- Speaker Redmond: "Have all voted who wished? Take the record. On this question there's 75 $_{\rm nays}$ 42 yes, the amendment is lost. We've gone through...a.. the House Bills....further amendments? Pardon me."
- Jack O'Brien: "Floor Amendment No. 2. McGrew. Amends House Bill 804 on page 1, line 1, and so forth."
- Speaker Redmond: "Has the bill been printed and distributed? We'll have to hold the bill on Second then. It hasn't been printed and distributed. Representative McGrew."
- McGrew: "A...Mr. Speaker, Amendment No. 2 corrected a minor error in Amendment No. 1, and...."
- Speaker Redmond: "It isn't printed, Representative McGrew."
- McGrew: "I'm...I'm going to make a motion in regard to that Amendment if I may and just say what it is, I would move and I'll table it. It's the same thing as this only it lets public...private schools vote on it."

Speaker Redmond: "The Gentleman has moved to table Amendment No. 2, any objections? The Amendment is tabled. Any further amendments? Third Reading. We've gone through the House Bills on Second Reading on priority to call. We are trying to get out of here by 1:15 or 1:30 so we can eat, and on...a...the order of Constitutional Amendments, Second Reading, appears House Joint Resolution 18. Are there any amendments on that?"

Fred Selcke: "House Joint Resolution Constitutional Amendment No. 18. Second Reading. Whereas the 92nd Congress of the United States of America at its second session in both Houses by a Constitutional majority at 2/3's thereof adopted the following proposition to amend the Constitution of the United States of America. Joint Resolution resolved by the House of Representatives and the Senate of the United States of America in Congress assembled, 2/3's of each House concurring therein, that the following Article is proposed as an Amendment to the Constitution of the United States, which shall be valid to all intents and purposes as part of the Constitution and ratified by the Legislature of 3/4's of the several states within seven years from the date of its submission by the Congress. Article....blank....Section 1, Equality of Rights under law shall not be denied or abridged by the United States or any State on account of sex. Section 2. The Congress shall have the power to enforce by appropriate legislation the provisions of this Article. Section 3. This Amendment shall take effect two years after the date of ratification. Therefore, be it resolved by the House of Representatives, 79th General Assembly, State of Illinois, the Senate concurring herein, that such proposed Amendment to the Constitution of the United States of America be in the same is hereby ratified. And be it further resolved that a certified copy of this resolution be forwarded by the Secretary of State of Illinois to the Administrator of General Services of the United States; to the President Pro-Tem of the Senate, and the Speaker of the House of Representatives of the Congress of the United States, and to each Senator and Representative from Illinois in the Congress of the United States. Second Reading of the Constitutional Amendment."

Speaker Redmond: "Any amendments? Third Reading. Announcements? The

- Clerk has vetoed the Chair. Agreed Resolutions."
- Fred Selcke: "House Resolution 220. Lechowicz. House Resolution 219.

 Meyer. A...Madigan...Madigan. Yeh. A....House Resolution 219. Meyer.

 House Resolution 220. Lechowicz. Agreed Resolutions."
- Madigan: "House Resolution 219 congratulates the Reverend Kenneth Borchart,
 Pastor of Sacred Heart Roman Catholic Church of Chicago, upon the 40th
 anniversary of his ordination. House Resolution 220 commends the...and
 congratulates the Polish National Alliance and all of Polania upon the
 celebration of the 184th anniversary of Poland's adoption of its

- Speaker Redmond: "Move the adoption...the question is on the adoption of the Agreed Resolutions. All in favor indicate by saying aye, opposed, no, the ayes have it, the resolution is adopted. Any further resolutions?" Fred Selcke: "A...House Joint Resolution 42. Giglio."
- Speaker Redmond: "Committee on Assignment of Bills. Representative Dunn, for what purpose do you rise? Ralph Dunn."
- Dunn: "Thank you Mr. Speaker, I'd like to rise for the purpose of making an announcement."
- Speaker Redmond: "Proceed."
- Dunn: "The meeting of the Model School for the Deaf and Hard of Hearing Study Commission that was scheduled to be held in Chicago on tomorrow, April the 12th, April the 26th, has been cancelled. I've been asked to make that by the Chairman. Thank you."
- Speaker Redmond: "Are there further announcements? Any committee chairman that desire.....Representative Mann. Representative Mann?"
- Mann: "Yes sir. A...thank you Mr. Speaker, I just got the volumn. A..a...
 thea....House Committee on Higher Education, Mr. Speaker, will not
 meet at 8:00 A.M. next Monday, but we will meet at 2:00 P.M. next Monday.
 I call that to the attention of any sponsors who have business before

- Speaker Redmond: "Any other committee chairmen with announcements?

 Representative Londrigan."
- Londrigan: "Mr. Speaker, the Motor Vehicles Committee, next Monday, will not meet at 9:30, but will meet at 4:00 P.M. and 8:30, and I would also like

- I would also like at this time to table House Bill 670 and 673, of which I am the principle sponsor."
- Speaker Redmond: "Any objections? Will you repeat the numbers again, Representative Londrigan?"
- Londrigan: "670, 673."
- Speaker Redmond: "670, 673. Representative Fary."
- Fary: "Mr. Speaker, Labor and Commerce will not meet tomorrow, Saturday, because the...a...bills have been postponed by request of the sponsors.

 However, Labor and Commerce will meet on the 30th of April at 8:00 o'clock in the morning....across the street in B-1."
- Speaker Redmond: "Any other announcements? Representative Williams."
- Williams: "Mr. Speaker, I would like leave to have my name removed as a sponsor of House Bill 2819 and then I'd like Representative Taylor, if you will hear him, and he's going to move to table the bill."
- Speaker Redmond: "I've been advised that in order to have your name removed, you must come to the Clerk."

Hart: "Yes, show Representative Catania as the chief sponsor and...a...me...

Speaker Redmond: "Representative Berman."

Berman: "Well, Mr. Speaker, I don't know whether this is an announcement or a point of personal privilege. I guess it would be best described as a point of very personal privilege. For approximately a week now, many of my colleagues have been extending the accolade of 'Senator' to me and ah... I thought that ah... it would be proper for me to clarify on the floor of the House some of the rumors and gossip and discussions that we've seen ah ... either in the Press or on one side of the aisle or one side of the rotunda or the other. Unknown: "However....."

Speaker Redmond: "Representative Shea."

Shea: "Mr. Speaker, I'm wondering if I could get some order. There is a resolution on the Clerk's desk that I would like to have read."

Speaker Redmond: "It is a very ominous resolution."

Fredric B. Selcke: "House Resolution 221, Redmond et al. Whereas, our friend and colleague, James R. Washburn of Morris, has again contrived to celebrate his birthday on a day in which the House is in Session.
