of Amendment #3, all in favor of the adoption indicate by saying 'aye'... 'aye', opposed 'no'. The 'ayes' have it and Amendment #3, is adopted. Any further Amendments?"

Clerk O'Brien: "Amendment #4... Amends House Bill 3392 as amended in Section 4, by deleting 'foster care' and so forth."

Speaker Redmond: "Representative Jaffe...."

Clerk O'Brien: "That's Gerald Bradley."

Speaker Redmond: "Representative Bradley."

Bradley: "Mr. Speaker, and Ladies and Gentlemen of the House. All

Amendment #4 addresses itself to, is a.... inequity, I believe
in... the payments that we make to foster parents and those
parents that take care of children coming into their homes and
what I attempted to do with this Amendment, is to add dollars
to the area in this legislation that make payments... or allow
us to pay the foster parents ah... for their care they provide for these children in their homes. And, at the same time
I have deleted the same number of dollars from the ah... Institutional line items so that we are not increasing the budget in
ah... this particular Department but, we're asking you and
indicating to the Department that we think more money should
be given to... foster care children and with hope: that, more
parents will become foster ah... foster parents, so I move the
adoption of Amendment #4, to House Bill 3392."

Speaker Redmond: "Representative Grotberg."

Grotberg: "Mr. Speaker, will the Sponsor yield?"

Speaker Redmond: "He indicates that he will."

Grotberg: "Ah... Representative Bradley... ah... you are trans... I

don't have a copy of your Amendment first of all, but you are

transfering Institutional Care money to... the foster care line

of the budget... is that...."

Bradley: "That's what we're doing, yes Sir."

Grotberg: "And, how many dollars are you talking about."

Bradley: "We're going from the ah... the foster care line item was nineteen million, and we've increased it to twenty-four million



and for Institutional Care Group Home ah... with twenty-three million, we have reduced that to eighteen three, six for even distribution dollars."

Grotberg: "Well, then Mr. Speaker, may I address the Amendment. gather by this Amendment, and I understand what the Gentleman is trying to do but.... we're reducing the ah... Institutional Care line by some five millions of dollars and I have every ah... sympathy for the foster care people of course, in this line but, that is not the method to achieve it. I ah.... you know if we're going to do this let's just appropriate money for that line, Representative Bradley, I... and I would be kinda support ive of.... some other route but the... the Institutional Care line has been very carefully budgeted, there is no growth... sufficient growth in it at all, this year and those same cost have accrued to the Institutional Care ... ah I just have to disagree with... looking at that line for this five million dollars ah... the other day in appropriations, I attempted to flat out put a quarter.... or three quarters of a million dollars ah... into another line but I didn't borrow it from any other line and we got the Amendment on, but the Bill died, so we had to strip it off in Committee to get this Bill out the way you see it now and I have another Amendment coming up that makes ah... restores two positions that we took out that budget for about thirty-five or fifty thousand dollars, something like that. But, ah... to use this method to get at the foster care needs and I get the same mail that you do, and I'm deeply involved in it... if this gonna be ah.... it's the principal that we're going to deal with, I think that we should ah... deal with it either on this Amendment and defeat your Amendment or sit down and take another look at the whole situation, Representative Bradley, otherwise I have to oppose the Amendment."

Bradley: "Well, the only reason for reducing the amounts on the Institution
Representative Grotberg, was to stay in the spirit, I hope of
this budget section that we're in and met our obligations ah...

that if we do increase in the amount of dollars sor.ewhere along in the ah... in these appropriation Bills, that at the same time we would meet our responsibilities by reducing it in the same area."

Grotberg: "Well, Mr. Speaker, may I continue with the dialogue... I presume that somebody is going...."

Speaker Redmond: "I thought...."

Grotberg: "... move us out of order, pretty soon."

Speaker Redmond: "I thought that ah... it's right here,

Representative Jaffe."

Jaffe: "Thank you. Ah... Mr. Speaker, I... I rise in opposition to Amendment #4. Ah... basically what you're doing is, you're taking five million dollars away from Institutional Care and we do have children in those Institutions and do have to pay for them. Ah... Institutional Care asked for literary ah... no increase this year. And, basically what you would do if you adopt this Amendment... is that you would simply Institutional Care in the State of Illinois and we would not be able to pay our bills to the Institutional Care people. I would therefore urge an opposition and a 'no' vote to Amendment #4."

Speaker Redmond: "Representative Ryan."

Ryan: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. Ah... will the Sponsor of the Amendment yield?"

Speaker Redmond: "He says, he will."

Ryan: "Representative Bradley, I believe that ah... your error... your Amendment is technically incorrect ah... on your first line there for foster care, you've got nineteen million, five-hundred and fifty-five thousand and four hundred dollars and I believe that figure should be, nineteen thousand, five five one and 400. I think that your Amendment is technically wrong.



Amendment #3, that we adopted piror to this has got that figure in as nineteen, five five one and 400 and you've got it in at nineteen, five five five 400."

Bradley: "Well, if we were fortunate to get this Amendment on, we could ah... change that ah... later on, Representative Ryan, ah... I was depending on the ah... staff to come up with the right figures I assumed that ah... that was ah... right ah... I'm not sure that they ah... wrong or your're wrong, I wonder if the Clerk would take a look at that and see what the ah... figure is... on the legislation."

Speaker Redmond: "Meantime, Representative Dunn."

Dunn: "Thank you ah... Mr. Speaker. I have a question if
the Sponsor would yield, I'm really not sure that its
a proper question for him ah... but I'll ask the question and maybe someone can answer it. Ah... what is
the position of the Department with regard to this
Amendment?"

Bradley: "I don't think the Department has ah... taken a position, at least to the best of my knowledge ah... on this Amendment ah... period, John."

Speaker Redmond: "Representative Jaffe, for what purpose do you rise?"

Jaffe: "Ah... Mr. Speaker, I... I don't think that the last ah... statement by Representative Bradley is correct.

Ah... the Department has the Children Institutional ah... care facilities and they have to take care of those individuals and I feel that the Department position ah... that they would be in opposition to this Amendment."

Dunn: "Thank you."

Speaker Redmond: "Representative Leverenz."

Leverenz: "Thank you, Mr. Speaker, would the Sponsor ah... yield to a question?"



Speaker Redmond: "He will."

Leverenz: "Will this... change in funding ah... will any

of the money go to fund a program known as kaleidoscope."

of the

Bradley: "I certainly hope not."

Leverenz: "Thank you."

Bradley: "Mr. Speaker... as to the best of my knowledge
ah... I did not have an opinion from the Department
one way or another, that was an honest remark ah..."

Speaker Redmond: "Mr. Clerk, did we ascertain the... nineteen million or nineteen thousand? Representative
Bradley, the Clerk advises me that there is ah...
a mistake in the ah... discrepancy in the Amendment...
it talks about deleting ah... nineteen million, fiftyfive, four hundred where as the figure is nineteen

million, five fifty-one four hundred. Presume that

Bradley: "Why..."

Speaker Redmond: "I don't know where...."

it could be corrected on. ..."

Bradley: "That's what I was going to suggest, we could correct that...."

Speaker Redmond: "Any objections to correcting it on its face? Nineteen million, five fifty-one... Representative Ryan."

Ryan: "Why, I would object to that, Mr. Speaker, because I'm opposed to the Amendment."

Speaker Redmond: "Well, that's not a valid reason."

Ryan: "It certainly is,"

Speaker Redmond: "We've done that before"

Ryan: "You asked if there was any objections and I...."

Speaker Redmond: "The record will note, Mr. Ryan's objection.

Representative Walsh."

Walsh: "Well, Mr. Speaker... that makes the copies that
were distributed to the Members incorrect and ah... I...
I think this is too serious of a matter to correct on

its face. I think you ought to get the...."

Speaker Redmond: "Okay, we'll take it out of the records then. We'll be here, July 4th. Take this one out of the record. Any other Amendments? I think that we might as well take the whole thing out of record, as long as this Amendment.... any further Amendments, other than Amendment 4.... Amendment #5, Representative Grotberg."

Clerk O'Brien: "Amendment #5, Grotberg. Amends House Bill 3392, on page 4, line 1 and so forth."

Grotberg: "Yes, Thank you...."

Speaker Redmond: "Representative Grotberg."

Grotberg: "Thank you, Mr. Speaker, ah ... Amendment #5, assuming Representative Bradley will support this as strongly as I opposed his Amendment.... ah... restores simply restores the badly needed nursing position at the Illinois Children's Hospital school and two Cottage Parents at the Illinois School for the Deaf, they are short two Cottage Parents to ah... maintain 24 hour ah.. staff at the several Cottages for a total of net increase of some sixty-five thousand, eight hundred and ninety-eight dollars, included in this is a transfer and a reduction of twelve hundred dollars of State funds ah... transferred out and transferred in of twelve hundred dollars in Federal Funds in the equipment line. The net affect of this is to add to the Children and Family Services total budget ah... sixty-five thousand eight hundred and ninety-eight dollars in General Revenue Fund. This is a commitment as we reduce their budget in Committee ah... that I and several Committee Members made to restore those two badly needed jobs that got caught in the ah... process as we reduced the personnel lines in staff and Committee work. I would appreciate adoption of Amendment #5."



Speaker Redmond: "Representative Jaffe."

Jaffe: "Ah... we have ah... we have no opposition for this particular Amendment, Mr. Speaker and I would move its adoption."

Speaker Redmond: "Representative Ryan."

Ryan: "Thank you, Mr. Speaker, would the Gentleman yield on the Amendment?"

Speaker Redmond: "Yes."

Ryan: "Representative Grotberg, how much money is appropriated now ah... in that.... you're trying to put in another approximately sixty-six thousand dollars, is that correct?"

Grotberg: "That's correct, Representative...."

Ryan: "I presume...."

Grotberg: "A hundred and fifteen million dollars appropriated there with 2% transferability."

Ryan: "So, do you think that money could be transferred rather than adding another sixty-six thousand dollars to this budget?"

Grotberg: "Ah.... it's a transferability... with, between
Institutions, Representative?"

Ryan: "Yes."

Grotberg: "I'm assuming then, that you would be talking

about total transferability capability on a million..."

Ryan: "A hundred and thirteen million."

Grotberg: "A hundred and thirteen million as some twenty millions of dollars.... be in total.... that's 2%...

no, it would be two million dollars spent...."

Ryan: "Right."

Grotberg: "... for ability ah... I have no response to
that question other than to the... these line items
refer to specific institutions and ah... what that
does to transferability that you're speaking of, I
have no idea."



Ryan: "Well, it's possible to do ah... Representative

Grotberg and probably should be done that way and based

on that reason I'm going to have to oppose your Amendment as it grieves me."

Speaker Redmond: "Any further discussion? Representative Lechowicz."

Lechowicz: "Thank you, Mr. Speaker... I'm sorry, Representative Ryan, were you completed? George... were you completed?"

Ryan: "Yeah, I'm done."

Lechowicz: "You posed a very important question, Representative Ryan, as far as transferability factor and ah...

I think it was pointed out that it is available between institutions... and now we are highlighting in Amendment #5, the... return of two employees for the Illinois
Children Hospital School and what was the total cost?

Well, he pointed out before that there were two employees at a cost of sixty-eight thousand dollars... what
two employees are they?"

Grotberg: "Ah... let me go into it just a little deeper,
Representative Lechowicz. It restores a ten thousand
dollar position at the Hospital School, and two positions
at the Illinois School for the Deaf... I'm sorry,
seven... seven Cottage Centers, my numbers are wrong.
So, it's a total of eight positions... seven Cottage
Parents at the Illinois School for the Deaf at fiftyfive thousand which puts them in at about ah... nine
thousand eight or nine thousand dollar position and
the fringe ah... gets generally the same because the
fringe was budgeted in the first place and left alone..."

Grotberg: "The positions, as I recall, the vacancy... in appropriations debate ah... we were assured that they had all been filled, at this point in time, my records



Lechowicz: "How long was the positions vacant?"

showed that a number of ah... vacancies in the whole Children Family Services of ah... a considerable number of vacancies as of six months ago. The Department Director, testified that these positions are still... the ones that we're talking about, that they are new positions."

Lechowicz: "You are requesting additional positions..." Grotberg: "Here we are... yes, at seven... at seven thousand dollars and thirty-eight.... seven thousand and thirtyeight dollars annual. Child care service workers, two, for a total of forty-nine thousand, two-sixty-six, that is the School for the Deaf. As I understand it, it is the night crew for 24 hour ah... round the clock and to reduce the racial staff student. I've been out there Representative Lechowicz, you know me, I wouldn't stand for much to go unneeded."

Speaker Redmond: "Representative Tipsword, please. Representative Jaffe, to close ... Representative Grotberg."

Grotberg: "Yes, as I understand it there is presently a forty-five to one staff ratio in these Cottages and this will reduce the staff ratio as well as ah ... add ah ... twenty-four hour coverage, for the kids and these are the more combined disabled kids... either than deaf some of them are retarded and of high need for personal care."

Speaker Redmond: "The question is on the adoption of Amendment #5, to House Bill 3392. The Gentleman has moved the adoption of the Amendment, all in favor of the adoption indicate by voting 'aye', opposed by voting 'no'. Have all voted who wished? Representative Grotberg."

Grotberg: "Well, thank you, Mr. Speaker. Ah... just to explain my vote. The whole principal of these positions in spite of the opposition of this Amendment, is that



indirect care to kids... ah... the State does some pretty bad things into direct care to kids and others do things pretty well. The State School for the Deaf does it well, and my position is, where the State does do things well, we should darn well make sure that they can get the job done. If ... I can think of other Institutions lines that I would amend the other way, including many other Institutions as well as the Children and Family Services, but until you have been to Jacksonville and seen the job that's going on it would be very difficult to appreciate that this here is one of the better run schools and if this will help it, I think the General Assembly should express itself to such an Amendment ah... for these relative few dollars for direct services to kids on a twenty-four hour basis. I ask your support."

Speaker Redmond: "Have all voted who wished? This requires a simple majority. The Clerk will take the record.

On this question 50 'ayes' and 35 'nos', the motion prevails the Amendment #5 is adopted. Any further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker Redmond: "Representative Bradley."

Bradley: "Mr. Speaker, I never did really hear what happen...

what the disposition with Amendment... my Amendment #4."

Speaker Redmond: "We took it out of the records, temporarily there was that mistake, there were objections made..."

Bradley: "Well, could we hold this... we're having the

mistake ah... corrected, it should be back on the floor any minute ah..."

Speaker Redmond: "I understand the Clerk has it in Amendment #6."

Bradley: "Amendment #6, fine."

Clerk O'Brien: "Amendment #6, Gerald Bradley. Amendments

Bradley: "I have already explained the Amendment is the same as Amendment #4, but technically correct now... I offer Amendment #6, to House Bill 3392."

Speaker Redmond: "Representative Ryan."

now that's been taken out of the records?"

Speaker Redmond: "That was taken out of the record, as I.... assume that we'll Table that very shortly."

Ryan: "Has Amendment #6, been distributed?"

Speaker Redmond: "Mr. Clerk... will you ask that Gentleman to stop bothering you...has Amendment #6, been distributed?"

Clerk O'Brien: "No."

Speaker Redmond: "I understand that it has not. We'll take
3392 out of the record until.... Representative Bradley."
Bradley: "Well, Mr. Speaker could we Table Amendment #4,
while we're here, so the only one that will be left to

Speaker Redmond: "Any objections to Tabling Amendment #4,
hearing none, Amendment #4 is Tabled. We'll take 3392
out of the record. House Bills, Second Reading appears
House Bill 3380."

Clerk O'Brien: "House Bill 3380, a Bill for an Act to provide for the ordinary and contingent expenses of the Department of Labor. Second Reading of the Bill, two Committee Amendments. Amendment #1...."

Speaker Redmond: "Representative Walsh."

address ourselves toc..."

Walsh: "Mr. Speaker, it would appear that you are not functioning in accordance to the rules, which suprised no
one, but to point out how you are... the last Bill on
House Bill, Second Reading was House Bill 3392, you've
asked the Clerk to call, House Bill 3380. I submit to



you that we should go to 3405, and or if that is not to be called, then through the rest of the Bills on House Bills, Second Reading... before we go back to..."

Speaker Redmond: "I hesitate to call your attention to the fact that 3405, was called and there were no Amendments and it is now on Third Reading. So, it would be rather difficult to call it again."

Walsh: "3406, Mr. Speaker, that..."

Speaker Redmond: "That is out of the records, 3408, is out of the records, 3409, is out of the records... 3410, is out of the records... 3479, is on Third Reading, we go back to the next order and ah... Second Reading and the next one to be called is 3380, which is the one that we're on."

Walsh: "Would you tell me what this position was made of 3379?"

Speaker Redmond: "That's being held... it's not being called today... or at the present time."

Clerk O'Brien: "Amendment #1, amends House Bill 3380, on page 1, by deleting line 11 through 24, and so forth."

Speaker Redmond: "Any discussion? Depresentative Stubble-field.... Representative Barnes."

Barnes: "Thank you, very much, Mr. Speaker. Amendment #1

to House Bill 3380, makes a overall ah... reduction of
ah... twenty-one thousand, six hundred and forty-four
for general offices. It makes a reduction of seven
thousand for EDP for a total reduction of twenty-eight
thousand and six hundred and forty-four. It eliminates
one ah... Section of the Federal Project Fund and distributes a total appropriation... to a total of a hundred and fifty thousand among three existing divisions
within the Department ah... a total of a hundred and
fifty thousand. This Amendment was adopted ah... and
ah.... Committee ah... Appropriations II, I would move



it's adoption, Mr. Chairman."

Speaker Redmond: "Any discussion? The question is on the adoption Amendment #1, to House Bill 3380. All in favor indicate by saying 'aye'... 'aye', opposed 'no'.

The 'nos', have it and the Amendment is adopted. Any further Amendments?"

Clerk O'Brien: "Amendment #2, amends House Bill 3380 as amended in Section 1, by deleting the following; for operations of General Office and so forth."

Speaker Redmond: "Representative Barnes."

Barnes: "Thank you, very much, Mr. Speaker. Mr. Speaker, and Members of the House. Amendment #2, restores

General Revenue line item of eighteen thousand, one hundred and forty-four dollars and makes a reduction and the conciliation in ah... immediation of eighteen thousand, seven hundred dollars. I would move for the adoption of Committee Amendment #2, to House

Bill 3380."

Speaker Redmond: "The question is on the adoption of Amendment #2, all in favor... Representative Lechowicz."

Lechowicz: "Yes, Mr. Speaker ah... will-athe Sponsor yield

to one question?"

Speaker Redmond: "He will."

Lechowicz: "Which position are you referring in ah... General Office?"

Barnes: "Which position are we restoring in General Offices?"

Lechowicz: "Yes.. Eighteen thousand and one hundred and

forty-four dollars."

Barnes: "Ted, I don't remember the exact position that is being restored, but what we did... was transfer ah... the difference in the like amount in the conciliation and mediation section.... Ah... perhaps the Sponsor of the Bill could tell you the exact position. Representative Stubblefield."



Stubblefield: "Mr. Speaker.... Representative Lechowicz,
this is a position of Assistant to the Director and
ah... it was restored in as much as, it was a duplication
and ah... it!s a technical Amendment that ah... corrects
the Bill. It has been deleted twice, we restored it
one time."

Lechowicz: "Is the position in the Personnel Detail Book of fiscal 77."

Stubblefield: "I believe so, a position currently held by Mr. Walsh."

Lechowicz: "All right, I'll check it. Thank you."

Speaker Redmond: "Any further discussion? Representative Ryan."

Ryan: "Thank you, Mr. Speaker ab... who's Amendment is this ab... will the Sponsor yield?"

Speaker Redmond: "Representative Barnes."

Barnes: "Thank you, very much ah... Representative Ryan, this is Committee Amendment #2."

Ryan: "And, this is the one that cuts an additional five hundred and fifty-six dollars?"

Barnes: "Right, this is the one where we restored a position and ah... the number 1, area of the Amendment with eighteen thousand and one hundred, forty-four, and we made a reduction in the conciliation and mediation section of eighteen thousand, seven hundred. It was a net reduction of five hundred and some odd dollars....

five hundred and ah"

Ryan: "Okay, thank you."

Barnes: "Fifty-six dollars."

Speaker Redmond: "Representative Lechowicz."

Lechowicz: "My question is to the Sponsor of the Bill... then.

Is that the position of Administrative Assistant three?"
Stubblefield: "No it isn!t. It's Mr. Walsh."

Lechowicz: "What Administrative Assistant is that there is,



2, 3, and 4."

Stubblefield: "By that number, I can't tell you Representative."

Lechowicz: "Well, based upon the salary that you've got in here... that's my whole point. That position was supposedly vacant in fiscal year 1976, their asking that it be appropriated in fiscal 77, at the exact dollar amount of sixteen thousand, two hundred and forty-four dollars and when you add in the retirement and social security, it comes up to eighteen thousand one hundred and forty-four dollars and how did they pay them in fiscal 76, if it wasn't authorized?"

Stubblefield: "I have no information on that."

Lechowicz: "Let's take it out of the records."

Speaker Redmond: "Take it out of the record. House Bills,
Third Reading... Representative Stone."

Stone: "Mr. Speaker, Ladies and Gentleman. I had a Parliamentary inquiry I would like to make, of the Chair, if I may."

Speaker Redmond: "Proceed."

Stone: "The Assistant Minority Leader, made a ah... real catty, nasty remark in reference to the Chair a while ago. I wondered if he apologized to the Speaker, after he found out that he was wrong."

Speaker Redmond: "What would your guess be?"

Stone: "The same as your, Sir."

Speaker Redmond: "Apologize, is not in him. Representative Bradley."

Bradley: "I believe now, before we go to Third Reading...

back up a little bit to Second Reading and ah... address ourselves to Amendment #6, on 3392, because I'm
informed that the Amendments have been distributed."

Speaker Redmond: "House Bill, Second Reading. On House

Bills, Second Reading appears House Bill 3392."

Bradley: "Again, Mr. Speaker, I move my motion for the adopt-



ion of Amendment #6, now to House Bill 3392."

Speaker Redmond: "Representative Jaffe."

Jaffe: "Ah... Mr. Speaker, I would renew my opposition
to Amendment #6, as I indicated here beforehand... this
five million dollars would be taken away from Institutional Care and it would virtually cripple Institutional
Care in this particular State. There are children
in those Instutitions ah... the bills must be paid,
there are contracts made and everything else and so....

therefore I would urge a 'no' vote on ah... Amendment #6.

Speaker Redmond: "Representative Ryan."

Ryan: "Thank you, Mr. Speaker, I would like to speak against this Amendment. First of all, I would like to ah... let the Membership of the House know that there is a substitute Bill, House Bill 3580... that's presently in the House Rules Committee, that will possibly be heard tomorrow and it tries to establish ah... higher rates for foster care and so, I would suggest to the Sponsor of this Amendment that it is not timely... based on that, secondly ah... this Amendment is a major reordering of priorities for this Department and this Amendment was not discussed in the ah... Committee and I feel that ah... this importance should have at least come through the Committee and so ah... I would suggest that we defeat this Amendment. Thank you."

Speaker Redmond: "Representative Walsh."

Walsh: "I don't care to talk right now, Mr. Speaker."

Speaker Redmond: "Representative Bradley, to close."

Bradley: "Well, thank you, Mr. Speaker and ah... Mr. Ryan
I'm well aware of 3580, because I'm the Sponsor of that
Bill and I hope that we get it out of Rules Committee
tomorrow and, I not a member of your Appropriations
Committee and I couldn't be there because of being in

Rules to offer this Amendment... at the.... Appropriation



ah... Committee, which I would have been very happy to have done. The only recourse I had, was to present it here for your consideration. Now, I have heard a great deal said ah... this afternoon, about Institutional Care... and I would like to draw the attention to the Members of the House that, the Institutional cost, in my opinion anyway, are astronomical... and the Illinois soldiers and children's ah...school at Normal, Illinois we're talking about an Institutional cost per student or per child.... are somewhere in the neighborhood of twenty thousand dollars a year and what I'm addressing myself too, with this legislation is the possibility of giving foster parents, at least enough money to break even. And, I say that again, just to try to break even.... in supplying the dollars and food, with those dollars in clothing that is so necessary for a child today. You're talking about, in case some of you don't know, we're paying less than a hundred dollars a month for children under 12 years old, to stay in a foster home, we're paying about a hundred and fifty dollars for a teenager and then the this bepartment comes along and mandates that, forty-five dollars of that hundred and fifty, be spent for clothing, so that leaves them a hundred and five dollars to pay for the food and the rest of the care, medical care, although we do provide them with the medical care they can get Public Aid for these children, but you two standing Gentleman.... standing that I'm looking at, know better than I... what the problems are and the difference between foster care and institutional care. The cost of institutions... or the cost for a child in the institution is just over... overwhelming and what I hope to do also, to. have other parents who are potential foster parents who can teach these children and I think anybody that's



studied the problem will agree, these children get better care... or have a more average childhood, in a foster home than they do in an institution. I don't think that there is going to be to many on the floor of the House to debate that.... but we simply do not have enough foster parents who will take these... accept the responsibility of raising these children.... Now, I do have House Bill 3580, in Rules tomorrow and I hope I can get that out of there. It does address itself to the same problem, let me suggest to you too, there is a difference in cost. The difference in cost between what private agencies... the private agencies cost per student ah... also what the cost is ah... what... how many dollars a child receives ah... aid to dependent children from the Department of Public Aid. They receive more money than we're talking about than the foster parents receive. I just think there has been an injustice for way too long of a time, in the amount of dollars that we can give to foster parents and the huge cost and I do remind you, it's costing us twenty-six thousand dollars in one institution, I wouldn't be surprised if it's not costing us over that amount of dollars in many many other institutions and it's time that we address ourselves to a problem we've had for a long time and now, the reason that I think there is opposition, is because I reduced the amount of the Institutions, but in the spirit of this budget year ... I was doing that so that the budget would come out with the same bottom dollar, that we have presently. We have no change there, it's a matter of where we are putting it on the line item and that is why I took the five million from one line item and put it in another. It would have been very simple, but I don't think it would have been meeting our responsiblit



as legislators, to do it any other way but this, so ... I simply ask the support of the Members to, let's at least address ourselves and try to justify an injustice in a very.... I think, in my opinion an inequity ah... in the manner in which we've been distributing dollars to those parents who are kind enough to take a child that they don't know, in many instances they have never seen, bring them into their house and offer them their home. Many times with their own children alive... with their own children living in the home with them and they bring them in and open the doors to them... open their hearts in many cases and I don't know how many families that would do something like this and I admire those people that do it. I think at least we should allow them to.... have enough dollars to supply the. necessary, the needs, the means to educate those children, to clothe them and to feed them... somewhere near what we're giving those private agencies and those Institutions for doing the same thing. I urge your support for this... on Amendment 46."

Speaker Redmond: "Representative Meyers, for what purpose do you rise?"

Meyer: "Just one quick question of the Sponsor, Mr. Speaker.

Representative, you made the statement that the State
is presently paying ADC payments, is this true?"

Bradley: "It's my belief that for one child with ADC, that

they are getting more money than a child ah... who is in a foster home... less than 12 years old."

Meyer: "Is this ah... an opinion or a fact. To the best of your knowledge."

Bradley: "To the best of my knowledge, I would say that it is a fact."

Meyer: "Thank you."

Speaker Redmond: "The question is on the adoption of Amend-



ment #6, all in favor of the adoption indicate by saying 'aye', opposed 'no'. The opinion of the Chair, the 'nos' have it and the Amendment fails. Are there anymore Amendments."

Clerk O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. House Bills, Third Reading 3212... Representative Bradley."

Bradley: "Is it to late to ask for a Roll Call?"

Speaker Redmond: "I have already announced.... Third Reading 3212."

Clerk O'Brien: "House Bill 3212, Chapman. A Bill for an Act making appropriations to the Department..."

Speaker Redmond: "Out of the record. 3303, Representative Tipsword."

Clerk O'Brien: "House Bill 3303, a Bill for an Act making appropriations to the Department of Agriculture. Third Reading of the Bill."

Speaker Redmond: "Representative Tipsword... 3303."

Tipsword: "Mr. Speaker and Ladies and Gentlemen. 3303, is a Bill that would appropriate on the behalf of the Department of Agriculture... a sum of a hundred and twenty-three thousand, eight hundred and sixty-three dollars as a supplement to the County Fairs of the State of Illinois. The County Fairs of the State of Illinois are required by the December 31, of the preceeding year to make a determination as to what they will pay in premiums for the coming year and at that time, it is indicated to them what kind of money will be available to them for premium payments from the Agriculture Fund. A year ago, the County Fairs throughout the State of Illinois did this and then as you will recall in June, we ran into the financial crisis situation in which we cut back on our appropriations. At that time the County Fairs had already made their publication



many of them as to what they would pay in their premium and they were shorted in the amount of money to pay those premiums, it was to late after their advertisements and Fair books were out to change their premium dates and many of them were shorted severely and found themselves in dire financial circumstances, consequently the Department of Agriculture, to the County Fairs division has come back in with this supplemental appropriation to take care of those fairs who found themselves in that kind of a situation and their fairs were so early that they were unable to buy additional advertising to change their premium scale. This is a... an appropriation which would provide from the Agriculture premium fund, the additional amount of money to cover the obligations that they incurred prior to the financial ah ... crisis being made aware to the public in general and consequently they found theirselves in a situation where they could not change. We have a great number of fairs throughout the State that find themselves in this situation and if anyone is... is interested in whether or not the fairs their particular area are concerned, I would be glad to give them to them ah.... this will give them only the amount

Reference Bureau in so drafting, because these are always paid from the Agriculture Premium Fund and we had to amend and put that in by Amendment so that, it came from the same Fund that it was supposed to come from."

Schlickman: "What is the total amount that was appropriated last year, for fiscal 76, for these premiums?"

Tipsword: "I regret that I don't have that information available ah... in the information that I have on hand on how much was totally appropriated last year, for this amount...."

Schlickman: "Loes this represent the 6% reduction?"

Tipsword: "Well, here's what I have... wait a minute, yes
I do have too. The Statutory base for all County
Fairs for fiscal year 76, of full funding was ah...

million, six hundred thirty-two thousand, five hundred
and six dollars. The sum of one million, four hundred
and twenty-seven thousand and six hundred dollars was
finally appropriated, now.... the... the amount appropriated finally was approximately 12% less than the
amount that was ah... told to the County Fairs at the
start of 1975, that they were going to have available
for their premiums ah... it was about a 12% reduction
in this particular item."

Schlickman: "One further question."

Tipsword: "Yes, Sir."

Schlickman: "Where is the present status of the Agriculture Premium Fund. What balance presently exist there."

Tipsword: "I... I.... that I do not have, I don't know what the balance is... that is in it, except that they tell me the balance is adequate to cover this ah... this appropriation, in fact I was lead to believe that it



was more than adequate to cover this appropriation for last year under the funds that would have been available. ah... but I can't tell you the exact figures that is in that fund, I regret, I do not have that."

Schlickman: "Do I understand ... or can I "

Tipsword: "I'm sorry, I didn't hear you."

Schlickman: "Do I assume correctly... that this Bill has

the support of the Department of Agriculture?"

Tipsword: "This Bill was drafted at the request of the

Department of Agriculture. Yes, Sir."

Schlickman: "Thank you."

Speaker Redmond: "Representative Skinner."

Skinner: "Yes, Mr. Speaker, would the Gentleman yield to

a question or two?"

Speaker Redmond: "He will."

Skinner: "Is this more important than the Special Education deficiency?"

Tipsword: "Pardon me, Sir."

Skinner: "Is this more important than the Special Education deficiency?"

Tipsword: "Well, on the basis of assigning priorities, as
far as, I think anyone would be concerned... is Special
Education ah... deficiency perhaps would have a... a
piror priorities, except to those people who are insterested
in County Fairs, however, it does not come from the
same fund. This is from the Agriculture Premium Fund
and not from the General Revenue Fund."

Skinner: "I would like to speak to the Bill, Mr. Speaker." Speaker Shea: "Proceed, Sir."

Skinner: "Now Mr. Speaker. We are having a myth perpetuated on us today and that is that the Agriculture Premium Fund doesn't apparently have any relationship to the General Fund. Surplus funds from the Agriculture Premium Fund go directly to the General Fund at the discretion



of the Governor and it seems to me that, somewhere you've got to start. So, far I haven't seen us willing to start anywhere ah... this is only a hundred and twenty-three thousand dollars, it will undoubtedly sail out with at least a hundred and two votes because there are at least a hundred and two counties that we all represent and incidentally all counties did not overspend, mine didn't for instance, that's why I have the guts enough to stand up here and say this... We just don't have that extra hundred million dollars, Guys... and if Representative Stone can find it, I would be happy to have him kick it in."

Speaker Shea: "The Gentleman from Logan, Mr. Lauer." Lauer: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House. I don't need to ask questions on this Bill because this is one of those Bills that represents giving back to those who have spent money on the basis of the assurance of the State that they would get the money back. Based upon our promise... now, if we're going to give the full faith in credit of the State to our own law... I think it's down well time we did it. It's getting to the place that everyone who under goes the program that has any kind of State support is beginning to say, that the credit of the State is not any better than that of a town bum. We mandate programs or we foster programs and say to a local agency... you pay the bill and we will reinburse you... this money comes out of the ah... pari-mutuel betting, and quite frankly this money goes to encourage the Agriculture industry and improvement in all aspects of that industry. There are County Fairs after County Fairs, after County Fairs.... that based upon our promise to give additional premium money... went ahead and raised their premium of small amount, for the first time in many cases, 20



years. I think that it is time that we finally made good on our word and at least to some extent... and since this doesn't take anything out of the General Revenue Fund, I think that this is the place to start. I strongly solicit an 'aye' vote."

Speaker Shea: "The Gentleman from Kane, Mr. Waddell."
Waddell: "Mr. Speaker, and Ladies and Gentlemen of the House.

I think that the issue that is before us today... is not whether or not we have come to this particular point in our history, that we can or we can not fund and then not fulfill the obigations on which we had the racing and the betting in the State of Illinois, in the first place. We had made a commitment as down state legislators and were willing... on the basis of sharing to the Counties and to the County Fairs and to the Fair and Exhibitions, that portion... after the State of Illinois took the cream off the taxing on the racing, we then had made an obligation. This merely fulfills that obligation and the promise to that portion of the money that we have spent all along and I suggest an 'aye' yote."

Speaker Shea: "The Gentleman from Christian, Mr. Tipsword, to close."

Tipsword: "Mr. Speaker and Ladies and Gentlemen, I appreciate the comments that have been made here in regard to this Bill ah... there are Fairs throughout the State of Illinois that are affected by this, because they didn't know the amount of money that they were actually getting until late in July or the first of August, last year and many... many of the Fairs had already advertized and it was to late to change their advertisement. This has to come out of other funds that was available to them. Since, I had ah... tried to answer Representative Schlickman's questions a little earlier, Representative



Ralph Dunn, has been kind enough to provide me with a figure that there is about five million, two hundred and fifty thousand dollars ah.... as of March 31, in the Agriculture Premium Fund. This would merely reimburse those County Fairs that had made their obligations for premiums under the existing law that we had, indicating to them what their premiums should be and could be. Ah... then when they were shorted by the 12%, later on they could not change, or had already held their Fairs and totally they are out about a hundred and twenty-three thousand, eight hundred and sixty-three dollars. I would move that we adopt this ah ... this Bill, to provide for these County Fairs, their total reimbursement which they had to pay out and which is really in comparison to our problems, a very small figure and comes from that five million, two hundred and fifty thousand, that is laying in the Agriculture Premium Fund. I urge your support for this and for all the County Fairs throughtout the State of Illinois." Speaker Shea: "The Gentleman from Christian, Mr. Tipsword

moves for the passage of House Fill 3303. The question is, shall House Bill 3303 pass, all those in favor will vote 'aye' those opposed will vote 'nay', this takes 89, votes. Get Shea, 'aye', please. Have all voted who wished? Have all voted who wished? Have all voted who wished? Take the record, Mr. Chairman... or Mr. Clerk. Take the record.... Miss Macdonald, 'aye' and would somebody please look at her switch. Telcser, 'aye'. Farley, is your switch on... Farley, 'aye'. Garmisa, 'aye', he on. Boyle is on 'aye'. Have all voted who wished? Have all voted who wished? Take the record. On this question there are 122 'ayes', 6 'nays' and 1, Member voting 'present'. Representative Duff, did you seek recognition? This Bill having



received the Constitutional Majority is hereby declared passed. Miss Chapman, did you want to call that Bill on Third Reading, today? And, Mr. Washington and Mr. Schneider want to hold their legislation. On House Bill, Second Reading... is Mr. Getty... did you want to call that today? Take that out of the record. Mr. Stubblefield... that's out. Mr. Davis.... that's out. Mr. Byers, that's part of a package, right. Mr. Terzich... is not.... that's out. Mrs Satterthwaite, that's part of a package Bill too, isn't it? Mr. Stubblefield... what about on 3410, Mr. Stubblefield, is he.... 3410 is that ready... we go..."

Clerk Selcke: "House Bill 3410, a Bill for an Act making supplemental appropriation ordinary contingent expenses of the Department of Labor. Second Reading of the Bill, one Committee Amendment. Ah... amend House Bill 3410, on page 1, line 5 by deleting four million and five hundred eighty-seven thousand and nine hundred, inserting in lieu thereof, six million, four hundred and forty-seven thousand, seven hundred."

Speaker Shea: "This is a Committee Amendment, from what Committee, Mr. Clerk?"

Stubblefield: "Appropriations II."

Speaker Shea: "The Gentleman from... Macoupin, Mr.... the Gentleman from Cook, Mr. Barnes."

Barnes: "Thank you very much, Mr. Speaker."

Speaker Shea: "Mr. Barnes, this is Bill that is the supplemental to the Department of Public Aid or I mean, the

Department of Labor for four and a half million, to

pay unemployment comp. and they raised it to 6½?"

Barnes: "Yes, I was trying to find the exact Amendment ah...

Mr. Speaker, but, what the Amendment was... the difference
and the original amount of four point five million,
which was raised... which was raised to six point

Speaker Shea: "The Gentleman from Kankakee, Mr. Ryan, on the question."

Ryan: "Thank you, Mr. Speaker. I think that I can help
you Gene. The Amendment adds one million, eight hundred
and forty thousand and eight hundred dollars to the
request of the Bill.... which is four million, five
hundred and eighty-seven thousand, nine hundred dollars
which makes this total package... just in this Bill

All those in favor will say 'aye', those opposed 'nay'. In the opinion of the Chair the 'ayes' have it and the Amendment is adopted. Are there further Amendments? Any Amendments from the floor? Third Reading. On the order of motions, appears House.... Mr. VonBoeckman's motion on House Bill 3054... take that out of the record.

Speaker Shea: "3390, Mr. Houlihan... is home being a father. 151, is Representative Mann here? 642, Mr. Leverenz and Huff, do you want to hold that Resolution, today. HJRCA 32, Mr. Totten, that's out... House Bill 33... or 3222, 3395 and 96, Mr. Grotberg, do you want to proceed with that written motion ... take that out. Senate Bill 193, Mr. Hart, do you want to proceed? Tomorrow. Mr. Grotberg, do you want to Table that motion, now that those Bills are posted. The Gentleman from Kane, Mr. Grotberg, ask leave of the House to Table his motion with regards to, House Bills 3222, 3095, and 3396, is there objections, hearing none the Gentleman's request to Table the motion will be granted. House Joint Resolutions 61, Mr. Kelly, do you want to go with that today ... that's out. House Joint Resolution 83, Mr. Polk... is Mr. Polk... do you want to go with your thing today ... Speaker Shea: "Is that your statement?"

Speaker Shea: "Can you tell me where in the rules... that's prohibited."

Walsh: "Well, there is no place in the rules that I'm ah....

fariliar with right now, Mr. Steaker...."

Speaker Shea: "That Mr. Walsh, authorized by our rules to post in that manner."

Walsh: "Ah... I've never seen it posted that way before,

Mr. Speaker... Committee Bills have to be introduced

and Committee Bills have number, I don't see how any
interested person could go to that Committee Hearing
and have any idea what might be proposed in that Bill..."

Speaker Shea: "Mr. Walsh, can I...."

Walsh: "I don't know whether this Bills has been introduced...

as not been introduced, if they are going to meet to

discuss some subject matter for the purpose for turning

out a Committee Bill, that's okay, but they don't have

to post it... as I understand it."



Speaker Shea: "Well, you see, our rules do ask them to

post by-subject matter, if there is not a Bill... then

our rules goes further and say, if from that a Committee

Bill is authorized... that the Bill then is introduced,

read a first time, sent back to Committee for a public

hearing in the form that it came out of."

Walsh: "To clear up this matter... would you...."

Speaker Shea: "If you would look at your...."

Walsh: "Your Parliamentarian...."

Speaker Shea: "Mr. Walsh.... could I finish, please Sir."

Walsh: "I thought that you were finished."

Speaker Shea: "I'm not...."

Walsh: "All right."

Spekaer Shea: "Rule 18 (i), serves notice of no Bill or
Resolution may be heard or any vote taken there on in

Assistant Minority Leader objection to House Bill 3509, I would point out that the ruling that you've just made in response to Representative Meyer, is ah... would comply with Rule 18 (i), and if 3509 does not come out of rules... ah... there is a proper pointing for the submission of a Committee Bill of the same subject matter as 3509.

Did I lose you...."

Speaker Shea: "I think that may have stretched the rubber band a bit far..."

Berman: "Not at all, Mr. Speaker."

Speaker Shea: "Mr. Clerk, would you please find out... where House Bills 3509, 3536 and 3583, presently are and those Bills are not posted until... let's see that's posted for Tuesday, so perhaps we'll try to get... Mr. Walsh, I see your light on, you don't have to shout... I'll get back to you, Sir. So, if you will check on that.

Now, Mr. Walsh you seek recognition, turn Mr. Walsh on."

Walsh: "Mr. Speaker, I... I just think that you ought to



make clear to the Clerk, that what we're looking for is were these Bills where five and a half days ago, or six and a half days ago from tomorrow. The rule requires that there be six and a half days posting, a Chairman may not post a Bill that is not in his name...."

Walsh: "Well, do you agree with my point ... "

Speaker Shea: "Shut him off. The Gentleman from McLean,

Mr. Bradley."

Bradley: "Well, thank you, Mr. Speaker. And, I think the ah... Assistant Minority Leader is being very dilitory because you have already stated that you're going to try to find out where those Bills are... at that time make some kind of a ruling, it's very clear to everybody else on the floor of the House, but the man that keeps standing up and hollering... Mr. Speaker, Mr.



Walsh... doesn't seem to understand that you will find out where those Bills are and how could he make a ruling on anything, as you suggest, until he finds out where the Bills are and I'm sure that he has already said to you on time and time again... if we've spent fifteen minutes on this, that when he finds out where the Bills are and the Clerk is trying to find out, then he will make the proper ruling."

Speaker Shea: "Mr. Bradley... Gentleman..."

Speaker Bradley: "The Gentleman from Cook, Mr. Shea."

Shea: "Mr. Speaker, Ladies and Gentlemen of the House.

would like to announce that the following Bills have been assigned, reassigned from the Rules Committee to the appropriate, Appropriations Committee, House Bill 3515, by Mr. Hanahan, that went to Appropriation II. House Bill 3431, went to Appropriations I, that was by ah... Mr. Boyle. House Bill 3427, went to Appropriations I, by Mr. Giorgi. House Bill 3551, Appropriations I, Mr. Tipsword. Speaker Bradley: "Is there unanimous consent, hearing no objections ah... leave to use the attendance Roll Call on the Gentlemans motion. ho objection, the attendance Roll Call will be used and the Gentlemans motion is adopted. Consideration Postponed, appears House Bills 3363, the Gentleman from Cook, Mr. Shea."

Shea: "Mr. Speaker and Ladies and Gentlemen of the House.

House Bill 3363, is a supplemental appropriation to
the Comptroller to pay... or reinburse the Counties
for the amount of salarys they have paid probation
officers and then pursuant to the Juvenile Court Act,
are reinbursed up to 50% of that salary... or for 50%
of that salary up to a maximum of three hundred dollars
per month, per employee. And, I would certainly try
to answer any questions."

Speaker Bradley: "Discussion. the Gentleman from Champaign,



Mr. Hirschfeld."

Hirschfeld: "Yes, Mr. Speaker, will the Sponsor yield please."

Speaker Bradley: "He has indicated that he will."

Hirschfeld: "Ah... Representative Shea, could you tell me ah... does this apply to all one hundred and two counties in the State."

Shea: "Yes, it does, Sir."

Hirschfeld: "And all counties have asked for reimbursements, that are entitled to it anyway."

Shea: "Any County that has a Juvenile Probation Officer and pays that county... that county that pays that Juvenile Probation Officer is then permitted to ask for reimbursement under this program."

Hirschfeld: "Can you tell me how many counties that applies too."

Shea: "The program applies to all one hundred and two."

Hirschfeld: "But how many are eligible for reimbursement,

because it is my understanding they don't all have

Probation Officers."

Shea: "I have not got the figures in front of me, but it's my understanding that this... the additional Probation Officers that have been put on since we've passed the original budget are primarily from downstate counties, Sir."

Hirschfeld: "Could you tell me this then ah... Representative ah... what proportion of the ah... four hundred and thirty-two thousand dollar goes to the County of Cook and what proportion goes to the other one hundred and one counties in the State."

Shea: "I have no way of knowing, I will tell you that out of the appropriation, the major appropriation... it has been broken down where about 60% goes downstate and about 40% to Cook."

Speaker Bradley: "The Gentleman from Cook, Mr. Madison."



4:4 to 1

Madison: "Thank you, Mr. Speaker, would the Sponsor yield for question?"

Speaker Bradley: "He indicates that he will yield, yes."

Madison: "Representative Shea, when the enabling legislation passed?"

Shea: "I think 1967 or perhaps 69."

Madison: "And, this enabling legislation made it possible for ah... ah... Juvenile Probation Officers to be added and the State would pick up one half of the cost, up to a maximum."

Shea: "Yes, Sir."

Madison: "Did the enabling legislation include a ceiling on the number of Probation Officers that could be added?"

Shea: "No, Sir."

Madison: "And, this supplemental appropriation is necessary because of additional pro... ah... probation officers, is that correct?"

Shea: "This is the exact situation that Mr. Lauer talked about, a few minutes ago and that we've authorized the counties to spend the money... they spent it and now all they are doing is, asking for that expenditure back and this money will allow us to do it."

Madison: "So the question... the present posture of the

State right now, is that the counties can add on addition
al Probation Officers ad infinitum and the State would

be responsible for reinbursing half the cost up to a

maximum of three hundred dollars, is that correct?"

Shea: "Yes, Sir."

Madison: "Thank you."

Speaker Bradley: "The Gentleman from Knox, Mr. McMaster."

McMaster: "Ah... will the Sponsor yield for a question?"

Speaker Bradley: "He indicates that he will."

McMaster: "Mr. Shea, we have many.... areas, judicial district



in the State of Illinois where a Probation Officer serves, let's say, five or six counties... how does this affect ah... districts such as that."

Shea: "Are those Juvenile Probation Officers, or regular Probation Officers?"

McMaster: "Regular and I believe Juvenile too."

Shea: "It is my understanding, and I talked to Judge Roberts from out in your area, one time and he's worked out as I understand it an arrangement where they... where if they split the cost, they split the reinbursement. In other words, if... if three counties pay a man nine hundred dollars a month, each county would probably er... three hundred dollars each, each county would be entitled to a reinbursement of up too... a hundred dollars from each of the three counties."

McMaster: "Thank you, Jerry."

Speaker Bradley: "The Gentleman from Tazwell, Mr. Luft."

Luft: "Thank you, Mr. Speaker, may I speak to the Bill."

Speaker Bradley: "You certainly may, Sir." -

Luft: "I would like to apologize first to ah... Representative Shea. Last time I spoke against this Rill, I indicated that I hadn't received some information that I had asked for ah... he did provide me with the information that he said that he said that he would give me but, I did not receive the information that I was told that I would get from the Comptrollers Office. This morning or this afternoon, in the ah... Appropriation Committee Dr. Manville, appeared before us, on another supplemental Appropriation Bill, I asked him about this Bill and our analyst, it was said to us... or told to us that this supplemental Appropriation Bill was for a hundred and twenty new... Juvenile Probation Officers in sixty counties. I would like to say that if you go beyond the population bases down in the sixty counties, you're



talking about counties with populations in the teens,
I asked him if these people were on board, if they
had been hired and he did not know. Some of the counties
that are supposedly being reinbursed have not, I know
hired these people. I would suggest that we keep this
on postponed consideration, Dr. Manville, told me that
he would provide me with the figures and the amount
of employee that have been employed since December,
and all I'm saying is, this can not be a supplemental
appropriation for something that there isn't in exsistants to supplement."

- Speaker Bradley: "The Gentleman from Cook, Mr. Shea, to close."
- Shea: "No, at the request of Representative Luft, I will certainly take it out of the record until he gets the material if he tells me that Dr. Manville has promised to bring him the material."
- Speaker Bradley: "Fine, we'll take it out of the record then."

 the Gentleman from Cook, Mr. Getty."
- Getty: "Mr. Speaker, Ladies and Gentlemen of the House. Ah..
