Clerk O'Brien: "A message from the Senate, by Mr. Wright, Secretary. Mr. Speaker, I am directed to inform the House of Representatives that the Senate has passed

Kenneth Wright, Secretary. A Message from the Senate, by Mr. Wright, Secretary. Mr. Speaker, I am directed to inform the House of Representatives that the Senate has concurred with the House of Representative in the passage of Bill with the following titles to with, House Bill 3213 together with Amendments passed by the Senate as amended May 4, 1976. Kenneth Wright, Secretary."

Speaker Redmond: "Committee Reports."

Clerk O'Brien: "Representative Lechowicz, Chairman from the Committee on Appropriations I, to which the following Bills were referred; action taken May 3, 1976, reported the same back with the following recommendation, do pass for House Bill 3378 and do pass as amended. And, House Bill 3343, 3346, 3372, 3374, 3389, and 3547. Representative Lechowicz, Chairman from the Committee on Appropriations I, to which the following Bills were referred; action taken May 4, 1976, reported the same back with the following recommendations, do pass for House Bill 3414 and do pass as amended for House Bill 3815 and 3817."

Speaker Redmond: "House Bills, Second Reading. On House Bill, Second Reading appears House Bill 3379, Representative Getty. Out of the record. 3380, Representative Stubblefield. Out of the record. Representative Hart..."

Hart: "I can't find my Calendar, would somebody bring me one..."

Clerk O'Brien: "House Bill 3385..."

Speaker Redmond: "I think that we'll hold that one for awhile. A Member with something on the Calendar want to volunteer..."

Representative Giorgi, do you seek recognition? Representative Hart. Representative Washburn."

Washburn: "Thank you ah... Mr. Speaker and Ladies and Gentlemen of the House. That's probably the greatest insult that I've had since I've been down here, Mr. Speaker. It is my pleasure though to introduce to the Members of this Body about forty members of the Kankakee Chamber of Commerce who are down here on their annual Government and legislative day to learn more of what we do, they are in the gallery behind me about forty members of the Kankakee Chamber of Commerce with their Executive Director, "Bill Konzarick", to welcome them, please stand."

Speaker Redmond: "Representative Washburn, who represents Kankakee?"

Washburn: "Oh, yes... by the way ah... ah... until next January, it will be Washburn, Beaupre and Ryan and after that, it will be Ryan and a couple of other fellows."

Speaker Redmond: "You care to name them..."

Washburn: "I would like to name them, ~~yeah~~"

Speaker Redmond: "Representative Mahar."

Mahar: "Mr. Speaker, I have a parliamentary inquiry, in regard to the Digest ah... the Digest shows ah... for example, a Bill that I had ah... last year, it was placed on the Study Calendar and then it shows that on April 5, 1976, it was recalled and referred to Elections. What's the status of that type of Bill?"

Speaker Redmond: "What's the number of the Bill?"

Mahar: "213, Mr. Speaker."

Speaker Redmond: "We will find out and let you know. I don't know whether this is correct, we'll find out what the..."

Mahar: "Okay, thank you."



Speaker Redmond: "We'll report back, Mr. Mahar. House Bills, Third Reading. On House Bills, Third Reading appears House Bill 3405."

Clerk O'Brien: "House Bill 3405, a Bill for an Act to provide for the ordinary and contingent expenses of the Commission on Delinquency Prevention. Third Reading of the Bill."

Speaker Redmond: "Representative Capparelli.... 3405."

Capparelli: "It's out... I don't have... I can't even open my locker."

Speaker Redmond: "Representative Capparelli..."

Capparelli: "It's in my locker and I..."

Speaker Redmond: "Out of the record. 3410... out of the record. 3479, Representative Darrow."

Clerk O'Brien: "House Bill 3479, a Bill for an Act to amend an Act in regard to a attachments. Third Reading of the Bill."

Speaker Redmond: "Representative Darrow."

Darrow: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. House Bill 3479, amends an Act in regards to attachments. Our current attachment law was held unconstitutional by a three judge panel and this Act is an attempt to put attachment back on the books. This has been drawn to comply with the judges ruling, it requires that facts be sent out in an affidavit for a writ of attachment, in addition to conclusions of law and requires that a hearing be sent immediately after the attachment if required by the defendant. I would move for a favorable vote on this measure."

Speaker Redmond: "Are there any discussion? The question is, shall this Bill pass. All those in favor vote 'aye' opposed will vote 'no'. Have all voted who wished? Have all voted who wished? The Clerk will take the record. On this question there is 107 'ayes' and 1 'no'

and the Bill having received the Constitutional Majority is hereby declared passed. 3392."

Clerk O'Brien: "House Bill 3392, a Bill for an Act to provide for the ordinary and contingent expense of the Department of Children and Family Services. Third Reading of the Bill."

Speaker Redmond: "Representative Jaffe."

Jaffe: "Ah... Mr. Speaker, this ah... appropriates money for the ordinary and contingent expenses of the Department of Children and Family Services, the amount of this Bill was originally one hundred and thirteen million dollars, the Committee chopped off approximately a million, two and that's the figure that we're at, at the present time. And, I would move adoption of House Bill 3392."

Speaker Redmond: "Is there any discussion? Representative Ryan."

Ryan: "Will the ah... Thank you, Mr. Speaker will the Sponsor...."

Speaker Redmond: "He indicates that he will."

Ryan: "Yes, Representative Jaffe, an... ~~is~~ this Bill as it came out of Committee now or are there any Amendments on it... any other Amendments?"

Jaffe: "Ah... this Bill is.... I was just trying to look... This Bill is as it came out of Committee with the exception that we adopted Representative Grotbergs Amendment #5, yesterday."

Ryan: "I can't hear him, Mr. Speaker."

Jaffe: "I said that this Bill is as exactly as it came out of Committee with the exception of Amendment #5, which Mr. Grotberg put on the Bill yesterday."

Ryan: "Thank you."

Speaker Redmond: "Any further discussion? The question is, shall this Bill pass. All of those in favor vote 'aye',



opposed vote 'no'. Have all voted who wished? Representative Taylor, 'aye'. Have all voted who wished? The Clerk will take the record. On this question there are 120 'aye' and 1 'no' and the Bill having received the Constitutional Majority is hereby declared passed. 3212, Representative Chapman... out of the records. 3382, Representative Harold Washington..."

Clerk O'Brien: "House Bill 3382, Washington..."

Speaker Redmond: "At the request of the Sponsor, that will be taken out of the record. House Bill, Second Reading. On House Bill, Second Reading appears House Bill 3385."

Clerk O'Brien: "House Bill 3385, a Bill for an Act provide for the ordinary and contingent expense of the Fair Employment Practices Commission. Second Reading of the Bill, one Committee Amendment. Amends House Bill 3385 on page 1, line 12 and so forth."

Speaker Redmond: "Representative Davis."

Davis: "Mr. Speaker and Ladies and Gentlemen of the House. I'm going to move to Table the Committee Amendment. The Committee Amendment was definitely beaten and ah... the motion was made to reconsider the vote by which the Amendment was beaten and my troops was in the ah... Rules Committee and ah... the Committee met in the ah... State Building and the Rules Committee met in the Capital. And, it placed me in at a decided disadvantage. The ah... Amendment cut out... fifty-seven thousand dollars and the fifty-seven thousand dollars was for a Deputy Director. The present Director is required to go all over the State of Illinois and has no Director traveling more than four hundred miles, it provided for an accountant, the accountant is needed because we are spending Federal money and the Federal Government say we must have an accountant. And, the other one is the Public Education Office, these were required. I



move to Table the Amendment."

Speaker Redmond: "Representative Ryan."

Ryan: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. Ah... Representative Davis, this is not a Committee Amendment, this is my Amendment and I'm not too fond of the fact that you want to Table my Amendment, but in explanation and to ah... speak in favor of the Amendment ah... Mr. Speaker, if I may."

Speaker Redmond: "Proceed."

Ryan: "We have deleted three new positions that were requested by the FEPC for the Administrative Division, for fifty-seven thousand, one hundred and forty-six dollars. Both staffs, the Democate staff and the Republican staff, agreed to those cuts and the Committee put it on, and the Bill couldn't get out of Committee unless it was on. And, so Representative Davis knows what we've done here and what we're trying to do and ah... we don't feel that, that fifty-seven thousand dollars is warranted and that Amendment should stay on that Bill and I would ask for a favorable vote on the Amendment."

Davis: "Mr. Speaker, I would like to...."

Speaker Redmond: "Representative Davis."

Davis: "Mr. Speaker and Ladies and Gentlemen of the House. I know exactly what was done, I didn't want to go into it but the Gentleman has forced me to go into it. I know exactly what was done... I said the Com.... the Amendment was soundly defeated and it was soundly defeated... and I said at the same time, the Rules Committee was meeting and the Gentleman who came over to the State Office Building to help me soundly defeat it went back to the Rules Committee and I said, another motion was made and I think that it was very unfair to wait until my troops left and make another motion. I

say to you... this Deputy Director is definitely needed and Assistant Deputy Director and an Accountant is needed and I say to you, Public Education is needed. This Bill here.... is a bootstrap Bill... and I don't understand why anyone would want to cut a measly fifty-seven thousand dollars from Fair Employment Practice. I just don't understand why you want to do this... Public Aid rolls are mounting.. they ought to be in the city that knocked off seventy million dollars and we stayed here until 6 o'clock, to put it back and I'm going to tell you now, the rolls are mounting and mounting and mounting.... and besides in 1971... in 1971, we amended the Fair Employment Practice, to include discrimination because of sex.... and over 43% of the cases are women and you want this Director to travel all over the State of Illinois, more than four hundred miles, if you please and you don't want to give him one assistant. We're spending Federal money and the Federal Government says, we must have a bookkeeper or they will cut off that money. I'm telling you that this is definitely needed and plead with you to Table that Amendment because it was Tabled in Committee and I think that it's unfair to try to take on... and unfair cut on me when most of the Members who was for it and voted to Table it... and thought the Amendment was Tabled... when they left and came back over here to the State Office Building, the Amendment was put back on. The seeds of Eve... that what you're saying is, that somebody else, including staff is running the Committee on Appropriations... that is not so, it should not be so, this is Federal money involved and we've got to have a bookkeeper or they will take it away from us."

Speaker Redmond: "Representative Tipsword.... Representative



Tipsword... Representative Tipsword, do you seek recognition? Representative Ryan."

Ryan: "Well, thank you, Mr. Speaker and we on the Appropriation Committee feel that the ah... Commissions and the Agencies aren't going to run the Appropriation Committee either. House Bill 38... 3384, contains a hundred and fifty thousand dollars supplemental Federal Funds for this year, Representative Davis and I doubt if your agency can spend it, we're asking for fifty-seven thousand, one hundred and sixty-four dollars, to be cut out of a one million, two hundred and sixty-six thousand, seven hundred dollar appropriation and you absolutely do not need these positions and that money should not be appropriated. And, again I would request that this Amendment be left on this Bill."

Speaker Redmond: "Representative Tipsword."

Tipsword: "Mr. Speaker and Ladies and Gentlemen, I would like to ah... confirm what Representative Davis told to this group. Myself and one other Member of the Rules Committee, Representative Choate ah... was in Rules Committee and the Appropriation Committee too was meeting over in the State Office Building and we were in the Capital Building. And, they were going back and forth, from one building to the other and we were called over there and we went over to vote on this Bill and the Amendment to this Bill and after we had voted and the Amendment ah... we understood it was defeated, we then got called back to the Rules Committee on a pressing matter in Rules and we came back to Rules and I found out, about thirty or forty minutes later that the matter was reconsidered, so what Representative Davis has said in regard to this Amendment ah... so far as the two Members who went back and forth to Rules Committee is absolutely correct."

Speaker Redmond: "Representative... Ready for the question? The question is on the Gentlemans motion to Table Committee Amendment #1, all in favor of Tabling Committee Amendment #1, indicate by saying 'aye', opposed 'no'. I am unable to determine.... all in favor Tabling vote 'aye', those opposed vote 'no'... Representative Ryan."

Ryan: "Mr. Speaker, I would like to point out to this Body that, that's not a Committee Amendment, that's my Amendment and I don't know what to ah... you know, what kind of procedure it is that Representative Davis can move to Table my Amendment."

Speaker Redmond: "Representative Davis."

Davis: "Point of order is, that it was read as a Committee Amendment and the Gentleman is out of order."

Speaker Redmond: "Well, the record shows that it is a Committee Amendment... it shows that it is a Committee Amendment and ah... the Gentleman has moved to Table the Amendment. Have all voted who wished? Representative Mann, do you seek recognition?"

Mann: "No, Sir."

Speaker Redmond: "Representative Youngue."

Youngue: "Ah... I wanted to explain my vote."

Speaker Redmond: "Proceed."

Youngue: "Ah... Representative Davis, has indicated that this is an Agency that has a responsibility for administering some one million dollars, now common sense would say that an agency that has that kind of responsibility, if it is going to be responsible, needs a bookkeeper. This Amendment has to do with hiring a bookkeeper to help this ah... Commission keep the fiscal matters of the Commission straight. We have weight great emphasis during this Session of the General Assembly on fiscal responsibility and it would seem the right reason would



require that we give the FEPC Commission the opportunity to be responsible by giving them a bookkeeper to account for these funds and secondly, ah... as Chairman of the Sub-committee on the status of women minorities in State Government employment is quite clear that the present staffing of the FEPC there would be no way in the world that they could meet their statutory responsibility with the present staff that it has. We feel in Southern Illinois that we are grossly under-hired in State Government and it is very clear that the present Director of the FEPC could not possibly carry his responsibilities all over the State with a staff of less than 100 people, there is no question but that the staff, requested is reasonable, the responsibility is urgent and that this ah... Amendment should not be ah... added to the ah... FEPC Bill and for those reasons I would ask the Members of the General Assembly to reconsider their vote and vote with Representative ah... Davis. There is a statutory responsibility to see there are... there is adequate employment of women in this State, women are.... are grossly ah... kept down in the lower paying jobs and the worse salary jobs and there is just no way in the world the FEPC can handle it's responsibility under its present staff and I will ask you to please reconsider your vote and give these people an opportunity to have their bookkeeper and have Deputy Director so they can live up to ah... their responsibilities in this bicentennial year. We say that we want to be fair, fairness would require.... that we be given an opportunity to do their responsibility. Thank you."

Speaker Redmond: "Representative Skinner."

Skinner: "Well, thank you, Mr. Speaker, I noticed you finally seen that my light was on, now that I'm not at my seat."



Ah... I was rising to ask a question of the Sponsor of Amendment which clearly beyond the point of that I don't want to say anything."

Speaker Redmond: "Representative Jones. Representative Jones."

Jones: "Yes, Mr. Speaker, I had intended to explain my vote but, I have changed my mind."

Speaker Redmond: "Have all voted who wished? Representative Ryan."

Ryan: "Well, at the proper time, Mr. Speaker, I would like to verify the affirmative."

Speaker Redmond: "The Clerk will take the record. The Gentleman has requested a verification of the affirmative Roll Call. Mr. Clerk, will you call the list of the affirmative Roll."

Clerk O'Brien: "E.M. Speaker Shea: "The Gentleman from Cook, Mr. Kelly, wishes to be recorded 'aye', is that correct, Sir. Mr. Madison, you wish to change your vote from... Mr. Madison."

Madison: "Mr. Speaker ah... after the affirmative Roll Call is ah... is verified, but before the results are announced



I would like ah... an opportunity to verify the negative Roll Call, if necessary."

Speaker Shea: "We will accommodate you, Sir."

Madison: "Thank you."

Speaker Shea: "Now, the Gentleman from Cook, Mr. Terzich seeks recognition."

Terzich: "Would you ah... change my vote to 'aye', please."

Speaker Shea: "Mr. Terzich wishes to be recorded as 'aye'. Mr. Londrigan, wishes to be recorded as 'aye'. Mr. McAvoy, wishes to be recorded as 'aye'. Mr. Vitek, wishes to be recorded as 'aye'."

Vitek: "Check."

Speaker Shea: "Oh.... 'no'."

Vitek: "Mr. Speaker, how am I recorded?"

Speaker Shea: "You are recorded as 'no', Mr. Vitek."

Vitek: "Change it to 'aye'."

Speaker Shea: "Change Mr. Vitek, to 'aye'. Mr. Williams... Mr. Williams, wishes to be recorded as 'aye'. Mr. Houlihan, would you go to your microphone... Turn Mr. Houlihan on, please. Mr. Houlihan, I realize you want to vote on this but, I'm wondering if you've got any report on matters that are important?"

Houlihan: "No news... no news."

Speaker Shea: "Record Mr. Houlihan as 'aye'. What's the Roll call, the starting Roll Call, please?"

Clerk O'Brien: "90 'ayes', 69 'nays'."

Speaker Shea: "The Gentleman from Kankakee, Mr. Ryan, has withdrawn his request for verification and Amendment #1, is Tabled. Are there further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker Shea: "Third Reading. On the order of House Bills, Third Reading. On the order of House Bills, Third Reading appears House Bill 3405. The Gentleman from Cook, Mr. Capparelli."



Clerk O'Brien: "House Bill 3405, a Bill for an Act to provide for the ordinary and contingent expense of the Commission Delinquency Prevention. Third Reading of the Bill."

Capparelli: "Mr. Speaker and Ladies and Gentlemen. House Bill 3405, appropriates one million, eight hundred and sixteen dollars and eight hundred.... ah... eight hundred for the ordinary and contingent expense of the Juvenile Delinquency Prevention, for the fiscal year 1976. Any questions?"

Speaker Shea: "The Gentleman from Cook, Mr. Capparelli, moves for the passage for the House Bill 30... 3405, is there debate? The question is, shall House Bill 3405 pass? This is final action, requires 89 votes, all those in favor will vote 'aye' those opposed will vote 'nay'. Shea, 'aye'. Mr. Washburn, could I see you for a minute, Sir. Never.... never. Have all voted who wished? Have all voted who wished? Have all voted who wished? Take the record. Gaines and Geo-Karis, 'aye'. On this question there are 132 'ayes', 11 'nays' and House Bill 30... 3405 is passed. On the order of Third Reading appears House Bill 3410, the Gentleman from Winnebago, Mr. Stubblefield."

Clerk O'Brien: "House Bill 3410, a Bill for an Act making supplemental appropriations for the ordinary and contingent expenses of the Department of Labor. Third Reading of the Bill."

Speaker Shea: "The Gentleman from Winnebago, Mr. Stubblefield."

Stubblefield: "Thank you, Mr. Speaker and this is a supplemental appropriation and as amended it provides six million, four hundred and twenty-eight thousand, seven hundred dollars to pay the unemployment compensation benefits for State Employees. The supplement is required because of the high number of unemployment among



State employees which went in the first quarter from five thousand and six hundred and twenty-two, a fourth quarter is projected at seven thousand, three hundred and ninty-two... it is necessary to reimburse the Federal Government and have us stay in compliance with the Federal Law. And, I would ask for a favorable Roll Call."

Speaker Shea: "The Gentleman from Winnebago, Mr. Stubblefield moves for the passage of House Bill 3410, on the question the Gentleman from Winnebago, Mr. Simms."

Simms: "Mr. Speaker, if the Gentleman from Winnebago...."

Speaker Shea: "He indicates, he will yield."

Simms: "Ah... Representative Stubblefield, you've indicated that part of the reason is... is the high number of State employees that are unemployed for this cost, but isn't it also true that the large increase of the workmens compensation benefits at the Illinois General Assembly inacted last year, is equally, if not more responsible for the increase of cost?"

Speaker Shea: "Turn Mr. Stubblefield on, please."

Stubblefield: "Representative Simms. I would assume that the increase benefits has some cost to... to say that it is equal to greater than.... is a figure that I don't have."

Simms: "Okay, thank you very much."

Speaker Shea: "Mr. Skinner, you wish to ask a question?"

Skinner: "Yes, Sir."

Speaker Shea: "Turn Mr. Skinner on, please."

Skinner: "I would like to know, from the Sponsor if he can answer this and if he can't perhaps we shouldn't even pass the Bill. Why should State Employees should be deem layoff?"

Stubblefield: "I don't have that... figure either, I only have the numbers that are layoff ah... and I think they



can be substantiated but ah... I don't have the reason for that layoff."

Skinner: "You know how many were Republicans and how many were Daley Democrats?"

Stubblefield: "That, again I don't have."

Skinner: "Mr. Speaker, I think I would like to speak against this Bill. The Walker administration has had one of the highest turnover rates of any administration in the history of this State, it's not quite as bad as probably as when President Jackson went to Washington and fired virtually everyone. But, it's pretty bad and I don't think that we bail out the Walker administration for having... for his ability to fire people who are competent and on State payrolls, to replace them with people who were incompetent or had to have on the job training before they became competent."

Speaker Shea: "The Gentleman from Madison, Mr. Byers."

Byers: "Mr. Speaker, I move the previous question."

Speaker Shea: "The question is, shall the main question be put. All those in favor will say 'aye' those opposed 'nay'. In the opinion of the Chair, the 'ayes' have it, the motion carries and Mr. Stubblefield to close."

Stubblefield: "Mr. Speaker and Members of the House. I don't think we ought to get involved in a partisan issue with some idea of making anyone look bad. The affect of not passing this Bill could be one that I think would bring considerable criticism on each of us from employers of the State. There are certain requirements that we should be in compliance with the law and if we are not in compliance with the law, then employers do not receive credit for the payment that they make to the State Unemployment Fund and it also mandates a charge of a 3.2, to the Federal Fund and if you think that you've had a lot of criticism for the increase



benefits to the Unemployment Compensation Act, let's have the Federal Government rule us a non-compliance and employers start paying a 3.2%, plus paying the State Funds, you have heard nothing yet. I would ask a favorable Roll Call, so that we can avoid that kind of situation."

Speaker Shea: "The questions is, shall House Bill 3410, pass. All those in favor will vote 'aye' those opposed will vote 'nay', it takes 89 votes. Shea, 'aye'. The Gentleman from Kane, Mr. Grotberg to explain his vote."

Grotberg: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. I would just like to explain in my 'no' vote, that this is a protest vote over a subject matter that came up out of the Appropriations meeting and may should be informative to all here. Every part-time employee on every short term Federal grant in the State of Illinois, on all of these wonderful grant programs that we've proceed on, so willingly. The State of Illinois itself is vulnerable for their unemployment compensation claims as those grants are completed and everybody on them runs out of work. It was new information to me in appropriations and I thought that we should at least share it with you in the debate on this subject, that every time that somebody runs out of a grant opportunity in the State of Illinois, the State of Illinois and the taxpayers in total bite the bullet in our own payment to compensation claims. Thank you."

Speaker Shea: "Have all voted who wished? Have all voted who wished? Take the record. On this question there are 95 'ayes', 39 'nays', 6 Members voting 'present' and House Bill 3410, is declared passed. Add Mr. Maragos to the Roll as 'aye' and Mr. Rayson to the Roll as 'aye'. Mr. Emil Jones as 'aye'. Committee



Reports."

Clerk O'Brien: "Representative Laurino, Chairman from the Committee on Elections which the following Bills were referred, action taken May 4, 1976, reported the same back with the following recommendation. Speaker Bradley: "The Gentleman from ah... Winnebago, Mr. Giorgi, on the Agreed Resolutions."

Giorgi: "Mr. Speaker, 784 is a Resolution by Capparelli, which notes that St Tarcissus Church held it's 50th Anniversary. House Resolution 785, by Dunn, honors the Illinois Federation of Business and Professional Womens Clubs and the Club is in Murphysboro. I move the adoption of the Agreed Resolutions."

Speaker Bradley: "The Gentleman moves the adoption of the Agreed Resolutions. All those in favor will signify by saying 'aye', opposed 'no'. The 'ayes' have it and
