Acitizen's committee was appointed to assist the Secretary of State with respect to site selection. And I might add, Mr. Speaker, Members of the House, that that contract between the Secretary of State and the Department of Transportation to this date has yet to be entered into. happened? At the present time every motor racing facility in the State of Illinois is in violation of the law and subject to being shut down. One has in fact already been shut down by the Attorney General and that is the Santa Fe Speedway. Ah, the, the, it's in Representative Yourell's district. Ah, there, uh, is approximately \$120,000,000 to the economy of the state of Illinois involved with some 1700 jobs and this Bill needs to be passed, needs to be adopted to provide so...so that all of the motor racing facilities in the state of Illinois can operate legally. Uh, if it isn't they're all in jeopardy and I would the Membership of this Body to support



this Bill."

Speaker Redmond: "Representative Rigney."

Rigney: "Will the Sponsor vield?"

Speaker Redmond: "He will."

Rigney: "As I look at the digest I note that you, or the Senate apparently included an amendment concerning grain elevators. Is that still a

part of this Bill?"

Hart: "Yes, it is, Representative Rigney. That...that was a Senate amendment, uh, and the Bill is still in the same form that it was when

Rigney: "In other words any grain elevator in a town under 2500 population.

Is that basically it?"

Hart: "It would be exempt under this Bill but of course it would still be subject to local ordinance or regulation if there was..."

Speaker Redmond: "Representative Lundy."

EPA before the House Appropriations II Committee about a week ago and

he said that there were proposed regulations before the Board but that

they had not been adopted or not effective. Is that...the case?"

Hart: "No....., they were adopted, Representative Lundy, ah, I believe it was last August and then there was some extensions granted for the enforcement of them which the last extension ran out on February the 10th 1976, and '77, '76 that's right, this year. And what it is, is the...the decibels at the property line level are the ones that apply and, uh, I think present regulations allow some decibels of about .61 which is...hardly above the sound of the human voice."

Lundy: "I don't see in the Bill any definition of the term sporting event.

Uh, would, uh, for...would for example motorcycle racing on city



streets, would that be a sporting event?"

Hart: "No, I don't believe that the regulations apply to city streets or any public property of that way, at least they wouldn't apply on streets. They apply to, uh, to private property."

Lundy: "Well, no but would we be depriving the Pollution Control Board
of authority to regulate, uh, uh, that kind of noise producing
activity at the same time that we took away their authority to regulate auto race track."

Hart: "Well, not eventually, we would be exempting these from the present regulations, ah, that have been adopted but they would have, you know, continuing power that we gave them in the, uh, uh, adoption of the Pollution Control Board Law and certainly they...they might be able to come in with some others and we're still of course, uh, uh, have local ordinances, local controls of these situations is always available to the cities and villages and counties in the case, townships in the case of, uh, uh, outside the corporate limits."

Lundy: "Thank you."

Speaker Redmond: "...Tuerk."

Bill was heard in the House in Committee but could you just briefly

Representative Lechowicz has been misplaced. Where are we?

Amendment what? 411, we're on Amendment #4. Representative Mahar."

Mahar: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House, Amendment #4 is out of order and I'd ask to have it tabled."

Speaker Redmond: "Any objection? Hearing none Amendment #4 is tabled.

Amendment #5."

Clerk Sullivan: "Amendment #5. VanDuyne. Amend House Bill 3411 as

amended in section 1 thereof and so forth."

Speaker Redmond: "Representative VanDuyne. All right, the House please be in order."

| |VanDuyne: "Thank you, Mr. Speaker, Amendment #5 is offered to you because



the administration feels that the cuts were too drastic and we would like to have them reinstated. Now what is, we're trying to put back in our budget \$68,300 which will give us a net reduction in the total budget of approximately \$70,000. Ah, as we all know I'd...but I would like to remind you the Community Services helps mayors and the township supervisors, county officials...and all other local officials all over the state. In fiscal year of 1975 year alone the Community Services helped out local government officials in almost district of this state. A total of 1900 cases of assistance to the individual local governments were completed on...at their request. In the first six months of this fiscal year the Community Service has completed about 750 cases of assistance. There'll be about 1400 more at least that's estimated for the rest of the year. Ah, the Committee's Amendment would cut the casework for local governments in your districts in half. It is estimated that only 700 to 750 of cases of assistance could be performed in the next fiscal year. Also, very little of that work could be done in Chicago and the northern section of the state or southern Illinois because Mr. Lechowicz has explained the cut as intending to eliminate the Chicago and Marion offices personnel as well as one position here in Springfield. Furthermore, the reduction and position is accompanied by a 50% reduction in travel and 44% reduction in auto equipment operation. The Division of Community Services would be unable to serve local government officials throughout the district of the state. Its reduced personnel would be confined to the Springfield office without adequate resources to perform the services it's supposed to provide. The cut in the Community Service budget alone is 27%, this is a crippling cut when you consider that the office has been cut the...two previous years. If you compare the FY74 appropriation of \$349,000 with FY77 request of \$252,000 the cut is already 28% from '74 to '77. If the Committee's Amendment imposing another 27% cut isn't reversed it will result in cumulative cut of 47.3% from '74 to '77. Now this cumulative cut is so extensive that I consider it crippling. Amendment #5 will hold the Community Service Appropriation steady from federal year '76 through



'77 so that they can continue to serve local governments adequately throughout the state. Ah, Mr. Speaker, I ask for a favorable vote on this Amendment. I'd be glad to try to answer any questions if I...if I may."

Speaker Redmond: "Representative McMaster."

McMaster: "Mr. Speaker, Ladies and Gentlemen of the House, I rise in support of this Amendment #5 of Leroy's. I happen to have been closely involved with local government for a number of years prior to coming down here. I do know that the Department of Local Government Affairs has been a very great assistance to local government over the past years and I've seen the quality of that assistance decline as their appropriation for community services has declined over the last three to four years and it's getting to the point where our local governments will...have no place to turn if we...cut this community services down to the point at which the Committee has attempted to do. I would urgently,...urge your support of Amendment #5 to House Bill 3411."

Speaker Redmond: "Representative Reed."

Reed: "Mr. Speaker, Ladies and Gentlemen of the House, I'd like to add my support of Amendment #5 as a former field representative for the Office of Community Services. The Office of Community Services is probably one of the most relevant agencies in state government in providing liaison to all units of local governments in special districts. Now it's been suggested that Legislators should be providing or could provide the necessary liaison and I suggest that this is not so. As an example of the services rendered by this office, they assist small municipalities, units of government with grant applications, fiscal management procedures where there is not a finance manager, sample ordinances that are necessary, encourage cooperation coordination between the various units of government. The real relevancy of this agency is revealed in the kind and the size of the units of local government that are assisted . I don't speak on behalf of municipalities of the size in which I reside where we have a professional business manager, I'm talking about units of government, municipalities, townships, counties where the population may be as



little as 5,000, in fact as small as 200. If these towns who have

not the professional expertise did not have the Office of Community Services to call on it would be a sorry day. They rely heavily upon this office within the Department of Local Government Affairs. I sincerely urge your support for Amendment #5."

Speaker Redmond: "...Bradley."

Bradley: "Well, thank you, Mr. Speaker. Mr. Speaker and Ladies and Gentlemen: of the House I rise to support this Amendment and I am going to
be very brief. I just didn't want the Assembly to think that this
side...those people on that side of the aisle, Mrs. Reed, Mr...Repre-

sentative McMaster, and I appreciate their comments were concerned because I'm also concerned about the services provided by this...by this service to the communities that I represent and the communities throughout the State of Illinois. And I think that the cut that has been suggested here is too drastic a cut to a service, uh, uh, to a community service effort by this department and I'm sure all aware of all the changes we make in the laws down here and this department helps explain those changes to the...to the small communities throughout Illinois as well as the large ones and I urge the down...I urge

all the Members to support this legislation. Thank you."

Speaker Redmond: "Representative Skinner."

Skinner: "This sounds like a eulogy for a department. Uh, could you tell

me how much the budget for the Office of Financial Affairs has been

decreased or increased from this year to last year so I may compare

it with the figures you gave for this office?"

VanDuyne: "The reduction that the Committee suggest, Representative Skinner, ah, in 1976 they were allocated \$1,022,700 and, uh, the Committee

Amendment reduces that by \$29,400 which is 2.9."

Skinner: "Wait a minute, that's the Office of Financial Affairs."

VanDuyne: "That's what you asked for, wasn't it?"

Skinner: "All right, that's ...\$1,022,700..."

VanDuyne: "That's what it says here."

Skinner: "All right and that's '76?"

VanDuyne: "'76"

Skinner: "And what's '77?"

VanDuyne: "Well,...well, it would be 29,400 less, Cal."



Skinner: "Okay, now how much is...how much was the Office of Community

Affairs in '76?"

VanDuyne: "\$252,600."

Skinner: "And how much is it being cut back?"

VanDuyne: "68,300 which is 27%. And you want to couple that with a...a..

the fact that it has been cut in '75 and '74 also. Uh..."

Skinner: "You've answered my question. Thank you very much."

Speaker Redmond: "Representative Lechowicz."

Lechowicz: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House, in listening to Amendment #5 you'd think that we eliminated the entire department. But actually what we're...what we're talking about is a budget request for the Area Community Services and they have 13 people employed over there. What we eliminated were four positions, one administrative assistant 1, one clerk typist 3, one community management specialist 2 and one local fiscal advisor 2. Now it was brought in...testimony in Committee that the function that they were trying to do in Community Services was training and publication activity and then in turn I asked for a copy of the report that they're going to be working on and in turn I asked the distribution that's going to be followed and I guarantee you that we in no way are going to affect that function within a community services budget. And I would strongly recommend...we're talking about general revenue funds and we are charged responsibility of supposedly looking through that budget on a section by section basis in trying to save as much general revenue fund in conjunction with the other fund as possible. That you're going to have to support the work of the Appropriations Committee and in turn, yes, we're going to have to hear a few phone calls from some people as some of the Representatives I think have had in this section. But until ...when you look at the function of the Community Services Area we do not intend nor we...with the Amendment to...to actually phase out the training and publication section as they are charged to do. I would strongly recommend you that cast a no vote because also included in here is a provision for a new automobile and I know Representative VanDuyne talked to me about the necessity of a new auto-



mobile and I know that the Director would like to have a new automobile because of the number of miles that are on that car but I guarantee you that I'm sure it'll last another year.

Thank you."

Speaker Redmond: "Representative Jones."

Jones: "Mr. Speaker, Ladies and Gentlemen of the House, I rise in support of this Amendment. My observation of the performance of this division to the various communities, the contribution to them throughout my district has been very helpful and I...I think it ought to be continued..."

Speaker Redmond: "Representative Totten."

Totten: "Thank you, Mr. Chairman. I rise to concur with the Chairman of the Appropriations Committee. We took a careful look at Amendment #1 when we put it on as to what effect it would have on the Community Services Division. I'd like to point out to the Members of the General Assembly that in addition to what Representative Lechowicz has said, ah, the Community Services Division has long been promoted as one that helps those small units of government which cannot afford the service nor do they have the, ah, technical ability to do so but Community Services has also spent an...an enormous amount of money on big municipalities and in the Chicago and Cook County area there are federal grants that are available to do this and this cut will not in any way impair services to small communities which really what the Community Services portion of this budget was intended for and I would urge a no vote on this Amendment."

Speaker Redmond: "Representative VanDuyne."

VanDuyne: "Well, Mr. Speaker, Members of the House, I'm sure there are plenty of people in this House that were here when this Department of Local Government Affairs had its inception. And you remember that the whole idea of the Department of Local Government Affairs is to go...be...be able to go back to, uh, local governments where they really don't have the expertise readily available at...at their fingertips. And besides that, there's a constant turnover of office holders and they need...they really need help in their budgeting and



their fiscal matters and such and such. ... Now, originally, or I would...shouldn't say originally ....but in 1974 they had 21 people in this department. In 1976 they've been reduced down to 13. Now this reduction would even reduce it further. Now you know that there...there is only humanely possible to do a certain amount of work with a certain amount of personnel. We're not saying that they won't do their publication but what we're saying if this reduction stays in vogue it reduces their capability to do the follow up. It's one thing to have things printed and to distribute them either by mail or whatever but you have to do the follow up work to help these people. Now I realize Representative Lechowicz and Representative Totten are sincere in their efforts to cut the budget, ah, we're going to be almost a half a billion dollars short in revenue, I understand, but the state will not dry up and blow away and we're talking about a measly \$75,000 and we're going to hurt the very people in the small communities that we started out to try to help. And I would ask you, ah, quite sincerely to go on with me on this and restore this money."

Speaker Redmond: "Question is on the adoption of the amendment. All in favor of the adoption indicate by saying aye, opposed no. Chair is unable to determine. All those in favor of the adoption vote aye, opposed vote no. Have all voted who wish? Clerk will take the record. This question 68 ayes, 36 nays and the motion carries and the amendment's adopted. Any further amendments?"

Clerk Sullivan: "Amendment #6. Mahar. Amend House Bill 3411 as amended

by deleting Section 4 and inserting in lieu thereof the following."

Speaker Redmond: "Representative Mahar."

Mahar: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House, Amendment #6 restores some of the funds for the Northeastern Illinois

Planning Commission, Southwest Illinois Planning Commission, the

Capitol City Planning. Ah, this section also has been cut previously,

from last year of \$250,000 to the \$206,000 and Amendment #1 cut

it to \$95,000 as far as Northeastern Illinois Planning Commission

is concerned. Now the function that the NIPC does provide was mandated by this General Assembly 19 years ago, uh, must be continued



and not only...not only are jeopardize...will be jeopardized by a loss if they're...had to work with 95,000 but that would, uh, miminize their ability to get federal funds. Ah, there's been some question about where their...where their money comes from and there was a question in Committee about miscellaneous income. And I'd like to...for the purposes of those who are concerned about that ...list what the miscellaneous income is, it's a \$111,000 basically made up in...in miscellaneous monies come from corporations many times earmarked for private grants, grants for conservation and other projects, it can't be used in federal matching funds, the publication...the sale of publications that the NIPC puts out; interest income on federal grants, uh, while they're being used, and, uh, uh, honorariums that they get for speaking. I think that they give a good account of themselves and I'd urge the adoption of this amendment."

Speaker Redmond: "...Discussion. Representative Lechowicz."

Lechowicz: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House,

I just want to point out that as far as the grant money that is, uh, being asked for in House Amendment #6 to 3411 and the money that was in Amendment #1 is a direct dollar amount that was put through the Bureau of the Budget in review with the Department. And when this amendment was offered in Committee the Department opposed the amendment and in turn they stated you have only x number of dollars in General Revenue, they did not want to hinder any one of these commissions as far as applying for federal funds and they did not. Let me give you a breakdown on Northeastern Illinois Planning Commission: \$501,000 is the amount needed to match federal grants supplied for by NIPC; \$314,000 of local money available for match; \$95,000 is state money from House Bill 3411 as it was introduced; and as, it was pointed out by Representative Mahar a \$119,000 of miscellaneous income and it was provided in testimony in the Committee most can be for matching for federal funds. Therefore, Ladies and Gentlemen, the \$94,000 that is contained in House Bill 3411 is more than sufficient to allow NIPC to match the federal grants applied for. Let. me also point out to the Membership that when we asked for the budget



we...of NIPC and I'd be more than happy to sit down with Representative Mahar as I pointed out in Committee, there's a \$130,000 that we couldn't decide where and for what reason it was used for. Let me go into SIPAC which is the Southwestern Illinois Planning Commission. Again, \$103,000 is the amount needed to match federal grants applied for by SIPAC; \$33,000 is local money available for match; \$50,000 is the money provided for in House Bill 3411; \$13,000 is state money budgeted for SIPAC in excess of amount needed or a total of \$96,000. Ladies and Gentlemen, again we're talking about General Revenue Funds and I would strongly encourage a no vote. Thank you."

Speaker Redmond: "Any further discussion? Representative Friedrich."

Friedrich: "Mr. Speaker, Members of the House, with respect to PAC that...they're...they are in the middle at least of one project on water survey that this money is cut off it will waste the money that's been spent in the last three years. And if it can be continued just one year then it could...it could stand a reduction in the next year so I would urge your aye vote."

Speaker Redmond: "Representative Hudson."

Hudson: "Well, Mr. Speaker and Ladies and Gentlemen of the House, it would seem to me that if there was ever an opportunity to save some money for the taxpayers and State of Illinois, this might, might be one. It would also seem to me to provide an opportunity to curtail the constant growth of these, ah, supervisory agencies such as NIPC and others that are supposed to be supervisory only in their functions but they seem to be ever enlarging in their scope. And furthermore it seems to me that the arguments that constantly advance that we must have more and more money poured into these agencies because if we don't they will not be qualified for federal funds of one kind or another leaves us in the position of letting the federal government dictate the expenditures made at the state level. I feel that this is a dangerous surrender of our control over our budget to the federal government and it might serve as some, uh, lesson perhaps to some if we were to begin to trim back in these areas. I think it's a great opportunity to do so and would urge, uh, uh,



of the amendment. Excuse me, Mr. Speaker, I would urge that this amendment be defeated. I beg your pardon."

Speaker Redmond: "Any further discussion? Question is on the adoption of the amendment. All in favor of the adoption vote aye, opposed vote no. Have all voted who wish? All voted who wish? Clerk will take the record. This question 45 ayes and 73 nays, the motion fails and the amendment is not adopted. Representative Byers.

Wait a minute. Any further amendments on this? Third Reading.
3411."

Byers: "Mr. Speaker, I've...we've all been wondering about Representative

Jim Houlihan and his wife and they have announced the birth of a

baby boy born this morning weight over 9 pounds, so, ah, wish that

Representative Houlihan and his wife, baby."

Speaker Redmond: "Typical of the press corp, Reporter McManus was not to

be outdone and his wife presented him with a baby girl this morning.

Representative Totten."

Totten: "Thank you, Mr. Speaker. ... I rise to object to this committee schedule you circulated for next week. I rise to object on this point. We have attempted in Appropriations I all week to try and get bills out of that committee. With a duplicate committee schedule that you have we are unable to have quorums under the the majority vote rule and we unable to get enough members to hear the testimony on any of the bills that we've had in committee all week because they're in other committees and as long as we're going to keep doing this I think it's the responsibility of the minority members of this House and of the majority to see that we have enough members by not duplicating committee schedules like you have on this schedule for next week if we're conduct business in a logical sensible manner. Now I think the chairman of the Appropriations Committee will concur as will many others that this committee schedule ought to be reviewed for next week so that we can logically go about our business with the necessary number of members in committee to hear bills."

Speaker Redmond: "Representative Shea."

Shea: "Well, Mr. Speaker, Ladies and Gentlemen of the House, as I read



it, on Monday there's only one conflict,...on Tuesday there's eight conflicts as far as the committee schedule goes and that's Executive at 9:30 and that had been scheduled previous. There are two subcommittees on there not full committee meetings."

Speaker Redmond: "Representative Totten."

Totten: "...Yeah, well, that's not the way I read the schedule. Appropriations I and II meets at 9 a.m. and with the bills that they have they are normally in 'til we convene on the floor which is 2 p.m. or whenever it's scheduled for. With that schedule Appropriations I and II conflict with every other committee hearing that's scheduled for that day; and particularly Revenue where a lot of our members are on it."

Shea: "Well, we'll try to be out by 5 o'clock so that you can have your meetings in the evening."

Speaker Redmond: "Representative Duff."

Duff: "Well, Mr. Chairman, Mr. Speaker, I also would like to inquire because it's been a problem for some of our Members, ah, what these expectations are Rules Committee meetings because also have been duplicative of some of the Members scheduling responsibilities and while I'm at it, Mr. Speaker, ah, I would like to join with Representative Totten with extra request and that is when these, ah, committees are scheduling, postponing and rescheduling it's become a big problem to...for many of these committees to have quorums this morning Jud I and Jud II were both hearing when they overlap in membership by 20%. Some of...members are not only on Jud I and Jud II but also on Appropriations. We have members who are members of Judiciary II, Human Resources and Appropriations, all meeting at the same time and it seems to me there ought to be some kind of scheduling so that we don't have members on three...Mr. Speaker, did I get across, did...did you understand what I was trying to say?"

Speaker Redmond: "For the first time, no. We're trying to work this

thing out, Representative Duff. Representative Shea."

Shea: "Well, Mr. Speaker, Ladies and Gentlemen of the House, why don't

we have this as tentative schedule until we get back next week. Or

Monday we will sit down with the leadership on the other side of the



aisle and certainly try to work out an accommodation so that the committees can meet in Appropriations. When we started to put this together we thought there would be more time for Appropriations and not as many bills coming out for other committees. Because we certainly realize that the Appropriation Committees need more time than they're getting. So we will leave this as a tentative schedule until next week, Monday afternoon or Monday morning we'll meet with Mr. Washburn and try to work out something that will accommodate both sides of the aisle."

Speaker Redmond: "Representative Katz."

Katz: "Ah, Mr. Speaker, there doesn't appear on the list but the House Rules Committee will be meeting on Tuesday and Wednesday and possibly Thursday in the morning on those days from 9 a.m. to noon in Room 118 here in the Capitol Building to consider the motions of members who desire to have their bills exempt."

Speaker Redmond: "Representative Choate."

Choate: "Well, Mr. Speaker, I understand that it's really tough to arrange committee meetings to the satisfaction of everyone however there is one thing that could be done where you have a duplication of meetings which I have suggested in the past. You take Representative Lundy,

Tipsword and myself as an example trying to go from Appropriations II to Rural at the same time, it's physically impossible when the committees meet so far apart. There rooms, if they are scheduled correctly Mr. Speaker, if you'll listen just a second..."

Speaker Redmond: "Representative..."

Choate: "There are rooms adjacent to each other where it would make it feasible and possible for the members to coordinate their committee meetings. As an example, Rule...Rules is meeting in 118, if I understand Representative Katz correctly, Appropriations II is on the House floor and Room 120, I believe it is right adjacent to 118, I don't see anything meeting there, the Rules and Appropriations could meet in those two rooms and it would facilitate the activities of at least three members and when Appropriations I is meeting 114 you've got Executive clear over in the other building, it's physically impossible for those committee members to traverse from one building



to the other in...attempt to make the roll call. What needs to be changed as far as the schedule is concerned is to coordinate the committees with conflicts in rooms that are adjacent or at least close to each other."

Speaker Redmond: "Big problem, of course, is that we only have I believe three rooms assigned to the House and the balance is the Senate.

And the Senate refuses, they think they may have..."

Choate: "Got more rooms than three, Mr. Speaker, you've got four right down there on one."

Speaker Redmond: "Three large ones."

Choate: "Rules doesn't take that big of a...120 could hold Rules and certainly 118 holds, uh, uh, 118 holds Appropriations II."

Speaker Redmond: "Well, we'll do that, as Representative Shea says we'll come in Monday and we'll do the best we can to try to accommodate it...part of the difficulty of course is that we probably shouldn't have anybody Appropriations probably shouldn't be on any other committee but...Committee Report."

Clerk Sullivan: "Representative Boyle Chairman from the Committee on
Appropriations II to which the following bills were referred. Action
taken on May 13, 1976 reported the same back with the following
recommendations. Do Pass Senate Bill 1611. Do Pass as amended

House Bill 3377 and Senate Bill 1609."

Speaker Redmond: "...Shea. ...Agreed Resolutions."

Clerk Sullivan: "House Resolution...814. Ron Hoffman. House Resolution,

813, Riccolo. House Resolution 810, Hoffman. House Resolution 811, Hoffman. House Resolution 812, Hoffman."

Speaker Redmond: "...Giorgi."

Giorgi: "Mr. Speaker, House Resolution 810 commends William Halberg on 22 years in elementary education. House 811 by Hoffman again commends Catherine Madison for the...for the same work. House Resolution 812 by G. L. Hoffman, commends Blanche Leslie for 27 years in that work. House Resolution 813 by Riccolo commends Leo Virden for 40 years of service to the Knights of Columbus and House Resolution 814 by R. K. Hoffman commends Chief Illiniwek for 50 years of service to the University of Illinois. I move for the adoption of the



Agreed Resolutions."

Speaker Redmond: "Representative McGrew."

McGrew: "Thank you very much, Mr. Speaker. I would...just wanted to double check a minute. You know we passed one rather unanimously to Roscoe Cunningham that said all the kids had to go to the University of Illinois and I caught all kinds of static being in Galesburg and the home of the Silverstreak, ah, Representative Giorgi just read one that said we're commending some gentleman on 22 years of elemnatary education. Has he been in school that long or...oh, teaching, thank you."

Speaker Redmond: "Question is on the adoption of the Resolutions. All
in favor indicate by saying aye. Aye. Opposed no. The ayes have
it. The Resolutions' adopted. Representative Shea."

Shea: "Mr. Speaker, I move that the House now adjourn until 10 o'clock tomorrow morning."

Speaker Redmond: "YOu've heard the motion, all in favor indicate by saying aye. ..."

Shea: "Mr. Speaker, I think Mr. Taylor has an announcement."

Speaker Redmond: "Let's stand at ease for two minutes until we find

Representative Taylor's motion. Committee Reports, is that it, Jim?"

Clerk Sullivan: "Representative Chapman, Chairman from the Committee on Human Resources to which the following Bills were referred. Action taken on May 13, 1976 reported the same back with the following recommendations: Do Pass House Bill 3834, 3835, 3836, 3837, 3838, 3853, 3854, 3855. Do Pass as amended House Bill 3222."

Speaker Redmond: "Representative Geo-Karis."

Geo-Karis: "Mr. Speaker, did I hear the Honorable Majority Leader correctly,

we are in Regular Session tomorrow at 10 a. m.?"

Speaker Redmond: "No."

Geo-Karis: "He didn't say perfunctory that's why I asked."

Speaker Redmond: "Representative Shea."

Shea: "At the time the Adjournment Resolution was adopted by Mr. Madigan when we started he informed the House that when we adjourn today we would go in Session tomorrow until Perfunc and then at time the adjournment at Perfunc at what time we would be back in on Monday."



Geo-Karis: "Thank you."

Speaker Redmond: "Motions."

Clerk Sullivan: "Motion pursuant to Rule 18K I move to suspend the votes requirement...Rule 18...relation to the following Bill: Committee on Cities and Villages, House Bill 3908, Representative Taylor."

Speaker Redmond: "Representative Taylor."

Taylor: "Mr. Speaker and Members of the House, I...like unanimous consent
of the House to bypass six and a half day posting in order that we
might hear...House Bill 3908 in Cities and Villages on Tuesday. I
have cleared this both side of the aisle and I solicit your support."

Speaker Redmond: "...Gentleman have leave? Use...Gentleman have leave to

use the attendance roll call on the motion? Hearing no objection the

attendance roll call will be on the motion. Representative Shea."

Shea: "I now remove my...renew my motion to adjourn until 10 o'clock a.m. tomorrow morning for a perfunctory session and the House will return to plenary session on Monday, at 2 p.m."

Speaker Redmond: "Question is on the adoption of the resolution. All in favor indicate by saying aye. Aye. Opposed no. The ayes have it.

The House stands adjourned."
