Duff: "I've been trying to get your attention for the last ten or twelve Bills, Mr. Speaker. Ah... looking at the Digest, I don't see the ah... action taken on these Bills that we've been going through referring 'em to Committee. Ah... in almost every one of

the last set, it simply lists them as a Committee Bill and gives no legislative history at all, doesn't refer to Second Reading.

Ah... we have nothing at all to go on. Moreover, ah... some several Bills back when we were on ah... 3833 which came before this set of Committee Bills, ah... there is a cryptic set of comments on May 12 ah... the Bill was apparently ruled emergency, recalled, referred to Committee on Assignment and a motion filed to discharge Committee, all on May 12, the Committee discharged on May 13. And... it seems to me that that was a Bill which it might of been appropriate for us on Second Reading to inquire of the Sponsor why this Bill received that particular kind of treatment.

Now that is apparently untimely now, although, Mr. Speaker, I have had my light on since that Bill was called and haven't been recognized. Now..."

Speaker Redmond: "I think your first analysis of the comment is untimely.

Now is probably correct."

Duff: "Well, Mr. Speaker, it seems that since I put my light on at the time, it would be appropriate for you, sir, to tell us when it might be appropriate to make that inquiry."

Speaker Redmond: "Representative Shea."

Shea: "Mr. Speaker, House Bill 3833 by Mr. Bradley deals with the
Bill on the prosecutorial council that was passed by this Assembly.

At that time, one of the things that that council had done prior
to the time it became a state entity, was to fund approximately
100 summer law students to work with the State's Attorneys throughout the state. There was... they had already committed themselves
to do that and thought it was within the purview of the act when
the Comptroller informed Mr. Hutchinson, the Executive Director
of that Committee that he did not think the language of the act was
broad enough to cover the hiring of summer law students for the
prosecutors throughout this state. That is the language change
that is in 3833. Mr. Bradley made a motion the other day to take
it from the Committee on Assignments where it rested and placed
it on the order of Second Reading, Second Legislative Day, so that
it could be moved along speedily and that was done by over 107



Members of this House by a motion from the floor by the Minority...

Majority Whip, Mr. Bradley."

Speaker Redmond: "Representative Duff."

Duff: "Well, Mr. Speaker, addressing myself to that question, I have asked two, but addressing myself to that question; my point was, I tried to be recognized when that Bill was called on Second Reading so I could ask the Sponsor of the Bill, I'm sure the Majority Leader is familiar with all of the Bills on the Calendar, but I wanted to ask the Sponsor of the Bill why that Bill required such favored and special treatment that it can be moved from Rules Committee to Assignments and motion to discharge ah... and Committee discharged all within 24 hours."

Speaker Redmond: "Representative Shea."

Duff: "The doesn't strike me as being that crucial and I would like to have asked the Sponsor on Second Reading why that favored treatment was accorded to that Bill."

Shea: "It did not get from Rules Committee to the Calendar. It went from the Committee on Assignment. It was voted out of Rules Committee and was then in the Committee on Assignments. The reason for it is a number of the Deans of Law School have called various leaders and informed them that there are a number of students who are dependent on that program for summer employment and if it is not passed, they have a rumber of people that will have to find other employment so they can continue with their education, sir."

Duff: "Mr. Speaker, was Representative Washburn informed of this?"

Shea: "Yes, sir."

Duff: "All right, then my next question, Mr. Speaker, which I also ask is, we have just read through a whole series of Bills which are listed as Committee Bills, but we're not given any of the legislative history of hearings or anything else on those Bills. Is this going to be a new order on the Digest or what?"

Speaker Redmond: "What, what is the Digest that you're looking at?"

Duff: "May 14."

Speaker Redmond: "Are you sure?"

Duff: "It's right in my hand, sir. May 14, 1976, Volume II. I would address you for example to ah... pages 966 on through a number of these Bills that we have just handled. For example, right now we're



on... as I look at the Calendar, we handled 3854 which was Human Resources Committee and all it gives us... excuse me ah... let me withdraw this. I'll show it to the Parliamentarian what I mean. To save some time, Mr. Speaker."

Speaker Redmond: "The question that occurs to me, are these... these
were reported out ah... last Friday, were they not? Thursday.

Any Amendments from the floor on 3871?"

Clerk O'Brien: "No Amendments."

Speaker Redmond: "Third Reading. Senate Bills, Second Reading. On Senate Bills, Second Reading appears 1... Senate Bill 1611."

Clerk O'Brien: "Senate Bill 1611. A Bill for an Act to provide for the ordinary and contingent expense of the Military and Naval

Department. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "None."

Speaker Redmond: "Third Reading. Representative Geo-Karis, do you seek recognition?"

Geo-Karis: "Yes ah... I just want to know there was a Bill passed in

Human Resources on Thursday. Now if it came up Friday, it's a

perfunctory Session, Mr. Speaker, ah... then it would be at Second

Day on today, would it not? On the Second Reading?"

Speaker Red lond: "Well, that's pretty 'iffy'. Anything that would have been reported or normally it would of had Second Reading,

First Legislative Day on Friday. We moved it along to Second

Reading today."

Geo-Karis: "Okay, and the Third Reading on ah... of the Second... ah...
would it stay on Second Reading for three days, Mr. Speaker?"

Speaker Redmond: "No, we..."

Geo-Karis: "Two days?"

Speaker Redwond: "By leave of the House, we advanced everything that came out Friday so that it would be on House Bills, Second Reading today."

Geo-Karis: "Cause I have Amendments on a Bill, Mr. Speaker. Thank you."

Speaker Redmond: "Well, has it been called on Second Reading?"

Geo-Karis: "I'd like to have point of information on ah... this Bill."

Speaker Redmond: "Which Bill is it?"

Geo-Karis: "I'll tell you in a second, Mr. Speaker, because ah..."

Speaker Redmond: "Which Bill is it?"

Geo-Karis: "It's 3853."

Speaker Redmond: "Well, okay, we'll request the Sponsor to return that

to Second Reading for the purpose of an Amendment when the time

comes. Representative Grotberg."

Grotberg: "Yes, Mr. Speaker, on that whole series of ah... Human

Resources Bills, it seems to me that they were... there were some

of those that were to go back to Human Resources. They came out

to get a number on them as Committee Bills."

Speaker Redmond: "When the Sponsor arrives, why, we'll discuss it with her."

Grotberg: "Yes, in the interest of everybody, I think they should not be called until we have a little talk on that whole series. Okay?"

Speaker Redmond: "Well, they're on Third Reading now, but when she comes back in again, there'll be no problem about returning it to Second Reading, I can assure you of that. Senate Bills, Second Reading 1638. 1611 goes to Third Reading. 1638."

Clerk O'Brien: "Senate Bill 1638. A Bill for an Act to amend Sections of an Act to provide for the ordinary and contingent expense of the Department of Local Government Affairs. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "None."

Speaker Redmond: "Third Reading. 1921."

Clerk O'Brien: "Senate Bill 1921. A Bill for an Act to provide for the ordinary and contingent expense of the Office of State Treasurer.

Speaker Redmond: "Any Amendments from the floor?"

A Bill for an Act making an appropriation for the ordinary and contingent expense of the Legislative Reference Bureau. First Reading of the Bill."

Speaker Redmond: "Representative Ryan."

Ryan: "Well, thank you, Mr. Speaker. I would like to ask a question of the Chair. We have Bills that came out of Committee last Thursday were read in perfunct on ah... here on ah... Friday and have now been moved to Third Reading fifteen minutes after we're in Session. That's a terrible way to do business, Mr. Speaker. If need be, I may have to question a quorum. I don't know. I think that that's certainly unfair and ah... there are some of these Bills that some people wanted to put some Amendments on 'em, talking about the Committee Bills specifically and ah... feel that you ought to back that thing up a little bit and ah... redo this some way."

Speaker Redmond: "Well, I have assured the Membership that anything that has been moved to Third Reading now, that when the Sponsors arrive, if there's any problem or if anybody comes up and indicates they want to put an Amendment, that we will remove... put 'em back to Second Reading. I would just like to remind the Gentleman that this House adopted a Resolution that we would convene at two o'clock today."

Ryan: "Here I am."

Speaker Redmond: "And it's not my fault that the... some people may not be ready to proceed with the business of the House."

Ryan: "Well, ah... that's not the problem, Mr. Speaker. The problem is that you... that Friday, we weren't in Session and the Bills were read, the Committee Bills and are now being put on Third Reading today, fifteen minutes after we're here to look over this



Calendar."

Speaker Redmond: "I think the House should be commended for its dispatch."

Ryan: "Well, I think so, too, if that's... if that's the way you're going to operate it, is ram all this stuff down our throat again to meet your schedule, but I think it's certainly an unfair practice."

Speaker Redmond: "Your objection is noted. Representative Kempiners."

Kempiners: "Pursuant to the questions that Representative Ryan addressed the Chair, I gather that all we're going to be able to do is object and I think that I'd like to add mine ah... my objection too because there's one Bill that was advanced that was voted out of a Committee as a Committee Bill with witnesses present who were not permitted to testify when that occurred. Now it's true that they came back a week later when the Bill itself was heard in the Committee and testified, but I don't think that acting in dispatch is the same as railroading which is occurring with at least this one particular Bill that I'm familiar with and ah... while I recognize the fact that apparently you're not going to recognize the objections we're making, I would like my objection to be ah..."

Speaker Redmond: "Representative Shea."

Shea: "Well, Mr. Speaker, if any Member has any of those Bills that
are now on Third Reading, has Amendments for 'em and would like
to file 'em, I will do everything I can to support them to get
those Bills back to Second Reading so those Amendments can be heard."

Speaker Redmond: "Representative Schraeder."

Schraeder: "Mr. Speaker, Members of the House, I'd like to commend the Speaker for starting on time. It's a novelty to see the House functioning like it should. Speaker's to be commended."

Speaker Redmond: "May, may the Members just be sure that if anybody
has an Amendment to any of those Bills, all you have to do is to
bring it up here and I have assured you that we will bring it back
to Second Reading and permit... either move to amend the Bill. Now
the only ones we called were the ones that as far as we knew, did
not have any Amendments proposed. And nobody will take any advantage



of you. If you have your Amendment, bring it up here and we'll see that it's returned to Second Reading. Representative Ryan."

Ryan: "Thank you, Mr. Speaker. My, my problem is not that. It's the fact that we've only had about fifteen or twenty minutes, thirty minutes at the most since we went into Session here to, to look at these Bills and have Amendments drafted for 'em. Now if you want Amendments in the next fifteen or twenty minutes, I don't think that's possible. If you'll guarantee us they won't be moved to tomorrow on Third till we get some time to draft some Amendments to it, I think that would be a reasonable proposal."

Speaker Redmond: "Well, get your Amendment here and... I didn't say that it had to be done today. We don't want to take any unfair advantage of anyone. If you have an Amendment that you want submitted, why, just bring it up."

Ryan: "Well, as soon as we have an opportunity to figure out what they...

what the Bills are, Mr. Chairman, we'll have the Amendments."

Speaker Redmond: "Okay. Senate Bill, First Reading.".

Clerk Selcke: "Senate Bill, First Reading. Senate Bill 1613. An Act to provide for the ordinary and contingent expense of the Board of Vocational Rehabilitation. First Reading of the Bill. Senate Bill 1612, Madison. An Act making a supplemental appropriation for the ordinary and contingent expense of the Board of Vocational Rehabilitation. First Reading of the Bill."

Speaker Redmond: "House Bills, Second Reading. On House Bills, Second Reading appears House Bill 3036."

Clerk Selcke: "House Bill 3036. An Act to repeal the Chicago Regional
Port District Act. Second Reading of the Bill. One ah... Committee
Amendment. Amends House Bill 3036 on line 1 by deleting the
word 'repeal' and so forth."

Speaker Redmond: "Representative Taylor. Representative Taylor, House
Bill 3036. Representative Taylor."

Taylor: "Mr. Speaker, would you please take it out of the record.

There's a few Amendments been drafted for that particular Bill."

Speaker Redmond: "Take it out of the record. 3222."

Clerk Selcke: "House Bill 3222. A Bill for an Act to add Section 5A to and amend Section 5 to an Act creating the Department of Children



and Family Services and so forth. Second Reading of the Bill.

One Committee Amendment. Amends House Bill 3222 on page 3 of

lines 22 through 24 and so forth."

Speaker Redmond: "Representative Grotberg."

Grotberg: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House, the Amendment to House Bill 3222 reinstates in part the language of the Governor's amendatory veto that was so complicated on this same Bill a year ago which ah... mandates the Department of Children and Family Services to now negotiate for 100% of reasonable costs and have written contracts to private agencies who have cus... who have care for state wards under the Department of Children and Family Services. It's an Agreed Amendment, Mr. Speaker.

Mr. Speaker, this truly is an Agreed Amendment."

Speaker Redmond: "The Gentleman has moved the adoption of Amendment #1.

Any discussion? The question's on the adoption of the Amendment.

All in favor indicate by saying 'aye', opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments? No further Amendments? Third Reading. 3229. Representative Neff on the floor? Who's the Sponsor of the Amendment on that one?

Representative Daniels on the floor? What Committee is that?

Representative Londrigan on the floor? 3229, is there Committee

Speaker Redmond: "Representative Londrigan."

Londrigan: "That was just to make the proper change. The wrong Section was cited of the statute and they cited the proper Section in the Amendment. There's no opposition."

Speaker Redmond: "Any discussion? The question's on the adoption of the Amendment. All in favor indicate by saying 'aye', opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments? No further Amendments? Third Reading. 3294. Representative on the floor? What's that Amendment? Representative Lechowicz."

Clerk Selcke: "House Bill 3294. A Bill for an Act making an appropriation to the Department of Conservation. Second Reading of the Bill. One Committee Amendment. Amends House Bill 3294 on page 1 by deleting lines 5 through 8 and so forth."

Speaker Redwond: "Representative Lechowicz."

Lechowicz: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House.

Committee Amendment #1 reduced the request of \$50,000 to \$25,000

and it deletes the reference for the Department of Conservation

to acquire the Jarrett Mansion property of the State Memorial.

It does provide for the Department of Conservation to develop and

restore the property and I move for adoption of Committee Amendment

Speaker Redmond: "Representative Duff."

Duff: "Mr. Speaker, it doesn't appear to us that the Sponsor of this Bill is on the floor."

Lechowicz: "Well, Mr. Speaker, maybe I didn't hear ah...make myself



clear. This was an Agreed Amendment with the Sponsor and the Membership of Appropriations I."

Speaker Redmond: "Questions on the adoption of the Amendment. All in favor indicate by saying 'aye', opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?

Third Reading. 3376."

Clerk Selcke: "House Bill 3376."

Speaker Redmond: "Representative Chapman."

Clerk Selcke: "A Bill for an Act..."

Speaker Redmond: "Out of the record at the request of the Sponsor.

3377."

Clerk Selcke: "House Bill 3377. A Bill for an Act to provide for the ordinary and contingent expense of the Department of Mental Health and Development Disabilities. Second Reading of the Bill."

Speaker Redmond: "Whose Amendment is it?"

Clerk Selcke: "Amendment #1 is Gene Barnes. He's here."

Speaker Redmond: "Representative Barnes."

Clerk Selcke: "Amendment #1. Amends House Bill 3377 by deleting all of Section 1 and inserting in lieu thereof the following."

Speaker Redmond: "Out of the record? Out of the record. Representative Getty here? 3379. Out of the record. 3403. Who's Amendment is it? Amendment's not printed. Out of the record. 3485,

Representative McMasters on the floor?"

Clerk Selcke: "House Bill 3485. A Bill for an Act to amend the Revenue
Act of 1939. Second Reading of the Bill. One Committee Amend-

ment. Amends House Bill 3485 page 1 by deleting all of line..."

Speaker Redmond: "Representative McMasters, you're indicating you want that out of the record, is that correct?"

McMaster: "Yes."

Speaker Redmond: "How about 3486?"

McMaster: "I want those two out of the record. I thought we were on ah... 3586, I'm sorry, Mr. Speaker. I'm ready to move 3586 when you get to it."

Speaker Redmond: "We'll get there. 3489. Oh, 3586 we moved already.

There were no Amendments. 34... Out of the record at the request of the Sponser. 3541."



Clerk Selcke: "House Bill 3541."

Speaker Redmond: "Out of the record at the request of Mr. Ryan.

3575... 3795. Will the Lady from DuPage stop bothering the Lady from Cook. 3795."

Clerk Selcke: "House Bill 3795. A Bill to provide for the ordinary and contingent expense of the Sudden Infant Death Syndrome Study Commission. Second Reading of the Bill. One Committee Amendment.

Amends House Bill 3795 on page 1, line 5 by deleting 6,000 and inserting in lieu thereof 4,500."

Speaker Redmond: "Representative Macdonald."

Macdonald: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House,

I offered this Amendment in Committee because this Committee...

this Commission has been very careful and very frugal with its
appropriation and has turned back consecutively since its ah...

beginning, money that was granted to it. So we have reduced the
appropriation to \$4,500 and I would recommend that we accept the
Bill in this manner."

Speaker Redmond: "Any discussion? Representative Duff. You don't seek recognition. Okay, questions on the adoption of the Amendment. All in favor indicate by saying 'aye', opposed 'no'. The 'zyes' have it. The Amendment's adopted. Any further Amendments?

No further Amendments, Third Reading. 3814."

Clerk Selcke: "House Bill 3814. A Bill for an Act in relation to the merit systems for sheriffs, personnel in certain counties. Second Reading of the Bill. One Committee Amendment. Amends House Bill 3814 page 1, line 25 and so forth."

Speaker Redmond: "Who's the Sponsor of the Amendment? Representative
Kempiners. Representative Yourell. Representative Kempiners on
the Amendment. Representative Yourell. Okay..."

Kempiners: "Buz, this is the Amendment that ah... was defective, so I would ah... I talked to Representative Yourell on this and I would move that we table House Amendment #1."

Speaker Redmond: "Any objections? The Gentleman's moved to table

Amendment #1. Does he have leave? Hearing no objections, Amendment #1 is tabled."

Clerk Selcke: "Amendment #2, Kempiners. Amends House Bill 3814 on page 1



and so forth."

Speaker Redmond: "Representative Kempiners."

Kempiners: "Mr. Speaker, Amendment #1 is a correction to make explicit what is implied in the Bill. And the Committee Members when this was brought before them, asked for this... that this Amendment be drafted and I would move its adoption."

Speaker Redmond: "Questions on the adoption? All in favor vote 'aye' or indicate by saying 'aye', opposed 'no'. The 'ayes' have it. the Amendment's adopted. Any further Amendments? No further Amendments, Third Reading. 3819. Out of the record the request of the Sponsor. House Bills, Third Reading. House Bills, Third Reading appears House Bill 3217. Representative Friedrich."

Clerk Selcke: "House Bill 3217." Speaker Redmond: "Yeah, sure. 3217."

Clerk Selcke: "A Bill for an Act to amend Section 1 of an Act to

tax gift legacies and inheritance transfers and so forth. Third

Reading of the Bill."

Speaker Redmond: "Representative Friedrich."

Friedrich: 'Mr. Speaker and Members of the House, this is a Bill to give some additional benefits to the surviving spouse for inheritance tax. It was amended on Second Reading to limit the benefit in any one inheritance tax return to \$400. In other words, it would take care of the little people and ... and where they had a large estate, they would not get credit for the larger amount. I have before me a letter from the ah... Mr. Riggs, the Assistant Attorney General inthe Inheritance Tax Division. And they have made a survey based on ah... the returns and they say that the loss in revenue for the year 1970 would not be more than two million dollars and their estimate is it would be about a million and a half. Ah... This is identical to the Bill that was passed by substantial majority in the Regular Session except this Amendment would limit the credit to \$400 which would make it ah ... as it was originally designed to help those small estates where it will not ah ... have to file returns under this thing. It's long overdue. The... this exemption has not been changed since 1906 and it's an effort on the part of the ninety... now ninety-five Sponsors



in the House to ah... help those people who've endeavored to save and have a little money and stay independent. Ah... I hope there's 95 people on the floor here, but I encourage your support."

Speaker Redmond: "Any discussion? The question is shall this Bill pass. All in favor vote 'aye', opposed vote 'no'. Have all voted who wished? Clerk will take the record. On this question there are 130 'aye', and no 'nay' and the Bill having received the Constitutional majority is hereby declared passed. 3301."

Clerk Selcke: "House Bill 3301. A Bill for an Act authorizing the Secretary of Transportation to convey certain real property in Winnebago County to Winnebago County. Third Reading of the Bill."

Speaker Redmond: "Representative Giorgi on the floor? Representative Giorgi, closing fast."

Giorgi: "Mr. Speaker, all this Bill does is it authorizes the Secretary of Transportation, State of Illinois, to convey 1.4 acres of real estate to Winnebago County and all the principles agreed that it's ah... a fair price and it's from a formal F.A.P. program that ah... that ah... was executed and now they don't need the land. Ryan: "And how much ah... how much money are you going to get for it?"

Giorgi: "\$9,350."

Ryan: "How much did we give for it?"

Giorgi: "How much did we give?"

Ryan: "Yeah, when we had it ... "

Giorgi: "I think we gave half of that, \$4,300."

Ryan: "I see."

Giorgi: "But the people ah..."

Ryan: "The Department of Transportation, is that..."

Giorgi: "...County of Winnebago."

Ryan: "Thank you."



Giorgi: "I'm not involved at all."

Speaker Redmond: "Representative Duff."

Duff: "Mr. Speaker, I'd just like to point out that the ah... Digest says 1,418 acres."

Giorgi: "That would be the biggest swindle since the state was incorporated."

Duff: "You said it, sir. I didn't."

Speaker Redmond: "Any discussion? The question is shall this Bill pass. Those in favor vote 'aye', opposed vote 'no'. Have all voted who wished? All voted who wished? Clerk will take the record. All voted who wished? The Clerk will take the record. On this question there's 100 'aye', no 'nays'. The Bill having received the Constitutional majority is hereby declared passed.

Clerk Selcke: "House Bill 3329. An Act to leave the requirements of annual information returns from the Service Occupation Tax Act, the Retailers Occupation Tax Act and Hotel Operators' Occupation Tax Act. Third Reading of the Bill."

Speaker Redmond: "Represenative Birchler."

Birchler: "Thank you, Mr. Speaker and Members of this General Assembly.

This is the Bill that eliminates the paperwork in the sales tax division by changing 3 Sections in the law so that you do not have to make that annual report. The Department now has sophisticated equipment that they can gather this information without this annual report. I have word ah... here from Willard Ice, who is the Manager of regulations and hearings, I think most of you know him, who approves of this action. So I ask that all of you give this an 'aye' vote on this particular Bill."

Speaker Redmond: "Representative Geo-Karis, do you seek recognition?

Representative Friedrich, do you seek recognition? Any discussion?

The question is shall this Bill pass. All in favor vote 'aye',
opposed vote 'no'. Have all voted who wished? All voted who
wished? Clerk will take the record. On this question there's
104 'aye', no 'nay'. The Bill having received the Constitutional
majority is hereby declared passed. 3382 being held at the request
of the Sponsor, is that correct? 3411. Representative Washington."



Washington: "Mr. Speaker, since ah... House Bill 3382 is incorporated into House Bill 3821, I therefore move to table... ask leave to table House Bill 3382."

Clerk Selcke: "House Bill 3556. An Act authorizing the Director of

Speaker Redmond: "Representative Schraeder. Schraeder, out of the record. 3559."

Clerk Selcke: "House Bill 3559, Madigan. An Act to amend Section 9.6A of an Act to create Sanitary Districts and so forth. Third Reading of the Bill."

Speaker Redmond: "Representative Madigan. Out of the record. 3624.

Representative Dyer."

Clerk Selcke: "House Bill 3624."

Speaker Redmond: "Out of the record. Representative Schraeder, for what purpose do you rise?"

Schraeder: "Can I get 3556 now?"

Speaker Redmond: "Ready to go on 3556? House Bill 3556."

Clerk Selcke: "House Bill 3556. Authorized... an Act authorizing the

Director of General Services to contract to sell and convey cer
tain real property. Third Reading of the Bill."

Speaker Redmond: "Representative Schraeder."

Schraeder: "Mr. Speaker, Members of the House, this Bill was introduced at the request of the majority of the Peoria State Hospital Land Use Study Commission and it authorizes General Services to sell the ah... Peoria State Hospital facilities to the highest bidder over the minimum bid of one million dollars and I would ask the adoption of... passage of House Bill 3556."

Speaker Redmond: "Any discussion? The ques... Representative Ryan."

Ryan: "Will the Sponsor yield?"

Speaker Redmond: "He will."

Ryan: "Representative Schraeder, how much is the Illinois Building



Authority... do we still owe them on this?"

Schraeder: "Pardon, sorry, I didn't hear you."

Ryan: "How much money does the state owe the Illinois Building Authority?"

Schraeder: "\$480,000 and that's the reason why I ask for a minimum bid of a million."

Ryan: "You're going to ask for a minimum bid of a million, leave you

a half a million, is that right after you pay off your debt?"

Schraeder: "Yes."

Ryan: "What was the appraisal value?"

Schraeder: "The appraisal was \$240,000 and that included the cost of demolition, \$240,000."

Ryan: "Wait a minute, you're telling me it was appraised for \$240,000 and you got somebody's going to pay to pay a million dollars for it?"

Schraeder: "There's a... we paid 'em a hundred thousand dollars for the appraisal and that's what they come up with."

Ryan: "You paid a hundred thousand dollars to get an appraisal on a \$240,000 piece of property?"

Schraeder: "That is correct."

Ryan: "And now you think you're going to get a million dollars for the property?"

Schraeder: "We've already been offered a million dollars."

Rvan: "Thank you."

Speaker Redmond: "Repre..."

Schraeder: "Representative Ryan, if you'd like, we'll reopen it and you can close Kankakee."

Speaker Redmond: "Representative Tuerk."

Tuerk: "Well, Mr. Speaker, Members of the House, there was a question asked about the appraisal of the land. I would like the Membership to be clear on the fact that the \$240,000 appraisal represents the net amount minus the demolition costs which ran up around six hundred and some odd thousand. So, actually make no mistake about it, the land and the current holdings are worth upwards to a million dollars and that's why Representative Schraeder has had incorporated in part of the Bill. I think if I may ah... mention the fact, Representative Schraeder, I think he mentioned



a hundred thousand dollars for the appraisal."

Schraeder: "Yes, that was the appropriation."

Clerk O'Brien: "Representative Bradley in the Chair."

Schraeder: "Speaker, just ask for a favorable vote. It's really noncontroversial."

Grotberg: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House.

Chapman: "Mr. Speaker and Members of the House, I move for ah... concurrence with ah... Senate Amendment #1 to House Bill 3213. This has the effect of removing an Amendment which was placed ah... on the Bill in Appropriations Committee. I have ah... checked with the people involved and this is satisfactory with ah... all of them. So, I would ask for your favorable vote."

Speaker Bradley: "The Lady moves that the House will concur in Senate

Amendment #1 to House Bill 3213. All in favor will signify by

voting 'aye'.... I'm sorry, Mr. Ryan, the Gentleman from Kankakee."

Ryan: "Thank you, Mr. Speaker. What was the Amendment that was put in the ah... in our Appropriations Committee?"

Speaker Bradley: "The Lady will... Wish to respond?"

Chapman: 'Mr. Ryan, you... you recall this was the one that Representative Catania had requested that was put on in the House and ah... because ah... we wanted to move the Bill along, we ah... there was some questions about the Amendment, but we moved it over to the Senate. Then, the... the concerns Representative Catania had were ah... responded to and ah... she was satisfied and so, we then ah... by Senate Amendment #1 ah... removed that ah... Ryan: "Well, this Amendment just deletes Amendment #2, is that right?"
Chapman: "That's right."

Ryan: "And ah... was Representative Catania satisfied with the interest as to where that \$93,000 had gone. It seemed to me that there was some question about that money being spent in the last campaign in the cities, last Congressional campaign and that was her, her reason for putting that Amendment on to take that money out. So, if the program had that much money to waste, that certainly they could stand that much more in reduction and I ah... I don't know if Representative Catania is agreed to that or not."

Chapman: "Yes, she has, sir. The ah... agency provided her with considerable information which responded to her concerns."

Ryan: "Well, that's, that's fine with me then."

Speaker Bradley: "The Gentleman from Lake, Mr. Deuster."

Deuster: "Would the Sponsor yield for a question?"



Speaker Bradley: "She indicates that she will."

Deuster: "I understand that the will of the House was ah... at the time ah... the Amendment was considered ah... when the Bill was here was that we would cut spending in this appropriation by about, just a little under \$93,000 and so ah... am I correct in understanding that if you vote for this Amendment, you're voting for more spending and ah... voting for \$93,000 more. Is that the dollar amount besides to the politics that Representative Ryan outlined?"

Chapman: "Mr. Deuster, the reason that Representative Catania put
this on, offered this Amendment in Appropriations Committee, was
because of her concern ah... because she felt that her questions
had not been answered. They were answered and you are right.

Her Amendment took money off that was in the original Bill and
this restores that money."

Deuster: "Mr. Speaker, if I might speak toward ah... this concurrence."

Speaker Bradley: "Proceed, sir."

beuster: "I think that ah... when we are searching dilligently everywhere for some ways to cut spending so that we can afford enough money for, to keep our schools running, pay our schoolteachers, where schoolceachers are being fixed from our end of the state to the other, we ought to take every opportunity to cut spending and here's an opportunity. It's not much. It's \$93,000, but I would suggest that we not concur with this, but we maintain the original House position which was to cut this money out. I think we can live without it and in this time of fiscal crisis for the State of Illinois, the responsible vote would be to vote to leave this Amendment on and not to concur with the Senate."

Speaker Bradley: "Further discussion? If none, the Lady renew her motion to concur. Did you wish to close? You had closed. I assume you want to renew your motion?"

Chapman: "I renew my motion, sir, and I'd like to point out that these are, are federal dollars we are talking about. Every last dollar is a federal dollar and it is being provided to continue a program which ah... has been an ongoing program and there are 1,300



people waiting for their paychecks ah... for our Legislative Body to act on this today."

Speaker Bradley: "The Lady renews her motion that the House shall concur in Senate Amendment #1 to House Bill 3213. This is final action and all those in favor will signify by voting 'aye', opposed by voting 'no'. Have all voted who wished. Representative Catania, the Lady from Cook, to explain her vote."

Catania: "Thank you, Mr. Speaker and Members of the House. The Amendment in question is one that I asked the House Appropriations II Committee to put on this Bill because the funds concerned were model city's funds that had come from the State of Illinois under contract at the beginning of the year. I have been unable to find out how the model city's money was being spent. However, after the Amendment was put on and the Bill got over to the Senate, model city complied with the request of the Department Manpower, told us how the money is being spent and it appears that it is in fact being spent to benefit the people that we originally appropriated the money for under contract. So we do have a contract with model cities to spend this money. I would suggest that we concur in the Senate's removal of the Amendment. What the Amendment did was to delete model city's funds and I would repeat, we do have a contract which apparently has been complied with now by model cities. So, we really are under obligation to spend this money. I would suggest a green light."

Speaker Bradley: "Have all voted who wished? Have all voted who wished? The Lady from... The Gentleman from Madison, Mr. Byers, to explain his vote."

Byers: "Yes, I'm a Member of the House Appropriations Committee and what Representative Catania explained is exactly right. This puts the money back in for this model city program and I would recommend an 'aye' vote on this. This money's going to be used for ah... some programs around the state where there's people employed that won't get paid this week and ah... I think an 'aye' vote would be proper on this now that that money's back in the Bill."

Speaker Bradley: "Have all voted who wished? The Lady from Cook,



Mrs. Chapman, to explain her vote."

Chapman: "Mr. Speaker, we need a few more votes on this concurrence. This Bill passed in the House ah... few weeks back without any difficulty at, at all. It ah ... simply makes transference and adds \$1,515,000 in federal funds to the appropriation for Manpower and Human Development and the Bureau of the Budget. It provides ceeder funds for 1,300 jobs for people all over the State of Illinois and during the two weeks that this Bill has been on the Calendar, "on the Concurrence Calendar, there have been a number of Legislators who have called my office and who have contacted me and who have said, when are you going to move for concurrence on House Bill 3213 for our people in my legislative district who are are asking me ah... about this. They are waiting for their checks and these jobs will, will not be able to be continued, these ceeder jobs ah ... which respond to the serious unemployment problem that we have in our state and all over the nation. And it will take 13 more votes."

Speaker Bradley: "Would you bring your remarks to a close, please."

Chapman: "Well...I think if we can't get those 10 more votes, that

perhaps I'd better ask that it be withdrawn from the record tem-

Speaker Bradley: "You'll have to move to postpone. Turn on Mrs. Chapman.

Did you move to postpone consideration?"

Chapman: "How about a poll... may I request a poll of the absentees?"

Speaker Bradley: "You certainly may. Have all voted who wished?

First. Have all voted who wished? Take the record. And now,

we'll poll the absentees. Yes, Mr. Deuster, for what purpose do

you rise, sir?"

Deuster: "Well, I ah... I thought that the ah... Clerk was going to call the absentees and nothing seems to be happening."

Speaker Bradley: "Well, we have to wait for the ah... sheet to come out and it's out now."

Deuster: "Thank you, Mr. Speaker."

Speaker Bradley: "It just takes ah... the mechanical age slows us down for a second there."

Clerk O'Brien: "Arnell, J.M. Barnes, Beatty, Beaupre, Berman, Boyle,



Brinkmeier, Capparelli, Capuzi, Craig, DiPrima, Downs, Ewell, Ewing, Fleck, Friedland, Giglio, Greiman, Hart, Hirschfeld, Gene Hoffman, Ron Hoffman, Dan Houlihan, Jim Houlihan, Katz, Keller, Kornowicz, Kozubowski, Kucharski, LaFleur, Laurino, Luft, Madigan."

Speaker Bradley: "Representative Madigan wishes to be recorded as voting 'aye'."

Clerk O'Brien: "Maragos, McAuliffe, McAvoy, McClain, McGrew, Palmer,
Peters, Polk, Rayson, Schlickman, Schoeberlein, Sevcik, Stearney,
Terzich, VonBoeckman, and Wall."

Speaker Bradley: "The Gentleman from Stephenson, Mr. Brinkmeier."
Brinkmeier: "Yes, Mr. Speaker, I'd like to be recorded 'present' if

I may and with leave, I'd like to explain why I'm voting 'present'."

Speaker Bradley: "Proceed, sir."

Drinkmeier: "Just recently, the Regional Advisory Council in my district made a recommendation that there be a change in the administration from this particular program from the present administrator to the Highland Community College. Now in my estimation, there are two things here. Number 1, I can't think of a better organization than... to administer a program than a community college. And secondly, the vote was 6 to 1 by the Advisory Council and yet the powers to be, the bureaucrats are refusing to accept that particular recommendation at this time. Therefore, I'm going to be recorded as voting 'present'."

Speaker Bradley: "Record the Gentleman as voting 'present'. The absentees have been called and there are now 83 'ayes'. Would you turn Mrs. Chapman on please."

Chapman: "I'd like to postpone ah... further consideration at this time."

Speaker Bradley: "The Lady asks that the... the Lady asks that the Bill be placed on postponed consideration. Hearing no objections, we will place it on postponed consideration."

Chapman: "I think Mr. Deuster should know that ah... of these 1,300 jobs, I understand that 1,200 of them are..."

Speaker Bradley: "I think that's out of order and we'll proceed. The Gentleman from Grundy, Mr. Washburn."



Washburn: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. It gives me a great deal of pleasure to introduce a young lady in the Speaker's gallery who has just returned from a year of studies in Dublin, Ireland and will enter Notre Dame as a Senior next year and this lovely young lady is the daughter of Representative Brian Duff. Ellen Duff, would you stand please.

We're very proud of you."

Speaker Bradley: "On the Calendar under the order of motions, appears

Holewinski: "Mr. Speaker, at this time, I'd like to table that motion."

Speaker Bradley: "We... the Gen leman moves to table the motion.

Hearing no objections, the motion is tabled. House Bill... on...

under motions, appears House Bill 3390. Representative Houlihan on the floor? Take it out of the record. Representative Schneider on your motion concerning 3635, 3636, and 3646. Take 'em out of the record at the request of the Sponsor. Under motions appears House Resolution 151. Representative Mann. Take it out of the record. House Resolution 642, Leverenz. Is Representative Leverenz on the floor? We'll take that out of the record. Where's ah... Totten on... take it out of the record. Representative Duff on House Joint Resolution Constitutional Amendment #41. Do you wish to proceed with it, sir? Turn on Mr. Duff, please."

Duff: "Ah... no, Mr. Speaker, not at this time."

Speaker Bradley: "Take it out of the record, then. The Speaker's Table on the Calendar under the order of Speaker's Table appears House

Joint Resolution 61. Mr. Kelly. Take it out of the record. House



Joint Resolution #83, Mr. Polk. Out of the record, sir? House
Joint Resolution 84, Mr. Madigan. Out of the record. House
Resolution 587. Representative Hanahan. Not on the floor, take
it out of the record. House Resolution 625, Representative
Brinkmeier. Take it out of the record. House Resolution 678,
Representative Beatty. Representative Beatty. Take it out of
the record. House Resolution 703, Representative Downs. Representative Downs. He's not here, take it out of the record.
Ladies and Gentlemen, we're going to go through the Calendar one
more time. Let's see if we can pick up some... see if we can pick
up some things here that ah... on the order... on the Calendar

The Gentleman from Cook, Mr. Madigan."

- Madigan: "Mr. Speaker, Members of the House, House Joint Resolution


 Resolution 84. Would the Clerk read the Amendment."
- Clerk O'Brien: "Amendment #1. Amends House Joint Resolution 84 on page 1 by deleting line 8 through 26 and by deleting all of page 2 and inserting in lieu thereof the following. Resolved by the House of Representatives, the 79th General Assembly, the State of Illinois, the Senate concurring herein. That there is created a special legislative committee to be called the Joint Committee on Units of Local Government. The Committee shall consist of six members."
- Madigan: "Mr. Speaker, if the ah... Chair would yield to Representative

 McMaster, I believe that he would explain the Amendment."
- Speaker Bradley: "The Gentleman from Knox, Mr. McMasters, to explain

 Amendment #1."
- McMaster: "Mr. Speaker, wasn't this Amendment adopted on the... before it got to this position? It certainly must have been."
- Speaker Bradley: "It was adopted in the Committee, but ah... was not adopted on the floor yet, sir."
- McMaster: "Mr. Speaker, several of us on our side of the aisle objected to the original language of the legislation. We got together with ah... Mr. Madigan and ah... council of his and arrived at a satisfactory position as far as the wording of the Amendment is concerned. And I'd thought this had already been adopted. I'm sorry, Pete.

Speaker Bradley: "Mr. Madigan."

Madigan: "Do you wish to move the... I move for the adoption of the Amendment."

by saying 'aye', opposed 'no'. The 'ayes' have it and the Amendment's adopted. Further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker Bradley: "Now, back to the Resolution. Mr. Madigan."

Madigan: "Mr. Speaker, I believe the Resolution has already been explained and I would request a favorable Roll Call."

Speaker Bradley: "The Gentleman moves to adopt House Joint Resolution #84. All those in favor will signify... the Gentleman from Cook,

Schlickman: "Now, I do appreciate that ah... Illinois stands at the top of the ladder with respect to the number units of local government on a per capita basis, but I do question any constitutional authority or support ah... for this Resolution. I have another question. I don't have a copy of the Resolution, but I do have the Digest and I'm wondering if there is the ordinary provision that no more than a majority of the Members from each of the two Houses shall be from one party?"

Speaker Bradley: "The Gentleman from Knox, Mr. McMasters, wishes to ah... answer that. Turn Mr. McMasters on."



GENERAL ASSEMBLY

McMaster: "Mr. Speaker, Ladies and Gentlemen of the House, this is one of the facets of the Amendment that we put on. It makes the Membership of the special study committee evenly balanced from both sides of the aisle in both the Senate and the House. There is no political power by extra numbers on either side as far as this Resolution is concerned the way it is now standing, as amended." Speaker Bradley: "Mr. Schlickman."

Schlickman: "I have no further questions. Thank you, Mr. Speaker."
Speaker Bradley: "The Gentleman from Cook, Mr. Totten."

Totten: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House.

I rise ah... in opposition to this Resolution. It appears from the Resolution ah... that the Committee that's created could, in fact, be used as a vehicle to abolish units of government such as townships. Even with the weaker language ah... that is apparently in the Bill via the Amendment, there could very well be resolved out of this Resolution a Committee that could abolish ah... the powers of township government. I don't think that that power should be vested in a Committee such as this Resolution suggests. That power is presently rested in the General Assembly ah... they could do it and we do not need a bi-partisan Committee of equal Membership to do that ah... We could do it by legislation. I don't think this Committee is needed and I very seriously question what may be the scope of their activities."

Speaker Bradley: "The Gentleman from Peoria, Mr. Schraeder."

Schraeder: "Mr. Speaker, Members of the House, first of all, I think this Resolution is of utmost necessity. We're having outdated units of government trying to ah... be economical with the taxpayers money and there's just no physical way they can do that. That's why I'm in complete support of it. However, I wonder if the deadline for the report of December the 31st of 1976 is realistic. I wondered if the Sponsor had thought about that."

Madigan: "Mr. Speaker and Members of the House, the Resolution would simply create a joint legislative study committee to study a very real problem which has been attested to by several of the speakers on the floor. Regarding the reporting date, if we see that there's

need for an extension of the reporting date, then we can report to the House and to the Senate and adopt the Resolutions which would extend the reporting date beyond December of this year. I would request a favorable Roll Call."

Speaker Bradley: "The Gentleman moves for the adoption of House Joint
Resolution #84. All those in favor will signify by voting 'aye',
and opposed by voting 'nay'. Have all voted who wished? Have all
voted who wished? Have all voted who wished? The Gentleman from
Peoria, Mr. Mudd, to explain his vote."

Mudd: "Yes, Mr. Chairman, we reviewed this ah... Resolution in Committee and ah... went over most of the concerns that the Representatives have voiced here today and I'm sure that they'll find the Resolution's in proper ah... form to pass today."

Speaker Bradley: "Have all voted who wished? The Gentleman from Cook,

Mr. Schlickman. You did take part in debate."

Schlickman: "I appreciate that, Mr. Speaker. Parliamentary inquiry." Speaker Bradley: "Proceed, sir."

Schlickman: "The number of votes that'll be required?"

Speaker Bradley: "89. Have all voted who wished?"

Schlickman: "If it doesn't go above 95, I'll ask for a verification."

Speaker Bradley: "Have all voted who wished? All voted who wished?

Have all voted who wished? The Clerk will take the record. On
this question there are 96 'ayes', 18 'nays', 10 voting 'present'.

And the Gentleman's motion is adopted. Do you want it verified,

Madigan: "Mr. Speaker, if you have declared the result, I suggest on

is not timely and request a ruling."



Speaker Bradley: "I think it's in order and so we go to the next order of business and ah... the Chair was ah... knowledgeable that that request had been made. So we will proceed in... do you wish to call the absentees, sir?"

Madigan: "Yes, poll the absentees."

Klosak: "Aye."

Speaker Bradley: "Poll the absentees. Kucharski changes from absent and will be recorded as voting 'aye'. Mr. Walsh. Mr. Kucharski has voted 'aye'. Mr. Schneider is voting from 'present' to 'aye'. Mr. Epton from 'present' to 'aye'. Oh, I'm sorry. Epton from 'no' to 'aye'. The Gentleman from Cook, Mr. Klosak."

Speaker Bradley: "Representative Simms wishes to be recorded as voting 'no'."

Speaker Bradley: "Mr... Representative Kempiners, how are you recorded, sir? Not voting, you wish to be recorded as voting 'no'.

Mr. Kempiners as 'no'. The Speaker wishes to be recorded 'aye'.

Speaker Bradley: "House Joint Resolution 678, er... House Resolution,

I'm sorry, on the Speaker's table. Mr. Beatty. Turn Mr. Beatty

on please."

Beatty: "Mr. Speaker, Ladies and Gentlemen of the House, this Resolution 678 calls for a recision of House Resolution 651. House Resolution 651 was passed by this House on the day that our Governor gave his speech advising us as to what expenditures would be made this year at a time when the House Membership was really not up to par. They were not up to par because they passed this Resolution. This Resolution that was passed calls for an investigation into various groups, civic groups and neighborhood groups into practices that they may be reviewing concerning real estate brokers. You may have read a little bit about this, but any event the basic issue is whether these groups really should be investigated. The investigation called for goes into whether or not there are violations of the civil or criminal law. Ladies and Gentlemen of the House, it is my belief that the House of Representatives is not a Body that is called upon to investigate violations of the civil or criminal law. We have bodies in our form of government that are investigative bodies that do determine if there are violations of the civil or criminal law. We have courts for this purpose. There are... that are certain persons are being hindered. We have what is known as the injunction. People can go in and seek an injunction to stop any type of action that violates the civil law. We have State's Attorneys. We have the Attorney General of the State of Illinois who's perfectly capable of seeing if there are any violations of the criminal law. And so now, Ladies and Gentleman, we have an investigation called for here. It's what is known as entrapment which is basically a violation of the criminal law. So, the Legislature's called upon to perform the function that really it is not suited to. We, we have other investigations that the House of Representatives is properly called upon to look into, such as I have a Resolution I've referred to before that investigates nursing homes and investigates the persons and the practices of nursing homes where State of Illinois funds are involved. And that investigation that I called for a year ago, Ladies and Gentlemen,



has not been completed as yet and I think that's an important investigation because the persons that are in nursing homes are not able to take care of themselves and they must rely on the management of nursing homes and they must rely on the officials of the State of Illinois to see that they get proper care. Ladies and Gentlemen, persons in nursing homes are not able to care for themselves. They need assistance and if there's any violation, those should be looked into by the Illinois Legislative Investigating Commission. Now, Ladies and Gentlemen, real estate salesmen and brokers are perfectly able to fend for themselves in our society. If, in fact, there is something that is bothering them and that there is a violation of the civil or criminal law, let them look to our court processes, Ladies and Gentlemen, not to the Legislature. Ladies and Gentlemen, the Resolution, 651, is a very broad Resolution. It calls for various kinds of investigations. It does nowhere call for any investigation to determine if we can change the law, if we can improve the law. It merely calls for to see if there is a violation of the civil or criminal law. Ladies and Gentlemen, I don't think this is the proper place for the Illinois Legislative Investigating Committee to look. Ladies and Gentlemen, Resolution 651 which I am trying to have rescinded was never brought before the Executive Committee, never was subject to a Committee scoop. Ladies and Gentlemen, we have the Committee system here and it is a good system. Ladies and Gentlemen, the Executive Committee did review Resolution 678 and it was passed by the Executive Committee. And so, Ladies and Gentlemen, I ask you to follow what the Executive Committee has recommended. I ask you to rescind Resolution 651 and so, Ladies and Gentlemen, I ask for a favorable vote."

- Speaker Bradley: "The Gentleman from Cook, Mr. Ron Hoffman. We're trying to determine... was this your Resolution, sir? The Gentleman from Cook, Mr. Hoffman, on the Resolution."
- R.K. Hoffman: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. For the Members that are sitting here, for those that have been here for some time, this will be a first for all the Members of this General Assembly. This will be your first opportunity to



vote for a legislative cover up. A situation that has arisen in the State of Illinois that has gotten to such magnitude where there are threats, charges, from two distinct groups that surface to the point where the people in my district want it looked into. And this we did with H.R. 651, a situation calling for an investigation and public hearings relative to real estate testing. Now as everyone knows here, the viable arm that the General Assembly has is I.L.I.C., the Illinois Legislative Investigating Commission. This has meritorious past and has gone into many areas of concern. at the request of Members of the General Assembly and has compiled for us informative reports as to their findings at public hearings and then made into a public document. In each and every case, Ladies and Gentlemen, the only ones that had anything to fear were those doing something wrong and yet we find that today we have a first. We have an H.R. on the floor now that we'll have an opportunity to vote on to cover up that type investigation. Allegations that took the time of the Executive Committee to almost three hours with testimony made before that Committee encompassing threats, intimidations, and veiled innuendoes and yet we are asked to consider that we should not take the time of this legislative body to consider this. Well, Ladies and Gentlemen, we're talking about people, all kinds of people. Circumstances that are such that they do need looking into. One of the aspects and one of the arguments that did come up 'cause if we're going to look into it, let's look into the complete spectrum relative to real estate practices and we have a Resolution that should be called that extends and broadens H.R. 651. As everyone in this House knows, for the years that I've been down here, I seek not to do anything but to disclose all that is to be seen and if there's wrongdoing, then let's discern it. And I say to you, consider then, if we are to do anything, let's not cover up something, let's broaden it then. Let's encompass all aspects of this. One of the arguments was we cannot tie up the Investigating Commission on trivial matters and yet the Executive Committee passed and is preand sently on the Calendar, H.R. 587 which also relates to investigating.. the Illinois Investigating Commission to investigate the Department



of Conservation. Is it not more our responsibility that the citizenry of our great state than the Department of Conservation. I say, for the Members that are here, for the Members that are considering this proposition, think more so not to cover up or veil that situation that is bad, that we know that exists, but commit it to that segment created by the General Assembly who can hold public hearings and compile all the information and compile complete reports to be sent back to the General Assembly and made to be public information. And I would ask, I would ask all of you not to participate in this cover up and that's what it is, Ladies and Gentlemen, but vote 'no' on H.R. 678."

Speaker Bradley: "The Gentleman from Peoria, Mr. Schraeder."

Schraeder: "Mr. Speaker, Members of the House, feels very difficult to have to speak against the Resolution introduced by Representative Beatty, who I admire very greatly. But I have received probably as much correspondence and telephone calls from the people involved in these Resolutions covering investigation by the Legislative Commission and if there ever was a time when we ought to be following through with a Resolution that was passed, investigating the potential abuse of civil rights in the housing market. And when an industry and when a profession themselves ask that they be investigated to find out whether their profession is doing a ... an unconstitutional act, it seems to me that we ought to go along and continue that type of investigation. We should maintain in force the previous Resolution that we adopted some time back and give 'em a chance to find out whether that profession is actually doing anything unconstitutional. When a professional group says, yes, look at us, see whether we're doing right, then we ought to take that invitation. I say we ought to defeat this Resolution."

Speaker Bradley: "The Lady from Lake, Mrs. Geo-Karis."

Geo-Karis: "Ah... First, I'd like to ask a point of order."

Sepaker Bradley: "State your point."

Geo-Karis: "I ah... this Resolution was one... up before once on a motion to suspend, but I guess the ah... I just saw the Digest.

I'll remove my point of order. It was approved by the Executive

Committee, 11 to 9. Now, I'd like to speak on the Resolution if



I may."

Speaker Bradley: "Proceed."

Geo-Karis: "Mr. Speaker and Ladies and Gentlemen of the House, I, too, have the utmost respect for the Sponsor of House Resolution 678, but I think I have more respect for the rights of both sides an issue and I think this is what it's all about. What this Resolution will do is delete Resolution 651 which has already passed this House which would require a thorough investigation by the Illinois Legislative Commission on a problem which I think we should know more about. And it seems to me that we should be interested in all sides of an issue. We cannot expect our Attorney General to take part in this because he is swamped with many things to do and we cannot expect to sit back and say, it is only fashionable to use the Illinois Legislative Investigating Commission when we only want to investigate one side. We are here under oath to do the best we can for the citizens of Illinois. If there are practices that are not proper and deplorable, they should be brought out on either side and therefore, I urge everyone to vote 'no' on this Resolution."

Speaker Bradley: "The Gentleman from Cook, Mr. Holewinski."

Holewinski: "Mr. Speaker, wondering if I could have a question answered by the Sponsor of the original Resolution, House Resolution 651,

Mr. Hoffman?"

- Speaker Bradley: "Representative Hoffman, in his seat back there? Ron, would you wish to reply to a question? He indicates that he...

 Turn on Mr. Hoffman."
- Holewinski: "Representative Hoffman, from your remarks, ah... can I deduct that you're going to be supporting ah... House Resolution 703 then, which will expand the study to include not only these groups, but the industry itself?"
- R.K. Hoffman: "For the record as I did in Executive, I supported it then and I support it now. I seek to cover nothing up."

Holewinski: "Thank you."

Speaker Bradley: "The Gentleman from Cook, Mrs. Barnes, Jane Barnes."

J.M. Barnes: "I happen to be a Lady from Cook, not the Gentleman..."

Speaker Bradley: "I'm sorry."



J.M. Barnes: "Your apology is accepted. It isn't a matter of how you vote on this Resolution today. There are several other questions that appear in my mind. When we had the original House Resolution 651, it flew out of this House and there were Members of the Leadership on the other side that also voted for this and in my local paper, one specific association seemed to rally around and pressure the Leadership on the other side of the aisle that their button was pushed and they walked off the floor. If I should ever happen to be in Leadership and I never happen to aspire to such heights, if any newspaper ever prints that my button was pushed and not to my wishes, I'll sue the darned newspaper. I shall never be pressured by any group such as the Leadership on the other side of the aisle has been. I shall always aspire to stand for what I stand for. No one will ever come around and threaten that I will not be re-elected to this House floor by a vote that I choose to vote and for this reason and for no other reason I should choose to stand with my Member on this House floor in my own local newspaper has been taken to task for being what he is not to be, myself because I sold some tickets to a brunch and the Real Estate Board bought a table, they're also questioning my integrity. I will stand with my integrity, with my fellow on this side of Ron Hoffman with the Leadership on the other side of the aisle who have bent to the wheels of the civic associations for the fear that he will not be re-elected. And for this reason, I stand with Ron Hoffman."

Speaker Bradley: "The Gentleman from Cook, Mr. Caldwell."

Caldwell: "Very briefly, Mr. Speaker and Ladies and Gentlemen of the House, ah... I, too, voted for this original Resolution. I think I was correct then and I think I'm correct in voting 'no' in this instance. We, as a Legislative Body, have the responsibility to create the laws by which the people of this state are governed. And in spite of what may be said, this Resolution was not passed in haste. It was passed because it was intelligently explained and many of us know very realistically that it was a needed Resolution and it provides the mechanism for everybody to understand what is actually being involved here. So, for that reason and for no other,



I suggest that we let the law as we have created it, stand and let the Legislative Investigating Committee do its job. This Resolution is ill-timed and is not needed and is designed to do more than meets the eye. I vote 'no'."

Speaker Bradley: "The Gentleman from Logan, Mr. Lauer. The Gentle-

Lauer: "Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House, I would like to point out that this Resolution came out of the Executive Committee by an 11 to 9 vote. It seems to me that this is a very tenuous vote to be entertaining this motion on the floor of the House. I have done some checking ah... before this meeting and before the Executive Committee and it was determined by my preliminary investigation that in order to have the Illinois Investigating Commission know what they were talking about, they would have to investigate the real estate industry in order to know what standard procedures were. Now if this be the case, it would seem to me that the Illinois Investigating Commission, I... I think every Member of this House respects that body as a non-political, non-witch hunting sort of an organization that plays it extremely straight. So, it seems also that if we pursee House Resolution 651 as passed by this House of Representatives that we are going to have a full investigation of both sides. And since the real estate industry welcomes the investigation and is hoping that it will happen, knowing full well that the bright lights of public scrutiny and scrutiny of the Investigating Commission is going to come upon them, they have nothing to hide. And quite frankly, because of the screaming and the squalling and the testimony that was given in Committee last week, I think some of the organizations that are doing the weeping and wailing and gnashing of teeth and the huge breast beating that is going on perhaps do have something to hide and if that be the case, let also the full light of investigation fall upon them. I would strongly support, Ladies and Gentlemen of the House, a full investigation according the tenets of House Resolution 651 and a defeat, a 'no' vote of House Resolution 678. Thank you."

Speaker Bradley: "The Gentleman from Cook, Mr. Terzich."



Terzich: "Yes, Mr. Speaker and Ladies and Gentlemen of the House, this Resolution ah... Representative Hoffman passed this House by 94 votes and I know that many Members of the General Assembly that personally would of voted against this Bill had they fully realized the impact of it. And those of you who think that all civic leagues and home owners associations are doing a bad job, I would suggest that they would come out into the 25th District and we'll show you some mighty fine civic groups. This Bill or this Resolution tends to say that they are intimidating the real estate business and I got news for you. Out in my area, it's the real estate people that are doing the blockbusting and the panic pedaling and everything else. And if you want to see some changing neighborhoods, come on out and watch the property values go up or down and what have you, but I would like to support this Resolution because if we investigate these ah... civic leagues and home owners associations, why don't we investigate everyone else. The Illinois Legislative Investigating Commission is overloaded with the number of investigations already. We get books and reports from the Commission that are stacked in my office at least two feet high and I would tend to say that nothing could possibly come out of this investigation. The industry is regulated by the Registration and Education. If there are any complaints by the real estate industry, I would suggest that they take it to the regulatory agency that we have ah... for the State of IIlinois. We have the Attorney General and I think that this particular investigation is very unnecessary and a waste of the taxpayers money."

Speaker Bradley: "The Gentleman from DeKalb, Mr. Ebbesen."

Ebbesen: "Mr. Speaker, I move the previous question."

Speaker Bradley: "The Gentleman has moved the previous question. All those in favor will signify by saying 'aye', opposed 'no'. And the Gentleman's motion prevails. The Gentleman from Cook, Mr. Beatty, to close. And the Chair would also, I think, ah... recognize Mr. Hoffman, if you would like to participate in closing, I think, in all deference to ah... we will do that, Mr. Beatty."

Beatty: "I ah... don't see where ah... Mr. Hoffman should be entitled to



close, ah ... but if you think he should, fine."

Speaker Bradley: "Would you like to have him... maybe he doesn't wish to close or ah... we can allow him to explain his vote, although

he's participated in debate."

Beatty: "Fine, that's fine. All right."

Speaker Bradley: "That all right? That all right, Mr. Hoffman? Fine.

All right, Mr. Beatty, to close."

Beatty: "Well, Ladies and Gentlemen of the House, you've heard the arguments pretty well on ... on the issue here. Basic issue as I see it is, this is Resolution 651 which I'm trying to rescind is actually an oppressive thing. It calls for an investigation into groups that are innocently tending to their homes, trying to take care of their homes and ah... keep their place... their home a good place to live. Many of you... I'm familiar with them fairly well, I've been a member of a home owners association for about 18 years in Scottsdale and the type of thing that we do is we keep our, try to keep the laws in shape. If there's some problem with ah... some... something the government can do, they call in the agency to get it done. They see that the neighbors keep their homes up and many of these people are fearful now of an investigation and I don't think that they deserve to be investigated. If this... if we had a Resolution that was very limited in scope, that would be one thing, but this is very broad and it's actually scaring people. Now some of the speeches that were made here would lead you to believe that this investigation is going to offer investigation of real estate brokers and real estate salesmen. This is not the case, not called for under the terms of the Resolution and it's merely a one-sided investigation. It's the type of thing as I see it that is a bad precedent. Ladies and Gentlemen, I ask your favorable vote."

Speaker Bradley: "The Lady from Lake, Ms. Geo-Karis, on a point of order. State your point."

Geo-Karis: "How many votes will this take to ah... pass."

Speaker Bradley: "Simple majority."

Geo-Karis: "Thank you."

Speaker Bradley: "All right, the question is on the Gentleman's motion.



The question is on the adoption of the Gentleman's... on House Resolution 678. All those in favor will vote 'aye' and opposed by... will vote 'no'. Now the Gentleman from Cook, Mr. Ron Hoffman, to explain his vote."

R.K. Hoffman: "All right, thank you, Mr. Speaker. Just to close, that there should be no time that the Members of the General Assembly or the citizens of the State of Illinois should ever find themselves in a compromising situation where they are threatened and I have been threatened. I have had bomb threats to my office relative to this investigation. We have tape recordings to substantiate. We have tape recordings of the testimony taken in Executive Committee relative to that which would happen if you do not destroy this investigation. And I think the time has come, Ladies and Gentlemen, to stand up the way your constitutuents want you to be and vote for the openness, the investigation into the allegations and let the full weight of the investigation fall on the wrong-doers because that is the responsibility of each and every Member of this House."

Speaker Bradley: "Now the Gentleman from Cook, the Majority Leader,
Mr. Shea."

Shea: "Mr. Speaker, I chose to cast a vote on this Bill although I am a licensel real estate broker."

Speaker Bradley: "The Lady from Cook, Mrs. Willer, to explain her vote."

Willer: "Yes, thank you, Mr. Speaker. I'm looking up at the 'no' votes here and I want you to see that I am voting 'no' which means that I support the investigation unless... and I want some of my fellow dele... Members here unless they think I've taken leave of my senses, I want to explain my vote. I find it amusing ah...that many of those who are voting 'no' against this Resolution which would rescind on Hoffman's call for an investigation are the very same people who voted 'no' ah... against investigation of brutality and inspiring on the part of Chicago police of the same organizations. We didn't want an investigation then ah... the Sponsor of the Bill has said, why should we fear the truth. Many of us felt the same way about that investigation that were aimed at these same



groups. Now these organizations are being accused of bad tactics and let's investigate them. Okay. That's okay with me, but I see an awful lot of hypocrosy up there with those votes."

Speaker Bradley: "The Gentleman from Cook, Mr. Gaines."

Gaines: "I wish to say that I am very active in the community organizations in my district and they're all in favor of this Resolution to ah... to Ron Hoffman's Resolution, so I'm voting 'no'."

Speaker Bradley: "The Gentleman from Cook, Mr. Mann."

Mann: "Well, Mr. Speaker, ah... I'm going to vote 'aye' on this Resolution, but I think it's noteworthy ah... here to observe that neither the first Resolution or this Resolution states in affirmative terms the right of people to live wherever they can afford to live without regard to their race, color, re... creed. I thought that that would be the ah... the issue around which every Member in this Eouse ah... could agree. After all, we have had ah... freedom of residence and open housing law for a long time and open accommodations law and all we're doing here, I guess, is rescinding ah... ah... a bad Resolution by substituting this one, but I thought perhaps that the most important Resolution would of been to ah... state very emphatically our beliefs in open housing for everyone, whether it be in the inner cities ah... or the sub-urbs or the rural areas."

- Speaker Bradley: "Have all voted who wished? Have all voted who wished?

 The Gentleman from Cook, Mr. Beatty."
- Beatty: "I would like to put this on postponed consideration in spite of the vote."
- Speaker Bradley: "Does the Gentleman have leave? Let's ah... let's take the vote, Mr. Beatty, and we'll... and then you can make that motion. Take the record. On this question there are 39 'ayes', 91 'nays', 3 voting 'present' and the Gentleman asks to have the Resolution placed on postponed consideration. Does he have leave? Representative... the Gentleman from Cook, Mr. Hoffman."
- R.K. Hoffman: "I think the will of the House has been best expressed at this point and I would object to that, Mr. Speaker."

Speaker Bradley: "The ah ... Gentleman from Cook, Mr. Yourell."

Yourell: "In light of the request by the Sponsor of the Resolution, I

have a ah... an inquiry to make of the Chair. If this Bill, if this vote is placed on postponed consideration, is this a matter of public record, of vote? Will the vote be recorded?"

Speaker Bradley: "No. sir. It will not."

Yourell: "Well. I want a record of this vote."

Speaker Bradley: "The Gentleman from Lake, Mr. Matijevich."

Matijevich: "Mr. Speaker, I think the Sponsor has the right to postponed consideration which nobody can take away from him under Rule 38."

Speaker Bradley: "We've extended that right on many occasions. Hoffman
has objected to placing it on postponed consideration. Mr. Beatty
is moving to put it... The Gentleman from Cook, Mr. Hoffman."

R.K. Hoffman: "Thank you, Mr. Speaker. Yes, I would object to this because I'm waiting to get the next ah... Resolution up so that we can all reaffirm our direction on this and indicate as the Sponsor said, that we should look into all aspects of it. Let's get to 703 and pass it."

Speaker Bradley: "The Gentleman from Lake, Mr. Matijevich."

Matijevich: "Mr. Speaker, I made the point of order that ah... Representative Hoffman cannot object to that ah... request by the Sponsor of placing it on postponed consideration because 38 says that ah... when a Bill is called on Third Reading, the Sponsor may before the vote is announced and it hasn't been announced may ah... place the Bill on the order of postponed consideration which he has so done and I think that that... that request must ah... now ah... be allowed by the Chair."

Speaker Bradley: "I think the Gentleman from Lake's point is well taken and we will put the B... the Resolution on postponed consideration. The... for what purpose does the Gentleman from Winnebago, Mr. Simms, arise?"

Simms: "Well, Rule 38 pertains to a Bill. We're addressing ourselves to a Resolution. Rule 38 of the House addresses itself only to a Bill which is pending and a Resolution does not have the same status as a Bill. So I think ah... Representative Hoffman's ah... objections are in order."

Speaker Bradley: "We've... We have extended this privilege on other



motions other than final passage and we're not at that final passage stage..."

Simms: "You've done that on Bills, but not on... but not on motions or Resolutions and you're dealing with a different topic. You're dealing with ah... before, you're dealing with ah... substantive Bills. This is a Resolution calling for action of the House."

Speaker Bradley: "The practice of the House has been...."

Simms: "Well, that's the practice of the House, but that's not..."

Speaker Bradley: "...in the past to allow a Member to put a Billoon...
or a Resolution on postponed consideration and that's the Chair...
even in all due respect to House Rule 38, we're going to allow
the Gentleman to put it on ah... and it can be called one more
time and it will be placed on postponed consideration, sir."

Simms: "Then, the ruling of the Chair is that a Resolution has the exact same ah... substance or status as a Bill, is that correct?

Just for the future."

Speaker Bradley: "On final passage in this particular situation, yes."
Simms: "Okay."

Speaker Bradley: "The Gentleman from Cook, Mr. Huff."

Huff: "Point of order, Mr. Speaker."

Speaker Bradley: "State your point, sir."

Huff: "Well ah..., it's my understanding according to a very cursory reading of the rules that all Resolutions with the exception of the Death Resolution and those Resolutions that are non-controversial ah... are treated as Bills."

Speaker Bradley: "Your point's well taken, sir. On... and I have so ruled, so on the order of the Speaker's table appears... House Resolution 703. Mr. Downs on the floor? I don't see Mr. Downs here, so we'll have to take it out of the record. The Gentleman from Cook, Mr. Washington, for what purpose do you rise, sir?"

Washington: "Simple request, Mr. Speaker. Mr. Downs is not here and obviously you can't call his Resolution, but would the Speaker make arrangements to call it again if Mr. Downs shows up because these three Resolutions are somewhat confusing to the unschooled eye. Now a vote against 678 carried with it in many cases, some implications relative to 703 and I, for one, would like to be recorded



- on both of those Resolutions today. So if at all possible, I wish you would call it again."
- Speaker Bradley: "If Mr. Downs appears, the Chair will go to Mr. Downs' as you request, sir, and ah... if I'm not in the Chair, I will relay your message ah... and thoughts to the Speaker at that time. On the Calendar appears House Bills, Second Reading, appears House Bill 3036. Representative Taylor. 3036, Second Reading, sir."
- Clerk Selcke: "House Bill 3036. An Act to repeal the Chicago Regional Port District Act. Second Reading of the Bill. One ah... one Committee Amendment. Amends House Bill 3036 in line 1 by deleting the word 'repeal' and inserting in lieu thereof and so forth."
- Speaker Bradley: "The Gentleman from Cook, Mr. Taylor, on the Amendment, sir."
- Taylor: "Mr. Speaker, I move for the adoption of Committee Amendment #1 to House Bill 3036."
- Speaker Bradley: "The Gentleman moves the adoption of Amendment #1 to House Bill 3036. All those in favor will say 'aye', opposed 'no'. The 'ayes' have it. The Amendment's adopted. Further Amendments? Third Reading. Second Reading appears House Bill 3376. The Gentleman from Cook, Mr. Collins."
- Collins: "Yes, Mr. Speaker, I think there's a misunderstanding here.

 House Bill 3036 was heard in Committee and was voted out with a

 clear understanding that it would be held until some Amendments

 could be worked out. I think you moved it to Third by mistake,

 Mr. Speaker."
- Speaker Bradley: "The Gentleman from Cook, Mr. Taylor. You want that Bill left on Second Reading, sir?"
- Taylor: "Mr. Speaker, will you take that back to Second Reading.

 That's the one I spoke about earlier that some Amendments was bein' ah... drafted for that particular Bill."
- Speaker Bradley: "If we... could we have leave to return the Bill at the request of the Sponsor, to Second Reading? Hearing no objections, the Bill will be returned to Second Reading. The Amendment was adopted, though. Amendment #1 was adopted and we'll leave it on Second Reading. House Bill 3376. The Lady from Cook, Mrs. Chapman.



Out of the record. House Bill 3376, Representative Byers. Out of the record? 3377, I'm sorry. Out of the record? House Bill 3379. Mr. Getty. Getty. Read the Bill a Second time, sir."

Clerk Selcke: "House Bill 3379."

Getty: "Mr. Speaker..."

Clerk Selcke: "A Bill for an Act to provide for the ordinary and contingent expense of the Illinois Law Enforcement Commission, Office of the Governor. Second Reading of the Bill."

Speaker Bradley: "The Gentleman from Cook, Mr. Getty."

Getty: "Mr. Speaker, Ladies and Gentlemen of the House, ah... Representative Barnes just indicated to me that ah... there's a defect in the Amendment #3 which has been passed out in that there's a page missing. I'm ready to proceed, however. There are 3 Amendments. Maybe it'll be ah... maybe it'll be down by then."

Speaker Bradley: "Let's ah... The Gentleman from Cook, Mr. Barnes."

E.M. Barnes: "Thank you very much, Mr. Speaker. Mr. Speaker, Members of the House, could you come back to this one? I think the Amendments were... which came down and was up in the Clerk's Office, but it was discovered that there was defect in that one, two of the pages was missing and if that Amendment was here, there will not be necessity for ah... at least a couple of those Amendments. As a matter of fact, a couple of those Amendments will be tabled.

So, if we could come back to that as soon as that defect is cleared up, I think we can clear up this whole matter. Mr. Speaker."

Speaker Bradley: "Why don't we just take it out of the record for now?

All right, take it out of the record."

E.M. Barnes: "It's being worked on now."

Speaker Bradley: "House Bill 3403. Take it out of the record. Representative McMasters on 3485, sir? Do you wish to proceed, Mr. McMaster?

Read the Bill a Second time."

Clerk Selcke: "House Bill 3485. A Bill for an Act to amend the Revenue

Act of '39. Second Reading of the Bill."

Speaker Bradley: "The Gentleman from..."

Clerk Selcke: "One Committee Amendment."

Speaker Bradley: "The Gentleman from Knox..."

Clerk Selcke: "Amends House Bill 3485 and so forth."



McMaster: "Mr. Speaker, Ladies and Gentlemen of the House, Committee

Amendment #1 merely amends out the Cook County Assessors and I

would accept the Amendment."

Speaker Bradley: "The Gentleman moves for the adoption of Amendment #1 to House Bill 3485. The Gentleman from Cook, Mr. Schlickman."

Schlickman: "Would the Sponsor yield?"

Speaker Bradley: "He indicates that he will."

Schlickman: "What is the affect of the exclusion of the Cook County
Assessors?"

McMaster: "Mr. Schlickman, it was the feeling of the Cook County

Assessors that they had sufficient salary. They did not want to

be included in any permissible salary increase. Therefore, they

asked ah... they indicated it was acceptable to them to be amended

out. This is a permissible salary Bill, Gene."

Schlickman: "Well, what will the schedule be for downstate Assessors compared to Cook County Assessors after this Amendment is adopted?"

McMaster: "Wait till I find this, Gene. I hope I've got the Bill with

me. I don't have it at this time. If you'd ah... do you want

to hold this a while till I get it ah... Mr. Speaker, and then

I'll..."

Speaker Bradley: "Till we take the Bill out of the record then."
Schlickman: "Thank you."

Speaker Bradley: "Take it out of the record. Mr. McMasters, 3486.

Does this relate to the same?"

McMaster: "I would like to hold 3486."

Speaker Bradley: "Take it out of the record. 3489, Mr. Kane on the floor? Mr. Kane? Take it out of the record at the request of the Sponsor. 3518, Mr. Jaffe. Out of the record. 3541, Mr. Ryan.

Mr. Ryan? House Bill 3541. Take it out of the record. House Bill

Mr. Ryan? House Bill 3541. Take it out of the record. House Bill 3819, Mr. Lechowicz. Out of the record. House Bills, Third Reading.

- Speaker Bradley: "House Amendment #1 to Senate Bill 1609. The Gentleman from Logan, Mr. Lauer."

Lauer: "Would the Gentleman explain the Amendment, please?"



Speaker Bradley: "He indicates that he will."

J.D. Jones: "This was an additional amount put in so that the... after the sound and light show which will be performed at the Old State Capitol, that the, that the ah... Old State Capitol be kept open an additional hour for candlelight tours for the visitors to tour the Old State Capitol after the ah... performance of the sound and light show."

Lauer: "Another question of the Sponsor, I sponsored this Amendment in

the Appropriations Committee without fully realizing the impact of

it. What was the genisis of the Amendment? Where did it come from?

I have information that the Illinois Historical Library ah... knew

nothing of the Amendment before it was offered."

J.D. Jones: "No, that is... May I respond to that, Mr. Speaker? It was ah... taken up with the State Historical Library and with the Director and he responded by giving me the amount of the money that it would take to... for the staff and the facility... ah... in the commodities used in the... in the ah... candlelight tours and ah... the Amendment was presented on that basis and Mr. Alterfer was in support of the same."

Lauer: "One further question of the Sponsor, is it not correct that
this is \$18,000 for candles and \$25,000 to clean up the mess afterward?"

J.D. Jones: "Well, it's the staffing for the whole project. That is simply correct. Yes, sir."

Lauer: "Thank you, Mr. Speaker."

Speaker Bradley: "The Gentleman moves to adopt House Amendment... Mr.

Schlickman: "Mr. Speaker, may I address myself to the Amendment?"

- Schlickman: "I understood, Mr. Speaker, that he was looking for an answer, is that correct?"
- Speaker Bradley: "That's correct, sir. We have... we'll be right with it."
- J.D. Jones: "Mr. Speaker, take it out of the record and we'll come back to it, if you would, sir."
- Speaker Bradley: "Let's take it out of the record."
- J.D. Jones: "I'll talk to the Sponsor."
- Speaker Bradley: "The Chair's gone through everything for ah... two times, so we'll go to ah... Agreed Resolutions."
- Clerk Selcke: "House Resolution 815, Polk. House Resolution 816, Kelly. House Resolution 817, Ralph Dunn et al."
- Speaker Bradley: "The Gentleman from Winnebago, Mr. Giorgi."
- Giorgi: "Mr. Speaker, House Resolution 815 by Polk commends David
 Evans, a freshman at Augustana College for receiving the highest
 score in the nation on a history examination administered by the
 'New York Times'. 816 by Kelly ah... honors the Great Highland
 Pipes who will be heard in the Village of Midlothian. And House
 Resolution 817 by Ralph Dunn marks the jurist occasion of the 100th
 birthday of Miss Ida M. Johnson. And I move the adoption of the
 Agreed Resolutions."
- Speaker Bradley: "The Gentleman moves the adoption of the Agreed
 Resolutions. All those in favor will signify by saying 'aye',
 opposed 'no'. The 'ayes' have it and the Resolutions are adopted.
 The Gentleman from Cook, Mr. Shea."
