O'Brien: "Senate Bill 59. A Bill for an Act making an appropriation to the Department of Conservation. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments? Any Amendments from the floor? Third Reading. Representative Choate. Hold it on Second. 163."

O'Brien: "Senate Bill 163. A Bill for an Act making an appropriation to the City of Salem. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 226."

O'Brien: "Senate Bill 226. A Bill for an Act making a supplemental appropriation to the Department of General Services. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Representative Choate."

Choate: "I, I was wrong on that 59. There is no amendment for it."

Speaker Redmond: "It may be advanced?"

Choate: "Yes."

Speaker Redmond: "Advance 59 to Third Reading. Where are we on 226? Any Amendments from the floor on Senate Bill 226?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 292."

O'Brien: "Senate Bill 292. A Bill for an Act making an appropriation to the ordinary contingent expense of the Commission on Children. Second Reading of the Bill. No Committee Amendments."

O'Brien: "Senate Bill 346. A Bill for an Act to provide for the ordinary contingent expense of the Illinois Arts Council. Second Reading of the Bill."

Speaker Redmond: "Any Amendments from the floor??"

O'Brien: "Two Committee Amendments. Amendment #1 amends Senate Bill 346 on page 1 by inserting after Section 2 the following and so forth."

Speaker Redmond: "Representative Shea on the Amendment on 346. Representative Lechowicz. Pardon me."

Lechowicz: "Thank you, Mr. Speaker. Ladies and gentlemen of the House, Committee Amendment #1 is a minor adjustment of \$2,800 and also lines out the grant appropriations to separate council programs, funds and grant funds to Illinois Art Organizations. The program is for 200,000, for grants it's 800,000 and I move for the adoption of Committee Amendment #1."

Speaker Redmond: "The gentleman has moved the adoption of Amendment #1 to Senate Bill 346. All in favor say 'aye', 'no'. Opposed 'no'. Any further Amendments?"

O'Brien: "Amendment #2 amends Senate Bill 346 on page 1, line 9 and so forth."

Lechowicz: "Amendment #2 appropriates Federal funds for the Illinois Arts Council. I move for its adoption."

Speaker Redmond: "The gentleman has moved the adoption Amendment #2 to Senate Bill 346. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. Any further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. 420."

O'Brien: "Senate Bill 420. A Bill for an Act to amend an Act making an appropriation to the Board of Governors of State Colleges and Universities. Second Reading of the Bill. No Committee Amendments."



Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 426."

O'Brien: "Senate Bill 426. A Bill for an Act to provide for the ordinary contingent expense of the Department of Agriculture. Second Reading of the Bill. Four Committee Amendments. Amendment #1 amends Senate Bill 426 on page, line 25 and so forth."

Speaker Redmond: "Representative Lechowicz."

Lechowicz: "Representative Williams."

Speaker Redmond: "Lechowicz."

Lechowicz: "On Senate Bill 426, ah... Mr. Speaker and ladies and gentlemen of the House, Amendment #1 amends the Senate action; places 112,280 in the contractual and part-time veterinarians and I move for its adoption."

Speaker Redmond: "The gentleman has moved for the adoption of Amendment #1 to Senate Bill 426. All in favor signify by saying 'aye'; opposed 'no'. The 'ayes' have it. The Amendment is adopted. Any further Amendments?"

Lechowicz: "Amendment #2 appropriates \$300,000 of Federal funds to wholesale, to the wholesale meat fund. I move for its adoption."

Speaker Redmond: "The gentleman has moved for the adoption of Amendment #2. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

Lechowicz: "Amendment #3 increases grants for the destruction of animals by \$52,500 and spends \$11,000 for special payments. I move for its adoption."

Speaker Redmond: "The gentleman has moved for the adoption of Amendment #3 to House Bill 426. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted."

Lechowicz: "Amendment #4 increases from 10,000 to 18,000 that the State is reimbursed for overtime pay and I move for its adoption."

Speaker Redmond: "The gentleman has moved for the adoption of Amendment #4 to House Bill 426. All in favor indicate by saying 'aye'; opposed 'no'. The Amendment's adopted. Any further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "No further Amendments. Third Reading. We skipped over



385. 385."

O'Brien: "Senate Bill 385. A Bill for an Act to amend an Act to provide for the ordinary contingent expense of the Illinois Investigating Commission. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 431."

O'Brien: "Senate Bill 431. A Bill for an Act to make a supplemental appropriation to the ordinary contingent expense of the Board of Vocational Education and Rehabilitation. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 455."

O'Brien: "Senate Bill 455. A Bill for an Act to amend an Act to provide for the ordinary contingent expense of the Bureau of the Budget. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 513."

O'Brien: "Senate Bill 513. A Bill for an Act making a supplemental appropriation to the Fair Employment Practices Commission. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 516."

O'Brien: "Senate Bill 516. A Bill for an Act making an appropriation to the ordinary contingent expense of the University Civil Service Merit Board. Second Reading of the Bill. One Committee Amendment amends Senate Bill 516 on page 1, line 12 and so forth."

Speaker Redmond: "Representative ah... Lechowicz. Representative Lechowicz can you handle ah... "

Lechowicz: "Yes, that's Representative Choate's Amendment in ah... Committee. The difference of \$9,375. It's an increase within the ah... University Civil Service Merit Board and I move for its adoption."



Speaker Redmond: "The gentleman has moved for the adoption of Amendment #1 to House... Senate Bill 516. All in favor say 'aye'; opposed 'no'. The Amendment's adopted. Any further Amendments?"

O'Brien: "Floor Amendment #2, Hirschfeld."

Speaker Redmond: "Representative Hirschfeld. Read the Amendment."

O'Brien: "Amends Senate Bill 516 on page 1, line 14 by changing 17,400 to 29,400 and in line 22 by changing 437,500 dollars to 449,500 dollars."

Speaker Redmond: "Anybody here to handle Representative Hirschfeld's floor Amendment. Representative Lechowicz."

Lechowicz: "Thank you, Mr. Speaker. Will the Clerk read that Amendment again and see what line we're amending?"

O'Brien: "On page 1."

Lechowicz: "Yea."

O'Brien: "Line 14 by changing 17,400 to 29,400."

Lechowicz: "I don't know anything about that ah... corrective Amendment ah... Mr. Speaker. In fact, that item was corrected in Amendment #1 which we just adopted. That caused the increase of 9,375 dollars. If the Clerk would check it, I think that he'll see that it's a duplicate Amendment and should be ruled out of order."

O'Brien: "And then in line 22 by striking 437,500..."

Lechowicz: "Yea, well that's just changing the total dollar amount."

O'Brien: "To ah... 449,500."

Lechowicz: "Well, I would have speak against that because if you take a look at Amendment #1, I think that it corrects line 14 and the difference is ah... our total is 446,875, I believe. I don't know if that's just mathematics. Why don't you just take that out and I'll check it. Okay?"

Speaker Redmond: "Representative Lechowicz, what's your pleasure? Hold this on Second or move it to Third."

Lechowicz: "Yes, Mr. Speaker. If you'd just hold it temporarily, I'll just check the figures and see which one is right or wrong."

Speaker Redmond: "It's been the inclination of the Chair and I think we announced it before, that anybody who wants a floor Amendment to a Bill has to be here at the time that the Bill is called. It's unfair to the sponsor to hold it indefinitely because of the absence of



the sponsor of an Amendment. Representative Palmer. Palmer."

Palmer: "Ah... Mr. Speaker, I don't have ah... the Amendment #2 on the desk. I wonder if it has been distributed?"

Speaker Redmond: "It has been distributed. Republican pages, will you please attend to Mr. Palmers needs. May the 20th it was ah... distributed. Representative Lechowicz."

Lechowicz: "Ah... yes, Mr. Speaker. On 516, we made the change that Representative Hirschfeld requested in Amendment #1. We also made another change on line 15. That's why there's a difference in the totals. I would, I vote to table Amendment #2 because it's not in order."

Speaker Redmond: "The gentleman has moved to table Amendment #2 to Senate Bill 116. Representative Ryan, for what purpose do you rise?"

Ryan: "Who's Amendment is Amendment #2?"

Speaker Redmond: "Hirschfeld."

Ryan: "And you move to table his Amendment and he's not here."

Lechowicz: "Yes, I'll tell you why. Because it was taken care of in Amendment #1, George which was heard in your Committee."

Ryan: "Well, are we going to have these ramrod tactics again this week ah... Mr. Speaker."

Speaker Redmond: "As I have indicated before, it is the opinion of the Chair that it's manifestly unfair to hold up the consideration of a members Bill by submitting a floor Amendment and then not being present in time to present it. If you were goin' to defer to the absences, you'd never get through this call. So that's the indication of the Chair."

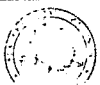
Ryan: "Well, I'm sorry to hear that another member can table ah... another members Amendment when he isn't on the floor."

Speaker Redmond: "He should be on the floor to take care of it. Representative Choate."

Choate: "I don't think the sponsor's even here on the Bill, Representative Stone ah... "

Speaker Redmond: "Well, I don't see any necessity that he be here. Representative Lechowicz, one of the Appropriation Chairman. Representative Telcser."

Telcser: "Mr. Speaker, can we take this Bill out of the record?"



Speaker Redmond: "No."

Telcser: "Just until the sponsor gets here."

Speaker Redmond: "No."

Telcser: "Are you trying to tell me, Mr. Speaker."

Speaker Redmond: "I'm telling you that if you want to amend..."

Telcser: "If I have a Bill and leave my microphone on. If I have a Bill and I don't happen to be here, you're going to call it and move it."

Speaker Redmond: "I'm telling you that if you have a Bill and somebody wants to amend it and the person who seeks it is not here..."

Telcser: "And you're going to call my Bill if I don't want it called?"

Speaker Redmond: "You've heard... You don't have a Bill. You're talking about some hypothetical situation."

Telcser: "That's the same thing that is happening now. Has Representative Stone asked that it be called?"

Speaker Redmond: "Yes."

Telcser: "Where's he at?"

Speaker Redmond: "I don't know."

Telcser: "Will you take this Bill out of the record, please?"

Speaker Redmond: "No. Any further discussion on the Amendment? Number 2."

Telcser: "Mr. Speaker, I question a quorum."

Speaker Redmond: "Okay, take the roll call. Open up the roll call.

The Clerk will take the record. There's 94 here. A quorum is present. The gentleman has asked for a verification. Proceed with the verification. Poll the absentees first."

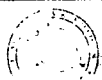

Speaker Redmond: "Hudson's here. Put him on the roll call."

O'Brien: "Huff, Jaffe, Emil Jones, Katz, Keller, Kozubowski, Kucharski, Lauer, Laurino, Kornowicz, Londrigan."

Speaker Redmond: "Londrigan is present. Put him on the roll call."

O'Brien: "Macdonald, Madison, Mann, Maragos."



Speaker Redmond: "Maragos is here. Gene Hoffman's here. Giddy Dyer is here."

O'Brien: "McAuliffe, McCourt, McLendon, McMaster, Meyer, Miller, Mugalian, Neff, O'Daniel, Patrick, Pierce, Polk, Pouncey, Randolph, Rayson, Richmond, Rigney, Rose, Sangmeister, Schlickman, Schneider, Schoeberlein, Schuneman, Stearney, Taylor, Telcser, Terzich, Totten, Tuerk, VanDuyne."

Speaker Redmond: "VanDuyne is present. Stearney is present."

O'Brien: "Walsh, Washburn, White, Winchester, Younge, Yourell."

Speaker Redmond: "Representative Schoeberlein is present. Representative Pierce. Representative Pierce is present. Representative Carroll is present. Representative O'Daniel is present. Anyone else that was not on the roll call? Representative Dyer, is she on the roll call? Representative Rigney. Representative Griesheimer. Representative Polk. Representative Yourell. Representative Barnes, was he on the roll call? Representative Randolph. He's on the roll call. Anyone else that's not on the roll call? Representative Duff. Proceed with the verification of the present roll call. What's your count, Representative ah... Jack? 107. Representative Telcser withdraws his request for a verification. Senate Bills, Second Reading. We're back on Senate Bill 516. Representative Lechowicz has moved to table House Bill er... Amendment #2. All those in favor of his motion indicate by saying 'aye'; opposed 'no'. The 'ayes' have it. The Amendment is tabled. Any further Amendments?"

Speaker Redmond: "Third Reading. 1490."

O'Brien: "Senate..."

Speaker Redmond: "1490."

O'Brien: "Senate Bill 1490. A Bill for an Act to amend an Act making an appropriation to the Fair Employment Practice Commission. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. House Bills, Second Reading. House Bill 235."



O'Brien: "House Bill 235. A Bill for an Act to provide for the ordinary contingent expense of the Advisory Committee on Compensation of members of the General Assembly. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Senate... er House Bill 235, Representative Choate."

Choate: "Ah... Mr. Speaker, just in between Bills, might I make the announcement to the membership that, at least scheduled for this evening at 6 o'clock, is the ill, now ill-famous House and Senate softball game. And the reason I say ill-famous is simply because the Senate in 28 years has never won a softball game. The proceeds, as we well know, goes to a very, very good cause here in the city of Springfield because it goes to the late Bill Chamberlain City Park. Mrs. Chamberlain and others are at a table in the rotunda to sell tickets to this very worthwhile event and I suggest that all of the members who have not received tickets by now, go to the rotunda and purchase their tickets from Mrs. Chamberlain."

Speaker Redmond: "Representative Choate, there's a message from Coach Lucco. I wonder if ah..."

Choate: "I might point out that the, the original message from ah... Representative Lucco, Mr. Speaker, has an Amendment to it. Amendment #1 and I think..."

Speaker Redmond: "Read the Amendment, please."

Choate: "He could probably speak more... I would yield the floor to Coach Lucco if he's on the floor. If he isn't on the floor, then I would yield to Coach Deavers, his assistant Coach."

Speaker Redmond: "Here comes Coach Lucco."

Choate: "There's Coach Lucco."

Lucco: "Thank you, Mr. Speaker, Representative Choate and so forth. Of course, it's a privilege and an honor for me to even get to write the lineup down of these illustrious stars but I hope that Representative Brandt will be with us. Is he with us now?"

Speaker Redmond: "Not yet."

Lucco: "Well, Representative Brandt, of course, has coached this championship team for quite a number of years and should he be here today, of course, I would be ah.. very, very glad to be of assistance



to him. If he is not here, I will ah... take over. Naturally, many of these teams, these fellows, have not been seen actually in practice. We certainly will play everyone tonight that shows up there even if we have to have wheelchairs for the Senators. We're going to try to get them around the bases, but some of you, of course, we haven't had the privilege to really see. So tonight, we will ah.. reserve the right to amend the starting lineup as we get a look at you this evening. We'd like for you to be there between 5 and 5:15. Game time is at 6 o'clock. The Governor is going to throw the first ball. We're probably going to override his veto on that and not only let him throw one out, but I think, we'll do that. We'd be glad to have him. Speaker Redmond: "Representative Deavers, the assistant Coach."

Deavers: "I'm sorry to be in the minority to get demoted from head Coach to assistant Coach, but seeing as we're in good capable hands of Phil Lucco, and as a matter of fact, we've had a little meeting and that was the reason for Amendment #1 and I heartily support Amendment #1 to get a few Republicans into the lineup."

Speaker Redmond: "Representative Lucco."

Lucco: "There was some question as to whether or not the Republicans were part of the team. But I, I recall once or twice... I recall once or twice when the Republicans did come across the aisle and did help make the team. So, we're very, very glad to have them with us tonight, of course. And the ladies, Geo-Karis. My goodness, yes. And Mrs. Younge."

Speaker Redmond: "House Bills, Second Reading. House Bill 235."

O'Brien: "House Bill 235. A Bill for an Act..."

Speaker Redmond: "Representative Skinner, for what purpose do you rise?"

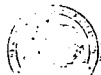
Skinner: "Well, just to wonder if it would be too much to ask if our new union printers could get the digest to us."

Skinner: "Thank you."



Speaker Redmond: "All I know is we have six inches of water down in the basement and there goes our new printing press and some of the things that were printed there, so... 235. Representative Brinkmeier."

Brinkmeier: "Mr. Speaker and members of the House, I urge for the... I move that we advance it to Third Reading. There are no Amendments that I'm aware of."

Speaker Redmond: "House Bill 235."

O'Brien: "House Bill 235. A Bill for an Act to provide for the ordinary contingent expense of the Advisory Committee on Compensation of members of the General Assembly. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 284."

O'Brien: "House Bill 284. A Bill for an Act making an appropriation to the Environmental Protection Agency. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Representative Williams."

Williams: "Ah... Yes, there is a Committee Amendment on that."

O'Brien: "One floor Amendment. Amendment #1, Lechowicz. Amends House Bill 284 on page..."

Williams: "Oh, it's a floor Amendment. I'm sorry."

Speaker Redmond: "Representative Lechowicz. Please come to order."

Lechowicz: "Thank you, Mr. Speaker. Ladies and gentlemen of the House, House Bill 284. This is the Amendment that we discussed in Committee. We're going to break the lump sum appropriation in House Bill 284 down in the amount to be appropriated by grant categories. The Amendment further allows EPA to reapportion 10% of the total appropriation among the various categories so that their reaction to grant applications has a degree of flexibility. And if money is available in a category, but applications are not received the reapportionment can take place to put money where the applications have been received. Ah... This Amendment has been discussed with the Minority Leader on the Appropriations Committee. It's been reviewed by the staff and I move for its adoption."



Speaker Redmond: "Representative Duff, for what purpose do you rise?"

Duff: "Will the sponsor answer a question?"

Speaker Redmond: "Indicates he will."

Duff: "Ah... Representative Lechowicz, it was indicated that it was not a Committee Amendment but a floor Amendment and yet you indicated that it had been discussed in Committee."

Lechowicz: "Yes, we didn't have the exact figures at the time of the Committee Hearing, Representative Duff."

Duff: "Ah... Was there some general agreement within the Committee Meeting?"

Lechowicz: "I'll let Representative Totten explain that."

Speaker Redmond: "Representative Totten."

Totten: "Thank you, Mr. Speaker and members of the House. I'll try and respond to the question. There was an Amendment in the Committee and there was agreement to the format. Some of the figures were questioned by the Department. We worked with them on both sides of the Amendment that is being presented now is an agreed Amendment."

Speaker Redmond: "The gentleman has moved the adoption of Amendment #1 to House Bill 284. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. Any further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. 592."

O'Brien: "House Bill 592. A Bill for an Act making an appropriation to the Joint Prisoner Release Study Committee. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 691."

O'Brien: "House Bill 691, Grotberg. A Bill for an Act making an appropriation to the Legislative Councils. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 941."

O'Brien: "House Bill 941. A Bill for an Act to provide for the ordinary contingent expense of the Illinois Racing Board. Second Reading of



Bill. One Committee Amendment. Amends House Bill 941 on page 1 by deleting line 5-33 and so forth."

Speaker Redmond: "The gentleman has moved for the adoption of Amendment #1 to House Bill 941. All in favor say 'aye'; opposed 'no'. Representative Lechowicz."

Lechowicz: "Thank you, Mr. Speaker. I know Representative Hanahan was just over here. He's preparing an Amendment, an additional Amendment to 941. I'd like to keep this Bill on Second Reading."

Speaker Redmond: "Second Reading. 966. No, they wanted it held. Representative Lechowicz requested it be held."

O'Brien: "House Bill 966. A Bill for an Act making an appropriation to the Chicago Zoology Society. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 1263."

O'Brien: "House Bill 1263. A Bill for an Act making an appropriation to the Violent Crime Study Commission. Second Reading of the Bill. One Committee Amendment. Amends House Bill 1263 on page 1, line 5 by deleting 100,000 and inserting in lieu thereof, 15,000."

Speaker Redmond: "Representative Peters."

Peters: "Mr. Speaker, the Amendment does exactly as read by the Clerk. I move for the adoption."

Speaker Redmond: "The gentleman has moved for the adoption of Amendment #1 to House Bill 1263. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. Any further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. 1297."

O'Brien: "House Bill 1297. A Bill for an Act making an appropriation to the office of States Attorneys Study Commission. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 1318."

O'Brien: "House Bill 1318."

Speaker Redmond: "Representative Choate. Go ahead, Jack."



O'Brien: "A Bill for an Act making an appropriation to the Illinois Rivers Marketing Study Commission. Second Reading of the Bill. One Committee Amendment."

Speaker Redmond: "Representative Lechowicz."

O'Brien: "Amends House Bill 1318 and so forth."

Lechowicz: "Thank you, Mr. Speaker, ladies and gentlemen of the House. The reduction of \$135,000, leaving a grand total of 15,000 in the Bill. I move for its adoption."

Speaker Redmond: "The gentleman has moved for the adoption of Amendment #1 to House Bill 1318. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading 1329."

O'Brien: "House Bill 1329. A Bill for an Act making an appropriation to the Law Revision Commission. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 1350."

O'Brien: "House Bill 1350. A Bill for an Act making an appropriation to the Spanish Speaking People Study Commission. Second Reading of the Bill. One Committee Amendment. Amends House Bill 1350 on page 1, line 5 by deleting \$75,000 and inserting in lieu thereof, \$50,000."

Speaker Redmond: "Representative Kozubowski."

Kozubowski: "Thank you, Mr. Speaker, ladies and gentlemen of the House. Committee Amendment #1 is a reduction of \$25,000 and I would move for adoption of Amendment 1."

Speaker Redmond: "The gentleman has moved for the adoption of Amendment #1 to House Bill 1350. Representative Totten."

Totten: "Mr. Speaker, just a ah... point of inquiry. Some of these Commissions are in and out of a Commission Bill ah... with the appropriation and I just question why we're acting on the appropriation when they're all going to be there ah... and maybe the Chairman of Appropriations could answer that."

Speaker Redmond: "Representative Lechowicz, do you care to answer?"



Lechowicz: "Ah... Yes, Mr. Speaker. In reply, some of these Commissions are but in turn ah.. there was a question when the ah... Omnibus Bill was going to be prepared or even presented. That's why this was introduced at the time. We will take this Commission out of the Omnibus appropriation Bill by amendment."

Speaker Redmond: "Questions on the adoption of Amendment #1 to House Bill 1350. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. The Amendment is adopted. Any further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "No further Amendments. Third Reading. 1504."

O'Brien: "House Bill 1504. A Bill for an Act making an appropriation to the Data Information System Commission. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 1525."

O'Brien: "House Bill 1525. A Bill for an Act making an appropriation to the Galena Preservation Restoration Association. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 1616."

O'Brien: "House Bill 1616. A Bill for an Act making an appropriation to the Board of Vocational Education and Rehabilitation. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 1711."

O'Brien: "House Bill 1711. A Bill for an Act making an appropriation to the Illinois Insurance Study Laws Study Commission. Second Reading of the Bill. One Committee Amendment. Amends House Bill 1711 on page 1, line 5 by deleting 125,000 and inserting in lieu thereof 85,000."

Speaker Redmond: "Representative Epton on the Amendment. He moves the adoption of Amendment #1 to House Bill 1711. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted."



Any further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "No further Amendments. Third Reading. 1796."

O'Brien: "House Bill 1796. A Bill for an Act making an appropriation to the Water Resources Commission. Second Reading of the Bill. No Committee Amendment."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 1816."

O'Brien: "House Bill 1816. A Bill for an Act makin an appropriation to the Department of Transportation. Second Reading of the Bill. One Committee Amendment. Amends House Bill 1816 by striking line 5-10 and so forth."

Speaker Redmond: "Representative Hudson, do you desire to explain the Amendment? Representative Lechowicz."

Lechowicz: "Thank you, Mr. Speaker and ladies and gentlemen of the House. Amendment #1 to House Bill 1816 is a reduction of \$130,020 and I move for its adoption."

Speaker Redmond: "The gentleman has moved the adoption of Amendment #1 to House Bill 1816. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "No further Amendments. Third Reading. 1829."

O'Brien: "House Bill 1829. A Bill for an Act making an appropriation to the Park District Problem Study Commission. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 2038. Take that out of the record. Representative Hirschfeld is not here. 2076."

O'Brien: "House Bill 2076. A Bill for an Act making an appropriation to the Capitol Development Board. Second Reading of the Bill. Two Committee Amendments. Amendment #1 amends House Bill 2076 on page 1 by deleting line 7 and 8 and so forth."

Speaker Redmond: "Representative Lechowicz."

Lechowicz: "Thank you, Mr. Speaker and ladies and gentlemen of the House."



Amendment #1 it, clarifies language C.D.B.'s role in constructing specialized living centers and I move for the adoption."

Speaker Redmond: "The gentleman has moved the adoption of Amendment #1 to House Bill 2076. All in favor indicate by saying 'aye'; 'no'. Representative Duff, for what purpose do you rise?"

Duff: "Well, Mr. Speaker, I wonder if to help out all ah... on an occasion where an... On an occasion where an appropriation Bill is being called relative to a companion Bill, ah... we could be told by the sponsor ah.. whether or not the companion Bill has passed. In this instance, ah..."

Lechowicz: "The companion Bill has passed on this."

Duff: "Well, I would... I think it would be helpful ah... as in this case and the one just prior to this ah... It doesn't... It doesn't reflect it in the digest and so if the sponsor is... Mr. Speaker could when they are putting forward an appropriation Bill, might also add the comment that the appropriation Bill has passed. It would be helpful. I mean that the companion Bill has passed. It would be helpful."

Speaker Redmond: "Representative Lechowicz."

Lechowicz: "The substantive Bill has passed, Mr. Speaker."

Speaker Redmond: "The gentleman has moved the adoption of Amendment #1 to House Bill 2076. All in favor of the adoption indicate by saying 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

O'Brien: "Amendment #2. Amends House Bill 2076."

Lechowicz: "Reduction of \$25 million and I move for its adoption."

Speaker Redmond: "The gentleman has moved the adoption of Amendment #2 to House Bill 2076. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

O'Brien: "Floor Amendment #3, J. Houlihan. Amends House Bill 2076 as amended on page 1 by deleting line 6 and inserting in lieu thereof, 'maybe necessary as appropriated for the Capitol Development Bond Fund for the Capitol Development'."

Speaker Redmond: "Representative Lechowicz."

Lechowicz: "This was not a Committee Amendment, Mr. Speaker, and I would ah... I'm trying to look at the Bill, now. Amendment #6 reads as,



as what Jack..."

Speaker Redmond: "Representative Lechowicz has moved the adoption..."

Lechowicz: "No, no, I haven't, Mr. Speaker. I'm just trying to ah... see how it alters the Bill. We ah... did move Amendment #1 which was corrective language. Let the sponsor explain the Amendment."

Speaker Redmond: "Representative Houlihan."

Houlihan: "Ah... Mr. Speaker, ladies and gentlemen of the House and ah... This Amendment merely changes the source of ah... make it from ah... Capitol Development Bond Authority rather than from General Revenue Fund."

Speaker Redmond: "Representative Lechowicz."

Lechowicz: "Will the sponsor yield to a question?"

Speaker Redmond: "Indicates he will."

Lechowicz: "Could you give me the status of the Capitol Development Bond Fund right now? He can't answer it either."

Speaker Redmond: "Representative Schraeder, do you seek recognition?"

Houlihan: "I believe there is enough ah... funds in there to cover this Amendment ah... I checked with staff and they indicated this was appropriate."

Speaker Redmond: "Representative..."

Lechowicz: "Is that what the existing ah... items within the Capitol Development Bond Fund as far as what's being proposed presently by C.D.B.?"

Houlihan: "You mean in the accelerated program?"

Lechowicz: "No, not the accelerated program. In their annual program."

Houlihan: "I believe so, but I'm not certain of that."

Speaker Redmond: "Representative Totten."

Totten: "Ah... Thank you, Mr. Speaker. Ah... on the Amendment, if I could. Ah... the proposal as Amendment 3 would bring it, would bring the Bill similar to the Governor's Bond Program which was defeated ah... by the House Appropriations Committee. What the sponsor of the Amendment is now, er... the sponsor of the Bill is trying to do is take the program and bring it out of the General Revenue and the sponsor of the Amendment is trying to bring it back to ah... bonding and ah... that would be inappropriate. I think the sponsor deserves to have the Bill in the order that



ah... he wanted it and that we should oppose Amendment #3.

Speaker Redmond: "Representative Lechowicz."

Lechowicz: "Ah... Yes, Mr. Speaker. I'll have to stand in opposition to Amendment #3 as well. Unfortunately, Representative Pouncey, I don't see him on the floor right now. I haven't had enough time to discuss the ah... this Amendment with him. I don't know what his indications are, but I'd be a little bit leary right now in stating that the Capitol Development Bond Fund has the necessary funds in order to accomplish this project. If this probably is the case, he'll know another appropriation that we could ask the Capitol Development Bond Fund to ah... absorb. We're talking about \$15 million and I think that's probably right at its maximum at the present time. And I would have to oppose Amendment #3."

Speaker Redmond: "Representative Houlihan."

Houlihan: "Ah... Mr. Speaker and ladies and gentlemen of the House, I had occasion to talk to ah... Representative Pouncey and he indicated that it was not his concern as to where the funds might come from, but merely that the program get established and ah... I'd urge the support. I think if we find that this program is adopted and all of the Capitol Development Bond Funds are used, ah... we might increase their authorization and I move for its adoption."

Speaker Redmond: "The gentleman has moved for the adoption of Amendment #3 to House Bill 2076. Representative Skinner."

Skinner: "Mr. Speaker, there are some of us that do not have last week's Digest and so don't even have the gleam of an idea of the subject matter of this Bill, let alone the Amendment. Ah... I wonder if it would be possible for someone to clue us in or for us to find the union printer who is doing the printing and get the ah... Digest to our desks where they may be useful."

Speaker Redmond: "I understand that the Digest will be here at 4 o'clock."

Skinner: "Will, that doesn't help a hell of a lot between now and then."

Speaker Redmond: "We're going to have a Joint Session at 1:30 and then we'll be adjourning."

Skinner: "Well, could the, could the sponsor of the Bill or the Amendment give us a clue as to ah... which one of the Governors ah... bankruptcy programs that this is."



Speaker Redmond: "Representative Houlihan."

Houlihan: "Ah... Mr. Speaker, maybe it might be appropriate to take this matter out of the record until after the break."

Speaker Redmond: "Representative McClain."

McClain: "Thank you, Mr. Speaker. With leave of the House, I could explain the Bill. Taylor Pouncey's Bill."

Speaker Redmond: "Proceed."

McClain: "Thank you, sir. Ah... Representative Skinner, ah... Representative Lechowicz asked what the subject matter of the Bill was ah... so that he could put in line what the Amendment meant to the Bill. With leave, I mean, I don't want to get in a middle of a 'dobbybrook' here. I just thought I'd help out Taylor Pouncey."

Speaker Redmond: "Proceed, Representative McClain."

McClain: "Thank you, Mr. Speaker. Ah... House Bill 2076 is a Bill which would authorize the building of five to seven special, specialized living centers for developmental disabilities. If you remember ah... we amended it, at least the Appropriations Committee amended it from an appropriation of 40 million down to 15 million and we discussed this ah... last week and that's what the subject matter of the Bill is, Representative Skinner."

Skinner: "Thank you."

Speaker Redmond: "The Chair knows that the substantive Bill passed out last week. Representative Duff."

Duff: "Well, Mr. Speaker, I wonder if Representative Houlihan's suggestion isn't appropriate since Representative Pouncey is not here and some of us are going to oppose this Amendment."

Speaker Redmond: "We might as well proceed on the adoption of the Amendment. Representative Houlihan."

Houlihan: "I'm sorry, Mr. Speaker. Someone was talking to me."

Speaker Redmond: "I say, you have moved the adoption of Amendment #3 to House Bill 2076. Representative Shea."

Shea: "Will the sponsor of the Amendment yield for a question?"

Speaker Redmond: "Indicates he will."

Shea: "As I understand..."

Houlihan: "Mr. Speaker. Excuse me, Jerry. Ah... Obviously, this is a somewhat controversial and I'd hate to have this ah... "



Speaker Redmond: "Representative Shea."

Shea: "Well, I was wondering if he'd yield for a question."

Speaker Redmond: "Indicates he will."

Shea: "Would you tell me as I read the Amendment, you're taking it, you're taking it out of another fund and... Representative Pouncey had it coming out of the Capitol Development Bond Fund."

Houlihan: "No, Representative Pouncey had it coming out of the General Revenue Fund."

Shea: "And you want to take out of the Capitol Development Bond Fund. Is that correct?"

Houlihan: "That's correct."

Shea: "All right, now can you tell me of the amount of limitation on the Capitol Development Bond Fund at this time?"

Houlihan: "I'm not certain of the limitation, but I've checked with staff and there is that, that amount of dollars in the fund."

Shea: "Well, I know that the fund is substantial, but isn't it every time that we appropriate money out of it, the rate limitation on the fund has to be changed?"

Houlihan: "I don't believe so, Jerry."

Shea: "Well, the ah... Capitol Development Bond Fund is not an open-end Bond Fund, is it?"

Houlihan: "No, it's not."

Shea: "All right, what is the present rate limitation on the Bond Fund and how much has been appropriated against that limitation?"

Houlihan: "Jerry, in conferring with Bill Foster who is standing over next to you as our staff, he indicates that there are the funds available, but I'm not sure of the specifics of your question. I'd be happy to get that information and provide it to you."

Shea: "Well, do you know if, you know, if you've got a staff member telling you that. But I don't know ah... Can you give me the dollar amounts of what the fund is since it's a closed-end fund, the dollar amounts of the fund and the amount that's been appropriated against those dollar amounts and what's been expended out of the dollar amounts appropriated?"

Houlihan: "Jerry, for the third time. I don't have those figures and I'd be happy to provide with, to you if you would ah..."



Speaker Redmond: "The Chair will indicate the, will entertain the suggestion that this matter be held. Suggest that Representative Houlihan come up to the Chair. House Bill 2103. 2076 will be held. 2103."

O'Brien: "House Bill 2103. A Bill for an Act making an appropriation to the Illinois Finance Commission. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 2120."

O'Brien: "House Bill 2120."

Speaker Redmond: "Representative Ryan, for what purpose do you rise?"

Ryan: "Well, I have a question, Mr. Speaker. Ah... Last week, 2102 was a companion..."

Speaker Redmond: "2120, I think it is. Maybe I transposed."

Ryan: "No, the Bill you just moved to Third. 2102, I believe."

Speaker Redmond: "21... We're on 2120."

Ryan: "2103, you just moved. Is that right?"

Speaker Redmond: "Yes."

Ryan: "2102 went to interim study last week as a companion Bill to the appropriation just moved. What's the procedure?"

Speaker Redmond: "Well, I seriously question that any money will be spent for a substantive Bill that is not the law."

Ryan: "Well, would it be better to take the Bill back into Committee?"

Speaker Redmond: "Well, I don't know. I don't..."

Ryan: "You're talking about keeping a Bill alive..."

Speaker Redmond: "Well, we can do that at a later date if it's necessary. 2120, Representative Totten. Representative Lechowicz."

Lechowicz: "On 21... On 2119 it was killed on the floor, Mr. Speaker. So, I think 2120 is ah... should be tabled."

Speaker Redmond: "Representative Totten."

Totten: "Thank you, Mr. Speaker. As chief sponsor of 2120, ah... 2119 the companion Bill was killed and I move at this time to table 2120."

Speaker Redmond: "Any objections? 2120 is tabled. 2240, Representative Telcser."



Telcser: "Mr. Speaker, I think that's the same point that Representative Ryan was making with respect to 21, 2103."

Speaker Redmond: "The difference is that the principal sponsor of the substantive Bill has moved to table it. Now the principal sponsor of 2104, I believe it is, has not made such a suggestion."

Telcser: "2103, is that Representative Chapman's Bill?"

Speaker Redmond: "Representative Chapman, right."

Telcser: "Is she going to table that Bill or move to table it, do you know?"

Speaker Redmond: "Representative Chapman, we just moved 2103 to the order of Third Reading. I understand that 2104, the companion Bill, was defeated. Is that correct?"

Telcser: "It's back in the interim study Committee. You've referred it back to Committee."

Chapman: "Ah... That's 2102 which is in ah... Study. It seems that this is a matter that will take some further amendment. However, I think it is very likely it could come forth as a Committee Bill. And if it would, it would be very logical to leave this Bill on 2103 on the House Calendar, Mr Speaker."

Speaker Redmond: "I agree with you. Representative Schraeder."

Schraeder: "Well, Mr. Speaker. I didn't want to interrupt. I've got a Bill I want to table at the proper time."

Speaker Redmond: "The proper time is now."

Schraeder: "All right, sir, thank you. 1414 is a companion Bill to 1415 which is in interim study in Appropriation I and I move the proper rule be suspended so this could join it in interim study."

Speaker Redmond: "What was that again?"

Schraeder: "1414."

Speaker Redmond: "You move to table that. Is that correct? Any objection? Hearing none, 1414 is tabled. 2240."

O'Brien: "House Bill 2240. A Bill for an Act making an appropriation for the Abandoned Mined Land Reclamation Act. Second Reading of the Bill. One Committee Amendment. Amends House Bill 2240 on page 1, line 15 by deleting \$150,000 and inserting in lieu thereof \$250,000."

Speaker Redmond: "Representative Lechowicz."



Lechowicz: "Thank you, Mr. Speaker, ladies and gentlemen of the House. An increase of \$100,000 for the appropriation to the office of Lieutenant Governor under the administration of the Abandoned Mined Lands Reclamation Act. The Bill calls for 3,150,000. With the Amendment, it will call for 3,250,000. It's an increase of 100,000 and I move for the adoption."

Speaker Redmond: "The gentleman has moved the adoption of Amendment #1 to House Bill 2240. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. 2439."

O'Brien: "House Bill 2439. A Bill for an Act making an appropriation to the State Board of Education. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "Floor Amendment."

Speaker Redmond: "Representative Schneider."

O'Brien: "Floor Amendment #1. Amends House Bill 2439 on page 1, line 1 and so forth."

Speaker Redmond: "Representative Schneider."

Schneider: "Excuse me, Mr. Clerk. Ah... the companion to 2439 was returned to Committee. Are we now going to move that or hold this on Second?"

Speaker Redmond: "Representative Jane Barnes."

Jane Barnes: "I'd like to have it moved to Third Reading."

Schneider: "Well, you don't have a companion Bill on the floor."

Jane Barnes: "Well, hopefully it will be in Committee, though."

Schneider: "Well, that hasn't been determined yet. I don't think, has it?"

Jane Barnes: "Ah... Mr. Schneider, you and I will be discussing this tiny turn alike..."

Schneider: "Well you haven't... To my knowledge it's not a Committee Bill at this point. I haven't seen ah... any indication on that. I think we ought hold the Second, hold the Bill on Second. You can move it."

Jane Barnes: "Well, you just ruled on 2102 and I'd like the same



consideration."

Schneider: "I didn't hear on 2102. I don't make the decisions."

Speaker Redmond: "Representative Duff, for what purpose do you rise?"

Duff: "Mr. Speaker, this is the second or third time this particular kind of atom has come up under the circumstances. And I agreed very much with ruling of the Chair before and I wonder if we could have it stated as a matter of policy that action on appropriations Bills, the substantive will, Bill of which may not be in a position to move it at this time will only be moved at the motion of the sponsor."

Speaker Redmond: "Well, the sponsor, in this case, has moved it."

Duff: "Yes, I agree with that. But I wonder if we could have that general understanding ah... as we had in 2102 and in this one. That would be a general practice so that we could have some ah... general..."

Speaker Redmond: "Not in blood. Not in blood, Representative Duff. In the vein, but not in the blood."

Duff: "Thank you, sir."

Speaker Redmond: "Representative Ryan, for what purpose do you rise?"

Ryan: "Well, Mr. Speaker, we just ruled on Representative Chapman's Bill, 2102 which was a substantive Bill. 2103 you moved to Third Reading. Ah... We have the same situation here with Representative Barnes' Bill."

Speaker Redmond: "As soon as the members seat, take their seats, we'll move it to Third Reading."

Ryan: "What members?"

Speaker Redmond: "Well, I see a few. Any further Amendments? Floor Amendment #1 to House Bill 2439. Who's the sponsor of the floor Amendment?"

O'Brien: "Jane Barnes."

Speaker Redmond: "You want to explain your Amendment? All in favor of the adoption of the Amendment indicate by saying 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. 2445. 2445."



O'Brien: "House Bill 2445. A Bill for an Act making an appropriation to the Department of Revenue. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 2454."

O'Brien: "House Bill 2454. A Bill for an Act making an appropriation to the Board of Vocational Educational Rehabilitation. Second Reading of the Bill. One Committee Amendment. Amends House Bill 2454 on page 1 by inserting between line 9 and 10 the following."

Speaker Redmond: "Representative Youngue."

Youngue: "Ah... Mr. Speaker and members of the House, the Amendment merely itemizes the Budget and I move for the adoption of this Amendment."

Speaker Redmond: "The lady has moved the adoption of Amendment #1 to House Bill 2454. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "No further Amendments. Third Reading. Representative Duff, for what purpose do you rise?"

Duff: "Well, Mr. Speaker, once again. If we could be told by the sponsor when they're moving the appropriation Bill whether or not the substantive Bill has been passed out or moved to interim study or some other phase."

Speaker Redmond: "What rule are you citing, Representative Duff?"

Duff: "It's not a rule, Mr. Chairman."

Speaker Redmond: "Okay."

Duff: "It's a request."

Speaker Redmond: "You're out of order, then. 2463. Another Amendment on 2454."

O'Brien: "Amendment #2."

Speaker Redmond: "Back to Second Reading."

O'Brien: "Amendment #2 amends House Bill 2454 on page 1, line 9 by deleting '78th' and inserting in lieu thereof '79th'."

Speaker Redmond: "Representative Youngue."

Youngue: "Technical error and I move the adoption of Amendment #2."



Speaker Redmond: "The lady has moved the adoption of Amendment #2 to House Bill 2454. All in favor of the adoption say 'aye'; opposed 'no'. The Amendment's adopted. Any further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "No further Amendments. Third Reading. 2463."

O'Brien: "House Bill 2463. A Bill for an Act making an appropriation to the Department of Transportation. Second Reading of the Bill. One Committee Amendment. Amends House Bill 2463 on page 1 by deleting line 8 and inserting in lieu thereof the following."

Speaker Redmond: "Representative Barnes."

Eugene Barnes: "Thank you very much, Mr. Speaker. House ah... Amendment #1 to 2463 changes House Bill 2463 from a dredging project to the construction of a flood ah... control ah... flood control structure. I move the adoption of Committee #1 to House Bill 2463."

Speaker Redmond: "The gentleman has moved the adoption of Amendment #1 to House Bill 2463. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. 2556."

O'Brien: "House Bill 2556. A Bill for an Act making an appropriation to the Illinois Commission of Labor Laws. Second Reading of the Bill. One Committee Amendment. Amends House Bill 2556 on page 1, line 5 by deleting \$40,000 and inserting in lieu thereof \$30,000."

Speaker Redmond: "Representative Schoeberlein."

Schoeberlein: "Mr. Speaker and ladies and gentlemen of the House, this is the only change in the Bill. A reduction of \$10,000."

Speaker Redmond: "The gentleman has moved the adoption of Amendment #1 to House Bill 2556. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. 2559."

O'Brien: "House Bill 2559. A Bill for an Act making an appropriation to the Illinois Housing Development Authority. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"



O'Brien: "Amendment #i. Amends House Bill 2559 on line 9 by changing 7.2a to 7.21a."

Speaker Redmond: "Who's the sponsor of the Amendment?"

O'Brien: "Meyer."

Speaker Redmond: "Representative Meyer."

Meyer: "Mr. Speaker, this corrects a paragraph numbering from 7.2a to 7.21a. I move its adoption."

Speaker Redmond: "The gentleman has moved the adoption of Amendment #1 to House Bill 2559. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. 2580. Representative Yourell, for what purpose do you rise."

Yourell: "Thank you, Mr. Speaker. On the order of Second Reading, ah... House Bills on the appropriation list, there appears House Bill 2445 that somehow is crossed over and not ah... acted upon. You went from..."

Speaker Redmond: "We advanced it to Third Reading."

Yourell: "You did?"

Speaker Redmond: "Yes."

Yourell: "Thank you very much."

Speaker Redmond: "2580."

O'Brien: "House Bill 2580. A Bill for an Act making an appropriation to the Department of Conservation. Second Reading of the Bill."

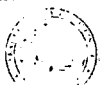
Speaker Redmond: "Representative Deuster."

Deuster: "Well, Mr. Speaker and ladies and gentlemen of the House, the Speaker is moving along so fast I'm tempted to mumble, but I would like to indicate that with House Bill 2580 the companion substantive Bill was caught in the shuffle Friday evening and referred to interim study calendar. However, I hope it springs eternal and I'm going to make an effort to get that out. So I would like to progress with 2580."

Speaker Redmond: "Explain the Amendment."

Deuster: "Amendment #1 actually rephrases the Bill, but this is a lateral transfer of \$225,000 from the State Voting Act Fund to the Illinois Water Patrol in the Department of Conservation."

Speaker Redmond: "The gentleman has moved the adoption of Amendment #1 to House Bill 2580. All in favor signify by saying 'aye'; opposed



'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "No further Amendments. Third Reading. On the order of Speaker's Table appears Senate Joint Resolution 41. Representative Washburn. Senate Joint Resolution 41. Representative Telcser."

Telcser: "Mr. Speaker, members of the House, Senate Joint Resolution 41 sponsored by Representatives Redmond and Washburn ah... re-affirms the independence of the State Election Board ah... with respect to its duties and functions. Ah... The Resolution in the various whereas clauses traces the historic development of the State Election Board's ah..., ah..., ah... legislative history, discusses the functions of the Board today, and threads throughout those various clauses ah... is the re-affirmation that the State Election Board is as we intended it to be. An independent agency, an agency that is not a partisan one and one that 'annoys' at one that should be ah... under the yoke of a Governor, whether that Governor be Republican or Democrat. The final paragraphs of the Resolution are resolved that the members of the State Election Board should not be subject to the Governors ah... Executive Orders and clearly delineates that the Governors appointments, so called, as designated in the original legislation were simply extensions of the appointments made or the nominees designated by the various legislative leaders. Ah..., Mr. Speaker, I now offer to move the adoption of Senate Joint Resolution 41."

Speaker Redmond: "Any discussion? The question is on the adoption of the Joint Resolution. All in favor of the adoption vote 'aye'; opposed say 'no'. The 'ayes' have it. The Resolution is adopted. Messages from the Senate."

O'Brien: "A message from the Senate by Mr. Wright, Secretary. Mr. Speaker, I am directed to inform the House of Representatives, that the Senate has adopted the following Senate Joint Resolution. The adoption of which I am instructed to ask concurrence of the House of Representatives, to wit. Senate Joint Resolution 42. Resolved, by the Senate, the 79th General Assembly, the State of Illinois,



the House of Representatives concurring herein that when the two Houses adjourn on Friday, May 23, 1975, they stand adjourned until Tuesday, May 27, 1975, at 12 o'clock, noon. Adopted by the Senate May 23, 1975. Kenneth Wright, Secretary."

Speaker Redmond: "Representative Shea."

Shea: "I move for the adoption of the Senate Joint Resolution."

Speaker Redmond: "The gentleman has moved for the adoption of Senate Joint Resolution 42. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. The Resolution is adopted. Representative Duff, for what purpose do you rise?"

Duff: "Point of order, Mr. Speaker."

Speaker Redmond: "State your point."

Duff: "We adjourned on the 23rd and we are already back in session.

What was the necessity of going through that?"

Speaker Redmond: "What rule are you quoting?"

Duff: "I'm asking a question, Mr. Speaker. Parliamentary inquiry."

Speaker Redmond: "Just to keep the record clear is all according to my Parliamentarian. Would hate it if you didn't get your per diem for coming today. House Bills, Second Reading. 2834."

O'Brien: "House Bill 2834. A Bill for an Act making an appropriation to the Wabash Light and Gallatin County Study Commission. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 2942."

O'Brien: "House Bill 2942. A Bill for an Act making an appropriation to the Education Service Region Study Commission. Second Reading of the Bill. One Committee Amendment. Amends House Bill 2942 on page 1, line 5 by deleting 20,000 and inserting in lieu thereof 5,000."

Speaker Redmond: "Representative Brinkmeier."

Brinkmeier: "Yes, Mr. Speaker and members of the House, as the Clerk has read, it reduces the amount from 20 to 5,000 and I urge the adoption of Amendment #1."

Speaker Redmond: "The adoption of the Amendment. All in favor of the adoption say 'aye'; opposed 'no'. The Amendment's adopted. Any



further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "No further Amendments. Third Reading. 2972. Representative Cunningham."

O'Brien: "House Bill 2972. A Bill for an Act making an appropriation to the State Board of Education. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Representative Cunningham, for what purpose do you rise?"

Cunningham: "Mr. Speaker, I rise to respectfully request that this Bill be held with agreement of the sponsor for an additional day for an Amendment. The Amendment was first offered in Committee and it lost there. 9, 9 1/2 to 0. The purpose of the Amendment is to fund the teachers retirement in accordance with the decision in the court case involving the I.E.A. versus the State of Illinois. The Amendment is being prepared; but despite the Herculean efforts of those preparing it, it will not be ready for an hour. Would it be an imposition to request a one days' delay?"

Speaker Redmond: "Well, the main sponsor is not here. So under the circumstances, we'll hold this."

Cunningham: "Thank you."

Speaker Redmond: "Were he here, we would go right through."

Cunningham: "I believe you, Speaker."

Speaker Redmond: "299... Take that one out of the record. 2991."

O'Brien: House Bill 2991. A Bill for an Act making an appropriation to the Department of Transportation. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 2995."

O'Brien: "House Bill 2995. A Bill for an Act making an appropriation to the J.L.I. Control Board. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 2996."



O'Brien: "House Bill 2996. A Bill for an Act to provide for the ordinary contingent expense of the Illinois Energy Resources Commission. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 3003."

O'Brien: "House Bill 3003. A Bill for an Act making an appropriation to the State Comptroller. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "Amendment #1, Harold Washington. Amends House Bill 3003 on page 1, line 10 by striking 1696 and inserting in lieu thereof 1775 and so forth."

Speaker Redmond: "Representative Washington."

Washington: "Mr. Speaker, members of the House, this Amendment makes certain deductions in line items in the appropriations for State Internship Program. I ask the adoption of Amendment #1 to House Bill 3003."

Speaker Redmond: "Representative Duff."

Duff: "Would the sponsor answer a question?"

Speaker Redmond: "Indicates he will."

Duff: "Representative Washington, it is my understanding that the Intern Program was developed this year to have a broader application to more areas, more districts."

Washington: "That's correct. It will cover all 59 districts of the State."

Duff: "And the line items..."

Washington: "The 30 northern districts will be covered by the consortium of colleges in the city of Chicago and the 29 southern districts will be covered by Sangamon..."

Duff: "And the line items don't diminish that broad coverage?"

Washington: "The line items do not diminish that broad coverage. That's correct."

Duff: "Thank you."

Speaker Redmond: "The gentleman has moved the adoption of Amendment #1 to 3003. All in favor of the adoption say 'aye'; opposed 'no'. Any further... er... the motion or the Amendment's adopted. Any further



Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. 3007."

O'Brien: "House Bill 3007. A Bill for an Act to amend an Act to regulate granting of assistance to indigent war veterans and their families. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 3021."

O'Brien: "House Bill 3021. A Bill for an Act to amend an Act in relation to compensation of members of the General Assembly. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. 3022."

O'Brien: "House Bill 3022. A Bill for an Act to amend an Act to amend the Illinois Municipal Code. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

O'Brien: "None."

Speaker Redmond: "Third Reading. Representative Duff."

Duff: "Well, Mr. Speaker, unfortunately, we've reached the point where ah... since we don't have the digest and these Bills are not printed, we're moving Bills now which are neither in the digest nor in the Bill Book and I wonder, Mr. Speaker, if it would be appropriate for us to hold at this point until we have either the printed Bill or the digest so that we may know what we are moving on."

Speaker Redmond: "Any discussion? Representative Ryan agrees. Anybody agree with Representative Ryan? Hearing none. How about Representative Totten, will he agree? He declines. Representative Shea."

Shea: "Are these Bills not printed?"

Speaker Redmond: "What did you say?"

Shea: "Are these Bills not printed?"

Speaker Redmond: "I believe they are printed."

Shea: "Could you tell me... I thought they were printed and distributed."



That's why Mr. Duff hasn't got them in his Bill Book."

Speaker Redmond: "They have been printed and distributed as far as our records are concerned. Representative Duff."

Duff: "Well, Mr. Speaker, I invite others to look at their desks. I think that I have, at least on this side of the aisle, the most complete Bill Book that we have with special effort of the Pages and the last Bill in it is 3016. And I don't believe that the Bill has either been printed and nor is it in the digest."

Speaker Redmond: "Representative Maragos."

Maragos: "Mr. Speaker, this is the same Bill that was 3020 because of a clerical error. If you have 3020, 3022 is the same Bill. They gave it a different number only because of a... It was not put in as a Committee Revenue Bill, but as a sponsor Bill and we had to correct it and table 3020. So if you have 3020, you have 3022. But this is was supposed to have been put in because it was put in last week."

Speaker Redmond: "I've been advised by the Chief Page that 2122 has not been distributed. So we will hold those. Senate Bills, Third Reading. Appears 2988. Representative Fennessey. Yes, back to Second Reading. We'll hold them. House Bill 2988. Representative Fennessey. Will you sit down?"

Fennessey: "Mr. Speaker, members of the House..."

Speaker Redmond: "The gentlemen would..."

Fennessey: "2988 is a Committee Bill that changes the primary date from in March to the first Tuesday in May. What Amendment #1 does is that as a candidate for the national convention delegates file at the same time as other candidates. A few years ago, we changed the filing for delegates because of the rules adopted by the Democratic National Committee. And this just brings the convention delegates filing at the same time as the rest of the candidates. I talked this over with the Republican spokesman of the Elections Committee. There's no opposition to it and I move for adoption of Amendment #1."

Speaker Redmond: "Any objection to moving House Bill 2988 from the order of Third Reading to the order of Second Reading? Hearing none, it's returned. Representative Fennessey has explained an



Amendment. The question is on the adoption of the Amendment. Those in favor say 'aye'; opposed 'no'. The 'ayes' have it. The Amendment is adopted. Any further Amendments?"

O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. The Joint Session will be convening in a matter of a few minutes. So we'll stand at ease. Representative Yourell."

Yourell: "Ah... An inquiry. A point of order. Ah... Senate Bills that have expired because of the 45 Day Rule, I have one ah... that is... The House sponsor is Representative Satterthwaite and about 10 that Representative McMaster is sponsoring and those Bills are posted to be heard in the Counties and Townships Committee tomorrow, Wednesday and I'm wondering if there was ever a motion made to extend the deadline on those Bills?"

Speaker Redmond: "I don't recall. We'll... Representative Barnes."

Eugene Barnes: "Thank you very much, Mr. Speaker. If it's proper at this time, I'd like to make a motion, Mr. Speaker."

Speaker Redmond: "Representative Campbell you're in between me and the member speaking."

Eugene Barnes: "If it's proper at this time, I'd like to make a motion concerning a posting date for Bills to be heard in appropriations tomorrow."

Speaker Redmond: "State your motion."

Eugene Barnes: "I would like to at this time, Mr. Speaker and members of the House, ah... waive the appropriate rule so that House Bill, Senate Bill 1487 could be heard in the Appropriations II Committee tomorrow morning. I talked with the ah... Republican minority co-spokesman. I talked with the Democratic leadership on this side of the aisle and there's no opposition to it."

Speaker Redmond: "Is there any objection? Hearing none. Leave is granted to post. Messages from the Senate. Representative Yourell, we'll have to find out the answer to that in the recess here."

in to be drawn for whatever Representative would like to go up in the hot air balloon ride ah... tonight before the baseball game, just come back to either Representative Calvo or myself for the list of names, thank you."

Speaker Redmond: "Representative Hanahan, there was a suggestion that that House Bill be amended to permit the Speaker to appoint the House member who should go up in the hot air balloon."

Hanahan: "We wouldn't need the propane gas, then."

Speaker Redmond: "It's a dead heat right at the moment. I won't mention who they are but it's a dead heat. Representative Friedrich."

Friedrich: "Mr. Speaker, I submitted to the Clerk of the House on May 23, a list of Bills on which I wanted to be recorded ah... on User List 0096 and 0098 and I'd like to ask for unanimous consent to have my vote recorded as provided by the list."

Speaker Redmond: "Any objections? Representative Shea."

Shea: "Mr. Speaker, I'm wondering if he'd hold this motion until after the Joint Session because this has to do with passing those two Users Lists and I'd appreciate it if we could wait until after the Session, until after the Joint Session."

Friedrich: "I understood the speaker to say we were not going to. We were going to adjourn at that time."

Shea: "Well, then could you hold it until tomorrow?"

Friedrich: "I have no objection."

Speaker Redmond: "We'll hold that until after the Joint Session. The hour of 1:30 o'clock designated in the Joint Resolution having arrived, the Joint Session of the 79th General Assembly will come to order. Will the members of the House and our esteemed guests from the Senate please be in their seats? Is a quorum of the House present, Mr. Clerk?"

O'Brien: "A quorum of the House is present."

Speaker Redmond: "Mr. President, is there a quorum of the Senate present in the chamber?"

President Partee: "Mr. Speaker, I am given to understand that a quorum of the Senate is present in the House."

Speaker Redmond: "There being a quorum of the House and the Senate in attendance, the Joint Session is convened. The honorable



Micheal J. Howlett, Secretary of State, the State of Illinois."

Secretary Howlett: "I would like to have better order than I had when I was Speaker here. Mr. Speaker, Mr. President, Senator Byrd and ladies and gentlemen, we have with us as our guest today a great American who's the Assistant Majority Whip of the United States Senate. In 1946, he was elected to the House of Delegates in West Virginia. He went on to the Senate, became a member of Congress and now a member of the United States Senate. No one in the history of West Virginia has served in a legislative body as long as he has and he's the greatest vote-getter in the history of that State. But, more importantly, he's a sound, middle of the road legislator. A great American, Senator Robert Byrd of West Virginia."

Senator Byrd: "Mr. Speaker, Mr. President, Secretary of State, Mr. Majority Leaders of both Houses, and Minority Leaders of both Houses, Members of the House and Senate, having been a Member of the West Virginia State House of Delegates, having been a Member of the West Virginia Senate, I feel a close rapport with you and I'm extremely grateful for the opportunity to visit with this ah... Joint Session. I want to express my thanks to the Speaker and the President of the Senate for their kindness in arranging for this Joint Session. In my days work I have to listen to many speeches on the floor of the Senate so I shall try to be considerate of the demands on your time and be reasonably brief. I count this as a special privilege to have been invited to address the Members of the Illinois Legislature and I would like to talk to you today as one legislator to another. The problems we face, are in many ways similar. The criticism we receive is probably very much the same and the rewards of public service and the satisfaction we feel when we have done a good job cannot be too different, whether in Washington or in Springfield. Government in the United States today, in Washington and in the State Capitals and in the Court Houses and the City Halls, is under closer examination from the citizenry than it has ever been in the 28 years that I have served in public life. Today as never before, I am aware that more people know more about legislative proposals and actions than in any previous time in my experience. I think this is true for two main reasons. What you and I do today, more clearly aspects the lives of more people than it has ever done before and the instant replay character and capability of present day news media flashes the story of our words and actions with incredible swiftness to our friends and foes alike. It is possible that when that towering son of Illinois, Abraham Lincoln, was shot in a theater in the nations capital, some people here in our country's heart land may not have heard the tragic news until days after the event. Contrast that with another assassination of another American President in Dallas,



when the American people saw almost the whole terrible drama unfold in their living rooms through television. Most political news is ah... fortunately, ah... not so dramatic, but today it is omnipresent. The microphone and the camera, tape recorder and the notebook are waiting just outside that Chamber of the Committee Room and by nightfall, the folks back in Sophia, West Virginia, know exactly what their elected Representatives have said and even how they looked when they said it. I do not think that this is necessarily bad, in fact it may be all to the good, but whatever the individual legislators evaluation of the news coverage to which he is subjected, or which he may seek, the fact is that it has added a whole new dimension to American politics. It may be argued by some today that politics is being over reported. One may think that the vast amounts of television time given to such events, such as the Senate's Watergate Committee Hearing or the hearings on the nomination of L. Patrick Gray or the hearings on the nomination of Nelson Rockefeller or the hearings on the nomination of Gerald Ford to be Vice-President; all of which hearings I have participated in as a Member of the Senate, with the exception of the Watergate Hearing. I think, however, that it should also be said that television looks to its rating and newspapers and magazines to their circulation and that the coverage would not be given if the public interests were not there. This means to us politicians that they.... we may be more on the spot than we think we are in the limelight. Public exposure is a two-edged thing that can cut us down as quickly as it can build us up. The public interests in the Congress of the United States and the Legislature of the State of Illinois and in all of our highly visible arms of government, stems from the fact that government at all levels is increasingly involved in almost every aspect of the citizens' life. We have come a long way indeed from Thomas Jefferson's famous dictum, that that government is dead, which governs least. Rather than any contention that government is over reported, I think that it can be persuasively argued that government is over expanded and over grown.



We're beginning the celebration of the 200th Anniversary of the American Revolution in which our Nation gained its independence. Perhaps we also ought to take note, in some way of the Bureaucratic Revolution of recent years, in which so much of America's traditional and cherished personal and business independence has been surrendered to the agencies of government. Almost one out of every five Americans now works for federal, state or local government. There are fourteen and one half million federal, state and local employees, 18.2% of the total U.S. payroll. Viewed from another angle, the cost of the federal governments activities alone, if continued at the present rate, by the year 2000 could eat up 60% of gross nation product. I'm old enough to remember when horse drawn wagons were still fairly common. As a matter of fact, I can remember when the battered furniture of my old foster father, who was a coal miner, was moved in a horse ah..... in a wagon and drawn by horses. It took three days to move the little bit of furniture that he possessed, but think for a moment of people..... people, instead of horses pulling a wagon. Let's try and visualize the situation we have created. We have created us. Put the productive people in the harness and the non-productives in the wagon. They the number of Americans riding in the wagon, those who recieved government benefits in one form or another, is greater than those who are pulling the wagon. There are now seventy-two and one half million riding and seventy-one and one half million pulling. Some of those riding, of course, get off part of the time to help with the job up front, but the full time load is getting heavier and heavier and heavier. In the years since Americas great deflation of the 1930's, I can remember that depression and possibly some of you do. Anyone who lived through it will never forget it. It has come to be accepted government policy and philosophy that the poor, the disabled and the other unfortunate members of our society should be taken care of by society as a whole. That compassionate approach, in my view, and I'm sure in your view, is right and proper. Society has



an obligation to help those who cannot help themselves, but many government programs now go beyond the humanitarian concept and we will eventually place in jeopardy, governments ability to do the necessary thing, if we ... if we continue to respond affirmatively to the increasing pleas that we do what, in the final analysis may well be unnecessary. So long as business and industrial growth and productivity is kept well ahead of the governments growth, the federal government and the states could safely embrace new programs and enter upon new areas of activity. Even if some programs proved impractical in the long run, not too much damage is done, but Mr. Speaker, when the situation is as it is now, when it is no longer practical to continue raising taxes again and again and again to pay for more and more and more costly programs, than danger lies ahead. That is one of the reasons that people are looking more closely at government today than ever before. They're questioning the use of their tax dollars. They're wondering if all of the activities that government is now engaged in, are really essential to their well-being. They're rebelling against over regulation in their lives and the proliferation of paper work and red tape. I get letters, day after day from the the small business people, from the professionals about these problems and I'm sure that you get the same kinds of letters. People are cynical about corruption and abuse of power and arrogance.... arrogance in office. Some of us forget that the path, that leads to Washington, leads back home. These things trouble me in Washington and I'm sure they trouble you. Mr. President, our jobs are probably are not too different in this regard. We're being weighed on the scales of public opinion and we must not be found wanted. The actions of a few, in recent years, have given politics an ugly image in much of the public minds. It is more difficult now than ever before to get good men and good women to stand for public office. All too many of our citizens are distrustful of politics and politicians. Many of them don't trust anybody; all politicians are bad. Each year more and more citizens drop their political party affiliation to



register as independents, if indeed they register at all. We should not forget that only 38% of the American people, eligible to vote, bothered to vote in 1974. Politics, while it is one of the most hazardous of professions, there is probably no other profession in which a man can hope to be of more service to his fellow man. It is a profession in which one can perhaps most easily lose his own reputation or even his own soul. It is the profession in which complete candor is perhaps the most difficult, if not impossible. It is the profession in which one must suffer the errors of criticism and often abuse and the stones of misunderstandings, but courage and sacrifice, self-discipline and forbearance are the unseparable companions of honor. Of all of the criticisms and disappointments, of all of the dangers and the trials that off set it, politics is still one of the noblest professions that any man or woman can choose. We who are politicians should keep this thought ever before us and I congratulate the men and the women who serve in these two great bodies because you sacrifice..... you sacrifice because you want to serve. You and I bear a substantial and serious responsibility as politicians and as public servants with a high profile. The legislative process, whether it is here or in Charleston, West Virginia or in Washington, is ever in the public eye and it should be. We have an opportunity, you and I, to contribute in a unique way to a restoration of confidence in government through legislative restraint as well as legislative largess. The Democratic self governments most vital aspect is to be found here in its legislative bodies. Other branches must carry out and interpret the laws and regulations that we make to govern society. We must draw our strength directly from the consent of the government, the people. I have not the slightest doubt that the heart and the spirit of the people are still basically strong. You and I, as their leaders, as well as their servants, have the duty to do all that is in our power to rekindle the faith of our people in their leaders and in their government. Let those of us who are here

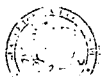


today, concerned with the dark and despairing problems of our times, be found always doing our duty. Thank you, Mr. Speaker. Thank you, Mr. President. Thank you, ladies and gentlemen."

Secretary Howlett: "Before I introduce to you another distinguished guest, I want to tell Roscoe Cunningham that we're not going to close the Drivers' License Station in Flora. You know, it is... Our alumni is so small, it isn't very often that I get a chance to introduce an old water polo player. But today, I consider it an honor to present to you a very effective, very able, hard-working public official, the Senior Senator from the State of Illinois, Chuck Percy."

Senator Percy: "Thank you very much indeed. I came prepared to listen, not speak at all. But with Mike's usual graciousness, I'm honored indeed to have this chance to say 'hello' to you and certinally, Mr. President, I'm honored to be in this chamber with the Speaker. I was delighted to be here for three reasons. First of all, my daughter, my son-in-law and my three grand-children, more of my family than live in any other State, look to Senator Byrd as their Senator. And ah... even though their party affiliation is not of my own particular choosing, and though some of my best firends are Democrats, I never thought my daughter would ever marry one of them and become a Democrat. I must say that they love the State of West Virginia as Senator Byrd does and we have, Lorraine and I, have learned to love it as well. But secondly, I, as soon as I heard that Senator Byrd was going to be here, I wanted to be in Springfield because I look upon him as one of the great legislators of all time. I think the United States Senate history will record that he will make a greater mark on the legislative process and for nine years, I have worked with him and under his direction as the Assistant Majority Leader; many, many times as the acting Majority Leader. What a marvelous combination of leadership we have with Senator Mansfield and Senator Byrd. And then, of course, on our side of the aisle, Senator Scott and Senator Griffin. But his impact on legislation is unmatched. When the Budgetary Reform Bill of 1974 was referred to the subcommittee and rules in administration, headed by Senator Byrd, I was somewhat concerned. We'd

worked on it in my own Committee for three years and to have another Committee suddenly take jurisdiction. But my concern was very shortlived. They held public hearings and Senator Byrd said, 'We will not hold that up'. And he held them himself over the Christmas holidays and made an immense improvement in the piece of legislation we'd gotten so close to, we'd lost sight of. And for the first time in the history of the Congress, we're going to try to establish a spending ceiling before we appropriate a single penny. And that's been what's wrong with the Congress of the United States for many years. So we're deeply indebted to him not for his nonpartisanship, but for his devotion to country, to his State, but all States in the Union and to the legislative process. And no matter whether the President is a Republican or a Democrat, when he feels he is right, Senator Byrd comes right down on the side of the President. I think that's what we must do. But third, I think I was deeply touched by what he said about the nobility of the legislative process. We do share in this country a great tradition of having a separation of powers. And it's that separation of powers that's preserved the Union in many respects. We cannot say that the legislative process in government is the noblest of all professions because that really is reserved for the divinity, and those who devote their lives to finding a way to have us better understand our relationship with our God. Nothing could be more noble than that. But we are the second most noble profession of all because it's our responsibility to help man define his relationship with his fellow man which we, in our society, do through law. So I join together in paying tribute on behalf of every member of this Legislature in gratitude to you, Senator Byrd, for being with us and emphasizing and putting in better perspective that profession that we all, in the tradition that we all hold so much in common. To make this a better and a stronger nation and my fellow Illinoisians, I can assure you that this is a better and stronger and greater nation because of the honor that we have had in the presence in the United States Senate of the distinguished Senator from West Virginia, Senator Byrd."



Secretary Howlett: "I want to express my appreciation to the Speaker and the President of the Senate for having this special session in honor of our two distinguished guests and tell Senator Percy that some of my best friends are Democrats. But I must say when he talks about being divine, he's a Democrat, too."

Speaker Redmond: "The President of the Senate, the honorable Cecil Partee is recognized for a motion."

President Partee: "Mr. Speaker, I move that the Joint Session do now arise."

Speaker Redmond: "Before the question is put, I want to affirm the fact that the President has advised me that there is absolutely no truth to the rumor that the Senate will not show up tonight. The President has moved that the Joint Session do now arise. Those in favor signify by saying 'aye'; opposed 'no'. The 'ayes' have it and the Joint Session will now arise. The House will come to order. Representative Madigan."

Madigan: "The Chair recognizes the gentleman from Cook, Mr. Shea."

Shea: "Mr. Speaker, I would move that the House would now recess for 5 minutes and then let the Clerk have 5 minutes to read in some Senate Bills, First. That we would then recess until 6:30 when he would finish reading in the rest of the Senate Bills, First and Committee reports and any messages from the Senate and that we would then adjourn until 9 o'clock a.m. tomorrow morning."
