Speaker Redmond: "Representative Williams."

Speaker Redmond: "Representative Caldwell, do you seek recogniztion?

Speaker Redmond: "Representative McClain."

McClain: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. Committee Amendment #1 I wish to table. I'd like to explain that it's exact same Amendment that was place on in the Senate and ah...



Representative Caldwell took this Bill for me and Banks and Savings and Loan, he's Vice-Chairman. and I defer to him, please."

Speaker Redmond: "Representative Caldwell."

Caldwell: "This is the Amendment that they've asked us to put on in the House, but we found it was already on in the Senate, Speaker. So I move that that Amendment be tabled."

Speaker Redmond: "The Gentleman's moved to table the Amendment #1.

All in favor say 'aye', 'aye'; opposed 'no'. The 'ayes' have it.

Amendment #1 is tabled. Any further Amendments?"

Jack O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. 543 as long as we have Representative McClain. 543."

Jack O'Brien: "Senate Bill 543. A Bill for an Act to amend the School Code. Second Reading of the Bill. One Committee Amendment."

Speaker Redmond: "Representative McClain."

McClain: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House, Committee Amendment #1 to Senate Bill 543 is much more restrictive than the ah... the original Bill ah... so stated. We believe that we had some problems with special districts and charter districts. So, therefore, we've included in the mandating of ah... transportation to pupils who reside more than one and a half miles from the school to include ah... high school districts and elementary districts with the agreement of ah... the parties as under the direction of Representative Art Berman and ah... I'd move for the adoption of Committee Amendment #1 to Senate Bill 543."

Speaker Redmond: "The Gentleman has moved for the adoption of the Committee Amendment #1 to Senate Bill 543. All in favor indicate by saying 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

Jack O'Brien: "Amendment #2, Londrigan. Amends Senate Bill 543 on page 1 in each of lines 1 and 5 by deleting Section 29-3 and so forth."

Speaker Redmond: "Representative Londrigan at all. Representative McClain, are you familiar with Amendment #2 Representative Londrigan's Amendment?"

McClain: "No, sir. I'm not."



Speaker Redmond: "Do you want to move it or keep it here for..."

McClain: "Let's move it, please."

Speaker Redmond: "Third Reading."

McClain: "I'd move for the adoption."

Speaker Redmond: "Representative Schlickman." Representative Schlickman."

Schlickman: "Has the filed not been ah... er... fiscal note been filed?"

Speaker Redmond: "I don't know. Has one been requested?"

Jack O'Brien: "Senate Bill 881, Ron Hoffman. A Bill for an Act to amend

an Act to provide for the creation and management of forest preserve districts. Second Reading of the Bill. One Committee Amendment.

Amends Senate Bill 881 on page 2 by deleting line 25 and 26 and so forth." $\,$

Speaker Redmond: "Representative Ron Hoffman."

Ron Hoffman: "Thank you, Mr. Speaker. There should be two Committee Amendments on that."

Jack O'Brien: "You're right, two Committee Amendments."

Ron Hoffman: "All right, one Amendment was prepared by the Reference Bureau to clarify some of the language and I would move for its adoption. The second Amendment ah... inserts per diem prior to fee and stipulates the amount of \$36 per day and I would move for its adoption."

Speaker Redmond: "The Gentleman has moved for the adoption of Amendment #1 to Senate Bill 881. All in favor indicate by saying 'aye', 'aye'; opposed 'no'. The 'ayes' have it. Amendment #1 is adopted. Any further Amendments?"

Jack O'Brien: "Amendment #2 amends Senate Bill 881 on page 1 and so forth."



Speaker Redmond: "Representative Hoffman."

Ron Hoffman: "The second Amendment as indicated indicates just the per diem fee and the amount specified, \$36. I would move for its adoption."

Speaker Redmond: "The Centleman has moved the adoption of Amendment #2 to Senate Bill 881. All in favor indicate by saying 'aye', 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

Jack O'Brien: "Floor Amendment #3, Daniels. Amends Senate Bill 881 on page in each of lines 1 and 6 by deleting Section 3A and so forth."

Speaker Redmond: "Representative Daniels."

Daniels: "Yes, Mr. Speaker, Ladies and Gentlemen of the House, Amendment #3, floor Amendment provides for the use of waste water through the production and sale of agriculture, silviculture and aquacultural products and I talked to the Sponsor. He agrees to the Amendment and I move for its adoption."

Speaker Redmond: "Hey, the House rules prohibit taking of pictures gentleman in the Gallery. I've got my shoes on, I'm not walking.

You can't take pictures. Where... Representative Giorgi."

Giorgi: "Mr. Speaker, I have a question for the Sponsor of the Amendment."

Speaker Redmond: "He indicates he'll yield."

Giorgi: "Does this ah... does this take over the county board's function as setting the per diems for the ah... members of the forest preserve districts or is this for the creation of their own forest preserve districts in a county?"

Daniels: "Well, that speaks to the Bill itself. The Amendment is, is different from that particular provision of the Bill."

Giorgi: "Ron Hoffman answer that question."

Daniels: "Can we move for the adoption of this Amendment and then maybe he'd answer the question after that if that's all right with you ah... Representative? I'd move for the adoption, Mr. Speaker."

Giorgi: "I'll support him."

Speaker Redmond: "The Gentleman's moved the adoption of Amendment #3



to Senate Bill 881. All in favor indicate by saying 'aye', 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

Jack O'Brien: "Amendment #4, Dyer. Amends Senate Bill 881 on page 1, line 1 and 6 by changing Section 3A and so forth."

Speaker Redmond: "Representative Dyer in the chamber? Representative Hoffman, what's your pleasure? Do you want it moved to Third or do you want to hold it?"

Ron Hoffman: "I would like it moved to Third."

Speaker Redmond: "Third Reading. Any other Amendments?"

Jack O'Brien: "No further Amendments."

Speaker Redmond: "910. 910."

Jack O'Brien: "Senate Bill 910. A Bill for an Act to amend the Shawneetown Regional Port District Act. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Jack O'Brien: "Amendment #1, Hart. Amends Senate Bill 910 on page, line 22 and so forth."

Speaker Redmond: "Representative Hart, 910."

Hart: "Yeh, oh, yeh ah... this, this ah... Bill amends the Shawneetown Regional Port District Act and adds two members to the ah... to the board. One to be appointed by the Mayor of Old Shawneetown and this Amendment would change the other appointment from the Office of the Governor to ah... the Mayor of Ridgeway. I move for the adoption of the Amendment."

Speaker Redmond: "The Centleman's moved for the adoption of Amendment #1 to Senate Bill 910. All in favor say 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

Jack O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. 957."

Jack O'Brien: "Senate Bill 957. A Bill for an Act to amend the Illinois Vehicle Code. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Jack O'Brien: "None."

Speaker Redmond: "Third Reading. 1109. Representative Schlickman."

Schlickman: "Is the Sponsor of this Bill here?"



Speaker Redmond: "Representative Hart."

Schlickman: "It's Representative Berman, I believe."

Speaker Redmond: "Oh, you mean 957."

Schlickman; "957."

Schlickman: "There is an Amendment to be offered."

Speaker Redmond: "Why don't we leave it on Second, then we won't lose it."

Berman: "All right, we'll leave it on Second."

Speaker Redmond: "1109."

Jack O'Brien: "Senate Bill 1109. A Bill for an Act to define executive agency recognition, reorganization and to regulate the expenditure of funds. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Jack O'Brien: "None."

Speaker Redmond: "Third Reading. 1118."

Jack O'Brien: "Senate Bill 1118. A Bill for an Act creating the Model School for the Deaf and the Hard of Hearing Study Commission. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Jack O'Brien: "Amendment #1, McCourt. Amends Senate Bill 1118 on page 1 by deleting line 1 and 2 and so forth."

Speaker Redmond: "Representative McCourt."

Schlickman: "I respectfully raise the issue of germaneness. We have a Bill here to create the Model School for the Deaf and Hard of Hearing Study Commission and by this Amendment, as I heard it explained, we would be recreating the Urban Area Study Commission. I question relevance. relevancy."

McCourt: "Well, Mr. Speaker, I'd like to ah... mention that this was brought up ah... I, I happen to be the Chairman of the Commission on Urban Education. Ah... through ah... ah... some, some fault, this was not ah... submitted before the deadline and it was, I was told, that this was the ah... vehicle that could be used and it would be considered germane and I would hopefully ah... ah... seek your support of this Amendment."

Speaker Redmond: "Representative Katz."

Katz: "Yes ah... on the question ah... of germaneness. In general, he is totally changing a Commission. Now I have constituents who are very interested in the Bill in its original form and are interested in the subject of Deaf and Hard of Hearing Study Commission and now by this Amendment, he is totally changing the legislation in which I know people who are interested in deaf and hard of hearing problems in my district are interested. It is not simply a question of satisfying his interest. It is that this is a Commission that meets the legitimate need and interest of people and it does seem to me a little unfair to snatch their Commission away from them."

McCourt: "Mr. Speaker, this does not do anything other than what the



Digest has. There actually will be two Commissions on this Bill. It leave the Bill in its original form. The Model School for Deaf and Hard of Hearing Study Commission. It adds to that the recreation of the Urban Education Commission. It does not change the Digest in any way. It just adds one other feature, the Commission on Urban Education."

Speaker Redmond: "Representative Katz, it appears from the Amendment that he is not eliminating the first Commission. He's adding the second one and under those circumstances, it would appear to me that it's germane. Representative Caldwell."

Caldwell: "I, I, I merely arose, Mr. Speaker, to agree with you and would hope that the people who are opposing this would ah... allow this to go.."

Speaker Redmond: "The original Commission remains in the Bill. It adds a second one. So I believe that under those circumstances, it's germane. Representative Schlickman."

Schlickman: "What is germane about this Amendment?"

Speaker Redmond: "What did you say?"

Schlickman: "What is germane about this Amendment?"

Speaker Redmond: "Well, its subject matter is Commissions and I believe this it's germane. It's one of those gray areas, I'll have to confess. The Gentleman has moved the adoption of Amendment #1 to Senate Bill 1118. All in favor indicate by saying 'aye', 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

Jack O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. 1131."

Jack O'Brien: "Senate Bill 1131. A Bill for an Act to amend the Southwest Illinois Metropolitan and Regional Planning Act. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Jack O'Brien: "None."

Speaker Redmond: "Third Reading. 1175."

Jack O'Brien: "Senate Bill 1175. A Bill for an Act to amend the Game Code. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"



Jack O'Brien: "None."

Speaker Redmond: "Third Reading. 1180."

Jack O'Brien: "Senate Bill 1180. A Bill for an Act to revise the law in relation to the Secretary of State. Second Reading of the Bill.

No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Jack O'Brien: "None."

Speaker Redmond: "Third Reading. 1380."

Jack O'Brien: "Senate Bill 1380. A Bill for an Act to create the Joint Legislative Service Commission. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Jack O'Brien: "None."

Speaker Redmond: "Third Reading. 1465."

Jack O'Brien: "Senate Bill 1465. A Bill for an Act to create the Illinois Governmental Information Service. Second Reading of the Bill.

No Committee Amendments?"

Speaker Redmond: "Any Amendments from the floor?"

Jack O'Brien: "None."

Speaker Redmond: "Third Reading. Senate Bills, Third Reading. On Senate... Senate Bills, Third Reading. On Senate Bills, Third Reading, appears Senate Bill 10, no, 184. The Sponsor's requested that we remove Senate Bill 184 to the order of Second Reading for the purpose of affixing an Amendment. Leave granted, return it to the order of Second Reading. Representative Ebbesen.

Ebbesen: "Mr. Speaker, we did that yesterday so it's on Third Reading

Speaker Redmond: "Well... Return it back to the order of Third Reading.

How about 208, Beaupre? Representative Schlickman, did we take care of that yesterday?"

Schlickman: "Mr. Speaker, I am the House Sponsor of this Bill."
Speaker Redmond: "208?"

Schlickman: "Yes, and I would as for leave of the House to return this Bill from the order of Third Reading to the order of Second Reading

for the purpose of offering Amendments."

Speaker Redmond: "Does he have leave? Senate Bill 208 will be returned



to the order of Second Reading. Representative Schlickman."

Jack O'Brien: "Amendment #1, Schlickman. Amends Senate Bill 208 on page 1, line 1 so forth."

Speaker Redmond: "Representative Schlickman."

Schlickman: "Mr. Speaker, Members of the House, Senate Bill 208 is an Amendment to the Campaign Financing Act and covers the issue of Committees that relate to both State and local candidates. The Amendment is an Amendment that was suggested in Committee. It's technical in nature, specifically that on the campaign material of the Committee covering both State and local candidates there shall be indicated on the face of it that a copy of the reports of the Committee are available at cost ah... from either the State Board of Elections or the County Clerk. It further provides that the Treasurer of the political committee shall file a copy ah... of the report filed with the State Board of Elections with the County Clerk and then on the second page ah... there's some language ah... that's deleted relative to the authority of the State Board ah... to charge a fee. This is covered elsewhere in the Bill. I respectfully move for the adoption of Amendment #1 to Senate Bill 208."

Speaker Redmond: "The Gentleman has moved the adoption of Amendment #1 to Senate Bill 208. All in favor indicate by saying 'aye', 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments."

Jack O'Brien: "Amendment #2. Amends Senate Bill 208 and so forth." Speaker Redmond: "Representative Schlickman."

Schlickman: "Mr. Speaker, Members of the House, Amendment #2 to Senate Bill 208 makes some technical changes. For example, it eliminates the reference to the 1974 ah... general election which is obsolete language. It does one other thing which is a matter of policy for this Body to determine and it would eliminate the necessity of the State Board of Elections to require ah... identification of the person or organization who are, who have filed requests for copies of reports of statements of organizations ah... by Committee. I move for the adoption of Amendment #2."

Speaker Redmond: "Any discussion? Representative Barnes. Representative



Barnes."

E.M. Barnes: "Thank you, Mr. Speaker. Would the Sponsor yield for just one question?"

Speaker Redmond: "Indicates he will."

E.M. Barnes: "Gene, when was the last ah... the effect of the Amendment of ah... persons or organization identifying theirself for information?"

Schlickman: "Amendment #2 as offered to this House for its consideration is a policy question as I indicated. One for this Body to determine. What the Amendment would do is to eliminate the requirement that the State Board of Elections require a person solociting a copy of a finance report or a statement of organization, eliminates the requirement of having the soliciter, the person seeking information, identifying ah... him or herself or identifying the organization. It's felt on the part of some people that this identification and its subsequent report to the Committee is inhibiting in nature."

E.M. Barnes: "Well, Mr. Speaker and Members of the House, could I have just a little order, Mr. Speaker."

Speaker Redmond: "Give the Gentleman order, please."

E.M. Barnes: "Mr. Speaker and Members of the House, I think this is one of the Amendments that many of you in the House should take some notice of. I think what we have here is a case where someone or some organization may go to the State Board of Elections and request specific information about you or about your ah... Committee in some form. Yet those people or that particular organization or person will not if this Amendment is enacted wil not have to identify themselves. Now I think that if we're going to live in a fishbowl, that people that are trying to look into information concerning us or how our Committees are established in or are ran should be willing to at least identify theirselves or the organization from which the information is being requested. I think that's the only right and proper thing to do and if ah... the effect of this Amendment is to eliminate the requirement, I think ah... it is a bad Amendment and I think many of you sitting here, all of you sitting here, will, this Amendment will have some effect in one way or another should take a real hard look at it."



Speaker Redmond: "Representative Kozubowski."

Kozubowski: "Mr. Speaker, will the Sponsor yield for a question?"

Speaker Redmond: "Indicates he will."

Schlickman: "No, I won't."

Speaker Redmond: "He indicates he won't."

Schlickman: "Yes, sir."

Speaker Redmond: "Indicates he will."

Kozubowski: "Representative, I would just like to know the reason for this Amendment and why those people who are requesting information dealing with our statements should not have to identify themselves." Schlickman: "Well, Representative, I indicated at the very outset that this was a policy question for issue to be decided by this Body. I further stated what the Amendment contained. The reasoning behind the Amendment is to eliminate the present or existing inhibition on the part of persons or organizations to seek copies of statements of organization or financial reports concerned that by their identity being revealed there may be some form of recrimination."

Kozubowski: "Well, I..."

Schlickman: "It's on that basis that I offer the Amendment and I leave it to this House in its judgement to ah... vote the Amendment up or down."

Kozubowski: "Mr. Speaker, may I proceed with another question?" Speaker Redmond: "Proceed."

Kozubowski: "Well, I think you've really skirted the question that I

asked you, Representative. I know that you're saying it's a matter of a policy decision, but I would just go one step further and say why is this Amendment or the contents of this Amendment necessary? Why should there be any ah... secrecy about whom is requesting information about our statement. What's the matter of policy? That's all I want to know. The question really is why? What's beneath this Amendment?"

Schlickman: "Well, as I stated previously, there is a feeling on the part of some people, some individuals and ah... organizations that by their being required to identify themselves and then having their identity revealed to the Committee that has filed the financial report or the statement of organization that there will a form



of recrimination that will have an inhibiting affect on these

individuals or organizations seeking this information."

Kozubowski: "Mr. Speaker, if I may speak against this Amendment."

Speaker Redmond: "Proceed."

Kozubowski: "Mr. Speaker and Ladies and Gentlemen of the House, I would

like to speak against this Amendment. My reasoning is very simple.

I certainly have no objections to anyone...

Speaker Redmond: "Give the Gentleman order."

Kozubowski: "I certainly have no objections to an individual or a group of individuals looking at the Ethics statements that I am required to file, however, I think merely as a matter of courtesy and I certainly don't see any means for recrimination at the Representative who is sponsoring this Amendment talks about. I think that if we are required to file these statements we should at least have the right to know who is requiring about the contents of those statements. Therefore, I would like to ask the membership of this House not to support the Amendment and to vote no."

Speaker Redmond: "Representative Schlickman."

Schlickman: "To close or are there others who desire."

Kosinski: "If I can have the attention of this body."

Speaker Redmond: "Give the Gentleman attention, please."

Kosinski: "I would like to speak to the Amendment."

Speaker Redmond: "Proceed."

Kosinski: "Ladies and Gentlemen of the Legislature, we make declarations by statute of this sort to permit people to investigate our backgrounds what our actions are and it is quite in accord with the law. At the same time I think we all enjoy a certain amount of curiosity. We are concerned as to who specifically is looking at our business and whether that look-in is legal in its intent. Now presently I get back triplicate documents indicating that I have been looked into without sufficient information to salve my curiosity. Where they indicate they are an analyst and for the purpose of seeing what my contributions were. I would like to know what organization is involved. So even in the use of these triplicates at this point in time, I think they are insufficient



But to deny me and everyone in this Legislature the option of knowing what organization is involved is incredible and I recommend that this House deny this Amendment."

Speaker Redmond: "Representative Peters."

Peters: "Mr. Speaker, I don't want to end up breaking the debate if there are alot of lights on there but I was going to move the previous question."

Speaker Redmond: "Representative Dunn."

Downs: "The last speaker, the distinguished gentleman from Cook has given

Speaker Redmond: "Please give the Gentleman order."

a perfectly good reason why he feels entitled to know who is looking at his records and he does so on the basis that he too like the public has the right to know, but this is clearly an Amendment that needs a kind word said for it and the questions have been asked well what is the need for it and why should they have to identify and I will give you two examples of why I think it is a very good Amendment. First, last year a number of us were embroiled in litigation over the question of filing of statements of economic interest and so in preparation for that we needed to determine who all filed and who didn't file statements and we made requests of the Secretary of State. We received three angry and eight curious telephone calls, but the important part is the angry calls that we received from public officials who demanded to know why we were looking at their statements. I think that is one good reason to have them. The other reason occurred last week. Another member of the General Assembly through some kind of misunderstanding that is not relavent to this apparently had made on his behalf requests to examine a number of disclosure statements among them mine and I received the copy in the mail indicating with his name on it the request for such information. Now I was mildly curious as to why he sought this information but I totally respected his right to have it and it did not bother me. But today I have learned that that individual is very genuinely and seriously was concerned that I might think that he is looking at my



records as though he doesn't have a right to see them and he also reported to me that others had contacted him with some concern as to why he is

prying into such records and I submit that is a good reason to dispense with this. I don't care and I am sure that individual doesn't care who looks at his records. I think that it is an intimidating apparently factor. It will inhibit public inspection of these records and if the purpose of disclosure is to be served which is the public's right to know then it is an excellent Amendment because I think that clearly the circumstances indicate that people may be intimidated, certainly members of this very body are very sensitive less anybody think they are prying. I submit they have a right to know and they need not apologize to me about it."

Speaker Redmond: "Representative Borchers."

Borchers: "Mr. Speaker and fellow Members of the House, I have but one remark to make. What is good for the goose, is good for the gander, I vote accordingly."

Speaker Redmond: "Representative Madigan. Representative Byers."

Byers: "I move the previous question."

Speaker Redmond: "The Gentleman has moved the previous question. The question is shall the main question be put. All in favor indicate by saying, voting aye, opposed no. All those in favor vote aye, opposed vote no. Have all voted who wish? Clerk will take the record Representative Choate."

Choate: "I was seeking recognition to explain my vote at the proper time, Mr. Speaker."

Speaker Redmond: "Representative Lechowicz."

Lechowicz: "Point of clarification, Mr. Speaker. This is to move the previous question, is that correct?"

Speaker Redmond: "That is correct."

Lechowica: "Thank you."

Speaker Redmond: "Have all voted who wish? Clerk will take the record.

On this question there are 128 aves. 3 no. Motion corries. P.

On this question there are 128 ayes, 3 no, Motion carries. Representative Schlickman to close."

Schlickman: "Thank you very much Mr. Speaker, Members of the House. In

offering this Amendment I described it and its contents. I also indicated to the Membership that there was a policy question that was involved.

I should say Mr. Speaker and Members of the House, that there is a multiplicity, a multiplicity of reports at the State and Federal Government



that involve each of us individually and there is no statutory requirement with respect to those reports where by the person seeking access to those reports is required to identify. I should point out Mr. Speaker, Members of the House, that this requirement is one that can be very easily evaded simply by having someone else do it on your part. This is a lie and I think that we should not be encouraging that kind of evasion. I offer the Amendment Mr. Speaker, Members of the House, so that this body can have the opportunity of reviewing its position on the matter. I respectfully suggest that this Amendment in a very critical area, the area of campaign financing will promote freedom of information and that it is a good Amendment and one that should be adopted and I thank you."

Speaker Redmond: "Representative Kosinski, point of order."

Kosinski: "Point of order, Mr. Chairman, would it be in order to reverse that Roll Call of the Amendment?"

Speaker Redmond: "I don't think so. The question is shall this Bill, shall this Amendment be adopted? Representative Choate. The question is shall this Amendment be adopted. All in favor indicate by voting aye, opposed vote no. Representative Choate."

Choate: "Well Mr. Speaker, Ladies and Gentlemen of the House, if you will give me your attention just one second."

Speaker Redmond: "Give the Gentleman your attention please."

Choate: "I dare say that there has not been a single member in State government today that has had their ethic statement looked at more than I have. And I dare say that standing on my own two feet I've got the same right to know whose looking at it that the general public has to took at it. And when you talk to me about the right to know as far as the media is concerned, and you talk to me about open meetings because the public has got a right to know, then what in the hell is wrong with us having the right to know, and I'll tell you one thing, I respect Representative Schlickman and I think that he thinks he's right, but Gene this is one time I have got to totally disagree with you and I have agreed with you on a lot of things. If there was ever a way, if there was ever a way to make a second clase citizen out of one who holds public office and must file an ethics statement within accordance of the laws of this State, this Amendment would do that very thing,



and I think that each and everyone of us should give it a resounding red light."

Speaker Redmond: "Representative McAuliffe."

McAuliffe: "Mr. Speaker, Ladies and Gentlemen of the House. I want to explain my no vote on this outrageous Amendment. During the past two or three months when the question of ERA was before the House, the members who voted in the past Session against ERA had their Ethics Statements pulled and their campaign finances statements pulled and the reason listed on there by the group that pulled it was for the lack of support of ERA and I was glad to know that the people that were backing the Equal Rights Amendment went to all the trouble to look up all of the Representatives statements to see how they voted. And the reason they put on there that they looked it up was because we failed to support the Equal Rights Amendment. I am glad to know what groups are looking at our statements because it certainly has an influence on the way you vote on their issues later on."

Speaker Redmond: "Representative GeoKaris."

GeoKaris: "Mr. Speaker and Ladies and Gentlemen of the House, in explaining my vote, I would like to say I don't think the ERA should be blamed or anyone else, I just don't think it is proper to have people become busy bodies instead of interested concerned citizens into those reports and I feel the only thing that we can do to be sensible about it is discourage the malicious person who just wants to cause trouble for nothing is to have them identify themselves and I urge a no vote."

Speaker Redmond: "Representative Choate."

Choate: "Just one little sentence that I left out, Mr. Speaker. And to be able to say it I have to do it on a point of personal privilege.

I said about how many had looked at my Ethics Statement and I want to tell everybody, nobody found a damn thing wrong with it either."

Speaker Redmond: "As I read the scoreboard, it's 13 to 138. Representative Schlickman."

Schlickman: "Mr. Speaker, Member of the House, it was not my intention or desire to bring up the time to impose upon the time of the House. I did think it was an Amendment that was worth consideration by this Body. I think there is an important policy issue involved. I do want to say this to the Gentleman from Anna. I have always respected his right to



disagree with another person and I appreciate that and for the Membership that's not aware the Cubs did win in ten innings four to three last night."

Speaker Redmond: "Representative Friedrich."

Friedrich: "Mr. Speaker and Members of the House, Russ Larson who is

President of Hollywood Candy Company felt there was a real need for
quick energy for the Members of this House so he sent up a little
Payday bar for everybody. I hope you enjoy it. In case you don't
know where Centralia is, it is half way between Chicago and Memphis."

Speaker Redmond: "Have all voted who wish? On this question there is 14 ayes, 15 ayes, 142 no's and the Motion is lost. The policy of the House I guess has been determined. Representative Washburn."

Washburn: "Thank you Mr. Speaker and Ladies and Gentlemen of the House.

We are pleased to have with us this afternoon a distinguished former colleague of our's who represented the 28th Legislative District, Jim Peterson, where are you Jim. There he is over there."

Speaker Redmond: "Any further Amendments?"

O'Brien: "No further Amendments."

Also allows those credit unions that are insured under the Federal Credit Union Act and subject to the rules of the Internal Revenue Code to become members of the Keel clan which allows them to accept up to 1500 a year for persons not members of a pension plan and who are self employed. I would ask adoption of this Amendment."

Speaker Redmond: "Representative Madison."

Madison: "Thank you, Mr. Speaker, would the Sponsor yield to a question?" Molloy: "Yes."

Speaker Redmond: "He indicates he will."

Madison: "Representative Molloy, what specifically does Amendment #2accomplish that Amendment #1 did not accomplish?"

Molloy: "Amendment #1 had some typographical errors. It was the same Amendment."

Madison: "The same Amendment. Okay."

Molloy: "With typographical errors." Madison: "Thank you."

Speaker Redmond: "Any further questions? The Gentleman has moved the -adoption of Amendment #2 to Senate Bill 522, all in favor indicate by



saying 'aye', 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments? No further Amendments.

Third Reading. 965."

Fred Selcke: "Senate Bill 965."

Speaker Redmond: "Representative Schlickman."

Schlickman: "Mr. Speaker, I would ask leave for the return of Senate
Bill 965 from the order of Third Reading to the order of Second
Reading for the adoption of an Amendment."

Speaker Redmond: "Does the Gentleman have leave. Bill will be returned to the order of Second Reading."

Fred Selcke: "Amendment #1, Schlickman. Amends Senate Bill 965 on page 1 in lines 1 and 6 and so forth."

Speaker Redmond: "Representative Schlickman."

Schlickman: "Mr. Speaker, Members of the Hose, Senate Bill 965 is a

Bill that amends the Park District Code and what this Amendment does
is to provide that the disconnection of provision in Section 3-6B

that is now available only in counties a million, would be available
in counties of more than a million and also provides that a copy
of the proposed annexing ordinance ah... shall be sent prior to its
effectiveness to the owners who are affected by the proposed annexation. Now I would and do move for the adoption of Amendment #1, House
Amendment #1 to Senate Bill 965."

Speaker Redmond: "Any questions? The Gentleman has moved the adoption of Amendment #1 to Senate Bill 965. All in favor indicate by saying 'aye'; opposed 'no'. The 'ayes' have it. The Amendment's adopted.

Any further Amendments? No other Amendments? Third Reading."

Giorgi: "Senate Bill 965, Third Reading."

Fred Selcke: "Senate Bill 1139. Ah... Got an Amendment ah... Mahar."

Giorgi: "Representative Mahar, Senate Bill 1139."

Mahar: "Thank you, Mr. Speaker ah... This is Representative Skinner's Amendment and he isn't here. I'd like to..."

Giorgi: "Is it your intention to take this Bill back to Second Reading for purpose..."

Mahar: "I'll take it back when the, when he arrives. He's here now.
I'll take it back."

Giorgi: "Hold the Bill, Mr. Clerk."



Mahar: "Hold the Bill please."

Giorgi: "How about 1260, Senate Bill 1260."

Fred Selcke: "Senate Bill 1260, ah... Kozubowski."

Giorgi: "Representative Kozubowski asks leave of the House to move

Senate Bill 1260 back to the Second Reading for the purpose of an

Amendment. Does he have leave? Leave has been granted. Put 1260
on Second Reading."

Kozubowski: "Is that Representative Kempiners Amendment?"

Fred Selcke: "Yes."

Kozubowski: "Okay, I have no objection to it."

Fred Selcke: "Amendment #2, Kempiners."

Giorgi: "No objection by the Sponsor. The motion is, the question is the adoption of the Amendment. All in favor of Amendment #2 to House, Senate Bill 1260 signify by saying 'aye'; those opposed 'nay'. The 'ayes' have it. The Amendment's adopted and Senate Bill... Any further Amendments?"

Fred Selcke: "No further Amendments."

Giorgi: "Third Reading. Senate Bill 1260. Senate Bill 1395."

Fred Selcke: "Senate Bill 1395."

Giorgi: "Representative Garmisa. Any House Amendments? Yes, sir, he wants leave of the House to bring Senate Bill 1395 back to Second Reading."

Fred Selcke: "Amendment #1, Garmisa. Amends Senate Bill 1395 and so forth."

Giorgi: "The Gentleman moves the Amendment of ah... the adoption of Amendment #1 to Senate Bill 1395. All in favor signify by saying 'aye'. Representative Barnes. Read the Amendment, Mr. Clerk."

Fred Selcke: "Amendment #1 amends Senate Bill 1395 by renumbering Sections 4 and 5 and Sections 3 and 4 respectively."

Giorgi: "Representative Garmisa on Amendment #1 to Senate Bill 1395."

Garmisa: "Mr. Speaker, the ah... ah... these ah... chap... er... these

paragraphs were misnumbered and this Amendment merely numbers them correctly. I ask for ah... ah... the House to ah... adopt Amendment #1."

Giorgi: "Any further discussion? The motion is, the question is the adoption of the Amendment. All in favor signify by saying 'aye';



the opposed 'nay'. The 'ayes' have it. Amendment #1 to Senate Bill 1395 is adopted. Third Reading. Representative Hart on Senate Bill 155."

Hart: "Ah... yes ah... with ah... the leave of the Sponsor, I'd like to have that ... "

Giorgi: "Mr. Clerk, read Senate Bill 155."

Hart: "No, it doesn't have to be read. It has to be returned to Second Reading."

Giorgi: "Senate Bill 155 back to Second Reading. Does he have leave? Leave has been granted. Senate Bill 155 is now on Second Reading for the purpose of Amendment."

Hart: "Ah... If I can get the attention of my ah... Representative Choate voted on the prevailing side of Amendment which I believe was #1 and ah... ah... he would like to move to reconsider the vote by which Amendment #1 was adopted so that ah... it can be ah... we can have another Roll Call on it."

Giorgi: "Mr. Choate, would you like to explain the move for the reconsideration of Amendment #1. Is that... Is that the reconsideration of Amendment #1?"

Hart: "That's right ah..."

Giorgi: "To Senate Bill 155, do you move to reconsider?"

Hart: "Yes, he does."

Giorgi: "Mr. Representative Schlickman."

Schlickman: "Can we be given an explanation of House Amendment #1."

Giorgi: "Mr. Hart."

Hart: "That's the reason that I was doing it because I'm going to explain it as soon as I made my motion. Ah... What happened on this Amendment was that ah... I had talked to Representative McMasters about it earlier last week and told him that I opposed it. It was actually ah... Representative ah... ah.... from Quincy ah... Mrs. Mary Lou Kent, right. Representative Kent's Amendment and I had also discussed it with her. There was some question about whether we were talking about the same kind of a taxing district and ah... they agreed that she was going to call her lawyer, I think, who represented the district and ah... find out. When I was off the floor, Friday afternoon, the Bill was called on Second Reading and the Amendment



was placed on the Bill. Ah... So I asked Representative McMaster and Representative Kent if they would give me the opportunity to take ah... to debate the Amendment on the floor and that's what's being done at this time."

Schlickman: "Oh, okay. Thank you."

Giorgi: "Representative McMasters. We haven't put the motion yet, have we?"

McMaster: "Mr. Speaker."

Giorgi: "Continue on."

McMaster: "Mr. Speaker, Ladies and Gentlemen of the House, the fact that ah... Representative Hart was not here the other afternoon had nothing to do with the Amendment being put on. It was the order of business. I did not know that Dick was absent and ah... certainly we had no intention of ah... doing something without his knowledge and this is the reason why we agreed to bring it back. Now I have not heard what the motion is. At the proper time, I would like to speak in regard to the Amendment."

Giorgi: "All right, in other words... Mr. Choate."

Choate: "Now, Mr. Speaker, ah... I think we've got the issue clear cut and I want Representative McMasters and Representative Kent both to understand that Representative Hart was not in no way saying that him being off the floor had anything to do with them calling the Bill or the Amendment at that particular time. It was just one of those unfortunate circumstances and I certainly want, certainly want this House to know that I appreciate Representative McMasters and Representative Kent giving Representative Hart and myself the opportunity of debating the merits of the Amendment. I appreciate it and I know that I speak for Representative Hart when I say that he appreciates it. So now, Mr. Speaker, I do move having voted on the prevailing side that the House now reconsiders the vote

by which Amendment #, #1 was adopted."

Giorgi: "You've heard the question. All in favor signify by saying
'ave': those opposed by all or a signify by saying

'aye'; those opposed 'nay'. The 'ayes' have it. The reconsideration is successful. Representative Hart."

Hart: "Well, now I think it would be proper for the Bill, for ah...

Representative Kent to present the Amendment and we'll present our



opposition to it. That would be my suggestion to the Chair."

Giorgi: "In other words, the same Amendment is being put?"

Hart: "That's right and ah... the Sponsor of the Amendment could explain the Amendment and we'll explain why we're opposed to it."

Giorgi: "Okay, Representative McMasters on Amendment #1 to Senate Bill

155. Are you moving now to put the Amendment back on Mr. McMasters?

The motion is to adopt Amendment #1 to Senate Bill 155. That's where

we're at at the present time."

McMaster: "Mr. Speaker, Ladies and Gentlemen of the House."

Giorgi: "Pardon me just a mount of the House."

Giorgi: "Pardon me, just a moment. Mr. Madison, for what reason do you rise?"

Madison: "Mr. Speaker, was Amendment #1 adopted before?"

Giorgi: "Yes, and it's been reconsidered and taken off."

Madison: "Reconsidered and tabled?"

Giorgi: "Taken off, no, just taken off of the Bill and now it's... The purpose is to put it back on."

Madison: "Well, I mean, how do you take it off unless it's tabled, Mr. Speaker?"

Giorgi: "No, it was just reconsidered and taken off of the Bill.

Madison: "Did we..."

Giorgi: "Speaker's table now."

Madison: "I don't remember us voting again on it ah..."

Giorgi: "We did."

Madison: "Okay."

Hart: "That's what we're going to do now."

Giorgi: "Now he's putting Amendment #1 back on the same Amendment, but they want to debate the issue. Mr. McMasters."

McMaster: "Well, Mr. Speaker, Ladies and Gentlemen of the House, we're not actually taking the Amendment off. We're reconsidering the Amendment at Representative Hart's and Choate's request. This Amendment was a Committee Amendment. As you know, several days or a week or two ago, we did pass a series of Bills by Representative Gil Deavers that changed the method of appointment to var... various districts ah... in the State of Illinois, the special districts. This happens to be ah... Water Conservancey District. At that time, the series of Bills that Representative Deavers had did not consider this



specific River Conservancy or Water Conservancy District. This applies to the fact that the Legislature becomes involved when a district crosses county lines. This has not been a very satisfactory method of appointment. Under that series of Bills, these appointive powers were given to the Chairman of the County Board in the district involved with the advise and consent of the County Board. The purpose of this Amendment is to add the Water Conservancy Distrixt into the same type of legislation so that all of these appointive powers will lay in the same place instead us having this one thing that we would still be involved in. Representative Mary Lou Kent came to the Committee with the Amendment and asked that we put it on. We ah... were glad to accommodate Representative Kent and it's our purpose when the Amendment comes to the floor to attempt to put it back on and I would certainly appreciate it if ah... Mary Lou would have a few words to say in regard to it."

Hart: "He has deferred to Mrs. Kent."

Giorgi: "Representative Hart."

Hart: "I think Mr. McMaster has deferred the explanation to Mrs. Kent at this point."

Giorgi: "Mrs. Kent on Amendment #1 to Senate Bill 155. Mrs. Kent."

Kent: "Thank you. This is no different than the one that ah... Representative Deavers had on the other districts. As you know, many of you have the forms that are sent to you from your district when it covers more than one county for you to sign for the trustee or commission. It seems to me that we should let those back home and the local control, we're so impressed with local control and want them to have their own that this is where it belongs. It will give the Count Board of each county the opportunity to elect or vote for the one that they want. I urge you to vote 'yes' on Amendment #1."

Giorgi: "Representative Hart on Amendment #1."

Hart: "Mr. Speaker and Ladies and Gentlemen of the House, now what we're, what we're debating here is the question of whether or not and it's River Conservancy Districts and not Water Conservancy Districts, whether or not this Legislature is going to retain the right to appoint the at large members of boards of trustees of River



Conservancy Districts or we're going to give up those appointments and give them to the County Boards of the multi-counties involved in the districts. Now although I didn't particularly favor the other Bills in giving up those powers which ah... we retained a couple of sessions ago when we passed all these Bills. Most of them were not of any, of any great importance and we did not ah... urge any opposition to it. But these appointments are paid emplo... a paid member of boards. And River Conservancy District trustees receive a \$3,000 a year salary and they manage ah... property of many millions of dollars. And I think they're very important positions and I believe that the Legislature should retain the power of these appointments unless there's been, there is demonstrated on the floor of this House some urgent reason for us to change it. It used to be under the Constitution, that the Judges made these appointments, but under the 1970 Constitution ah... it was eliminated and ah... legislation sponsored by ah... Representative George Lindberg, our present Comptroller, ah... placed the appointive powers in multicounty districts in the Members of the Legislature. These ah... appointments in our are very important and we would like for the Legislature to ah... support us in the retention of these appointive, appointments."

Giorgi: "Representative McClain."

McClain: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House.

I'd urge your support for this Amendment and I'k like to compliment
Mrs. Kent on the Amendment. It's a terrific Amendment. I don't
know how the rest of you handle it but in my area, we tend to or
at least I tend to just accept the nomination by your Conservancy
District or ah... by a lawyer who writes me a letter asking me to
sign a petition and I have no knowledge of the Conservancy District and how it functions, how well it functions and I think the
local County Boards ah... would ah... be more amenable to it. They're
closer to the situation ah... it's their people. I just think it's
a tremendous Amendment and ah.. I think it get it out, get it out

Giorgi: "Representative Choate."

Choate: "Well, Mr. Speaker, Ladies and Gentlemen of the House, I don't think it's a tremendous Amendment and I'll go into more detail as to



of our hair and I'd urge a favorable vote."

why I don't think it's a tremendous Amendment rather than just say that some lawyer submitted a name to me. If you're familiar with the amount of money that has come out of the coffers of the State of Illinois and the Federal government that has gone into projects like Rend Lake in our Representative District and in our Congressional District, then you ought to know that we ought to have a little bit more so say about who is going to be in charge of spending all of these hundreds of thousands and millions of dollars of taxpayers money. I found it true that being involved in the appointment that I look at the background of this man or woman whoever the case may be to see of she is qualified to see if she has or he has the best interest of first the Conservancy District and the taxpayers expenditure of dollars at heart. I'm saying to you that we who appropriate the moneys to bring about the effectiveness of an area such as this that can turn into one of the great recreational areas of the entire midwest, we in the Legislature who appropriate that money, should have something to say about the appointment of these people who's going to expend that money. That's how I feel about it and I think that if you will look at it from a constructive standpoint, from the standpoint that you want to do justice to having a board that will spend the taxpayers dollar feasibly and wisely, you will reject this Amendment."

Giorgi: "The question is on the adoption ah... Representative McMasters, to close, is that it?"

McMaster: "Well let me say one thing, Mr. Speaker, Ladies and Gentlemen of the House. The only time that we as Legislators become involved in the appointments is when the district extends beyond the boundaries of a single county. In other words, Clyde, if the district is included solely within one county, the Legislators have nothing to do with it and at that tim, it is the power and duty of the County Board to do so. I think this is good legislation. I think the Amendment is good, and as I said before when we adopted it last week, I would certainly urge that you vote in favor of this Amendment and put it on so that we can have all appointive powers in the same place instead of spreading part of them with the County Boards and part of them with the General Assembly. I urge a 'yes' vote."



Giorgi: "The question is the adoption of Amendment, Amendment #1 to Senate Bill 155. All in vot... All in favor will signify by voting 'aye' and those opposed by voting 'no'. Have all voted who wished? All voted who wished? Take the record, Mr. Clerk. Mrs. Kent."

Kent: "Could I explain my vote, please?"

Giorgi: "Yes, you certainly may."

Kent: "Could I explain to you that we have given the power back to the County Boards in every other kind of district. Why would this be different. Also, please open the board."

Giorgi: "I'm sorry. I apologize. Drop the..."

Kent: "I want this, Mr. Speaker, and I hope that people will vote green.

Members of the House, this is an important decision that you are
making now. It seems to me that by the time we pass a piece of paper
around to everybody, some sign, some do not. What do we do when
they don't all sign? What if there are two or three names? Then
it goes into court and then there are extra costs. To me, this is
very important to all of you and I hope that you will vote green."

Giorgi: "Representative Hart, to explain his vote."

Hart: "Well, Mr. Speaker, I think the issue is clouded here by ah... lack of attention and maybe a couple of Legislators have paid to these appointments. As Representative Choate pointed out in our 'no' vote here, when we, when the names of ah... persons are suggested to us for appointment to ah... the Board of Trustees of River Conservancey Districts, we look into their background. We find out their qualifications and we ah... ah... consider ah... the, what is the best interest of the ah... district and the management of this property. The Rend Lake ah... itself ah... is ah... owned and operated by the Corps of Engineers and the Rend Lake Conservancey District, for instance. That's a \$75,000,000 project and it isn't something that we should just want to give away ah... to anybody. I think what happened in ah... in the area represented by ah... the two Representatives from Adams that have spoken against, er... for this Amendment was that some name was submitted to them and ah... the signed some paper an it turned out that that was a bad suggestion as far as that person was concerned for that ah... River Conservancy District. But certainly one experience of that kind doesn't justify



the ah... ah... changing of the system as we're doing here. What, what is asked by this Amendment is to turn the appointments over to the County Boards and ah... certainly ah... ah... in view of the large responsibility that the Legislature has for the money for these projects within these districts, I don't believe that it's appropriate for the County Boards to have the say on the names of the persons who are ah... trustees and it should remain in the Legislature where we placed it several years ago as I pointed out on a Bill sponsored by Representative, then, George Lindberg. Ah... The importance of the appointments, the ah... consideration of where the money comes for the projects ah... urges this Legislature to retain the appointing power. I don't believe there's a single River Conservancy District in the State of Illinois that lies wholly within one county. So ah... what we're doing here is ah... is ah... retaining the appointment of these very important positions of which we fund ah... largely when a project comes ah... to the districts such as the Rend Lake ah... the ah... Saline Lake, the Carlyle Lake, the Shelby Lake and other major projects of such a nature as that."

Giorgi: "Are there any other explanation of votes? Mrs. Kent to explain her vote."

Kent: "I've explained my vote, but I want to say before the board is closed that I would like a verification please."

Giorgi: "Okay, have all voted who wished? Take the record. Mr. Clerk.

A verification has been requested. Do you want to poll the absentees
first? Mrs. Kent, should you ah... do you want to ah... verify
the negative rather than the affirmative to begin with or should
we... Mr. Hart, do you want the proper, regular procedure?"

Hart: "In accordance with the rules, that's right."

Giorgi: "All right, then let's poll the absentees and then ah... verify the affirmative and then the negative."

Fred Selcke: "Beaupre, Boyle, Brandt."

Giorgi: "Representative Beaupre."

Beaupre: "Mr. Speaker, I thought I was on that. I would like to vote 'yes."

Giorgi: "Representative Beaupre votes 'aye'. 'Aye' or 'nay'."



Fred Selcke: "'aye'. Byers, Collins, Epton, Fary, Getty."

Giorgi: "Hold it, Mr. Clerk. Mr. Fary."

Fary: "I would like to be recorded as voting 'no' ah... Mr. Speaker."

Giorgi: "Representative Fary 'no'. Excuse me, Mr. Clerk. Representative Getty 'no'."

Fred Selcke: "Getty 'no'."

Giorgi: "Continue on."

Fred Selcke: "Hirschfeld, Katz, Madison, Mann, Marovitz, Palmer, Schneider, Skinner, Waddell, Wall, Williams."

Giorgi: "Williams votes 'no'."

Fred Selcke: "Winchester, Mr. Speaker."

Giorgi: "Okay then let's take the affirmative... Excuse me, Mr. Clerk.

Representative Madison votes 'no'. How many does that make in the
affirmative and the negative, Mr. Clerk? The count at the present
time is 73 'ayes', 85 'nays'. Proceed with the affirmative verification."

Fred Selcke: "Anderson, Arnell, Jane Barnes, Beaupre, Bluthardt, Campbell, Capuzi, Carroll, Catania, Coffey, Daniels, Deavers, Deuster, Duff, Dyer, Ebbesen, Ewing, Fleck, Friedland, Friedrich, Gaines, Geo-Karis, Griesheimer, Grotberg, Gene Hoffman."

Giorgi: "Mr. Choate, for what reason do you rise?"

Choate: "I don't really know how Representative Hart is expected to see a single soul recognized their name being called with everyone on that side of aisle standing up."

Giorgi: "Your point is well taken, Mr. Choate. Now let's try to help with the verification by ah... at least pointing to the fellow if he's in the room or something."

Fred Selcke: "Gene Hoffman, Ron Hoffman, Holewinski, Jim Houlihan, Hudson, Dave Jones, Kempiners, Kent, Klosak, Kucharski, LaFluer, Lauer, Leinenweber, Macdonald, Mahar, McAuliffe, McClain, McCourt, McGrew, McMaster, Meyer, Miller, Molloy, Mugalian, Neff, Peters, Polk, Porter, Randolph, Rayson, Reed, Rigney, Rose, Ryan, Schisler, Schoeberlein, Schraeder, Schuneman, Sevcik, Simms, Stearney, E.G. Steele, Cissy Stiehl, Telcser, Totten, Tuerk, Walsh, Washburn, Willer. That's it."

Girogi: "Representative Washburn."



Washburn: "Thank you ah... Mr. Speaker. At the request of Speaker Redmond, the following persons are in the Speaker's office. If they could be verified without their being present and I'll give you the names and they are back there. Walsh, Ryan, Telcser, Totten."

Giorgi: "Excuse me, Mr. Washburn. Slower for the Clerk." Washburn: "Oh, Walsh, Ryan."

Giorgi: "Have they been voted? There's no change in their vote, are they..."

Washburn: "Telcser, Totten, Randolph and ah... myself, if you'll ah...

Thank you very much."

Mr. Choate we have a parlimentary snarl here and I don't know how previous Speakers have ruled but my personal opinion has always been that if a member is back on the Floor before the verification is completed, I think he is entitled to be voted. I would not want to be denied of my votes."

Choate: "Mr. Speaker, I certainly agree with you as for as Representative Griesheimer is concerned. I wouldn't want to deny him his perogative of voting when he had voted and then for some reason had to leave the Floor. Now let me ask you this, parlimentary inquiry though, Mr. Speaker. Those who those I'm talking about the green lights, now I'm not talking about the red lights because there has not been a completion of the verification as far as the red lights the negative votes are concerned. asks leave to bring it back to Second Reading for the purpose of an Amendment. House Bill 305... Any objections? Proceed, Mr. Fennessey. Clerk will read the Amendment. House Bill 3057. He's taken it back. We've already got leave to take it back to Second Reading for the purpose of an Amendment."

- Fred Selcke: "Amendment #1, Fennessey. Amends House Bill 3057 page 2 and so forth."
- Giorgi: "Representative Fennessey on Amendment #1 to House Bill, Committee Bill 3057."
- Fennessey: "Mr. Speaker, Members of the House, Amendment #1 does not change the Bill in any way. It just adds two lines that were inadvertently left out by the printer and ah... what it says, irregularity relied upon by petitioner was believed to have occurred or such other grounds relied upon by the petitioner. It doesn't change the substance of the Bill whatsoever and I ask for adoption of this Amendment."
- Giorgi: "Any discussion? The Gentleman moves the adoption of Amendment #1 to Committee Bill, House Bill 3057. Any, all in favor signify by saying 'aye'; the opposed 'nay'. The 'ayes' have it and the Amendment's adopted. Third Reading. We're trying to take care of some of the Members requests. Mr. Clerk, Senate Bill 543."

Fred Selcke: "Senate Bill 543."

- Giorgi: "Representative McClain. Representative Londrigan on Senate Bill 543."
- Londrigan: "Representative McClain's Bill and he said it was all right to move it back to Second for purposes of my second Amendment."
- Giorgi: "The Gentleman moves to ask leave of the House to move Senate
 Bill 543 back to Second Reading for purpose of Amendment. Does he
 have leave? Leave has been granted."
- Fred Selcke: "Amendment #2, Londrigan. Amends Senate Bill 543 page 1, and so forth."
- Giorgi: "Representative Londrigan on Amendment #1."
- Londrigan: "The purpose of this Amendment is that in transportation funds that are now earmarked will become unearmarked and local school boards may upon their own resolution, use the transportation funds in case of emergency for the educational fund and the Sponsor approves of the



Amendment. I move its adoption."

Giorgi: "The Gentleman moves the adoption of Amendment #2 to Senate
Bill 543. Any discussion? All in favor will signify by saying
'aye'; opposed 'nay'. The 'ayes' have it. The Amendment's adopted.
Any further Amendments?"

Fred Selcke: "No further Amendments."

Giorgi: "Third Reading. We have a House Bill that's on consideration postponed where the Sponsor wants to bring it back for an Amendment. Does he have leave? House Bill 783. It's on consideration postponed, 783. House Bill 783, okay Clerk. It's already been moved back to Second for purpose of an Amendment."

Fred Selcke: "Amendment #2, Calvo. Amends House Bill 783 by striking line 24 and so forth."

Giorgi: "Representative Calvo on Amendment #2 to House Bill 783."

Calvo: "Mr. Speaker, Ladies and Gentlemen, all Amendment #2 does is add a one sentence section in place of the present section 2 which says now the funds appropriated herein shall be used for the employment of medical examiners except for the purpose of medical evaluations for rehabilitation purposes. I've discussed this with ah... the Commissioner and he ah... agrees to the Amendment because that's what he said he planned to do with the funds that were in there anyway. So I would move for the adoption of Amendment #2 to House Bill 783."

Giorgi: "Any further discussion? Representative Ryan, on Amendment #2."

Ryan: "Will the Gentleman yield?"

Giorgi: "He indicates he will."

Ryan: "Representative Calvo, would you tell me once more or again what that Amendment does?"

Calvo: "It provides... There's some funds in there on contractual services, George, which I think ah... the Committee reduced somewhat, but the balance of the funds we were assured was not for purposes of employing impartial medical experts and in order to ah... make sure that that was correct, we put the language in that ah... the ah... Director said he wanted to use the money for ah... medical evaluations for rehabilitation. In other words, to see whether or not the man might need rehabilitation or would be beneficial and ah..



the Amendment just limits it to that, you know, puts the language in to limit it to that purpose."

Ryan: "Thank you."

Giorgi: "Any further discussion? Representative Schlickman on Amendment #2 to House Bill 783."

Schlickman: "783?"

Giorgi: "Yes, sir. It's on postponed consideration to whence it will return."

Schlickman: "Oh, this is House Bill. I'm sorry. Thank you."

Giorgi: "No further discussion? The Gentleman moves the adoption of
Amendment #2 to House Bill 783. All in favor signify by saying 'aye';
the opposed 'nay' and the 'ayes' have it and the Amendment's adopted.

It goes back to postponed consideration. Senate Bills, Second Reading.
I mean, House Bills, Second Reading. House Bill 235, Representative
Hill. That's Senate Pill 234.

Fred Selcke: "Senate Bill ah... 234. A Bill for an Act to amend Sections 1, 4, 6, 7, and so forth to Workmen's Occupational Disease Act. Second Reading of the Bill. Where's the Amendment? Amendment #1, Deavers. Amends Senate Bill 234 on 42, line 22 by striking the word procedural and so forth."

Giorgi: "Representative Hill on Amendment #1 to Senate Bill 234. Representative Deavers."

Deavers: "Mr. Speaker and Members of the House, Senate, Senate Bill 234 and what we're doing with this one Amendment, Amendment #1, is striking the work procedural and inserting including impartial medical standards for determining the extent of loss or disability and we feel that what this does is clarify that language and takes out the ambuguity that is created by the work procedural and I move for the favorable adoption of Amendment #1."

Giorgi: "Representative Hill on the Amendment #1."

Hill: "Mr. Speaker and Members of the House, ah... I am opposed to this particular Amendment, Amendment #1 ah... The Commission may appoint at its own expense impartial position. This Amendment would duplicate powers already existing under the act. Ah... The standards ah... certainly each case should go on its own merit and that the setting up the system in the way Representative Deavers wants it would eliminate



that procedure and I'd appreciate a vote in opposition to it."

Giorgi: "Is there any further discussion? The question is on the adoption of Amendment #1 to Senate Bill 234. All in favor will signify by saying 'aye'; the opposed 'nay'. The 'nos' have it.

Roll Call is requested. Then we'll signify by voting 'aye' and those opposed by voting 'nay'. All voted who wished? Take the record, Mr. Clerk. On this question there are 59 'ayes', 73 'nays', none voting 'present'. This Amendment is lost."

Fred Selcke: "Amendment #2, Schlickman. Amends Senate Bill 234 page 42, line 22 and so forth."

Giorgi: "Representative Schlickman on Amendment #2 to Senate Bill 234." Schlickman: "Well, Mr. Speaker, Members of the House, Amendment #2 is one in a series of Amendments that are intended to put this Bill in the form of which would make the Bill ah... acceptable to a number of us. Specifically, if I can direct your attention to page 42 of the Bill, Section 16 which provides that the Commission shall make and publish procedural rules and reg... and orders for carrying out the duties imposed upon us by law which rules and orders shall be deemed prima facie, reasonable, and valid. Now the law presently provides that the Commission can, shall make and publish rules and orders both of a procedural and substantive nature. What this Amendment does is simply to strike the word procedural so that the present ruling making authority of the Commission would be retained. Now without Amendment #2 ah... the Commission could not, would not be able to make any decisions, could not enter any orders relative to substantive matters. Thereby, promoting more litigation in the area of Workmen's Compensation. What this Amendment will simply do is to retain the law as it presently exists and will satisfy ah... the objective of objective individuals who feel that we should be resolving Workmen's Compensation problems ah... more by administrative activity and less by litigation. I, therefore, move, Mr. Speaker Members of the House, for the adoption of Amendment #2, House Amendment #2 to Senate Bill 234."

Giorgi: "Is there... Mr. Mugalian on Amendment #2."
Mugalian: "Yes, a question to the Sponsor."

Giorgi: "Proceed."



Mugalian: "How can a, a rule relating to the carrying out of the duties of the Commission be other than procedural?"

Giorgi: "Mr. Schlickman."

the Commission."

Schlickman: "Would you repeat that, please?"

Mugalian: "Ah... The Amendment would ah... strike the word procedural as I understand it and yet the rules referred to ah... are the ah... affect, the way in which the Commission would operate. It, it deals with the procedure of the Commission and, therefore, I think, almost by definition these would have to be procedural rules rather than substantive rules. The law or the substance is in the statutes. So I suggest that the Amendment doesn't do anything and the law as presently, the Bill as presently drafted clarifies the situation so that the Commission cannot make law. Making law is our duty, not that of

Giorgi: "Representative Hill, maybe you can answer that question."


Hill: "Well, no ah... Certainly the explanation given ah... by ah...

Representative Mugalian is correct and ah... the way the Bill is written certainly is in a correct nature and I would suggest that the Sponsor of this particular Amendment ah... apparently doesn't understand ah... that the word procedure should be in there and I would appreciate very much a vote in opposition to Amendment #2."

Glorgi: "Representative Schlickman to close."

Schlickman: "Mr. Speaker, Members of the House, I would simply suggest to the Sponsor of this Bill who is opposing this Amendment and of the Gentleman from Cook who raises the inquiry. If the word, if the present authority of the Commission was restricted solely to procedural matters in the area of rule making, then this Bill would not have the word procedural in it. It is a significant change and would constitute a significant change in the law; and it would by retention of the word procedural, result in further litigation as I indicated earlier the modern thought with regard to Workmen's Comp. is to keep at the administrative level as much as possible the resolution of claims for Workmen's Compensation rather than promoting litigation which this Bill will do and again I repeat my solicitation for your support and your 'aye' vote on Amendment #2."

Giorgi: "The question is the adoption of Amendment #2 to Senate Bill 234.



234 purports to do is to strike that provision of the present law and make any disease compensable, to wit. A person reports for work with a cold or a sore throat and if he gets a doctor to testify that such a disease, if it can be called that, is aggravated by his work, he's compensable, he's compensated under ah... the provisions of Senate Bill 234. What this Amendment attempts to do is to strike that language and go back to the original purpose of the Act and that is to compensate those employees who are aggrieved by reasons of a workplace origin. There's no such legislation existent in any other State. Those cost of this provision, 234, is beyond comprehension. Ah... It's just a bad concept entirely and what I am attempting to do with this Amendment is to revert back to the original language and that is not to make it compensable for those people who can consider themselves to be aggrieved and aggravated. For example, the cold or the sore throat. I, example... The example I mentioned a moment ago. I would move for the adoption of this Amendment." Giorgi: "Representative... Is there any discussion? Representative

Hill: "Mr. Speaker, Members of the House, ah... Representative Tuerk comes from certainly very clean and tidy plants like Caterpiller, but I happen to come from a plant that isn't quite as tidy and we have more difficulty involved in this particular subject and if you are transferred from one department to another, especially into our smithshop, you will find out that the situation exists where it's possible to be aggravated ah... with that dust over there or with welding as far as that's concerned and I certainly would suggest that you vote in opposition to this particular Amendment."

Hill on Amendment #4."

Giorgi: "Any further discussion? Representative Tuerk to close."

Tuerk: "Well, Mr. Speaker, Members of the House, I suggest to the Sponsor of this Bill that if an employee has a cold or a sore throat and he works in those areas where he feels it's going to be aggravated, then he's better off to stay off of work that day rather than aggravate it and then expect the employer to compensate him for the aggravation. I submit to you and Members of the House that this is a ludicrous part of this Bill. It should be ah... the present language of the Act should be retained. When a person is injured at his place



of work then it makes sense to compensate him for that. But when a person reports to work with a coal or a sore throat or some other minor ailment and he gets somebody to testify that it has been aggravated because he has been at work, then I say that this should not be reason for compensation and I re-submit to you this language in this Amendment

voting no. Mr. Hill to explain his vote." Hill: "Mr. Speaker and Members of the House. I feel confident that the medical profession in the State of Illinois are more honest than Representative Tuerk would like us to believe. And he brings up the situation of a cold. This goes much further than just a common ordinary cold and if the piece of legislation that is vitally needed but this Amendment is not needed and I would appreciate a no vote in regards to it."

the error that was made in Amendment #2 or 3 rather."

Giorgi: "Just a moment Mr. Walsh, Representative Hill, on a point of order."
Hill: "Mr. Speaker, that Amendment hasn't been distributed and ..."

Giorgi: "Don't you have that?"

Hill: "No the Amendment you had was certainly mislabeled by page number and

by line number."

Walsh: "I can tell you pretty much what it does, Representative Hill. It'
Hill: "Do you insist..."

Walsh: "I don't insist..."

Hill: "You have it on the next Bill and why don't you run it on the next

Walsh: "Well, the problem with it is that it's loused up on the next Bill too, and also as you knew. Also if we are going to adopt this Amendment it should be adopted on both of them because they are very similar and there is no need to have it on the Workmen's Compensation Bill and not the Occupational..."

Hill: "Mr. Speaker, I would like to have leave for bending the rules for the Minority Leader over there and Assistant Minority Leader, I'm sure he would never do that for us. But all through this whole situation that I have experienced, I have bent over backwards to see that Mr. Walsh and Mr. Tuerk has gotten more than a fair break even though at

Walsh and Mr. Tuerk has gotten more than a fair break even though at times they weren't quite proper with me, but as I say I'll request that they bend the rules for those poor gentlemen over there and see what we can do."

Giorgi: "Representative Hill turns the other cheek. Representative Walsh."

Walsh: "Well not, if he'll just turn a little bit further Mr. Speaker. This wouldn't hurt him a bit to accept this Amendment. All it does, all it does is change from three years in the Bill to two years the statute of Limitations on when a suit can be brought on an occupational disease



matter. Now the Bill extends the time from one year to three years. So this is doubling the period in which a suit can be filed under the

occupational or a claim can be filed under the occupational disease act.

The Bill chose to triple it, that is unreasonable. Now may I also suggest that if you are in an automobile accident sustain personal

injury two years is the period of time in which you have to make a claim or file suit against the person who injured you. This makes the

Bill consistent with other statutes with respect to personal injury.

I don't see any reason why it should be any different for this than it is for other things and I submit to you that it is entirely as

is for other things and I submit to you that it is entirely reasonable and I would hope that Representative Hill who has been magnaminous for the past little while would accept this Amendment."

Giorgi: "Ms. Geo-Karis on the Amendment."

Geo-Karis: "Mr. Speaker and Ladies and Gentlemen of the House. I think

it is much easier on the rights of the agreed to know that there is

a statute consistent with the personal injury statute in workmen's compensation. I think this Amendment is very reasonable. It does extend the period from one year to two years. All personal injury cases now are two years except for malpractice and that will be changed once those malpractice. Wills are the content of the period of the changed

once those malpractice Bills come through and I certainly urge your consideration of this Amendment. It's far simpler for the people who are grieved. It's not just for business. It's for the labor people to know that they are consistent with the rest of the personal injury statutes."

Hill: "Mr. Speaker and Members of the House. I am surprised that the good Representative on the other side would pick on this particular section because this is a recommendation of the national commission and

Giorgi: "Representative Hill on Amendment #5."

Giorgi: "Representative Walsh to close."

I am sure he wouldn't want the Federal Government to come in here and direct us to do this. Certainly I understand his philosophies more than that and I would suggest that you would vote down this Amendment.

Walsh: "Mr. Speaker, Well, it's entirely reasonable it seems to me that the Sponsor would accept this and I am surprised to see that he is not.

Now another problem that this is going to bring about that occurs to me is that insurance premiums are going to go unreasonably high because they



are going to have to retain a pool of money for possible claims for a good deal longer than they presently do. Three times as long under the present Bill, but two times as long under this Bill. Now that is going to be money that is retained and kept for service where no one is going to get any benefit. Now this entire Bill, this entire Bill is going to raise the cost of products to people in the State of Illinois for goods made in the State of Illinois. This Bill is going to drive industry it's going to drive business from the State. This is a small attempt to make the Bill a little more reasonable by doubling the period during which a person has to make a claim. Doubling mind you the Bill would triple it and I think it is reasonable and I think we ought to adopt it."

Giorgi: "The question is on the adoption of Amendment #5 to Senate Bill 234.

All in favor will signify by voting aye and those opposed by voting no.

Representative Beatty on the Amendment to explain his vote."

Beatty: "I would like to briefly explain my vote. In the case of an occupational disease, it may take a little longer to determine actually whether you have got such a disease and to extend it to two years is not unreasonable but the Sponsor of this Bill is actually saying let's limit the statute of limitations to two years. We don't want these rates to go up. In fact what he is saying is we don't want workers who sustain occupational disease to get paid for them. That's what he is saying. So all I say is let the workers get paid if they get something through their employment. Let this term be extended more reasonably. Let the rates go up if they go up and let our workers who get diseases at their plants get compensated and that's what this

Giorgi: "Representative Mugalian to explain his vote."

Amendment is all about and it's a bad Amendment."

Mugalian: "Mr. Speaker, I can't say that I feel very strongly that it should be one year, two years, or three years, but this is a very controversial measure and many of us are going to have a difficult time in making a final decision when the Bill comes up for Third Reading. I would suggest that perhaps to engender a spirit of compromise that we certainly not try to defeat all of the Amendments that are sincerely presented by members of one point of view. Doubling the statute of limitations would make it coincide with the statute



66. of limitations on personal injury and ab... an affirmative vote and the passage of this rather minor Amendment would indicate a spirit of trying to work this problem out together and I would suggest that ah... on this one, many of us might want to vote 'yes' to indicate that spirit of working together on a very difficult problem."

Jack O'Brien: "Representative Madigan in the Chair." Madigan: "Have all voted who wished? The Clerk will take the record.

On this question there are 61 'ayes', 76 'nos', 1 voting 'present' and Amendment #5 having failed to receive the majority is hereby declared lost. Are there further Amendments?"

Jack O'Brien: "No further Amendments."

Madigan: "Third Reading. On the order of Senate Bills, Second Reading appears Senate Bill 235. The Chair recognizes the Gentleman from Kane, Mr. Hill."

Jack O'Brien: "Amendment #1, Schlickman. Amends Senate Bill 235 on page 54, line 2 by striking the word procedural and so forth."

Madigan: "The Chair recognizes the Gentleman from Cook, Mr. Schlickman." Schlickman: "Thank you, Mr. Speaker. House Amendment #1 to House Bill

235 is identical to House Amendment #1 to Senate Bill 235. It's strikes the word procedural which is not in the existing law. It's a modifying word that is in the Bill and in lieu of the word procedural, would insert the language including impartial medical standards for determining extent of loss or disability. As was indicated previously, the insertion of the word procedural is new. It's limitating and contrary to the thought and views of those who are interested in reforming Workmen's Compensation in indus... ah... in disability laws to contain as much as possible the administration of the Act at the administrative level through the Industrial Commission rather than promoting litigation. Now I move for the adoption of House Amendment #1 to Senate Bill 235."

Madigan: "Is there any discussion? The Chair recognizes the Gentleman from Kane, Mr. Hill."

Hill: "This Amendment to 235 is the same Amendment that was issued ah...

on House, on Senate Bill 234 and went to a resounding defeat and I would appreciate a 'no' vote."

Madigan: "The Chair recognizes the Gentleman from Cook, Mr. Mugalian."

Mugalian: "Would the Sponsor of the Amendment yield?"

Madigan: "The Sponsor indicates that he will yield."

Mugalian: "Well I don't have a copy of the ah... Amendment before me,

but I heard the explanation that it deletes the word procedural but

then I think it adds some language and I wasn't, didn't know that.

What is the effect of the additional language?"

Schlickman: "Well it simply provides that the rules that are established

by the Industrial Commission ah... would concern themselves with the impartial medical standards for determining extent of loss or disability. Certainly the medical determination as to the extent of loss or disability can be subjective depending on source and by this Amendment, we would clarify and insure a maintenance of the Indus-

trial Commissions present rulemaking authority to insure that there will be impartial medical standards for determing the extent of loss or disability."

Mugalian: "Mr. Speaker, may I ask the Sponsor of the Bill a question?

Ah... Representative Hill..."

Madigan: "The Sponsor indicates that he will yield."

Mugalian: "Would there be any objection if the word procedural were left in and you also included this language and if there is an objection, what would it be?"

Hill: "Well first of all, the Amendment is not drawn up that way and
I have held this Bill ah... since last Thursday and I would like to
certainly ah... proceed with the Amendments the way they're written
and ah... try to pass this Bill on Third Reading."

Mugalian: "Well, I'm only asking you if the additional language would hurt the Bill."

Madigan: "The question is shall Amendment #1 to Senate Bill 235 be

adopted. All those in favor signify by saying 'aye'; all those opposed by saying 'no'. In the opinion of the Chair, the 'nos' have it and Amendment #1 is lost. Are there further Amendments?"

Jack O'Brien: "Amendment #1 is lost. Are there further Amendments?'

Jack O'Brien: "Amendment #2, Tuerk. Amends Senate Bill 235 on page

20, line 4 by striking the word incompetency and so forth."

Madigan: "The Chair recognizes the Gentleman from Peoria, Mr. Tuerk."

Tuerk: "Mr. Speaker, Members of the House, this is new language to

the Act. I don't know how to define incompetency. The words men
tal incapacity are quite ah... incisive. There's no need to change

the present language and that's why this Amendment is being drawn

and submitted to ah... refer back to the original language of the Act. Ah... I'm sure the Sponsor can't explain to anyone in the chamber what incompetent means. It cant' refer to minors ah... It's just confusing and it'll lead to useless litigation. I think the present language is sufficient and spells out very well what we're talking about and I would move for the adoption of the Amendment to House Bill, er... Senate Bill 235."

Madigan: "The Chair recognizes the Gentleman from Kane, Mr. Hill."

Hill: "Mr. Speaker and Members of the House, I oppose Amendment #2

to Senate Bill 235. The present language of the Bill would exempt

minors from the statute of limitations until a guardian is appointed.

The Amendment would make the statute of limitations apply to minors

even under 16 years of age and I'd appreciate a 'no' vote on this

Amendment."

Madigan: "The Chair recognizes the Gentleman from Cook, Mr. Mugalian."

Mugalian: "Yes, Mr. Speaker. Thank you. I would also like to add that ah... the term incompetency has legal meaning and it's surprising that this word wasn't used in the statute long ago. Mental incapacity is an imprecise term that does not carry with it the connotation of the inability of a person to represent himself in court and incompetency does cover minors and those who've been ajudged to be imcompetent and I think it's a necessary important technical addition to the I'm surprised there's any objection to it."

Madigan: "The Chair recognizes the Gentlemen from Christian, Mr. Tipsword;"
Tipsword: "Mr. Speaker, Ladies and Gentlemen, also I'd like to add that
the provisions of the Probate Act which provide for the appointment

of guardians and conservators as provided in this Section which is purported to be amended. It uses the term incompetent and is the only term that is used ah... in regard to those for the conservator and the ah... ah... guardian ah... is to apointed under that Section and consequently, this is legally the proper term as pointed out by Representative Mugalian."

Madigan: "Is there further discussion? There being no further discus-

sion, the question is shall Amendment #2 to Senate Bill 235 be adopted. All those in favor signify by saying 'aye'; all those opposed signify by saying 'no'. In the opinoin of the Chair the 'nos' have it and Amendment #2 is lost. Are there further Amendments? Are there further Amendments?"

Jack O'Brien: "Amendment #3, Hudson. Amends Senate Bill 235 on page 7 by deleting lines 25 through 27."

Madigan: "Who's the Sponsor of the Amendment?"

Jack O'Brien: "Hudson."

Madigan: "Mr. Hudson. The Chair recognizes the Gentleman from DuPage,
Mr. Hudson."

Hudson: "Yes, thank you very much, Mr. Speaker. Ladies and Gentlemen of the House, Amendment #3 to Senate Bill 235 ah... on page 7 of the Bill deletes lines 25 through 27. Now what the ah... Amendment does is to strike out the provision which ah... Well, I'll put it this way. The additional coverage of any business in which electric, gasoline, or other power driven equipment is used goes much too far and that's what the three lines do. They add ah... to ah... the definition of ah... hazardous occupations ah... the coverage of any business in which electric, gasoline, or other power driven equipment is uesed. It would seem to us that this is unreasonable. It will require a Workmen's Compensation policy for everyone who uses ah... for example a pocket calculator or dictating machine or even an electric typewriter. Presently, such coverage is only elective.

This Bill makes it compulsory and any such person who did not get a policy would be guilty of a petty offense under the criminal code. Now it seems to me, Ladies and Gentlemen of the House, that this

sort of ah... provision snuck into this Bill here, 235, is just foolish ah... type of business. Is there any crying need to be

met in the office of a real estate broker and insurance agency or a sole practitioner of the law for this type thing? Doesn't seem to me to be reasonable that it, that it should be, but here it is and this Amendment, 235, addresses itself to that problem. It would delete those three lines and I would urge a favorable vote on this

Madigan: "Ladies and Gentlemen of the House, I would like to introduce a former Member of the House of Representative standing on the Republican side of the aisle and talking to Representative Jones, former Representative Ben Harpstrite. Benny, how are you. The Chair recognizes the Gentleman from Kane, Mr. Hill."

Hill: "Mr. Speaker and Members of the House, this Amendment above all others is one of the worst. Now if any of you people have ever operated any ah... power driven machinery and I'm sure that you have especially in a factory. It's one of the most dangerous areas there is and I certainly would appreciate a 'no' vote on this Amendment."

Madigan: "The Chair recognizes the Gentlemen from Cook, Mr. Mugalian."
Mugalian: "Will the Sponsor of the Bill..."

Madigan: "The Sponsor indicates that he will yield."

Mugalian: "Representative, I've read the three lines which this Amend-

ment would delete and I'm concerned that this may include workers in, say a two ah... an office where there are two employees, including a secretary and a bookkeeper, an electric typewriter, it seems to me would technically fit this description as would an electric adding machine and the third part of my three part question is would this include someone who delivers materials or supplies by use of an automobile?

Hudson: "Well in response, I would say yes it does include..."

Mugalian: "My question is of Representative Hill."

Hudson: "I beg your pardon."

Mugalian: "Maybe he wasn't..."

Amendment."

Hill: "I was consulting with my attorney, but I think what you asked was ah... you're afraid that two people working in an office would come under this provision. I don't believe it would."

Mugaliam: "Well many of us have small law offices and small insurance

businesses. Isn't that ah..."

Hill: "If it was highly hazardous, I could see why it would come under it. But under the conditions that you state, I feel confident that you would not be covered in your office where two people are employed."

Madigan: "Is there any further discussion? There being no further discussion, the question is shall Amendment #3 to Senate Bill 235 be adopted. All those in favor signify by saying 'aye'; all those opposed signify by saying 'no'. In the opinion of the Chair, the 'nos' have it and Amendment #3 is lost. Are there further Amendments?"

Jack O'Brien: "Amendment #4, Hudson. Amends Senate Bill 235 on page 16..."

Madigan: "The Chair recognizes the Gentlemen from DuPage, Mr. Hudson on Amendment #4."

Hudson: "Thank you, Mr. Chairman. Ladies and Gentlemen of the House, Amendment #4 to Senate Bill 235 ah... goes to page 15 of the Bill and deletes lines 23 through 25 which include the ah... which does this. It takes out the ah... lines or within six months after the appointment of a legal representative. Now what we're talking about here is that the way the Bill stands currently unless these lines are deleted, an individual is permitted to sue anytime he obtains ah... legal counsel. The ah... statute limitations might never run under this Bill. Ah... For example, assume 14 year old boy who may be illegally employed at a particular job and ah... he does nothing about rejecting the Act which he has to do to be able to ah... sue within six months. At age 40, he could get a legal representative appointment and be able to sue. Now this Bill as it ah... it's now worded, says that this is timely by its phrase whichever is later. The Bill reads, he will have the right within six months after the time of injury or death, that's the way it reads currently and then ah... has been added, or within six months after the appointment of a legal representative which shall be later to file with the Commission a rejection of his rights to the benefits under this Act. Well clearly this extends his time, his permission to ah... do this filing and to ah... possibly ah... gain the benefits

72. of ah... Workmen's Comp. Almost for the period of the rest of his lifetime if he chooses to play the game that way. Now this was never the intention of the ah... of the ah... Bill, the law in the first place and it seems to be a gross perversion of the ah... original intent of ah... the compensation features. And it's clearly a provision which should be rejected and I urge your 'aye' vote on this Amendment which addresses itself to that correction and I, I urge ah... my colleagues an 'aye' vote on this Amendment #4."

Madigan: "The Chair recognizes the Gentleman from Kane, Mr. Hill." Hill: "Mr. Speaker, this Amendment specifically relates to minors under 16 and it seems to me that the guardian when he is appointed should have additional time and the Sponsor of this Amendment is eliminating that additional time and I'd appreciate a 'no' vote on it."

Madigan: "Ah... Incre being no further discussion, the question is shall Amendment #4 to Senate Bill 235 be adopted. All those in favor signify by saying 'aye'; all those opposed signify by saying 'no'. In the opinion of the Chair, the 'nos' have it and Amendment #4 is lost. Are there further Amendments?" Jack O'Brien: "Amendment #5, Walsh. Amends Senate Bill 235..."

Madigan: "The Chair recognizes the Gentleman from Cook, Mr. Welst." Walsh: "I move to table Amendment #5." Madigan: "Is there leave? Leave being granted, Amendment #5 is tabled.

Are there further Amendments?"

Jeck O'Brien: "Amendment #6, Tuerk. Amends Senate Bill 235..." Madigan: "The Chair recognizes the Gentlemen from Peoria, Mr. Tuerk." Tuerk: "Mr. Speaker, Members of the House, Amendment #6 is a real important Amendment. What Senate Bill 235 does in its present form is put temporary total disability and permanent partial disability all in one bag. Now I submit to you they are different and need to be classified as being different and what this Amendment does is designate and returns the language of the present differential be-

tween permanent partial and temporary total benefits. Many of you on the House floor probably don't know the difference between tenporary total and permanent partial and it gets to become a pretty complicated subject, but the point is the proponents of this Bill,

the way it's presently written would lead you to believe that the National Commission has recommended this change when, in fact, the Commission has not and what I'm saying that there should be a differential between these two. Namely, temporary total benefits and permanent partial benefits and I'd be glad to explain the difference of those two if you don't know what they are. But what I'm saying, in this Amendment is that the Act now provides, the Act in its present State provides for the differential and it also provides a benefit schedule of maximums where as the Bill as proposed would eliminate that differential and ah... make these maximums which are now current the minimums and I submit to you that we do need this Amendment on this Bill and I would move the adoption of Amendment 6 to Senate Bill 65, 235."

Madigan: "The Chair recognizes the Gentleman from Kane, Mr. Hill."
Hill: "Mr. Speaker, if I understand the Amendment properly ah... the
word more would change the present compensation rates from maximums
instead of minimums so that compensation benefits would be reduced
instead of increased. The present language is designed to preserve
the present benefits so that no one receives less under this Bill
than they would receive now and I'd appreciate a 'no' vote on this
piece of legislation."

Madigan: "The Chair recognizes the Gentlemen from Peoria, Mr. Tuerk."

Tuerk: "Well, Mr. Speaker, Members of the House, what the Sponsor of the Bill just said is not true and I want the Members to know that. He, he gave you the bum dope ah... when he tried to explain that because what ah... more means is that it takes the maximums, what the Bill purports to do is to take those maximums and make them minimums. Now what this Amendment does is put it right back where it was to make it maximums. That's all."

Madigan: "Is there further discussion? There being no further discussion, the question is shall Amendment #6 to Senate Bill 235 be adopted. All those in favor signify by saying 'aye'; all those opposed signify by saying 'no'. In the opinion of the Chair, the 'nos' have it and Amendment #6 is lost. Are there further Amendments?"

Jack O'Brien: "Amendment number..."

Madigan: "For what purpose does the Centleman from Peoria, Mr. Tuerk,

arise."

Tuerk: "Mr. Speaker, I wasn't able to ah... discern that much of a margin. I'd like a Roll Call on that Amendment."

Madigan: "Are you joined by five of your fellow Republican colleagues?

You are. We will have a Roll Call on Amendment #6. The question is shall Amendment #6 to Senate Bill 235 be adopted. All those in

favor signify by voting 'aye'; all those opposed by voting 'no'.

The Chair recognizes the Gentlemen from Christian, Mr, Tipsword,
to explain his vote."

Tipsword: "In explaining my vote, it appears to me in trying to insert the language that on line 8 and 9 of the Amendment, when you insert it, it doesn't in the use of the English language even make sense any more. So it doesn't appear to me that this, that the Amend... that possibly ah... be adopted and have ah... a sensible

provision in that paragraph at all."

Madigan: "Have all voted who wished? The Clerk will take the record.

On this question there are 54 'ayes', 86 'nos', 1 voting 'present'

and Amendment #6 is lost. Are there further Amendments?"

Jack O'Brien: "Amendment #7, Schlickman. Amends Senate Bill 235 on

page 54, line 2 by striking the word procedural."

Madigan: "The Chair recognizes the Gentlemen from Cook, Mr. Schlickman."

Schlickman: "Mr. Speaker, Members of the House, the issue underlying this Amendment has been well discussed. I ask for a Roll Call."

Hill: "All I ask for is a 'no' vote. I agree with the Sponsor of the Amendment, it has been thoroughly discussed."

Madigan: "On this question, excuse me, the question is shall Amendment

Madigan: "The Chair recognizes the Gentleman from Kane, Mr. Hill."

#7 to Senate Bill 235 adopted. All those in favor signify by saying 'aye'; all those opposed by saying 'no'. In the opinion of the Chair, the 'nos' have it and Amendment #7 is lost. Are there further Amendments?"

Jack O'Brien: "Amendment #8, Ryan. Amends Senate Bill 235 on page 8..."

Madigan: "The Chair recognizes the Centlemen from Kankakee, Mr. Ryan."

Ryan: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House.

Amendment #8 to House Bill 235 ah... on line 19 makes some changes that shall apply to real estate brokers, brokerage firms and employees of the, brokerage firms and salesmen who are paid on a commission basis and for law firms which employ associate members on a salary basis and ah... fair legal professionals on a salary basis and I would ask for a favorable Roll Call."

Madigan: "The Chair recognizes the Gentlemen from Kane, Mr, Hill."

Hill: "Well, Mr. Speaker and Members of the House, these are not now specifically identified ah... If covered, the nature of the employment is at all hazardous and if there were insurance involved in this, it would be minimal and I certainly would request that you give a 'no' vote to this Amendment."

Madigan: "The question is shall Amendment #8 to Senate Bill... For what purpose does the Gentlemen from Kankakee, Mr. Ryan, arise?"

Ryan: "I'd like to close on the Amendment, Mr. Speaker."

Madigan: "Oh, thank you. Mrs. Geo-Karis, do you seek recognition?"

Geo-Karis: "Yes, I do. Mr. Sneaber."
Madigan: "Prior to Mr. Ryan."

Geo-Karis: "Yes, I do, Mr. Speaker."

Madigan: "Fine, proceed."

Geo-Karis: "Thank you, Mr. Speaker. Mr. Speaker and Ladies and Gentlemen of the House, I, I think we're going away from the actual orbit of the thrust of the Bill and I think this Amendment is simply trying to say that any real estate agency or brokerage firm that employs real estate brokers and associates and salesmen and any law firm which employees associate members on a salary basis and/or employees ah... fair legal professionals on a salary basis would not be included in there. And ah... I think it's only fair because what the thrust of the whole Bill is is to protect the labor, not the professionals and therefore I certainly urge your consideration and favorable vote on this Amendment."

Madigan: "The Chair recognizes the Gentleman from Kankakee, Mr. Ryan, to close the debate."

Ryan: "Well, thank you, Mr. Speaker. I certainly agree with Representative Geo-Karis and as Representative Hill pointed out ah... they're not spelled out in the Bill. They're not ah... these people are not left ah... are not exempted by this Bill and what's this Amendment does and I'll tell you. If I were in a law firm, I'd be very

interested in this Amendment. Ah... this, this keeps members, associate members or even pari-professionals that you may hire in your law firms ah... real estate people that are on commission.

Ah... This keeps these people from collecting on this Bill and I think it's an excellent Amendment and I would ask for an 'aye' vote."

Madigan: "On this question, er... the question is shall Amendment #8 to Senate Bill 235 be adopted. All those in favor signify by saying 'aye'; all those opposed signify by saying 'no'. In the opinion of the Chair, the 'nos' have it and Amendment #8 is lost. Are there further Amendments?"

Jack O'Brien: "Amendment #9, Tuerk. Amends Senate Bill 235 on page 68, striking line 18 through 29."

Madigan: "Who's the Sponsor? The Chair recognizes the Gentleman from Peoria, Mr. Tuerk."

Tuerk: "Mr. Speaker, Members of the House, the Section that sh... I'm proposing to amend here is the reason why I asked for a fiscal note on this Bill because in this Section, Senate Bill 235 proposes to add a penalty of 25% in the event that an, the employees injury results from the employers violation of an OSHA safety standard. Now as we all know, the purpose of Workmen's Compensation is to compensate the injured employee and to eliminate the element of fault on the fact of the employer and the employee. If an employer is to be fined under the provisions of Senate Bill 235, an additional 25% for ah... OSHA violations. Then it seem logical, sensible that perhaps the employee ought to be fined if it is out of ah... negligence on the part of the employee because the national safety counsel estimates that over 75% of the industrial accidents are contributable to employee negligence. Now the reason I ask for a fiscal note to this Bill was simple because if you get into this area as provisions of this Bill provide, it's going to ah... get into many fishing expeditions and it's going to increase the cost of the Industrial Commissions ah... administrative responsibilities and by the Industrial Commissions own adminition, they're going to have to have additional employees to police these provisions and it's going to cost anywhere from \$600,000 to \$1,000,000 a year just for the provisions of this particular Section of the Act. That's the reason

for the Amendment. I think it should be eliminated and I would ask for your favorable support to adopt Amendment #9 to Senate Bill 235." Madigan: "The Chair recognizes the Gentleman from Kane, Mr. Hill." Hill: "Mr. Speaker and Members of the House, the Section that's now in the Bill and that would be eliminated by this particular Amendment, I have run into continuous problems for quite some time. Not only in the factory I work in, but listening to employees complain about other factories including the one where this gentleman works. It's very difficult and I'd like you to know that to get some of the manufacturers to eliminate not only health hazards but accident hazards and this certainly in the long run would reduce their insurance because they would be more inclined to fix up the situation that are accident prone. There are many times that companies are requested to take care of belts or to take of machinery where people bave been injured and completely refused to do it and certainly with this incentive in the Bill the way it is now, those manufacturers and place of business would be more inclined to see that these areas were cleaned up and fixed up so some human being would not be injured. So I ask for a 'no' vote on this piece of legislation."

Madigan: "The Chair recognizes the Gentleman from DuPage, Mr. Hudson."
Hudson: "Well, Mr. Speaker and Ladies and Gentlemen of the House, ah...

it seems to me that some of the ah... discussion that's been carried on here has to do with businesses of considerable size, but it should come as no news to you that many businessmen, particularly the smaller businessmen are already finding ah... OSHA, this Federal ah... octopus ah... of extreme concern to them as small businessmen complying with its rules, regulations, and so forth. Now all of us subscribe to the idea of safety in business or anywhere else, but I will submit to that adding 25% more to the compensation here allowed because there was some violation of an OSHA regulation somewhere maybe is going to have an impact on the small businessman in Illinois that he can ill afford and here's another case of another provision that's going to make it additionally difficult for businesses in Illinois to stay in Illinois to new businesses to want to come into Illinois and I certainly would ah... urge a support. I think this

is a very ah... a very ah... key Amendment here that Representative

Tuerk has and I would support him fully on this one and would urge you to instead of ah... ah... perhaps of voting an automatic red light here to give it your full consideration and ah... vote in what ah... truly ah... can be and I believe to be the best interest of ah... business people in Illinois and hence the workers and working men in the State who wants jobs and a place to, aplace to work."

Madigan: "The Chair recognizes the Gentleman from Cook, Mr. Mugalian." Mugalian: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House, fear that many of us are not being attentive to all the Amendments that have been offered to this very important Bill and to the previous one and I would like very much for those of my colleagues who are lawyers on both sides of the aisle and those who have voted against these Amendments to listen just for a moment and to consider the implications of this Amendment. I believe that this Amendment addresses something very significant in the Bill as presented. This Bill for the first time, introduces into Workmen's Compensation cases the element of negligence. It in... It includes the intentional tort and also of negligent tort. Up to now Workmen's Compensation cases have been ah... based on on the basis of, of loss and without fault. It's a very revolutionary concept when Workmen's Compensation laws came into effect. We are now going to have the Industrial Commission get into the case, cases of deciding whether harm resulted from the intentional or negligent action on the part of the employer. A revolutionary concept which I wish you would consider carefully. Now those of you who have some familiarity with OSHA or represent clients who have manufacturing businesses, I think will agree that there is no plant or office or industrial facility in this State that does not OSHA violations. If you read this Act carefully, you will have to conclude that the, the new venture upon which we would embark if this Amendment is not adopted would be incalculable in its effect upon the Workmen's Compensation system. I'm not just talking about the cost. I don't care what it costs to have safe plants and to have safe working conditions, but I think you should think twice before converting Workemen's Compensation in part to a law suit as negligence or intentional tort. I

suggest this is a good Amendment."

Madigan: "The question is shall Amendment #9 to Senate Bill 235 be adopted. All those in favor signify by saying 'aye'; all those opposed signify by saying 'no'. In the opinion of the Chair, there should be a Roll Call. The question is shall Amendment #9 to Senate Bill 235 be adopted. All those in favor signify by voting 'aye'; all those opposed by voting 'no'. All voted who wished? Have all yoted who wished? The Charle will a be a senate by the wished?

voted who wished? The Clerk will take the record. On this question there are 58 'ayes', 81 'nos', no voting 'present' and Amendment #9 is lost. Are there further Amendments?"

Jack O'Brien: "Amendment #10, Tuerk. Amends Senate Bill 235 on page 60 by inserting..."

Madigan: "The Chair recognizes the Gentleman from Peoria, Mr. Tuerk."

Tuerk: "Mr. Speaker, Members of the House, I drew this Amendment because of the advice and counsel of the Sponsor of the Bill, Representative Hill. This Amendment says merely that maximum fees for attorneys practicing before the Industrial Commission shall not exceed 10% of the amount in excess of undisputed compensation payments. It is an Amendment which ah... Representative Hill ah... recommended. I was listening quite attentively in Committee and that's where the idea for the Amendment eminated from the Sponsor of the Bill himself

and I would move for the adoption of the Alendment."

Madigan: "The Chair recognizes the Gentleman from Kane, Mr. Hill."
Hill: "Mr. Speaker and Members of the House, never would I try to advise Representative Tuerk what to do or what not to do. I've learned long ago that I cannot implant my pregnant ideas into his mind and I certainly would never try to do that. Although I had made some statements similar to this, I'd like to point out that since that I have talked to quite a few of the people that practice in this particular field. I find out it's more difficult than I realized. The Commission itself has the right to set the rates and I intend leaving it with the Commission to do and I'd appreciate a 'no' vote on this piece of legislation."

Madigan: "The Chair recognizes the Lady from Lake, Mrs. Geo-Karis."

Geo-Karis: "Mr. Speaker and Ladies and Gentlemen of the House, I'm

speaking as an attorney. I am willing to be paid only 10% of the

fee anyone who's injured and I think if I am willing and I'm in the field, I certainly think that those people who are not intrepidated with any ideas of unfair play toward labor should support this Amendment."

Madigan: "The Chair recognizes the Gentleman from Franklin, Mr. Hart."
Hart: "Well, Mr. Chairman, ah... Speaker and Ladies and Gentlemen of
the House, this Amendment would violate the prevailing wage law
and it should be defeated."

Madigan: "The Chair recognizes the Gentleman from Cook, Mr. Beatty." Beatty: "Mr. Speaker, Members of the House, at the present the Industrial Commission is authorized when there's any questionable fee to look into it and assess it properly. Many of these Workmen's Compensation cases especially in the more serious injuries are cases that are ah... a lawyer must spend many hour with, many times he'll sit with the file and work with it a couple of years and in order to do justice to his client to prove up his case, he has to do investigative work. He has to ah... send to them doctors, he has to have basic knowledge which takes years to acquire. If the fees were cut, many cases would, which maybe should proceeded with would not followed with as much ardor as they are with 20%. In order to balance out the living of an attorney, he needs 20% on these cases and many of them which consumes much time and of which there are serious problems and which are not readily proven up and I think $\dot{}$ that a cut in attorney's fees to 10%, Rolly, doing this I think would not have a good affect on working men in this State and it wouldn't help you lawyers either."

Madigan: "Is there further discussion? There being no further discussion, the question is shall Amendment #10 to Senate Bill 235 be adopted. Next, Mr. Speaker, we've discussed this matter, the question of changing the statute of limitations from that that exists in the Bill three years to two years just as we attempted to do this on the Occupational Disease Act and let me say, Mr. Speaker, that the best speech for this Amendment was made in opposition to the similar Amendment to Occupational Disease Act because the Gentleman made a distinction between occupational diseases and personal injuries. There can be no reason on earth for extending from one to three years as the Bill does the statute of limitations for injuries received while working. As has been discussed previously, the personal injury statute of limitations is two years now. The relationship between an employer and an employee is such that it's a good deal closer than the typical personal injury case. I see no reason on earth why in the spirit of compromise, the Sponsor can accept this and let this Bill go to Third Reading. Let me say this that even if he does accept it, this is still a pretty bad Bill and I'm not going to vote for it."

Madigan: "The chair recognizes the Gentleman from McCoupin, Mr. Boyle."

Boyle: "Thank you, Mr. Speaker. For the purpose of an announcement,

Appropriations II will meet tomorrow at 10:00 in Room 118. Appropriations

II will meet at 10:00. Room 118."

Maragos: "The chair recognizes the Gentleman from Cook, Mr. Maragos."

Maragos: "Mr. Speaker, for purpose of an announcement. Please pay attention.

All the members of the Revenue Committee are going to meet immediately after adjournment. It's going to be only five minutes we have two considerations for subject matters for next week which we have to vote on and we will be in Room 118 as the recess meeting of this morning.

Please come early so you can leave right away. Thank you."

Madigan: "The chair recognizes the Gentleman from DuPage, Mr. Schneider."

Schneider: "The Committee on Elementary and Secondary Education will meet
at 8:15 tonight to complete our business."

Madigan: "The chair recognizes the Gentleman from Cook Mr. Fary."

Fary: "Labor and Commerce has been advanced to 8:00 tomorrow morning in

D-1 across the street. Labor and Commerce, 8:00 a.m. in lieu of 9:30.

Everybody has been notified except one man. Please understand we have

22 Bills to get rid of."

Madigan: "The chair recognizes the Gentleman from Cook, Mr. Merlo."



Merlo: "Thank you, Mr. Speaker. The Insurance Committee will meet on the Floor of the House. I repeat on the Floor of the House, tomorrow morning at 9:00 a.m."

Madigan: "The Chair recognizes the Gentleman from Cook Mr. McLendon."

McLedon: "Mr. Speaker, Personnel and Pensions Committee will meet tomorrow morning, Wednesday, at 9:00 sharp at 122 A. Pensions and Personnel.

Thank you very much."

Madigan: "The chair recognizes the Gentleman from Cook, Mr. Garmisa."

Garmisa: "Mr. Speaker and Ladies and Gentlemen of the House, the Transportation Committee will meet at 8:00 tonight to consider one Bill in Room 122 B.

I would appreciate a prompt attendance and the sooner we get over there

and consider this Bill, the sooner we will be out."

Madigan: "For what purpose does the Gentleman from Cook Mr. Beatty arise?"

Beatty: "Point of inquiry, Mr. Speaker. Is Friday night the 13th the

deadline on Senate Bills for getting out of the House? Out of House

Committee just. Well Mr. Speaker I have got a Senate Bill 283 and

the companion Bill is the Appropriation Bill 284 and they both have

been sent to Appropriations. 283 sets up the local tax property tax

study. That shouldn't be in Appropriations I don't believe."

Madigan: "Well, Mr. Beatty, I am sure that Mr. Lechowicz will accommodate our schedule. If you two will get together."

I want some action."

Beatty: "No, it is on the schedule but is it necessary that both the Bill and the Appropriation Bill be heard by Appropriations. Shouldn't, 283 already passed out of Revenue. Why isn't that on the calendar. What is it doing in appropriations? I would like to move that Senate Bill 283 be placed on the calendar 2nd Legislative Day on Second Reading.

Madigan: "You have all heard the motion. And on the motion, you're going to get alot of opposition."

Beatty: "Well, is that suppose to be on the Calendar in Appropriations, or is it suppose to be on the Calendar. I withdraw my motion."

Madigan: "Motion is withdrawn, and the chair recognizes the Gentleman from Cook, Mr. Shea for the adjournment Resolution, Joint Session Resolution."

O'Brien: "House Joint Resolution 60 resolved by the House of Representatives

79th General Assembly, State of Illinois, Senate Concurring herein, that the two Houses meet in Joint Session in the Hall of the House of



Representatives on Wednesday, June 11, 1975 at the hour of 6:30 p.m. for the purpose of hearing the Governor deliver a message."

Madigan: "The chair recognizes the Gentleman from Cook, Mr. Shea to explain the Resolution."

Shea: "Mr. Speaker, I would move for the adoption of the Joint Session Resolution."

Madigan: "For what purpose does the Gentleman from Effingham, Mr. Keller arise?"

Keller: "Well, Mr. Speaker, I would like to ask the Sponsor hear a question. Whether we are going to allow TV..."

Madigan: "The Sponsor indicates that he will yield. What is your question?" Keller: "Jerry are we going to have the TV cameras here tomorrow night and have the wide open session, ho-down or whatever you want to call it?" Shea: "Mr. Keller, whether there will be cameras in the Chamber of not,

will be up to the President of the Senate and the Speaker of the House." Keller: "Well the Governor said last night that he had 110 radio stations coming in and I don't know how many TV cameras, and I just wondered where we were going to set."

Shea: "I would presume, Mr. Keller, you're going to sit in the seat that you chose to sit when you became an elected Representative."

Madigan: "For what purpose does the Gentleman from Cook, Mr. Collins arise?"

Collins: "Yes, Mr. Speaker, I rise to speak against the Resolution. I think that this House is to busy to participate in this cheap political maneuver. Thank you Mr. Speaker I'm happy to hear you say that. And I really think, I think that this is such a patently political manuever that I for one resent it highly. I think many members of the House do. I for one want to be recorded for voting no on this cheap politics and I would ask for a Roll Call."

Madigan: "For what purpose does the Gentleman from DuPage, Mr. Gene Hoffman arise."

Hoffman: "Mr. Speaker, Ladies and Gentlemen of the House. I take issue with the Sponsor of this Resolution. I don't believe it is up to the Speaker of the House and the President Pro-Tem to decide whether we are going to have television or whether we are going to have anything else in this House. It is up to the Members of the Body to decide and I



resent anyone taking the position that two people can decide what we are going to do and I agree with Representative Collins, if you have had a chance to look at the newspapers today, it is another good example of the General Assembly being used by the Governor of this State. So be my guest, but count me out and I want a Roll Call on this cause I want to vote no."

Madigan: "The Chair recognizes the Gentleman from Cook, Mr. Shea."

Shea: "Well, Mr. Hoffman, everything we do down here is done by the will of the Membership under rules and as I understand under the rules, it is given to the two presiding officers."

Madigan: "Is there further discussion? The Parlimentarian informs me that this question requires a simple majority to pass and the question is shall House Joint Resolution 60 be passed, be adopted. All those in favor will signify by voting aye, all those opposed by voting no. The chair recognizes the Gentleman from Cook, Mr. Duff."

Duff: "Well, Mr. Speaker, I am going to urge as many people as I can to vote red on this. All that we are asked to have this Joint Session for is so the Governor can come in and tell us that last March the Comptroller was right."

Friedrich: "A clarification of your ruling, a majority of those voting, or majority of those elected?"

Madigan: "A majority of those voting. The chair recognizes the Gentleman from Franklin Mr. Hart to explain his vote."

Hart: "I just wanted to add to the words of the Gentleman from Cook Mr. Duff
that it was also the words of a State Treasurer, Alan Dixon on the
Floor of this House when he made his Inaugral Address I guess you
could say after being re-elected and I remember his very words are
'be parsimonious' and he predicted what is happening in the State along
with the Comptroller."

Madigan: "For what purpose does the Gentleman from Cook, Mr. Duff arise?"

Duff: "Parlimentary inquiry, Mr. Speaker. You originally said this would take 89 votes to pass and then you said it would take a simple majority of those voting. Now I don't know that we have ever passed a Resolution in this House with less than 89 votes or a Bill and this is a Resolution



not a motion."

Madigan: "Mr. Duff, I never ruled that this Resolution required 89 votes."

Duff: "Well, Mr. Speaker, you did say that and I commend you to the transcript which is available, Mr. Speaker and in any event, I would like to see where there is a rule that says we can pass a Resolution by 89 votes, Mr. Speaker, would the Parlimentarian please tell us which rule it is? No, he rules a simple majority. I'm asking the Parlimentarian Mr. Speaker to tell us what rule allows us to pass a Resolution by less than 89 votes."

Madigan: "Mr. Duff, if you are raising a point of order."

Duff: "No, parlimentary inquiry, Mr. Speaker."

Madigan: "If you are raising a parlimentary inquiry, please inform the chair as to which rule you are addressing your inquiry."

Duff: "I am by parlimentary inquiry asking the Parlimentarian to tell us under which rule we can pass a Resolution by less than 89 votes."

Madigan: "The chair recognizes the Gentleman from Cook, Mr. Shea."

Shea: "Mr. Speaker, you ruled that it takes a simple majority to pass this. Now if the Gentleman has got a rule where he says it takes more than a simple majority, would he point it out."

Madigan: "Have all voted who wish? The Chair recognizes the Gentleman from Cook, Mr. Fleck."

Fleck: "Well, I am looking at rule 41 A, which says all Resolutions except those concerning deaths, congratulations, adjournment, and joint rules or house rules shall be introduced as original and four copies all such Resolutions shall be read once and assigned to a Committee. Now does this go to a Committee. Are we by passing Committee and suspending that rule? And so do it. And if so it takes 107 votes according to my rule book."

Madigan: "Have all voted who wish? Have all voted who wish? Clerk will take the record. On this question there are 71 ayes, 27 no's, 13 voting present and House Joint Resolution 60 is hereby adopted. The chair recognizes the Gentleman from Cook, Mr. Shea."

Shea: "Mr. Speaker, I'm alright Mike, Mr. Speaker, I move that the House do now stand adjourned until 1:30 tomorrow afternoon."

Madigan: "You have heard the motion, all those in favor signify by saying aye, opposed no, the ayes have it and the House is hereby adjourned."
