Speaker Redmond: "On the Order of Concurrence appears House Bill 2506. Representative Jaffe is recognized. Serious matter. The House please be in order and give the Gentleman attention."

Jaffe: "Mr. Speaker and Members of the House, yesterday the
Senate passed out House Bill 2506 by a vote of 39 to 8.

Basically they made two changes. Two Senate Amendments.

I move to concur in both Senate Amendments. Senate Amendment #1 makes a technical change in the Bill to compensate
for its delayed enactment. Applicants renewal could not



meet the original deadlines specified in the Bill, as they were specified in the version which was passed in the House. So we take the March 1, 1978 deadline then we extend that to October 1, 1978. The Amendment also inserts the effective immediate clause. Senate Amendment #2 clarifies the intent of the Bill to provide that only fully licensed physicians will serve on the new Limited License Review Board. The Amendment exempted limited licensees from being members. Mr. Speaker, I would now move to accept Senate Amendments #1 and #2 on House Bill 2506."

Speaker Redmond: "Is there any discussion? Representative Hart."

Hart: "Well, I hope the..."

Speaker Redmond: "The Gentleman standing between Representative

Hart and the Chair...please be seated."

Hart: "I hope the Membership knows what we're going on here.

This is a very substantial Amendment to this Bill. What

we're doing is trying to create law without having any

Committee process. We had a long, serious debate about

the..."

Speaker Redmond: "It's a serious matter, please give the Gentle-man order."

Hart: "...We had a long and serious debate about whether or not to even let these limited license physicians practice at all in these institutions. And finally, with Governor Thompson's persuasion, we were persuaded to let it happen for a while, but put a deadline on it. And now what's happening is that we're being asked to extend that deadline without any consideration from the public or any knowledge of how it's worked up to now. We have institutions in our area and I don't think it's right or proper for the people in the institutions to continue to be subjected to second-rate medical care. There are plenty of doctors available, if we approach the matter in the proper way, so that the people in the institutions who probably

can care less for themselves than we can for ourselves.



can get adequate medical attention. I oppose the Amendment and I think that we should refuse to concur in it and send it back to the Senate to recede. I think it's time that we stop extending deadlines and urge the Department of Corrections in the State of Illinois to provide as good....medical care for people in the institutions as is available to us on the outside. I oppose the Amendment."

Speaker Redmond: "Representative Schlickman."

Schlickman: "Mr. Speaker and Members of the House, I arise to support the House concurrence of these Senate Amendments. With all due respect to the prior speaker these are not substantive Amendments. Senate Amendment #1 simply takes into account the fact that this Bill was not passed by the Senate, until yesterday, within the month of April. Now the Bill, as it passed this House, provided for March 1, 1978, to be the date. We're simply extending that to October 1, 1978, in light of the fact that the Bill didn't pass the Senate until yesterday. Number two. Senate Amendment #3 simply eliminates or prohibits a limited licensed physician from serving on the board to consider the qualifications of these limited licensed physicians, which I think eliminates the element of conflict of interest. These are not substantive Amendments and I would respectfully urge the House to concur with them as suggested...recommended..by the House Sponsor of the Bill."

Speaker Redmond: "Anything further? Representative McGrew."

McGrew: "Thank you very much, Mr. Speaker and Ladies and

Gentlemen of the House. At the risk of jeopardizing my

reputation I would like to say that Representative

Schlickman is absolutely 100 percent correct..."

Speaker Redmond: "Please give the Gentleman order...please."

McGrew: "The Senate Amendments made no substantive change.

It simply allows the physicians to return to the mental



health facility at which they were employed previous to the deadline of the first day of April. That Amendment does not allow physicians to travel at all across the State of Illinois to change facilities. It would put them in the area which the doctors have been looking over their shoulders and reviewing their cases once again and the other first Amendment simply changes the date to October the first. It is not a substantive change. We have already passed the Bill. I would ask for concurrence of these Amendments."

Speaker Redmond: "Representative Telcser, for what purpose do you arise?"

Telcser: "Mr. Speaker, I believe the rules say that his motion

has to be on a Member's desk for one day. What's the

rule number, Don? You've got it."

Speaker Redmond: "What rule is that?"

Telcser: "Pursuant to Rule number 68-D."

Speaker Redmond: "Mr. Parliamentarian"

Telcser: "Frankly, everyone in this Assembly was taken by surprise. I don't see why this can't wait until next week anyway, but...."

Speaker Redmond: "Representative Teleser has questioned whether

or not this....it's proper to consider this. He calls

cour attention to the rules. Sixty....what is it?"

Telcser: "68-D."

Speaker Redmond: "68-D. Representative Jaffe."

Jaffe: "Mr. Speaker, I would suggest that Mr. Telcser's
remarks are not timely. We have already made the motion.
We are in debate and I would suggest that his remarks at
this time are not timely."

Speaker Redmond: "The Parliamentarian advises me that if the objection is 'poised' before the vote is taken that it is timely. Does the rule preclude theconsidering the matter...today? It says one day on the desk. It does preclude it. Representative McGrew?"



McGrew: "That being the case, Mr. Speaker, would it be possible to return to this tomorrow, before we go home?"

Speaker Redmond: "As far as I'm concerned we'll return to it tomorrow, but if you'll look at the Calendar there isn't really a great deal of work to keep us here and I'm really not too sure that we're going to have enough to be here tomorrow...my problem. Representative Jaffe."

Jaffe: "Mr. Speaker, I would move to suspend the rule so that we could have an immediate hearing upon this motion...at this time."

Speaker Redmond: "Representative Jaffe has moved that the provisions of 68-D, with respect to requiring this subject to be on the Calendar one day, be suspended. It requires an affirmative vote of 89. Those in favor of the Gentleman's motion vote 'aye', and opposed vote 'no'. Have all voted who wish? Have all voted who wish? Representative Telcser?"

Telcser: "Mr. Speaker, should this get 89 votes I'd like a verification."

Speaker Redmond: "Representative Schlickman? Schlickman." Schlickman: "Mr. Speaker and Members of the House, in explaining my vote, as was explained previously these are simple, nonsubstantive Amendments. Furthermore, Mr. Speaker and Members of the House, we do have an emergency in the State of Illinois with respect to the provision of health services to patients in our mental institutions. And then Mr. Speaker and Members of the House, we have a matter of equity and justice with respect to these limited licensed physicians who many, many years ago were the only ones who were available, who were interested, who were willing to commit themselves to provide needed health service in our mental health institutions. If we don't consider this, Mr. Speaker, and consider it favorably, I think we will be committing an act of injustice relative to these institutions, who everyone has conceded are providing, have

provided a needed service and a quality service to these residents of our state institutions. I encourage an 'aye' vote on this motion to suspend the rule so that we can give immediate consideration to the concurrence of these Senate Amendments."

Speaker Redmond: "Representative Bradley votes 'aye'. The House please be in order."

Clerk O'Brien: "Rich Brummer, Dyer, Friedrich, Garmisa, Hoffman Huskey, Kane, Katz..."

Speaker Redmond: "Representative Katz votes 'no'. Representative Huskey, 'no'."

Clerk O'Brien: "Klosak, Kucharski..."

Speaker Redmond: "Klosak votes 'no'."
