Doorkeeper: "Attention, Members of the House of Representatives. The House will convene in fifteen minutes. Thank you. All persons not entitled to the House floor please retire to the gallery. Attention, all of the House of Representatives. The House will convene in five minutes. Thank you."

Speaker Redmond: "The House will come to order. Members please be in their seats. We'll be led in prayer by the Reverend Krueger, the House Chaplain."

Rev. Krueger: "In the name of the Father, the Son, and the Holy Ghost. Amen. O Lord, bless this House to Thy service this day. Amen. James Monroe said, 'It is only when people become ignorant and corrupt that they are incapable of exercising sovereignty. Usurpation is then an easy attainment and a usurper soon found the people themselves become a willing instrument of their own abasement and ruin.' Let us pray. O Eternal Lord God, we pause this day before we consider the mighty issues before us as Members of this House of Representatives. We ask Thy divine help that we may do only that which is pleasing in Thy sight. We ask that what we do here will be accepted and understood by the peoples of this State of Illinois. Speaker Redmond: "Representative Telcser."

Telcser: "Mr. Speaker, on the Supplemental Calendar of House Bills, Second Reading, Second Legislative Day, Mr. Clerk, would pay attention. I think House Bill 2005 was a do not pass motion, if I'm not mistaken. Do you want to check for next week, Jack?"

Clerk O'Brien: "House Bill 2005?"

Telcser: "Yeah, I think that was a do not pass. If you'd check it for next week."

Speaker Redmond: "House Bills, Third Reading. House Bill 341, Representative Taylor is recognized."

Taylor: "Thank you, Mr. Speaker, Members of the House. I'd like to have leave of the House to return House Bill 341 to Second Reading for the purpose of an Amendment."

Speaker Redmond: "Does he have leave? He was out of his seat yesterday and we moved it up on him. Hearing no objections, it will be returned to the Order of Second Reading. 341, Mr. Clerk."



Clerk O'Brien: "Amendment #2, Taylor. Amends House Bill 341 on page 3 by inserting immediately after line 14, the following paragraph, so forth."

Speaker Redmond: "Representative Taylor."

Taylor: "Mr. Speaker and Members of the House, Amendment #2 to House Bill 341 is an Amendment that was suggested by some of the Members of the Committee who had some concerns about the words rape, murder, kidnapping and other related offenses, treason and sexual offenses involving a minor to be disclosed on the application for exconvicts and unemployment. I move for the adoption of Amendment #2 to House Bill 341."

Speaker Redmond: "Is there any discussion? The question's on the Gentleman's motion for the adoption of the Amendment. Those in favor say 'aye', opposed 'no'. The 'ayes' have it. Amendment's adopted. Any further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. Representative Lechowicz."

Lechowicz: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. Would the record show that Representative Brandt and Kornowicz are excused because of illness and Representative Kozubowski on official business? Thank you."

Speaker Redmond: "Any objection? Hearing none, the record will so show. Representative Ryan, do you seek recognition? Representative Collins might perform them."

Ryan: "Yes, Mr. Speaker, would you excuse Representatives McAvoy, Keats, and Schoeberlein and Representative McBroom for a death in the family?"

Speaker Redmond: "Are there any objections? Hearing none, the record will so show. Is the use of Collins' microphone, is that a harbinger of things to come? House Bills, Second Reading. Speaker Redmond: "Are there any Amendments?"

Speaker Redmond: "There was no motion by any Member with respect to Amendment #1 as I recall. Is that correct? Now, are there any Amendments from the floor?"
