Speaker Redmond: "Representative Ryan, we haven't taken the Roll Call for Attendance and don't intend to until about a quarter to two."

Ryan: "Thank you, Mr. Speaker, I have an introduction I'd like to make. We have a former Member of the Illinois House on the floor with us here today....a fellow that's been retired and gone to Florida, decided to come back and spend a little time with us. He's clipping coupons and his money now, Leo LaFleur, right here on the floor."

Speaker Redmond: "I would also like to introduce the former Member who decided not to run for reelection and then wanted to get to heaven and changed his mind again and did run for reelection, Representative Conti. Representative Greisheimer. We're introducing former Members who decided not to run and then got a second thought. Representative Meyers, I understand that he made the same choice. Representative Greisheimer."

Greisheimer: "Mr. Speaker, I just inquired of the Minority Leader, who I understand has applied to attend law school down in Florida, is there any truth to that?"

Ryan: "I would imagine that's probably true. As much trouble as he's in he probably needs to be his own attorney."

Speaker Redmond: "Representative Matijevec."

Matijevec: "Mr. Speaker, last week the Appropriations I Committee met,



we...we heard 1736 which is the BOB and that was postponed until this week. I found out this morning, inadvertently it was left off the notice and I'd like to move to use the Attendance Roll Call when we so have one to request leave that 1736 be heard today in Appropriations I Committee. It's been posted, Bill, and I've talked it over with Representative Ryan."

Sepeaker Redmond: "Are there any objections? Hearing no objections leave is granted.Mr. Clerk, what else do you have there?"

Clerk O'Brien: "Senate Bill 3. A Bill for an Act to amend Sections of the Waukegan Port District Act. First Reading of the Bill.

Speaker Redmond: "Agreed Resolutions.

Clerk O'Brien: "House Resolution 269. Ryan, Epton and Deavers, et al. "

Speaker Redmond: "Representative Matijeovich."

Matijeovich: "Yes, Mr. Speaker and Ladies and Gentlemen of the House, House Reso-
lution 269 by Ryan, Epton and Deavers honors one of our own Members, one of our longtime Members, Clarence Neff, who has received a Doctor of Law Degree from his alma mater, Tri-State University. So it gives me a privilege to move the adoption of the Agreed Resolution."

Speaker Redmond: "Representative Cissy Stiehl on 269. Representative Stiehl."

Stiehl: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House, the Resolution before us, a Resolution congratulating and honoring an outstanding Member of this House. He has been a credit not only to the Legislature and to the citizens of his district but also to the citizens of the State of Illinois. And I think that it is only fitting and proper that we honor Representative Clarence Neff today just as his university honored him last Saturday when they bestowed an honorary Doctor of Law degree upon him. And, Mr. Speaker, I would ask for permission for all of the names of the Members of this House to be added to that Resolution. Thank you."

Speaker Redmond: "Will you read the Resolution, Mr. Clerk?"

Clerk O'Brien: "House Resolution 269. Ryan, Epton, Deavers and all Members of the House. Whereas, Representative Clarence E. Neff has and continues to serve his country, his state and his community with distinction, and



Whereas, excellence has been his trademark in his life beginning with his days at Springfield High School and continuing in his educational career through his graduation with an Engineering Degree from Tri-State College in Angola, Indiana; and Whereas the Honorable Clarence E. Neff before his election to this Body served as Mayor of Stronghurst and in many other areas of local government; and Whereas, he has been active for many years as Chairman of the Henderson County Republican Central Committee supporting the election of Republican candidates for local, state and national office; and Whereas, in business he has been fair to all and has built a reputation for fairness in his activities in banking, the automobile business and farm implement business; and Whereas, as a Member of this Body for eight terms he has become a recognized expert in the areas of agriculture, financial institutions and transportation; and Whereas, he has served in this Body admirably as Chairman of the House Transportation Committee, as Minority Spokesman of that Committee; and as a Member of the Transportation Study Commission during a period of time when Illinois developed a nationally-recognized transportation program in the areas of highways and mass transit; and Whereas, as Chairman of the House Transportation Committee he won the moving force behind development of the Illinois State Passenger Train Program, which is the largest in the nation; and Whereas, Representative Clarence E. Neff has the respect and admiration of all the members of his community, and all those who know him throughout this state and all of the Members of this body; and Whereas, today, May 21, 1977, Representative Neff has been honored by his alma mater, Tri-State University, with an honorary Doctor of Law degree, for having brought great credit to Tri-State through his civic and business activities in this his home State of Illinois; therefore be it resolved by the House of Representatives of the Eightieth General Assembly of the State of Illinois, that we do hereby honor and offer our best wishes and congratulations to our colleague and friend, Clarence E. Neff, and that a suitable copy of this Resolution be presented to his wife, Elaine, his daughter, Janice, and his son, Charles."

Speaker Redmond: "Representative Stiehl moves for the adoption of the



Resolution. Those in favor say 'aye', 'aye', opposed 'no'. The 'ayes' have it. The Resolution's adopted. Representative Neff advised me that at his service here and he saw the quality of the lawyers that he thought the only way he could get right with his Maker was to also get a law degree. And he told me all the rest of you lawyer lovers like Giorgi, Friedland and all the rest of them that if you wanted to enroll that he would recommend it as a very fine course of conduct. Representative Schneider. Representative Schneider is going to give a concert on the Flight of the Bumblebee down in 114 pretty soon. Representative Cunningham, for what purpose do you rise?"

Cunningham: "Mr. Speaker, I was detained and heard over the box that you were adopting some Resolution honoring Representative Neff and I ask unanimous consent to be added as endorsing that program. Only his wife thinks more highly of Representative Neff than I. May I have consent to be added to the endorsement?"

Speaker Redmond: "All Members have been added. It shows that you joined a very fine group."

Cunningham: "I'm indebted to you, Mr. Speaker, always."

Speaker Redmond: "Senate Bills First Reading."

Clerk O'Brien: "Senate Bill 1013. A Bill for an Act to amend Sections of the Criminal Code. First Reading of the Bill.

Speaker Redmond: "Representative Pechous, will you stand please? We've got a problem here. Which one of these two gets the per diem?"

Pechous: "I'll accept the check but I would like to introduce the presence of my twin brother, Donald Pechous."

Speaker Redmond: "Twin, I assume."

Pechous: "My twin, yes."

Speaker Redmond: "Go ahead, Mr. Clerk."

Clerk O'Brien: "Senate Bill 801. A Bill for an Act in relation to marriage and divorce. First Reading of the Bill.



Senate Bill 917. A Bill for an Act to amend Sections of an Act concerning public utilities. First Reading of the Bill."

Speaker Redmond: "Representative Pierce."

Pierce: "Just for purpose of an announcement. We did post the meeting of the Revenue Committee for 2 p.m. but after numerous requests from the powers that be, we've decided to cancel that meeting and we'll meet next week whenever the appropriate day for the Tuesday is next week, probably Tuesday the 31st. So there will be no meeting of the House Revenue Committee today at 2 p.m. It's just cancelled and will be held next week."

Speaker Redmond: "You'll have tomorrow morning available, will that do you any good?"

Pierce: "No, we won't be able to do that tomorrow morning because our Members don't know about it and some are not around so we better do it next week."

Speaker Redmond: "Okay."

Clerk O'Brien: "Senate Bill 1134. A Bill for an Act to amend the Vehicle Code. First Reading of the Bill."

Speaker Redmond: "Representative Macdonald, will you come up here? Macdonald."

Clerk O'Brien: "Senate Bill 732. A Bill for an Act to create the Kankakee River Commission. First Reading of the Bill."

Senate Bill 1097. A Bill for an Act to amend Sections of the Vehicle Code. First Reading of the Bill.

Senate Bill 903. A Bill for an Act to amend Sections of an Act in relation to counties. First Reading of the Bill.

Senate Bill 320. A Bill for an Act to amend Sections of an Act in relation to fire protection districts. First Reading of the Bill.

Speaker Redmond: "There are some books on the Republican side that interfere with the orderly process of government. I would point your attention



to the fact that on the Democratic side there is no such obstruction. I don't know whether that is a credit of the Majority Leader and the fault of the Minority Leader or whether the Democratic pages are that much more industrious or just what it is but whatever it is, there it is. Representative Collins to compliment the Democratic pages."

Collins: "I certainly do, Mr. Speaker, and I just want to say that I'm glad there are some portions on the Democratic side where there is no disruption."

Speaker Redmond: "Roll Call for Attendance. Representative Madigan."

Madigan: "Would the record show that Representatives Kornowicz and Domico are excused because of illness? That Representative Mann is excused because of illness? Thank you, Mr. Speaker."

Speaker Redmond: "The record will so show. Representative Ryan, do you have any excused absences?"

Ryan: "No, Mr. Speaker, all my Members are here, well, healthy and ready to go to work."

Speaker Redmond: "Looks to me like.... Any announcements? We have Committee Meeting, 2 o'clock. Any announcements? Representative Madigan for a motion."

Madigan: "Mr. Speaker, before we take the Attendance Roll Call there are several Representatives from Chicago who don't plan to be here today and I would request the Members please not to push their switches as being...being in attendance."

Speaker Redmond: "I would make the same...same suggestion on the Republican side that you may...you will not be doing your colleague any favor if you put him on the Roll Call when in point....I think it's been suggested we dump the Roll Call and start over again. Please do not put anyone on the Attendance Roll Call that...other than yourself. You don't know what his plans are and could lead to a lot of difficulty and trouble. Roll Call for attendance. Mr...Mr. Clerk, will you announce what your requirements are before we adjourn?"

Clerk O'Brien: "We'll stay in Perfunctory Session for about fifteen minutes so we can introduce Senate Bills...."

Speaker Redmond: "At one, five?"

Clerk O'Brien: "If Members will come down and identify themselves for the



Bills...."

Speaker Redmond: "Did you say one, five?"

Clerk O'Brien: "Fifteen minutes, one, five."

Speaker Redmond: "Representative Madigan."

Madigan: "Mr. Speaker, I move that we adjourn until 12 o'clock tomorrow afternoon."

Speaker Redmond: "You heard the Gentleman's motion. Representative Mahar."

Mahar: "Thank you, Mr. Speaker, I had a motion. Is it too late for that? I wanted to move a Senate Bill to Second Reading, Second Legislative Day without reference to committee. I filed that motion with the Clerk and cleared it with both sides of the aisle. It's Senate Bill 282. This is just a very technical Bill, am I too late for that?"

Speaker Redmond: "Representative Madigan, have you discussed Representative Mahar's motion?"

Madigan: "Mr. Speaker, I withdraw my motion that we adjourn. I discussed this matter with Mr. Mahar and I am in agreement with it."

Speaker Redmond: "What was that? You...you joined with him?"

Madigan: "I do."

Speaker Redmond: "Okay. Will you read the motion, Mr. Clerk?"

Clerk O'Brien: "Motion. Pursuant to Rule 31, I move to advance Senate Bill 282 to the Order of Second Reading without reference to Committee."

Speaker Redmond: "Representative Mahar."

Mahar: "Yes, Senate Bill 282 is a Bill that was passed, signed into law and was found to be an error in the legal description and had to be run through the General Assembly again to comply with the Title and Trust. And this is the reason why I ask that it be moved to Second Reading."

Speaker Redmond: "Any discussion? The question is on the Gentleman's motion. Those in favor vote 'aye', opposed vote 'no'. Requires a 107 votes. Change the legal description....evidently a Bill went through here before and the legal description was in error and the Title and Trust Company called it to our attention and suggested we change the legal description. Is that right, Representative Mahar?"

Mahar: "Yes, Sir, it is...."

Speaker Redmond: "Have all voted who wish? Clerk will take the record. On this question there's a 117 'aye' and no 'nay'. The Gentleman's



motion carries and Senate Bill 282 is put on the Order of Second Reading without reference to Committee. Now, Representative Madigan. Representative Ryan."

Ryan: "Mr. Speaker, it's been brought to my attention that Senate Bill 1200 is...is needed to meet a payroll in the Department of Corrections. And I've been told Representative Barnes is not on the floor but Representative Peters tells me that they'd like to suspend the posting rules for tomorrow so they can hear the Bill, Senate Bill 1200."

Speaker Redmond: "Representative Madigan. Representative Peters."

Peters: "Mr. Speaker and Ladies and Gentlemen of the House and Representative Madigan, might I just indicate to you that if we can't get this done now and some objection does come up and your thinking to the Bill or that of Representative Barnes, we will certainly abide by your wishes not...not call the Bill tomorrow. But it is an emergency, emergency thing as far as we know in terms of the payment in the Department of Correction."

Speaker Redmond: "Representative Madigan."

Madigan: "Mr. Speaker, I will not object to the Gentleman's motion at this time but we've...I've been here for at least an hour on the floor and I would suggest in the future that you communicate with this side of the aisle on these matters. We're getting down to the point in the Session where I know that they will occur more frequently than they have and I know that Representatives Lauer and Peters are willing to cooperate. And I would simply ask for some common courtesy from Representative Ryan."

Ryan: "No comment, Mr. Speaker."

Speaker Redmond: "Does the Gentleman have leave to hear Senate Bill 1200, suspend the posting rule? Hearing no objection leave is granted. The Attendance Roll Call. Now, Representative Madigan."

Madigan: "I move that we adjourn until 12....."

Speaker Redmond: "Representative Matijevich."

Matijevich: "One...Mr. Speaker, one quick announcement. The Appropriations I Committee accept the same Bills for tomorrow as today. I would like the Sponsor, if at all possible, come in Committee today. We'd like to finish as much work as possible today and if we don't finish then they'll be heard tomorrow. But try to get there today. Thank you,



Mr. Speaker."

Speaker Redmond: "It's suggested that any Sponsor that doesn't show up a 'do not pass' motion is in order. So we'll stand in Perfunctory Session for fifteen minutes and then at which time we'll adjourn till tomorrow at 12 o'clock. Is that correct. Question...question's on the Gentleman's motion. Those in favor say 'aye', 'aye', opposed 'no'. The 'ayes' have it, the motion carries. Now adjourn.... 12 o'clock tomorrow."

Clerk O'Brien: "Senate Bills First Reading.
