Speaker Redmond: "Parliamentarian advises me that the Amendment is germane. Representative Leinenweber."

Leinenweber: "Is this Amendment....has it been circulated?"

Speaker Redmond: "The Amendment has been printed and circulated."

Speaker Redmond: "Yes, it has."

Leinenweber: "Has it?"

Leinenweber: "I don't think this side of the aisle got it, I've

Speaker Redmond: "About a month ago, maybe...."

Leinenweber: "Our side says they haven't gotten it yet."

Speaker Redmond: "Who's your side?"

Leinenweber: "The good guys. White hats."

Van Duyne: "In all defense...the Gentleman from Joliet, that was distributed weeks and weeks and weeks ago."

Leinenweber: "My assistant distributed it to me now, Mr. Speaker.

I have some questions of the Sponsor then."

Speaker Redmond: "Proceed."

Leinenweber: "LeRoy, what exactly does your Amendment do?

Would you repeat it once more."

Van Duyne: "Well, Harry, under the law as it is written right
now, it just says that not having any money in the bank
or overdrawing it....writing a check on your account and



overdrawing your account is prima facie evidence that the offender knows that it will not be paid by the depository. Now all I have done is just remove that...the legal entanglement of this if he makes the check good within thirty days. Now if I had written you a check, as of today you can go down to our State's Attorney and have me indicted. Or you can have be brought into court ... and you know, I can see where somebody can suffer damage to his reputation. Now for example, if you have a limited account in your checking account ... I can go out and write a check this afternoon and my wife, not even knowing that I had written a check might go out and write a check of the similar amount and overdraw the account. Now all I'm doing is giving the guy thirty days to make the check good and getting out of the legal entanglement of the Deceptive Practice Act. That's all...."

Leinenweber: "How many people do you know who have been indicted without having a request to make the check good....being made to them?"

Van Duyne: "Well...none. But by the same token, I don't know any people who were ever put in jail under this Act for ever writing a bad check either."

Leinenweber: "Well, Mr. Speaker, although I have the highest
esteem for the Sponsor of this Amendment, nevertheless...
as anyone who looks at the Bill book can see, this Bill
had originally had to do with unlawful use of weapons
inside of a dormitory of one of our educational institutions.
Now the Representative is putting an Amendment to the
Bill which will greatly change the laws of deceptive
practices as it relates to cashing NFS checks. Now I
would suggest to you that the passage of NFS checks is
an extremely serious problem in the financial community
and in the business community of this state. Representative
Polk, himself....last Session came in with a Bill which
would have totally reversed this and made it much more



difficult for a person who writes a bad check....to get off. I would suggest that the law is now carefully balanced. One of the problems is, you have to prove intent...so the law was written in the specific way that Representative Van Duyne wants to change it because of the difficulty in proving intent by creating a prima facie situation when you write a check when you don't have enough money in your account. Now asea practical matter, you will not find anybody who's indicted the day after they write a NFS check. In every case an opportunity is given an individual to make the check good including from the prosecutors office. I would suggest that the practical effect of this Amendment will be that you will delay at least thirty days before any collection effort can be made from a criminal point of view against the person who writes the bad check. Now thirty days is plenty of time in order to skip town, skip the state and skip the jurisdiction. I think that while the motive and the intent is obviously good, there is not a problem...the law is working well, it is delicately balanced between the right of the business community and the right of the individual who happens to write a bad check. I don't think we ought to monkey with it, this will have a detrimental effect and increase the difficulty of collecting a bad check and I urge a 'no' vote on Amendment #2."

Speaker Redmond: "Is there any further discussion? Representative

Van Duyne to close."

Van Duyne: "Well, thank you, Mr. Speaker. I know what Harry means and I know that there are none practically if any...

none that would be indicted the first day." But I can also see where they could be, if somebody....had an ill will towards me, if he could find out about he could make it very very embarrassing for me in my home town. Now the only reason for teeth that has been inserted in this



law last year was to make sure that the people who were the receivers of these bad checks would have some lever or some recurrence to these people who write the checks. Now in no way in the world would this have...take any teeth out of this Bill. All it would do is just delay it thirty days and if the only intent of the people is to get their money, I don't really think the thirty days means all that much. And I think the inconvenience for the thirty days is much more outweighed by the embarass ment of the person who inadvertently writes a bad checks. So I would pray for the adoption of this Amendment."

Speaker Redmond: "Representative Geo-Karis, for what purpose do you arise? I called on Representative Van Duyne to close."

Geo-Karis: "Oh, I'm sorry...."

Speaker Redmond: "Let me put the question and then we'll let you explain your vote. The question is on the Gentleman's motion for the adoption of Amendment #2.
