Speaker Redmond: "Representative Taylor on the floor? You're not
Taylor. Representative James Taylor. From the Speaker's Table
appears House Resolution 150. Representative Kucharski. House will
come to order. Well, maybe Skinner will take care of it. Mr. Clerk,
do you want to read the Resolution 150? Don't you even call 150?

Representative Skinner, you disavow 150 like you do House Bill 990?
House Bills First Reading."

Clerk Hall: "House Bill 3403. Matula. A Bill for an Act for appropriation for Illinois Racing Board. First Reading of the Bill."

Speaker Redmond: "Committee on Assignments. Representative Walsh....
it's 1:30. Representative Walsh is on the floor. House Resolution 154, Representative Taylor, you want that one called? Out of the record. 457, Representative Steczo, you want that one called? Out of the record. 478, Representative Giglio? Out of the record. House Joint Resolution 11, Representative Yourell. Out of the record. House Joint Resolution 26, Stearney. Representative Stearney. Out of the record. House Joint Resolution 42, Representative Porter. Out of the record. House Joint Resolution 48, Representative Deavers. Out of the record. House Joint Resolution....Representative Bradley, for what purpose do you rise?"

Bradley: "Well, Mr. Speaker, for the purpose of recognizing some people who do a lot of work in the House of Representatives and get very little recognition or not nearly as much as they deserve. And I'd like to recognize the Democratic Staff members and I hope that they're listening for we have submitted, Mr. Speaker and Ladies and Gentlemen of the House, 3....we have submitted three reports to the National Conference of State Legislators....Legislatures who will be meeting in July of this year, and we have submitted three reports, one of them, the budgetary issue in Fiscal Year '79 by John Matijevich, one of the chairmen and Gene Barnes the other, the report was written and



prepared with their help and with the help of the Democratic staff. Also, the 1978 survey of state residential facilities was submitted to compete with other states throughout these United States for honors. And I would like to specifically announce the...the Judiciary I Subcommittee Report on Product Liability was submitted to the Conference for their consideration and that report, Mr. Speaker, Ladies and Gentlemen of the House, five copies of that report was also requested by the White House, that the staff reports be sent to Washington, D. C. to be analyzed in Washington. And I certainly am glad to be able to take this opportunity to make this announcement in behalf of the Democratic staff. Speaker Redmond: "House Joint Resolution 82, Representative Brady."

Clerk Hall: "House Joint Resolution 82. Brady."

Speaker Redmond: "Representative Brady. Please give the Gentleman order."

Brady: "Mr. Speaker and fellow Members, House Joint Resolution 82 does exactly what it says it does on the Calendar. I had a letter from the Illinois Energy Resources Commission Chairman, which is Representative Lucco, who said he would welcome the opportunity to hold these hearings in support of...of them. The fiscal impact would be mimimal since the Commission budget already includes for hearings under which this Resolution would be applicable. And I think it's important to check into the energy usage in our schools and I urge your favorable support."

Speaker Redmond: "Is there any discussion? Question's on the Gentleman's motion for the adoption of House Joint Resolution 82. Those in favor say 'aye', 'aye', opposed 'no'. Parliamentarian says simple majority. Motion carried and the Resolution's adopted. Representative Pierce."

Pierce: "Mr. Speaker, if that Commission, to suspend funds on this, shouldn't we get a record vote? It might...it might require some travel expenses or some court reporter or...or incidental expenses."



Speaker Redmond: "Energy Resources Commission has their own funds."

Pierce: "Oh, so it'll come out of their appropriation..."

Speaker Redmond: "Right. Chairman's pretty tight too. The Order of Concurrence, House Joint Resolution 67. James Houlihan, do you want that one? Out of the record. Senate Bills Third Reading. Senate Bills Third Reading appears Senate Bill 82. Representative Polk, Senate Bill 82. Mr. Clerk, will you read the Bill?"

Clerk Hall: "Senate Bill 82. A Bill for an Act to amend Sections of the Criminal Code. Third Reading of the Bill."

Speaker Redmond: "Representative Polk. 82. Out of the record. 1394,
Representative J. David Jones. Is he on the floor? 1395, out of the
record. 1475, Jack Davis. Read the Bill, Mr. Clerk."

Clerk Hall: "Senate Bill 1475. A Bill for an Act to amend Sections of the Revenue Act. Third Reading of the Bill."

Speaker Redmond: "Representative Jack Davis."

Davis: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. Senate Bill 1475, before it was amended, is...an identical duplicate to House Bill 2669 that this House passed out without a dissenting vote in April of this year and now rests in the Senate on Second ... or in the Committee in the Senate. The Bill itself in its unamended form addresses the problem for Lake and Will Counties only in that it provides a validating action for actions taken by the county boards that were contrary to a statute passed last year in this General Assembly to allow the extension of the tax delinquency dates from March 1st to a date uncertain but no later than...than June 1st. The Amendments on the Bill also address some problems that took place in Lake and Will County...as far as publication dates. There are a couple of other Amendments that were accepted to the Bill that I have no particular objection to and at this point in time I would urge you in....in the spirit of getting this Bill quickly back over to the Senate for a concurrence in the Amendments to please cast an affirmative vote for Lake and Will Counties."

Speaker Redmond: "Is there any discussion? Question is....Representative Simms. Please give the Gentleman order. Representative Geo-Karis, please."



Simms: "Well, Mr. Speaker, Ladies and Gentlemen of the House, I reluctantly rely...arise and oppose this legislation. Out of the respect...to the Sponsor of the Bill, this does overturn a Supreme Court decision which in essence does take away from the taxpayer the right of timely notice in the change of assessments. The Bill has been amended by Representative Matijevich to make it a better Bill than what it was when it came from the Senate. But it still, to a certain degree, deprive the taxpayer of his rights under the law. And for these reasons I'm going to cast a 'no' vote."

Speaker Redmond: "Anything further? Representative Davis to close."

Davis, J: "Mr. Speaker, I would defer to Representative Matijevich to close."

Speaker Redmond: "Representative Matijevich."

Matijevich: "Mr. Speaker and Ladies and Gentlemen of the House, as Co-Chief Sponsor of a similar Bill that Representative Davis had in the House and as Sponsor of the Amendment, I would urge the Membership to support Senate Bill 1475. It is needed in Will and Lake County...in its original form and also the Amendment that I proposed and was added onto the Bill is needed in about 90 counties of Illinois or we will...many taxing bodies will lose much needed revenue. The Amendment that I worked out with the Illinois Public Action Council satisfies most of the...the objections that Representative Simms and his county had because the individual taxpayer and the farmland taxpayer is now protected by the Bill. So I would urge your support of Senate Bill 1475."

Speaker Redmond: "Representative Stuffle, for what purpose do you rise?

Question is, shall this Bill pass? Those in favor...Representative

Campbell."

Campbell: "Yes, Mr. Speaker, either from the Sponsor or from Representative Matijevich, I just wanted to know if this had the Amendment that was proposed that I had on your Bill. It's a one...one shot deal?

For one year only?"

Matijevich: "I have the Amendment which was worked out which was the

Amendment you had and the Amendment Simms had that were all incorporated into the one Amendment by the Illinois Public Action Council,

Representative Campbell. Yes."



Speaker Redmond: "Representative Stuffle."

Stuffle: "Yes, Mr. Speaker, along the same lines as that question of Representative Campbell. Then Representative Matijevich, you're saying that this takes care of the people involved in the suit in our district, Vermilion County, with regard to the...to the billing and notice last year, that would....that Supreme Court case with regard to them would not be affected?"

Matijevich: "That...that's right because they're exempted out as individual taxpayers."

Stuffle: "So it's prospective."

Matijevich: "That's right, there's no problem with them."

Speaker Redmond: "The question is, shall this Bill pass? Those in favor vote 'aye', opposed vote 'no'. Former Member of the House, former Representative Merlo. Never been heard of since he left the chamber. Have all voted who wish? Have all voted who wish? Clerk will take the record. On this question there's 131 'aye' and 8 'no'. Clerk O'Brien: "Senate Bill 1060. A Bill for an Act to create the

Speaker Redmond: "Representative Tipsword. Please give the Gentleman order."

Clerk O'Brien: "Second Reading of the Bill. Amendments #1, 2, 4 and 5 were adopted in Committee."

Speaker Redmond: "Any motions with respect to the Committee Amendments?" Clerk O'Brien: "No motions filed."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "Floor Amendment #6. Bennett. Amends Senate Bill 1060, as amended, in Section 9.02 and so forth."

Speaker Redmond: "Representative Bennett on the floor?"

Bennett: "Mr. Speaker, I...my understanding that this Bill was not ready to proceed with on Second Reading. I don't know...I'm wondering if...might take it out of the record for a few minutes?"



Speaker Redmond: "That's within the control of Representative Tipsword, the House Sponsor."

Tipsword: "I'll take it out if the people with the Amendments are not ready."

Speaker Redmond: "Take it out?"

Tipsword: "Yes, Sir."

Speaker Redmond: "Out of the record. House Bills Third Reading,
House Bill 2580. Representative Schisler. Representative Van Duyne,
is Representative Schisler back there? Can't see him. You want
2580 called? Out of the record. 3013. Out of the record. 3128,
Representative Dunn. Out of the record. 3231, Representative
Richmond."

Clerk O'Brien: "House Bill 3128."

Speaker Redmond: "3231."

Clerk O'Brien: "House Bill 3232. A Bill for an Act making an appropriation for the Capital Development Fund. Third Reading of the Bill." Speaker Redmond: "Representative Richmond."

Richmond: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House.

This...House Bill 3231 reappropriates 100,000 dollars for the Jackson Union Counties Regional Port Authority. In its amended form that is all this Bill has in it, is the reappropriation for those funds. The other funds that were in the Bill originally for the Joliet Metropolitan Exposition and Auditorium Authority has been amended out. And I said, 'Doctor King, it's my pleasure to have you say you want to talk to me.' He said, 'You know, I had Reverend Carey at my church, he's a powerful orator. I've heard you speak', and he said, 'both of you associated together in the ministry.' I said, 'Yeah.' He said, 'Well, how does it happen that Reverend Carey is a delegate to the United Nations and he seconded the nomination of President Eisenhower and he's such an outstanding Republican and you are an outstanding Democrat and you fellows work together so harmoniously.' He says, 'I want to know what makes you two guys click. And I said, 'Doctor King, you see it's like this, we're members of different parties and our parties are different but' I said, 'our problems are just the same.' being given in my honor tonight. And especially do I appreciate the Resolution that was being read that came from His Excellency the Governor, Governor Thompson, declaring of Corneal Davis' Day.

I never thought I'd ever live to declare this day especially when I can hear the voice of a man that I've learned to like, Representativenow I've learned to like him past years, who said, who said to me once, 'If you know what's good for you, you'll stay out of this town.'

So you appreciate, you know...you...you have to appreciate freedom when you have been denied that freedom. Sometimes we just take it for granted. Some people say, 'Oh, it was going to happen anyhow.'

Tell me that knew it was going to happen anyhow. Well, I say to you that progress is not automatic. Doesn't necessary have to happen anyhow. The world goes better because there are men and women like you who helped to make it better, who dedicate their lives to the cause of the men that are farthest down and the men that are farthest up on the ladder, that's how the world grows better, dedicated public servants like you. I appreciate all of this. People say to me, 'Where...how do you devote so much time? You're there, you're in church, you're at all ... make you do all these things. How can you keep it up?' I said, 'You see, when the Lord shovels it in, and that goes for everything, the little two, three dollars that I have and the money that I have to pay the installment note on my car and all that sort of thing, when he shovels it in, I shovel it out.' I say but...and that means my time and my energy and my fighting form, the poor and the needy. I know you're getting tired of me in here and I do not object to you opposing because perhaps I do get on your nerves sometimes. I do not object to it. But you see, when the Lord shovels it in, I try to shovel it out and the only difference is, the Lord's shovel is bigger than my shovel and he can shovel more God bless you and God keep you and may he make his face to shine upon you. I just got a call and I was deeply moved by that call because it was one of the great Governors...past Governors of the State of Illinois. It came from my friend, Bill Stratton, and he said, 'Deacon, I'm trying my best to get up there to honor you.' I want to say that to you because I want my fellows to know this, that Bill Stratton was the first Governor and the only Governor to ever



name a black man Director of Public Safety. Put that down in your black history books. Thank you so much. Thank you and keep you and may the Lord keep you, may the Lord bless you and make his face to shine upon and I expect to make two or three remarks tonight. Thank you."

Speaker Bradley: "Deacon, we'll get a repair man up to....now that you ...on your last speech you broke the microphone. The Gentleman from Cook, Mr. Taylor."

Taylor: "Thank you, Mr. Speaker and Members of the House, I know you heard the proclamation by...read by the Clerk there. We are also going to have a proclamation tonight at the dinner from the City of Chicago, Mayor Michael A. Bilandic, also have declared this as Corneal A. Davis' Day. I also....like to express regret to the fact that the Minority Leader who had previously planned to be with us tonight has some problems and will not be there because of his kid's graduation. But I do want him to express his, will, and hope that all of you that have not picked up your tickets, go into Corneal A. Davis office, we have a person there able to pass out the tickets. Thank you, Mr. Speaker and Members of the House."

Ryan: "Well, thank you, Mr. Speaker and Ladies and Gentlemen of the House. Representative Davis, I apologize for not being able to be with you this evening as I planned but I have a graduation of a son from the eighth grade this evening and I feel that that's my place and that's where I'll be. Although I would like to say that it will be a privilege, or it has been here at least this afternoon, to honor you who has distinguished yourself in public office as few have before you and all too few will in the future."

Speaker Bradley: "Mr. Ryan, Mr. Davis is right here."

Speaker Bradley: "The Gentleman from Kankakee, Mr. Ryan."

Ryan: "I wondered where he was. You're going to be praised tonight,

Representative Davis, not because of the length of your public service,

although that's a remarkable feat in itself, but rather because of

the quality of public service which is absolutely remarkable and has

been a hallmark of your tenure here. There's going to be many words

spoken about you tonight by your friends and your colleagues as they

join in tribute to you but your legislative record stands as the

real tribute to you and your people and our words tonight will



hardly be adequate to describe those accomplishments. I send my best wishes personally and as a spokesman for the Republicans, we'll have a good showing there tonight. I wish you the best in whatever you do in the future and certainly in tonight. You've certainly been an outstanding leader in the State of Illinois and you'll go down in history as such."

Speaker Bradley: "Motions. I'm sorry, what purpose, the Gentleman from Cook, Mr. Madison, arise?"

Madison: "Well, thank you, Mr. Speaker and Ladies and Gentlemen of the House. I certainly echo the feelings of our Leadership in terms of Representative Davis. And I believe, Mr. Speaker, that we should give honor to whom honor is due in any situation. And we have in our midst today, Mr. Speaker, another Gentleman, a distinguished public servant that I think honor is due. I think that, Mr. Speaker, because two weeks ago Friday was in fact his finest hour. While he stood in the midst of us, Mr. Speaker, with...with perspiration pouring down his face and with an eloquence that I've never heard before, he stood before us and he said, 'Mr. Speaker, the President of the United States'. And it was indeed his finest hour for he is a distinguished public servant, our Doorkeeper, Mr. Emery Koehler. I think we ought...."

Speaker Redmond: "Motions. On motions appears a motion with respect to Senate Bill 1847. Representative Lee Daniels."

Daniels: "Mr. Speaker, Ladies and Gentlemen of the House, I would move to discharge Judiciary Committee I and bring SB 1847 to Second Reading, First Legislative Day. I've cleared this with the Chairman of the Judiciary Committee I and both sides of the aisle."

Speaker Redmond: "Representative Madigan."

Madigan: "Inquiry of the Clerk. Is Representative Daniel Houlihan listed as a principal Cosponsor of this Bill?"

Speaker Redmond: "Mr. Clerk. Is Dan Houlihan a principal Cosponsor?

Mr. Clerk."

Clerk O'Brien: "The records indicate Representative Daniels as the Sponsor of the Senate Bill."

Madigan: "Mr. Daniels, would you indicate that Representative...."

Speaker Redmond: "Representative Daniels."

Daniels: "Yes, Mr. Speaker, Representative Houlihan should be a



Chief Sponsor. It should read, Daniels, hyphen, Houlihan, on the Bill. With leave of the House we'd like to add that."

Speaker Redmond: "Gentleman have leave....What's this? The Clerk...

the Clerk advises me that as far as the computer and our synopsis
and Digest the computer is unable to hyphenate, so the synopsis and
Digest will only show the one name but the Journal will show
Daniels-Houlihan. Now does the Gentleman have leave to have Daniels-Houlihan be shown as a principal Cosponsor of Senate Bill 1847?
Hearing no objection, leave is granted. Now the procedure would be
that you have to move to suspend the provisions of Rule 66(b)."

Daniels: "So move."

Speaker Redmond: "Representative Daniels moves to suspend the provisions of Rule 66(b). Those in favor vote 'aye', opposed vote 'no'. It takes a 107 votes. Have all voted who wish? Clerk will take the record. On this question there's 137 'aye' and 3 'no' and the motion carried. Representative......this is only a motion. The motion carries, the rule is suspended. Now Representative Daniels moves to discharge the Committee on Judiciary I and to have Senate Bill 1847 be advanced to the Order of Second Reading, First Legislative Day. Those in favor vote 'aye', opposed vote 'no', 89 votes. Clerk will take the record. On this question there's 137 'aye' and no 'nay'. The motion carries, the rule is suspended. Mr. Clerk, will you read Senate Bill 1847?"

Clerk O'Brien: "Senate Bill 1847. A Bill for an Act to create the Illinois Products Liability Act. Third...Second...Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Representative Mann."

Mann: "Mr. Speaker, by way of explanation of my vote, for the benefit of the other Members of the Judiciary I Committee on both sides of the aisle, Representative Daniels has indicated to me that this Bill will be held on Second Reading until further notice. And I just wanted you to know that."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "No Floor Amendments."

Speaker Redmond: "Third Reading. Representative Madigan is recognized with respect to House Resolution 913. Representative Roman Kosinski."



Kosinski: "Mr. Speaker, having examined..."

Speaker Redmond: "Representative Mann."

Mann: "Mr. Speaker, I think inadvertently the Chair, not having been advised, this Bill was moved to Third Reading and I don't think that was the intention of the Sponsor."

Speaker Redmond: "Representative Dan Houlihan."

Houlihan, D: "Mr. Mann is correct, I've just checked with Represntative

Daniels who would like Senate Bill 1847 held on the Order of Second

Reading."

Speaker Redmond: "Okay, we'll move it....we'll take it back from
Third Reading to Second Reading. Representative Roman Kosinski."

Kosinski: "Mr. Speaker, having examined House Resolutions that passed
unanimously on an Agreed List last week, I discovered that House
Resolution 913 was not so qualified, not being in agreement with
House rules. It's an investigative Resolution and should be considered
further. Therefore, having voted on the prevailing side, I request
reconsideration of the vote by which House Resolution 913 passed."

Speaker Redmond: "Is there any discussion? Question...Representative
Porter."

Porter: "Well, could the Representative tell us what 913 is all about?"

Kosinski: "If the Clerk would read the Resolution."

Speaker Redmond: "Would you explain the Resolution to Representative Porter...it's a...it's a Resolution that establishes....to direct the Illinois Legislative Investigating Committee to investigate attendance in making report and so forth."

Kosinski: "And as I understand it, Sir, this is contrary to House rules that this go on a....Agreed List. I've discussed this with the leadership on both sides of the aisle."

Speaker Redmond: "Anything further? The question's on the Gentleman...

Representative Bradley. Representative Madigan. Bradley is recognized."

Bradley: "Mr. Speaker, I was wondering who the Chief Sponsor of that

Resolution was?"

Speaker Redmond: "McGrew."

Bradley: "I wonder if Mr. McGrew is on the floor? Wonder if we couldn't hold that until Mr. McGrew would be on the floor of the House."

Kosinski: "Mr. Speaker, I think the technicalities, however, of this



are contrary to House rules that such a Resolution be passed on a voice vote."

Speaker Redmond: "Well, I think out of a courtesy there's nothing lost in waiting till Representative McGrew gets on the floor. Anything further? Representative Porter."

Porter: "Mr. Speaker, Ladies and Gentlemen of the House, I would like to ask leave of the House to have Representative James Taylor added as a Chief Sponsor, together with myself, in the House of Senate Bill 237 and Senate Bill 238."

Speaker Redmond: "Who is the Sponsor now, you?"

Porter: "Yeah."

Speaker Redmond: "The Gentleman have leave? Hearing no objection leave is granted. Agreed Resolutions."

Clerk O'Brien: "House Resolution 919, DiPrima. 920, Johnson.

921, Pechous. 922, Waddell. 923, Waddell. 924, Redmond.

926, Murphy. 927, Redmond. 929, Yourell. 930, Pechous. 931, Kelly.

932, E. M. Barnes."

Speaker Redmond: "Representative Giorgi."

Giori: "Mr. Speaker,....DiPrima's House Resolution 919 tells about a retiree, Captain McInerney. Johnson's House Resolution 920 notes the Nazi Party is planning on marching in Skokie. 921 by Pechous marks the Sokol-olrama in his city. 922 by Waddell informs about an 80th birthday. 923 by Waddell recognizes the Golden Wedding Anniversary. 924 by Redmond talks about 39 years of a retiree. 926 by Murphy heralds the clinic in Aurora. 927 by McClain denotes ...about a McClain in Missouri. 929 by Yourell says that....someone's receiving a bachelor of science degree. 930 by Pechous informs of a 43rd anniversary. 931 by Kelly talks about an Eagle Scout Progress Award. And 932 by Barnes talks about a first generation. And I agree...I move for the adoption of the Agreed Resolutions."

Speaker Redmond: "Is there any discussion? Question's on the adoption ...motion...Gentleman's motion for the adoption of the Agreed Resolution, those in favor say 'aye', 'aye', opposed 'no'. The 'ayes'

have it, the motion carries, the Agreed Resolutions are adopted.

Clerk O'Brien: "A message from the Senate by Mr. Wright, Secretary.

Mr. Speaker, I am directed to inform the House of Representatives
that the Senate has concurred with the House of Representatives in
passage of a Bill of the following title, to wit: House Bill #3380.

Together with the attached Amendment and the adoption of which I am
instructed to ask concurrence of the House, to wit: Passed by the
Senate as amended, June 6, 1978. Kenneth Wright. Secretary."

Speaker Redmond: "Just received a message from the Senate. We're
printing a Supplemental Calendar, we have to have a concurrence on
a DOT Appropriation Bill so we'll have to stay here for a little bit
anyway. I understand the Amendment's being distributed now. Senate
Bill First Reading."

Clerk O'Brien: "Senate Bill 1802. Bluthardt-Williams. A Bill for an

Act to amend Sections of the School Code. First Reading of the Bill."

Speaker Redmond: "While we're waiting here, are there any announcements?

Any Committee Chairmen that have an announcement to make? Representative Pierce."

Pierce: "Mr. Speaker, Ladies and Gentlemen, the House Revenue Committee has a very important meeting today as soon as we adjourn in our usual room, that is Room 118 of the Capitol Building. Taylor: "Thank you, Mr. Speaker and Members of the House. The Committee on Cities and Villages will meet immediately after adjournment. We have two Bills, shouldn't take us very long. I wish you would be very prompt because of the festivities this afternoon I'd like to get out in a hurry."

Speaker Redmond: "Representative Katz."



Katz: "The Judiciary II Committee will be meeting in its usual room,
114, in the Capitol Building, hearing this afternoon the so-called
Skokie Nazi Bills....immediately upon adjournment."

Speaker Redmond: "Representative Tipsword, the Chairman of Insurance,
do you have an announcement?"

Tipsword: "I have a question of the Chair. Will there be any change in the time for 4 o'clock Committee by virtue of our delay?"

Speaker Redmond: "There hadn't been...why don't you discuss that with Representative Madigan and we'll get back to you."

Tipsword: "All right, thank you."

Speaker Redmond: "Representative Kosinski, for what purpose do you rise?"

Kosinski: "Mr. Speaker, inasmuch as there'll be no Session to make an announcement such as this prior to the meeting of Subcommittees, may

I indicate that Subcommitte of Appropriations II concerned with

Departmental Law Enforcement, Liquor Control Racing Board and the

Army and Navy will meet at 8:30 tomorrow morning in 122-B. All

Members are urged to be there on time."

Speaker Redmond: "On the Supplemental Calendar #1, on the Order of Concurrence, House Bill 3380. Representative Reilly is recognized."

Reilly: "Mr. Speaker, Ladies and Gentlemen of the House, in order that we might act on this emergency measure today, I move that we suspend the provisions of House Rule. House Rule (8(d) so that we can take up the Motion to Concur immediately."

Speaker Redmond: "Is there any discussion? Representative Capparelli.

Representative Mudd."

Mudd: "Yes, would the Sponsor yield for a question?"

Speaker Redmond: "He will."

Mudd: "Representative Reilly, could you tell me what...what the...if
the Amendment adopted by the House is still on that Bill? It is?
Thank you."

Speaker Redmond: "Question is on the Gentleman's motion to suspend the

Darrow: "I'm going to vote for this even though it looks like our

Covernor is trying to take an opportunity to take shots at Bakalis."

Speaker Redmond: "The Gentleman has moved that the House concur in

Senate Amendment 1 to House Bill 3380. Those in favor vote 'aye',



opposed vote 'no'. Have all voted who wish? Clerk will take the record. On this question there's 145 'aye' and 2 'no'. The motion carries, the House does concur in Senate Amendment 1 to House Bill 3380. Representative Capparelli."

Capparelli: "Mr. Speaker, I'd like to suspend the appropriate rule so that all House Bills that have been assigned to Executive Committee be heardat this Thursday and also Senate Joint Resolution #60."

Speaker Redmond: "What was that again?"

Capparelli: "I'd like to have all Senate Bills that have assigned to Executive Committee be heard this Thursday and I'd like to waive the appropriate posting rule."

Speaker Redmond: "Gentleman has moved to suspend the provisions of Rule 18 in order that all Senate Bills assigned to Executive Committee be heard this week. Is there any objection? Hearing none, we'll use the Attendance Roll Call."

Capparelli: "Mr. Speaker does that also include Senate Joint Resolution #60?"

Speaker Redmond: "Anything that...you have everything that was assigned to you...."

Capparelli: "Yeah, but can I...."

Speaker Redmond: "That was assigned to you the answer is yes."

Capparelli: "Well, it had...she forgot to post that. Could I have leave on that? Oh, all right, thank you."

One other thing, Mr. Speaker, and this is a personal matter, I read just about three days ago that Bob Whitler has left the employ of state government and he got a couple of bad raps in the newspaper and I want to say that in my work with the Appropriations Committee and anytime that I had anything to do with the Department of Revenue, I thought Bob Whitler did an admirable job. And I...I think he handled that department as well as anybody could handle, so I'd like it to be made public that I, at least, think Bob Whitler did a good job. I can't say the same for Bill Murray the other guy that resigned."

Speaker Redmond: "Representative Tipsword, you seeking recognition?"

Tipsword: "Mr. Speaker, I've conferred with the Majority Leader and the Insurance Committee will meet at 4 o'clock sharp in Room 122-B."

Speaker Redmond: "Representative Mudd."

Mudd: "Yes, Mr. Speaker, Members of the House, tonight is the last practice for the House soft ball team and it's at 4 o'clock in Lincoln Park on Diamond 2. And Representative Capparelli hopes that as many people who are going to play turn out to practice because it's the last night. Thank you."

Speaker Redmond: "Representative Madigan. Representative Madigan."
Madigan: "Mr. Speaker, are there any announcements?"

Speaker Redmond: "I think we've had them all."

Madigan: "Motions."

Speaker Redmond: "Did you have any Democrats who should be excused for their absence?"

Madigan: "Yes, I do. Would the record show that Representative Giglio is excused because of a death in his family."

Speaker Redmond: "Hearing no objections, the record will so show."

Speaker Redmond: "Proceed."

Madigan: "Did you authorize the distribution of this xeroxed piece of paper by Representative Skinner?"

Speaker Redmond: "No, I did not. Didn't even see it."

Madigan: "Mr. Speaker, I have a question of the Chair."

Madigan: "It's right here, it's on my desk, it has his name on the bottom and in light of your nonauthorization, I wish that pursuant to the rules you would chastize him."
