

Doorkeeper Koehler: "Attention, Members of the House of Representatives, the House will convene in fifteen minutes. All persons not entitled to the House floor, please retire to the gallery."

Speaker Redmond: "House will come to order. Members please be in their seats. Be led in prayer by Reverend Koch, Chaplain for the day."

Rev. Koch: "We bow our heads, we humble our hearts before Almighty God. The earth is the Lord's and the fullness thereof, the world and they that dwell therein. O God of Abraham and atom and automation, of Babylon and beauty and brotherhood, be with all people in this perilous period of human history. Speaker Redmond: "At the request of Minority Leader, that one's out of the record. 1598, Representative Hoxsey. Out of the record. 1627, Representative Schisler. Clerk O'Brien: "Senate Bill 250. A Bill for an Act to revise the law in relation to mental health and developmental disabilities. Second Reading of the Bill."

Speaker Redmond: "Representative Madigan."

Madigan: "Mr. Speaker, I believe that there's an Amendment filed to this Bill by Representative Dunn."

Speaker Redmond: "Is there? There's a Floor Amendment so we'd better take this... Representative Sandquist, are you familiar with that Amendment? Representative Madigan. Out of the record. Proceed. Take it out of the record. 252."



Clerk O'Brien: "Senate Bill 252. A Bill for an Act to amend the Probate Act. Second Reading of the Bill. This Bill has been read a second time previously. Amendment #1 was adopted in Committee."

Speaker Redmond: "Is there any motion with respect to Amendment 1?"

Clerk O'Brien: "No motions filed."

Speaker Redmond: "Is there any Amendment from the floor?"

Clerk O'Brien: "Floor Amendment #2, Schlickman. Amends Senate Bill 252 as amended as follows: On page 13 by deleting line 3 through 5 and so forth."

Speaker Redmond: "Representative Pullen. Would the Gentlemen standing between Representative Pullen and the Chair please be seated? Representative Pullen."

Pullen: "Mr. Speaker, the Gentleman who offered that Amendment is not here so I would ask to take the Bill out of the record."

Speaker Redmond: "Out of the record. 253."

Clerk O'Brien: "Senate Bill 253. A Bill for an Act to create the Guardianship and Mental Health Advocacy Commission. Second Reading of the Bill."

Speaker Redmond: "Has the fiscal note been furnished?"

Clerk O'Brien: "The fiscal note is filed and no Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "None."

Speaker Redmond: "Third Reading. 255."

Clerk O'Brien: "Senate Bill 255. A Bill for an Act to protect the confidentiality of records and communications of recipients of mental health or developmental disability services. Second Reading of the Bill. Amendment #1 was adopted in Committee."

Speaker Redmond: "Any motion with respect to Amendment 1?"

Clerk O'Brien: "No motion filed."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. 554. Representative Mugalian."

Mugalian: "Mr. Speaker, on Senate Bill 255, I ask you to hold that on Second Reading. There's a Floor Amendment expected."

Speaker Redmond: "Return it back to the Order of Second Reading. 2...

554. Representative Skinner, please maintain order. 554."



Clerk O'Brien: "House Bill 2... 554. A Bill for an Act to add Section to the Illinois Pension Code. Second Reading of the Bill. Amendments #1 and 2 were adopted in Committee."

Speaker Redmond: "Any motion with respect to Amendments 1 and 2?"

Clerk O'Brien: "A motion to table Amendment #1 and 2 by Representative Madigan."

Speaker Redmond: "Representative Madigan. Please give the Gentleman order."

Madigan: "Mr. Speaker, Amendments #1 and 2 contained some material which were not intended to be placed in those Amendments. Therefore, I move to table those two Amendments and there is a subsequent Amendment, I believe Amendment #3, which is properly... excuse me, Amendment #4 which is properly drafted. Therefore, I move to table Committee Amendments #1 and 2."

Speaker Redmond: "Is there any discussion? Representative Ryan."

Ryan: "Thank you, Mr. Speaker. Representative Madigan, can you tell me what those Amendments are and what they do?"

Madigan: "The Amendments are..."

Ryan: "Why would you want to table Committee Amendments? I don't understand that."

Madigan: "Because they were improperly drafted and they contain material which relates to the Chicago Police Pension Fund which was not intended to be in the Amendments. And what we attempting to do is to remove all the material in these Amendments that relate to the Police Pension Fund and simply offer the material which relates to the Municipal Pension Fund."

Ryan: "Thank you."

Speaker Redmond: "The question's on Representative Madigan's motion to table Amendments 1 and 2. Those in favor say 'aye', opposed 'no'. The 'ayes' have it, the motion carried. Amendments 1 and 2 are tabled. Any further Amendments?"

Clerk O'Brien: "Floor Amendment #3, Ebbesen. Amends Senate Bill 554 as amended in the title in the introductory clause of Section 1 and so forth."

Speaker Redmond: "Representative Madigan."

Madigan: "Mr. Speaker, this Amendment is offered by Representative



Ebbesen. It's similar to other Amendments we've seen offered in the past which attempts to place a moratorium on pension benefits. However, this Amendment contains language which reads as follows, and I wish to quote from the second paragraph of the Amendment, 'Any Act amending, adding to or repealing the provisions of this code which would otherwise become law after the effective date of this Section shall not have the effect of law.' Mr. Ebbesen is attempting with this Amendment to preclude any further legislative activity..."

Speaker Redmond: "Representative Ryan, for what purpose do you rise?"

Ryan: "Well, Mr. Speaker, the Sponsor of the Amendment's not even on the floor. I don't think we ought to be even taking this up. You ought to take it out of the record."

Madigan: "Mr. Speaker."

Speaker Redmond: "Representative Madigan."

Madigan: "Could Mr. Ryan represent Mr. Ebbesen on this Amendment?"

Ryan: "No, I really don't. Mr. Ebbesen represents himself on this Amendment and he's not here."

Madigan: "Mr. Speaker, possibly we should take this from the record until Mr. Ebbesen returns."

Speaker Redmond: "Out of the record. 571. It's been the policy of the Chair not to take matters out of the record when Amendments are submitted by Members that are not here. I think we're going to have to enforce that pretty stringently very soon because time is running against us."

Clerk O'Brien: "Senate Bill 571. A Bill for an Act to amend Sections of the Illinois Pension Code. Second Reading of the Bill. Amendment #1 was adopted in Committee."

Speaker Redmond: "Any motion with respect to Amendment 1?"

Clerk O'Brien: "No motion filed."

Speaker Redmond: "Any Amendment from the floor?"

Clerk O'Brien: "Floor Amendment #2, Dan Houlihan-Giorgi. Amends Senate Bill 571 on page 1, line 1 by inserting immediately before the word 'and' the following: amends Section 18-112 of... and so forth."

Speaker Redmond: "Representative Dan Houlihan."



D. Houlihan: "Mr. Speaker, I ask leave of the House to table my Amendment #2. It... or to withdraw it, more accurately. The provisions of the Amendment have been incorporated into a... another Bill."

Speaker Redmond: "Representative Houlihan withdraws Amendment #2. Any further Amendments?"

Clerk O'Brien: "Floor Amendment #3, Yourell. Amends Senate Bill 571 as amended in the title and in Section 1 and so forth."

Speaker Redmond: "Representative Dan Houlihan."

D. Houlihan: "Handling the Bill or the Amendment for Representative Yourell, we're asking leave to withdraw Amendment #3. There is an Amendment #4 which covers what he is addressing."

Speaker Redmond: "Amendment #3 is withdrawn. Is that correct? Any further Amendments?"

Clerk O'Brien: "Floor Amendment #4, Yourell. Amends Senate Bill 571 as amended in the title and in Section 1 by inserting 9-169, 9-209 and 10-107 and so forth."

Speaker Redmond: "Who's the Sponsor? Representative Yourell. Representative Ryan."

Ryan: "We don't have copies of that, Mr. Speaker. Has that been distributed?"

Speaker Redmond: "Has that been printed and distributed, Mr. Page? Amendment 4, Joe. It has not been printed and distributed. Take it out of the record. 736."

Clerk O'Brien: "Senate Bill..."

Speaker Redmond: "Representative Yourell, for what purpose do you rise?"

Yourell: "I'm told, Mr. Speaker, that this Amendment has been printed and distributed."

Speaker Redmond: "Well, the Page tells me that it wasn't so we'll take it out temporarily."

Yourell: "All right, fine."

Speaker Redmond: "736. Remind our guests in the gallery that the taking of photographs is prohibited."

Clerk O'Brien: "Senate Bill 736. A Bill for an Act to exempt from certain occupation and use taxes, machinery and equipment."



Speaker Redmond: "Representative Ryan."

Ryan: "Can we take this one out of the record, too, Mr. Speaker?"

Speaker Redmond: "Out of the record. 825."

Clerk O'Brien: "Senate Bill 825. A Bill for an Act in relation to regulation of independent colleges and universities by the Board of Higher Education. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "None."

Speaker Redmond: "Third Reading. 1419."

Clerk O'Brien: "Senate Bill 1419. A Bill for an Act to revise the law governing local government and school elections to implement the consolidation of elections. Second Reading of the Bill. Amendments #1, 2, 3, 4, 5, 6, 7 and 8 were adopted in Committee."

Speaker Redmond: "Any motions with respect to Amendments 1 through 8?"

Clerk O'Brien: "No motions filed."

Speaker Redmond: "Any further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. 1512. Out of the record, request of the Sponsor. 1524."

Clerk O'Brien: "Senate Bill 1524. A Bill for an Act making certain appropriations and reappropriations to the Board of Trustees of the University of Illinois. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "Amendment #1, Deavers. Amends Senate Bill 1524 on page 4 by inserting between line 5 and 6 the following."

Speaker Redmond: "Representative Wikoff, what's your pleasure?"

Wikoff: "Thank you, Mr. Speaker. The... in light of your instructions a little while ago, the maker of...only... or the Amendments that I believe are put on this Bill are not here. I would ask it be moved to Third Reading."

Speaker Redmond: "Third Reading. 1525. Representative Ryan, for what purpose do you rise?"

Ryan: "Yeah, what about the Amendment, Mr. Speaker?"



Speaker Redmond: "What'd you say?"

Ryan: "What about the Amendment?"

Speaker Redmond: "Well, the Sponsor of the Amendment is not here.

The Principal Sponsor of the Bill requested the matter be moved to the Order of Third Reading."

Ryan: "Well, I would request that it be held on Second till the Sponsor of the Amendment's here."

Speaker Redmond: "It's on Third Reading now. 1525."

Clerk O'Brien: "Senate Bill 1525. A Bill for an Act to provide for the ordinary and contingent expense of Southern Illinois University. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "Amendment #1, Deavers. Amends Senate Bill 1525 on page 2 by inserting between line 19 and 20 the following."

Speaker Redmond: "Representative Ryan, for what purpose do you rise?"

Ryan: "I would request that this be held till the Sponsor of the Amendment is here, Mr. Speaker."

Speaker Redmond: "Well, we wouldn't hold it for that purpose, but the Sponsor of the Bill isn't here. So for that purpose, we will."

Ryan: "Well, I knew you'd accommodate me in some manner."

Speaker Redmond: "1526."

Clerk O'Brien: "Senate Bill 1526. A Bill for an Act making appropriation to the Board of Governors of State Colleges and Universities. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "Amendment #1, Deavers. Amends Senate Bill 1526 on page 6 by inserting between line 12 and 13 the following: Section 6."

Speaker Redmond: "Representative Ryan."

Ryan: "I would request that you hold this on Second Reading."

Speaker Redmond: "Is Representative Barnes on the floor? You want to move that one? 1526?"

Ryan: "I would request it be held, Representative Barnes."

Speaker Redmond: "It's the appropriation to the Board of Governors of State Colleges and Universities."

Ryan: "Will you hold it? Thank you."



Speaker Redmond: "Held at the acquiescence of the Sponsor. 1527."

Clerk O'Brien: "Senate Bill 1527. A Bill for an Act making appropriation to the Board of Regents. Second Reading of the Bill. Amendment #1 was adopted in Committee."

Speaker Redmond: "Any motion with respect to Amendment 1?"

Clerk O'Brien: "No motion filed."

Speaker Redmond: "Any further Amendments?"

Clerk O'Brien: "Floor Amendment #2, Deavers. Amends Senate Bill 1527 on page 4 by inserting between line 12 and 13 the following."

Speaker Redmond: "Representative Bradley."

Bradley: "Mr. Speaker, I'd like to move that to Third, George. And I'll speak with 'Gil' when he gets here and if he wants me to bring it back to Second later on, I'd be glad to do it."

Speaker Redmond: "Any further... any Amendments other than the one that Representative Deavers who's not here?"

Clerk O'Brien: "Amendment #4, Terzich-Hanahan."

Speaker Redmond: "Representative Bradley. We'll move it Third Reading with your representation it'll be returned to the Order of Second. 1530. Representative Brady. Out of the record? Is that correct? Representative Bradley, for what purpose do you rise?"

Bradley: "I didn't hear what you did with..."

Speaker Redmond: "Third Reading."

Bradley: "Third Reading. Thank you, Sir."

Speaker Redmond: "1546."

Clerk O'Brien: "Senate Bill 1546. A Bill for an Act to amend an Act concerning public utilities. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Representative Conti."

Conti: "There's a... Mr. Speaker and Ladies and Gentlemen of the House, I introduced an Amendment on the floor and... I introduced an Amendment to this Bill on the floor. I don't see the Sponsor on the floor of the House though and I would like to extend him the courtesy of waiting till he gets here before we go ahead with the Amendment. He wanted to check with the Senate Sponsor first."

Speaker Redmond: "Representative Kane, the Sponsor of this Bill."

Conti: "He's the Sponsor here and I want to extend him that courtesy, what, till he gets on the floor of the House."

Speaker Redmond: "Take it out of the record. 1555."

Clerk O'Brien: "Senate Bill 1555. A Bill for an Act making..."

Speaker Redmond: "Any motion with respect to Amendment 1?"

Clerk O'Brien: "A Bill for an Act relating to higher education. Second Reading of the Bill. Amendment #1 was adopted in Committee."

Speaker Redmond: "Any motion with respect to Amendment 1?"

Clerk O'Brien: "No motion filed."

Speaker Redmond: "Any further Amendments?"

Clerk O'Brien: "No Floor Amendments."

Speaker Redmond: "Third Reading. 1583."

Clerk O'Brien: "Senate Bill 1583. A Bill for an Act to provide for the ordinary and contingent expense of the Board of Vocational Rehabilitation. Second Reading of the Bill. Amendments #1, 2 and 3 were adopted in Committee."

Speaker Redmond: "Any motion with respect to Amendments 1, 2 and 3?"

Clerk O'Brien: "No motions filed."

Speaker Redmond: "Any further Amendments?"

Clerk O'Brien: "Floor Amendment #4, Skinner. Amends Senate Bill 1583 as amended by inserting after the last line in Section 3 the following."

Speaker Redmond: "Representative Ryan."

Speaker Redmond: "Representative D.L. Houlihan."

Clerk O'Brien: "Amends Senate Bill 1605 on page 1 by deleting line..."

D.L. Houlihan: "I don't see the Sponsor of the Amendment on the Sponsor of the Amendment on the floor. Since he is not here, I'd like the Bill moved to Third."

Speaker Redmond: "Any further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. Representative Ryan."

Ryan: "Mr. Speaker, did you adopt that Amendment or not? What'd you do with that Amendment?"

Speaker Redmond: "Sponsor of the Amendment was not on the floor."

Ryan: "Thank you."

Speaker Redmond: "Holewinski was told to me as to be the Sponsor. Representative Bowman."

Bowman: "Aren't they hyphenated Sponsors? Don't they have equal access to the floor on this matter? There's Representative Robinson."

Speaker Redmond: "I don't know. I was told that... Representative Robinson. Representative Robinson."

Robinson: "Well, I am one of the Sponsors on this Bill. Representative Holewinski has worked hard on this and I would request that we hold this on Second Reading until later today."

Speaker Redmond: "It's on Third now."

Robinson: "How'd it get to Third?"

Speaker Redmond: "Because the Sponsor of the Amendment was not here."

Robinson: "I'm here."

Speaker Redmond: "You weren't on the floor at the time we called it."

Robinson: "I was standing right here talking to Representative Madigan."

Speaker Redmond: "Representative Dan Houlihan."

Robinson: "He was commenting on my blue jeans."

D.L. Houlihan: "I was under the impression that the Sponsor of the



Amendment was not on the floor and they informed me that the Sponsor of the Amendment was Representative Holewinski. I don't see him and in consequence, I'd like the Bill on Third where it is now."

Speaker Redmond: "It's been the practice of the Chair to honor the request of the Sponsor when the Sponsor of the Amendment is not on the floor."

Robinson: "Well, I'm here, let's take a vote on it then. If he won't..."

Speaker Redmond: "Representative Ryan."

Ryan: "Well, Mr. Speaker, I had a similar request of you five minutes ago and you didn't honor that. You moved this Bill to Third Reading. I don't see why it shouldn't stay there and you move along to the order of business."

Speaker Redmond: "Which Bill are you referring to?"

Ryan: "1605."

Speaker Redmond: "Which one? No, I mean the one where you wanted to have it moved to Third."

Ryan: "I don't remember right now."

Speaker Redmond: "Well, if you tell me which one it is then we'll do it for you."

Ryan: "It was 1530. I asked that it be held and you said the Sponsor wasn't here and you moved it. Now, I..."

Speaker Redmond: "1530?"

Ryan: "What I'm saying is that 1605..."

Speaker Redmond: "1530 was taken out of the record at the request of the Sponsor. Must have a wrong number there."

Ryan: "No, no, not 1530. It was... 1524 is what it was, but that's not what I'm talking about, Mr. Speaker. This Bill, you told me it moved to Third Reading and that's where it ought to be."

Speaker Redmond: "Well, that's where it is. Representative Byers."

Byers: "Well, Mr. Speaker, Representative Robinson's a Cosponsor on this and there's many cases in the past where legislation is up that if a Cosponsor is on the floor, they let them handle the Amendment. And Representative Robinson was standing right up here and what I think's in effect, there's two sets of rules here. There's one set for one group of people and another set for another group."



And I think Representative Robinson should have every right to present his Amendment to this Bill because he was here. Just because Representative Holewinski was not on the floor and I think that it's... that he has every right to present that piece of legislation."

Speaker Redmond: "It's been the policy of the Chair that at this stage of the game particularly that if the Sponsor of the Amendment is not here, we don't... we don't encourage holding up the proceedings here in order to accommodate a Sponsor who is not here. Yes, Representative Robinson. Well, I don't care where you were standing."

Robinson: "I was in the chamber and you called and asked whether the Sponsor was here. I went to my microphone from over on that side of the floor. Now if the Sponsor of the Bill will not leave it on Second Reading, I'd like to present the Amendment."

Speaker Redmond: "I would suggest that you talk to Representative Houlihan and get it straightened out."

Robinson: "Well, I'll ask him right now."

Speaker Redmond: "There's no way you can put ninety-four Sponsors of an Amendment and frustrate the movement of this House by that way."

Robinson: "I'm not trying..."

Speaker Redmond: "We're now... I don't say that you are, but my responsibility is to try to move things along here. Representative Bowman."

Bowman: "Mr. Speaker, just as a clarification of the rules then. What is precisely the status of Cosponsors on Amendments? Is the first named Sponsor..."

Speaker Redmond: "There is no provision in the rule for any Cosponsorship of an Amendment."

Bowman: "Well, we, we... this House operates under precedent as I understand as well as... as well as by rule. And what is the status in terms of what you plan to do in terms of recognition as Cosponsors of Amendments?"

Speaker Redmond: "Representative Robinson."

Robinson: "Mr. Speaker, I suggest that I am not trying to stall the procedures of the House. There's an Amendment filed on House Bill 1605 which I'm Cosponsor and I'd like to have a vote on it."



Speaker Redmond: "The Sponsor is... why don't you talk to the Sponsor? We're not going to call it for passage. See if we can bring it back again if that's the wish of the majority out here. But, you know, at this stage of the game, I think it's manifestly unfair not to proceed and Representative Holewinski was the Sponsor. You didn't stand up very promptly and immediately and after it had been moved to Third Reading, then you presented yourself. Now that's my recollection of the scenario here and I think that we're going to have to proceed. Senate Bills, Third Reading."

Robinson: "Mr. Speaker."

Speaker Redmond: "Talk to Representative Houlihan and see if we can get this thing straightened out. Representative Robinson."

Robinson: "May I clarify this right now by asking Representative Houlihan if he would..."

Speaker Redmond: "We're not... we can't take the... he's sitting back there. Go back and talk to him. Senate Bills, Third Reading. Representative Totten, for what purpose do you rise?"

Totten: "Mr. Speaker, on a point of personal privilege."

Speaker Redmond: "Better be a point of personal privilege. What is your point? I've called Senate Bills, Third Reading now."

Totten: "Mr. Speaker, I rise on a point of personal privilege. The point is that I and every other Member of this chamber have not been given the personal privilege to consider House Joint Resolution Constitutional Amendment 44. I think we've reached a sorry point when we have to consider that a privilege. Mr. Speaker, every Member of this House has the right... Mr. Speaker, the right to have his or her Bill heard. Now, Mr. Speaker, I think you have a very genuine concern that every Member of this House be treated fairly and in the past you've worked very diligently to see that Members receive a fair opportunity to present their legislation in this Assembly. But, Mr. Speaker, your hesitation on Constitutional Amendment 44 is a gross departure from your commitment to observe the rules of this House. Mr. Speaker, the Speaker of this House must be a person that each and every Member can respect. But hesitation, indecision, promises to make a decision that aren't honored, these are qualities, these are not qualities that merit



the respect of the Membership. I'm very worried, Mr. Speaker, that the very high esteem all of us have had for the conduct of this chamber is beginning to slip. Mr. Speaker, I'm addressing you. I just read this week that Mr. Solzhenitsyn who gave the commencement address at Harvard University..."

Speaker Redmond: "Representative Totten, I do not consider that to be a point of personal privilege. Now as far as calling that measure is concerned, if you go back to the transcripts you'll find out that it's been called ten or twelve times. I don't believe that this is a proper point of personal privilege and I ask you to bring your remarks to a close at least refer to a point of personal privilege. The conduct of this House has to go on in an orderly fashion. I told you that in due time that that would be reached and now I have already called Senate Bills, Third Reading. Put him back on again, but this is not a point of personal privilege."

Totten: "Mr. Speaker, I'm addressing a point of personal privilege regarding a Member's right to be heard in this General Assembly and..."

Speaker Redmond: "That isn't a point of personal privilege as I read Robert's Rules of Order of the House proceedings. Now if you have a point of personal privilege, we're on the Order of Senate Bills, Third Reading."

Totten: "Mr. Speaker, my point of personal privilege is that I as a Member have not had the right as other Members have had and I'd like..."

Speaker Redmond: "Your Bill, this measure has been called ten or twelve times. You don't have the opportunity or the right to usurp this floor and this House interminably on this matter. I said it would be called in due course. Senate Bills, Third Reading. Senate Bill 82."

Clerk O'Brien: "Senate Bill 82."

Speaker Redmond: "Representative Totten, for what purpose do you rise?"

Totten: "Well first of all, I think..."

Speaker Redmond: "I've already ruled on that, Representative Totten."



Now please in order to conduct of business in this House, it's Senate Bills, Third Reading. Senate Bill 82."

Clerk O'Brien: "Senate Bill 82. A Bill for an Act to amend Sections of the Criminal Code. Third Reading of the Bill."

Speaker Redmond: "Representative Polk. Out of the record. Senate Bill 238."

Clerk O'Brien: "Senate Bill 238. A Bill for an Act to amend Sections of the School Code. Third Reading of the Bill."

Speaker Redmond: "Representative Porter. Out of the record. 309."

Clerk O'Brien: "Senate Bill 309. A Bill for an Act to amend Sections of the Illinois Pension Code. Third Reading of the Bill."

Speaker Redmond: "Out of the record. 386, G.L. Hoffman."

Clerk O'Brien: "Senate Bill 386. A Bill for an Act to amend..."

Speaker Redmond: "Out of the record, is that what you want? 386 out of the record. 388 out of the record. 389 out of the record. 393 out of the record. 395 out of the record. What's the next one? 430, Representative Bowman."

Clerk O'Brien: "Senate Bill 430. A Bill for an Act to amend Sections of the School Code. Third Reading of the Bill."

Speaker Redmond: "Out of the record. 471, is that? 771."

Clerk O'Brien: "Senate Bill 771. A Bill for an Act to amend Sections of the Criminal Code. Third Reading of the Bill."

Speaker Redmond: "Representative Getty."

Getty: "Mr. Speaker, is Representative Johnson on the floor?"

Speaker Redmond: "Representative... I don't see him."

Getty: "All right. Well then, would you take it out of the record then please?"

Speaker Redmond: "Out of the record. 1055, Hoffman. Out of the record. 1395, J. David Jones. Out of the record. I understand that 1455 should be on the Order of Second Reading. Is that right? Mr. Clerk, will you check on that and make sure? Here's Representative Johnson. You feel like going to work on 771? Representative Hoffman, the Clerk says it was moved to Third on June 12. Now is that correct? On 1395? 1455 rather. 1055. Wait a minute, wait a minute."

Hoffman: "Mr. Speaker."



Speaker Redmond: "1455."

Hoffman: "Yes, on June... June 14th, we moved it back to Second Reading for an Amendment and we... the Amendment was not printed and distributed and we held it on Second on that day. That was the day the Amendment was introduced. That's all."

Speaker Redmond: "We took it out of the record because the Amendment was not printed. Is that correct? So it should show, it should be on the Order of Second Reading. Is that right? It's on the Order of Second Reading. Representative Johnson's on the floor. 771, Representative Getty?"

Getty: "Mr. Speaker, Members of the House, I'd ask leave to bring Senate Bill 771 back to the Order of Second Reading."

Speaker Redmond: "Representative Getty asks leave to return 771 to the Order of Second Reading. Does he have leave? Hearing no objection, it will be returned to the Order of Second Reading."

Clerk O'Brien: "Amendment #2, Johnson. Amends Senate Bill 771 as amended in Section 12-11 and so forth."

Speaker Redmond: "Representative Johnson."

Johnson: "Mr. Speaker, Members of the House, Amendment #2 simply adds the word 'intentionally' in front of the word 'causes' in paragraph or one of the subparagraph 2 of the Bill. This is to require an intent element with respect to one of the elements of this crime of home invasion. I believe it's agreed to by the Sponsor and just improves a good Bill slightly."

Speaker Redmond: "Representative Getty. Getty."

Getty: "Mr. Speaker, Members of the House, I support the Amendment and would ask for its adoption."

Speaker Redmond: "The question's on the Gentleman's motion for the adoption of Amendment 2. Those in favor say 'aye', opposed 'no'. The 'ayes' have it, the motion carried, the Amendment's adopted. Any further Amendments?"

Clerk O'Brien: "Floor Amendment #3, Johnson. Amends Senate Bill 771 as amended in Section 12-11 and so forth."

Speaker Redmond: "Representative Johnson."

Johnson: "Thank you, Mr. Speaker, Members of the House. This Amendment is in response to a couple of hypotheticals raised by



Representative Leinenweber and others in Committee and simply deletes the language 'or without authority remains within the property' or something to that effect from the existing Bill. This would require then that someone intentionally invade a home or enter a home and the other elements of the crime and would preclude the coverage of this Bill from a situation that I don't believe the Sponsor or anybody else intended it to cover. I think the Sponsor also agrees with the intentment of this Amendment and I would ask for its adoption."

Speaker Redmond: "Representative Getty."

Getty: "Yes, Mr. Speaker, Members of the House, Representative Darrow and Representative Leinenweber along with Representative Johnson brought this to my attention and I do concur in Amendment #3 and would ask for its adoption."

Speaker Redmond: "Any further discussion? The question's on the Gentleman's motion for the adoption of Amendment 3. Those in favor say 'aye', opposed 'no'. The 'ayes' have it. Motion carried, Amendment's adopted. Any further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. 1483."

Clerk O'Brien: "Senate Bill 1483. A Bill for an Act making an appropriation to the Board of Trustees of Southern Illinois University. Third Reading of the Bill."

Speaker Madigan: "Mr. Flinn. Out of the record. Mr. McPike, do you wish to call Senate Bill 1506? Mr. Mautino. Mr. Kane. Is Mr. Kane on the floor? Mr. Ebbesen. Mr. Ebbesen. Mr. Ebbesen. Mr. Ebbesen, do you wish to call Senate Bill 1523? Senate Bill 1523. Mr. Ebbesen."

Clerk O'Brien: "Senate Bill 1523. A Bill for an Act making appropriation to the Illinois State Scholarship Commission. Third Reading of the Bill."

Speaker Madigan: "Mr. Ebbesen. Would you turn on Mr. Ebbesen?"

Ebbesen: "Yes, Mr. Speaker and Ladies and Gentlemen of the House, just one moment please. Yes, Senate Bill 1523, Mr. Speaker and Ladies and Gentlemen of the House, is the appropriation for the State Scholarship Commission and it had one Amendment and it



was nothing more than a technical correction for a thousand dollar error. It would have to go back to the Senate for approval, but other than that, why it's been approved in the Senate unanimously in its present form and I would encourage an 'aye' vote."

Speaker Madigan: "Mr. Waddell."

Waddell: "Would the Sponsor yield?"

Speaker Madigan: "Sponsor indicates that he will yield."

Waddell: "Does this Bill still have the provision of the reduction of the salary of the Director?"

Ebbesen: "Yes, it does."

Waddell: "Thank you."

Speaker Madigan: "Is there any further discussion? The question is, shall this Bill pass? All those in favor signify by voting 'aye', all those opposed by voting 'no'. Have all voted who wished? Have all voted who wished? The Clerk shall take the record. On this question there are 123 'ayes', 4 'noes', 7 voting 'present' and this Bill having received a Constitutional Majority is hereby declared passed. Mr. Peters. Mrs. Younge. Mr. Bowman on Senate Bill 1561."

Clerk O'Brien: "Senate Bill 1561. A Bill for an Act making an appropriation to the Legislative Information System. Third Reading of the Bill."

Bowman: "Mr. Speaker and Ladies and Gentlemen of the House, this is a simple Appropriation Bill for the Legislative Information System which is one of the hardest working adjuncts to the General Assembly. They are the people who support the computer system on which all the Bills are drafted. And frankly without them, we would be tied up in knots and I'd be happy to respond to questions. Otherwise, I ask a favorable Roll Call."

Speaker Madigan: "Is there any discussion? There being no discussion, the question is... Mr. Conti."

Conti: "Not on this Bill, Mr. Speaker and Ladies and Gentlemen of the House. I'm working on two Bills at the same time and I thought I was voting on... on the bilingual Bill when I voted 'no' on the Bill previous to this. Can I change my vote to 'aye'? I need leave of the House. 1523."



Speaker Madigan: "The Gentleman requests leave. Leave is granted to be recorded as voting 'aye' on Senate Bill 1523. And now returning to the proper order of business, Senate Bill 1561. All those in favor signify by voting 'aye', all those opposed by voting 'no'. Have all voted who wished? Have all voted who wished? The Clerk shall take the record. On this question there are 124 'ayes', 8 'noes', 6 voting 'present' and this Bill having received a Constitutional Majority is hereby declared passed. Lynn Martin, do you wish to call... no. Mr. Hart. Mr. McAuliffe. Mr. Huskey. Mr. Huskey. Mr. Huskey, do you wish to call Senate Bill 1571?"

Huskey: "Take it out of the record."

Speaker Madigan: "Mr. Bartulis. Senate Bill 1578."

Clerk O'Brien: "Senate Bill 1578. A Bill for an Act making appropriation to the Board of Trustees of the General Assembly Retirement System. Third Reading of the Bill."

Speaker Madigan: "Mr. Bartulis."

Bartulis: "Yes, thank you, Mr. Speaker, Members of the House. Senate Bill 1578 is the annual appropriation for the ordinary and contingent expenses for the General Assembly Retirement System for our next fiscal year beginning July 1, 1978 and I appreciate a favorable Roll Call."

Speaker Madigan: "Is there any discussion? There being no discussion, the question is, shall this Bill pass? All those in favor signify by voting 'aye', all those opposed by voting 'no'. Have all voted who wish? The Chair recognizes Mrs. Kent."

Kent: "My light does not go on here to speak as well as the green and I would like to be recorded as green please."

Speaker Madigan: "Mr. Brady. Have all voted who wish? The Clerk shall take the record. On this question there are 136 'ayes', 7 'noes', 2 voting 'present'. This Bill having received a Constitutional Majority is hereby declared passed. Mr. Houlihan. Daniel Houlihan, do you wish to call Senate Bill 309? Mr. Bowman, do you wish to call Senate Bill 430? Bowman."

Bowman: "Well, I believe this is an agreed Bill. I don't have my file with me, but I'd be happy to take a shot at it."

Speaker Madigan: "Mr. Bowman on Senate Bill 430."



Clerk O'Brien: "Senate Bill 430. A Bill for an Act to amend Sections of the School Code. Third Reading of the Bill."

Bowman: "Mr. Speaker and Ladies and Gentlemen of the House, the primary goal that this Bill serves is to extend to the City of Chicago the same kind of hearing officer privileges that the teachers downstate have. Under the terms of this Bill, any teacher or civil service employee or principal serving within the... under the jurisdiction of the Chicago Board of Education, if they were dismissed, would be able to have a hearing before a hearing officer. The decision of the hearing officer would be binding on all parties and I ask for a favorable Roll Call. This is essential... it's essentially no different from the procedures used downstate."

Speaker Madigan: "Is there any discussion? Mr. Kempiners."

Kempiners: "Yes, will the Gentleman yield?"

Speaker Madigan: "The Gentleman indicates that he will yield."

Kempiners: "You indicate that this procedure is basically no different from the one for the downstate systems. However, if I'm not mistaken, the hearing officers are supplied by the State Board of Education, whereas the Digest indicates under your Bill that individual attorneys would serve as hearing officers. Is that distinction correct?"

Bowman: "I believe the Digest is in error. My recollection... see, I don't have my file with me right now. That's why I took it out of the record earlier, but I... my recollection is that the State Board of Education will appoint a list of five candidates and then the two sides in the contest will continue... eliminate one at... until they eliminate four total and then whoever is left will serve. And the list is originally submitted by the State Board as I recall."

Kempiners: "Okay, thank you."

Speaker Madigan: "Mr. Waddell."

Waddell: "Would the Sponsor yield?"

Speaker Madigan: "The Sponsor indicates that he will yield."

Waddell: "How do you propose to pay these and who is going to pay them? Secondly, how much have you set down for each hearing day



or date?"

Bowman: "Wait a minute... Would you repeat the last part of the question on that? How much I set down?"

Waddell: "Yes, when.. if and when you select the hearing officers, what are the perimeters, how much can they be paid per day or per hearing or per case? And who pays them?"

Bowman: "Could we take this out of the record till I can respond to the Gentleman's question?"

Speaker Madigan: "You wish to take this out of the record? Do you want to call that up today?"

Bowman: "I didn't have... I'll be happy to get the file over here, but..."

Speaker Madigan: "Did you want to call for the file?"

Bowman: "Yes."

Speaker Madigan: "And then we'll call the Bill again?"

Bowman: "Yes."

Speaker Madigan: "Okay. We'll take this Bill out of the record.

Mr. Collins, for what purpose do you arise, Mr. Collins."

Collins: "Mr. Speaker, pursuant to Rule 10(b), I move to change the order of business to the Order of Constitutional Amendments, Second Reading for the purpose of considering Amendments to House Joint Resolution Constitutional Amendment 44. This motion is in order at all times, Mr. Speaker, and I have the support of the necessary five Members."

Speaker Madigan: "You're not recognized for that purpose, Mr. Collins."

Collins: "Mr. Speaker, Mr. Speaker, you didn't ask me..."

Speaker Madigan: "Senate Bill 1594, Mr. Wikoff. We are now on the Order of Senate Bill 1594. Mr. Wikoff. Mr. Clerk, would you change the board, 1594."

Clerk O'Brien: "Senate Bill 1594."

Speaker Madigan: "Senate Bill 1594, Mr. Wikoff. Mr. Wikoff. Senate Bill 1594."

Clerk O'Brien: "1594, a Bill for an Act to make an appropriation to the Board of Trustees of State Universities Retirement System. Third Reading of the Bill."

Wikoff: "Mr. Speaker and Ladies and Gentlemen of the House, this



is the appropriation by the Bureau of the Budget to the Board of Trustees, State Universities Retirement System."

Speaker Madigan: "Mr. Ryan."

Ryan: "Well, thank you, Mr. Speaker. I think that you had failed to ask Representative Collins, as a matter of fact I know you did, for his reason for rising and so his motion certainly was in order, Mr. Speaker. And there's been an organized attempt by your Leadership for the last ten days or so to totally ignore Representative Totten's request to have this Constitutional Amendment heard. Now these are the rules of the House, Mr. Speaker, and I would certainly hope that you would abide by them. Representative Collins' motion is in order. He has the five Members that are needed and I would certainly wish that you would call that motion according to the rules."

Speaker Madigan: "Mr. Ryan, the transcripts will clearly indicate that I asked Mr. Collins for what purpose did he arise. And the order of business at this time is Senate Bill 1594. Mr. Wikoff. The transcript will clearly indicate that. Mr. Wikoff. Mr. Wikoff."

Wikoff: "This Bill is an automatic appropriation for the Bureau of the Budget to the Board of Trustees for the various Universities Retirement Systems that passed out of both the Senate, passed with the Senate with a unanimous vote and out of the House Committee with a unanimous vote. I would ask for a favorable Roll Call."

Speaker Madigan: "Is there any discussion? Is there any discussion? There being no discussion, the question is, shall this Bill pass? All those in favor signify by voting 'aye', all those opposed by voting 'no'. Have all voted who wished? Have all voted who wished? Have all voted who wished? The Clerk shall take the record. On this question there are 127 'ayes', 11 'noes', 4 voting 'present'. This Bill having received a Constitutional Majority is hereby declared passed. For what purpose do you arise, Mr. Totten?"

Totten: "Mr. Speaker, I just wonder if I shaved off my moustache, would it help you to recognize me?"

Speaker Madigan: "Mr. Kane, do you wish to call your Senate Bill 1522, appropriation to the Comptroller? Excuse me, appropriation to the Board of Higher Education? Mr. Peters. Is Mrs. Young in



the chamber? Senate Bill 1571, Mr. Huskey."

Clerk O'Brien: "Senate Bill 1571. A Bill for an Act making an appropriation to the ordinary and contingent expense of the Industrial Pollution Control Finance Authority. Third Reading of the Bill."

Huskey: "Mr. Speaker, Ladies and Gentlemen of the House, this is the annual appropriation, the annual appropriation for the Industrial Pollution Control Financing Authority. And the appropriation is eighty thousand, seven tenths dollars. This Authority pays back to the state two hundred thousand dollars every year, so actually it's just an advance loan really. But... so I move for its adoption."

Speaker Madigan: "Is there any discussion? There being no discussion, the question is, shall this Bill pass? All those in favor signify by voting 'aye', all those opposed by voting 'no'. Have all voted who wished? Have all voted who wished? Have all voted who wished? The Clerk shall take the record. On this question there are 120 'ayes', 10 'noes', 13 voting 'present'. This Bill having received a Constitutional Majority is hereby declared passed. Mr. Stearney in the chamber? Mr. Dave Jones, do you wish to call your Senate Bill 1395? Mr. Mahar, do you wish to call Senate Bill 1593?"

Clerk O'Brien: "Senate Bill 1593. A Bill for an Act making appropriation for certain retirement benefits for teachers. Third Reading of the Bill."

Speaker Madigan: "Mr. Mahar."

Mahar: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. Senate Bill 1593 appropriates eight hundred and fifty thousand dollars to the Chicago Public School Teacher's Pension Retirement Fund. This is a declining fund because the number of disabled teachers are being removed each year. Last year it was nine hundred thousand dollars and this year it's eight hundred and fifty thousand. I urge its adoption."

Speaker Madigan: "Is there any discussion? Is there any discussion? There being no discussion, the question is, shall this Bill pass? All those in favor signify by voting 'aye', all those opposed by



voting 'no'. Have all voted who wished? Have all voted who wished? Have all voted who wished? The Clerk shall take the record. On this question there are 136 'ayes', 5 'noes', 1 voting 'present'. This Bill having received a Constitutional Majority is hereby declared passed. Mrs. Hoxsey. Out of the record? Mr. Schisler. Senate Bill 1627."

Clerk O'Brien: "Senate Bill 1627. A Bill for an Act making appropriation to the Department of Agriculture for certain expenses of Western Illinois Fair Association, Incorporated. Third Reading of the Bill."

Schisler: "Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House, Senate Bill 1627 appropriates fifty-five thousand, five hundred and sixty dollars to the Department of Agriculture for reconstruction of a beef and dairy barn at the Pike County fairgrounds and I move the adoption. This building was destroyed by an ice storm in... on... in March this year. Ask for a favorable Roll Call."

Speaker Madigan: "Is there any discussion? Is there any discussion? There being no discussion, the question is, shall this Bill pass? All those in favor signify by voting 'aye', all those opposed by voting 'no'. Have all voted who wished? Have all voted who wished? Have all voted who wished? The Clerk shall take the record. On this question there are 93 'ayes', 38 'noes', 15 voting 'present'. This Bill having received a Constitutional Majority is hereby declared passed. Mr. Flinn. Mr. Monroe Flinn, do you wish to call Senate Bill 1674?"

Clerk O'Brien: "Senate Bill 1674. A Bill for an Act to amend Sections of the Downstate Public Transportation Act. Third Reading of the Bill."

Speaker Madigan: "Mr. Flinn."

Flinn: "Thank you, Mr. Speaker. Mr. Speaker and Ladies and Gentlemen of the House, Senate Bill 1674 is the annual Bill in which we support the bistate transpor... Bistate Transportation Authority in the metro east area of the St. Louis metropolitan area. What this basically does is provide for the second one thirty-second of the sales tax collected in the area that bistate serves. And



it therefore, voids a local tax which the other downstate areas must have in order to use their one thirty-second. . . I know of . . . no opposition on this Bill and I would ask for its adoption."

Speaker Madigan: "Is there any discussion? There being no discussion, the question is, shall this Bill pass? All those in favor signify by voting 'aye', all those opposed by voting 'no'. Have all voted who wished? Have all voted who wished? Have all voted who wished? Have all voted who wished? Mr. Flinn to explain his vote."

Flinn: "Well, Mr. Speaker, I don't know why some of the people are not voting for this Bill. We've passed this Bill each year, each and every year and it's necessary to maintain the mass transit systems for the metro east part of the St. Louis metropolitan area. And without this support, there will be no mass transit down there. In the first place, we get about twenty percent of the total service that's provided out of the metropolitan St. Louis area and we furnish by this only eighteen percent of the total amount of government subsidies that are supported to the bistate bus system. I see no reason at all why we shouldn't vote for it."

Speaker Madigan: "The Clerk shall take the record. On this question there are 97 'ayes', 47 'noes', 9 voting 'present'. This Bill having received a Constitutional Majority is hereby declared passed. Mr. Stuffle, do you wish to call Senate Bill 1691? Mr. Lechowicz, Senate Bill 1785. Mr. Matejek. Mr. Brady. Senate Bill 1790. Mr. Lechowicz, Senate Bill 1792. Mr. Lechowicz."

Clerk O'Brien: "Senate Bill 1792. A Bill for an Act to amend Sections of the Illinois Insurance Code. Third Reading of the Bill."

Lechowicz: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. Senate Bill 1792 as amended provides that there will be no discrimination for people who are physically handicapped in the . . . receiving motor automobile insurance. It also provides that four Members be . . . are not employees on this new board, the Governing Committee for the Department of Insurance. And as amended in the House it also provides a corrective Amendment which was offered for the Department of Insurance to exclude fidelity insururity as a means under the Insurance Code. And the fourth Amendment was by



Representative Epton which provides a fair plan for the home owners insurance throughout this state. This Bill was debated quite extensively on the floor. I believe that there is now a common interest and a common knowledge of the Bill providing for the strong support of Senate Bill 1792. Be more than happy to answer any questions. If not, I ask for a favorable Roll Call."

Speaker Madigan: "Mr. Brummer."

Brummer: "Yes, will the Sponsor yield?"

Speaker Madigan: "The Sponsor indicates that he will yield."

Brummer: "We have an Amendment, I think, that was offered last week on this Bill prohibiting sex discrimination. I don't recall, was that Amendment adopted or was it not?"

Lechowicz: "The Amendment was defeated because of the fact that if the Amendment was adopted, it would have promoted tremendous increase in rates for all the women in Illinois. I opposed the Amendment for that reason. I believe that the Department, the insurance companies as well opposed the Amendment for that reason. I believe Representative Walsh offered the Amendment and he recalled quite vividly his strong support was for the Amendment because he is against E.R.A. and he just wanted to bring about some of the impacts for E.R.A... against E.R.A. by offering that Amendment. If you recall, the Amendment was defeated on the floor."

Brummer: "Thank you."

Speaker Madigan: "Is there any further discussion? Mr. Bradley."

Bradley: "A question of the Sponsor."

Speaker Madigan: "The Sponsor indicates that he will yield."

Bradley: "Ted, I'm wondering on Senate Amendment #1, is that still part of the Bill?"

Lechowicz: "Yes, it is and there is no... in Committee the insurance companies per se have now agreed with that concept and I believe that they have no objections to that Amendment."

Bradley: "All right, thank you."

Lechowicz: "As amended."

Speaker Madigan: "Mr. Walsh."

W. Walsh: "Mr. Speaker and Ladies and Gentlemen of the House, first of all, I resent people attaching motives to Amendments that I



make or to anything else that I do here. And the Gentleman incidentally was not correct in the assessment he made. The Amendment that I introduced would have done something for this Bill that without which the Bill does nothing. I submit to you, Mr. Speaker, that the Gentleman's statement that insurance rates would have gone... would have skyrocketed for women if the Amendment had been adopted is a half-truth. They would have gone up certainly but they would have come down accordingly for men and for young men, boys. I submit to you, Mr. Speaker, that sex is not a proper classification in determining insurance rates. Insurance rates ought to be determined on the basis of individual experience. That's why I offered the Amendment. Now I suggest since the Amendment was not adopted, the Bill does nothing and so, let's defeat it."

Speaker Madigan: "Is there any further discussion? Mr. Meyer."

Meyer: "Question of the Sponsor, Mr. Speaker."

Speaker Madigan: "Sponsor indicates that he will yield."

Meyer: "Representative Lechowicz, what would be the situation of a physically impaired person with a vision problem? Would he... would the insurance company have to insure a blind person or near blind person?"

Lechowicz: "No, if you read the Bill, let me be quite specific, on page 1, line 31, Section 5 'making or charging any rate for insurance against losses arising from the use of ownership of a motor vehicle which requires a higher premium for any person by reason of his physical handicap' and then underlined is 'race, color, religion or national origin'. That's the only new addition as far as for the physically handicapped. I believe if a person has a visual impairment, unfortunately, he does not qualify to, one, receive an Illinois driver's license; two, to apply for insurance in driving an automobile."

Meyer: "Well, Mr. Speaker, I... it just seems to me that physical disability in some cases may be a rational basis for increasing premiums, especially people that are nearsighted or farsighted or near blind. I think that this is going overboard and insurance companies should be allowed to make, determine their rates on some



basis."

Speaker Madigan: "Mr. Epton."

Epton: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House, apparently there is some misunderstanding about this Bill. Whether or not the previous Amendment relating to sex was put on to it has no bearing upon this present Bill which is an extremely good one. I'm rather shocked to find that there are people who feel that this legislation is not a great help. Very simply what it does is what every community organization in the State of Illinois has been asking for. It puts home owner's insurance coverage in the fair plan which today it does not have. This is an integral part of this Bill. In addition, it allows for the use of premium installment plans. On top of that, it allows for immediate binding. It's the most effective piece of legislation against redlining that we have ever had in the State of Illinois. It's approved not only by the administration, by the Department of Insurance. It's even reluctantly accepted, reluctantly accepted by the insurance industry. The fact remains that this is an extremely valid Bill, an extremely good Bill. Some of you have made some very logical points and they should be taken up. For example, I think that the insurance companies can discriminate, discrimination in itself is not necessarily derogatory. They can distinguish between blind and semi-blind people. There are some handicapped drivers who have a safer driving record than others, but more important than anything else is the fact that for the first time the fair plan must provide full coverage to the home owner's insurance. And I suggest that this is a Bill that we should all vote for."

Speaker Madigan: "Mr. Levin."

Levin: "Mr. Speaker, I rise to commend Representative Lechowicz and Epton for this legislation, especially for Amendment 4 because I do believe that the extension of the full scope of home owner's coverage under the Illinois Fair Plan is a very important provision and one that's long overdue. Since 1969, the Director of Insurance has had the authority if he wanted to to extend the scope. Unfortunately, past Directors have not exercised this and the



result has been that many home owners have been...who have been forced into the fair plan, have only been able to get very limited insurance. They have not been able to get the full scope of coverage that is offered under this proposal. Therefore, I very strongly urge the adoption of this Bill."

Speaker Madigan: "Mr. Deuster."

Deuster: "Very briefly, Ladies and Gentlemen of the House, we all give speeches back home about the free enterprise system and then every time we get down here, we seem to be offering legislation that ties the hands of business enterprises. Now none of us or very few of us are insurance experts and I think that the insurance industry in Illinois would be better off if we would stop passing laws telling them what they can't do and let them make the actuarial studies, let them determine what classifications of people and persons they need to lump together to make decisions. And if they... they happen to feel that a blind person should not drive an automobile or should have a higher rate of insurance or somebody with other kinds of physical impairments and handicaps, the insurance industry which is competitive and should be competitive ought to be left as free as possible to do this. Now the law already prohibits discrimination on the grounds of race and some ethnic background, whether you're German or Polish or Irish or whatever, they can't discriminate against you on that or if you're white or black whatever. But when we get into the area of characteristics of your body that might affect your ability to be a safe driver, certainly this is an area where we ought to be reluctant, we ought to show some restraint and I would urge a 'no' vote so that we don't tie the hands of our insurance industry here in Illinois."

Speaker Madigan: "Is there any further discussion? Mr. Lechowicz to explain his vote."

Lechowicz: "How about to close?"

Speaker Madigan: "Excuse me. To close the debate."

Lechowicz: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. First of all, let me point out to Representative Deuster, quite specifically that I, for one, do not want to tie anyone's



hands whether it be industry, labor or government. But I think we act here as a catalyst, a catalyst where you have a problem in a certain area and you try to bring people together and come up with a rational solution. Senate Bill 1792 fills that totally. One, as far as with the handicap, there was some problem areas and this is agreed with with the insurance companies. Two, there was a situation that developed by a Bill that was passed last year. The Department of Insurance asked if it could be corrected. That was corrected by Amendment #3. Amendment #4 which provides for a fair plan for home owners throughout this state is again a situation that the insurance companies and the home owners in every urban area of this state have finally come up with a solution and the Amendment #4 agrees and has the concurrence of the Department of Insurance, the insurance industry and, yes, the consumer groups throughout this state. First of all, I'd like to commend the Chairman of the Insurance Study Commission in working closely with the House Sponsor of Senate Bill 1792. I would hope that the Membership would read the Bill as amended and I'm sure they would concur with the Amendments that were adopted on this House floor and I ask for your favorable consideration to Senate Bill 1792 as amended."

Speaker Madigan: "The question is, shall this Bill pass? All those in favor signify by voting 'aye', all those opposed by voting 'no'. Have all voted who wish? Have all voted who wish? The Clerk shall take the record. On this question there are 142 'ayes', 11 'noes', no voting 'present'. This Bill having received a Constitutional Majority is hereby declared passed. Mr. Kane on Senate Bill 1522."

Clerk O'Brien: "Senate Bill 1522. A Bill for an Act making appropriation to the Board of Higher Education. Third Reading of the Bill."

Speaker Madigan: "Mr. Kane."

Kane: "Mr. Speaker, Ladies and Gentlemen of the House, Senate Bill 1522 appropriates thirty and a half million dollars for the operation of the Board of Higher Education for fiscal 1979. Not only does it provide for the operation of the Board of Higher Education,



but also a number of grant programs run by the Board and it's a modest increase over last year and I would ask for the favorable consideration of the House."

Speaker Madigan: "Is there any discussion? Mr. Edgar."

Edgar: "Would the Sponsor yield?"

Speaker Madigan: "Sponsor indicates that he will yield."

Edgar: "Representative Kane, in Committee the other day when this Bill came up, I asked for some information from the Executive Director of the Board of Higher Education regarding the number of employees... higher education making over twenty thousand in the cost of pay raise. He said he'd furnish that to me. Has he given that you? I haven't received that yet. He said we'd get it before we'd vote on it."

Kane: "I haven't received it in the last week. But about a month ago I got a list of it and there's approximately seven thousand, six hundred and fifty-three."

Edgar: "Seven thousand over... making over twenty thousand in higher education?"

Kane: "Yes."

Edgar: "You don't know what the pay raise, how much money that was involved for these people over twenty thousand do you?"

Kane: "No, I don't have a breakdown of that."

Edgar: "Thank you. They didn't have that information. I wish I'd have talked with you."

Speaker Madigan: "Is there any further discussion? Mr. Porter."

Porter: "Mr. Speaker, will the Gentleman yield to a question?"

Speaker Madigan: "The Sponsor indicates that he will yield."

Porter: "Representative, I don't think you stated how much of an increase there was from the previous fiscal year. I think that's relevant."

Kane: "Last year Senate Bill 479 appropriated twenty-eight million, nine hundred and ninety-nine thousand, one hundred and eight dollars. Senate Bill 1522 appropriates thirty million, six hundred and eighty-two thousand, about a seven hundred thousand dollar increase. Most of that is in grants."

Porter: "Thank you very much. I would ask that all of the Members



presenting appropriation Bills please to tell us how much of an increase each time so we don't have to keep asking that question. Thank you."

Speaker Madigan: "Is there any further discussion? There being no further discussion, the question is, shall this Bill pass? All those in favor signify by voting 'aye', all those opposed by voting 'no'. Have all voted who wished? Have all voted who wished? Have all voted who wished? The Clerk shall take the record. On this question there are 128 'ayes', 17 'noes', 5 voting 'present' and this Bill having received a Constitutional Majority is hereby declared passed. Mr. Mautino, Senate Bill 1513."

Clerk O'Brien: "Senate Bill 1513. A Bill for an Act making an appropriation to the Department of Agriculture for certain expenses for the Bureau County Fair Association, Incorporation. Third Reading of the Bill."

Speaker Madigan: "Mr. Mautino."

Mautino: "Thank you very much, Mr. Speaker and Ladies and Gentlemen of the House. This legislation, Senate Bill 1513, appropriates forty thousand dollars from the Ag. Premium Fund for the fine arts building replacement which was destroyed by a tornado and it's effective in '78. I believe that Senator Shapiro has the appropriation in the budget and I would ask for an affirmative Roll Call."

Speaker Madigan: "Is there any discussion? Mr. Skinner."

Skinner: "Where is the fine arts building?"

Mautino: "Pardon?"

Skinner: "Where is the fine arts building."

Mautino: "The Bureau County fairgrounds. Fair property in Princeton, Illinois."

Skinner: "All right, I'm sorry. I thought that perhaps we were talking about another fine arts building for Northern Illinois University and that cost forty-five dollars per square foot. I'm sure this one won't cost that much."

Mautino: "It's only called a fine arts building. That's when it went...that's the name of it when the tornado hit it and they just reapplied the name to the new building."



Skinner: "Are there no insurance proceeds?"

Mautino: "Yes, I think the building cost more than forty thousand."

This is the share under the formula under the Ag. Premium Fund."

Skinner: "Oh, that's free money. I forgot."

Speaker Madigan: "Is there any further discussion? There being no further discussion, the question is, shall this Bill pass? All those in favor signify by voting 'aye', all those opposed by voting 'no'. Have all voted who wished? Have all voted who wished? The Clerk shall take the record. On this question there are 113 'ayes', 26 'noes', 5 voting 'present'. This Bill having received a Constitutional Majority is hereby declared passed. Mr. Pierce on Senate Bill 1634."

Clerk O'Brien: "Senate Bill 1634. A Bill for an Act relating to the assessment and extension of capital stock taxes on corporations and associations created under or subject to the General Not for Profit Corporation Act. Third Reading of the Bill."

Speaker Madigan: "Mr. Pierce."

Pierce: "Mr. Speaker, Ladies and Gentlemen of the House, Senate Bill 1634 is an emergency matter. It passed the Senate unanimously and the House Revenue Committee without a dissenting vote. What it does is assure not for profit corporations incorporated in the General Not for Profit Act who have not been assessed for capital stock tax in the past that they will not be assessed for 1978 in subsequent years. Through the Attorney General's opinion, there's been cast some doubt whether not for profit corporations are subject to the capital stock tax. We know they have no stockholders. By definition there's no stockholder of a not for profit corporation, but at the same time the Attorney General has raised the question of whether they're subject to the capital stock tax. All this Bill says is that those not for profit corporations that weren't assessed for capital stock tax prior to 1978, will not be assessed for 1978 and subsequent years. It's an emergency because those assessments are now being made for '78 and I ask your support of this Bill which passed the Senate unanimously and the House Revenue Committee without a dissenting vote."

Speaker Madigan: "Is there any discussion? There being no discussion,



the question is, shall this Bill pass? All those in favor signify by voting 'aye', all those opposed by voting 'no'."

Pierce: "Everybody get 'aye' now."

Speaker Madigan: "Have all voted who wished? Have all voted who wished? The Clerk shall take the record. On this question there are 147 'ayes', 2 'noes', 2 voting 'present'. This Bill having received a Constitutional Majority is hereby declared passed.

Mr. Matijevich on Senate Bill 1845."

Clerk O'Brien: "Senate Bill 1845. A Bill for an Act to make an appropriation to the ordinary and contingent expense of the Illinois Economic and Fiscal Commission. Third Reading of the Bill."

Speaker Madigan: "Mr. Matijevich."

Matijevich: "Mr. Speaker, Ladies and Gentlemen of the House, Senate Bill 1845 as was said is the annual appropriation for the ordinary and contingency expenses of the Illinois Economic and Fiscal Commission. The Senate Committee in Senate action made a very small reduction and the House Appropriations Committee affirmed that amount and the Bill now before you is a total of three hundred and forty-seven thousand and thirteen dollars. I ask for your favorable Roll Call vote on Senate Bill 1845."

Speaker Madigan: "Is there any discussion? For what purpose does Mr. Totten arise?"

Totten: "It's not for a motion, Mr. Speaker. I'd like to ask a question of the Sponsor."

Speaker Madigan: "You wish to direct a question to the Sponsor."

Totten: "Precisely. I would like to direct a question to the Sponsor regarding this Bill."

Speaker Madigan: "The Sponsor indicates that he will yield."

Totten: "Would the Chairman of the Appropriations Committee indicate what increase this is over last year's budget?"

Matijevich: "Fifty-nine thousand dollars. Mum's the word."

Totten: "Thank you."

Speaker Madigan: "Mr. Wolf."

Wolf: "The Sponsor yield for a question?"

Speaker Madigan: "The Sponsor indicates that he will yield."

Wolf: "What does this Commission do for three hundred and forty-seven



thousand dollars?"

Matijevich: "Who asked that? Oh, Jake Wolf. Well, so far, I haven't been a Member of it too long, Representative Wolf. I've been a Member since I have been the Chairman of the Appropriations I Committee and I think the Economic and Fiscal Commission has been doing a good job, one of making revenue estimates, developing economic trends in the State of Illinois. I think they have had some very valuable hearings as far as I'm concerned that were valuable in determining the impact on the economy in the State of Illinois and especially as it relates to the agricultural economy. I think that their annual report that they file is a very good annual report. As you know, an agency of the state Legislature has got to under our Constitution make fiscal estimates so that we can do a better job in appropriated funds. So I think the Commission has served a valuable purpose since it has been formed."

Wolf: "John, wouldn't this kind of be some conflict with the Business and Economic Development or the things that our own staff do?"

Matijevich: "Well, Representative Wolf, we could eliminate all Commissions and staff could do the work. But we're never going that way evidently so this... because we aren't going in that direction I think that this is a valuable Commission that is doing a service to the legislative process."

Speaker Madigan: "Is there any further discussion? There being no further discussion, the question is, shall this Bill pass? All those in favor signify by voting 'aye', all those opposed by voting 'no'. Have all voted who wished? Have all voted who wished? The Clerk shall take the record. On this question there are 114 'ayes', 30 'noes', 4 voting 'present'. This Bill having received a Constitutional Majority is hereby declared passed.

Mrs. Younger, do you wish to call Senate Bill 1533? Mrs Younger, Senate Bill 1534? What about your Bills on the Order of House Bills, Second Reading, Mrs. Younger? House Bill 3067."

Younger: "There are no changes; it should be moved to Third."

Speaker Madigan: "Okay. House Bill 3067 on Second Reading, page 2 of the Calendar."



Clerk O'Brien: "House Bill 3067. A Bill for an Act making an appropriation to the Depressed Land Use and Community Development Authority. Second Reading of the Bill. Amendment #1 was adopted in Committee."

Speaker Madigan: "Are there any motions?"

Clerk O'Brien: "No motions filed."

Speaker Madigan: "Are there any Floor Amendments?"

Clerk O'Brien: "No Floor Amendments."

Speaker Madigan: "Third Reading. House Bill 3069."

Clerk O'Brien: "House Bill 3069. A Bill for an Act making appropriation to the Illinois Energy Resources Commission. Second Reading of the Bill. Amendments #1, 2, 3, 4, 5, 6, 7, 8, 9, and 10 were adopted in Committee."

Speaker Madigan: "Are there any motions?"

Clerk O'Brien: "No motions filed."

Speaker Madigan: "Are there any Amendments?"

Clerk O'Brien: "No Floor Amendments."

Speaker Madigan: "Third Reading. Mr. Barnes."

E.M. Barnes: "Thank you very much, Mr. Speaker. This is the House Omnibus Commission Bill. I had indicated to Members on the floor and in Committee, Mr. Speaker, I would appreciate it if this Bill having been read a third time will be held on Second Reading for today and be moved tomorrow. That's to give all Members of the House an opportunity to look at this Bill, this is the House Omnibus Commission Bill to insure that your Commission is included or not included and to have one day to look at it and tomorrow move it to Third Reading."

Speaker Madigan: "Mr. Barnes, are you on House Bill 3069?"

E.M. Barnes: "3069, yes. That's the Omnibus Commission, House Commission Bill."

Speaker Madigan: "All right. The Bill is now on the Order of Third Reading. The Clerk shall read the Bill a third time."

E.M. Barnes: "Mr. Speaker, Mr. Speaker, I had indicated that it would be left on Second for today so that the Members could see what was in it and then move it to Third Reading tomorrow."

Speaker Madigan: "Mr. Barnes."



E.M. Barnes: "Yes, Mr. Speaker."

Speaker Madigan: "Would you, in light of our time constraints, would you wish to leave this on Third and then bring it back tomorrow?"

E.M. Barnes: "That would be just fine, but we..."

Speaker Madigan: "We have to leave it on Third overnight."

E.M. Barnes: "That's just fine, but I just wanted to make the announcement so everyone would know that this is the Omnibus Commission Bill. It will be left on Third so that they can look at it. If there's any indication from any Member of the necessity to bring it back to Second, we would do it at that time."

Speaker Madigan: "For what purpose does Mr. Collins arise?"

Collins: "Question of the Chair, Mr. Speaker. I'm confused. The Calendar says that this is a Bill for the Illinois Resources Commission. Now has it been changed to be the Omnibus Commission Bill?"

E.M. Barnes: "Yes, it was changed in Committee. It was amended in Committee; struck everything and added all of the Commissions. That's the reason I'm leaving it there so you can see them."

Collins: "Thank you very much."

Speaker Madigan: "House Bill 3071, Mrs. Youngue."

Clerk O'Brien: "House Bill 3071."

Speaker Madigan: "Mr. Ryan."

Ryan: "Well, thank you, Mr. Speaker. On House Bill 3069, is it my understanding that Representative Barnes or Representative Youngue whoever's going to be the Sponsor has agreed to take this Bill back to Second? Is that the agreement?"

Speaker Madigan: "Mr. Barnes, would you respond to that question?"

E.M. Barnes: "Yes, that was the indication I just made. It's on Third but at the time that it is necessary to move it back, it will be moved back."

Ryan: "Thank you."

E.M. Barnes: "It's there for the review of the House right now."

Clerk O'Brien: "House Bill 3071."

Speaker Madigan: "For what purpose does Mr. Bluthardt arise?"

Bluthardt: "I'd like to go back to that last Bill. My understanding was that Mr. Barnes said that that included all Commissions and



I don't see several Commissions on there. Are there other Omnibus Bills, Eugene, that would cover Commissions-like Cities and Villages, Municipal Problems Commission?"

Speaker Madigan: "Mr. Barnes. Would the Membership please give their attention to Mr. Barnes? There seems to be a great deal of confusion regarding this Bill. If everyone would give their attention to Mr. Barnes, we might eliminate some of the confusion."

E.M. Barnes: "Thank you very much, Mr. Speaker. You're absolutely correct, Representative. I misspoke. There are two Omnibus House Commission Bills and one that you're asking about is 3385 and those Commissions are included there. So the two Bills are now out on the House floor so everyone can peruse them and make sure that all those Commissions have been put in one or the other Bill. 3385 or 3069."

Bluthardt: "Thank you."

Speaker Madigan: "For what purpose does Lynn Martin arise?"

L. Martin: "Just to tell the House that in regards to House Bill 3069, there are a series of Amendments being prepared by Representative Hanahan, Davis and myself that will be ready for both Omnibus House Bills."

Speaker Madigan: "House Bill 3071, Mrs. Younge."

Clerk O'Brien: "House Bill 3071. A Bill for an Act making an appropriation to the Department of Business and Economic Development for the development of Progress Plaza Industrial Park. Second Reading of the Bill. No Committee Amendments."

Speaker Madigan: "Are there any motions? Are there any Floor Amendments?"

Clerk O'Brien: "No Floor Amendments."

Speaker Madigan: "Third Reading. House Bill 1089, Mrs. Younge."

Clerk O'Brien: "House Bill 1089. A Bill for an Act making appropriation to the Department of Business and Economic Development. Second Reading of the Bill. Amendment #1 was adopted in Committee."

Speaker Madigan: "Are there any motions?"

Clerk O'Brien: "No motions filed."

Speaker Madigan: "Are there any Amendments?"

Clerk O'Brien: "No Floor Amendments."



Speaker Madigan: "Third Reading. House Bill 2585."

Clerk O'Brien: "House Bill 2585. A Bill for an Act making appropriation to the Capital Development Board. Second Reading of the Bill. Amendment #1 was adopted in Committee."

Speaker Madigan: "Are there any motions?"

Clerk O'Brien: "No motions."

Speaker Madigan: "Are there any Amendments?"

Clerk O'Brien: "No Floor Amendments."

Speaker Madigan: "Third Reading. House Bill 2885. Mr. Dan Houlihan."

Clerk O'Brien: "House Bill 2885. A Bill for an Act making appropriation to the Supreme Court for the pay of certain officers in the judicial system. Second Reading of the Bill. Amendments #1, 2, 3, 4 and 5 were adopted in Committee."

Speaker Madigan: "Are there any motions?"

Clerk O'Brien: "No motions filed."

Speaker Madigan: "Are there any Amendments?"

Clerk O'Brien: "Floor Amendment #6, Brady. Amends House Bill 2885 as amended by inserting immediately after Section 2 the following and so forth."

Speaker Madigan: "Mr. Brady."

Brady: "I'd like to withdraw Amendment #6."

Speaker Madigan: "The Gentleman requests leave to withdraw Amendment #6. Is there leave? Leave being granted, Amendment #6 is withdrawn. Are there any further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker Madigan: "Third Reading. Mr. Abramson is not in the chamber. Ms. Catania, do you wish to call 2978? Mr. Kane, House Bill 3197?"

Clerk O'Brien: "House Bill 3197. A Bill for an Act to provide for the ordinary and contingent expense of the State Comptroller. Second Reading of the Bill. Amendment #1 was withdrawn in Committee. Amendment #2 was adopted in Committee."

Speaker Madigan: "Are there any motions?"

Clerk O'Brien: "No motions filed."

Speaker Madigan: "Are there any Amendments?"

Clerk O'Brien: "Floor Amendment #3, Cunningham. Amends House Bill



3197 on page 2 by inserting immediately after Section 1 the following: Section 1(a) and so forth."

Speaker Madigan: "Mr... Who is the Sponsor of the Amendment?"

Clerk O'Brien: "Representative Cunningham."

Speaker Madigan: "Mr. Cunningham."

Cunningham: "Well, Mr. Speaker and Ladies and Gentlemen of the House, Amendment #3 is the recognition of the wisdom of a principle being applied across the rotunda called the Hynes Amendment, formerly the Partee Amendment. The Comptroller has made quite a display of making a superficial cut in his budget and the thought occurs that maybe we ought to limit the times recognized that he'll be leaving for private occupation after the first of January. And that being true, we are offered the Amendment that's been known as the Hynes Amendment and assume it'll have unanimous support. Ask an 'aye' vote."

Speaker Madigan: "Mr. Brummer."

Brummer: "That was the clearest nonexplanation I've ever heard. Can you explain the Amendment?"

Speaker Madigan: "Mr. Brummer, what was your question?"

Brummer: "I was wondering if the Sponsor would explain the Amendment."

Speaker Madigan: "Mr. Kane, do you wish to respond? Mr. Kane."

Kane: "Mr. Speaker, Ladies and Gentlemen of the House, the Comptroller has no objection to this Amendment. For Mr. Brummer's information which evidently Mr. Cunningham is not able to provide, what the Amendment does is say that no more than fifty percent of the funds for the fiscal year can be encumbered in the first half of the year."

Speaker Madigan: "Mr. Kane accepts the Amendment. All those in favor of the Amendment signify... For what purpose does Mr. Lechowicz arise?"

Lechowicz: "Well, Mr. Speaker, I'm going to stand in opposition to the Amendment for the sheer purpose of having uniformity in the appropriation process not only for the Comptroller's Office but the other four state elected officials as well as the twenty-three code departments. I believe that this Amendment, I know when we were in the process of, the appropriation process two years ago



and it was for a two year term and there was some question as... and it was the Partee Amendment at that time in the Senate. It was adopted through all the appropriation measures on the uniform basis. But here now this afternoon, we have the Amendment; the first time that it's offered is on the Comptroller's Bill. And in all fairness if you're going to be offering it on one, it should be across the board on all appropriation matters. And I don't believe that this has been the case. At this time and for this reason, I'm going to oppose this Amendment for uniformity. I would strongly recommend a 'no' vote on this Amendment #3 to 3197."

Speaker Madigan: "Is there any further discussion? Mr. Cunningham."

Cunningham: "Thank you for waking the electrician. We don't want to promote controversy here and we'll just withdraw it and let Senator Hynes put it on when it gets over at the Senate, Representative Lechowicz and see what your reaction at that time is. So we'll move to withdraw that Amendment."

Speaker Madigan: "Mr. Lechowicz."

Lechowicz: "Well, if that's the case if they're putting them on in the Senate, I would not... I would with... would withdraw my previous remarks and move for its concurrence. In case, if they're putting it on on all Bills, that's fine. But if you're only going to put it on one, I'd have to be opposed to it. According to the statement that's been made, Mr. Speaker, they are putting them on on the other Bills and I would move to concur with Amendment #3."

Speaker Madigan: "Mr. Lechowicz withdraws his objection. Mr. Kane accepts the Amendments. There's no need to hear from Mr. Cunningham any further. All those in favor of the Amendment signify by saying 'aye', all those opposed say 'aye'. In the opinion of the Chair, the 'ayes' have it. The Amendment is adopted. Are there any further Amendments?"

Clerk O'Brien: "Floor Amendment #4, Cunningham. Amends House Bill 3197 on page 1, line 16 and so forth."

Speaker Madigan: "Mr. Cunningham."

Cunningham: "How kind of you, Speaker. Now Amendment #4 is needed



very much. It's an earnest Amendment. It's something that deserves your attention: "I want to publicly commend the Comptroller as I did when it came before Appropriations for the fact, and you'll hear much about it as the season rolls on, that there has been a miniscule reduction in his budget this year over last. But the catch is that there's an increase over the amount of money that is actually spent last year as compared with the year 1979. That's what the taxpayers are interested in, not the arithmetic. Anybody can cite figures to quote their position, but he's asking for more money in '79 than was spent in '78. And you and I know that that isn't the message that we're getting from back home. We've pointed out some economies in the prior discussion of the Comptroller's budget. We have a full scale picture, we have... we were regaled with tales of horror in the Appropriations I by the incomparable Honest John Matijevich because there was a thumb-nail sketch there of Director Block. I thought he was going to climb over the bench and shake Block because he had the audacity to put his picture on the particular budget. But you see that in the exhibit that I'm holding here before you that the Comptroller recognized no modesty whatever in advertising the occupant of the office. There has been the question last year of an expensive survey that was done and it has been pointed out many times to the press and they refuse to print it that the survey had a political implication. It was a classic example of a public official using his office as a springboard or a hoped for springboard to higher things because the survey asked the questions to what the taxpayers were interested in. But those comments might be thought partisan. What is nonpartisan here is the irrefutable arithmetic that there is forty-three thousand taxpayer dollars in this budget that should be removed by the economy minded servants of the people that are going to be pulling their switches. We urge you to believe that that amount can be taken from the Comptroller's budget without any harm whatever and I assume that the Sponsor will graciously accede to our request that 4 might be adopted and we move on."

Speaker Madigan: "The Gentleman moves for the adoption of the Amendment."



On the Amendment, Mr. Kane."

Kane: "Would the Sponsor of the Amendment yield for a question?"

Speaker Madigan: "The Sponsor indicates that he will yield."

Kane: "Mr. Sponsor, you indicated that the appropriation for the Comptroller this year was a reduction of a miniscule amount from the appropriation of last year. Would you characterize the reduction, if any, that the Governor has in the departments under his control, is that a reduction? Perhaps you could characterize the difference between this year's appropriation and last year's appropriation for the Governor's office and the departments under the Governor's control?"

Cunningham: "Fairness and impartiality are a many splendored thing and if you'll recall at the meeting when we held before the Committee I, I publicly commented that the Comptroller was to be saluted. I have never, ever heard you make such a damaging political remark in behalf of one of the opposite side of the aisle. So we will not be lectured to you, by you on partisan issues. What's involved here is not the size reduction, but what can be done to serve the taxpayers. There is a slight reduction over the amount that was authorized last year, but you're not challenging our prior assertion that there's actually an increase in the amount of money that's been expended over last year and that's the thing that the taxpayers object to. That's why we're asking you in good faith and conscience to support the Amendment #4. Do you support it?"

Speaker Madigan: "Mr. Kane."

Kane: "Mr. Speaker, Ladies and Gentlemen of the House, I would oppose Amendment #4. It's obvious that the perpetrator of this Amendment is perpetrating it for political purposes. He wishes that he had a Leader on his side of the aisle that would have a reduction in a budget. And what happens is that his Leadership has come in with an increase in budget and he is castigating the Leader on our side for a reduction. And if he would want to vote for... vote against a reduction, that would be up to him. But let me point out the budget for the Comptroller's Office this year, the Comptroller is asking for a reduction of a hundred and



eighty-seven thousand, one hundred dollars for a 2.1 percent reduction in his budget for this coming year. This is the second straight year that he has asked for a reduction in his budget. That reduction over a two year period has been a reduction of 5.1 percent and if one looks at the rate of inflation which in the last two years has been in the neighborhood of six and nine percent, this is a reduction in real terms of close to twenty percent over a two year period. What the Gentleman wants to do is to cut twenty-eight thousand dollars from the budget to eliminate a contract with Data Resources Incorporated and I would urge that that information, its economic forecasting information is vitally needed in government to have a balance with the Bureau of the Budget. He also wants to reduce printing by seven percent when if he checked his arithmetic he would know that the cost of Xerox paper has gone up eleven percent in the last year and cannot take this additional cut. And I would urge the defeat of this Amendment that is patently political and also indicates the Gentleman's envy for a Leader who is able to reduce real budgets five percent in dollar terms, twenty percent in real terms over a two year period. I would urge the defeat of Amendment #4."

Speaker Madigan: "Mr. Matijevich."

Matijevich: "Yes, Mr. Speaker, I understand that the Gentleman from Lawrence used my name. I was just walking out the door to see a constituent and I think I know what his remarks were. I think he's half right on what he's doing. He's totally wrong on Amendment #4. He may be half right as far as annual reports are concerned and I criticize anybody that uses any document with full-blown photographs. However, if the Gentleman from Lawrence will look at that document, at least that document does follow the law and tells you how many copies are printed. And the annual report of the Department of Agriculture Director and I believe there's some other agencies that violate the law and don't tell us exactly how many copies are being printed. Now that's important in an election year because there's a lot of these copies of annual reports are floating around just for political purposes. I saw one from the Department of Public Aid that's a pretty nifty



report and I saw they've got ten thousand of those copies. Now everybody here gets a copy of that report and the first thing they do is throw them in the waste basket right under our desks and we're wasting ten thousand of those reports. And I'll go along with that criticism. But as to the Amendment, we hear people talk about bare bones budgets. Now I do realize that Comptroller Bakalis knew that he's in an election year and he had to really keep his budget down, but he did that. Governor Thompson knows that he's in an election year, too, but he didn't keep his budget down and provide for tax relief which is what we're trying to do. So I think in all honesty, we've got to defeat Amendment #4. I agree with the Sponsor of the Bill. It's totally political. I'm kind of surprised at Representative Cunningham being the Minority Spokesman on Appropriations Committee that he would take this avenue with a Bill that is so tight and fiscally responsible. Very often Representative Cunningham in Committee said, says that pep without point is piffle. Roscoe, with regards to this Amendment, pep without point is piffle. I'd urge the defeat of the Amendment."

Speaker Madigan: "Is there any further discussion? Mr. Cunningham to close the debate."

Cunningham: "Well, Mr. Speaker and Ladies and Gentlemen of the House, I want to publicly reject any suggestion whatever that politics is involved in the arithmetic of figuring out how much the taxpayers can stand. And I want to say in regard to the Comptroller Bakalis, I yield to none in my admiration of him. I wish him a long, happy retirement. But in regard to this Bill, Representative Kane spelled it out quite well a moment ago when he itemized the breakdown, I was going to do it at this point. Twenty-eight thousand and four hundred dollars for the economic and fiscal forecast. You remember those forecasts of a year ago. They were so far wrong that there isn't a one of you that has a five year old child that couldn't come up with a more accurate figure. There's, it's a duplication of the services. Representative Matijevich just rammed through an appropriation here a minute ago for the Economic and Fiscal Commission and why in the name of fiscal sanity



is it necessary to have a second group of experts making the same guesses in the dark as to what the balances are going to be. I suggest to you in complete nonpartisan objectivity there is no way on earth to justify that twenty-eight thousand, four hundred dollars from the Comptroller. There's another item there for three thousand dollars for wearing apparel. I don't know what the wearing apparel could be; whether they're new swimming suits or what they are but there is no reason we can't figure where they could spend the three thousand dollars. There's a printing bill that can be reduced twenty-five hundred dollars. If not... it's any defense whatever to say that somebody else's budget may have more fat in it than this particular budget. What we're considering now is how many taxpayer dollars can be expended for the functioning of the Office of Comptroller. I suggest to you that you... you can best serve your taxpayers by voting for Amendment #4. Take our word for it, take the staff's word on both sides of the aisle that adoption of this Amendment will in no way diminish the efficient operation of the office. It deserves your 'aye' vote."

Speaker Madigan: "We have closed the debate and the question is, shall the Amendment be adopted? All those in favor signify by voting 'aye', all those opposed by voting 'no'. Have all voted who wish? Mr. Skinner to explain his vote."

Skinner: "To the surprise of my Minority Spokesman on this Committee I'm going to vote 'yes'. Or excuse me, I'm going to vote 'no' on this Amendment because I think the Comptroller needs all the help he can get in revenue forecasting. He was off so much last time around."

Speaker Madigan: "Have all voted who wished? The Clerk shall take the record. On this question there are 62 'ayes', 84 'noes', no voting 'present'. The Amendment fails. Are there further Amendments?"

Clerk O'Brien: "Floor Amendment #5, Kane. Amends House Bill 3197 on page 5 by deleting line 8 and 9 and so forth."

Speaker Madigan: "Mr. Kane."

Kane: "Mr. Speaker, Ladies and Gentlemen of the House, Amendment #5 amends the state officer's salary portion of the Comptroller's



Bill. As you know, the Comptroller's Bill or the money for state officer's salaries - is part of the Comptroller's Bill. There were two Acts that were passed last year by the General Assembly - Public Acts 80-176 which created a Second Chief Assistant to the Adjutant General in the Military and Naval Department and also Public Act 80-1094 which provided for salary increases for the Chairman and the Members of the Illinois Industrial Commission. What Amendment #5 does is put in the money to pay for the Second Assistant to the Adjutant General and to pay for the increased salaries for the Chairman and the Members of the Industrial Commission. And I would urge the adoption of Amendment #5."

Speaker Madigan: "Is there any discussion? There being no discussion, the question is, shall the Amendment be adopted. All those in favor signify by saying 'aye', all those opposed by saying 'no'. In the opinion of the Chair, the 'ayes' have it, the Amendment is adopted. Are there further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker Madigan: "Third Reading. Mr. Ryan, do you wish to hold 3276 on Second? House Bill 3316."

Clerk O'Brien: "House Bill 3316. A Bill for an Act changing the name of the Illinois Institute of Environmental Quality to the Illinois Institute of Energy and Environmental Resources. Second Reading of the Bill. Amendments #1, 2, 3 and 4 were adopted in Committee."

Speaker Madigan: "Mr. Kane. Out of the record? Take this Bill out of the record. House Bill 3319, Mr. Madison."

Clerk O'Brien: "House Bill 3319. A Bill for an Act making appropriations to the Department of Public Aid, ten percent cost of living increase in the financial aid to all persons receiving assistance. Second Reading of the Bill. No Committee Amendments."

Speaker Madigan: "Are there any Amendments from the floor?"

Clerk O'Brien: "None."

Speaker Madigan: "Third Reading. Mr. Edgar. Mr. Edgar. Mr. Edgar. House Bill 3374?"

Clerk O'Brien: "House Bill 3374. A Bill for an Act to amend Sections of an Act to provide for the ordinary and contingent



expense of the Department of Public Health. Second Reading of the Bill. Amendments #1 and 3 were adopted in Committee."

Speaker Madigan: "Mr. Edgar."

Edgar: "Committee Bill."

Speaker Madigan: "No motions? Are there any Amendments from the floor?"

Clerk O'Brien: "No motions."

Speaker Madigan: "Are there any Amendments from the floor?"

Clerk O'Brien: "No Floor Amendments."

Speaker Madigan: "Third Reading. Mr. Matijevich, House Bill 3383? Take that out of the record. Mr. Matijevich, 3385?"

Clerk O'Brien: "House Bill 3385. A Bill for an Act to provide for the ordinary and contingent expense of the Chain of Lakes - Fox River Commission. Second Reading of the Bill. Amendments #1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12 and 13 were adopted in Committee."

Speaker Madigan: "Are there any motions?"

Clerk O'Brien: "No motions filed."

Speaker Madigan: "Are there any Amendments from the floor?"

Clerk O'Brien: "Floor Amendment #14, Peters. Amends House Bill 3385 as amended on page 4 by inserting between lines 23 and 24 the following: Section 8.1 and so forth."

Speaker Madigan: "For what purpose does Mr. Totten arise?"

Totten: "Well normally you've ruled if the Sponsor isn't here the Bill is moved without the Amendment. The Sponsor isn't here, so I'd assume you'd follow the same practice."

Speaker Madigan: "Mr. Peters in the chamber? Is there anyone capable of offering the Amendment on Mr. Peters' behalf? Mr. Matijevich."

Matijevich: "Mr. Speaker, this is the Omnibus Commission Bill and there's another one that Representative Barnes has and then there's, they're all going to be incorporated into a Senate Omnibus Bill. I'll accept the Peters' Amendment because we're going to have to work this all out in another Omnibus Bill. So I'll move for the adoption of Committee Amendment #14."

Speaker Madigan: "For what purpose does Mr. Totten arise?"

Totten: "Well, Mr. Speaker, you're departing from procedure. You haven't offered that same opportunity to other Members when they



had Amendment they may have favored when the Sponsor was absent.

"I think the Bill should be taken out of the record till the Sponsor of the Amendment's here."

Speaker Madigan: "Well, Mr. Totten, I'm personally concerned with the movement of the Bills in an orderly and expeditious fashion."

Totten: "Boy, so am I."

Speaker Madigan: "Yes, and therefore, I asked if there were anyone who could represent Mr. Peters and offer this Amendment and then the House can proceed to a full debate and decision on the matter. Mr. Ryan, do you seek recognition?"

Ryan: "Well, I would request that the Sponsor hold the Bill till Representative Peters is here."

Speaker Madigan: "Mr. Ryan, can we expect Mr. Peters tomorrow?"

Ryan: "No, he's here someplace in the building, Mr. Speaker."

Speaker Madigan: "Mr. Matijevich."

Matijevich: "Mr. Speaker, I understand that all the Amendment does is allow us the vehicle for amending the other Omnibus Bill into this Omnibus Bill and we're going to amend this Omnibus Bill into the other House Omnibus Bill so that when we do finally amend the Senate Bill, we'll have it all in one package. So it is a good Amendment."

Speaker Madigan: "Seems to be a certain... deal of controversy on this. The Minority Leader has asked that the Bill be held on Second Reading. Therefore, the Bill shall be held on Second Reading. On the Order of House Bills, Third Reading, Mr. Schisler. Mr. Schisler in the chambers? Mr. Ryan. House Bill 2739. Mr. John Dunn. House Bill 3128. Mr. Harris or Mr. Richmond on House Bill 3384. House Bill 3384 on page 3 of the Calendar..."

Clerk O'Brien: "House Bill..."

Speaker Madigan: "You wish to hold that? Mr. Terzich. House Bill 3387. Mr. Terzich."

Clerk O'Brien: "House Bill 3387. A Bill for an Act making an appropriation to the Department of Transportation. Third Reading of the Bill."

Terzich: "Yes, Mr. Speaker, Ladies and Gentlemen of the House, House Bill 3387 is requesting six million dollar appropriation for a



grade separation for my area in the 25th District. In my area there are approximately twenty grade crossings which is blocking off the entire ward and district in my area. I've discussed this problem with the Department of Transportation, Mr. John Kramer, and they have suggested and recommended that this be given serious consideration for a grade separation at 63rd and Harlem Avenue. And I'm requesting this appropriation for that grade separation for the feasibility study. In addition, the street that is cutting through is a state maintained street and I would appreciate favorable consideration for this appropriation."

Speaker Madigan: "Mr. Cunningham."

Cunningham: "Will the Sponsor yield?"

Speaker Madigan: "The Sponsor indicates that he will yield."

Cunningham: "Representative Terzich, is your Bill the same as Amendment 33 on the DOT budget?"

Terzich: "It could be. I don't know what Amendment 33 is, Representative Cunningham. If that is, it may be. Yes, it may be."

Cunningham: "Well, it was adopted by the other incomparable Representative from that district, Representative Kozubowski. There's no point in proceeding with yours in view of the compactness and directness of having it all together is there?"

Terzich: "No, that's all right with me, Representative, because I appreciate your vote in the Appropriation Committee for that Amendment, so if that's the case... why..."

Speaker Madigan: "Is there any further discussion? Mr. Ryan."

Ryan: "Well, thank you, Mr. Speaker. Will the Gentleman yield?"

Terzich: "I always do, George."

Speaker Madigan: "Yes, the Sponsor yields."

Ryan: "Very good, I'm glad to hear that. I'm talking about questioning. Representative, I see that the Department of Transportation says that 63rd Street in Chicago is not under the state's jurisdiction."

Terzich: "There was a..."

Ryan: "Or under their maintenance responsibility. Is that true?"

Terzich: "It is under the state's jurisdiction from Central Avenue all the way through Archer Road, that particular street on 63rd



Street. It is under the state's jurisdiction."

Ryan: "Well, where you want to build this overpass is not though, is that right?"

Terzich: "Yes, it is."

Ryan: "It is? Well..."

Terzich: "It's a grade... it's a grade separation. It's between Central Avenue and Harlem Avenue on 63rd Street which is..."

Ryan: "Well, I'm under the impression that it was designated a federal aid to urban system highway. And that would mean that any construction or improvements on that highway can be funded with the assistance of the Federal Government on a seventy-thirty basis."

Terzich: "That's correct. That's why..."

Ryan: "But the funding is handled by the City of Chicago. Is that correct?"

Terzich: "That's correct."

Ryan: "Well if you use that method, then the six million dollar package that you've got in here would only be 1.8 with the Federal Government picking up the remainder of the 4.2. Now why do you want to raid the Road Fund of six million dollars when you could go the route you're supposed to?"

Terzich: "Well, this was the amount suggested, Representative. Needless to say, if the money is not utilized, it's returned back to the DOT Fund anyhow. I really don't know. It's in the feasibility studies. These things don't happen overnight."

Ryan: "Well, Mr. Terzich, what I'm saying to you is that you're trying to get your money from the wrong place. That this road and this bypass or overpass or whatever it is you're trying to build at 63rd Street is not under the jurisdiction of the Illinois Department of Transportation. You ought to petition the City Council of the City of Chicago to start this project for you. It certainly doesn't belong to the Illinois Department of Transportation and you could do it and... and it would only cost the City of Chicago \$1.8 million. And you could get the other 4.2 from the Federal Government."

Terzich: "Well, Representative Ryan, the route is a state maintained system and, therefore, I feel I'm justified in asking for the



state to pay for the construction on a seventy-thirty basis. I have been working with the Department of Transportation; at their recommendation, I'm also suggesting this amount. And if the amount is excessive or not, I haven't build a grade separation in my life so I have no idea."

Ryan: "I don't question the amount, whether it's excessive or not, Representative. I question where the money comes from and I'd like to address the Bill. There's no reason that the Road Fund should be raided for six million dollars worth of projects for projects that may go in somebody else's district when the Representative hasn't gone the proper route for the money that he wants. And so I would certainly urge the defeat of this Bill."

Speaker Madigan: "Is there any further discussion? Mr. Terzich, to close the debate."

Terzich: "Well, yes, Mr. Speaker, I... you know, I've been trying for about two years to go to the right route. I've written letters, I've contacted railroads, Department of Transportation, Department of Streets and Sanitation, the Public Works Department, the railroads. Next, I think I'll ask God to send the money to me. I... you know, we have a problem in our district. I've never requested any DOT money for any projects in my area. This is very vital to the, my constituency... It's vital to my area and it would be money well spent for a project that is very, very desperately needed. We have, like I say, over twenty grade crossings in my district which we're completely surrounded by railroads and anybody who knows or had the experience of being stopped, emergency vehicles, the transportation is a big, big problem and I would appreciate support of House Bill 3387."

Speaker Madigan: "The question is, shall this Bill pass? All those in favor signify by voting 'aye', all those opposed by voting 'no'. Is Mr. Giorgi within earshot of the microphone? If he is, would he please come to the chamber? Mr. Giorgi. Have all voted who wished? Have all voted who wished? Have all voted who wished? Mr. Lechowicz, to explain his vote."

Lechowicz: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. Very briefly, this reminds me of a situation where



Representative Phil Collins a number of years ago put in a request for a bridge and through his perseverance and Representative Maragos at the time the Department of Transportation eventually included it in its budget and the bridge was built. This is a very serious situation in the southwest side of the City of Chicago as was presented by the Sponsor where we have over twenty different locations, twenty different intersections that are unfortunately blocked by railroad crossings. And I listened to the Minority Leader express his concerns as far as the funding of this program. The six million dollar figure was given to us by John Kramer himself and as far as the funding of it, you and I know that the Governor has an amendatory veto and if he wants to designate it that seventy percent comes out of the federal fund and thirty percent comes out of the state fund, he may do so. But in all fairness, Representative Terzich has gone through every recourse at his command and ask that the people listen to the people in his district and the plight of those residents. Ladies and Gentlemen, this is a situation that not only occurs in the 25th Legislative District, but I know that Jack Williams has similar problems. With the help of this House and the Senate, some of the situation was alleviated in Franklin Park. With your help, we can also alleviate this serious problem in the 25th Legislative District. I recommend your serious reconsideration on this Bill and ask for an 'aye' vote."

Speaker Giorgi: "Representative Wolf on House Bill 3387."

Wolf: "Mr. Speaker, Members of the House, I rise in support of this Amendment and I think more Members on this side of the aisle should be supporting it. I understand there's a terrible job shortage up there in the DOT, especially up in the Cook County area and with this extra six million dollars, I think maybe they could find some more jobs and put some people to work. I certainly encourage Members on this side of the aisle to help Representative Terzich in this fine piece of legislation."

Speaker Giorgi: "Members of the House, I have a very special announcement to make. Representative Totten is recognized."

Totten: "For what purpose, Mr. Speaker?"



Speaker Giorgi: "You know what."

Totten: "Mr. Speaker, I have a very special presentation. It's been said by many that there's too much popping off here and a lot of corn and I know there's nothing like a contented Greek to be a safe Greek and I also know that we want to move the order of business rather fast and it's been suggested by some Members that in order to do that, I make this presentation to the Lady from Lake, Mrs. Geo-Karis, figuring that if she keeps her mouth full, she'll keep it closed for the rest of the week. And from the Members, all the Members of the House, the General Assembly, this bag of popcorn which was made in my district, District 3, for you on the House floor."

Speaker Giorgi: "Representative Geo-Karis in gratitude."

Geo-Karis: "Mr. Speaker and Ladies and Gentlemen of the House, if Mr. Totten were Greek, I would say beware of the Greeks bearing gifts. What's this all about, Don? I've never been so honored."

Totten: "I just like you."

Geo-Karis: "Now, I'll pass the popcorn to everyone. This is the most money Totten has ever spent for this General Assembly and I want everybody to enjoy it."

Speaker Giorgi: "Has everyone voted that wished? Representative Ryan, for what reason do you rise?"

Ryan: "Well, at the proper time, I'd like to verify this Roll Call."

Speaker Giorgi: "Representative Terzich."

Terzich: "Well, yes, Mr. Speaker, I would just like to explain my vote and I understand... I say that Mr. John Kramer from the Department of Transportation did suggest this. Now it's my understanding that the, it is on a seventy-thirty basis, that seventy percent will be paid for by the Federal Government. It's a matter of fact routine that you request the amount necessary for the project and the state would be reimbursed by the Federal Government on seventy percent of the project. I don't know how many people I have to see or talk to, but like I mentioned that there are twenty, twenty grade crossings in my district and there are approximately two or three grade separations. If it wasn't so urgent and if I haven't spent over a year trying to contact the



necessary people and go through the proper channels, I'm at my end right now. Now I've supported many downstate projects. Needless to say I don't live in a farm country or farm town, but certainly the transportation problem in my district is just as serious as... and important to me as it is to any of the downstate Representatives. So please have a little compassion for my project here and give me an 'aye' vote."

Speaker Giorgi: "Have all voted who wish? Representative Garmisa to explain his vote."

Garmisa: "Yes, Mr. Speaker, in explaining my 'aye' vote, I wish that every Member of this district or of this General Assembly could have come along with me when I went into that district at the invitation of Bob Terzich and Ed Kornowicz to take a look at what is happening there with their railroad crossing problem. And let me tell you they really have a problem there and they have a problem that is insoluble without some help from this General Assembly. And anytime any Member of this General Assembly whether it be from downstate or upstate, wherever it may be, when they come with a type of problem that Bob Terzich has in his district, he always or any one of us should be getting a sympathetic ear. This is a problem that we should come up with and give him the help that he needs. I visited there and there were at least a hundred people that represented different leadership groups in that district. I went to every one of those twenty-three crossings. I, we were held up in making the crossings at least a half a dozen times ourselves. We were, a bus trip that would ordinarily take us no more than fifteen minutes, took us two hours and twenty-two minutes. Their problem there is a very serious one. I don't believe there's another one that can compare with it anywhere in the State of Illinois. He needs our help. Let's give him the help that he needs and let's give it to him with a green light."

Speaker Giorgi: "Have all voted who wished? Take the record, Mr. Clerk. Mr. Ryan, you persist in verification? Mr. Terzich requests a poll of the absentees. On this question there are 93 'ayes' and 65 'nays' and 3 voting 'present'. The Clerk will proceed with a poll of the absentees."

Speaker Giorgi: "Representative Bennett. Representative Bennett."



How's he recorded, Mr. Clerk?"

Clerk O'Brien: "The Gentleman's recorded as voting 'aye'."

Speaker Giorgi: "Is Mr. Bennett in the chamber? Representative Bennett in the chambers? Take him off the record."

Ryan: "Representative Birchler."

Speaker Giorgi: "Representative Birchler is here near the press box."

Ryan: "Representative Bradley."

Speaker Giorgi: "Bradley is at the back of the room."

Ryan: "Representative Caldwell. All right, I see him. Representative Christensen."

Speaker Giorgi: "Representative Christensen. He's up here in the Democratic aisle."

Speaker Giorgi: "Is Representative Laurino in the chambers? Take him off the record, Mr. Clerk."

Ryan: "Representative Luft."

Speaker Giorgi: "Representative Terzich, for what reason do you rise?"

Terzich: "Yes, Mr. Speaker, in consideration of the House, I'll move to put this Bill on to Postponed Consideration."

Speaker Giorgi: "The Gentleman have leave? The Bill's on Postponed Consideration. House Bills, Third Reading. House Bill 3392."

Clerk O'Brien: "House Bill 3392. A Bill for an Act making appropriation for certain claims against the State of Illinois in conformity with awards made by the Court of Claims. Third Reading



of the Bill."

Speaker Giorgi: "Representative Kozubowski on House Bill 339..."

Kozubowski: "Thank you very much, Mr. Speaker and Ladies and Gentlemen of the House. House Bill 3392 makes appropriations to the Court of Claims for awards during the period from November 9, 1977 through June 6, 1978. This period covers five hundred and fifty-seven awards for a total of two million, eight hundred thousand dollars. I would ask for a favorable Roll."

Speaker Giorgi: "Is there any discussion? No discussion, being no discussion, the question is, shall House Bill 3392 pass? All those in favor will vote by... vote... will signify by voting 'aye' and those opposed by voting 'no'. Have all voted who wish? Have all voted who wish? Take the record, Mr. Clerk. On this question there are 126 'ayes', 4 'nays', 4 voting 'present'. And this Bill having received the Constitutional Majority is hereby declared passed. On the Speaker's Table on page 9 appears House Resolution 27. Mr. Clerk, read House Resolution 27."

Clerk O'Brien: "House Resolution 27, Mudd."

Speaker Giorgi: "Representative Mudd on House Resolution 27."

Mudd: "Mr. Speaker, Members of the House, this particular Resolution was drafted. We already have a Committee who is doing some studies on the placement and treatment of criminals and what this Resolution does, it broadens the scope and allows them to participate in hearings specifically on work release programs. We have one particular area within my district who has had a significant amount of problems, this is Jubilee Work Release Program, and we would like to try to have a few hearings and resolve the differences between the Department of Corrections, the people in the area and also the Legislature in regards to these problems. And I would ask everyone for a favorable vote. This was amended in Committee to specifically direct attention to work release programs."

Speaker Giorgi: "Is there any discussion? There being no discussion, the question is on the adoption of the Resolution. All those in favor will signify by voting 'aye' and those opposed by voting 'no'. Takes 89 votes. Have all voted who wish? Representative



Mudd to explain his vote."

Mudd: "Yes, I think the thing that might help is that this will probably be referred to this Committee that it's already established so this isn't going to establish a new one or anything, just broaden the scope. I'd ask for your favorable vote."

Speaker Giorgi: "Have all voted who wish? Take the record, Mr. Clerk. On this question there are 95 'ayes', 31 'nays' and 11 voting 'present'. And this Resolution receiving the majority is hereby declared passed and adopted. Is Representative Schisler... Senate Bills, Second Reading. There are some Amendments that have been printed and we can proceed with some of the Bills. Representative Sandquist on Senate Bill 250. Out of the record."

Speaker Giorgi: "...Representative Pullen, on Senate Bill 252? Want to call it? Senate Bills, Second Reading, Senate Bill 252.Pullen."

Clerk O'Brien: "Senate Bill 252, a Bill for an Act to amend Sections of the Probate Act, Second Reading of the Bill. Amendment #1 was adopted in Committee."

Speaker Giorgi: "Any motions on the Committee Amendment?"

Clerk O'Brien: "No motions filed."

Speaker Giorgi: "Any Amendments from the floor?"

Clerk O'Brien: "Floor Amendment #2, Schlickman, amends Senate Bill 252, as amended, as follows: on page 13, by deleting line 3 through 5 and so forth. Schlickman's Amendment."

Speaker Giorgi: "Representative Schlickman in the chamber? Representative Pullen, would you want to hold this for Representative Schlickman or do you...Any further Amendments?"

Clerk O'Brien: "Floor Amendment #3, Willer, amends Senate Bill 252, on page 12, line 15, by deleting 11a-9, and so forth."

Speaker Giorgi: "Representative Willer, on Amendment #3. Senate Bill 252."

Willer: "Mr. Speaker, ..."

Speaker Giorgi: "Yes, Mrs. Willer..."

Willer: "...I'm sorry, there seems to be some confusion over who is... first of all sponsoring this Bill and as far as Senate Amendment #3, I have no knowledge of it. Staff has not brought it to me yet. Mr. Speaker..."

Speaker Giorgi: "I understand, ...I heard you, Mrs. Willer... I was going to ask the Sponsor...the records...the sponsor of records, Representative Pullen, how she'd like to proceed. Would you like to pull this out of the record? Representative Pullen?"

Pullen: "Mr. Speaker, why don't we advance it to Third Reading and if we have some problems that we need to bring it back, I'll do that."

Speaker Giorgi: "She agrees ...Return it to Third...so...Okay, Third Reading, with the understanding that if they've got an Amendment she'll honor their request. Third Reading. We'll continue on with Senate Bills, Second Reading. There was one House Bill, Third Reading that we failed to call and we'll call House Bill, Third Reading, 2580. House Bill 2580."



Clerk O'Brien: "House Bill 2580. A Bill for an Act making appropriation to the Department of Conservation. Third Reading of the Bill."

Speaker Giorgi: "Representative Schisler on House Bill 2580."

Schisler: "Mr. Speaker, Ladies and Gentlemen of the House, in the hopes that I might start a trend for this Session, I'd ask leave to table House Bill 2580."

Speaker Giorgi: "The Gentleman have leave? House Bill 2580 is tabled. Back to Senate Bills, Second Reading. Representative Terzich, are you ready with Senate Bill 554? Out of the record. Representative Yourell. Out of the record. Representative Capparelli. Out of the record. Representative Schuneman on Senate Bill 1512? Out of the record. I'm just following orders. Representative Schuneman, for what reason do you rise?"

Schuneman: "Mr. Speaker, I'm not sure how you're going to be getting back to these Bills. But on that last Bill of mine that you just read, we're waiting for an Amendment to come from the Legislative Reference Bureau and that's the reason we're passing. Just wanted that in the record."

Speaker Giorgi: "Representative Richmond. Senate Bill 1525? Out of the record. Representative Eugene Barnes. Out of the record. Representative Brady on Senate Bill 1530? Out of the record."

Speaker Giorgi: "Representative Kane on 1546. Kane. Senate Bill.
Representative Kane on Senate Bill 1546."

Clerk O'Brien: "Senate Bill 1546. A Bill for an Act to amend Sections
of an Act concerning public utilities. Second Reading of the Bill.
No Committee Amendments."

Speaker Giorgi: "Any Amendments from the floor?"

Clerk O'Brien: "Amendment #1 was withdrawn. Floor Amendment #2. Conti-
Levin...."

Speaker Giorgi: "Representative Kane."

Clerk O'Brien: "Amends Senate Bill 1546 on page 2 by deleting lines 1
and 2 and so forth."

Speaker Giorgi: "Representative Conti on the Amendment."

Conti: "Mr. Speaker and Ladies and Gentlemen of the House, I've asked
to introduce this Amendment and Doug Kane says that he wants to talk
with the Senate Sponsor, he finds no problem with it. You want me
to read the Amendment?"

Speaker Giorgi: "Explain the Amendment...."

Conti: "Amendment....Senate Bill 1546 is by deleting lines 1 and 2 and
inserting in lieu thereof the following: 'For natural gas service
shall be given to residential customers, to hospitals and to govern-
mental agencies performing'. And by inserting immediately after line
27 the following: 'As used in this Section, residential customers
means nursing homes, other long term care facilities, multifamily
dwellings and resident buildings of any kind where a majority of
residents live for a period of at least three consecutive months.
Hospital means an institution licensed under the Hospital Licensing
Act.' In other words it would not include veterinarian hospitals."

Speaker Giorgi: "Representative Walsh on the Amendment. W. Walsh on
the Amendment."

Walsh, Wm: "No. I know, Mr. Speaker, my light's been on for some time,
I'd like to be recognized after this is disposed of."

Speaker Giorgi: "Representative Johnson on the Amendment. Representa-
tive Johnson."

Johnson: "Representative Conti, what....you've read the Amendment. Can
you tell me what it does and how it changes the Bill? I'm not sure



I understood."

Conti: "It just includes the 300 therms for residential homes where there's....I haven't got the Bill in front of me, Tim. Doug, would you want to...have you got the Bill?"

Speaker Giorgi: "Representative Kane."

Kane: "Representative Johnson, what this does...what the effect of the Amendment does is to specify or limit the preferential treatment to natural gas service rather than to electric and natural gas and what it does is give to preference to residential customers, hospitals and governmental agencies performing law enforcement function. And then it includes a definition of residential customer and also hospitals."

Speaker Giorgi: "Representative Johnson."

Johnson: "Right. I understand and I support the Amendment. Thank you."

Speaker Giorgi: "Any further discussion? Representative Conti to close or.... The question is on the motion to adopt the Amendment #2 to Senate Bill 1546. All in favor will signify by saying 'aye' and opposed 'nay'. The 'ayes' have it, the Amendment's adopted. Any further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker Giorgi: "Third Reading. Senate Bill 1525, Mr. Richmond is ready on that. Senate Bill 1525. It's the first Bill."

Clerk O'Brien: "Senate Bill 1525. A Bill for an Act... A Bill for an Act to provide for the ordinary and contingent expense of Southern Illinois University. Second Reading of the Bill. No Committee Amendments."

Speaker Giorgi: "Any Amendments from the floor?"

Clerk O'Brien: "Floor Amendment #1, Deavers. Amends Senate Bill 1525 on page 2 by inserting between line 19 and 20 the following: Section 5."

Speaker Giorgi: "Representative Deavers on Amendment #1 to Senate Bill 1525."

Deavers: "Would you have the Clerk read the Amendment please?"

Speaker Giorgi: "Read the Amendment, Mr. Clerk."

Clerk O'Brien: "Section 5. No Members of the American Association of University Professors as of May 1, 1978 shall receive a salary



increase for fiscal year 1979."

Speaker Giorgi: "Representative Deavers, will you continue?"

Deavers: "Mr. Speaker, I move for the adoption of this Amendment. I think it's offered in the same good faith as the letter was written to all the Members."

Speaker Giorgi: "Any further discussion? Representative Vinson, are you requesting the floor? Representative Vinson on the Amendment."

Vinson: "Mr. Speaker, I would urge the defeat of the Amendment. What the Amendment does is to use government money to punish people for their political beliefs. While I oppose the ERA and intend to continue voting against it, I don't think we should use the government to punish people for their political beliefs."

Speaker Madigan: "Mr. Stuffle."

Stuffle: "Yes, Mr. Speaker and Members, I as Representative Vinson arise in opposition to this Amendment. But in so doing to say a few words about the American Association of University Professors. I think their political outlook may not be the only problem that we have in dealing with them because they rose in the Senate in sending a letter of reprimand around to the Members of that Body attacking and accusing the Democratic candidate for Governor and attacking and accusing, too, legitimate labor organizations of attempting to cut the budget for salaries in the university systems. If anyone deserves to have their salaries cut for their political beliefs and for their lack of effort and their lack of candor and their lack of honesty, it's the AAUP. They've attacked this party and they've attacked legitimate organizations in so doing. I oppose the Amendment; regrettably oppose it for the reason cited. I should support it, but I say this in opposition to it. It may be impossible to break out the money in reducing the budget to limit any salary cut to only AAUP Members. It's too back we can't, but because we can't I feel we should oppose the Amendment despite the great need to do something with these people."

Speaker Madigan: "Mr. Friedrich."

Friedrich: "Mr. Speaker, I got the impression that this group wanted to dry up business out of Illinois and thereby reduce state revenues



from which we pay their salaries. I don't understand why they would object to reducing their salaries if they want to drive business out and reduce revenue. You can't have it both ways."

Speaker Madigan: "Mr. Terzich."

Terzich: "Well, yes, Mr. Speaker, I also received a letter. It's a Mr. Scott Eatherley whoever he is, if he feels that the salary that we pay him from taxpayers money should not be spent in Illinois then I don't see why the taxpayers in Illinois should sponsor any pay raises for these people. That these university professors, we have enough shotguns put to our heads on ERA; we don't need state workers, we don't need professors or university people telling the Legislature what they can do or can't do on ERA. They're the ones who took the initiative in sending that letter and they stipulated that they would not hold any conferences in Illinois with Illinois taxpayers' money as long as the Illinois Legislature did not pass the ERA Amendment. Well, I got news for them. If they can't spend their money, I don't think that we should support their efforts for pay raises. At the present time, they are probably one of the highest paid, over paid professors in the state educational system and let's give it to the working people of the state by giving the lower people some higher increases rather than eight percent." They're asking for raises of approximately fifteen hundred to two thousand dollars when the poor secretaries are only getting a pay raise of less than a thousand dollars. So let's put it where it's needed. Let's put it back in the State of Illinois and not into the hands of the Members of the AAUP. And I would urge support of this adoption of this Amendment."

Speaker Madigan: "Mr. Deavers."

Deavers: "To close on the Amendment, let me say one thing."

Speaker Madigan: "Oh, Mr. Deavers, I'm sorry. I just returned to the Chair. You're the Sponsor of the Amendment?"

Deavers: "Sponsor of the Amendment."

Speaker Madigan: "Well then, Mr. Johnson, in debate."

Johnson: "Thank you, Mr. Speaker and Members of the House. Like Representative Vinson and others, I voted negatively on the question of the Equal Rights Amendment in the past. But I also believe



that people in this state whether they're professors or others have a right to free speech and they have a right to express their opinions on matters of public interest. Whether it's by a boycott or otherwise. And I don't think the Legislature has a right to penalize that right to free speech by withholding funds. And I think in addition to that, SIU and the University of Illinois and others that would be affected by these Amendments are ones that are slowly falling behind comparable institutions and other schools in the Midwest and around the country in the quality of higher education. And that's tied in directly in my mind to the level of faculty salaries. Think we've got a long ways to go in making up lost ground with respect to the funding of our educational institutions of higher education in the Illinois. And I think to penalize them, to cut faculty pay hikes here would hurt the quality of higher education around the state. And so while the Sponsors of this and other Amendments, I'm sure, are well intended, I would ask the Members of this Legislature in the House here to vote 'no' on all these Amendments to cut faculty pay hikes."

Speaker Madigan: "Mr. Richmond."

Richmond: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. As Sponsor of the Bill, I rise to oppose the Amendment. I'm sorry that this issue has been interjected into the issue of pay raises for those who have fallen considerably behind in the prices that have... they've been paying as the result of spiralling inflation. And I'm not just talking about members of the AAUP. It's unfortunate that some of those, some members of that organization chose to put their names on a letter which I disagree with very much myself although I did support the Equal Rights Amendment. I don't care for that type of tactic, but I think that this Amendment should be defeated and furnish this pay raise to these people that has... the need is being recognized by the Board of Higher Education and also the Governor in his budget request."

Speaker Madigan: "Mr. Bluthardt."

Bluthardt: "Yes, Mr. Speaker, Members of the House, I think we're losing sight of one thing. We can talk about freedom of speech and all that, but we're talking, I think, about per diem



allowances, travel allowances, allowances to attend conferences that are paid for by the taxpayer of Illinois. And I think there's a difference. If they can say to us, unless we support ERA they're not going to hold any conferences in Illinois and spend the money that they receive out of the State of Illinois from the taxpayers, then I think we should say, well then you're not going to get any more money. Too bad. I think it's a good Amendment and we ought to vote for it."

Speaker Madigan: "Mr. Madison."

Madison: "Yes, Mr. Speaker, first of all I would like to ask the Chair to rule that... to the germaneness of this Amendment."

Speaker Madigan: "Mr. Madison, did you pose a question to the Chair?"

Madison: "Yes, I did."

Speaker Madigan: "Would the Parliamentarian come to the podium?"

Mr. Epstein. Mr. Epstein, the Parliamentarian. There's a question on germaneness, Mr. Epstein. For what purpose does Mrs. Satterthwaite arise?"

Satterthwaite: "Mr. Speaker, while the Parliamentarian is deciding on that question there are a couple of things that have been said on the House floor that I think need to be set straight. I have before me a letter from the American Association of University Professors at the University of Illinois and although this is not the University of Illinois Appropriation Bill I think the statement in that letter is pertinent to this Bill as well. It says, 'In reference to that letter that was referred to in discussion earlier, neither the Illinois Conference AAUP nor the Urbana-Champaign AAUP has endorsed boycotts in support of ERA and Mr. Eatherley had no license at all to write to you as he did. I apologize to you and to Mr... for Mr. Eatherley's ill-judged letter.' And I think this puts the record straight that the Illinois Conference of the AAUP had no part in the letter that was circulated to the Members of the House. However, I think in fairness to the members of the AAUP we should also set the record straight in indicating that the AAUP is not a tax-supported body. It is a private membership organization paid for by the members themselves. It in no way expends tax dollars in any of their



conventions or their other meetings. It would be ill-advised it seems to me for us as a deliberative governmental Body to take some kind of recriminatory action against a certain segment of our employees even though they have indicated in this fashion that they were not a part of that decision. I suggest that this Amendment is perhaps well intentioned, but not indeed a message that ought to go out to the State of Illinois that we are going to reprimand people for political action they may choose to make."

Speaker Madigan: "Ladies and Gentlemen, the ruling of the Chair is that we are dealing with an Appropriation Bill in this instance. Also, the authority to set salaries for university professors and other employees of the university system has been delegated by statute to the respective Board of Trustees. This Amendment would act as a restriction upon that authority which has already been delegated by statutes and, therefore, this Amendment is out of order as an Amendment to an Appropriation Bill. Are there any further Amendments? Mr. Deavers."

Deavers: "Parliamentary inquiry. Do I have the right to ask for a vote to override the Chair?"

Speaker Madigan: "You do."

Deavers: "I so move."

Speaker Madigan: "The Gentleman moves to overrule the Chair. All those in favor of the Gentleman's motion to overrule the Chair shall vote 'aye', all those... all those in favor of sustaining the Chair shall vote 'no'. Mr. Madison to explain his vote."

Madison: "Mr. Speaker, I would ask the Members of the House to consider the fact in your vote that it has been the practice and tradition of this House not to, in effect, put substantive language into an Appropriation Bill. I believe that this Amendment, its nature addresses substantive language to an Appropriation Bill and, therefore, is very much improper and should not cloud the... the proponent of this Amendment while his position may be laudible, it is, in fact, not the kind of thing to be attached to Appropriation Bills and we should very definitely sustain the Chair. Thank you."

Speaker Madigan: "Mr. Bradley to explain his vote."



Bradley: "To explain my vote and also to clarify something, Mr.

Speaker, On the exact same type of Amendment some two or three terms ago by Representative Hall to the same Appropriation Bill, we deleted one specific amount of money that was going to a teacher's salary exactly as Representative Deavers was attempting to do and that was ruled germane and it was passed and the dollar amount in that... for that... in fact, it was for the Board of Regents Bill. There was some eighteen thousand dollars reduced. The total amount of appropriation was reduced by eighteen thousand dollars. I'm voting to support the Chair, but I'm not... In my opinion, what we should be voting on sometimes is whether we want to sustain the Parliamentarian and not the Chair because the Chair has to take the ruling of the Parliamentarian, but we're not always consistent it appears to me. And the ruling, I know one Session doesn't... we don't have to do in one Session what we did in the other. But just exactly what Representative Deavers is attempting to do here was done, was successful with the Board of Regents Bill on one specific amount for a particular teacher. But I am still going to support the Chair. However, if I had a chance to support the Parliamentarian, it might be a different matter."

Speake Madigan: "Mr. Barnes to explain his vote."

E.M. Barnes: "Thank you very much. Well, Mr. Speaker and Members of the House, not only to support the Chair in this motion, but also to support the interpretation of the Parliamentarian. We tried and attempted to do this in one Session. This went all the way to the Supreme Court. The Supreme Court indicated to us in the appropriation process that we were wrong. The Parliamentarian ruled properly in this instance for we have attempted in previous Sessions to accomplish this very fact by this method and our Supreme Court here in Illinois said that this was not a proper manner, we could not do this, we can only reduce the amounts. We could not have substantive language therein. So our Parliamentarian ruled correctly, the Chair ruled correctly and we should support the Chair."

Speaker Madigan: "Have all voted who wished? The Clerk shall take



the record. On this question there are 50 'ayes', 95 'noes', 3 voting 'present'. And the motion to overrule the Chair fails.

Are there further Amendments?"

Clerk O'Brien: "Floor Amendment #2, Deavers. Amends Senate Bill 1525 on page 1, line 7 and so forth."

Speaker Madigan: "Mr. Deavers."

Deavers: "Mr. Speaker and Ladies and Gentlemen of the House, I move to table this Amendment. Representative Richmond and I worked out an agreement."

Speaker Madigan: "Is there leave? Leave is granted to table Amendment #2. Are there further Amendments?"

Clerk O'Brien: "Floor Amendment #3, Terzich-Hanahan. Amends Senate Bill 1525 on page 1, line 11 and so forth."

Speaker Madigan: "Who is the Sponsor of the Amendment? Mr. Terzich."

Terzich: "Yes, Mr. Speaker, this again will deal with the same situation. This will amend the... the Bill by... it deletes the eight percent salary increase from the General Revenue personal service line by a total of three million, four hundred and twenty-one thousand, two hundred dollars which represents that eight percent salary increase for university professors. Unfortunately, I would have withdrawn this Bill had Representative Deavers Amendment #1 been adopted. Since this does cover all of the university professors including those who are members of the AA... or not members of the AAUP. Unfortunately, it will be guilty by association with this Amendment and I won't go through all of the wording so... I'm sorry, Mr. Speaker. I have been notified that there is a technical error in Amendment #3 so I would move to withdraw Amendment #3 and move to Amendment #4."

Speaker Madigan: "The Gentleman requests leave to withdraw Amendment #3. Leave is granted."

Clerk O'Brien: "Floor Amendment #4, Terzich-Hanahan. Amends Senate Bill 1525 on page 1, line 11 and so forth."

Terzich: "And again, Mr. Speaker, it's the same Bill. This is in the correct form and again deletes from the appropriation the eight percent salary adjustment for university professors amounting to three million, four hundred and twenty-one thousand, two



hundred dollars and I would appreciate support of adoption of Amendment #4."

Speaker Madigan: "Mr. Richmond."

Richmond: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. As Sponsor of Senate Bill 1525, I rise to oppose this Amendment for the same, some of the same reasons as previously stated concerning Amendment #1. It... I think that the impetus behind this effort all comes from a letter that was unfortunately, as stated earlier was written which... and I don't think it should have been. However, if we move with this eight percent there, the deletion of this eight percent increase for all of the employees, I want to emphasize, this would remove the increase to all the employees, those who are on the bottom end of the pay scale and who so badly need it. I do have... I intended to discuss on Third Reading the formula which has been proposed for the distribution of this eight percent increase. It will not be across the board increase and those on the lower end of the pay scale will be the recipients of a larger increase as I understand it than those that are making the higher salary. So I would urge defeat of this Amendment."

Speaker Madigan: "Mr. Barnes."

E.M. Barnes: "Yes, Mr. Speaker and Members of the House, I can understand and even sympathize with the Sponsor of this Amendment. But as a matter of fact, it is just something that we here in the General Assembly cannot carry out to its fruition. Fact of life is if you reduce this appropriation, we will simply be... will be reducing the capabilities of these various institutions to carry out their contractual agreement under the collective bargaining procedure. These percentages that are built into these appropriations are built into these appropriations based on various procedures that have been worked out with collective bargaining through, for various... various unions and agencies that represent these institutions of higher education. And if we reduce the dollar amount in these appropriations, I'm not certain what kind of situation we will be getting the universities and the state itself into by cutting out the money that would, in fact,



carry out a basic firm contractual agreement with the unions and representatives of these individuals. I know there's well intent here and I can sympathize with some of the intent, but the practicality of it, it's just not workable and it's not something that we here in the General Assembly, I think, would like to get into because not only are we talking about the high-paid individual instructors but we are also talking about all the other allied workers in these various institutions. And for those reasons, I would rise to oppose this Amendment."

Speaker Madigan: "Mr. Vinson."

Vinson: "Mr. Speaker, Ladies and Gentlemen of the House, a distinguished American Leader has said that that government which is big enough to give you everything you want, can take away everything you have. This is an example of that big government trying to take away people's constitutional rights again to punish them for their political beliefs and I urge the defeat of the Amendment."

Speaker Madigan: "Is there any further discussion? Is there any further discussion? The question is, shall Amendment #4 be adopted? All those in favor signify by voting 'aye', all those opposed by voting 'no'. Have all voted who wished? The Clerk shall take the record. On this question there are 20 'ayes', 93 'noes', 1 voting 'present'. Amendment #4 fails. Are there further Amendments?"

Clerk O'Brien: "Floor Amendment #5, Terzich. Amends Senate Bill 1525 as amended by deleting all of Section 1 and so forth."

Speaker Madigan: "Mr. Terzich on Amendment #5."

Terzich: "Yes, Mr. Speaker, it's unfortunate that the university professors have not heard from the General Assembly on this issue and, therefore, I would move to table Amendment #5. Withdraw Amendment #5."

Speaker Madigan: "The Gentleman requests leave to withdraw Amendment #5. Leave is granted. Are there further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker Madigan: "Third Reading. Senate Bill 1526. Mr. Barnes."

Clerk O'Brien: "Senate Bill 1526. A Bill for an Act making



appropriation to the Board of Governors for State Colleges and Universities. Second Reading of the Bill. No Committee Amendments."

Speaker Madigan: "Are there any motions? No Committee Amendments? Are there any Floor Amendments?"

Clerk O'Brien: "Floor Amendment #1, Deavers. Amends Senate Bill..."

Speaker Madigan: "Mr. Deavers."

Deavers: "Mr. Speaker, this is the same Amendment that you ruled was not germane. I'd like to make an inquiry of the Chair. Being's my running mate from McLean County in the 44th District opposed me on that other Amendment, I'd like to know how I can get Representative Lauer back."

Speaker Madigan: "Mr. Deavers, did you address a question to the Chair?"

Deavers: "Yes, I'd like to know what procedure I go through to get Representative Lauer back to replace Representative Vinson."

Speaker Madigan: "Do you wish to address yourself to the Amendment?"

Deavers: "It's not germane you ruled before. Would you like to kill it?"

Speaker Madigan: "The Gentleman requests leave to withdraw Amendment #1. Leave is granted. The Amendment is withdrawn. Are there further Amendments?"

Clerk O'Brien: "Floor Amendment #2, Deavers. Amends Senate Bill 1526 on page 1, line 7 by inserting immediately after the comma, the following and so forth."

Speaker Madigan: "Mr. Deavers."

Deavers: "This Amendment is a very good Amendment. This mandates a cost of living increase of six percent for the faculty and then allows the other two percent to be spent for merit. And the civil service nonacademic personnel, it allows eight percent cost of living and two percent merit raise and I move for the adoption."

Speaker Madigan: "Mr. Stuffle."

Stuffle: "Yes, would the Sponsor yield?"

Speaker Madigan: "Sponsor indicates that he will yield."

Stuffle: "Representative Deavers, then is the intent of this Amendment to do away with the collective bargaining process and the



Board of Governors system which has already recognized it by putting a limitation on a specific limitation as to the amount of the salary increases to be provided in a percentage to each of the types of employees in the system?"

Deavers: "It's across the board six percent cost of living, one time; we're not trying to change. It only applies to this year, this fiscal year appropriation. And as you know, I've never been a proponent of collective bargaining."

Stuffle: "To the Bill, Mr. Speaker, if you would. I would rise in opposition to this Bill. In the Board of Governors system, collective bargaining rights have been granted by that system to the employees. Both sides, labor and management, have worked hard to work out their differences. They have worked hard to come to agreement with regard to the amount of money appropriated each year and to do so legitimately across the bargaining table. This Amendment to this Bill would hamstring; in effect, eliminate any attempt or any ability of the two sides to sit down across the bargaining table and negotiate an agreement based upon the appropriations of this General Assembly. Also, Mr. Speaker, I would ask you at this time whether or not this Amendment is germane to the Bill using the same argument that you made as to germaneness on the previous Amendment."

Speaker Madigan: "Would the Parliamentarian, Mr. Epstein, come to the podium? Mr. Stuffle, would you please restate your question?"

Stuffle: "Yes, Mr. Speaker, due to the fact that this Amendment places substantive language in the Bill and I believe flies in the face of your ruling with regard to the limitations on the various systems in the General Assembly and the appropriations process, I feel that this Amendment is not germane to the Bill before us now and would ask you to so rule."

Speaker Madigan: "The Chair rules that the Amendment is not germane for the reasons previously enunciated. Further Amendments?"

Clerk O'Brien: "Floor Amendment #3, McGrew-Edgar-Stuffle. Amends Senate Bill 1526 as amended on page 1, line 12 and so forth."

Speaker Madigan: "Who's the Sponsor of the Amendment? Mr. McGrew."

McGrew: "Thank you very much, Mr. Speaker and Ladies and Gentlemen



of the House. Amendment #3 to House or Senate Bill 1526 adds to the amount of three hundred and sixty-two thousand, four hundred dollars. It would make the expenditure the same as it was introduced, recommended by the Illinois Board of Higher Education, eight percent salary increase and I move for its adoption."

Speaker Madigan: "Is there any discussion? Mr. Barnes."

E.M. Barnes: "Thank you very much. Well, Mr. Speaker and Members of the House, one question to the Sponsor if he would yield."

Speaker Madigan: "The Sponsor indicates he will yield."

E.M. Barnes: "Now as I understand the formula that you've got set out is based on the appropriation of the fiscal year 1978. Is that correct?"

McGrew: "That is correct."

E.M. Barnes: "Not on the expenditure?"

McGrew: "That is correct. What we've done is..."

E.M. Barnes: "How much is the difference between the two?"

McGrew: "The difference is three hundred and sixty-two thousand dollars. It would be ninety-three thousand for Chicago State, hundred and nine for Eastern, hundred and twenty-nine thousand for Western, thirty-three thousand for Governor's State."

E.M. Barnes: "Well, Mr. Speaker and Members of the House, as much as I would like to support this Amendment and as much as I would like to support my fellow Committee Member, I rise to oppose this Amendment. This is three hundred and sixty-two thousand above the amount that was acted on in both Committees, both in the Committee in the House and in the Committee in the Senate. This is over and beyond the approximately, I believe about seven... seven percent, between seven and eight percent that's built into the Bill. I believe it's seven and a quarter percent that's built in the Bill currently for increases for salaries. I believe that in working out this formula with the Board of Governors and with the Board of Higher Education, that they was in agreement with the amount that was built into the formula both in the Senate that we... we reaffirmed in the House and that this additional amount which is very attractive especially to one of their universities in my district, but I would still rise to oppose this Amendment



for you're talking about additional three hundred and sixty-two thousands of dollars of general revenue that is not in the budget that is not... has not received the okay of the Board of Higher Education, and to the best of my knowledge, has not been requested by the system for this current fiscal year. So on those bases, I would urge all the Members not to support this Amendment and keep this Bill at the level which has been worked out and agreed upon by both Houses, both Appropriations Committees of both Houses of this legislative Body."

Speaker Madigan: "Is there any further discussion? There being no further discussion, Mr. McGrew, to close the debate."

McGrew: "Thank you very much, Mr. Speaker. Basically once again, what this does is to make the salary increase eight percent for all university employees. It would be eight percent of last year's budget item and I move for its adoption."

Speaker Madigan: "The question is, shall Amendment #3 be adopted? All those in favor signify by voting 'aye', all those opposed by voting 'no'. For what purpose does Mr. Totten arise?"

Totten: "For point of clarification, Mr. Speaker. Is an 'aye' vote to cut money out of this budget?"

Speaker Madigan: "Mr. Barnes, do you wish to respond to that question?"

E.M. Barnes: "An 'aye' vote would be to add three hundred and sixty-two thousand to it."

Totten: "Thank you."

Speaker Madigan: "Have all voted who wished? The Clerk shall take the record. On this question there are 21 'ayes', 88 'noes', 2 voting 'present' and the Amendment fails. Are there further Amendments?"

Clerk Hall: "Amendment #4, Terzich-Hanahan. Amends Senate Bill 1526 on page 1 and so forth."

Speaker Madigan: "Mr. Terzich."

Terzich: "Amendment #4 is defective and I move to withdraw Amendment #4."

Speaker Madigan: "Mr. Terzich."

Terzich: "Withdraw Amendment #4."



Speaker Madigan: "The Gentleman withdraws Amendment #4. Are there further Amendments?"

Clerk O'Brien: "Floor Amendment #5, Terzich. Amends Senate Bill..."

Speaker Madigan: "Mr. Terzich:"

Terzich: "Amendment #5 again, Mr. Speaker, would reduce the appropriation by eight percent for faculty members. It reduces a total of three million, sixty-nine thousand, seven hundred dollars. I notice that the other Amendment was ineffective and again it's a sad day that the university professors can tell the General Assembly what they can do but the General Assembly can't tell them what they can do. And therefore, I would withdraw Amendment #5."

Speaker Madigan: "Is there any discussion? The Gentleman requests leave to withdraw Amendment #5. Leave is granted. The Amendment is withdrawn. Are there any further Amendments?"

Clerk O'Brien: "Floor Amendment #6, McGrew. Amends Senate Bill 1526..."

Speaker Madigan: "Mr. McGrew."

McGrew: "Leave to withdraw the Amendment."

Speaker Madigan: "The Amendment is withdrawn. Are there further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker Madigan: "Third Reading. On the Order of Senate Bills, Third Reading, Senate Bill 1532, Mr. Peters."

Clerk O'Brien: "Senate Bill 1532. A Bill for an Act making appropriation to the State Treasurer. Third Reading of the Bill."

Peters: "Mr. Speaker, Ladies and Gentlemen of the House, Senate Bill 1532 is for the ordinary and contingent expenses of the Office of the State Treasurer. There... the only increase in the Bill is an increase of twenty-eight million dollars for debt service. There is no increase for operating costs over the budget of FY78. The Bill did come out of the Appropriations I Committee on a 27 to 0 vote. I respectfully request your approval of this appropriation."

Speaker Madigan: "The question is, shall this Bill pass? All those in favor signify by voting 'aye', all those opposed by voting 'no'. Have all voted who wished? Have all voted who wished? Have all voted who wished? The Clerk shall take the record. On this

Those Members of the Committee in favor of the adoption of the Amendment will meet in Room 400 at five p.m. Senator Maragos is the Chairman. Those Members in opposition to the adoption of the Amendment will meet in Room A1 at five p.m. Senator Guidice is the Chairman. And now moving to the more important Amendments to be considered by the people, H.J.R.C.A. 29 which deals with the exemption from taxation for veteran's posts. Those in favor of that Amendment will meet in Room 122 at five o'clock under the Leadership of Representative DiPrima. And those against the adoption of the Amendment will meet in Room 114. Representative Jaffe is the Chairman of that group. And the Chair recognizes Representative Giorgi on the Agreed Resolutions. Mr. Giorgi."

Giorgi: "Did you take 988 out, Mr. Clerk?"

Clerk O'Brien: "988 is withdrawn."

Giorgi: "Mr. Hoxsey's House Resolution 981 talks about and Eagle Scout Progress Award for Scout Jackson Williams. Mahar's 982 talks about seven young ladies receiving a First Class Scout Award. 983 by Sharp recognizes a 90th birthday. Anderson's 984 tells about the 125th anniversary of Tomica, Illinois. 985 by Kelly spreads on the record that Joseph J. Smaron spent 17 years as Mayor of Posen, Illinois. 986 by Ryan recognizes the plight of retired teachers. 987 by Leverenz talks about the Naples' Vegetable Stand on North Avenue in Melrose Park. 989 by



Pechous mentions the Illinois Register of Historical Places. 990 by Pechous notes the 28th anniversary of the Mentally Retarded Children's Aid of Seguin School, Berwyn, Illinois. 999 by Geo-Karis honors the Illinois, the High School Association for AA Champs. And I move for the adoption of the Agreed Resolutions."

Speaker Madigan: "Mr. Giorgi moves for the adoption of the Agreed Resolutions. All those in favor signify by saying 'aye', all those opposed by saying 'no'. In the opinion of the Chair, the 'ayes' have it, the Resolutions are adopted. Introduction and First Reading."

Clerk O'Brien: "House Bill 3412, Polk. A Bill for an Act to amend Sections of the Illinois Pension Code. First Reading of the Bill."

Speaker Madigan: "Committee on Rules." For what purpose does Mr. Mudd arise?"

Mudd: "Mr. Speaker, I would like to have leave for the appropriate rule, to suspend the appropriate rule for posting so that a couple of House Resolutions may be heard in Executive Committee on Wednesday afternoon after we adjourn. House Resolution 974 and House Resolution 986. And I would like leave of the House to suspend the appropriate rule so these two Resolutions may be posted for this Wednesday afternoon."

Speaker Madigan: "Mr. Mudd, could you tell us the Sponsor of those Resolutions?"
