The failure of local governmental officials to consider the revenue production of the Corporate Personal Property Replacement Package will result in a substantial increase in real estate taxes. This increase necessitates prompt action by the General Assembly on Senate Bill 1292 before the appropriate local officials prepare the 1980 Real Estate Tax Bills. Any further delay in consideration of Senate Bill 1292 will render ineffectively its provisions Therefore pursuant to Article 4. Section 5B of the Constitution of 1970, I hereby call and convene the 81st General Assembly in a Special Session to convene on January 12, 1980 at ten a.m. in order to consider Senate
