Speaker Redmond: "The House will come to order. Members please be in their seats. How was everything at the Itasca Country Club? I intended to go but I couldn't make it. Be led in prayer by the Reverend Krueger, the House Chaplain."

Krueger: "In the Name of the Father, the Son and the Holy Ghost. Amen. O Lord, bless this House to Thy service this day. Amen. Let us remember in our prayers this day Margaret, who is deceased, the wife of Representative Leon. Rest eternal grant from O Lord and let light perpetual shine upon them. The righteous shall be had in everlasting remembrance: he will not be afraid of any evil doings. O God, whose mercies cannot be numbered; accept our prayers on behalf of the soul of Thy servant, Margaret departed, and grant her an entrance into the land of light and joy, in the fellowship of Thy saints, through Jesus Christ our Lord. Speaker Redmond: "Are there any Republican absences that are being excused, Mr. Ryan? Mr. Ryan has left the floor. Representative Madigan, are there any Democrats whose absences should be excused?"

Madigan: "Mr. Speaker, I have some."

Speaker Redmond: "Representative Ryan has returned."

Ryan: "The Speaker is returned. Representatives Campbell and Representatives Epton is to be excused for illness, Mr.



Speaker."

Speaker Redmond: "Are there any objections? Hearing none, the record will so show. Representative Madigan. Representative Madigan, are there any Democrats..."

Madigan: "Mr. Speaker, would the record show that the following Representatives are excused; Representative Nardulli, Domico, Kozubowski, Capparelli, Leon and Vitek."

Speaker Redmond: "Any objections in showing... Representative Walsh."

Walsh: "Will the Gentleman tell us why he is asking these people be excused?"

Speaker Redmond: "Representative Madigan."

Madigan: "These requests were transmitted to my office, Mr. Speaker. I am now transmitting them to the Body. I think it's a normal courtesy which is offered to every Member of the Body."

Walsh: "Mr. Speaker, if I may respond that? It is not a normal courtesy. The people may be excused for illness, death in the family or absent because of House business. Those are the only reasons that anyone may be excused. Now if none of these apply then these Gentlemen may not be excused."

Speaker Redmond: "Representative Lechowicz."

Lechowicz: "Well, Mr. Speaker, if the Gentleman listened yesterday, these people were excused except for Representative Vitek, who took ill this morning. It was here yesterday..."

Walsh: "Representative Vitek is..."

Lechowicz: "Representative Leon is excused because of the death of his wife, which was in the record yesterday... Vitek because of illness today, who was here yesterday, and the other Gentlemen were excused yesterday as well."

Speaker Redmond: "Representative Walsh. Walsh."

Walsh: "I have no objection, of course, for Representative Leon and Representative Vitek. I'm talking about the other Gentlemen. And the fact that they were excused



yesterday has nothing to do with it. I want to know why they're being excused today and if it's not for any of the reasons I've given, then I object to them being excused."

Speaker Redmond: "Representative Madigan."

Madigan: "Mr. Speaker, I'll simply reiterate my previous comment. These requests have been transmitted to my office. I have now transmitted them to the Body. I feel that this is a normal courtesy. If the Gentleman wishes to have his objection noted on the record, then so be it."

Speaker Redmond: "Representative Walsh."

Walsh: "I go further than that, Mr. Speaker. I object to them being shown in the Journal as excused. If they do not...if their reasons for being excused do not fit one of those three categories."

Speaker Redmond: "Representative Madigan has requested that Representative Kozubowski...Taylor was it? What were the names of the...Capparelli..."

Madigan: "Domico."

Speaker Redmond: "...that their absences be excused..."

Madigan: "Kozubowski."

Speaker Redmond: "Representative Walsh has objected. It would seem...it would seem to me that Representative Madigan should ask for a Roll Call whether or not the House grants leave that these absences of these Gentlemen be excused. Representative Walsh."

Walsh: "Would you delay that while my Parliamentarian looks up the Rule for me?"

Speaker Redmond: "Rule 57. Representative Friedrich."

Friedrich: "Mr. Speaker, we certainly all understand that Representative Leon has an excusable absence. He's had the loss of his wife and I hope certainly that isn't in question here."

Speaker Redmond: "No, I understand that Vitek and Leon that



there's no objection to them. Representative Walsh, are you also objecting to Representative Epton's absence being shown as excused?"

Walsh: "No, I'm not, Mr. Speaker."

Speaker Redmond: "O.K."

Walsh: "Representative Epton is ill." Now what does the Parliamentary rule...the vote must be to suspend Rule 57, Mr. Speaker. That's in fact what we're doing..."

Speaker Redmond: "Rule 57 says that the House may grant leave to...that anybody's absence can be excused."

Walsh: "Rule 57 says that no Member may be absent from a Session of the House unless he has leave, is sick or his absence is unavoidable."

Speaker Redmond: "That's right. That's right. And the motion...the motion..."

Walsh: "We then are going to vote on whether or not we should give leave to some people to go home and work in the precincts. Is that what we're voting on, Mr. Speaker?"

Speaker Redmond: "No, the question is whether or not the House is going to grant leave that their absences be shown as excused."

Walsh: "All right, before we vote on this, I think it reasonable that Representative Madigan tell us why Representatives Kozubowski, Nardulli and the others are being...are being asked to be given leave."

Speaker Redmond: "Representative Madigan. Madigan."

Madigan: "Mr. Speaker, I have already explained to the Body the background to these requests. I have no further information to offer other than to report to the House that today in the House Cities and Villages Committee Mr. Walsh offered a Bill before that Committee which failed on a Roll Call of 11 to nothing. So I think that he feels a little strained."

Speaker Redmond: "Representative Giorgi."

Giorgi: "Mr. Speaker, Rule 57 is pretty plain in the last line



when it says; 'unless he has leave, is sick or his absence is unavoidable'. I don't think Mr. Walsh or this House can determine that their absence is unavoidable and I think it's up to them...Members themselves to explain their unavoidableness. And I think this is out of order."

Speaker Redmond: "Well, Representative Madigan has asked leave and Representative Walsh has objected. It seems to me that the Body has to make that determination. If Representative Madigan persists and places a motion that leave be granted. Now is there such a motion? In the absence of such a motion, it would appear to me that the House is not granting leave. Representative Madigan."

Madigan: "Mr. Speaker, I so move that the previously enumerated names be recorded in the Journal as excused."

Speaker Redmond: "Representative Matijevich."

Matijevich: "Mr. Speaker, there's really no issue before the House. Representative Walsh has not allowed them to have leave. Therefore, the guy's absent and he does not have leave so there's nothing...you can't now suspend the Rule and say he has leave because he hasn't got leave. So all we've got left is that a man has an unavoidable absent, that's all."

Speaker Redmond: "Parliamentarian advises me that the Rule says that the House grant leave and he says that a simple majority is required to have a motion carry that particular question. Representative...report the question. Representative Walsh."

Walsh: "Mr. Speaker, I ask for a division of that question. I am not objecting to Representative Vitek or Representative Leon to be given leave."

Speaker Redmond: "That's right, their not included anymore."

Walsh: "So I ask that the Gentleman give the names of those persons who he is asking leave for, except for Representative Leon and Representative Vitek."



Speaker Redmond: "It...my understanding is that leave was granted Representative Leon and Representative Vitek. There was no objection to that. Now the objection was raised to the other Gentlemen. Who are...what are the names of the Gentlemen, Representative Madigan? Representative Friedrich."

Friedrich: "You said a simple majority, we're suspending the Rules you mean..."

Speaker Redmond: "We're not suspending the Rules. He advises...he advises me that pursuant to the Rule, the simple majority is required."

Friedrich: "I think you're suspending the Rule, Sir, to give leave. It takes 89 votes."

Speaker Redmond: "That's...question. The Rule says we can grant leave by majority vote, 57. Yeah...motion is to grant leave."

Collins: "Mr. Speaker."

Speaker Redmond: "Representative Collins."

Collins: "Mr. Speaker."

Speaker Redmond: "Collins. Turn Collins on."

Collins: "Mr. Speaker, it seems to me that the Rule is quite simple. It says unless he has leave, is sick or his absence is unavoidable. So, I would think that the only way you can get away from that is to suspend the Rule and that would take 89 votes."

Speaker Redmond: "Parliamentarian, whose advice I have always followed, advises me that we can grant leave with the simple majority."

Collins: "Well, Mr. Speaker, the Parliamentarian..."

Speaker Redmond: "Representative Madigan. Representative Madigan."

Madigan: "Mr. Speaker, I simply ask what I consider to be a normal courtesy of the House, if Mr. Walsh wishes to object to that normal request then of course that is his right and his prerogative and in light of that it seems



to me that those Gentlemen whose names were previously enumerated have been denied a leave to be shown as excused and I withdraw my motion."

Speaker Redmond: "Very good, he withdraws his motion. House Bills, Second Reading. Well, the Republicans were all right, the objection was not raised there. House Bills, Second Reading. Representative Lechowicz."

Lechowicz: "Mr. Speaker, Ladies and Gentlemen of the House, a number of Members have asked as far as what the funeral arrangements are for Representative Leon's wife. Mrs. Leon was waked last night and she'll be waked tonight at the William Smith Funeral Home, 2500 North Cicero Avenue in Chicago. The funeral will be conducted from 9:30 from the William Smith Funeral Home tomorrow morning. The Mass will be said at St. Philomena's Church at 10 A.M. Thank you, Mr. Speaker."

Clerk O'Brien: "A Fiscal Note is filed." House Bill 242. A Bill for an Act to amend Sections of the School Code. Second Reading of the Bill. Amendment #2 has been adopted previously. Amendment #3 was withdrawn. Floor Amendment #4, McClain, amends House Bill 242 as amended at the end of the second paragraph and so forth."

Speaker Redmond: "Representative McClain."

McClain: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House, Amendment #4, after talking with Representative Brady and Representative Birchler and the Illinois Education Association, seems like they're satisfied that now the whole state is covered and I'd withdraw Amendment #4."

Speaker Redmond: "Representative McClain withdrew...withdraws Amendment #2. Was it...Amendment 4 withdrawn? What's the status of Amendment 2?"

Clerk O'Brien: "Amendment 2 was adopted previously."

Speaker Redmond: "No motion was filed with respect to it, is that correct?"

Clerk O'Brien: "No motion was filed in relation to Amendment #2."

Speaker Redmond: "And are there any...are there any Amendments



from the floor? He withdrew #4."

Clerk O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. Representative Lechowicz. Hold it."

Lechowicz: "Yes, Mr. Speaker, there is another Amendment. If we could just hold this on Second...just momentarily."

Speaker Redmond: "Hold 242 on Second Reading. Is there an Amendment? Mr. Clerk, do you have another Amendment? Representative Lechowicz."

Lechowicz: "Thank you, Mr. Speaker. No further Amendments to my knowledge."

Speaker Redmond: "Third Reading; 345."

Clerk O'Brien: "House Bill 345. A Bill for an Act to amend Sections of the Illinois Public Aid Code. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor on 24...345?"

Clerk O'Brien: "No floor Amendments."

Speaker Redmond: "Third Reading. Representative Kempiners. Wait a minute."

Kempiners: "Mr. Speaker, I just wanted to indicate I believe that a request for a fiscal note is filed..."

Speaker Redmond: "Is there a request for a fiscal note?"

Clerk O'Brien: "There is a request for a fiscal note filed."

Speaker Redmond: "Then it will have to be...kept on Second Reading until the fiscal note is furnished. House Bills, Third Reading. House Bill 9. Oh, yeah, yeah. Committee Report before we go to Third Reading."

Clerk O'Brien: "Representative Redmond, Chairman of the Committee on Rules, reported the following Resolution for introduction, House Resolution 67, Proposed House Rules."

Speaker Redmond: "House Bills, Third Reading. #9. House Bill 9, Third Reading. Representative Huskey on the floor? Huskey. Representative Walsh, do you have any comment? House Bills 33. Representative Collins. Representative



Collins asks leave to excuse Representative Huskey."

Collins: "I was going to ask leave...excuse Representative Huskey, yes, Sir...Mr. Speaker."

Speaker Redmond: "33. House Bill 33."

Clerk O'Brien: "House Bill 33. A Bill for an Act to amend Sections of the School Code. Third Reading of the Bill."

Speaker Redmond: "Representative Darrow."

Darrow: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House, it was my understanding that this Bill was to be ...left on Second Reading for some Amendment. I was surprised today to learn that it was moved to Third Reading. I was wondering if the Sponsor planned to move it back to Second?"

Speaker Redmond: "Representative Deuster."
