Speaker Lechowicz: "The Gentleman from Lake, Mr. Deuster has Amendment #1."

Floor Amendment #1."

Deuster: "Mr. Speaker, Ladies and Gentlemen of the House , House Bill 95

is the Bill that repeals and deletes an obsolete provision in the School Code requiring the Regional Superintendent to keep a list of all the textual material and instructional materials. As the subject came up on other Member pointed out to me that there might be a need for a clarifying Amendment to make sure that the members of the public could go to their school and inspect the text and the instructional material.

In response to that suggestion I am offering Amendment #1. Amendment #1 will clarify what I think is the law that any member of the public may inspect all text and instructional material used in the public

questions. As I say the Amendment was offered simply because there was some concern that if you couldn't go to the Regional Superintendent

schools. That's all the Amendment does. I'll be happy to answer any



and get all this information we ought to make sure that you can go to your local school. In a way I think this is already the law, but the Amendment is offered to make that clear."

Speaker Lechowicz: "The Gentleman from Cook, Mr. Brady on the Amendments.

Excuse me. Mr. Brady."

Brady: "Mr. Speaker and fellow Members, I appeciate what Representative

Deuster is trying to do here. I think the Bill itself is clarifying

language to clear up an old rule that is no longer in force and then

allowing the Regional Superintendents to comply with the law. But the

Amendment that is being added is good intention but it is simplistic

language and allows anybody from the public at any time to walk in

to any school and ask for any text material. I think that because of

the problems we might get with the individuals who just want it for the

sake of harassment interupt a classroom or a school activity anywhere

in the state that this Amendment should not be placed on the Bill and

would work with him in the future to try and make sure to insure that

the public has full and complete access to any records or texts used

in any school. I think that is presently covered under the law and I

think that this would open it up to just cause great confusion. I

urge the defeat of this Amendment to this Bill."

Speaker Lechowicz: "The Gentleman from DuPage, Mr. Schneider."

Schneider: "Thank you Mr. Speaker, and Members. I share Representative Brady's point of view. It is very loose language; it is done already in the schools. In a district the size let's say of Naperville, which has over 13 schools, there's no indication as to whether or not there's going to be a central location for the location of the materials, no indication as to whether or not there would be new books...or texts rather, that are adopted and can we go back and pull out books in the library, well, that probably doesn't cover this Amendment, but there is no clarification on the value of the inspection in my judgement. It is done in an organized fashion in my area. I think the intent of the legislation is right. This Amendment is bad and I would solicit also a 'no' vote."

Speaker Lechowicz: "The Gentleman from Cook, Mr. Schlickman."

Schlickman: "Would the Sponser yield?"



Speaker Lechowicz: "Indicates he will."

Schlickman: "Usually when you're giving somebody the right to inspection there is required that the person who desires to inspect give notice of his desire and that the inspection shall be subject to the constraint of reasonable hours, or business hours. I'm wondering if you have given any thought to the notice requirement and the restriction to reasonable hours."

Deuster: "In response to Representative Schlickman's observation normally statutes are construed in a reasonable manner. I didn't want to make this too complex. Certainly it could be improved, but you're right. In its present form it does not provide for notice, or during business hours, but I presume that...I had the feeling that if a parent wanted to go over to the local school and say could I take a look at the textbooks, that that would be doen when the school was open and secondly if it weren't reasonable they could work out someway to get the textbook. It's kind of a simple thing; I didn't feel it was necessary to clutter it up with a lot of language although that would have been acceptable to me had the Reference Bureau done that."

Speaker Redmond: "Any discussion? Representative George Ray Hudson, the Gentleman from DuPage."

Hudson: "Yes."

Speaker Redmond: "Representative Hudson control yourself."

Hudson: "Would the Sponser yield ?....OK. He says he will. Representative

Deuster in your Amendment is there any....do you see any real danger

as a result of your Amendment that this is going to be disruptive to

the classroom? Doesn't your Amendment simply give the interested parents the right to come to the school and take a look at textbook material? Does it go any beyond that?"

Deuster: "Well, in answer to your question Representative, it seems to me
that the taxpayers who support the schools certainly ought to have the
basic right to go over to the local school and say could I see what
you're teaching the children. And as a matter of fact I think the:
schoold would welcome that. We try very hard to encourage parent-teacher
organizations to involve the public. Yes it is true there might be
some left-wing or right-wing radicals who would ...are going over there



snooping around and making a nuisance of themselves but it seems to me that by and large, of the people who pay the taxes the members of the public should have a right to go and find out what textual material, what instructional material is being used in the public schools. It would probably be educational for them and good for them."

Hudson: "Well, thank you Mr. Sponser, I will speak to the Amendment , Mr. Speaker and Ladies and Gentlemen of the House, I fail to understand really the almost knee-jerk reaction on behalf of some to any demand on behalf of the taxpayers and the public to have a better understanding of what is going on in their public high schools. Representative Deuster has mentioned, I think this is a basic right that the taxpayers and parents of children in the schools have. One of their basic rights I think is to know something about the textbook material and the material that provides the basis for the instruction that the students are getting. They have every right in the world and as for as I'm concerned this falls squarely under the concept that we hear so much talk about these days, and that is the public's right to know. And again I can't say strongly enough that I feel that the taxpayer and the parents of students in the schools have every right to know what their children are being taught; they have a right to information as to the materials being used as a basis for this instruction. There's nothing wrong whatsoever with this concept that I can see. I don't think we need fear it; I don't think that as a result of this there's going to come disruption in the classroom. It's a reasonable Amendment; it seems to me and I would urge the Members support of Representative Deuster's Amendment."

Speaker Redmond: "Representative Pullen."

Pullen: "Mr. Speaker, Ladies and Gentlemen of the House, I don't know how anyone on this House floor can quarrel with writing into law the right of the public to inspect text materials in the public schools.

They bought them; their children are being taught by them. I would say I cannot understand but I'm almost afraid I can why there is opposition to this Amendment. I certainly don't think that the great majority of Representatives in this chamber who do represent parents and taxpayers should share the opposition to this Amendment. Represen-



tative Deuster is attempting to put into law something which all of us assumed was already there. But something which is needed because there can be instances where a taxpayer is refused the right to inspect text materials. What is it that the school people are afraid of? What it is that they have in their schools that they don't want the taxpayers and parents to know about? I urge you to vote 'aye' on this excellent Amendment. Thank you."

Speaker Redmond: "Representative Kane."

Kane: "Would the Sponser yield to a question?"

Speaker Redmond: "He will."

Kane: "Representative Deuster if I walked into a classroom in the middle of a teaching session and asked the teacher to show me what she or he was teaching, what would be the teacher's appropriate response under the provisions of this statute?"

Deuster: "Well, my wife is a teacher and I'm sure if somebody walked into the school and didn't go to the office and wondered down the hall and jurst into a classroom and said I want to see what books you're using, if it were a parent probably my wife or any other teacher would say, 'I'm so happy to see you, would you like to sit in the back of the room or the back of the classroom and observe what we're teaching the children this morning?' Normally I would think that a stranger or any member of the public would stop at the office; they normally have to do that. If they didn't stop at the office, if they burst into a classroom said, 'I am a member of the public and I have a right to see your books and let me see them', I think the teacher would probably say 'well, we have a class going on right now, would you go down to the office, I'll be happy to provide you with a copy of the textbook in which you're interested.' That's the way it would be worked out. If it didn't work out that way, you can imagine all kinds of wild sorts of abuses of any law that we have. We start out with the assumption that people will be reasonable and that still would be consistent with the exercise of the right of the public to see what's being used. They can exercise that right by talking to the building principal and looking at the books in the office rather than in the middle of a class room."

Kane: "But isn't it true that that's not what your Bill says? What I asked



was not, what is the best way of implementing it, but what would be the responsibility of the teacher in that situation? And you're replying, 'I think this would be...I think that ...', and in truth your Amendment doesn't say any of that."

Deuster: "Well, if my Amendment said everything that was in your mind and in my mind, and in the mind of every Member of the General Assembly, we would have 20 pages of statutes. You have to write something in the King's English or in common understandable English and assume that it will be reasonably administered. And if it isn't, if some... if you discover a problem you can come in with an Amendment at some future time. All it says is a member of the public may inspect the text and instructional material used in the school. They can do that in the library; they can do it in the office...any event we find a lot of classroom disruption we can come in on some other day and write a lot of language to deal with it. Although I would be happy if you wanted to offer some language to clarify it, to leave it on Second Reading. But I think it's simple enough and plain enough and that reasonable

Kane: "Mr. Speaker, Ladies and Gentlemen of the House, I think that since teachers, principals, school board members, superintendants are going to have to administer and respond to the statute and that there's no appropriate way set out in the statute to respond to their responsibilities and since I don't think we want to be in the position of leaving rule-making authority and unclear kinds of things to the executive to put out, I urge that at this time that we defeat this Amendment. It may have a lauditory aim but that there's no way for the people that are supposed to enforce it, no means for them to know what the appropriate response is, to that kind of request and that kind of possibility of disruption, I'd urge a 'no' vote."

people will administer it and live with it in a reasonable manner."

Speaker Redmond: "Representative Kelly."

Kelly: "Yes, I'd like to ask the Sponsor a question. Don if in fact this were part of the state law, how many parents do you think would actually review this type of information?"

Speaker Redmond: "Representative Deuster."

Deuster: "Well, one of the problems we have in our society is parent apathy



I don't a great many parents would do this. I know some of the parents are interested in finding out what they're teaching the children about sex education; some of them are interested in knowing what they're teaching about birth control or family planning, a variety of things are of concern. Some of them are interested in making sure whether they're properly commemorating Casimer Pulaski's birhtday. There might be a million things that people would be concerned about but in answer to your question as quickly or as simply as possible...I don't think a great many parents or people are going to be trudging into the public schools."

Kelly: "Mr. Speaker and Members of the House, in my opinion if this simple

propsal, and what it does it permits parents to review textbook material, if this were a part of the law, I would feel I certainly expect that less than 100 parents would actually take advantage of this statute by reviewing the material. I don't think this is a major change in our educational system. But I do think it gives the parents an opportunity to moniter the educational material and if nothing elseit lets the educators know that the parents have this right and I think would be more selective. I've had a number of parents come to me and are very concerned about sex educational material and reviewing this material. There's been a great deal of difficulty, and I think this proposal would help to allow parents to review these materials. I think it's a good proposal; I think it's a very needed proposal; and I intend to support Representative Deuster's motion."

Speaker Redmond: "Representative Waddell. Representative Waddell."

Waddell: " Mr. Speaker, I move the previous question."

Speaker Redmond: "The question...Gentleman's moved the previous question.

The question is shall the main question be put? All those in favor

indicate by saying 'aye', 'aye', opposed 'no'. The 'ayes' have it.

The motion carries. Representative Deuster to close."

Deuster: "All the Amendment does is it says any member of the public may inspect all text and instructional materials used in the public schools.

As many of the speakers have indicated it appears to be that this is what the public policy of the State of Illinois is right now. It would be astonishing to me if someone would assert that members of the public do not



have the right to inspect textbooks and instructional material. It's a simple Amendment. I would ask that the House give it favorable consideration. Thank you."

Speaker Redmond: "Question is on the Gentleman's motion for the adoption of Amendment 1. Those in favor vote 'aye'. Opposed vote 'no'. Have all voted who wish? Have all voted who wish? The Clerk will take the record. On this question there are 94 'aye' and 25 'no' and the motion carries and the Amendment is adopted. Any further Amendments?"

Clerk Hall: "No further Amendments."

Speaker Redmond: "Third Reading. Turn the chair over to Representative McMaster."

McMaster: "Thank you Mr. Speaker. Speaker Redmond: "Representative Slape are you seeking recognition?"

Speaker Redmond: "Representative Deuster."

Deuster: "Mr. Speaker, Ladies and Gentlemen of the House . I had filed

Amendment #1 to this Bill which Amends the Illinois Marriage and Dissolution of Marriage Act. Amendment #1 would have changed the name
Dissolution of Marriage back to Divorce the way it always was.

It is sort of a matter of principle with me however I told the Judiciary Committee that I would present that to the Committee in the form of a Bill which I did and if they gave me a fair hearing that would be fine and whatever the Committee did, I would accept that and I would table the Amendment. The Committee decided to stay with the word 'Disillussion of Marriage' instead of Divorce. I think the Committee was wrong. But I told the Committee I would abide by their judgement and so consistent with that understanding and agreement I am tabling Amendment #1."

Speaker Redmond: "Is there any discussion? Representative Friedrich on the Amendment. Representative Schlickman."

Schlickman: "Well, Mr. Speaker the Gentleman asked for leave to table the Amendment."

Speaker Redmond: "Representative Deuster withdrew the Amendment."

Deuster: "That's right."

Speaker Redmond: "So there's no one to table it; he withdrew it. Please be precise Representative Schlickman. Your apology is accepted. Any further Amendments?"

Personally I don't have anything to hide, and I don't believe any Member of the House does. And let me say further that most of the people who make these inspections and requests have a legitimate right to do it and do it for a sincere purpose. And most of the people in the press, and I hope the press is listening, particularly the Lady in the press box on the right, have made inspections and they put spurious remarks on their reasons. And let me read the one they put on mine and I resent it, it was not made by that Lady, it was made by some guy by the name of Robert Springer, and the statement is: The reason for this inspection is a prisoner of a Chinese fortune cookie factory says Centralia's future includes lots of laundry. Now you know that that is a lie. That is not the reason they did it. I can say that Representative Hanahan had a statement made on one of his that would reflect on his integrity. And I resent that too. And I can tell you that Representative Winchester had an inspection made by some person who put down a phony telephone number. Now if we're going to have these requests and if this continues I'm going to ask people in the House to have their same problem and we're going to have an investigation of these people who make these requests. This is not a joking matter. This is serious business and anyone who takes it lightly including the Lady in the press box, as far as I'm concerned they are destroying the creditability of the press. Now they talk about the creditability of the Legislature, let's talk about the creditability of the press. These are the kind of people who destroy people's confidence in government and I think they ought to be censored."

Speaker Redmond: "Representative VonBoeckman."

VonBoeckman: "I would like to add a little bit to that. Recently a dead singer, I don't know who in the Hell she is, but I want to say to you



Deborah, you are the lowest form of life I've ever known."

Speaker Redmond: "Representative Collins."

Collins: "Well, Mr. Speaker, Ladies and Gentlemen of the House, I'm glad that the two preceeding speakers brought this up. I had one too that I was quite insulted by the same jerk named Springer, and on mine he said the reason for this inspection was anything but voyeuristic.

Now I don't know if he's peeking in my windows or what Mr. Speaker but I too resented this very highly."

Speaker Redmond: "House Bill 180. Representative Bowman for what purpose.

Representative Terzich and Ralph Dunn will you please be seated.

Terzich, Dunn please be seated. Mr. Doorkeeper, will you please seat

Mr. Terzich and Mr. Ralph Dunn?"

Bowman: "I'll talk to you over hear. Mr. Speaker I have a simple request. Reading of the Bill. Amendment #1 was adopted in Committee."

Speaker Redmond: "Any motion with respect to Amendment #1?"

Clerk O'Brien: "No motion filed."

Speaker Redmond: "Any motion from the floor?"

Clerk O'Brien: "Floor Amendment #2 Pullen, Amends House Bill 192, on page 2 by inserting immediately after line 30 the following and so forth."

Speaker Redmond: "Representative Pullen. Representative Bluthardt will you please sit down and get..."

Pullen: "Mr. Speaker and Ladies and Gentlemen of the House, this Bill would require the Department of Public Health to maintain an evaluate it's file on nursing homes, on each nursing home that it licenses. The file would include a rating that the Department were to assign to the nursing home. The Bill was passed out of the Human Resources Committee in the House after much testimony about how bad conditions are in the nursing homes because the Department of Public Health alledgedly doesn't do a very good job of policing them. I consider it rather ludicrous to have the Department of Public Health evaluating and rating nursing homes if they haven't been able to do a very good job of policing them So I am offering this Amendment to say of the following: each piece of paper contained in an evaluative file shall contain the following language: warning, the evaluations and ratings contained in this file were compiled by a governmental agency which has been unsuccessful in regulating nursing homes, shelter care homes, and homes for the aged. If we are going to have an agency which many people who came into the Human Resources Committee asking for this Bill feels cannot do a good job of policing nursing homes, have that agency evaluating and rating them and thereby have the stamp of approval of government upon anything in that evaluation file, I think we should have a little truth in packaging and warn the public that what their opinions are might not



necessarily account for much. So I urge the adoption of this truth in packaging Amendment. Thank you."

Speaker Redmond: "Is there any discussion? Representative Borchers?"

Borchers: "I'd like to ask Representative Pullen if she is serious about putting this on this Bill?"

Speaker Redmond: "Representative Pullen."

Pullen: "Certainly Representative. I think when we have a government agency making an evaluation and a rating where they say A+ to EI think that we should be telling the people don't forget this is government speaking and if we think they've done such a lousy job of policing nursing homes, we ought to be admitting that to the public."

Borchers: "I'd like to speak a moment to the Amendment."

Spacker Redmond: "Proceed, Mr. Borchers."

Borchers: "Well, I've inspected a lot of nursing homes and I can't quite

make up my mind whether I should be for it or not. But I have run, as
I have in the past, I saw the dried urine on the floor, old people
laying in their own filfth in a certain nursing home and others that
I have been into. I saw lettuce that was dried in the kitchens dried.

the heads of lettuce dried nearly to the center, bread that was actually
4 or 5 years...days old, why I believe I'm inclined to vote for this
Amendment."

Speaker Redmond: "Any further discussion? Representative Pullen. Any further comment? Question is on the Lady's motion for the adoption of Amendment 2. Representative Marovitz."

Marovitz: "Thank you vey much Mr. Speaker and Ladies and Gentleman of the House. This Amendment is perhaps one of the most ridiculous Amendments that we will ever see on the floor of the House of Representatives.

All of us may have some problems with a particular department be it under a Democratic administration or a Republican administration.

But to put a warning like this for all of the citzens of the State of Illinois is absolutely the most absurd thing in the world. And I hope you all read this ridiculous Amendment; it's almost like a cigarette warning that they want to put on every file which will tell the people of the State of Illinois what these nursing homes are and tell them something about each nursing home and give people access to these



files about the nursing homes. But to put a warning on every file like a pack of cigarrettes is just the most absurd thing in the world and if my Republican collegue who is Sponsoring this Legislation has serious problems with the Department of Public Health, take it up with the Director, but don't penalize the citizens and bring it to the floor of the House of Representatives."

Speaker Redmond: "Representative Chapman."

Chapman: "Mr. Speaker, I would ask the Members of the House to vote 'no' on this Amendment. Representative Marovitz is dealing with a serious matter and he is treating it in a serious manner. This is a Bill that is important to people who live in nursing homes who may live in nursing homes and this is every single one of us in this room, aren't you any of us who may be making difficult decisions in regard to our loved ones. And I don't think that we should put on an Amendment that is making light of a serious matter like nursing home placements and the quality of nursing home care. I urge each and every one of you to vote 'no' on this Amendment."

Speaker Redmond: "Representative Skinner."

Skinner: "In spite of the flowing gown that the Lady was wearing last night at dinner I must admit that her logic is peccable. The Department of Public Aid has proven itself incompetent time after time, after time. And all this Amendment suggests is that we put into law the fact that we know the Department can make mistakes and does make mistakes. Anybody that doubts that this Department makes mistakes must admit the Sun-Times series on abortion. It was just unbelievable what that Department allowed the abortion clinics to get away with..."

Speaker Redmond: "Representative Marovitz for what purpose do you rise?"

Marovitz: "I rise for the purpose of correcting the Gentleman. We are not speaking about the Department of Public Aid and have not been speaking about the Department of Public Aid. We're talking about the Department of Public Health and if the Gentleman has a problem with the Department of Public Aid there will be a form for that one."

Speaker Redmond: "Representative Skinner."

Skinner: "Every since I was 28 my mind has been rotting and I'm now at

the state of advanced rot and I apologize. I didn't mean to say Public

Aid, I meant to say the Department of Public Health. And if I could



finish my sentence the word that was left out was supported."

Speaker Redmond: "Representative Kempiners."

Kempiners: "Thank you Mr. Speaker, Ladies and Gentlemen of the House, I
may not necessarily like the wording that the Sponser of this Amendment wants to put on the file. However I have to agree with her that
we are having people make evaluations which have to be subjective of
a private institution that is operated in the State of Illinois. And
I think that anybody going through those files should be alerted that
this is some subjective decision made by a state employee. And I would
urge your support of this Amendment."

Speaker Redmond: "Anything further? Representative Pullen, do you desire to close? Representative Pullen."

Pullen: "Mr. Speaker, this Amendment simply makes clear to the public that we'll be looking over these evaluation files, that the source of an A+ or an E- rating comes from indeed the Department of Public Health which the nursing home reform Legislators are very concerned, have not been successful in policing in the job that they are supposed to be doing. It is a very simple Amendment. It is an honest Amendment. And it's about time that we play honest with the people in the things that we publish through the bureaucracy. I urge the adoption of the Amendment. Thank you."

Speaker Redmond: "Question's on the Lady's motion for the adoption of Amendment 2. Those in favor of the motion, idicate by voting 'aye', opposed by voting 'no.' Have all voted who wish? Speaker Redmond: "Representative O'Brien."

O'Brien: "Mr. Speaker, I think since Representative Kent's Amendment went on the Bill that Amendment #3 is no longer necessary and I move to table."

Speaker Redmond: "Representative O'Brien withdraws the Amendment 3. Any further Amendments?"

Clerk Hall: "Amendment #4, Kent, Amends House Bill 460 by deleting lines 8-35 and so forth."

Speaker Redmond: "Representative Kent. Amendment #4."

Kent: "Since the Amendment....this one we need on there yet? This will do the same thing. It will just correct and deaccelerate. So I urge you to vote 'yes' on Amendment #4."

Speaker Redmond: "Is there any discission? Repesentative Bradley?"

Bradley: "We're in favor of the Amendment Mr. Speaker."

Speaker Redmond: "OK. The question's on the Lady's motion for the adoption of Amendment #4. Clerk Hall: "No motions filed."

Speaker Redmond: "Any Amendments from the floor?"

Clerk Hall: "No floor Amendments."

Speaker Redmond: "Third Reading. 555."

Clerk Hall: "House Bill 555, a Bill for an Act to Amend Sections of an Act relating to alcoholic liquors. Second Reading of the Bill. Amendments #1 &2 were adopted in Committee."



Speaker Redmond: "Any motion with respect to Amendments 1 &2?"

Clerk Hall: "A motion to table Amendment #2 by Representative Mahar."

Speaker Redmond: "Representative Mahar."

Mahar: "Thank you Mr. Speaker . I filed a motion to table Amendment #2,

House Bill 555 and let me tell you what it does. The Legislation we
now have in the book, an Act was passed a couple of years ago, allows
for the sale or the use of alcoholic beverages in the city of Chicago
and the aquariums and museums where other ...where they have food offered. Amendment #2 expands that to all the park districts in the city
of Chicago. Now I think this is a whole new concept, I might back up
a' second there...House Bill 555 expands the original Bill to allow
Lake View Museum in Peoria to do the same things that those areas in
Chicago can do. Amendment #2 which we're asking to table is an Amendment which allows the sale of alcoholic beverages in all the park districts in Chicago. I think that this particular piece of legislation
is one that ought to be acted upon by itself. I don't think it belongs
with this Bill; it opens up a whole new area of the serving of alcoholic
beverages and for that reason I ask that we table the Amendment."

Speaker Redmond: "Is there any further dicussion? The question's on the

Speaker Redmond: "Is there any further dicussion? The question's on the Gentleman's motion...Representative Madigan."

Mandigam: "Will the Sponsor of the Amendment have an opportunity to participate in the debate?"

Speaker Redmond: "Surely. Who's the Sponsor of the Amendment?"

Madigan: "Mr. Yourell."

Speaker Redmond: "Representative Yourell? There's a motion made to table

Amendment 2 to House Bill 555. I understand that you're the Sponsor

of Amendment #2....Representative Tuerk for what purpose do you rise?

Representative Teurk will the Member standing between Representative

Tuerk and the chair please be seated? Representative Schlickman.

Representative Macdonald."

Tuerk: "Mr. Speaker, Members of the House, being the Sponsor of House Bill 555, I'm well aware that this Amendment was added to the Bill ..."

Speaker Redmond: "John Miller, please be seated."

Tuerk: "This Amendment was added in Committee and it was offered by Representative Yourell. At the time that it was offered, I offered no opposition



to the Amendment at that stage. However there was some discussion among the Members relative to the fact that this Amendment may or may not jeapordize the Bill in its present form. Now it appears that it's becoming at that point because as I look ahead to Amendment #3 which will be offered depending on the outcome of this tabling motion by Representative Mahar. Then it would appear that this Bill is becoming a somewhat of a Christmas Tree and that was not the intent of the Bill at the out-set. As Representative Mahar pointed out in has discussion this Bill was a very simple Bill at the out-set which would give a museum in the city of Peoria which is located on park property, the same rights and priviledges as was accorded to several museums in the city of Chicago 2 years ago with House Bill 1459. And that's all I was asking for and this Amendment as I say, gets to the point where I think with plus the succeeding walnument which will be offered depending on the outcome is getting to the point where it may or may not jeapordize the Bill. So I wanted to offer that as background information for Representative Yourell's benefit as well as the Members of the House." Speaker Redmond: "Representative Yourell."

Yourell: "Thank you Mr. Speaker. Ladies and Gentlemen of the House, what Representative Tuerk refers to is partially right. House Bill 555 had a very difficult time in the Cities and Villages Committee , on the occasion when it was heard. And the reason that it had a difficult time was that there was some definition involved as to where these beverages could be served or should be served. The Sponsor of the Amendment instead of weakening the Bill, though that perhaps the Bill could be strengthened by including other park districts and other facilities as well. It seems to me that if it's fine to do that in Peoria, well those who enjoy those facilities in the Chicago park district, such as the Museum of Science and Industry, the Planetarium, the Aquarium, and other facilities such as that of that nature, should have the same opportunity. That was the purpose of the Amendment. And I don't know what Amendment #3 does that the Sponsor referred to, but again I don't think this has any Christmas Tree effect . I think this just broadens the concept of the Legislation and adds to the Bill. And I would move



to table the motion to table Amendment #2 to House Bill 555."

Speaker Redmond: "Representative Mahar moved to table Amendment #2.

Representative Yourell has moved to table the motion to table.

Representative Skinner in a subdued voice wanted to know if this was debatable. The Parliamentarian advises me that it is not. Is that

Bill."

Speaker Redmond: He's not the Sponsor of this Bill. Tuerk is the Sponsor of this Bill. Well, anyway I think the question is on Representative Yourell's motion to table Representative Mahar's motion to table Amendment 2. Question is on Representative Yourell's motion...

Representative Hanahan. Point of order he says. His name was mentioned

Hanahan: "Not anything to do with the debate. I'm just curious if another motion to table the motion to table of the motion to table would be

Speaker Redmond: "I've already put the question. We'll get to that the next time..."

Hanahan: "But the point of order is before the question of how could you move...I mean...I could vote no on Representative Mahar's just as easily as I could vote 'yes' on Representative Yourell's. I don't see the real value of moving to table a motion to table."

Speaker Redmond: "Well, we'll have a meeting of the Rules Commmittee in the Speaker's Office right after the session to discuss that. The question is on Representative Yourell's motion to table Representative Mahar's motion. Those in favor of Representative Yourell's motion vote 'aye',

Skinner: "Mr. Speaker, it seems to me that a lot of people that don't think



opposed vote 'no'. Representative Skinner."

It is obvious to me that if Representative....if the Representative's

Speaker Redmond: "Representative Schlickman, for what purpose are you shouting?"

21. And we wouldn't want that to happen..."

Schlickman: "Well, if a motion to table is not debatable, I should think that should include explanation of both because that is a part of the debate."

Speaker Redmond: "That's another one of the matters we'll take up at the Rules Committee after the session.... to Amend our rules and we don't have any such rule Mr. Schlickman. Have all voted who wish? Have all voted who wish? Clerk will take the record. On this question there are 77 'aye' and 68 'no'. And Representative Yourell's motion to table Representative Mahar's motion to table, carries. Yourell's motion carried so now we're on the question, are there any other motions with respect to Amendments 1 & 2?"

Clerk Hall: "No motions filed."

Speaker Redmond: "Are there any Amendments from the floor?"

Clerk Hall: "Amendment #3, Grossi, Amends House Bill 555 is Amended in the first paragraph after the words 20 years and the following."

Speaker Redmond: "Representative Grossi. Amendment #3."

Grossi: "Thank you Mr. Speaker. Ladies and Gentlemen of the House, I offer Amendment #3 to House Bill 555 in light of Amendment #2. Amendment #2 simply says that the Chicago park districts through approval of its commissioners may sell or serve alcoholic beverages. My Amendment is simply adds to that any park district which the park district commissioners so authorize."

Speaker Redmond: "Any discussion? Representative Tuerk."

Tuerk: "Well, Mr. Speaker and Members of the House this is the Amendment that
I alluded to and my remarks a moment ago relative to the tabling motion
by Representative Mahar and Yourell. I just don't happen



to feel that we should give broad sweeping powers to any and all park districts throughout the state. I know that in a sense when I speak against this Amendment in effect there's somewhat of a paradox because all I was trying to do in my original Bill was give the one museum in Peoria the same rights that the city of Chicago obtained 2 years ago. Now when we go to broadening this clear across the state I just don't think this is the intent of the Bill and therefore I would oppose this Amenment nor would I Sponsor a Bill that would give very park district in the state the approval to sell alcoholic beverages by any park district as long as they had park district commissioners approval. I would oppose the Amendment."

Speaker Redmond: "Representative O'Brien."

O'Brien: "Mr. Speaker, Members a question of the Sponsors of the Amendment. I just want to clarify to know if this Amendment allows the park commissioners to either opt-in or opt-out or set-up the guideline and provisions by which they would sell alcoholic beverages."

Grossi: "My understanding is that it does."

O'Brien: "Is that it does?"

Grossi: "Commissioners have that option. They make the choice."

O'Brien: "Fine. Mr. Speaker and Members of the House I speak in favor of this Amendment. I think it's a good Amendment. I think if it's good enough for Peoria, Representative Tuerk's area, it's good enough for the rest of the state of Illinois. I would encourage everybody to support the Amendment."

Speaker Redmond: "Representative Mahar."

Mahar: "Thank you Mr. Speaker. Ladies and Gentlemen of the House, I oppose
this Amendment as I opposed the last Amendment. I think that we're
getting into a subject here which should be dealt with in specific
legislation. I'd like to call your attention...if you look at the
Bill there are no provisions in there as to how the local liquor
commissioner will act. Whether additional licensese presented by local
municipality or what. I think this is a very important consideration.
Number 2, just a week or so ago we had great debate on the drinking
age raising it to 21 years of age. It seems to me it's totally inappropriate, and improper based upon the majority of this House and



based upon the majority of people throughout the state, that we now serve alcoholic beverages in park facilities where the young people are playing basketball or volleyball or whatever. It seems to me we're going in the opposite direction. And by opening up this legislation, opening up the serving of alcoholic beverages to all these park people in this type of Bill which was not designed to set the mechanics as to how the licenses would be granted, is totally wrong. It ought to be handled in some other type of legislation, discussed on its merits on that basis and not added on to this particular Bill. It's totally the wrong Bill and I urge opposition to the Amendment."

Speaker Redmond: "Representative Schlickman."

Schlickman: "Well, Mr.Speaker, Members of the House, I joined in tabling the motion to table Amendment #2 and the reason I did was because I thought it was consistent with the goal of the Bill as originally introduced and existing law being to allow for the sale of alcoholic beverages in connection with the consumption of food. But Mr. Speaker, Members of the House, when you look at Amendment #3 the serving of liquor at any facility on land owned by any park district is not restricted to the incidental value of liquor when consuming food. And on that basis Mr.Speaker, and Members of the House, I feel that this Amendment goes too far; it's without the context of existing law and the Bill that was introduced and I would urge a 'nay' vote."

Speaker Redmond: "Representative Getty."

Getty: "Will the Gentleman yield?"

Speaker Redmond: "He will."

Getty: "Representative Grossi, as I read this Amendment you provide that liquor may be served at the facility if the sale is approved. Now it seems to me that that does not track the language of the Act as it is now which provides delivered to or sold and secondly it would seem to me that it would not permit a park district to authorize delivery where the facility is, was we'll say rented, but it wasn't going to be sold to the people there. It was going to be given away."

Grossi: "In my Amendment there , there is no intention that it be given away unless the sale is approved by the Park District Commissioner."

Getty: "Well, what I'm suggesting is that the Amendment in the form that it is



now, may not do what you intend the Amendment to do because I think as it reads you would be limiting to a sale situation and not to say if they wanted to rent it and give away beer or something like that it wouldn't be permitted under the Act as you are Amending it."

Speaker Redmond: "Representative Grossi."

Grossi: "As I look at the language I believe it is possible for that interpretation to be made and that is not my intent. My intent is in the same general sense as the other provisions of the original Bill is to allow the serving under some circumstances for certain benefits of a park district."

Getty: "I would just respectfully suggest that maybe the Amendment is not in the form that the Sponsor of the Amendment would have wanted it to do what he wants. And that possibly it would be preferable to take that Amendment out of the record and maybe address it later in the Senate or if the Sponsor of the Bill wanted to hold it, to try it again later."

Speaker Redmond: " Representative Grossi."

Grossi: "I will hold the Amendment for a correction if the Sponsor of the
Bill will hold it on Second Reading."

Speaker Redmond: "Representative Tuerk? Where is Tuerk? Where is your seat? Will he use Representative Donovan's microphone? Representative Grossi is indicated that his position is to hold consideration for Amendment #3 providing you will hold the Bill. What's your response?

No, he doesn't want to hold the Bill. Representative Grossi."

Grossi: "Will the Sponsor of the Billor the Bill goes to Third Reading, will it be brought back to Second Reading for the corrected Amendment?"

Speaker Redmond: "Representative Tuerk."

Tuerk: "Only if I see the Amendment and... but my position is we'll move it to Third."

Speaker Redmond: "A request for a fiscal note has been filed. Who filed the request Mr....Representative Skinner...Tell him about the Forest Park Foundation."

Tuerk: "Am I understanding that I cannot go to Third Reading without the fiscal note, is that correct?"



Speaker Redmond: "Unless somebody wants to know whether the request for the fiscal note was dilatory. Did Representative Skinner file that new form that says that in his judgement it was well founded and not intercourse for the purpose of delay? Representative Skinner."

Skinner: "Mr.Speaker, it occurs to me since one of the people deeply involved in this Bill was one of the Sponsors of House Bill 21 that he may be trying to make-up for the revenue loss which House Bill 21 will resolve in. I just want to find out if that's really the case. If we let everybody drink in every park in the state will we really bring in the 5 to 8 million dollars that House Bill 21 is going to lose I don't think that's a frivilous request."

Speaker Redmond: "Representative Tuerk."

Tuerk: "Mr. Speaker, Members of the House, there's no fiscal implication to this Bill whatsoever even with Amendment #2 on it. I see no reason for any fiscal note being filed, the request for the fiscal note...

I would remind the Body that this just doesn't apply and I object to the filing of the motion fiscal note. And I would move that that request for a fiscal note lie on the table and it's not applicable to this Bill."

Speaker Redmond: "Representative Tuerk there's a motion that you can ask the House to determine whether the Fiscal Note Act applies if you put that ..."

Tuerk: "That's just what I did."

Speaker Redmond: "Well, he didn't say...he said it..."

Tuerk: "Well, I said it in a different way than you said it but the intent was the same."

Speaker Redmond: "OK. Representative Tuerk desires to put the question as to whether or not the provisions of the Fiscal Act apply. Representative Daniels, for what purpose do you rise?"

Daniels: "Does that motion have to be in writing?"

Speaker Redmond: "In case the Minority spokesman on Judiciary II requests it in writing."

Daniels: "Well, I don't know who that is but I'm of Judiciary I and I would request in writing and furthermore and I would request that the Sponsor of this Bill give the courtesy to a new Member of this House to hold it for one day so he could review his Amendment. It might be a bad



Amendment Representative; we might all vote against it but I'd like this Member of the House to have a fair opportunity and Representative Terzich I think it would be only reasonable for you too to extend that courtesy to this Member."

Terzich: "You too Fred."

Speaker Redmond: "Well, Representative Daniels has objected to the fact

that the motion is not in writing. And that objection is well founded."

Daniels: "Why don't we just hold the Bill and go on to the next one?"

Speaker Redmond: "Well, Representative Tuerk."

Tuerk: "Well, Mr. Speaker, I'll certainly file in writing. I have sympathy for all new Members. However I just think that this Amendment to the Bill is just not in the spirit of the Bill itself and there's no fiscal implications whatsoever. I see no reason to hold the Bill. Now I mentioned earlier that we'll move it to Third and if anybody has an Amendment they would like to offer for it, I'll take a look at it. And then go from there. But there's no reason why we should hold this Bill up any longer and in just a moment I'll have the motion right on the Clerk's desk relative to the fiscal note being requested and then I would ask for the Members' vote on it."

Speaker Redmond: "Representattive Deuster."

Deuster: "Well, I'm just going to say that Representative Skinner is the one who is asked for the fiscal note and as we all know, he's not a new Member."

Skinner: "Well, I...there's several trains of logic and illogic going through this discussion. I cannot imagine why the city of Chicago's parks could possibly be relavant to this little museum or whatever it

Speaker Redmond: "Will you repeat that? Representative Skinner."

parks could possibly be relavant to this little museum or whatever it is in Peoria County while all the down state park districts in the state are irrelavant. But I really think that the General Assembly ought to know how much extra revenue this is going to bring into the General Revenue Fund, especially since many of the proponents of this Bill just voted to deprive the state of \$5-\$8 million in liquor taxes by lowering

Speaker Redmond: "Representative VanDuyne, Representative Bradley and Schisler will you please be seated?"

Van Duyne: "Mr.Speaker, could I ask the Sponsor of the Bill a question please? Or do I have to wait until we take note."

Speaker Redmond: "I would think that you should wait until the motion is put."

Van Duyne: "God Bless You."

Speaker Redmond: "The question is on the Gentlman's motion that the House determine whether or not the provisions of the Fiscal Act apply. The question is do the provisions of the Fiscal Act apply to House Bill 555? Those in favor signify be voting 'aye', opposed by voting 'no'. Representative Tuerk... Representative Schlickman."

Schlickman: "My understanding Mr. Speaker is that we're voting on the motion of Representative Tuerk; is that right?"

Speaker Redmond: "That is correct. If you want a..."

Schlickman: "If you want a fiscal note you vote 'no' and if you want the Bill to advance to Third you vote 'yes'."

Speaker Redmond: "The way I stated the question if you want a fiscal note you vote 'yes' and if you do not want a fiscal note, if you decide that the provisions of the Fiscal Note Act Statute do not apply, then you vote 'no'."

Schlickman: "Well, the reason I asked, there was some confusion..."

Speaker Redmond: "The question is does the Act apply."

Schlickman: "Alright thank you."

Speaker Redmond: "Somebody bring ice to Representative Skinner. Have all voted who wish? Clerk will take the record. On this question there's 26 'aye' and 115 'no' and the House has determined that the provisions of the Fiscal Act do not apply. Proceed with the Roll. We're on Amendment #3. Representative Van Duyne."

Van Duyne: "Thank you Mr. Speaker, I'd like to know the impact a little bit futher down the road on people that are in business privately and also



the taxes that are going to be collected from an operation such as this. And I'd like to have somebody explain to me just what kind of happenings are going to go on and I conceive of maybe some big type of gathering there where somebody is going to be honored or you know .. a fundraisers; or a testimonail dinners where we have a bar open... are these people going to buy a lisence; are they going to pay their \$1,000 or \$1200 to the municipality in which they lie or to the county which controls their liquor lisences? Are they going to be subjected to the same type of taxing proceedures? You know our church, the Catholic Church, is one of probably one of the biggest vilators of every law that we have on the books in terms of paying lisences and in terms of operating a business against our own private entrepreneurs. This is what I envision. And if this is going to happen, if some poor guy in Joliet or DuPage County or Cook County is going to be paying \$1200 a year license, \$3,\$4,\$5,\$6,000 a year taxes,bartenders , Social Security and everything else, we're going to be in direct competition and I wish somebody would pay attention, Grossi if nobody else, if we are going to be in direct competition inevitably with the guy who is trying to make a buck for example like I am, and a dozen other people that I could name I just got on the tip of my tongue...and I'm

Speaker Redwond: "Well, I think we're now on the question of the adoption of the Amendment #3."

Van Duyne: "Well, I'm asking Representative Grossi. He's the Sponsor of
the Amendment and I'd like to at least engage him in some type of conversation so it would be a little bit more clear because these things

Speaker Redmond: "Representative Grossi. Can you respond to the inquiry?"

The policy of racial of apartheid in the Republic of South Africa are well known to everybody. It should not be the function of the taxpayer of the state of Illinois to finance racial seperation in that country. It is the only country in the world that does this by a Constitutional Mandate and until such time as that mandate is lifted, I think it's appropriate that we not use our tax moneys to promote racial apartheid and so I offer Amendment #3."

Speaker Redmond: "Representative Leinenweber."

Leinenweber: "Would the Gentleman yield for a question?"

Speaker Redmond: "He will."

Leinenweber: "Representative Bowman, why did you pick South Africa out of all the other countries in the world?"

Bowman: "Representative Leinenweber, I thought I had addressed myself to that in my opening remarks. The Republic of South Africa is the only country, and I stress the only country in the world, that has a policy of racial apartheid in its Constitution. And so while there may be any number of human rights violations throughout the world, it is the only country that sanctions apartheid in its Constitution. And I think it's time that we take a stand against this gross injustice.

Thank you."

Leinenweber: "Are you suggesting that these myriad of other countries which I believe you said may practice discrimination of one type or another, that because their Constitution may prohibit that , that that cleanses them?"

Bowman: "It would certainly make them eligible for the receiving loans from such financial institutions. It cleanses them in that respect."

Leinenweber: "Why did you select the United Nations as the Body to certify the elimination of racial discrimination in South Africa?"

Bowman: "Because it seems to me that the United States, of which we are a Member, is a Member of that Body. And it is a Body which continuously moniters human rights violations around the world, and would be a third party, if you will, that we could appeal to in the event that there was any question as to what action the Republic of South Africa had taken."

Leinenweber: "Are you aware that this so called Body of third party so to speak, also has by Resolution equated Zionism with racism?"

Bowman: "I am aware of that."

Leinenweber: "And you therefore still continue to feel that this could be an impartial Body which could make this certification?"

Bowman: "As we all know Representative, I'm sure you raised that because you object to that equation as much as I, as much as any other Member of this Body. Nonetheless, the United States continues to be a Member of the United Nations and it seems to me that it is entirely appropriate to have some entity other than an agency of the Federal Government to make the determination. What we are talking about in fact is a statement, a clause language in the Constitution of the Republic of

South Africa which would be an easy matter to determine, and I think it's an appropriate Body to make a determination."

Leinenweber: "Would it suit your purpose, in other words, ...is it your

intent that if the Republic of South Africa merely Amend its Constitution, and nevertheless continues with the apartheid, that they would then be eligible for a loan...in other words a bank making them loans wouldnthen be eligible for this in the state of Illinois?"

from the Constitution would not by itself constitute a complete reversal of the policy, let me suggest to you in reply that the first step, namely that of taking the sanction out of its Constitution, would be a major public policy reversal in that country. And it seems to me that it is precisely the reversal of that policy that we must seek at this time. Until they turn around in their tracks and start going the other direction, they're not going to get to the point where you know I think

Bowman: "Well, Represenative, I think if you're suggesting that the removal

To turn in to the ...to make this even more ludicrous, to turn the determination of the certification of whether or not an apartheid Bill exists in South Africa over to the UN is absolutely beyond belief. That Body has on its books a Resolution equating Zionism with racism. It's just beyond me how anybody could vote for this Amendment and I certainly urge its defeat."

the Chicago Sun Times and the Federal Government Association disclosed the autrosities that were being performed in the abortion clinics on Michigan Avenue in Chicago. A special subcommittee of the House, made many recommendations to respond to the investigations and the findings of that expose. The next 4 Bills which we are to consider are the implementations of those reccomendations. Whether one is an opponent of abortion or not, there must be universal support for the improved regulation of these facilities and the enforcement of existing laws so that the rest of death and injury can be lessened. We cannot tolerate a situation that continues to allow profiteers to victimize women seeking abortions. This package of Legislation is concerned solely with improved regulation of the facilities operating at abortion clinics in Illinois. It is not designed to limit a restrictionist from getting an abortion, nor is it intended to make it easier for women to obtain abortions. The objective is to insure these facilities are operated in a safe and healthy manner. The sooner we do that, the sooner we will know that women will not experience any more tragedies of the type reported last fall. I have distributed a copy of Chicago Sun-Times' Sunday editorial supporting these Bills. If I could first



turn then to House Bill 437, which is the first one in the package.

The highlights of the Bill are as follows: We define a criminal abortion

as one that: is not performed by a licensed physician or not performed in a hospital or ambulatory surgical treatment center. The 2nd most important point of this Bill, is that we specifically require counseling before an abortion is performed. A counseling shall include the discussion of alternatives in dealing with an unwanted pregnancy, a description of the proceedure to be used in performing the abortion, and an explanation of the risk and the possible consequenses of these proceedures. The counseling shall also include information about contreceptives. Another major part of this legislation is to rquire that the results of the pregnancy test be disclosed to a woman before an abortion is to performed. This will avoid the practice of an abortion being performed on a woman who is not pregnant. A futher provision of the Bill requires that the doctors who discover complications after an abortion to report these to the Department of Public of Health. However, the identitiy of the woman will not be disclosed. And finally the Bill prohibits payment, bribes, or kickbacks, for abortion referrals. This legisaltion is extensive and it is Constitutional. There are very few things which we

Speaker Redmond: "Is there any discussion? Representative Skinner."

Skinner: "During the hearings I asked the Department of Public Health regulators who are nurses what they considered their role to be, whether they considered it to be more of one of counseling or one of a policeman.

And they replied very vehemently as a matter of fact that they considered their role to be one of a counselor, that they wanted to make things better in the facility in question. It seems to me that in this case we need someone who considers. we need inspectors who consider themselves policeman. Now under your legislation...has that flaw been corrected? Will the inspectors who inspect abortion clinics still be


