Daniels: "Mr. Speaker, Ladies and Gentlemen of the Conference Committee Report on Senate Bill 1324 basically creates a new piece of legislation amending the Capital Development Bond Act, making a net reduction of 6,480,700 dollars in the Capital Development Bond Authorization. increases bond authorization by a total of 14,948,700 dollars in various categories: in the area of education, approximately 2,100,000; corrections, 800,000; state agencies, 12,000,000, for a total increase, as I stated, of 14,948,700 dollars. And it decreases authorizations various categories, total decrease being dollars, and a net decrease in the total authorization Bill of 6,480,700 dollars. I have a breakout, by category, of the Conference Committee action, which is presented in the legislation that you have on your desks. It has been gone over very carefully by both sides of the aisle and has been reviewed carefully by them, and I would ask for your favorable support and approval of the Report."

Speaker Telcser: "Is there any discussion? Hearing none, the question is, 'Shall the House adopt Conference Committee Report #1 to Senate Bill 1324? . All those in favor signify by voting 'aye', the opposed by voting 'no'. will take 107 votes since it increases authorization. Have all voted who wish? Take the record. On this question, 145 votin...146 voting 'aye', 4 voting 'no', 9 answering 'present', and this Conference Committee Report, having received the Constitutional three-fifths Majority, is hereby declared passed. Matijevich: "Mr. Speaker and Members of the House, first, Speaker, I want to commend you in your short tenure as Speaker for your austerity. I noticed your portrait in the galley...gallery, and you're very frugal, congratulate you. Now, in the spirit of that austerity, I offer and move for the adoption the Conference Committee Report #1 on Senate Bill 1524, which is a supplemental Bill in the amount of 6,926,000 dollars. 4,054,600 dollars is out of the University of Illinois Income Fund. That is an additional 4,054,600 from their fund, of which are the mid-year tuition increases. The 1,645,400 from the Capital Development Bond Fund; 940,000 from the General Revenue Fund; 286,000 from the SIU Income Fund. We have monies for food...for Century III incorporated into this Bill: various projects under the Capital Development Board: 395,000 dollars to the Department of Mental Health; 480,000 dollars to the Department of Transportation: monies for Secretary of State; planning funds for a new State Library in Springfield and 180,000 dollars for the Attorney General. I move for the adoption of Committee...Conference Committee Report #1 to Senate Bill 1524, and it's all agreed."

Speaker Telcser: "Is there any discussion? The Gentleman from Winnebago, Representative Mulcahey."

Mulcahey: "Just one question of the Sponsor."

Speaker Telcser: "Indicates he'll yield."

Mulcahey: "John, this University is just simply asking the authorization to use that 4,000,000 dollars that is from their Income Fund? Is that correct, John?"

Matijevich: "This, I understand, is a result of the additional increases in tuition at the U of I. So, the monies are therefore appropriated because of that additional revenue."

You all knew Ken. He was our friend. He epitomized, in my opinion, what is right with this country, and that is individual who is a self-made, disciplined, hard-working, family-oriented individual with an extremely high sense of moral principles. The tenure of our friendship, although it transcended party lines, always represented to me ideal in what was good with government, what was good with the business community that he so ably represented certainly what was good with home and family life. family I ve grown to know well over the years and can truly attest of their loss with their loving husband and father. He was only 59 years old, but I should point out to those of you who did not know Ken that some five years ago, suffered a massive heart attack and, to most of us, it would have represented the end to a professional career. For Ken Cole, however, it was the beginning of a new one. He recuperated through hard work, through a loving wife. loving children and a dedication to a professional career that knew no physical bounds. He went on his own, of which I was associated with him. He represented some of the most prestigious institutions in this state and in this country,

which was an...a testament to his capabilities as an honest, credible lobbyist. The selection of Ken Cole as the State Representative nominee for the Republican DuPage County for the 39th District came as no surprise to me, for he presented what was truly right with all of us in this chamber. Shapiro; and whereas, Russ Hamilton was rightly proud of his involvement in Democrat politics and his

- Matijevich: "Mr. Speaker, first I'd have leave that everybody's name be on the Resolution."
- Speaker Telcser: "Are there any objections? Hearing none, leave has been granted."
- Matijevich: "I'd also like to say that I was very close to Russ

Hamilton, and the one thing about Russ is that he enjoyed living every moment of his life, because he enjoyed people. And it was just a pleasure to know Russ. I kept in contact even after he left, as consultant with the Bankers' Association, and through his illness I would talk to him on occasion. And near the end, his wife, Dorothy, would say, 'John, Russ just doesn't want to talk to you'. And that was because Russ wanted to be remembered as a person was strong, and he didn't want any pity from anybody. just wanted to always be himself, and the best you can say about anybody is that the person is decent, and that's what Russ Hamilton was. He treated everybody decently, and I offer my sympathy to his wife, Dorothy, his two daughters and his sister and brother and his grandchildren all whom I met last week at his funeral, and move for the adoption of the Resolution."

Speaker Telcser: "Is there further discussion? As the Members know, it is customary to adjourn upon the adoption of a Death Resolution of a former Member. We have another Death Resolution of a former Member. We'll read that, and then we'll adopt both of them on the same Roll Call, adjourn, and after we adjourn, I'll make another announcement."

Clerk Leone: "House Resolution 1346, sponsored by Representative Vinson. Whereas, the Members of the Illinois House and lawmakers throughout the state are deeply saddened by the death of Nicholas L. Hubbard, a former State Legislator; and whereas, he served his country faithfully during World War I, attaining the rank of Second Lieutenant, and then returned to his home county of Logan to take up farming and the operation of a grain business; and whereas, he was elected to the Illinois House in 1934 and served the people of his district for six years before winning a seat in the Illinois Senate, and after retiring from the Legislature

Speaker Telcser: "Gentleman from DeWitt, Representative Vinson."

Vinson: "Thank you, Mr. Speaker, Ladies and Gentlemen of the

this chamber added to sponsorship of the Resolution."

Speaker Telcser: "Are there any objections? Hearing none, leave has been granted."

Vinson: "Mr. Hubbard did serve his country well in World War I.

He did serve his district well, in both this chamber and subsequently in the Illinois Senate. Mr. Hubbard never permitted partisan politics to divert or distract him from the...his fidelity to constitutional principles, as his record makes clear. He served his community, his profession, his church very well. I don't know of anyone who I've had the privilege of ever meeting who more betokened an example of what this country and this state are all about. And, for that reason, I would ask that we pass the Death Resolution in token of our sympathy for Mr. Hubbard."

Speaker Telcser: "Gentleman from McLean, Representative Bradley." Bradley: "Mr. Speaker and Ladies and Gentlemen of the House, the Resolution indicates. Mr. Hubbard had a very distinguished and successful life. I couldn't help but think of the difference between Representative Cole and Mr. and Mr. Hubbard's fortunate in being able to lead Hubbard. a full life and be...do the things that he wanted to do. I'm sure that every one of us when we're out on the campaign trail, at some time or another, run into a former Legislator, which I was fortunate to do on a number of occasions when I would go down to Mount Pulaski in Logan County on the campaign trail. He never failed to have some words of wisdom of things that we should be doing or things that we weren't doing. And when you consider that it was 48 years ago at this time that Mr. Hubbard came to this chamber and started that distinguished political career. it's very remarkable that up until just a...just recently, he was still working and very active in operating a grain elevator in Mount Pulaski. Everybody that I knew in that particular area had nothing but kind remarks in his behalf. and so, Mr. Speaker and Ladies and Gentlemen, I would move the adoption of the Death Resolution, or of both Death

For Ken Cole, however, it was the beginning of a new one. He recuperated through hard work, through a loving wife, lowing children and a dedication to a professional career that knew no physical bounds. He went on his own, of which I was associated with him. He represented some of the most prestigious institutions in this state and in this country,
