Honorable James Edgar: "While we're waiting for the final tally I'd like to introduce the distinguished Attorney General of the State of Illinois, Attorney Tyrone Fahner. 177, Representative Elect having answered the Roll Call and being in attendance, a quorum is present and the House of Representatives of the 82nd General Assembly is officially convened. I have the honor of presenting the Honorable Justice of the Illinois Supreme Court, the Honorable Howard Ryan, who will administer the Constitutional Oath of Office. Following which each Member should execute the written oath on his desk which will be filed up at the Clerk's desk following the swearing in. Justice Ryan."

Justice Ryan: "Will the Members Elect please rise. Raise your right hand, say I. State your full name, do solemnly swear, that I will support the Constitution of the United States, and the Constitution of the State of Illinois, and that I will faithfully discharge the duties, of the office, of Representative in the General Assembly of the State of Illinois, to the best of my ability. Congratulations, Ladies and Gentlemen."

Honorable James Edgar: "We got to get back on schedule here.
We're not done yet, folks. Just everybody sit still here,
we still got some more things, families, just stay tight
for a few more minutes. Would all Members remember to
execute their oath, and have those brought up front. Pages
are collecting them, so Members you don't have come

yourself, the pages will pick them up. Okay. May I have your attention, please? Those who haven't got them up, we can get them later, we need to move along. As a former Member of the House, and as now Secretary of the State, I too would like to join in Justice Ryan's congratulations to you as the Members of the 82nd General Assembly. I now have the pleasure, we're extremely honored to have with us today, John Cardinal Cody, Archbishop of the Archdiocese of Chicago for the purpose of offering a prayer for the success of the House of Representatives during the 82nd General Assembly, also with His Eminence is Bishop Joseph Bishop of the Diocese of Springfield. We are McNicholas, delighted to have His Eminence here today. This is the first visit to the Illinois House of Representatives and it is most appropriate that he help open this new Session of the General Assembly. Cardinal Cody."

Cardinal Cody: "Let us pray. Almighty and Eternal Pather, place ourselves in Your Presence and ask Your benediction. You have created us to live and to work out our salvation in society. And so Pather, we ask You to grant to the men and women of this House of Representatives the faith and vision to see

- Honorable James Edgar: "Alright, we're ready. I hope. Under Article 4, Section 6B of the Constitution, the first order

of business of this House is the election for ... it's Member of a Speaker as presiding officer. 89 votes shall be required for the election of a Speaker. The House is now governed by the rules of the House of Representatives of the 81st General Assembly which are made applicable to these proceedings by Section 3 of an Act relating to the operations of the General Assembly and to repeal certain Acts therein, approved July 7th, 1967 as amended. rules provide ten minutes per Member for debate and one minute for explanation of votes of Members who have not previously spoken in debate on the point. With the consent of the House I would limit nominations speech...nominating speeches to ten minutes and seconding speeches to five I would then permit three minutes debate time on minutes. the vote itself or one minute explanation of vote by any Member not previously having spoken on the Roll Call for the election of Speaker. Is there consent? alright. Representative Vinson."

- Vinson: "It sticks in my memory that my running mate amended those rules which are now applicable to these procedures to require that after the prayer we say the Pledge of Allegiance."
- Honorable James Edgar: "I will check with the Parliamentarian on that, Representative Vinson. I think you're correct, Representative Vinson, we'll now have the Pledge of Allegiance. Would you like to lead us?"
- Vinson: "I pledge allegiance to the flag of the United States of
 America and to the Republic of which it stands one nation
 under God, indivisible with Liberty and justice for all."
- Honorable James Edgar: "It wasn't in the rules when Zale was here...nominations are now in order for the office of Speaker of the House. Nominations? Representative Peters.

Peters: "Mr. Secretary, Ladies and Gentlemen of the House, eight years ago when I was first elected to this Body, I believed and believe now that that election and the election since have probably been the greatest expressions of support and confidence from the people from my community that I could have received. To contemplate that 177 of sit here, representing over eleven million people and that each of us in our areas has been selected by constituencies to speak and act for them in this chamber, to me is a sobering and humbling thought. I stand with a sense of great pride for what we have accomplished in the past and with a sense of vision and purpose for what this General Assembly can end up accomplishing for the people of the State of Illinois. For the third time, I stand before the Members of this House to ask and recommend that they cast their votes for a certain individual as the leader of this Body. This is the third time that I have had that privilege. I stand here again today with the same sense of conviction and feelings of friendship and purpose that I felt twice before for the man that I wish to place in nomination for your consideration as Speaker of the General House of Representatives of the General Assembly of the State of Illinois. That individual is our former Minority Leader and soon to be Speaker, George Kankakee. George, I think brings to this position certain very important kinds of attributes. Attributes garnished in serving in local government as a member of his county board, understanding the problems of the counties, cities, the villages, the school districts in his county, he's a small businessman and a successful businessman who understands the heavy burdens that the small businessman really suffers under in the economic climate we have today

his record here on the floor clearly demonstrates that he has put in much effort and time in order to lift that burden, to help that small businessman, to return to some of those principles of free enterprise and competition that made our system really work.
