- Speaker Ryan: "Doorkeeper, will you clear the floor of all unauthorized persons please. I understand there are several agency liasons here and would you clear the floor please? Under the order of motions appears House Bill 294, the Gentleman from Cook, Mr. Madigan."
- Madigan: "Mr. Speaker, I have filed three motions which are shown on the Motion Calendar, and I would like to call the second motion first."

Speaker Ryan: "Which one, Representative?"

Madigan: "The second motion."

Speaker Ryan: "That...that motion, I think, would be out of order, Representative. The Bill presently resides in Committee on Transportation."

Madigan: "The purpose of the motion..."

- Speaker Ryan: "I think the first motion is to discharge that

  Committee. Is that the motion you want to call,

  Representative?"
- Madigan: "Mr. Speaker, if you persist, we could take the first two motions together. The import of the second motion is to create a Committee of the Whole tomorrow at 12 noon on the House floor to consider House Bill 294 which would provide a temporary interim borrowing authority for the Regional Transportation Authority. If that motion is successful, then we would call the motion which is listed first on the Calendar which would take the Bill from the regularly assigned Committee and assign it to the Committee of the Whole."

Speaker Ryan: "Mr. Madigan, your motion...your second motion

reads 'If the said Bill is discharged from Transportation Committee. So I think it would be out of order to take the second motion ahead of the first motion."

Madigan: "And as I said, Mr. Speaker, if you persist, then I'll call the two motions together."

Speaker Ryan: "Are you asking for leave to do that, Mr. Madigan?"
Madigan: "If that is required, that is what I request."

Speaker Ryan: "The Gentleman has asked leave to call House Bill 294, the two motions under the category of motions on page three on the Calendar, he asks leave to call those as one motion...take one vote as I understand it. Is that right, Representative? Are there any objections to the Gentleman's motion? Hearing none, leave is granted, Representative Madigan."

These two motions taken Madigan: "Thank you, Mr. Speaker. together address the problem of an eminent shut down of the RTA and the CTA in the City of Chicago and the surrounding suburbs. News reports which have been documented in the newspapers clearly indicate that the Mass Transit agencies in the Chicago area are slowly moving toward a cash shortage which will result in a shut down to those systems unless there is some provision made for temporary borrowing authority. House Bill 294 would simply provide additional borrowing authority which would be in existence from the date of issuance of the notes until July1, 1981. The purpose of this borrowing would be to correct a cash flow problem at the RTA and to keep that system operational into the month of June at which time it is hoped that there will be a legislative solution fashion for both the RTA and the state road fund. The purpose of my motion and the purpose of my request for a Committee of the Whole is two-fold. Number one ... "

Speaker Ryan: "Just a minute, Mr. Madigan. Let me get a little

order here for you. Could we give the Gentleman some order please? Would you be in your seats and pay some attention here to the Gentleman from Cook? Proceed, Mr. Madigan."

Madigan: "Number one, a Committee of the Whole would give the officials of the RTA and the CTA an opportunity to appear before the entire House of Representatives to offer their financial documentation on behalf of their request for this temporary borrowing authority and it would give them an opportunity to address all of us at one time on this very important subject matter. Secondly, an appearance by those officials before a Committee of the Whole, before the whole House, would give those of us who wish to question those officials an opportunity to pose questions to the RTA, to cross-examine if you so desire, these particular officials determine in your own mind if you as an individual Member of this House wish to grant additional borrowing The Bill is currently scheduled to be heard in authority. the Transportation Committee of the House on Thursday. the Bill is heard only in the Transportation Committee, then only those Members of that Committee will have the benefit of the testimony offered by the RTA officials and the opportunity to question and cross-examine those Ιf my motion is adopted, then the full House will have those opportunities. All of us will be in position to determine whether we wish to vote for or against this very important Bill. I read with great interest in the early additions of the Chicago Tribune this morning that the very officials that I wish to appear before the full House appeared yesterday before a select group of Legislators in a Chicago hotel. I have no objection to those officials appearing before any Legislators, but I do feel that all of us should have equal opportunity to hear testimony and to offer our

Speaker Ryan: "The Gentleman from Cook, Mr. Telscer."

Telscer: "Mr. Speaker and Members of the House, the Gentleman from Cook, in my opinion, has made a very specious argument regarding our giving him an affirmative vote on the motions appearing on the Calendar. As he said, his Bill is posted in the Transportation Committee Thursday of this week. Gentleman has asked you for a Committee of the Whole and frankly, I cannot really grasp the rationale for his doing The Gentleman neglects to mention that in a Committee 50. of the Whole, Amendments aren't offered and that the Bill which is heard in the Committee of the Whole will then move to the floor of the House in its present condition. Minority Leader also makes a point that he would have participation on the part of all the Members of the House. I would like to respond by simply saying that any Member of the House is free to attend any Committee meeting which the Legislature holds. And what's more, I confident that the CTA and the RTA or even the commuter railroads would be more than happy to answer any inquiry or question which any Member of the Assembly has on his or her I can't quite figure out the logic which the Gentleman is trying to present today. Levin: "Mr. Speaker, Members of the House, I rise in support of the motion by the Minority Leader. The issue of the RTA is

probably one of the most important issues that will come before this Body this year. If there is a shut down of mass transit in the six county area, it will affect not only the residents of the area who take the buses, and the trains, and the commuter railroads, but it will affect disasterously the economy of the entire State of Illinois. saw the experience in Boston where they ended up with a brief shut down. The effects were disasterous. House Bill 294 does not provide for any state subsidies. It does not provide for a roll over even of the state loan. It does not provide for an acceleration of payments of the taxes to the RTA. What it simply does is authorizes additional interim borrowing on the part of the RTA so that we can get through till June 30 without the entire system closing down. This is something that is an approach which I think fair approach. It keeps the status quo. It allows for deliberation by this Body in coming up with a permanent solution. The idea of a Committee of the Whole makes infinitely good sense in this particular matter. This Body had a Committee of the Whole with respect to the problems in the Chicago Board of Education, and it allowed the individual Members of this Body to hear the testimony from the experts, from Mrs. Rohter, Van Gorkum, and others, and have their individual questions answered. I think that is really needed in this case. I think there is a credibility problem as far as the RTA because we've been hearing that the RTA is in financially bad shape for a while now. The facts are that the system is about ready to close down sometime between March 15 and March 30, but the Members have to have the evidence presented to them...have have the opportunity to listen to the witnesses, to ask their own questions, to make up their own minds. And this, I think, is the best, the most expedicious way of

There are times in this that we've had people on this floor, used the House floor on a very important subject matter so that the people that could come in and testify could be heard by the entire Membership and questions could be asked by the entire Membership. This issue will not go away. This issue can actually break the back of the State of Illinois and its fiscal implications for this state and yes, for private industry. When you're talking about moving over a million people a day in an urban area, this issue has to be coordinated and questions should be available and should be

Ewell: "Mr. Speaker, Ladies and Gentlemen, I think we have to take recognition of what this will do to the City of Chicago and the State of Illinois. What we have to do is something about the RTA now. Not next month, not next June. We cannot bury this in Committee and make it a
