- Ackerman: "Thank you, Mr. Speaker. I rise for the purpose of an introduction. In the gallery to my right, is a group from Morton, Illinois who's with the Morton Chamber of Commerce Leadership School. Would they please arise?"
- Speaker Ryan: "169 Members of the House answering the Roll Call, a quorum is present. Committee reports."
- Clerk Leone: "Representative Ewing, Chairman from the Committee on Revenue, to which the following Bills were referred, action taken April 22, 1981 and reported the same back with the following recommendations: 'do pass' House Bill 900, 'do not pass' House Bill 810, 'do not pass as amended' House Bill 875. Representative Hudson, Chairman from the

- Speaker Ryan: "On the Calendar on page four, under the Order of House Bills Second Reading Short Debate Calendar appears House Bill 523, Representative Bartulis. Out of the record. House Bill 600, Representative Satterthwaite. Read the Bill, Mr. Clerk."
- Clerk Leone: "House Bill 600, a Bill for an Act to revise the law in relationship to counties, Second Reading of the Bill.

 Amendment #1 was adopted previously."
- Speaker Ryan: "Are there any Motions filed with respect to
 Amendment #1?"

Clerk Leone: "No Motions filed."

Speaker Ryan: "Further Amendments?"

- Clerk Leone: "Floor Amendment #2, Satterthwaite, amends House Bill 600.."
- Speaker Ryan: "The Lady from Champaign, Representative Satterthwaite."
- Satterthwaite: "Mr. Speaker and Members of the House, this is an Amendment suggested by the Department on Aging. It's a permissive sort of thing giving counties equal power to townships in terms of supportive social services designed to keep people out of institutional care. It's purely optional on the part of the county as to whether they exercise it. The Department on Aging is suggesting it because they fear that some of the programs that they are funding and are channeling through counties, do not have appropriate authority. I've checked with the Chairman and the Minority Spokesman on the Committee. They see no

- Clerk Leone: "House Bill 101, a Bill for an Act in regard to judgments, and the manner of enforcing the same by execution, First Reading...Second Reading of the Bill.

 Amendments #1 and 2 were adopted in Committee."
- Speaker Ryan: "Are there any Motions filed with respect to Amendments 1 or 2?"
- Clerk Leone: "Motion...I move to table Amendments #1 and 2 to
 House Bill 101, Representative Abramson."
- Speaker Ryan: "The Gentleman from Cook, Representative Abramson."
- Abramson: "Mr. Speaker, Ladies and Gentlemen of the House,
 Amendments #1 and 2 are technically defective and we have

- Polk: "Mr. Speaker, I'm the single Sponsor of House Bill 848, I'd like to table that Bill."
- Speaker Ryan: "Would you repeat your ... ?"
- Polk: "Yes, I am the Sponsor and the only Sponsor of House Bill 848 and..."
- Speaker Ryan: "Well, Representative Polk, can you hold that?

 It's not timely at this...at this, right now."

Polk: "Yes."

- Speaker Ryan: "Is there any discussion to the Gentleman's Motion to table Amendments 1 and 2? Your Motion is to table Amendments 1 and 2, Representative? The Gentleman moves to table Amendments 1 and 2 to House Bill 101. All in favor will signify by saying 'aye', all opposed 'no', and the Amendments are tabled. Further Amendments?"
- Clerk Leone: "Floor Amendment #3, Abramson, amends House Bill 101..."
- Speaker Ryan: "The Gentleman from Cook, Representative Abramson,

Abramson: "Amendment #3 corrects the deficiencies in the Bill and raises the interest rate on judgments from 8 to 9% during the period of redemption. I move the adoption of Amendment #3."

Speaker Ryan: "Is there any discussion to Amendment #3? The
Gentleman moves the adoption of Amendment #3.

Representative Dunn, for what purpose do you rise?"

Jack Dunn: "Sponsor yield for a question?"

Speaker Ryan: "He indicates he will."

Jack Dunn: "I'm picking this Amendment up for the first time and in a hurry. It appears to relate to the interest rate and other charges in connection with sales on credit. Is that just a reference to the Section of the Interest Act or does this affect interest rates on things other than judgments?"

Abramson: "All this Bill does is raise the interest rate on...during the period of redemption on judgments from 8 to 9%, only affecting real estate redemptions."

Jack Dunn: "Where there's been a mortgage foreclosure?"

Abramson: "Right, and during the period of redemption after the foreclosure. It makes it the same interest rate as for judgments generally. Right now due to a oversight last year when we changed the general interest rate. It wasn't changed."

Jack Dunn: "And affects nothing else?"

Abramson: "Nothing else."

Jack Dunn: "Thank you."

Speaker Ryan: "Is there any further discussion? The Gentleman moves the adoption...the Lady from Cook, Representative Braun."

Braun: "I think Representative Younge has question about this Bill."

Speaker Ryan: "Pardon?"

- Braun: "I think Representative Younge has a question...has a question about the Amendment. I'm sorry I rose in response to something she just said to me."

The 9% is the same rate of interest you get on judgments generally. There's an oversight in changing the interest rates last year when we changed them, and we did change this particular one. So this just brings it into conformity."
- Speaker Ryan: "Do you the understand what the Gentleman said,
 Representative? Are there any further questions? The
 Gentleman from Cook, Representative Levin."

Levin: "Would the Gentleman yield?"

Speaker Ryan: "Indicates he will."

Levin: "Okay. Can you explain the context in which this applies, these foreclosures and under what process?"

Abramson: "I don't know what your question is."

Levin: "I mean are these foreclosures by banks, we're talking about or is this redemption from taxes..."

Abramson: "Okay, this is mortgage foreclosures, okay? Generally by banks, I assume."

Speaker Ryan: "Is there any further discussion? The Gentleman moves the adoption of Amendment #3 to House Bill 101. All in favor will signify by saying 'aye', all opposed 'no'.

The 'ayes' have it and the Amendment is adopted. Further

Stiehl: "Mr. Speaker, Representative McAuliffe has Amendment #1, if he's here I'd like to call it."

Speaker Ryan: "The Gentleman doesn't seem to be on the floor,

Representative. We may get back to it today if he shows

up."

Stiehl: "Alright, thank you."

Speaker Ryan: "House Bill 301, Representative Topinka, out of the record. 305, Representative Swanstrom, out of the record. 342, Representative Balanoff, out of the record. House Bill 364, Representative Hoffman, run it, read the Bill, Mr. Clerk."

Clerk Leone: "House Bill 364, a Bill for an Act to amend an Act making appropriations for certain continuing boards and commissions, Second Reading of the Bill, no Committee Amendments."

Speaker Ryan: "Any Amendments from the floor?"

Clerk Leone: "None."

Speaker Ryan: "Third Reading. House Bill 441, Representative McGrew. Is the Gentleman on the floor? Out of the record. House Bill 496, Representative Schneider. Representative Schneider on the floor? Out of the record. House Bill 497, Representative Hoffman. What does that signal mean?

Speaker Ryan: "Any Amendments from the floor?"

Clerk Leone: "Floor Amendment #4, Bowman amends House Bill 525 on page 1, line 5 and so forth."

Speaker Ryan: "The Gentleman from Cook, Representative Bowman on Amendment #4."

"Thank you Mr. Speaker. Ladies and Gentlemen of the Bowman: Representative Peters offers to us in House Bill 525 a day care Bill that is basically a good Bill and basically one which I can support. I have discussed substance of every section of Representative Peters' Bill with various parents, day care providers, the Auditor General's staff, virtually everyone that I can think of who has some input on this subject, and we'll have only a few things I'd like to now present to the House. Amendment #4 attacks a particular provision of the Bill which creates a special exemption for a class of part day We do not have a special exemption of the law facilities. right now. My basic problem with creating this exemption is that the health and safety standards, fire safety standards are not required by this exemption if the Bill were to pass on its present unamended form, the ... such centers would not have to meet even simple fire safety. And so I think we're better off leaving the present law the way it is and so I offer Amendment #4 to restore the

Peters: "Mr. Speaker, Ladies and Gentlemen of the House, what we had intended to do in the particular section of the Bill addressed by Amendment 4 was to release from regulations certain kinds of facilities which were involved I think that the original part of the Bill dealing with that was correct and is still correct. however. since the introduction of this piece of legislation, dealing specifically with this area, a number been expressed by individuals in of concerns have organizations involved in day care centers and caring for That it seems to me that until such children generally. time as we can reconcile the differences between those various groups, prudence would dictate that the Amendment offered by Representative Bownan at this point be accepted. I want the record to indicate that in terms of what we are trying to do, I still think that we are absolutely correct in what we are trying to do by exempting certain categories of day care centers. However, at this point, until we can get resolved the differences between these various groups and until such time as we can reason together, so to speak, I would suggest to the Members of the General Assembly that they accept Amendment #4 understanding again my attitude and my proviso that I personnally do not oppose the concept and will support it and other legislation but do not feel that we should be doing it on this particular Bill at this particular time because of the apparent confusion it has caused. Thank you, Mr. Speaker."

Speaker Ryan: "Is there any further discussion? The Lady from DuPage, Representative Karpiel."

Karpiel: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I just rise in support of this Amendment. This

I can't find my copy of this Amendment but it seems to me as if it's the one that says that we're not going to have any regulation at all of centers that have people in them for fewer than eight hours a week, and it troubles me how we're going to know which centers don't have people in them for any great length of time than eight hours a week if we're not paying any attention to those centers at all. And perhaps in closing the Sponsor would want to address that. It just seems to me like...."
- Speaker Ryan: "Well, Representative it's proper for you to ask the question at this time, if that's what you would like to do."
- Catania: "All right, well maybe he would want to...."
- Speaker Ryan: "Representative Peters, would you respond to Representative Catania's questions?"
- Peters: "Representative Catania, what Representative Bowman is attempting to do here is bring the law back to what it was originally and require the same kind of standards and the same kind of licensing before this particular Section was enacted. At this particular time, is that the law should remain as is in regard to these kinds of programs until such time as the Members of the General Assembly, the various church groups, etc. etc. can get together and come up with some reasonable kind of standards etc. that would satisfy both points. That is all that we're doing here. We are taking out of the Bill what we put in and we're returning the law to what it was originally. We make no changes in regard to 'the licensing of what has been referred to as Mothers Day Out Program'."

Catania: "All right, so you're telling me that this is not going to leave totally unattended those centers that have children..."

Peters: "Correct."

Catania: "...for fewer than eight hours a week."

Peters: "Correct."

Catania: "Okay. Thank you, very much."

Speaker Ryan: "Is there any further discussion? The Gentleman from Wayne, Representative Robbins."

Robbins: "Mr. Speaker and Ladies and Gentlemen of the House, it's too bad that these things have to come up like this because Representative Peters had a very good Bill which would allow churches to house children and in a day care center where they can be properly taken care of, instead of spread out over the communities and homes that are not safe and are not addressed in anyway to this. I hate to see this Amendment adopted, I do appreciate the Sponsor's and Bowman's concerns on this but this is something that really does need to be addressed. And the main thing is the technicalities in the Fire, Health and Safety Code that is driving the churches up the wall on this. We do...they do

need an exemption on this and they do need to be licensed. So, I hate to see this Amendment adopted. I think we are doing a disservice to the many of the small communities in Southern Illinois which cannot support the kind of programs that is necessary. And it is creating nurseries to take care of children which are more totally illegal and are not near as safe as what we would have the other way. Thank you."

Speaker Ryan: "The Lady from Kane, Representative Zwick."

Zwick: "Thank you, Mr. Speaker. As a Member of the Committee that heard this particular Bill, I would like to rise in support of this Amendment and praise Representative Peters and Bowman for agreeing to this. As much as I agree with some of the concepts that were in the original proposal, there were some inherent problems that were brought to light in the Committee Hearing. And I know that they will be dealt with in the future but that this particular Section of the Bill was not the appropriate way to deal with them and that I'm sure that we will seek other legislation or other additions to this Bill which will correct those. So, I would just urge you to support this Amendment. Thank you."

Speaker Ryan: "Further discussion? The Lady from Sangamon, Representative Oblinger."

Oblinger: "Mr. Speaker and Members of the House. I too, support
Representative Bowman and Representative Peters. I've
worked in this field for a long long time and I hate to
have to say this to my seatmate, but part of my work was
done in southern Illinois. And down there the fire
marshall and the safety groups were very upset because
there were no general uniform rules for day care centers.
I think at this time we should leave it the way it is,
until we can work this out with all the organizations and

Again in concept, what we try to do in the Bill but as a result, we with varying and very have become embroiled in a sense strong opinions from the schools operated by the Christian Scientist people by the Montessori People, by various other christian groups by private groups by Pre-school people, all of whom have different points of view. Again, in Order to not get those issues embroiled with the bulk of this legislation which is really very progressive and strong and I have offered Amendment #7 which good legislation. returns this legislation to what it was originally without any changes. Peters: "The original law requires that ordinances relating to fire and safety must be adhered to. What we try to do by putting in the word 'Fire Marshal' and by giving the DCFS the right to call in, we then become embroiled in whether DCFS should have that right or whether a school

superintendent should have that right and whether DCFS should have that right with the Montessori Schools and so forth. Clerk Leone: "House Bill 544, a Bill for an Act to amend the Fish Code, Third Reading of the Bill."

Wolf: "Thank you, Mr. Speaker and Members of the House. House Bill 544 as was House Bill 405 is jointly Sponsored by Representative Yourell and myself. This amends the Fish and Game Code by providing that all the interest earned by money deposited in the Wildlife Fish and Game fund and the Salmon fund shall be deposited in those funds effective immediately and the Bill was amended. Originally the Bill called only for the Fish Code. It was amended to include the Wildlife and Fish fund and the Salmon fund as well. There was also a Section added that any interest received on the monies held in the Wildlife Fish fund or the Salmon fund will be deposited in those funds with reference to the Banking Act. - Clerk Leone: "House Bill 28, a Bill for an Act in relationship to the possession and use of firearms by convicted felons, Third Reading of the Bill."
- Speaker Ryan: "The Gentleman from Cook, Representative Cullerton."
- Cullerton: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. The law in Illinois with respect to the availability of a weapon for convicted felons says that a convicted felon has to wait for five years after he's released from the penitentiary before he can obtain a firearm owner identification card. What this Bill does, is to say that if that convicted felon had been convicted of a forcible felony and if he wishes to obtain a handgun that in addition.."

Speaker Ryan: "Just a minute, Representative. Alright, let's be

The noise level is awful high here. I think that we ought

to, Mr. Doorman, would you clear the aisles please.

Proceed, Representative."

Cullerton: "Thank you, Mr. Speaker. What this Bill says is that if a person has been convicted of a forcible felony that and he wishes to obtain a firearm owners identification card for a handgun that he has to wait the five years that he must wait right now and in addition obtain the permission of the director of the Department of Law Enforcement. It does not change the law with respect to one who commits a felony other than a forcible felony and it does not change law with respect to the obtaining rifles for the purpose of hunting. I would be happy to answer question if there are any."

Speaker Ryan: "Is there any discussion? The Gentleman from Cook, Representative Peters."

Peters: "Representative Cullerton, was Amendment #1 still on?"

Speaker Ryan: "Representative Cullerton."

Cullerton: "Amendment #1, Representative Johnson's Amendment?"

Peters: "It just doesn't indicate that but it refers to the fact

that an individual whose religious affiliation precludes

him from taking a photograph."

Cullerton: "Yes, this is, that Amendment was Representative

Johnson's Amendment. I would ask that he explain it. It

has to do with the Amish religious community in his area.

Representative Johnson has the answer, Mr. Speaker."

Speaker Ryan: "The Gentleman from Champaign, Representative Johnson."

Johnson: "Yes, Representative Peters, we received, as I think all of us in the district, received a communication from a number of people particularly law enforcement people in the, around the Arthur-Arcola area which is a heavy Amish

settlement. A good many, if not all of those people, the Amish people and some Menonites own firearms but because of a new interpretation by I guess the Department of Law Enforcement, they were required to have their pictures on all the firearm owners identification cards. Their religion prevents them, it's a very strict tenant in their religion from having their pictures taken and as a result we're trying to do by this Amendment what was done administratively before and that is to allow Amish people and others who can sign an affidavit under oath at the pain of perjury that their religion prevents them from having their picture taken to do that in lieu of having the picture appear on the front of the FOID."

Peters: "Representative Johnson, I'm not being picky here but is there some chance or is there any discussion in Committee or on the House and I'm sorry to say I don't recall the discussion on this. Could this possibly include groups other than legitimate religious groups like the Amish.

We're not talking about some kind of semi-terrorists kind of operation."

Johnson: "No, I think that the provisions of the Criminal Code require that the affidavits be made in pain of perjury and if somebody wants to take the chance of going to the penitentiary to fill out a false affidavit, they can do it. I understand your concern, but we talked to the staff and they felt this is the only we could address the problem."

Peters: "I accept your judgment, Representative."

Johnson: "Thank you."

Speaker Ryan: "Is there any further discussion. The Gentleman from Cook, Representative Kosinski."

Rosinski: "Mr. Speaker and Ladies and Gentlemen of the House, over the eleven years of my being in the General Assembly I have had two concerns. One, to protect the legitimate

person in his ownership of firearms but the second to prosecute with thorough vigor, those people who illegitimately and feloneously use firearms with the adoption of Amendments #3 & 4 which have been put on this Bill I think it's good for the people of the State of Illinois and I support it thoroughly."

Speaker Ryan: "Further discussion? The Gentleman from Cook, Representative Grossi."

Grossi: "Will the Sponsor yield?"

Speaker Byan: "He indicates he will."

Grossi: "Representative Cullerton, is any felon included or just those felons that have committed crimes with a handgun?"

Cullerton: "No, it's any person that has been convicted of a forcible felony."

Grossi: "Thank you."

Speaker Ryan: "Further discussion. The Gentleman from Bureau, Representative Mautino."

Mautino: "Thank you, Mr. Speaker. Will the Gentleman yield for a question?"

Speaker Ryan: "He indicates he will."

Mautino: "I'm sorry, Representative Cullerton, I missed one of the Amendments yesterday. I'm going to give you a hypothetical situation. Will you please tell me if it qualifies or does not qualify under the newly amended House Bill 28? Let us assume someone was convicted of a felony. It was a gambling charge. Now you have removed from this Bill the previous provisions for obtaining a FOID card on the five year basis according to the analysis. Now, that person be deprived of getting an FOID card or owning a firearm under your provisions of the Bill as it now stands? Thinking seriously that he did not, he was not confined to a penitentiary etcetera but he had a sentence."

Cullerton: "No, this Bill does not apply in that case because

you're describing a felony which is not a forcible felony and therefore, current law remains as it is would apply in that particular case. He has to wait five years and then he gets it automatically."

Mautino: "Okay, thank you."

Speaker Ryan: "Further discussion. The Gentleman from DeWitt,
Representative Vinson."

Vinson: "I move the previous question."

Speaker Ryan: "Would you hold that. I think there is only one more, Representative. The Gentleman from Cook, Representative Levin."

Levin: "Thank you, Mr. Speaker. Will the Gentleman yield for a question?"

Speaker Ryan: "Would you yield, Representative? He indicates he will."

Levin: "Okay, Representative Cullerton, you indicated in your explanation of the Bill that the person would be required to obtain the permission of the director of the Department of Law Enforcement. Are there any standards that the director would have to apply in making his determination whether to grant permission?"

Cullerton: "Yes."

Levin: "What are those standards?"

Cullerton: "First of all he has to have been granted relief by
the appropriate federal authority which is required by
federal law. The circumstances regarding the conviction
are reviewed. The applicant's criminal history and his
reputation have to be such that he will not be likely to
act in a manner dangerous to public safety. That's in the
Bill."

Speaker Ryan: "Is there any further discussion? The Gentleman from Cook, Representative Cullerton to close."

Cullerton: "I would ask for a favorable Roll Call and remind

everyone that Representative Kosinski has given us his impromanter on this good law and Order Bill."

Speaker Ryan: "The question is, shall House Bill 28 pass? All in favor will signify by voting 'aye', all opposed by voting 'no'. Have all voted who wish? Have all voted who wish? Take the record, Mr. Clerk. Leon, 'aye'. On this question there are 153 voting 'aye', none voting 'no' and this Bill having received a Constitutional Majority is hereby declared passed. House Bill 33, Representative Neff."

Clerk Leone: "House Bill 33..."

Speaker Ryan: "Mr. Clerk, on House Bill 28 would you record Representative Pullen from the gallery as voting 'aye'. Representative Giorgi wants to be voted 'aye' too. object to that Representative Kane? There's a bit of objections of Representative Giorgi's vote. Representative Kane objects. You'll have to fill out a form I guess. Pullen from the gallery. House Bill 33, Representative Neff. Out of the record. House Bill 38. Out House Bill 45, Terzich. Read the Bill." record.

Clerk Leone: "House Bill 45, a Bill for an Act to amend the State
Employees Group Insurance Act, Third Reading of the Bill."
Speaker Ryan: "The Gentleman from Cook, Representative Terzich."
Terzich: "Yes, Mr. Speaker and Ladies and Gentlemen of the House.
House Bill 45 amends the State Employees Group Insurance
Act by increasing the state's contribution for Employee
Dependent Health Insurance coverage from seven dollars to
twenty dollars per month effective in the next fiscal year.
The reason for the introduction of this Bill which is
similar to House Bill 426 which we passed in the last
General Assembly was that the dependent contribution for
the health insurance of seven dollars became effective
during the fiscal year of 1975 and since that time has not
been increased or changed during interim. During the seven

years, the cost of Dependent Health Insurance has increased dramatically from the high option 166%, 182% with two dependents, 43% on the low with one dependent and 189% with two or more dependents. As a result of these costs I want you to realize that these statistics are very shocking. The employees have altered their coverage for dependents. In the fiscal year 1975, 88% of the employees enrolled for the high option of dependent coverage, enrolled in 1975. As of 1981 this has decreased 40% because of the high cost of the group insurance. In addition a survey of the State Realth Plans by Martin E. Segal Company showed that ten states now pay 100% of the employees and dependent health premiums compared to five and seventy-six. Also there are four states which pay 90% to 100% of the dependent premiums. Four of them from 75 to 90% and seventeen from 50 to 75%. There are only two states that pay less than 33% and that is in Illinois. Now the General Assembly to give an example that the premium is \$100 a month which constitutes 5% of your gross salary. The employees cannot afford this. The health care costs continue to rise and is taken out of the reach of our employees and I would urge support of House Bill 45 for all the employees in the State of Illinois."

Speaker Ryan: "Is there any discussion? The Gentleman from Cook, Representative Telcser."

Telcser: "Well, Mr. Speaker and Members of the House. It's always difficult to rise on a Bill like this. Especially when one knows how sincere the Sponsor is in helping raise the quality of health care for a good number of citizens in Illinois. I might also point out that this is probably going to be one of the first Bills of many we're going to hear during the course of the Session that are going to be well intentioned, be for a good purpose but yet cost the

State of Illinois millions of dollars far beyond our ability to pay the Bill. House Bill 45 would cost the state some eight and a half million dollars more than we are in a position to spend. Mr. Speaker and Members of the House, I think it would do us well to remember the message the voters sent to all of us last November. The voters They don't want us to hold the line on spending money. want to pay more taxes. They don't want more programs. They're not necessarily looking for more benefits that will increase taxes for all of Illinois' citizens. It is Bills like this which cumulative in their totals cost the state millions and millions of dollars beyond our ability to pay. Now, Mr. Speaker, Members of the House, it is for this House Bill 45. reason that I rise to oppose I do so because we simply do not have the money to pay the Bill. Hember of this Legislature who introduces Bills that cost the state money beyond their ability to pay ought be introducing tax increase Bills also. accompanying measure of this type to House Bill cannot afford the eight and a half million dollars which House Bill 45 would cost the citizens of Illinois. T+ is for that reason, Mr. Speaker and Members, that I rise to oppose the Bill and urge the Members to recognize the dire fiscal condition in which we find ourselves and to join me in a 'no' vote."

Speaker Ryan: "The..Further discussion? The Gentleman from Whiteside, Representative Schuneman."

Schuneman: "Thank you, Mr. Speaker. I rise in opposition to this
Bill, not because I don't think the state should do
something about raising the support for dependent insurance
coverage, but rather, along the same lines that
Representative Telcser has just addressed, and that is,
that this is not the time, this is not the time in the

financial life of the State of Illinois when we can afford to do something like this. There's another point involved here and that is that the proponents of this Bill normally describe the great increase in costs that have been faced by our state employees for the high option that they carry on dependents and I'd like to point out that not only for those other state employees, but for those of you who are Members of the General Assembly, that the state probably should add some emphasis to the bargain that we can get by carrying the low option that is available on the state group employees' insurance. I think that this Bill perhaps would be a good Bill sometime later when the financial condition of the state is better than it is now. But this is not the time. I think we should defeat the Bill."

Speaker Ryan: "Is there any further discussion? The Gentleman from DeWitt, Representative Vinson."

Vinson: "Thank you, Mr. Speaker and Members of the House. serve on the State Employees' Group Insurance Commission. One of the problems that we have faced in the past month is that the new bid by Blue-Cross for the contract has raised the premium rate to the state 26%, 26% in one year, some 25 to 27 million dollars is what they want to take off the existing benefits. Now, we're in a position where we had to rebid the program and very probably we're going to be in a position where we have to cut the existing benefits to the employee. Our first obligation is to the employee. And to take eight million dollars and to put that into dependent coverage when we may need that to protect employee coverage would be a terrible mistake. Employees of the university system, employees of the personnel system across the street, as a matter of fact, General Assembly Members are covered by this system. And to take the money away from the employees and to give it to dependent

coverage would be a very bad mistake. I would urge a *no* vote."

Speaker Ryan: "The Gentleman from Cook, Representative Wolf." Wolf, J.J.: "Thank you, Mr. Speaker, Members of the House. Frankly, there's really nothing wrong with House Bill 45, I must reluctantly rise in opposition. sa∀ One is I can reluctantly for two reasons. see the necessity for such a Bill and in better financial times would probably be here in support of it. The second is that I regard the Sponsor of this Bill as one of my truly good friends of this House and one which I have the utmost respect for. But as Chairman of the House Appropriations Committee, I have to get up and tell you we have a tremendous job. We're looking to cut some 220 million dollars out of state agencies at this particular time. haven't even begun to get to the human services area yet where they're going to be talking about cutting back on prescription pharmacies for people in need, the education the mental health needs and all of the other needs. agencies in which all of us I am certain have some kind We have a problem with roads interest. special crumbling, with mass transportation problems, and we can't at this time afford additional money taken out of the State Treasury to afford this program. Those of you who have been here a few years as I have recall when the state teetered on the brink of financial ruin with practically up from that and nothing in the Treasury. We came established some kind of a year end balance at the end of the last Session which would take care of the state's bills for approximately fifteen working days. We're heading in a downward trend. We know we're going to get more federal cutbacks. We know the economy of the state has not been what it should be. Sales tax receipts have leveled off and 28th Legislative Day

have gone down because of certain tax relief that we've issued. Mr. Speaker and Members of the House, I ask you to sensibly address yourself to this Bill. Hopefully next year or in the next Session we could pass such a Bill, but I ask you to exercise fiscal restraint. Help us do our job. Help us end up in the black and have a balanced budget in the Eighty-Second General Assembly. Thank you."

Speaker Ryan: "Is there any further discussion? The Gentleman from Cook, Representative Piel."

"Thank you, Mr. Speaker. I move the previous question." Piel: think that will be necessary, Speaker Ryan: "I don't We've only got one more. That's Representative. Representative Bradley. Could you hold that for a minute? Representative Bradley."

Bradley: "Thank you, Mr. Speaker and Ladies and Gentlemen of I'm standing here quite amazed that of all the speeches we had on this piece of legislation offered Representative Terzich. every person that spoke was opposing the legislation. There is probably no greater way that we can help the state employees than to help them in and health and hospitalization their hospitalization There's no greater cost that has skyrocketed and caused inflation than the rapidly increasing costs medical hospitalization costs to the workers of the state and to everybody else. It seems to me that this would one small way that we, as Members of the General Assembly, can show our concern for the state employees, for all state employees and help them in some small way. Because if the Governor of the state continues to cry wolf as he's doing insofar as the appropriations and the revenues that are going to be generated ... the State of Illinois, there won't be any financial increases to state employees. This Bill at least gives us one small way that we can make some

of a gesture to the employees of our sincerity in appreciation of that work. And I urge an 'aye' wote."

Speaker Ryan: "The Gentleman from Cook, Representative Terzich, to close."

Terzich: "Mr. Speaker, Ladies and Gentlemen of the House, I am really and truly surprised at those people who spoke opposition of this Bill because they're speaking out of both sides of their mouths, that these Bills have been before which they didn't support. Last year we were so fortunate to pass the Bill which the Governor vetoed which was an additional seven dollars. The health care costs is increasing at a substantial rate yet our employees cannot even afford to participate in their own group insurance plan because they can't afford the premiums. There's been no effort on the part of the administration to come up with a suggestion or a recommendation. How about putting our employees in the black rather than the red when they get their hospitalization bills and they can't afford to participate in the program? How about tending to the needs of our employees just as well as other needs throughout the state? And this Bill is a Bill that is necessary. The employees have been neglected for their group insurance. They've...We've reneged before on this. This is a small amount and we're one of the lowest participants in the United States on helping the employees afford a practical health insurance plan and we're taking it away from them by neglecting their needs. So let's take a look at it. If there has to be a reduction, then fine. Let the administration come back and reduce it. But is a minimal request. It's needed. If you take your own self that you have to pay five percent of your salary just buy the dependent high option health insurance, that's ridiculous. That's ten percent or fifteen percent of

employee who is only making \$12,000 a year that he has to pay for his group hospitalization plan. There's no one in this House that can afford it. So why not give our employees a break. It's a reasonable request and it's been endorsed by the Group Insurance Commission, has endorsed the idea of increasing the contribution. The 27% increase in rates I will guarantee you that it will go back to the dependent insurance because in the previous years all these big increases were on the dependents, not the employees. There were five percent, two percent and the state said, We're going to pick up the two or three 'Oh, big deal. percent, but they passed a 20 and a 30% increases on the employees. So let's give...let's give a break here and let's make the people be able to afford a good viable health insurance plan by supporting House Bill 45."

- Speaker Ryan: "The question is, 'Shall House Bill 45 pass?' All in favor will signify by voting 'aye' and all opposed by voting 'no'. The Gentleman from Marion, Representative Friedrich, to explain his vote."
- Priedrich: "Mr. Speaker, this Bill certainly has an emotional appeal and it's pretty difficult to vote against it. It's kind of like being against motherhood. But, my analysis shows that it will cost some eight million dollars and it will only help a third of the state employees. Now, certainly state employees have ..are entitled to some consideration, but when we're trying to cut another 200 million dollars out of the budget, I think the best we can hope for is to save some of the existing programs and save some of the jobs otherwise, some of these people who won't have insurance, they won't have jobs either. So, I think that's where we go. But I think it bothers me a little when the Gentleman who's sponsoring this Bill turns a deaf ear when I start talking to him about the widows and some

retired school teachers that are trying to live on \$100 a month. He's deaf when it comes to that. But on something like this, apparently he speaks out very vocally."

Your legislation if it's adopted and signed by the Governor could result in another couple of thousand. That could be five thousand people out of a job with maybe 40,000 people getting a few extra benefits and I don't think it's worth it and I think I can explain that to my constituents back home and I ask for a 'no' vote."
- Speaker Ryan: "Have all voted who wish? Have all voted who wish?
