Darrow: "Mr. Speaker, perhaps for a point of personal privilege. Today will be Representative Ben Polk's last day as Member of this General Assembly. I don't see the Gentleman in his chair. I don't know if he's going to call this to anyone's attention, but I just wanted to say that, since 1973, Representative Polk and I have campaigned in the 36th Legislative District. At times we were opposed. we were together; but, once the election was over with. we took the bumper stickers off and we worked for the district. Speaker Ryan: "Representative Lechowicz."

Lechowicz: "Thank you, Mr. Speaker. The Gentleman from really served, not only that district, but the entire state very, very well, and I want to commend the Governor and the Republican Party for selecting a man who has compassion, has shown the tremendous degree αf compatibility and the ability of putting together good legislation for the entire State of Illinois; a man who has really taken the concerns of his district and improved the betterment and life for everyone in Illinois. I know, in that capacity, as a Legislator, he has shown that he the ability to put together coalitions, to put together understanding, to put together a betterment for here. And I know, as far as in this capacity as the

Assistant Director of that Department, probably one of the most important Departments in State Government, a segment of our population in the State of Illinois is getting older. An alliance was forged, at point. with Representative Allen Bennett and Representative Len Martin, who came in; and, I think, that point, Ben, Len, and Allen and I were the original gang of four. And we were inseparable that first term, and Representative Martin has gone on to higher office and glory elsewhere. Representative Bennett is still around on a part-time basis. We do see him frequently. I'm only pleased that Ben is still going to be in Springfield so that we can get together and continue, on some basis, the gang of four, now only it's the gang of two. Ben at the orientation session for Legislators, and we became friends at that time. And I can recall Ben sponsoring legislation that didn't pass, but it was a very good piece of legislation. He said, 'During all our trials and tribulations in this Body, we need someplace in Capitol where we can all sit down and look to God to help solve some of these problems, and he sponsored legislation for a non-denominational chapel in the Capitol. It didn't pass, but it was a very good idea, and that's the type of person that Ben is. So, Ben, I wish you well in your new duties. I know you will do well, and all the Members of the General Assembly hearts will be with you, when you assume your new duties."

Speaker Byan: "Representative DiPrima."

DiPrima: "Yes, Mr. Speaker and Ladies and Gentlemen of the House,
when I came down here 20 years ago, I rummed with the late
and beloved Pete "Granada" and Louie "Capuzi". We shared a
suite together in the Abe Lincoln; and, ever since then,
I ve always considered myself a Republicrat. And the
closest thing to myself; I always considered Ben. Ben is
so neighborly here. Really the best. The best to you."

Speaker Ryan: "Representative Bullock."

Bullock: "Mr. Speaker, what Ben Folk doesn't know is that we're trying to filibuster so he can't speak. I want to say, Mr. Speaker and Ladies and Gentlemen of the House, before I came to the Legislature, I was in the third house and I got

to know Ben Polk then, as a lobbyist. But I think that the testimonial remarks #6, 46 had here today from the colleagues are sincere, and I think that all of recognize the high esteem in which Members of this Body hold Ben Polk. My personal experiences with Ben have been such that I have great admiration for him. When I came to the Legislature, I remember, on several occasions, I became quite vociferous and interested in legislation that did not pass. And I think, perhaps, Ben Polk, in a mild sort of way, is responsible for me tempering some of my enthusiasm, because I never will forget when I lost a Bill, and I was highly indignant and upset, that Ben Polk came to me and he gave me advice. And he was sincere and he was genuine. In the time that I've known Ben Polk, I guess can best described - so many of us on the campaign trail make remarks, and we say that politicians look forward elections after elections and statesmans look forward to the next generation. I think Ben Polk is a statesman. I think that the Governor has done himself well. I think the Republican Party has something to be proud of, of a partisan politician, when he has to be. Speaker Ryan: "Representative Giorgi."

Giorgi: "Mr. Speaker, inasmuch as this is go... all going into the record, I'd like to put something in the record about how great a guy I think Ben Polk is. You know, I'm a little about out-spoken about some of the things we do on the floor of this House, but I talked to Ben about a ... something that was wrong in the marketplace for the last hundred years, and that was that all over the State of

And I've got to say, Ben, you're a man of your convictions. I'm proud here to be giving you plaudits."

Speaker Byan: "Representative Kulas."

Kulas: "Mr. Speaker, Ladies and Gentlemen of the House, the Royal Order of Mushrooms is losing one of their top spores today. Representative... Representative Polk has always been a faithful and dedicated mushroom. Thanks to you. Mr. Speaker. And I would just like to say, Ben, that when... in your new position, don't forget about us poor and try to shed a little light upon us, once in a while." Speaker Ryan: "Thank you, Representative Kulas. Representative Polk, the plan has worked well. We now have Darrow, McClain, Lechowicz, Jones, Bullock, Kulas, DiPrima and Giorgi all on tape and testimony for you, which will lead the way well for your candidacy for the Illinois Senate against Clarence Darrow. I'll have those records for you in just a little bit. I think it's all been said about Ben Polk. He is certainly a gentleman's gentleman, has served me well in my Leadership, and I know that he's going to continue to serve the government and the people of Illinois well. Ben Polk, for your comments."

Polk: "Mr. Speaker and Ladies and Gentlemen, this... I understand why Ed Bluthardt left early, and I was back in my office

admit that I was wasn't coming out. I will approached by about six secretaries and said you will go to the floor. I appreciate the comments. I have nothing prepared. But this is a group of people that bond together and, although; we have our differences on the floor, when we get off of that floor, I think I've found such great deal of friendship from people from the City of Chicago who.... you are completely different people from where I come from. And yet, we've been able to work together and to socialize together. And my people and my friends from downstate say the very same thing. From the people who have come from southern part of the state, it's a different ... it's a different locality than where I come from: but. fraternity within itself bonds people together. It isn't a simple thing to walk out of here this afternoon. I'll be back and see you many times. I thank you all, one and all, for what has been said here today, for my family, and look forward to working with you in the future. It's not all over. I'll be around. Mr. Speaker, thank you."

Speaker Ryan: "Thank you, Representative, very much. I'd be anxious to see how you fare in the first appropriations encounter. Representative McGrew."

McGrew: "Thank you, very much, Mr. Speaker. Just a point that I would like to make for the Membership. In attempting to

Speaker Ryan: "We'll probably be out by the 15th of June anyway,

Representative. It won't..."

McGrew: "I hope you're correct."

Speaker Ryan: "Representative Friedrich."

Friedrich: "Well, Mr. Speaker, I'm kind of concerned because,
apparently, the way that you can get that many plaudits for
resigning — we may have a mass resignation around here."

Speaker Ryan: "Not a bad idea. Representative Hoxsey."

Hoxsey: "Yes, Mr. Speaker, I would ask leave to suspend the posting notice requirement, Rule 18E, so that House Bill 2493 can be heard in the Appropriation Committee on Tuesday. The original posting notice contained a typographical error, which omitted the Bill, and House Bill 2493 is sponsored by Representative White. It's my understanding that this is agreeable with the minority."

Speaker Ryan: "Lady asks leave to suspend the appropriate rules to have..."

Hoxsey: "House Bill 2493."

Speaker Ryan: "...House Bill 2493 posted properly. Are there any objections? Hearing none, leave is granted."

Hoxsey: "Thank you."

Speaker Ryan: "Representative Telcser, for adjournment."

Telcser: "Mr. Speaker, I now move the House stand adjourned until Monday, 4:00 p.m., May 3rd."

Speaker Ryan: "Allowing five minutes perfunctory time for the Clerk, the Gentleman moves that the House now stand adjourned until the hour of 4:00 o'clock p.m. on Monday.
