Bless the Governor, the Leaders of this House, all the Representatives, and the people of Illinois. Speaker Ryan: "Representative Kociolko will lead in the Pledge."

Kociolko et al: "I Pledge Allegiance to the Flag of the United

States of America and to the Republic for which it stands,

one nation, under God, indivisible, with liberty and
justice for all."

Speaker Ryan: "Roll Call for Attendance. Representative Greiman, for what purpose do you seek recognition?"

Greiman: "Well, Mr. Speaker, for actually a question that has

been on my mind the last few days. I have noted over the past week that a team of about seven armed folks in uniform have been guarding the chamber, that they have been in the back hall here, up there, usually up there now, outside. There is a team of about seven. I have always relied on those wonderful men in red jackets to watch our doors. Are we in peril? I recognize that under...under four....Rule 4K, you have the general supervision and duty to protect the security and safety of the House chamber. Are we in peril that I don't know about?"

- Speaker Ryan: "I would imagine a fellow like you with your voting record is probably always in peril, Representative Greiman."
- Greiman: "Well, but I can defend myself. Somebody my size can defend themselves."
- Speaker Ryan: "However, I would suggest that you speak to your Minority Leader before you quote the rules to me. Representative Madigan."
- Madigan: "Mr. Speaker, thank you for this rare opportunity to see you and to talk with you. And..."
- Speaker Ryan: "You mean besides in private."
- Madigan: "And in your defense, Mr. Speaker. Mr. Greiman, actually, I was the one who suggested to Mr. Ryan that we might improve our security around the chamber. This happened immediately after the assassination attempt on Pope John. And at that time I suggested to the Speaker that we might be well advised to improve our security around the chamber. He agreed, and I believe that he contacted the Secretary of State's office to do just that."
- Speaker Ryan: "Representative Greiman, I might add to that. Not only did Representative Madigan approach me with that, but several Members from your side as well as my side talked to me about that. Representative Greiman."

Greiman: "If I might just have an opportunity to comment. I...agree with my Minority Leader on many issues like statewide grand jury and things like that, the great issues of the day, but I can disagree with him on this issue and disagree with the Speaker on this issue. I don't think that we should...each time there is some world thing that occurs, assume that we're going...we're in some kind of peril. I haven't found any State Representatives yet that have been the object of assassinations or anything like that, and I think that I find my...well, you can down if you want, but I find that when we are in this free society and we require armed guards in both of the balconies, that this is indeed a sorry day for democracy and for open expression and for freedom. Too many people in Parliaments long gone complained about the notion of armed people around the Legislature. And I would ask that you rethink that, Mr. Majority Leader ... I mean Mr. Minority Leader, and Mr. Speaker, and perhaps remove the armed guards from our midst."

Speaker Ryan: "Take the record, Mr. Clerk. 167 Members answering the Roll, a quorum of the House is present. Representative Vitek."

Vitek: "Mr. Speaker, a point of privilege. I don't know where Greiman was the other night when we...Conti got up and expressed that one of our lobbyist who is a good friend of both sides of the aisle had a knife stuck into his stomach out in the parking lot. And that helped bring the armed guard situation up and also lighting all around the Capitol while we're in Session. For your protection when you go down to the car, it will be lit up so you won't get a knife stuck into your fat belly."

Speaker Ryan: "Introduction and First Reading of House Bills."

Clerk Leone: "Amendment #2 was tabled in Committee. Floor
Amendment #3, McClain, amends House Bill 447..."

Speaker Ryan: "Representative McClain on Amendment #3."

McClain: "Thank you, very much, Mr. Speaker, Ladies and Gentlemen Amendment #3 to 447 adds a little over a of the House. million dollars to the appropriation. Right currently, indigents that appeal in the State of Illinois, the state pays for the indigent appeal for all counties except for Cook County. Cook County, about a third of their indigent appeals are paid for by the state dollars. This was pointed out to me by Herman 'Nell' and I agree with him that that's unfair. And so, all this does is equalize Cook County with the way they treat all their counties in the state. And I would move for the adoption of Amendment #3."

Speaker Ryan: "Is there any discussion? Representative Wolf."
Wolf,J.J.: "Yes, Mr. Speaker, Members of the House, all this does
is add 1,175,824 dollars to the appropriation. I'm going
to urge people to vote against this. You know, we've been
working. There's a number of Amendments coming up here
today. There's a total out to over 133,000,000 dollars of
additions. The Appropriations Committee has been working
diligently, working long, hard hours. We were able to find
105,000,000 dollars to take out and some of those cuts were
very painful. Most of these Amendments we're adding on
today are strictly budget-busters and I hope everyone will

vote 'no' on this Amendment. It's money we just can't afford."

Speaker Ryan: "Is there any further discussion? Representative Telcser."

Telcser: "Mr. Speaker and Members of the House, Amendment #3 comes to me as quite a surprise. The Gentleman who's offering the Amendment is my, I believe, my principle Cosponsor on House Bill 447 and we discussed at this some at length, and I think...I thought that we had some understanding that the agency was not in favor of this additional fund I, perhaps, may have been in error. Speaker, Members of the House, I find it somewhat bewildering that the downstate leader on the other side the aisle would be offering this Amendment to bail out some funds for Cook County. Now, the Cook County people who are interested in this Amendment spent little, if any, time talking with me about the offering of this Amendment and the spending of this additional money. Mr. Speaker and Members of the House, everyone knows how this agency is funded and what their individual responsibilities are. come down to the Assembly in the closing weeks of the Session and try to grab an extra million and a half dollars only for Cook County certainly isn't fair to the agency, nor is it fair to the taxpayers all around the state. Amendment adds excessive dollars to this particular agency. And for those reasons, Mr. Speaker and Members of the House, I rise to oppose it."

Speaker Ryan: "Is there any further discussion? Representative McClain to close on the Amendment. Representative Currie, did you seek recognition? I didn't see you. Go ahead."

Currie: "Can you... Thank you, Mr. Speaker, Members of the House.

It seems to me that if the concern about the budget that
both Representative Wolf and Representative Telcser are

addressing is very real, we would, instead of this kind of an Amendment, seek one in which they would be reducing the expenditures that right now go only to downstate counties. It seems to me that if we are concerned about finding places to close up expenditures that are not, in fact, necessary, for you to argue that equity is not relevant in Representative McClain's Amendment is exactly the wrong tact to be taking. And I would feel that your sincerity would be a good deal more clearly put on the line if either of the Gentleman who spoke against this Amendment were instead offering this House an Amendment to reduce this appropriation by the amount that downstate expenses are, in fact, picked up by the State of Illinois, rather than by opposing Representative McClain. I'm going to vote 'yes' on this Amendment and I hope the other Members of this House will too."

Speaker Ryan: "Is there any further discussion? Representative McClain to close."

McClain: "Thank you very much, Mr. Speaker. Ladies and Gentlemen of the House, I'd like to bring out three things if I can. First of all, neither the Appropriation Chairman nor the Majority Leader should talk about holding the line on the budget. In the Mental Health budget alone, they passed out a five million dollar Amendment onto the Mental Health appropriation that was not in the Governor's budget. they can't really talk about always that the Governor's budget is sacrosanct and that it should never be amended. Secondly, Mr. Telcser, if you recall our discussion, there was some confusion on what you meant by 'agency'. And I let you off the hook on your word because of that confusion and we did not have any trouble there. I did not take any personal affront at that. It was just confusion on our word. And so... But for you to say that a downstate leader

is supporting this Amendment. I think all downstater's should support it because all we're talking about is All downstate counties now ... The indigent appeals are paid for by the State Appellate Defender's Office. Only in Cook does a third of the appeals ... be paid for bv the State Appellate Defender's appropriation. Two-thirds are paid for by the county taxpayers. I think that's inequitable. I think this is a fair, equitable Amendment. I think everybody in the House ought to be in favor of it, but don't start talking to me about holding a sacred budget in line because you're own majority-held appropriation budget passed on an Amendment of five million dollars for the Mental Health that was not in Governor's budget, just a bludgeon to the Director of Mental Health. So I'd ask for a favorable vote."

Speaker Ryan: "The Gentleman asks for the adoption of Amendment #3 to House Bill 447. All in favor will signify by saying 'aye'; all opposed by saying 'no'. Relax, Mr. Getty. It's too early to get excited. You too, Madigan. The Gentleman moves for the adoption of Amendment #3 to House Bill 447. All in favor will signify by voting 'aye'; all opposed by voting 'no'. Bartulis, 'no'. Have all voted who wish? Have all voted who wish? Take the record, Mr. Clerk. On this question there are 65 voting 'aye', 82 voting 'no', and the Amendment or the Gentleman's Motion fails. Further Amendments?"

stuff done. We've got 150 Amendments to do..."

Schneider: "Thank you, Mr. Speaker, Members of the House. Amendment #5 takes its direction from the Republican appropriations Subcommittee and which originally recommended a reduction in operations to a level 16-2-55. Working with other Members of the House. agreed that that was an appropriate figure, and part of the rationale relates to the notion that there will be some decreases for some public personnel teaching in otherwise, at university levels, for example, to take their pay increases later in October. So the operations budget, as you see it in this Amendment, offers to the House for its adoption a lesser figure than came out of the Appropriations Committee, but one that was originally a recommendation of the Subcommittee. Davis: "Well, thank you, Mr. Speaker. The Subcommittee Chairman, Mr. Wikoff, is absolutely right. There was a point of departure Amendment in the Subcommittee, and through further negotiation I must inform those of you who have talked to all of the people that came to see you, that Representative Schneider's Amendment also includes decrease for the summer internship programs for those young students who have particupated in that. You must remember that in the intensive negotiations that took place after the Subcommittee had acted on that particular morning, the full Committee then adopted the additional increases to the budget. It still is some 40% below the new money that was in the operations budget. And this agency, regardless of what all of us think about it from time to time, is still the agency that is charged with the responsibility of monitering 2.8 billion dollars of the state's money and how it is spent programatically and how it needs to be spent

and how it is misspent. So I suggest to you that money spent in operations at this level is an adequate and complete amount, and I certainly would resist the Amendment and suggest you vote 'no', because this is the very agency that is protecting the major balance of dollars."

Speaker Ryan: "Representative Satterthwaite."

Satterthwaite: "Mr. Speaker, will the Sponsor of the Amendment yield for a question? Glen, would you repeat again since some of us were just coming in, your Amendment is a reduction in the operation of the Office of Education budget? Is that accurate?"

Schneider: "In the operations portion, correct."

Satterthwaite: "And what...by what total amount would that be reduced?"

Schneider: "The total is three hundred, I think, and seventy-eight thousand. 358. Thank you."

Satterthwaite: "358,000?"

Schneider: "That's right. It is consistent with my attitude to
evaluate programs that are not service programs and to
restore monies in things like special ed, transportation,
gifted, and so on."

Satterthwaite: "Mr. Speaker, if I may then address the Amendment.

It seems to me rather unusual that the Republican administration which has been extremely critical of the operation of the Office of Education in the past would not be supporting this Amendment, and I would urge a supportive vote for the Sponsor of the Amendment."

Levin: "George."

Speaker Ryan: "Representative Levin."

Levin: "I rise in support of this Amendment also. I think that where there is waste in the bureaucracy, and we've been hearing from the other side of the aisle about waste in government and how people don't want to pay higher taxes.

But here we have an example of a substantial amount of waste in the State Board of Education, positions that they don't need, money that can be used to either reduce taxes or better fund programs for the school systems. I think this is an important Amendment. I know it is one of many that will be focusing on waste in the bureaucracy, getting rid of the fat. And I urge your support, be you a Democrat or Republican, of this Amendment."

Speaker Ryan: "Representative Schneider to close."

Schneider: "Thank you again, Mr. Speaker and Members of the House. I think it is pretty clear that what we're looking at in terms of education as a budget that will provide the services for the children of the State of Illinois in a variety of programs. It is true the State Board monitors and observes and sometimes offers program advise to the Legislature and other educational units throughout the state, but I think if we're going to make some reductions at all that this is the appropriate line to do it on, then we can begin to look at other kinds of programs as we progress through the next four Bills. So I would ask that you support the reduction to Amendment...Amendment 5."

Speaker Ryan: "The Gentleman moves for the adoption of Amendment #5 to House Bill 491. All in favor will signify by voting 'aye', all opposed by voting 'no'. Have all voted who wish? Wolf (J. J.): "Ladies and Gentlemen of the House, I would like to make an introduction as Representative Tony Miles from the Indiana House of Representatives who is here in Springfield tonight to give a talk at the Museum on drug pushing from

I hope some might attend. I would like to socialize with you further. I sort of came over here to see why you're still in Session and we adjourned by April 30 and had reapportioned. What's wrong? But again, it is my...it is my pleasure to be here, and you're welcome in the Indiana State House at any time and any imformation or aid I might give you, please call. Thanks again for having me."
- Wolf: "While I'm up here, one more introduction. I just noticed up in the gallery is one of our former colleagues, John 'Gredamen' up in the gallery. John. He used to have the banana concession down here. The Gentleman from Johnson, Representative McCormick."
- McCormick: "Well, you forgot your old buddy, Doc Springer.

 You've been down there eating off of him every summer for years."
- Wolf: "Where is Doc Springer? Here he is right down here. Doc Springer, former colleague."
- Speaker Ryan: "Further Amendments on House Bill 491."
- Clerk Leone: "Floor Amendment #6, Schneider, amends House Bill 491 on page 21 line 27 and so forth."
- Schneider: "Thank you, Mr. Speaker and Members of the House.

Stuffle: "Yes, Mr. Speaker and Members, this Amendment is an attempt to put back in this appropriation Bill only the amount of money that would have been there had we continued the appropriation for the school aid formula distributive fund at the amount of the Governor's original requested \$90,000,000 allocation for elementary and secondary education. I think it is important to note on this particular Amendment that if we were to restore the amount of money in this Amendment, we would indeed be at the original allocation level, not at the SBE's first represents only a 2% increase in the formula distribution from last year. I believe if you go back and look, that is the lowest increase in this state in at least a decade for the formula distribution. Let me show you what's happened here so far. We hear a lot talk about how we're going to make cuts in operations in order that we can justify increases in grants. Great. \$9,800 in cuts. Now, the Gentleman who offered this Amendment, and I'm not questioning his sincerity, but has constantly put Bills before this Assembly increasing pension benefits by millions of dollars, and I submit to anybody with an ounce of common sense, where are we going to get the money from? We are committed to a balanced budget to keep Illinois in the black and keep us solvent,

Terzich: "No, let's move the previous question. One more or two more, I move the previous question. All in favor will signify by saying 'aye', all opposed 'no'. The 'ayes' have it, and the Motion prevails. Representative Stuffle to close."

Mr. Speaker and Members. I hope that the Stuffle: "Yes. Republicans look at what the Democrats, at least this Democrat and some others, are willing to do with regard to budget cuts on other Bills. Schneider: "Well, Mr. Speaker and Members of the House, this proposal, I thought, was doing the Governor's work. were talking about the...the direction the Governor wants to go is to force the local taxpayer to pick up the catagorical programs, increase the taxes locally, and drive some credit from advancing more funds through the per pupil quarantee into the districts. So I think that is pretty much the motivation of the Governor, and I sense that those of us on this side of the aisle, at least, who appreciate the difficulties of other kinds of catagorical grants can also vote for this as well as those grants. We cannot continue, as the Governor has done in the last four years, to back away from our Constitutional obligation. That is to provide 50% or more of the educational funding responsibility for education. So what we're seeing here is that an effort to, as you'll see in subsequent Bills, an effort to place the costs of education back in the locals. Look at the last four years. We have moved from about 47% at the arrival of the Governor down to about 42 or 43% of state responsibility. Inversely, the the responsibility has increased. So I think we're in line, in

part, with what the Governor wants. That is to give more money to distribute statewide for those districts. I can't understand: why there would be any rejection or resentment about an Amendment that conforms, at least if you look at the next Amendment, to the intent of the Governor."

Speaker Ryan: "Representative Hoffman, one minute to explain your vote."

Hoffman: "Thank you very much, Mr. Speaker, Ladies and Gentlemen of the House. We cannot look at this Amendment by itself.

It has to be looked at in relationship to everything else and the bottom line. I am inclined to think that this is a number where, for the general distributive fund, we ought to end up. But until there is some agreement on where those resources are going to be moved away from the catagoricals in the general distributive fund, I don't believe that we can support this until that agreement is arrived at."

Speaker Ryan: "Have all voted who wish? Take the record, Mr. Clerk. Representative Stuffle."

Stuffle: "I notice that there are 19 absentees, and I would like you to poll them please."

Speaker Ryan: "Poll the Absentees, Mr. Clerk. Mautino 'aye'."

Clerk Leone: "Poll of the Absentees. Abramson, Alexander..."

Speaker Ryan: "Representative Alexander 'aye'."

Speaker Ryan: "Third Reading. House Bill 493, Representative Steczo. Read the Bill, Mr. Clerk."

Clerk Leone: "House Bill 493, a Bill for an Act making appropriation to the State Board of Education, Third Reading of the...I mean Second Reading of the Bill.

Amendments #1, 2, and 4 were adopted in Committee."

Speaker Ryan: "Are there any Motions filed?"

Clerk Leone: "No Motions filed."

Speaker Ryan: "Further Amendments?"

Clerk Leone: "Floor Amendment #5, Braun, amends House Bill 493 as amended."

Speaker Ryan: "Representative Braun on Amendment #5."

Braun: "I would like to withdraw this Amendment."

Speaker Ryan: "Withdraw #5. Further Amendments?"

Clerk Leone: "Floor Amendment #6, Barnes - Keane, amends House
Bill 493..."

Speaker Ryan: "Representative Barnes on Amendment #6."

Barnes: "Mr. Speaker, Ladies and Gentlemen of the House, this Amendment would seek to restore some of the money that has been cut from the text book program. This...to fully fund the program it would take \$25,000,000. In the '79 - '80 fiscal year, the program was at \$11,000,000 leve.
\$9,000,000 was distributed through the public schools. 1.5

million dollars was distributed through the non-public schools. And what the text book program is, it gives a book per student from Kindergarten through 12th grade to every student in the State of Illinois."

Speaker Ryan: "Is there any discussion? Representative Wikoff."
Wikoff: "Thank you, Mr. Speaker. I hate to oppose the lovely
Lady down here, but we're talking \$9,000,000 in addition to
what is presently on the Bill. And as a very noted Senator
said one time, 'A million here and a million there soon
adds up to a lot of money, and we've...there is a lot of
money we're talking about. This is \$9,000,000 that I can't
see is a very high priority item. I urge a 'no' vote."

Speaker Ryan: "Representative Keane."

Keane: "Thank you, Mr. Speaker. It may be a large amount over the proposed, but it is not that much over last year's.

Last year's, it is my understanding, was \$12,000,000.

We're asking for a \$2,000,000 increase which approximates what inflation is. I would ask for favorable reception of this Amendment."

Speaker Ryan: "Further discussion? The Gentleman from Cook, Representative Wolf."

Wolf: "Yes, Mr. Speaker and Members of the House. I, too, ask for the rejection of this Amendment. Again, using the same arguments, we are striving very hard trying to contain a budget to keep Illinois solvent, to keep us with a balanced budget, and I would ask for a 'no' vote on this one as well."

Speaker Ryan: "Further discussion? Representative Hoffman."

Hoffman: "Thank you very much, Mr. Speaker, Ladies and Gentlemen of the House. We cannot afford this Amendment. This is an Amendment that goes into a specialized program. The schools can use these resources in either the catagorical program, the special ed program, the transportation program

or in the general distributive fund to a much better degree. If we put this money in those...in the general distributive fund, for example, the school district can decide for themselves whether they want to buy the books or not. I think this Amendment should be rejected."

Speaker Ryan: "Representative Ewing."

Speaker Ryan: "She indicates she will."

Ewing: "In the budget as it presently stands before your Amendment, is the amount in for text books equal to or above what we had last year?"

Barnes: "Last year we had \$11,000,000, and it has been reduced to \$5,000,000."

Ewing: "Mr. Speaker, Ladies and Gentlemen of the House, I, too, hate to oppose this program, but have from the beginning.

I think this is a wonderful place to save the \$6,000,000 and I would hope we would defeat the Amendment."

Speaker Ryan: "Further discussion? Representative Meyer."

Meyer: "Thank you, Mr. Speaker. I would just like to point out that there are 255,000 children in this state who attend non-public schools. The public school children are going to be the beneficiary of about \$2,000,000...\$2,000,000,000 from the public treasury. The non-public school kids are going to get about \$3,000,000. That is inequitable, Mr. Speaker. I urge approval of this Amendment."

- Speaker Ryan: "Is that the group that Russell 'Sharbenou' is with, Mr. McBroom?"
- McBroom: "Is Mr. 'Sharbenou' up there?"

And what this program does, it offsets any increase in
school fees for any school student."

Tuerk: "Well, I am trying to get a handle on last year's appropriation versus this, and what you're saying is you need \$9,000,000 in order to affect the program. Is that what you're saying?"

Barnes: "No, Representative Tuerk. To fully fund the program from kindergarten through 12, one book per student in the entire State of Illinois, it would take \$25,000,000. We have only been able, since 1976 through last year, to complete the cycle twice, because we have never really been able to fully fund the program."

Tuerk: "Thank you."

Speaker Ryan: "Is there any further discussion? The Lady from Cook, Representative Barnes, to close."

Barnes: "Well, Ladies and Gentlemen of the House and Mr. Speaker, I would like to point out that three of the speakers that did get up and object have never supported the program at all since day one. So their opposition is very natural. Mr. Cook told me that four public school administrators have contacted him unsolicited, to testify before the Senate Committee. This is one of the best programs that we have ever passed out of this House. There is less red tape. All they do in the school system is order the book, and within three months, they are sitting there at the schools waiting for the students to return in the fall.; It would seem ashame that we would cut this program back to \$5,000,000 when every single parent in every district saves money through this particular program. If you really want to do something for the people in your district, please vote on this Amendment. Please vote 'yes'."

Speaker Ryan: "The Lady moves for the adoption of Amendment #6 to House Bill 493. All in favor will signify by voting 'aye', all opposed by voting 'no'. Have all voted who wish? Representative Brummer, one minute to explain your vote." Brummer: "Yes, I think this is a very important Amendment. I fail to understand why there is only \$5,000,000 in the budget this year with regard to this excellent program if last year there was 10.5 million dollars expended out of this program. That is a cutting in half of the program. I think that should be restored to a decent level up to at least what it was last year. It is an outstanding program that has been expanding, is utilized, is very important both for the public and the private schools. I don't understand how we can cut that funding in half. This only

It changes the Chicago downstate bilingual in the following fashion, recommends \$13,500,000 for Chicago bilingual; \$3,875,000 dollars downstate bilingual. The Chicago figure is a slight increase over last year's expenditures and the downstate bilingual is also...is a slight drop because of various lapses in the program. We also then, we'll change text books downward to \$8,000,000 from last years 12 and from the Amendment that was just adopted at 14. Further on or the Amendent rather, under regular package, transportation this Amendment will bring the school districts into almost 98% of full funding, special ed. transportation, 99%. Those two figures, I believe, come of the Republican Sub-committee, once out Appropriations. That Committee as in a full and final School foods is at 95%. number reduced it. The Death-Blind Center is also at 95% full funding. this Amendment attempts to address, Mr. Speaker, Members of the House, is the very serious reality that if we don't make our commitments as they are prescribed in law to fully will fund those programs in special education, we failing in our obligation as a Legislature so we attempt through compromise to come as close as we possibly can to the idea of distributing what funds we think are available for the education program."

Speaker Ryan: "Excuse me just a minute, Mr. Schneider.

Representative Meyer, for what purpose do you seek

Meyer: "No, I was hollering for Keane."

We have an honest and legitimate concern about how we're special going to deal in particular with education problems. I move that this Amendment be adopted."

Preston: "Where are those figures you have from? Because I've seen other figures and talked to people who are in the school system, in bilingual education and they indicate to me that where the program initially was designed to be for no longer than two years, in fact, many students are in the bilingual education program for four, five, six, seven and all the way through their elementary school education."

Braun: "No. No, Representative, the figure that I have is the figure as provided me by the Chicago public schools but I would point out that in the Appropriations Committee in hearing, the State Board of Education affirmed that figure, that in fact the Chicago program as were the other programs in the State were functioning as transitional programs to provide basic services. I'd like, since you're concerned, to go through some of the statistics. 94% of the students participated in the program for three years or less. This figure which almost identical to last years report, shows a high rate of transitioning since the vast majority of

participants leave the program in less than three years. For example, 8,093 students who received bilingual services in 1979, June of 1979 were no longer in the program in June of 1980. Most of them left because they had sufficiently proficient in English to enable them to participate in English instruction in other subject areas. that the...90% of the program point out participants were in the elementary schools. 60% of them were between the ages of five and eight. We're talking about little children for whom, in many instances, there is no alternative. 57% of those little children spoke little 22% were only marginally proficient in or no English. Again, I...and 80% of the program participants English. received three or more periods daily of instruction in English. Again, Representative Preston, Ladies and Gentlemen of the House, we are talking about basic education to a significant portion of young children in the public schools to deny them this funding, to deny them this program is to deny them an education and that's really what we are here to do, it seems to me. The need for this program is apparent. Without the bilingual education forced. funding these youngsters will be...will be literally, to not receive education in all the basic subjects, including English to get it as best they can and I think that we are only buying into future problems by cutting off educational services to young children through our failure to fund this program adequately."

Preston: "Mr. Speaker, may I speak to the Bill or to the Amendment? I, as I indicated, I've heard a great deal of conflicting information about the nature of the bilingual education program in the Chicago public schools.

Representative Braun, presents one side of it and I'm sure that from her knowledge that is accurate. I have had

discussions with people who are in the administration of the bi-education program, bilingual educational program, that indicates that there...it has become far more than the transitional program that it was intended to become. That's my only comment on the Bill. I don't what the facts are, unfortunately. I have this conflict."

Speaker Ryan: "Is there any further discussion? The Lady from Cook, Representative Currie."

Currie: "Thank you, Mr. Speaker, Members of the House, I rise to support Amendment #11. Let me remind the Members of the House of two things. First of all, we are not here today to take a referendum on whether there ought or ought not to be bilingual education in Illinois public schools. only do our own statutes require it and the Federal Government statutes require it but in Chicago that Board of Education is, right now, under a decree, a consent order, from the Office of Civil Rights. We're not here to say whether there should or should not be bilingual. answer is, that there is going to be bilingual in the foreseeable future. If you don't like it, you have every opportunity to introduce legislation to demandate bilingual at the State level, at the Federal level and through the I, personally, support Office of Civil Rights. the bilingual program and I think that the evidence that has particularly recently, on its effectiveness come in. overwhelmingly suggests that the program does work to help children become proficient in English at the same time that they're able to make strides in other...other academic Ιt That's the point of the program. subjects. transitional. It is not a permanent consigning of a child to staying with a foreign tongue but in fact it is the way in this country at this point that we try to help children learn the English language and also learn the other kinds

of subjects that are before them. This Amendment does not increase beyond the level that the State Board of Education requested dollar allocations in the bilingual program. That request compared to last years appropriation is only increased by 5%. I would ask you to compare it to the State Board request for regular transportation, up 30% over last year. The House Appropriations Committee bilingual education stranded. It left it hanging out on a limb. It left it hanging out to dry. The point is, that Chicago and in the downstate areas, transitional bilingual programs have to be offered and they will be offered. They will be offered not just for children who are Spanish speaking but also for children who are French speaking, German speaking, Greek speaking, Polish speaking and Romanian speaking. The question before us right now is whether we're going to help the local school districts fund those programs at a level that is commensurate with the The Chicago Board of actual costs to those districts. Education asks for \$16,000,000 for this appropriation. State Board reduced that request 13,750,000. 13,750,000 is the dollar figure for Chicago in Amendment #11. I strongly urge your support."

Speaker Ryan: "Representative Braun to close."

Braun: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. The request that's made in this Amendment, it is consistent with the request from the State Board of Education, which in and of itself, was below the needs to fully fund bilingual education. It was below even the formula that had been applied to other mandated programs in this budget. Representative Currie is absolutely right. This is not a debate over whether or not we should have bilingual education. That is already the law of the land and again, Ladies and Gentlemen, I think that it is

short-sighted for us, the law notwithstanding, not to fund a program that provides education to little children. That is what we are talking about here. We are talking about a program that allows small children at an initial chance, an initial chance to participate fully in our American society. I encourage, encourage your support for them, for this Amendment. Thank you very much."

- Speaker Byan: "The Lady moves for the adoption of Amendment #11 to House Bill 439. All in favor will signify by voting 'aye', all opposed by voting 'no'. Representative Hoxsey to explain her vote."
- Hoxsey: "Yes, Mr. Speaker, Ladies and Gentlemen of the House. I submit to you that this is a program that has gone far beyond the original intent of this Sponsor that introduced it in the first place. The quickest way to demandate a program is to wipe out the appropriation. I suggest you vote 'no' on this."
- Speaker Ryan: "Have all voted who wish? Representative Kulas, one minute to explain your vote."
- Speaker, as your subservient slave, may I explain my Kulas: HMr_ Ladies and vote? Mr. Speaker, on the Amendment. Gentlemen, a lot of you who are under the misapprehension that this bilingual education deals with one language Well, there are 17 different bilingual language group. programs in the city of Chicago. And these transitional programs. Programs which are needed for young children who have immigrated from different countries from all over the world, and it is a transitional program. Once these children learn the language that they can start picking up the subjects in English, they are automatically put into an all English program. I would strongly beg of you to reconsider ... " (cut off)
- Speaker Ryan: "Representative Levin, one minute to explain your

vote."

Levin: "Mr. Speaker, Ladies and Gentlemen of the House, I think
Representative Kulas is correct. This is a good Amendment.

I pleased to represent a district that has a substantial
different language groupings. We have Vietnamese. We have
various other kinds of oriental, Spanish speaking and these
programs are good programs. They help them to adjust to
the English language. They help them to become full
fledged students in the English speaking classes. It's a
good investment and I urge more 'aye' votes."

Speaker Ryan: "Have all voted who wish? Take the record. On this question there are 68 voting 'aye', 87 voting 'no', and none voting 'present'. And the Motion loses and the Amendment is not adopted. Further Amendments?"

Clerk Leone: "Floor Amendment #12, Schneider, amends House Bill 493 as amended."

Speaker Ryan: "Representative Schneider."

Schneider: "Thank you, Mr. Speaker and Members of the House, for the benefit of Representative Davis...get Davis off the Amendment #12, Mr. Speaker and Members of the phone. House, is a very important concept that I've addressed over the last three years, in agreement with Doctor Cronin, by his commitment of the Leader at that time, the Majority Leader of the House and Members of the Senate Democratic Appropriations Committee, we had been in accord that Bills that are not...that are forumla driven mandates will be settled in one Bill and those that are not formula driven Currently, bilingual and would belong in another. books, although identified properly as mandates, are really not what we call formula driven mandates and are in the wrong proposal. So, you cannot make distinctions over mandates without recognizing the questions of reimbursement as a factor in the formula driven. It is sufficient for me

to point out to all of you that the State Board of Education has chosen to make an identification for these programs that places them with special education, a sensitive area that they know will allow text books and bilinguals to increase because many people support special ed out of a genuine interest in the hardships that those children face. The Bill has had many Amendments. going to withdraw this but next perhaps vear and subsequently weeks to follow I think we ought to instruct the State Board properly about what constitutes a formula driven mandate and what constitutes a statutory mandate. There is a significant difference. What it does to us. Members of the Legislature, is make it very difficult to evaluate programs. They know that. They try to beef up their programs because it keeps them afloat and hopefully, indirectly, it might serve the children. T Amendment #12."
