- Speaker Peters: "Could you indicate the content of the Bill, Sir?"
- Huff: "Yes. Senate Bill 286 creates the Chicago School Study
 Commission."
- Speaker Peters: "The Gentleman asks leave to suspend the appropriate rule so that Senate Bill 286 may be heard in the next meeting of the Executive Committee. He asks leave for use of the Attendance Roll Call. Senate Bill 286.

 Representative Pullen objects, Sir."
- Huff: "I'd like to talk with the Representative and perhaps make that Motion again."
- Speaker Peters: "All right. Are there any other announcements?

 Any other requests? Committee reports."
- Clerk Leone: "Representative Stearney, Chairman from the Committee on Judiciary II to which the following Bills were referred, action taken June 4th, 1981 and reported the same back with the following recommendations: 'Do pass' Senate Bills 176, 516, 601. 'Do not pass' Senate Bills 84 and 135. 'Do pass as amended' Senate Bills 63, 448, 490 and 534. Interim Study Calendar, Senate Bill 123."

- Speaker Peters: "Now there's only one Senate Bill left; Senate
 Bill 160 by Senator Grotberg. Representative Huff? Have
 we reached any...Representative Huff, have we reached an
 amicable solution?"
- Huff: "I believe so, Mr. Speaker. I think I will remove my request for the Motion and defer to my esteemed colleague, Mrs. Pullen."
- Speaker Peters: "You remove your request, Sir? Thank you.

 Representative McBroom on a point of information that the

 House Members I think will be interested in this. Give the

 Gentleman your attention please."
- McBroom: "Mr. Speaker, Members of the House, since I sent out the memorandum in regard to the dimunition of our insurance company, our insurance coverage, subsequent to that I with Representative Lechowicz in his office and it was his suggestion that the Republican staff, as far as insurance is concerned, and the Democrat staff, as far as insurance is concerned, would meet and go over and in effect see if the figures which I submitted were correct and accurate. Sometime on Monday -and Nr. 'Calahand' of our staff is adjacent to me- sometime on Monday, he and Mr. Delort, official from ASPME and an official from the Department of Personnel met in my office and said in effect, yes, the figures that you sent out were indeed accurate. I've asked by probably ten to twelve Members since then what we're going to do about it. I have an Amendment being drafted which has the approval of the Democrat staff as well as the Republican staff and the Amendment says -and I'll conclude here Ladies and Gentlemen in just one second-.. 'Such deductible and coinsurance provisions shall not be increased over the level as in the plan and in effect immediately before July 1st, 1981. In effect, Amendment would say that the Director cannot act and change

the plan without the advice and consent of the Legislature. I'd be glad to ..glad to respond to one or two questions on it if anyone would want to ask them. But I've been kind of deluged with questions about it and that's the posture. It's going to be put on a Bill in Personnel and Pensions on Tuesday afternoon. Thank you for your attention."

Speaker Peters: "Representative Winchester, for what purpose do you seek recognition?"

Winchester: "Well, would the Gentleman yield for a question?"

Speaker Peters: "He indicates he will."

McBroom: "Yes."

Winchester: "All right. It's my understanding, Ed, that all state employees, including the General Assembly, that our insurance benefits will be going down. The amount of coverage that we will be getting will be going down, but the cost will be going up. Now, I know what your language will do, but what does that mean as far as the actual cost and the less coverage that we're getting under the present plan? Will that be renegotiated now?"

McBroom: "We'll keep under the present plan and it will cost the state an additional eight or nine million dollars to keep our insurance...the insurance for state employees intact as it is now."

Winchester: "All right. But, as the insurance coverage is now?"
McBroom: "That's correct. That's correct. That's the idea was
to..."

Winchester: "We'll still be paying more money, but we'll still be getting...we'll be getting more coverage than what we would be getting under the original proposal."

McBroom: "No, we will not be paying more money. The state will be paying more money to keep the coverage intact for all the state employees, including Members of the Illinois General Assembly."

Winchester: "Good. Thank you."

Speaker Peters: "Representative Lechowicz, do you wish to...."

Lechowicz: "Very briefly, Mr. Speaker. I would just concur with Representative McBroom's remarks. Also the Director of Personnel came into my office late, as of today, and he showed the respective proposal as being...was presented by Blue Cross and Blue Shield to his Department. I told him that it was our intent to proceed with the Amendment to make sure that the coverage that the state employees presently have is maintained at the current level. What Representative McBroom has pointed out to you, the best way to do that would be to amend that Bill. It's my intent to support the Amendment and I would hope that this Membership as a whole would support the Amendment at the appropriate time. Thank you."

Speaker Peters: "Representative McBroom?"

McBroom: "I didn't have anything. Just thank you, Representative Lechowicz."

Speaker Peters: "Representative Robbins."

Robbins: "I have a question on this insurance problem and I wondered if he could answer maybe? Representative McBroom? The way I have been reading part of this, there are several surgical procedures that will be paid for only in out-patient...as an out-patient instead of a hospital admission and in our area of the state the procedures that I see in this, they are not set up to handle these in the emergency rooms. What is the posture in the case of that kind?"

McBroom: "Well..."

Speaker Peters: "Excuse me. Representative McBroom, I don't know that this would be the proper time or place or forum to ask questions in those particulars. Perhaps the staff people can get together with..."
