That, in effect, will cost the State of Illinois between 8 and 9 million dollars more money, and we're going to have to have an appropriation for that and find an appropriate appropriation Bill to tack that on to. We just feel that this might give further substance to this Resolution to what we're endeavoring to accomplish."

Preston: "Does the present insurance package, then, contain any provision for coverage after a Member is no longer a Member of the General Assembly?"

McBroom: "I do not think so. I would appreciate some help on that question."

Preston: "Does the..."

Speaker Peters: "Representative Preston, excuse me. I think on that point, Representative Lechowicz can give you a clear answer. Representative Lechowicz."

Lechowicz: "Thank you, Mr. Speaker. The answer is no. That's a separate Bill."

Preston: "Thank you, Mr. Lechowicz."

Speaker Peters: "Proceed, Sir."

Preston: "Does the...does your Resolution apply to any other than General Assembly Members? Does it apply to any other State employees?"

McBroom: "All State employees."

Preston: "All State employees. Thank you."
