Friedrich: "Mr. Speaker, I was occupied. Was 267 removed from the Consent list?"

Speaker Peters: "Yes, Sir."

Friedrich: "Thank you."

Speaker Peters: "Any other questions in regard to? Take the record, Mr. Clerk. Take the record, Mr. Clerk. On this question there are 138 voting 'aye', none voting 'nay', 14 voting 'present'. The Consent Calendar as read is hereby declared passed. And the Chair reminds Representatives Daniels and Friedrich to file the appropriate Motions in regard to the Bills on which they objected. Epton: "Thank you. Ladies and Gentlemen of the House, I have an apology to make and I hope that you will all listen to me do so. This morning in Financial Institutions a Bill was supposed to be called and for reasons with which I was not familiar or for reasons which I suppose, the Chairman sent Representative McBroom, recessed the meeting and said that he would call a meeting one half-hour after adjournment. The Bill in question was one that was particularly important to many of us in the Legislature, many of us in

the Judiciary and many of us in various departments of government. I obviously lost my temper because I did not know . why the Bill was not called, since the witnesses were present and as a matter of fact, I should add, the votes were present. And at that time I took strenuous issue with McBroom, who is one of my oldest friends in Senator (sic) I doubt that there...Although I think I respect and admire and even like the vast majority of individuals in this House, there are very few that I am closer to than Senator (sic) McBroom. At the time I thought he did soand I probably stated to the media- he did so at the request of Representative Telcser and Representative Collins. Representative Collins was in the room and I knew that he was not particularly in favor of the Bill. Representative Telcser had also indicated to me that he was not in favor of the Bill. And at that time, I publically stated that Senator (sic) McBroom was bowing to their I now must admit that I was in error. The posting wishes. notice that went out to the Members of the Committee not identical in all cases. Several of us received the posting notice which showed that Bill 269 would be called. Several other Nembers of the Committee received the posting notice showing that 295 would be called. At the time, Senator (sic) McBroom indicated that there was confusion, but he assured the Members of the Committee that they would meet one-half hour after adjournment as soon as he could straighten out the confusion and the necessary assigned to the Committee would be called. My remarks against the Chairman of the Conmittee. Representative McBroom, my remarks against Representative Collins and Representative Telcser were certainly uncalled for and although I hope they will accept my apology, whether they do or not, I want the whole House to know that

losing your temper is not a very valuable asset. I was in error. And I apologize and I would certainly respect the Chairman's decision to have the meeting after adjournment. Mr. Speaker and Ladies and Gentlemen, thank you for listening."

Speaker Peters: "Thank you, Sir. On that point, Representative Leon."

Leon: "And, Mr. Speaker and Ladies and Gentlemen of the House, at that meeting I, a Democratic Spokesman of the Committee, raised the issue early this morning, called the Clerk's Office and there was some confusion on the posting of the Bills and the numbers and I called the attention to the Chairman, Mr. McBroom, and as a result of that he took the action that he took in order to clarify the record."

Speaker Peters: "Thank you, Sir. On that question, Representative McBroom."

McBroom: "Well, Mr. Speaker, Members of the House, first of all, Representative Epton, I accept your apology and don't feel that one was even necessary. I think every...each and every Member, including myself, from time to time have been angry or disappointed over the disposition of a Bill, either because it passed or because it failed. And, it certainly in no way impairs the friendship and respect that I have for you. I want to extend my sincere thanks to the Minority Spokeman on the Committee, Representative Leon. He and I have worked together for many years and I tried to be cooperative with Representative Leon when he was Chairman of the Committee and he has been more than cooperative with me as Minority Spokesman. John keeps reminding me that things might change in two years and he might be Chairman. So, and I might be Minority Spokesman, add a bit of levity I guess to this business once in a while. The Committee on Financial Institutions will meet a

half-hour after adjournment. It will be in C-1 where we met this morning. There was confusion. We now find that a Bill, House Bill 295, was apparently assigned to both Registration and Regulation and to our Committee. It has to do with the licensing of snowmobiles so I hardly think it would be in our Committee. There has been some confusion. And, the Committee will resume a half-hour after adjournment in C-1. Thank you."

- Sandquist: "I just would like to get the record clear then that
  House Bill...I mean Senate Bill 269 of which I'm the House
  Sponsor will be heard then this afternoon in Financial
  Institutions. Am I correct?"
- Speaker Peters: "That's what the Gentleman indicated."
- Sandquist: "I want to clarify. He talked about 295. 269 was posted properly so."
- Speaker Peters: "I...The Gentleman is not here to respond to that now. Representative Stearney."
- Stearney: "Mr. Speaker, Ladies and Gentlemen of the House, on a point of personal privilege. It deals with the subject of the assignment of Bills. It deals with Senate Bill 890...867, which deals with the subject of insanity and guilty by mentally ill. This Bill was originally assigned to Judiciary II, then reassigned to Executive, Judiciary re-reassigned back to II and then re-re-reassigned back to Executive this morning after it was set to be heard in Judiciary II this morning of which I'm the Chairman. The Bill deals with a substantial area of substantial concept in the area of criminal justice and I'm thoroughly appalled and so are the Members of the Committee that we could play such games with this matter.

Now, there was a Bill that passed out of Committee, Executive Committee, Jack Davis' Bill, which dealt with the subject of child beating and death penalty that went to Executive. I didn't object to that and that was a serious infringement upon the Committee process. But when you begin doing it over and over again and you begin emasculating, eradicating the entire criminal justice system to placate one Sponsor, then I think we've gone too And I think at this time I'm going to file a Motion to recommit that Bill back to Judiciary II so that we honor the Committee process. Remember, no one is going to bring the Bill to any Committee if they feel they cannot get it passed and I, on one hand, did not want a particular Bill sent to Health and Family Services, but they said it was going there and it did go there. Well, if that be the it should apply across the Board for each and every Bill. Thank you, Mr. Speaker."

- Speaker Peters: "The Chair will now proceed with the business of the House. On that point, Representative Getty? Representative Getty."
- Getty: "Mr. Speaker, Members of the House, I, too, rise on matter of 867 and I arise further as a point of personal privilege. I am the Democratic Member of the Committee on I want to let you know that on the initial assignment, I voted that that should go to the Judiciary II Committee. It is a Bill clearly within the provence of the Judiciary II Committee and should not have been assigned to any other Committee. Subsequently that Bill was reassigned to the Executive Committee and then beyond belief, re-reassigned to the Judiciary II Committee. And today, of apparently after a poll the Members and an unsatisfactory result appeared to be forthcoming, it was again reassigned to the Executive Committee. On none

those subsequent reassignments was I consulted or notified that a vote would be taken by the Committee on the reassignment. I would like it clearly understood in this record that I would have vigorously opposed any of those reassignments. It should have stayed in the Judiciary II Committee and to move it someplace else was in derrogation I think of the traditions of this House and a derrogation of the best interests of this House and the people of the State of Illinois."

Hoxsey: "You're not taking any Bills with Amendments?"

Speaker Peters: "That's correct, Ma'am."

Hoxsey: "Okay. That's all right. I'll wait."

Speaker Peters: "Top of page..top third of page four, Senate
Bills, Second Reading, Short Debate. Senate Bill 22.
Representative Smith. Irv Smith. Read the Bill, Mr.
Clerk."

Clerk Leone: "Senate Bill 22, a Bill for an Act relating to benefits of certain military personnel. Second Reading of the Bill. No Committee Amendments."

Speaker Peters: "Any Amendments from the floor?"

Clerk Leone: "None."

Speaker Peters: "Third Reading. The Chair now recognizes

Representative Ropp for the purposes of an introduction and
the reading of a Resolution. Representative Ropp."

Speaker Peters: "Excuse me. Representative Preston, for what purpose do you arise, Sir?"

Preston: "Mr. Speaker, I thought I heard the Clerk say, 'Senate
Bill 266'. Is that.."

Speaker Peters: "226."

Preston: "226?"

Speaker Peters: "226."

Clerk Leone: "Senate Bill 226..."

Speaker Peters: "Top of the Calendar, page two. Representative Greiman."

Greiman: "Thank you, Mr. Speaker. This deals with an Amendment to the Condominium Property Act requiring that an owner which converts a property..a building into a condominium to give the tenants access to the building and relevant documents during the period when they have by law a right of first refusal. It provides that they can exercise that right when they receive notice..."

Speaker Peters: "Representative Greiman, excuse me."

Greiman: "Yes."

Speaker Peters: "The Chair has asked those who are not entitled to the floor to please leave. The Chair now makes that request once again without any intent to embarrass anyone.

It is difficult to hear. It is difficult for the Chair to

If...That's all it does is seek to give tenants the right when they are going to exercise their option to be able to look at the property that they're going to buy and look at some of the pertinent stuff in the file. Clerk Leone: "Senate Bill 373, a Bill for an Act to amend Sections of an Act in relationship to state finance. Third Reading of the Bill."

Speaker Peters: "Representative Wikoff."

Wikoff: "Thank you, Mr. Speaker. This, as it says, does change the Finance Act to provide that funds received by the University of Illinois from discoveries and patents copyright works of the faculty and staff be retained in the University Treasury. This is a result of public law 96-517 of the 96th Congress which regulates the funds derived from the patents. This bascially eliminates ... What they've been doing is using these in the foundation..goes to the university. This is with the approval and suggestion of the Auditor General. The Legislative Audit Commission has reviewed procedures for handling these funds and this, as I said, is a recommendation of the Auditor General to solve the problem that did arise with this public law of Congress. I know of no opposition and would ask for favorable support."

Speaker Peters: "Anyone in opposition? Representative John
Dunn."

Dunn: "Not necessarily in opposition, Mr. Speaker, but I have a question of the Sponsor and the question is, does this legislation in any way change the rights of an inventor who may happen to be an employee of the University of Illinois to the patent royalties or the rights to a patent?"

Speaker Peters: "Representative Wikoff."

Wikoff: "No, it does not, John.."

Dunn: "Thank you."

Wikoff: "This is just because of the federal law change."

Speaker Peters: "The question is, 'Shall Senate Bill 373 pass?'.

Senate Bill 401 simply provides that ambulances and other medical transport vehicles must have the same mechanical inspection that other vehicles, pickup trucks and all that sort of thing, have to have. It seems kind of odd that any truck that's going to move some goods or some animals would have to have an inspection and not a vehicle that's going to move people. It deals only with mechanical aspects. I would ask for a favorable Roll Call."

- Hoffman: "Thank you very much, Mr. Speaker and Ladies and Gentlemen of the House. This Bill affects DuPage County only. It amends the population up from 500,000 to a million to cover the increase in population on the 1980 census. This has to do with control of the county law library. And I know of no opposition. I appreciate your support."
- Speaker Peters: "Anyone stand in opposition? There being no one. the question is, 'Shall Senate Bill 420 pass?'. Those in favor will signify by voting 'aye'; those opposed by voting 'nay'. Mr. Clerk. The voting is open. Have all voted who Have all voted who wish? Have all voted who wish? Mr. Clerk, take the record. On this question there are 156 voting 'aye', none voting 'nay', 4 voting 'present'. This Bill, having received the Constitutional Majority, hereby declared passed. - Clerk Leone: "Senate Bill 426, a Bill for an Act to amend the Business Corporation Act and the Act to enable corporations in other states and countries to lend money in Illinois.

  Third Reading of the Bill."
- Speaker Peters: "Representative Hallock."
- Hallock: "Thank you, Mr. Speaker, Members of the House. Very basically, what this Bill tries to do is give the Secretary of State the power to require only one annual report filed by corporations in Illinois. They anticipate a savings of about \$50,000. And I ask for your support. The Bill is sponsored by myself and Representative Beatty. Thank you."
- Speaker Peters: "Anyone stand in opposition? Representative John Dunn."

Dunn: "Yes. The explanation of this Bill was awfully short, awfully fast and I couldn't hear it. What does this Bill do?"

Speaker Peters: "Representative Hallock, would you repeat your statement, Sir?"

Hallock: "...Senate Amendment. The Bill would allow the Secretary of State to require only one annual report to be filed yearly by corporations in Illinois instead of the two annual reports required now."

Dunn: "What is the Senate Amendment?"

Hallock: "The Amendment would enable facilitating language for corporations from around the nation to invest in Illinois.

It's a technical Amendment just sought by the Secretary of State to allow corporations that were making loans in Illinois to continue making loans. Apparently there's some language in the Statutes which makes it questionable as to whether some corporations can, in fact, make loans in our state."

Dunn: "Our analysis seems to indicate that this Bill would allow corporations who are not qualified to do business in the State of Illinois to invest in loan money in the State of Illinois. Is that correct?"

Hallock: "No, that's not true whatsoever. All the language would do is allow all corporations to invest in loans in Illinois."

Dunn: "Are they allowed to do that now?"

Hallock: "They are in terms of the..what's done but they aren't in terms of what the Statutes say they can do. And so this language is actually technical to make sure that there's no question whatsoever that any corporation, whether it's in New York or California or in Illinois, can, in fact, make loans in Illinois. It's purely technical language correcting what appears to be some misunderstanding in the

Statutes. There was no opposition to this Bill in the Senate or in the House Committees and I would ask for your support."

Clerk Leone: "Senate Bill 494, a Bill for an Act to amend the Revenue Act. Third Reading of the Bill."

Speaker Peters: "Representative Ralph Dunn."

Senate Bill 494 amends the Revenue Act to include the 'kiln gas system' which is a new form coal ..to take the sulfur out of coal to make Illinois coal better to burn so we can burn it. Speaker Peters: "Anyone stand in opposition? There being no one, the question is, 'Shall Senate Bill 494 pass?'. Those in favor will signify by voting 'aye'; those opposed by voting 'nay'. Mr. Clerk, the voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record, Mr. Clerk. On this question there are 159 voting 'aye', 1 voting 'nay', 1 voting 'present'. This Bill, having received the Constitutional Majority, is hereby declared passed. Senate Bill 495, Representative

Bower. I'm sorry. Fawell. Representative Fawell."

Clerk Leone: "Senate Bill 495, a Bill for an Act to amend an Act in relationship to Fire Protection Districts. Third Reading of the Bill."

Fawell: "Thank you, Mr. Chairman (sic, Speaker) and Ladies and
Gentlemen of the House. This is just a very simple Bill.

It merely allows the Board of Trustees to be expanded from
three trustees to five. It has been supported by the

Favell: "This is optional."

Fawell: "This is if the Board is appointed. There will be five appointed instead of three."

Brummer: "How is the decision made as to whether it's going to be a three member board or a five member board?"

Fawell: "By the authority that decides which one is going to...who appoints them."

Brummer: "And who makes that appointment?"

Fawell: "Well, it can be a township board. It can be a county board or it could be a city council, depending on the Fire District."

Speaker Peters: "Representative McGrew."

McGrew: "Thank you very much, Mr. Speaker and Ladies and Gentlemen of the House. Senate Bill 607 is very similar to

McGrew: "Sixty."

Alexander: "Thank you."

Speaker Peters: "Representative Macdonald."

Macdonald: "I'd like to ask the Sponsor a question please."

Speaker Peters: "Proceed."

Macdonald: "Our analysis here says that a person may not be put in a nursing home if he or she objects orally or in writting to the admission. Can you elaborate, expand a little bit on that?"

McGrew: "Well ... "

Macdonald: "What if the person is..."

McGrew: "I'm not sure that I heard you. But what I think you're getting at there...some discretion right now ...we're talking about trying to let someone act as an administrator of their estate, whether or not they could have them committed as incapacitated into the nursing home and they're saying now wait a minute. Let's make sure that if you want to go that far, that you indeed are declared

incompetent by the courts."

- Macdonald: "In other words, they ...this is only for a person who would not be senile or such. If they object, then they cannot be put in the nursing home. Is that right?"
- McGrew: "Without further court proceedings, yes. You know, there are degrees of senility and if, you know, if you want your son or your daughter to administer your estate to pay for your hospital bills and so and so forth, then you can give them the right to do so. But this does not go clear to the point of totally incapacitated and therefore, you'd have to go through the regular court system in order to do that."

Macdonald: "I think our analysis is not totally correct."

Speaker Peters: "Representative Robbins."

- Robbins: "This Bill is identical to House Bill 368 which we passed out of here with no dissenting votes. So I recommend that you..."
- Speaker Peters: "The question is, 'Shall Senate Bill 607 pass?'.
