Representative Telcser, for the purpose of an introduction."
- Telcser: "Mr. Speaker and Members of the House, I'd like to take this opportunity to introduce a new Member of the House of Representatives. The Gentleman is a... is going to represent the 53rd District. He was sworn in on September 28th to fill the vacancy of Representative Schuneman who was appointed as a Member of the Senate. I'd like to take this opportunity to introduce to you Representative Myron Olson who is a former Circuit Clerk of Lee County, and he resides in Dixon, Illinois. Representative Olson."

I wonder if you would withhold that Motion for the time being and let us refresh our recollection. I want to let you know that it's our intention to dissent or to challenge the approval as those Journals have been submitted, and I'd like to have you withhold that Motion so that we can at least eliminate those dates where there is no controversy."

Telcser: "Alright, Mr. Speaker and Members, I'd be delighted to accommodate the Gentleman, and I will withdraw my Motion so that he can refresh his memory regarding certain dates in regard to the Journal."

- Conti: "Nr. Speaker and Ladies and Gentlemen of the House, as was recited in our prayer this morning, a plea for peace throughout the nation. We have a foreign dignitary here today. I wonder if Mr. Kulas would bring our honored guest here behind the podium. Will you all come, please? Mr. Speaker and Ladies and Gentlemen of the House, in 1941, yaroslav Stetsko and other members of the Organization of Ukrainian National led a revolt against the Soviets..."
- Speaker Ryan: "Alright, can we break up the conflab back here?

 Representative Collins, Representative Meyer, would you be
 in your seats, please?"
- Conti: "As I was saying, he led a revolt against the Soviets in convening national assembly. The assembly appointed Stetsko Prime Minister of the newly independent government.

Two weeks later because of the lack of cooperation with Hitler he was arrested and wounded several times by the Nazis and jailed in the 'Saucenhausen' concentration camp. Ladies and Gentleman, the Ukrainian Prime Minister, the President of the Central Committee of the Anti-Bolshevik Bloc of nations, which is known as ABN, Mr. Yaroslav."

Yaroslav Stetsko: "Thank you, very much. Honorable Mr. Speaker, Honorable Representatives, Ladies and Gentlemen. like to express my heartfelt thanks to the Legislators of the State of Illinois for commemorating the 40th anniversary of the restoration of Ukrainian Statehood proclaimed in Lvov, capital of Western Ukraine June 30, 1941 by Ukrainian national Assembly. June 30, 1941 marks the beginning of a period in our history known as the Ukrainian Underground State, which lasted well into the 1950's, when the military units of the Organization of Ukrainian nationalists and the Ukrainian Insurgent Army were still leading an armed struggle in defense of the Ukrainian Independence and Statehood. As a result of this proclamation, the Ukrainian nation waged а war of liberation fought on two fronts against both Nazi Germany and Bolshevik Russia - two of the largest imperialistic, totalitarian and military powers of that time. It is my opinion that the act of June 30, 1941 was of historical significance, not only for Ukraine and for the subjugated nations of that time, but perhaps for all of Europe and the Free World. If the western allies had established a common front with Ukraine, a nation 53 million strong, greatest oppressed nation in the world and with other subjugated nations against both Nazi Germany and Bolshevik Russia, the Second World War would have been victorious for the world of freedom and justice. Not only are the Nazi Germany, but also are Russian communists prison of nations.

Ladies and Gentlemen, the contemporary international situation is particularly grave. The expansion of Russian imperialist is well known to us all. **Policies** of friendship, appeasement, containment, convergence and proven to be useless in detente have stemming the centuries-old brazen Russian imperialist which complete world domination. The West must realize that within the Russian empire there exists a new ideological and political revolutionary superpower - the subjugated nations, which is destroying the empire from within. These nations are the best allies of the West. Taking this factor into consideration, the following points should included in Western political and military strategy. The Free World should engage the Soviet Russia in the struggle of ideas and ideologies by recognizing the liberation movements of the subjugated nations as the legitimate representatives of these countries at all international forums, including the United nations. The provide the national liberation movements with access to various forms of mass media to facilitate the communications with their contrymen behind the Iron Curtain on a mass scale. Assistance should also be provided in the military training as well as other political and material and technological means of support. of the Free World should proclaim A Great Charter of Independence for all of the nations subjugated by Russian imperialist and communist in the USSR and the so-called Satellite States. The United States, as the champion freedom and justice, should establish a George Washington World Freedom Academy, as a counterpart to the Moscov Lumumba University which trains imported terrorists for the implementation of Russia's imperio-colonial policies throughout the world. A Department of Insurgent-Liberation

Warfare should be established within the Pentagon and/or the Headquarters of the NATO alliance. The liberation struggle of Ukraine, Afghanistan or Poland are proof of the internal weaknesses of the Russian prison of nations - this colossus on clay feet. The might of the subjugated in its struggle against Russian imperialist invaders is exemplified by Afghanistan where soldiers of the Soviet fight agaist a freedom-loving people. Army refused to Poland is another proof that the atomic superpower helpless in suppressing the will to freedom of the smaller Polish nations. The best example is their ten year long arm struggle of Ukraine against Russian occupational armies without any help from the Free World, and the present regeneration of the nationalism and Christianity, especially among the youth in Ukraine with its underground catacombe church and seven catacombe bishops. Russia, being able to mobilize the working classes against these nations, created in Moscow a center of international a means of destroying the free societies of terrorism as The danger of nuclear holocaust cannot negotiated away. Soviet Russia has skillfully exploited Western fears of nuclear war by blackmailing the West into meekly acquiescing with each ever-increasing conquest. Our strategic alternative is based on the knowledge that the subjugated nations within the Russian empire represent a vast untapped force, which, in a common front with the nations of the Free World, provides the strategic raison for defeating the last remaining empire. political and military strategy, based on synchronized national liberation revolutions within the Russian colonial empire is the only alternative to the thermonuclear war. In conclusion, I would like to quote an outstanding British military strategist, Major General J.F.C. Fuller, who once

wrote, I quote, 'Only the unity of the western nations and their agreement with the national liberation movements behind the Iron Curtain can ensure final victory...The reason should be obvious. It is that the Kremlin is living on a volcano, and it knows that the most explosive force in the world is not to be found in the hydrogen bomb, but in the hearts of the subjugated peoples crushed under its iron heel...'. Thank you, very much for your attention."

Conti: "Mr. Prime Minister, we wish you all the luck in your endeavors, and I was sincerely honored to know that one of your members of your delegation is a resident of the Village of Elmwood Park, Dr. 'Sharski', who...He and his wife reside in Elmwood Park. I've asked Myron Kulas to come up here, the second Member in the State of Illinois to be of Ukrainian descent, to introduce the rest of the delegation for the correct pronunciation of the names. And we sincerely hope the best for you and your organization. Myron Kulas, will you do the honors in introducing all of them?"
