Speaker Ryan: "Is there any discussion? The Gentleman from Cook,

Vinson: "Representative, if you would direct your attention to Amendment #4 on your desk, that would become the Bill in the event that it is discharged, and the Amendment is adopted, which is what my intention would be. And what the Amendment would do would be to conform Illinois state statutes regarding municipal bonds to the new requirements contained in the Federal Tax Act that was passed this year. And in short summary, what that would simply do would be to permit municipal corporations in the State of Illinois to issue bonds in registered form rather than bearer form, which is a new requirement imposed by the Tax Act that the feds passed."

Speaker Ryan: "Representative Kane."

Kane: "Would the Sponsor yield?"

Speaker Ryan: "Indicates he will."

Kane: "It is not your intention, then, to do anything else with this Bill?"

Vinson: "No, Sir."

Kane: "And if someone else wanted to do something with it, you would object."

Vinson: "Yes, Sir."

Speaker Ryan: "Representative Getty."

Getty: "Mr. Speaker, will the Gentleman yield?"

Speaker Ryan: "Indicates he will."

Getty: "Representative Vinson, it's my understanding that if this

is discharged, you're going to seek to put on Amendment 4 which would totally gut the Bill and have it only address this subject, and that would be the only thing this emergency matter that would be treated by this Bill if it were to be passed by the House. Is that correct, Sir?

Getty: "With that understanding, Mr. Speaker, I support the Motion, and I will support the Motion to adopt the Amendment when it is put."

Speaker Ryan: "The Gentleman moves that Senate Bill 1667 be taken from the Committee on Financial Institutions and placed on the Order of Second Reading. And on that question, Representative Van Duyne."

Van Duyne: "Thank you, Mr. Speaker. But that doesn't preclude anybody else from putting on another Amendment when it is on Amendment stage, does it?"

Speaker Ryan: "Not if you've got the votes."

Van Duyne: "That's what I say. That wasn't Representative

Getty's question, though, so I just wanted to point that

out."

Speaker Ryan: "Any further discussion? Representative Dunn."

Dunn: "Question of the Sponsor, Mr. Speaker. Will he yield?"

Speaker Ryan: "Indicates he will."

Dunn: "Alright. Mr. Sponsor, the definition of bonds contains a provision that says bonds mean any instrument which the public corporation has assumed or agreed to pay. Now, if...if your Amendment is adopted, will all bonds which are now tax exempt still be tax exempt or will there be any change in the categories of bonds which are tax exempt? For example, industrial revenue bonds, the public corporation really doesn't agree to pay. They are like a revenue bond, but they are tax exempt. Does the language in this Amendment take care of industrial revenue bonds?

  Does it take care of every kind of bond which is now tax

  exempt?"
- Vinson: "The intent of the Amendment is to protect the tax exempt status for all those bonds which now have tax exempt status."
- Dunn: "And there is no intention to change tax exempt status for any bonds that were tax exempt one and two years ago."
- Vinson: "No, the sole intention is to try to preserve tax exempt status in conformity with federal law."
- Dunn: "Thank you."
- Speaker Ryan: "Further discussion? The Gentleman moves that Senate Bill 1667 be taken from the ta...the Committee on Financial Institutions and placed on the Order of Second Reading Second Legislative Day. All in favor will signify by voting 'aye', all opposed by voting 'no'. 107 votes. Representative Barkhausen, for what purpose do you seek recognition?"
- Barkhausen: "Mr. Speaker, I am a man of few words, so I would appreciate it if the electrician could take my speaker button off of the stuck position."

- Clerk Leone: "House Bill...Senate Bill 1667, a Bill for an Act to amend the Illinois Banking Act. Second Reading of the

Speaker Ryan: "Representative Barkhausen, for what purpose do you seek recognition? You seek to have your button turned off.

Are there any Motions with respect to Amendment #1?"

Speaker Ryan: "Any Amendments from the floor?"

Clerk Leone: "Floor Amendment #2, McClain - Friedrich, amends

Senate Bill 1667 on page one, line three and so forth."

Speaker Ryan: "Representative Friedrich."

Friedrich: "I would like to withdraw that Amendment."

Speaker Ryan: "Withdraw #2. Further Amendments?"

Clerk Leone: "Floor Amendment #3, McClain - Friedrich, amends
Senate Bill 1667 as amended."

Speaker Ryan: "Who's the Sponsor?"

Priedrich: "I would like to withdraw that Amendment."

Speaker Ryan: "Representative Friedrich, withdraw Amendment #3.

Further Amendments?"

Clerk Leone: "Floor Amendment #4, Vinson, amends Senate Bill 1667 as amended."

Speaker Byan: "Representative Vinson on Amendment #4."

Vinson: "Thank you, Mr. Speaker. I don't..."

Speaker Ryan: "Could we have a little order in the House chamber, please? The Senate Members please take a seat, that are visitors here today, so we can conduct the business of the House. Proceed, Representative."

Vinson: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I don't believe there is any controversy on the substance of the...of Amendment #4. What the Amendment would do is gut the Bill and incorporate into the Bill one concept. That one concept is to conform current Illinois statutes to the requirements of the Federal Tax Act enacted this summer by Congress, signed by the President, which requires that municipal bonds, to continue to have their

tax exempt status be issued in registered form. Registered form, in this case, means that they bear the name of the owner rather than be assigned to bearer. Now, whether or not any of us agree with the intent of the Federal Tax Act—and some of us don\*t—we have to conform to its requirements if any municipal bonds in the State of Illinois are going to have the benefit of tax exempt status. And that is all this does. I would move for adoption of Amendment #4 to Senate Bill 1667."

Speaker Ryan: "Any further discussion? The Gentleman from Marion, Representative Priedrich."

Priedrich: "Would the Sponsor yield?"

Speaker Ryan: "Indicates he will."

Friedrich: "Has this Federal Act been enacted at this point?"

Vinson: "Yes, the Federal Act is the tax Bill that was passed and signed by...passed by Congress and signed by the President last summer, so...and it would take effect and deny tax exempt status to Illinois municipal bonds unless we take this action prior to January 1."

Friedrich: "And we're taking...talking about new issues, not existing issues."

Vinson: "Yes."

Friedrich: "Thank you."

Speaker Ryan: "Further discussion? The Gentleman moves for the adoption of Amendment #4 to Senate Bill 6...to Senate Bill 1667. All in favor will signify by saying 'aye', all opposed 'no'. The 'ayes' have it, and the Amendment's adopted. Further Amendments?"
