There is a whole class of Americans that I would call the recently disadvantaged. They're not the poor, the urban poor. They re middle-class. who bought homes, who found themselves with they working and their spouse working, who found themselves with overtime a few years ago, and they pursued the American dream of home ownership. And now they find, through forces of which they have no control, they are of a job, their income cut, they're unable to sustain their They are people who live in mortgage. urban areas. Accordingly, I have filed Amendment #2 to House Bill which establishes the Illinois Homeowners Emergency Assistance Act. It allows an agency to come and work first with mortgage companies trying to get the lenders to develop a program to recast loans if necessary and then finally to help them for a period of up to 36 months. help them in the payment of their mortgages so that the homes will be saved. I read the 'Chicago Law Bulletin' day and I see more and more mortgage foreclosures. We are the leading state in home mortgage foreclosures. That is not a matter of which I am proud. And I say to you that this Amendment will provide homeowners in urban areas, not Chicago only, not just Skokie or Arlington Heights, but places all over this state, in Decatur, in East St. Louis, in Alton, in every city... Springfield, every city we will have an opportunity to save the this state. homes of Illinois people. It is for that reason that I have offered this. crucial to our economy and to people who wish to live, as is the farm credit Bill. They should move together. They are of a single piece. Greiman: "This Amendment is not directed, Mr. Huff, at the farmer. It's directed at people who live in urban areas, basically, who have mortgage foreclosures. And it will assist them in developing a payment program where they can pay off their mortgage without having to loose their house."

Speaker McPike: "Representative Huff."

Huff: "Yes. But how specifically is this going to be done, Mr. Greiman? I mean, where is the money going to come from?"

Greiman: "Alright. It provides for a special lottery aimed only at this particular purpose, and on a short-term basis will engender and develop the kind of funds necessary to save Illinois homes. Now it gets to a point, excuse me, Mr. Buff, of five million where it cuts off. At the five million point it cuts off, and then that money is used essentially to help homeowners pay their mortgage."

Huff: "Alright. But that ... "

Greiman: "Now, I must say the state then has a lean on those houses for the amount of that mortgage. So they're not...

You know, nobody's getting nothing for nothing in this deal."

Huff: "Alright. But you mentioned a lottery. Would that be like
the federal... program at the state level?"

Greiman: "Like the what?"

Huff: "You say a lottery, a special lottery. Right? You
mentioned a special lottery."

Greiman: "Yeah, it would be tagged onto the lottery that we run.

It would be a special lottery. You know, they have all these..."

Huff: "Oh, from the ... "

Greiman: "Yeah, lottery... lottery. Right."

Huff: "...the existing lottery. It would be a diversion from the lottery funds."

Greiman: "No, it would be a new lottery specially earmarked at that. So it wouldn't be a diversion. People would go into that lottery buying tickets for that lottery only. And they would know what they were doing."

Huff: "Who would be buying these tickets?"

Greiman: "You and me."

Huff: "Okay. And that would generate... that would generate the... the principal..."

Greiman: "Five million dollars. That's not a great... great deal of money in the 11 million people, five million dollars."

Huff: "And this doesn't even apply to farmers..."

Greiman: "Pardon?"

Huff: "This applies to urban dwellers, right?"

Greiman: "This is... This is for urban people. Right. Farmers

can apply too, of course. Everybody who has a home can

apply, Mr. Huff."

Huff: "Okay."

Speaker McPike: "The Gentleman from DuPage, Representative Hoffman."

Hoffman: "Thank you very much. Mr. Speaker, Ladies and Gentlemen of the House, I rise in support of this Amendment. I think the purpose of the Bill is... is a laudable purpose. Having spent my early years in rural Illinois, I certainly appreciate the situation on many of the farms in this state today. 
