have one township left and that township would be under a thousand and it would negate previous legislation which is now law which allows for assessment purposes multi-townships to join together and hire one assessment... one assessor. So, I am... your staff can explain this to you better than I. This was brought... This error in drafting was brought to me by the staff and all I'm trying to do is correct it."

Piel: "Thank you."

Speaker Breslin: "There being no further discussion, the question is, 'Shall Amendment #1... Committee Amendment #1 to House Bill 576 be tabled?' All those in favor say 'aye', all those opposed say 'nay'. In the opinion of the Chair, the 'ayes' have it and Amendment #1 is tabled. Are there any further Amendments?"

Clerk O'Brien: "Floor Amendment #2 offered by Representative Van

Duyne, amends House Bill..."

Speaker Breslin: "Representative Van Duyne."

Van Duyne: "Thank you, Madam Speaker. I think I've explained why
I'm doing this and what the necessity is so I move for 'do
pass' or adoption of Amendment #2."

Speaker Breslin: "The Gentleman has moved to adopt Amendment #2

to House Bill 576 and on that question is there any
discussion? There being no discussion, the question is,
'Shall Amendment #2 to House Bill 576 be adopted?' All
those in favor say 'aye', all those opposed say 'nay'. In
the opinion of the Chair, the 'ayes' have it and the
Amendment is adopted. Are there any further Amendments?"
Clerk O'Brien: "No further Amendments."

Speaker Breslin: "Third Reading. Ladies and Gentlemen, moving to page seven on your Calendar, appears House Bills Third Reading. Reading Short Debate Calendar. This is Third Reading. House Bill 31, Representative McNamara. Representative

- McNamara. Clerk, read the Bill."
- Clerk O'Brien: "House Bill 31, a Bill for an Act to amend Sections of the Illinois Vehicle Code. Third Reading of the Bill."
- Speaker Breslin: "Representative McNamara."
- McNamara: "Yes, this Bill simply provides for parking violators to pay their fines. As it is now, judges can no longer issue warrants to parking violators due to the decision by the courts. This provides for the Police Department, municipalities, etcetera to issue notification so that the license suspension can take affect in the term of ten parking warrants have been sited."
- Speaker Breslin: "The Gentleman has moved for the passage of House Bill 31 and on that question, the Gentleman from Lake, Representative Churchill."
- Churchill: "Thank you, Madam Speaker. Will the Gentleman yield for some questions?"
- Speaker Breslin: "The Gentleman will yield for a question."
- Churchill: "Representative McNamara, was the law at this point prior to some court case was this the law before the court case?"
- McNamara: "The... From my understanding of the court case, the Supreme Court decided that the judges could no longer issue... or could issue warrants, but if they issued a warrant for parking violations, they would be subject to civil suit. So, the judges will no longer be able to file those warrants."
- Churchill: "So, then is your Bill consistent with the court case or will the court case still prohibit what your Bill is trying to do?"
- McNamara: "The court case will still prohibit the judges from issuing... not prohibit them, but encourage them not to present the... present the warrants. The other situation

though is that the Bill now just permits notification to the Secretary of State's Office by the municipalities, Police Departments, etcetera. So, it allows the law to take affect by other means other than a warrant being issued."

Churchill: "Okay. But this Bill that you have in here now is for ten parking violations and then it also includes two outstanding warrants does it not?"

McNamara: "That's correct."

Churchill: "Okay. So that everybody in the Legislature should understand that if they vote for this Bill and somebody has ten parking tickets, they're going to have their driver's license suspended."

McNamara: "That is absolutely correct."

Churchill: "No further questions. Thank you."

Speaker Breslin: "On that question again, Representative Cullerton."

Cullerton: "Yes, will the Sponsor yield?"

Speaker Breslin: "The Sponsor will yield for a question."

Cullerton: "The Bill refers to official notice. Now, official notice in these circumstances is a situation where someone has been given a ticket and they ve been told to go to court on ten separate occasions, is that correct?"

McNamara: "That's correct."

Cullerton: "And if they have not gone to court, isn't the practice for them to receive a second notice of these parking tickets? Do they receive any kind of a second notice as far as you know?"

McNamara: "That is correct. They will have a notification."

Cullerton: "Okay. And then is there a judgment entered against them for failure to show up in court?"

McNamara: "That I am not familiar with."

Cullerton: "Okay. I think that the ... I think that that is what

happens if there's a... there's a couple of chances for the defendant to appear in court. They have not paid the ticket. They have not come to court twice. That has to happen ten times or in effect twenty notices and it's then that the... instead of having to wait for a warrant to issue, it's then that Secretary of State would be notified and then that the license would be suspended. And so I think for that reason that there are enough due process protections in this particular Bill, and I would support it."

Speaker Breslin: "Representative McCracken."

McCracken: "I move this be taken off Short Debate and ask the requisite number of people to join me in the Motion."

Speaker Breslin: "The Gentleman has moved that this Bill removed from the Order of Short Debate. He is joined by the requisite number. The Bill is, therefore, on the Order of Regular Debate. Proceed, Representative McCracken."

McCracken: "Will the Sponsor yield for a question?"

McNamara: "Yes."

McCracken: "Representative McNamara, I'm not familiar with the case you're referring to. What did it hold? Why are we changing this?"

McNamara: "In our area this Bill was presented to me by the police officers of the area. One of the problems that occurred was that there was a warrant issued... I'm not totally familiar with the case myself only as reported... and a notification was sent out to the Police Departments that they would not issue warrants in the procedure of parking violations, because by doing that, according to the Supreme Court... the State Supreme Court, they would be subject to civil suit for issuing a warrant for a non-felonious activity."

McCracken: "In the past, prior to that decision had the warrants

been issued only for persons convicted or for persons failing to appear or under what circumstances?"

McNamara: "The same circumstances that were... that are here in this Bill. This Bill does not change the circumstances, the ten parking violations, two outstanding warrants, etcetera. Those warrants were issued for that."

McCracken: To the Bill, Madam Speaker. I think it does "Okay. change the current law much more dramatically then Sponsor believes. I understand that there's some concern over issuing bench warrants for minor violations as result of a Supreme Court decision. But I think that the Amendment adopted in Committee does not, in fact, produce sufficient safeguards to protect the defendant's rights. You know, warrants historically were issued for a failure appear or in some instances for absconding. Now, this notice process does not necessarily limit itself to cases absconding or cases of failing to appear. Amendment says is that an official notice has been informing him that he is charged with ten or more outstanding parking violations. There's no certified mail requirement as to the notice. There is no particular necessity of proof that he has received notice prior to the suspension of the license. I understand the purpose behind this and I think it's a. you know, a very worthwhile purpose. but the fact of the matter is that there are not adequate protections. I think a more proper would be some sort of certified notice and limiting its use to those who have been convicted of the parking violations or who have been convicted exparty for failing to appear. Neither of which applies in this case. So, I think it's a good purpose and I'd be willing to work with the Sponsor. but not in this form. This is not the right form."

Speaker Breslin: "The Gentleman from Macon, Representative Tate."

Tate: "Would the Gentleman yield for a question?"

Speaker Breslin: "He will yield for a question."

Tate: "Representative McNamara, do you have any idea of what...

how many tickets were issued in the City of Chicago in the
last year?"

McNamara: "I'm sorry, I do not know that number."

Tate: "Do you have any idea how many tickets were issued in the City of Chicago between Chicago residents and residents that live in other counties outside the City of Chicago?"

McNamara: "I don't have that information."

Tate: "Representative McNamara, one of the problems I see is what happens to people that are issued tickets that have never been to the City of Chicago before? I mean we have many constituents in downstate Illinois that are issued or given Chicago parking tickets that have never... never been to Chicago before."

McNamara: "That may happen in my area also, because I am not from Chicago. None of my... the towns in my area are from Chicago. And also this Bill provides that ten parking citations of which a person is notified on ten separate occasions that person elected not to show up in court, elected not to abide by the law. So, therefore, has been self-incriminatory as far as conviction under the law."

Tate: "But what happens to the individual that has a problem with his vision and gets numbers mixed up and consistantly come out writing the ticket for the wrong parking... license plate?"

McNamara: "I believe that the protection existing under the law... ten visionary problems is very unlikely first of all."

Tate: "Okay. Thank you."

Speaker Breslin: "The Gentleman from Cook, Representative Levin."

Levin: "Would the Gentleman yield?"

Speaker Breslin: "He will yield for a question."

Levin: "Alright. First, a point of clarification. The Amendment that was adopted to this Bill talks about striking what is after, I think, line seven, is the intention to strike all of the language, the rest of the language on page one and page two?"

McNamara: "I'll pull the Bill out of the record."

Speaker Breslin: "Out of the record. House Bill 37,
Representative Olson. Clerk, read the Bill. House Bill
37. Clerk, read the Bill."

Clerk Leone: "House Bill 37, a Bill for an Act to amend an Act relating to certain custodians of public monies. Third Reading of the Bill."

Speaker Breslin: "Representative Olson."

Olson: "Thank you, Madam Speaker, Ladies and Gentlemen of the House. This is a clean up language Bill in Chapter 102 dealing with school boards reporting. It amends the Act relating to publication of annual statements by certain custodians of public monies. And in a quirk of Chapter 102 members of school boards had a report on their... both Section 1017 and Section 4 and at the request of the State School Boards Association, we have offered this legislation and I would seek your favorable affirmation of this piece of legislation."

Speaker Breslin: "The Gentleman has moved for the passage of House Bill 37 and on that question is there any discussion?

The Gentleman from McHenry, Representative Klemm."

Klemm: "Will the Sponsor yield for a question."

Speaker Breslin: "He will yield for a question."

Klemm: "Representative Olson, in this Bill is this a uniform type
of form of reporting that the school districts would fill

McNamara: "Yes. Representative, what it basically says under the

Klemm: "Alright. Thank you. To the Bill, Madam Speaker."

Speaker Breslin: "Proceed."

Rlemm: "I certainly support this legislation. I think it's a long time that school districts need to consolidate their reports. I think it'll give us a chance to compare. And I certainly support the Bill."

Speaker Breslin: "There being no further discussion, the question is, 'Shall House Bill 37 pass?' All those in favor vote 'aye', all those opposed vote 'no'. Voting is open.

Representative Vinson on the guestion. To explain his vote."
