Speaker Giglio: "You've heard the Gentleman's Motion. On that Motion, are there any questions? Representative Koehler, the Lady from Marshall."

Koehler: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. In accordance with Rule 55(c), I would like for four other Members to join with me in asking for a Roll Call vote on this Amendment. I think that it is important to point out that while I certainly do not object to the \$25,000,000 that is being included for the emergency credit for farmers, and the coal bond, and 10 out of the 12 part... portions of this Bill. I do have a few reservations about the reapportionment Bill that is also included in there, but of course, as you well know, the

And while I do not object to the major portions of this Bill, I must oppose the manner in which it is I think it is disappointing that we see these good things being used in an effort to pass what we all know is the pay raise supplemental. And I do think that just an effort to make it somewhat easier to vote for that. think that we may be fooling ourselves, but we will not be fooling the public. This is just an attempt the issue, and I believe that it should be opposed. and unfortunately, it's methods like this that contempt by the public for the Legislature, and ultimately for the laws we enact. So, I would like to have а Call vote on this issue, please."

Speaker Giglio: "It's the intent of this Speaker to have a recorded Roll Call on this Amendment. Further... Further discussion? The Representative from Effingham, Representative Hartke."

Hartke: "Yes, Sir, Mr. Speaker. I'm opposed to this think we've worked very hard trying to put a farm Bill together, and I think this is another attempt to 050 the farmers. and I would urge you to vote against this Amendment. As I look through this analysis, it contains everything for everybody, including that pay raise, and I cannot go back to my district and say that I voted this. In spite of me being a hyphenated Sponsor on this Bill, if this Amendment does pass, I plan to withdraw as a Sponsor of that Bill, because I cannot justify voting for this Amendment. I urge that you defeat this Amendment."

Speaker Giglio: "Further discussion? The Gentleman from DuPage, Representative Hoffman."

Hoffman: "Thank you very much, Mr. Speaker. Ladies and Gentlemen of the House, I think we have to look at this Amendment for what it is. The issue that has been brought up by some of the previous speakers in terms of the pay raise is after The fact is that we all had an opportunity to participate in that issue. We did that during the Session, and this is just implementing law that is already in place. Voting for or against this Amendment doesn't anything in terms of indicating where you stand on any particular issue. It merely puts in place those things, particularly as far as the pay raise is concerned, already in law. And you will notice as you look through these other Sections, we have income tax refunds involved here. We have lottery prizes which wе have to appropriations to pay lottery prizes out of money that's collected. That is not automatic. As well as another... a number of other germane items. I did not support the farm Bill that left the House, and I don't think supporting this Amendment or opposing the Amendment says anything about position on the farm issue. I think that addressed and will be addressed when we deal with the substantive issue. This is merely the appropriation to put into place, into effect, the substantive legislation which passed, and it's for that reason that I rise in conjunction with Representative Matijevich and ask that you vote for Amendment #3 to Senate Bill 262."

Speaker Giglio: "Further discussion? The Gentleman from Cook, Representative Bullock."

Bullock: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. Senate Bill 262 and the Amendment 3 to 262, I believe, goes an awful long way to helping Governor Thompson meet his commitment for economic development as he outlined for this Assembly on several occasions. The three

items in the Bill that I think are most striking, in estimation, are the 8.1 million dollar authorization for aging and home health services, which is a major of this state administration. The Bill also provides 6.2 million dollars for the very, very needy in our those on public aid - as an income program, but more importantly, Governor Thompson has advocated for the state. the super conductor - semiconductor program, 'Permi' Lab study of a half million dollars is certainly something that we want to support in the State of Illinois. The semiconductor - super conductor program that Governor Thompson talked about is going to be a major economic development tool for central Illinois and for Illinois, and we need this study. And we need to let the 'Fermi' Lab get on with the study so that the Governor can. in fact, bring his program to the State of Illinois. for those of you who would want to be may sayers and nit pick. I think there's some major substance to Amendment. It's a bipartisan Amendment. It certainly is a step in the direction of helping the Governor achieve some of his objectives for moving our state ahead. And I would urge an 'ave' vote."

Speaker Giglio: "The Gentleman from MacLean, Representative Ropp."

Ropp: "Thank you, Mr. Speaker and Members of the House. The real tragedy of this particular Amendment is that nearly every issue that's on this Amendment is good, but the real problem is that when we wanted to deal with a real crisis, dealing with agriculture, and many of us had been working on it for several months, this Bill could have been passed a month ago. To think that we had to wait almost a month to put the appropriations into effect, and then to include in the whole vegetable basket, is certainly something that

I think is untimely at this point, and certainly has delayed the real intent of trying to help some people who desperately need some funds in order to put a crop in within the next week. And I certainly would see no major opposition to even drafting another Amendment to somewhat separate some of these issues. Frankly, I think I could support every issue, but I really don't like to support them all in one big bunch."

Speaker Giglio: "Further discussion? The Gentleman from Fulton, Representative Homer."

Homer: "Thank you, Mr. Speaker and Ladies and Gentlemen. One previous speakers, I think, in arguing for the passage of the Amendment actually hit on the reason why we ought to defeat it. He indicated that ordinarily, appropriation Bills are simply to implement substantive legislation on which we've already taken action. As you well know. there's no Member of this House that had an opportunity to take action on the substantive legislation which authorized the pay raise, and the reason for that is because of the peculiarity of the Compensation Review Board. When this General Assembly met in the waning days of the 83rd General Assembly, and as its last act, took action on that pav raise Bill, it had already been 'fait accomplished'. Senate's action in refusing to reject the pay board's report sealed the fate, and no Member of this House has had, yet, an opportunity to vote on the pay raise This will be our first, and perhaps only, opportunity to take the vote that we, I think, owe the people we represent to cast a vote on. So I think it becomes very clear that difference as to how you vote on this does make a Bill... on this Amendment, because by voting 'no', you saying that you are opposed to the action taken by the Compensation Review Board in the pay increase. If you vote

'yes', then you voted to confirm and ratify what that board has done. I think it's very clear that if we defeat this Amendment, that other Amendments will come back to us which will implement the appropriations in the farm Bill. Is there anyone here who would pretend that this vote, by voting 'no', would deny the implementation of that farm Bill by the appropriation? It will never happen. That appropriation Bill will be back before us. The vote is very simple. A 'yes' vote is for the pay raise. A 'no' vote is against the pay raise."

Speaker Giglio: "Further discussion? The Representative from Livingston, Representative Ewing."

Ewing: "Mr. Speaker and Ladies and Gentlemen of the several things have been said that caused me to rise and discuss this Amendment. First of all, we oftentimes together different appropriation Bills, but unless they are politically sensitive, they go right out of this Body with very little comment. It's been said that we are holding up aid to the farmers by tying this together. I can't buy that logic. because we still have to vote on the appropriation for the farmers, and it won't move any faster or any slower whether it's alone or together. Second, pay issue - and that's the real issue here, is the pay issue - and that is now in the courts. The Legislature has taken their action. I didn't vote for the pay raise. Hany of you people didn't, but I would say that probably all us in this Body have been accepting it each month, and how many of us have asked the Comptroller to set aside the raise in case the court called it unconstitutional? If we feel that strongly, maybe we should have taken that action. We have separation of powers in this state, and as I said, the issue of the pay raise is in the courts, and if the courts say what we did was unconstitutional, then it will

be back in our lap to take that action which is necessary to rectify the situation. And finally, all of us at down here do not agree with action taken by this General Assembly, but in the end, government must go on. fund government, and the will of the majority must control. And that's like saying that I will vote for appropriation because I didn't support the substantive legislation. Well, I can tell you, Ladies and Gentlemen, that we have never given my schools enough in my area. I have voted for that appropriation Bill because it was the only thing I could do. And I think that holds true with this Amendment."

Flinn: "Mr. Speaker, I move the previous question."

Speaker Giglio: "The Gentleman moves the previous question. question is, 'Shall the guestion be put?' All those in favor signify by saying 'aye'. 'Nays'? The 'ayes' have Representative Matijevich to close. Representative?" Matijevich: "Alright. Thank you. Not only that, if you really want to be responsible, we have already committed, by statute, these funds. Many of you remember one year that I made a mockery of the system when one of the Members vote 'no' on everything, everything.
