relates to emergency services and disaster agencies created
in townships in Cook County. With the adoption of

Amendment #1, there were a few problems created which
has... which needed to be discussed between the State

Emergency Services and Disaster Agency and the County of
Cook. With Amendment #2, those problems have been answered
and basically what Amendment #2 does is to provide that the
townships who wish to create an emergency service and
disaster area in Cook County must, within thirty days after
the enactment of this law, provide a copy of the report to
the State BSDA, and must also have an approved report, and

approved plan on file with the Cook County Sheriff's Office. It makes it really applicable to only one township in Cook... in Cook County... a township which currently does have and is the only township in the state that does have an emergency services and disaster agency. And I would move for the adoption of Amendment \$2."

Viason: "Madam Speaker and Members of the Assembly. the Gentleman's Amendment is an Amendment which has a negative impact on the concept of home rule in the State of Illinois. Now, it is also true that the Bill has a negative impact on the concept of home rule in the State of Illinois, but the Amendment doesn't cure that problem as it might have been intended to do and he needs a much Amendment to do that. The Bill still involves, even with that Amendment, adverse impact limitation of home rule powers and mandates on home rule units of government and other local units of government in the State of Illinois. I don't believe that we should permit this Amendment to go with the Bill because if we take this Amendment off the Bill, the Gentleman will have to come in with a Bill... with an Amendment which absolutely cleans up the Bill removes the impact and the cost on home rule and local units of government. Now, the Speaker has been forthright in condemning past efforts in this General Assembly to impose impacts on local units of government which raise costs for taxpayers at those local levels of government and he has adopted a program to strike at possibility that this General Assembly might continue its war on local governments. This Amendment that is on the

Bill now is part of a concerted effort against local government in the State of Illinois. By supporting my Motion to table you will be effectuating your constituents desires that we place local power in local hands and that we stop passing sweeping mandates and shipping the bill to the local taxpayers. I would urge a 'yes' vote on the Motion to table the Amendment."

Speaker Breslin: "The Gentleman has moved to table Amendment #1 to House Bill 33, and on that question, the Gentleman from Cook, Representative Terzich."

Terzich: "Yes, Madam Speaker. I wish I knew what the previous speaker was talking about. It was certainly kind Amendment #1, which was adopted unanimously in confusing. Committee, simply would stipulate that... is pertaining to the Indoor Clean Air Act, which was stated that it did not affect any home rule mandates and, therefore, the mandate wasn't even required, as stated by the ... under the State Mandate Act. What the Amendment only did is that it allows local government organizations to enact more strict no smoking regulations than those that are provided under the legislation. I'm sure that all of us are aware that some local units of government may want to incorporate no smoking because of either health or safety rules and, therefore, this Amendment simply allows the local unit of government to do that and certainly is necessary on this legislation and I would move that we vote against the Motion to table Amendment #1."

Speaker Breslin: "Representative McCracken, to the Motion."

McCracken: "Thank you, Madam Speaker. I rise in support of the

Motion and cite Rule 42 to the House, where it holds that

no Bill denies or limits any power or function of a home

rule unit unless there is specific language limiting or

denying that power. The fact of the matter is that House

Bill 33, as amended with \$1, falls within Rule 42. So the question becomes, 'Do you want to fully exempt or not have applied to home rule units HB 33 and then make it a simple 60 or 61 vote majority for passage or do you want to leave Amendment #1 on? It... Amendment #1 specifically. explicitly applies to home rule units of government and allows them to pass only more restrictive measures. It is clearly a preemption of home rule authority and if it on Third Reading does not receive 71 votes, then it would be appropriate to declare it not passed. So I move to table it at this time and you can proceed with a Constitutional Majority. I support the Motion to table."

Yes, Representative Terzich, the Amendment was filed just before we began on your Bill, but it has been printed and distributed. Representative Piel, on Amendment #2."

Amendment #2 basically is clarifying language that a public place does not mean a retail establishment that derives 75 percent of its income from the retail sale of alcoholic liquor, which means a... basically what we are doing is a bar that sells sandwiches would be classified in this category. And all that... the clarifying language on this is basically, you know, clarifying as far as what a liquor establishment or a bar is classified as and I'd ask for a... you know, affirmative vote on Amendment #2 on House Bill 33."
- Speaker Breslin: "The Gentleman has moved for adoption of Amendment #2 to House Bill 33, and on that question, the Gentleman from Cook, the Sponsor, Representative Terzich."

And so I would move that we do not adopt Amendment #2 and vote 'no'."

Speaker Breslin: "There being no further discussion,

Representative Piel is recognized to close."

Piel: "Thank you, Madam Speaker, Ladies and Gentlemen of the House. Madam Speaker, could we have some order here, please? It's beyond my comprehension why the Sponsor is opposing this Amendment. If he is in a situation where he says he hasn't had a chance to read the Amendment, hey, I'm willing to hold the Amendment and come back to the Bill tomorrow or later on today when he has had a chance to read it. But as far as, you know, using as an excuse he hasn't had a chance to read the Amendment when it has been printed and distributed on the Members desks, I mean that's sort of a flimsy excuse. What this basically states according to the Bill the way it is written right now, that a bar, tavern is classified as a public place. Very few times do you go into a bar where there are not people smoking. this would just be exempting a establishment that has... 75 percent of its income is derived from liquor sales being exempt from this Act. It does not exempt a restaurant, like the Gentleman was a little bit worried about that before. It doesn't exempt a restaurant, but it does exempt And I think it is a good Amendment. It's a fair Amendment. I was, you know, the Gentleman was in a discussion with Representative Vinson before. I'd be more

than happy to talk to him. If he has questions as far as the Amendment, I'll be more than happy to hold the Amendment until he has a chance to read it. But I would ask for a favorable Roll Call and I would ask for a Roll Call on this, Madam Speaker, on Amendment #2, please."

Ronan: "Thank you, Madam Speaker. This is a very simple Amendment. We were going to put it on in Committee, but it wasn't prepared in time so I'd like to add it now on the floor. Basically, what it does is it expands the coverage of what this legislation would handle dealing with infrastructure rebuilding where we can also include financing for transit and solid waste facilities. It also clarifies some further language dealing with community

involvement. I'll be glad to answer any questions concerning the Amendment."

Speaker Breslin: "The Gentleman has moved for the adoption of Amendment #1 to House Bill 241, and on that question, the Gentleman from DeWitt, Representative Vinson."

Vinson: "I wonder if the Sponsor might yield for a question?"

Speaker Breslin: "He will yield for a question."

Vinson: "Representative, do I understand the Amendment to mean that you have given up on the idea of getting money from the Federal Government and now you are after some state source of funds for infrastructures?"

Ronan: "No, Representative Vinson. I have tremendous faith in the Reagan administration. I'm going to take your lead and I'm going to put my future in Ronald Reagan's hands and I assume that he's going to just send a big pot of money here to Illinois."

Vinson: "And is the real purpose of the Amendment... is the next one going to be a build Illinois Amendment?"

Ronan: "Representative Vinson, as you are well aware, we are for build Illinois, as long as those dollars go where they are needed, including your county and some of the other fine counties in this state because I know it's going to go to your county."

Vinson: "Thank you."

Speaker Breslin: "Representative Mautino, on the Amendment."

Mautino: "Will the Gentleman yield?"

Speaker Breslin: "He will yield for a question."

Mautino: "Representative Ronan, would you please explain to me the provisions on the twenty percentiles used in the categories for those communities that can use these funds?"

Speaker Breslin: "Representative Mautino, do you have a question of Representative Ronan?"

Mautino: "I posed my question, Madam Speaker. I didn't get a

response yet."

Roman: "Yeah, Madam Speaker. I'm looking at the Amendment right now. I'll be right there with a response. The intent of the Amendment, it says that 20 percent of the financing of this program must be given to 20 percent of the communities in this state who are most in need of it. So it limits it to 20 percent of the financing of the program."

Speaker Breslin: "Representative Mays, to the Amendment."

Mays: "Thank you very much, Madam Speaker. Will the Sponsor yield for a question?"

Speaker Breslin: "The Gentleman will yield for a question."

Mays: "This is more or less a followup on Representative Mautino's question. On page two, lines 15 through 24, there is three qualifiers on this thing as to... as to what, who is going to be eligible for this pot of funds?"

Ronan: "Madam Speaker, I can't hear the question."

Speaker Breslin: "Representative Mays, would you repeat your question? Ladies and Gentlemen, we are having difficulty hearing on the floor again. Representative Mays to repeat his question."

Mays: "Thank you very much, Madam Speaker. Mr. Sponsor, on page two, lines 15 through 24, are basically, as I read it, criteria for determining eligibility for this... these monies, for infrastructure repair. Is that correct?"

Ronan: "Yes, they are."

Mays: "And a given unit of local government must meet two of the three criteria set forth in this Bill. Is that correct?"

Roman: "That is correct."

Mays: "Have you any idea what cities would be... would fall within these categories or what units would not?"

Ronan: "Representative Mays, what we are going to do is we're going to strike that Section of the Amendment so that what I'll do is I'm going to hold the Bill until I can remove

Mays: "Thank you very much."

There being no further discussion, the question is, 'Shall

Representative Ronan. Representative Bonan, a fiscal note
has been filed on this Bill also at this time, the request
for the fiscal note, I should say. The Bill, therefore,
remains on the Order of Second Reading. House Bill 335,
Representative Ewing. Clerk, read the Bill. Out of the
record. House Bill 337, Representative Ewing. Clerk, read
the Bill."

Clerk Leone: "House Bill 337, a Bill for an Act to amend the Agricultural Areas Conservation and Protection Act. Third Reading of the Bill."

Speaker Breslin: "Representative Ewing."

Ewing: "Mr. Speaker... Madam Speaker, Ladies and Gentlemen of the House, House Bill 337 amends the Ag Areas Conservation Act and basically it provides for how additional land can be added to ag areas. It provides for the reporting of counties when ag areas are created within a county to the state. It also asks the county boards to report to the county when an ag area is eliminated, when it is removed. These... Bill is basically a cleanup of the Ag Areas Act

that we passed a few years ago. Passed out of the Committee overwhelmingly and I would ask for your consideration, favorable consideration."

Speaker Breslin: "The Gentleman moves... has moved for passage of House Bill 337, and on that question, is there any discussion? There being no discussion, the question is, 'Shall... Representative Cullerton, did you... Do you have your light on?"

Cullerton: "Yes."

Speaker Breslin: "Ckay. Mr. Electrician, would you check that because it's not flashing up here. Representative Cullerton, on House Bill 337."

Cullerton: "Yes, will the Gentleman yield for a question?"

Speaker Breslin: "He will yield for a question."

Cullerton: "I have no further questions."

Speaker Breslin: "Representative Ewing."

Ewing: "Madam Speaker, I would like the record to show on this Bill and I would like to state for the record that the Bill is not the intent of this Bill to preclude the use of land within an agricultural area for placement of utility lines or easements, substations or related facilities which are required to meet the health, safety and energy needs of the people of the State of Illinois. And I read that into the record to make it absolutely clear that we are not in any way affecting the eminent domain powers of public utilities."

Speaker Breslin: "The question is, 'Shall House Bill 337 pass?'

Bill 480, Representative Klemm. Clerk, read the Bill."

Clark Leone: "House Bill 480, a Bill for an Act to amend the Revenue Act. Third Reading of the Bill."

Speaker Breslin: "Representative Klemm."

Klemm: "Thank you, Madam Speaker and Ladies and Gentlemen of the House Bill 480 attempts to allow some procedure for people wishing to change their mailing address on real estate tax Bills. Presently, there is no real law that allows a procedure for people to properly have their tax bills sent to a correct or a new address. anybody can go to a county treasurers office and if he or she knows the real estate property tax number they can have that tax bill mailed to any address they wish. They don't have to have any relationship to the property. They even have to know the owner. They don't have to even be involved whatsoever. If we carry that to an extreme case, this could result in the rightful owner of not receiving a tax bill, not paying their taxes inadvertently and losing the property in a tax sale. This establishes a simple procedure that the county treasurer or county collector would be able to at least know that those people who submit the request for changing the property tax mailing address for that bill at least has an interest in the property. And I'll be happy to answer any questions."

Speaker Breslin: "The Gentleman has moved for passage of House Bill 480, and on that question, is there any discussion? There being no discussion, the question is, 'Shall House Bill 480 pass?' All those in favor vote 'aye', all those opposed vote 'no'. Voting is open. Have all voted who wish? The Clerk will take the record. On this question there are 106 voting 'aye', 3 voting 'no' and none voting 'present'. This Bill, having received the Constitutional Majority, is hereby declared passed. House Bill 528,

Representative Flinn. Clerk, read the Bill."

Clark Leone: "House Bill 528, a Bill for an Act to Amend the Illinois Credit Union Act. Third Reading of the Bill."

Speaker Breslin: "Representative Flinn."

"Madam Speaker, thank you and Members of the House. Bill 528 amends the Illinois Credit Union Act to the extent that it adds groups instead of limiting it to groups and the definition of 'common bond'. It will also... the also puts the state chartered banks ... I mean the state chartered credit unions in the same posture as the federally chartered credit unions and that they can make change by rule as opposed to law. Right now the chartered credit unions must go... come back to Legislature each time they make a change and the federal chartered credit unions do not. And I would ask for a favorable vote and try to answer any questions if there are I know of no opposition."

Speaker Breslin: "The Gentleman has moved for passage of House Bill 528, and on that question is there any discussion? There being no discussion, the question is, 'Shall House 528 pass?' All those in favor vote 'aye', all those opposed vote 'no'. Voting is open. Have all voted who Have all voted who wish? The Clerk will take the record. On this question there are 105 voting 'aye', 1 'no' and 1 voting 'present'. voting This Bill, having received the Constitutional Majority, is hereby declared passed. House Bill 555, Representative Woodyard, Clerk, read the Bill."

Clerk Leone: "House Bill 555, a Bill for an Act to amend Sections of the Agricultural Fair Act. Third Beading of the Bill."

Speaker Breslin: "Representative Woodyard."

Woodyard: "Thank you, Madam Speaker and Members of the House.

House Bill 555 is the result of several meeting that

transpired starting last November with the Illinois County Pair Association in an attempt to give the county fairs in the State of Illinois some relief from the financial problems that they have had. The Bill does, basically, three things. We have changed the formula and the method of reimbursement to the county fairs up to 66 two-thirds percent of what we call an authorized base predicated on the amount of agricultural premiums that they have paid. The second thing that this Bill does is to increase the amount of capital money reimbursed to the county fairs where they improve whether it be horse barns, race tracks or so on. The third thing the Bill does is to allow those ten large fair and expos more flexibility in the use of their reimbursements. As of right now, their particular reimbursement only allows them to use their money for capital projects and we are saying within this Bill that they would be able to use that reimbursement for things other than capital improvement and certainly the ... for agricultural premium funds. There will be absolutely no appropriation in conjunction with this Bill. The Bill actually would not trigger into effect until Fiscal 1987. That's basically what the Bill does. I would be glad to answer any questions on it."

Speaker Breslin: "The Gentleman has moved for the passage of House Bill 555, and on that question, the Gentleman from Madison, Representative McPike."

McPike: "Thank you, Madam Speaker. Is this Bill on Short
Debate?"

Speaker Breslin: "Yes, it is."

McPike: "I would request that it be removed from Short Debate."

Speaker Breslin: "The Gentleman is joined by the appropriate number to remove this Bill from the Order of Short Debate.

It is, therefore, on Third Reading, regular debate.

Proceed, Representative McPike."

McPike: "Will the Gentleman yield?"

Speaker Breslin: "The Gentleman will yield for a question."

McPike: "How does money get into the Agricultural Premium Fund?"

Woodyard: "I'm sorry, what?"

McPike: "How do we fund the Agricultural Premium Fund?"

Woodyard: "The Agricultural Premium Fund is funded by parimutuel betting in this state and the county fairs were the first people that were funded out of the Ag Premium Fund in 1927."

McPike: "Okay, so that the money goes into the Ag Premium Fund comes from horse racing, and out of the Ag Premium Fund, what do we pay? What do we pay for from the Agricultural Premium Fund?"

Woodyard: "Into county fairs?"

McPike: "County fairs, what else?"

Woodyard: "We pay for... now, I'm guessing, Representative, and
I'm not sure, but I think we pay for some veterans'
scholarships. I know we pay for some capital operating
costs in McCormick Place... several funds."

McPike: "McCormick Place, yes. And civic centers."

Woodyard: "And civic centers."

McPike: "And what is the cost of this Bill in FY '87?"

Woodyard: "Approximately 1.2 million dollars."

McPike: "Thank you. Madam Speaker, to the Bill."

Speaker Breslin: "Proceed."

McPike: "There... really, the question before the General Assembly, for each and every one of your districts, is how do you want to spend the money that we skim from horse racing around the state? How do we want to spend this money? Last year we increased the amount of money to civic centers. We have authorized about ten new civic centers. There is probably another ten Bills in this year to

authorize new civic centers. Those civic centers, the new civic centers are funded from the Agricultural Premium and we have a seventy-five million dollar debt limit so that as those bonds are paid off, we are allowed float more bonds to pay for new civic centers. We pay of approximately four million dollars in bonds every year. have refused to raise that debt limit from 75 million to 80 to 90 or to 100 because we simply can't pay for those bonds so we have frozen the debt limit at 75 million dollars. There are a lot of Members in this General Assembly that have pet projects in their districts to build new civic centers. Those civic centers will not be built if we are going to spend the money on county fairs. There are a lot people from Chicago that are anxious to pav off McCormick Place. That would be leopardized if we spend more and more money for county fairs. There are some people that think that the excess that goes into the Agricultural Premium Fund should be returned to the General Fund so that we can fund education, mental health and everything else we provide for in this state. So this is a matter of priorities. This does not fit with mу I don't think that we should spend more and more money for county fairs. I don't think we can afford a million dollars for country fairs for operating costs. already take most of the money that we skim from horse racing, most of the money that we skim from horse racing in Cook County and in Madison County and we give that to a 11 the county fairs all over the state. I think it's about time that we realigned our priorities and stop skimming all this money simply to spend on county fairs, start spending it for some civic centers, for education and mental health and the other proper functions of state government and not continue to bear the burden that should be borne by local

counties. So I would oppose this Bill."

Speaker Breslin: "The Gentleman from Cook, Representative Bullock."

Bullock: "Thank you, Madam Speaker. Will Representative Woodyard yield for a question?"

Speaker Breslin: "He will yield for a question."

Bullock: "Representative Woodyard, when this Bill was in Committee, who testified in support of it?"

Woodyard: "Representative, I don't recall specifically, but this
Bill is supported by certainly the Illinois County Fair
Association, Department of Agriculture and, quite frankly,
an awful lot of county fair board members all over the
state."

Bullock: "And it's... you are representing to the Body that the Department of Agriculture now supports the Bill?"

Woodyard: "Yes."

Bullock: "Perhaps our staff analysis is incorrect. It indicates that the Department is neutral, but I'm sure Representative Ropp has some influence in that Department. Madam Speaker, and Members of the Assembly, first of all, I'm chagrined as how this Bill could come out of the Agriculture Committee and be placed on Short Debate when it has such a devastating effect on exposition centers across the state. as the Majority Leader had indicated. I'm also chagrined that at a time when we are talking about the Build Illinois Program and the Governor has set up a horse racing task force to talk about a dying industry, we now have a Amendment... amended Bill before us which is a subsidy for county fairs over and beyond what they are presently receiving. I'm sure those of you who are from major metropolitan areas and who last Session fought to make certain that your local civic centers, whether they be in Rosemont or McCormick Place or Rockford or Springfield,

that you are going to take a close look at House Bill 555 and make your decision based on what is best for those civic centers in your home districts or in the districts adjacent to you. I respect Representative Woodyard for trying to represent his constituents and on this particular issue, I'm going to represent my constituents, and on this particular issue, we are in total disagreement. And I would urge those of you to look closely at the Bill and vote 'no' on House Bill 585 (sic - House Bill 555) as amended because it does a disservice to civic centers across the state."

Speaker Breslin: "The Lady from Sangamon, Representative Oblinger."

Oblinger: "Madam Speaker and Members of the General Assembly, I recall last year eight million dollars went up to the Chicago area for planning on the ... 1992 fair. There are a lot of us downstate here who are not going to be able to go to that fair every day or every time we turn around because we are going to have a lot of costs in addition to the admission charges. We go to our local county fairs and this is our option and that is where we want our money to If you can give eight million to a world's fair that we are not going to attend, I think you can give eight million to us downstate to attend our own fairs. There are some people who don't understand that we all aren't going to flock to metropolitan areas, and in answer to those people who have just recently spoken. I have a civic center in my district just as well as the rest of you, but I also have a county fair. We have been supporting our civic center for a long, long time. I think it's time that we looked to the rural communities for them to have some of the things they need. I would urge a 'yes' vote on this and I think most of you can understand that when

realize that our county fairs is to us what the world's fair is to you people in the metropolitan area."

Speaker Breslin: "The Gentleman from McLean, Representative Ropp."

I think it's very ironic that we talk about a lot of civic centers in the State of Illinois, when, in fact, we want to save money and spend on civic centers when there hasn't been a single one of them that has stayed out of the red. So I think it's quite interesting how we are very much concerned about that. Let's point the finger to the thing that we are really attempting to do here in terms of spending dollars and making some priority assessments. know, we spend a lot of money on social programs throughout the ... part of our state, a lot of 4-H fairs. FFA fairs. county fairs are training grounds for young people, young people who, in fact, are busy with their hands creating growing livestock, developing new projects. kinds crafts and so forth. And I can assure you that very little money for these people. These are the kinds of people who, frankly, will not need money in their later years because they have been involved in doing something illegal, corrupt or indecent. These are good, honest young These are the kinds of people that we ought to be spending dollars for. If the small amount of money that we spend for these kinds of programs in our county throughout the State of Illinois in comparison to what we spend in trying to prevent gang crime in other portions the state... It's also an economic development for many of our counties. A lot of small towns have county fairs. T÷. creates a center for a lot of activities both rural and urban. And I urge you to support this Bill because of contributions that it makes to keeping people together and

Hicks: "Yes, thank you, Madam Speaker. Could I have a question of the Sponsor, please?"

woodyard: "Well, in answer to that, I really haven't counted those. I want to think in the back of my mind maybe 65, 67 county fairs..."

Hicks: "Well, the analysis I have says it's 92 with the possibility of two additional ones down the road. You're actually talking about appropriation of a little over a million dollars, is that correct, in year '87?"

Woodyard: "In 1987, yes. In fiscal 1987."

Hicks: "So you're talking about spreading a million dollars over 84 counties. Is that correct?"

Woodyard: "That's correct."

Hicks: "So I... I would take it then that everybody's getting a little piece of that million dollars and that you're also looking at an appropriation two years down the road.

You're not trying to rush something through. Is that correct?"

Woodyard: "That's absolutely correct..."

Hicks: "Madam Speaker..."

Woodyard: "If a county fair wishes to put on the same size fair that they have put on in the past, they will get a little more money. If they want to reduce the size of their county fair, they'll get less money."

Hicks: "Madam Speaker, to the Bill."

Speaker Breslin: "Proceed."

Hicks: "House Bill 555, as I understand it to be, puts my county,

Jefferson County, in the biggest losing position of any county fair in the state. But irregardless of that, this Bill is talking about trying to help county fairs over the entire State of Illinois. As T mentioned, there will absolutely be no appropriation this Bill this year. It's an attempt to try to address a very, very serious situation all over the State of Illinois in trying to get our county fairs a little more money. Do you realize how long it's been since they've had any kind of increase? 1980. Well, you tell me how many other
