I'd appreciate the adoption."

Speaker Greiman: "Gentleman from Cook, Mr. Cullerton, has moved for the adoption of Amendment #1 to House Bill #1. On that, is there any discussion? The Gentleman from Lake, Mr. Churchill."

Churchill: "Will the Gentleman yield for a question?"
