It's a way of funding both the proposal to provide direct state grants to public radio stations, and adds money for the statute already on the books that provides the same amount of help for public television stations. I would appreciate your support for the Amendment. I'm happy to answer any questions."

Speaker McPike: "The Lady has moved for the adoption of Amendment #2, is there any discussion? The Gentleman from DeWitt, Representative Vinson."

Vinson: "Yes, Mr. Speaker, I would ask at this point that the Sponsor take the Bill out of the record at this point, and that we move to just moving those appropriation Bills for which Amendments are not on file, and move those to Third.

I think that might be more expeditious for a few minutes."

Speaker McPike: "Representative Currie, you've heard the Gentleman's request. Whatever you desire. Representative Currie."

I ask for your affirmative vote."

Speaker McPike: "The Lady has moved for the passage of House Bill 219, is there any discussion? The Gentleman from DuPage, Representative Hoffman."

Soliz: "The appropriation would provide for the building or the construction of a high tech center in... at 23 and Wels... Western in the 'Peilson' Little Village Communities in near west side of Chicago."

Vinson: "And is that appropriation from Capital Development Funds?"

Soliz: "That's correct."

Soliz: "My understanding is that that they are."

Hastert: "So..."

Soliz: "The only reason... the reason that this was not included

going the route of bypassing the Board of Review at the county level in order to get to the state level, because they can't afford to hire the type of appraisal service to present to the Board of Appeals which would establish an appraised value considerably less than that established by the local supervisor of assessments. I think that this Office of Appraisals properly funded as provided by this legislation would provide the kind of service that local units of government need. For some reason or another, this agency was created in 1980, has never been funded for one reason or another. I think the time is long passed for this to be accomplished. I ask for your support."

Speaker McPike: "The Gentleman moves for the passage of House
Bill 362. And on that, the Gentleman from Kendall,
Representative Hastert."

Hastert: "Would the Sponsor yield?"

Speaker McPike: "Yes, he will."

Hastert: "Representative, is the... is this in the Governor's budget?"

Wolf: "I don't believe it is at this time."

Hastert: "Thank you."

Speaker McPike: "The Gentleman from Livingston, Representative Ewing."

Ewing: "Mr. Speaker, Ladies and Gentlemen of the House, we have existed for 10 years without the expenditure of \$431,000.

I think we could probably exist another 10 years very well, and save that money for education or some other needed service. I would vote 'no'."

Speaker McPike: "The Gentleman from Cook, Representative Harris."

Harris: "Question of the Sponsor, Mr. Speaker."

Speaker McPike: "Proceed."

Hastert: "Yes, as a matter of fact, Representative, to the best of my recollection, last year there were several Amendments defeated, and I think in the year before, there were two Amendments defeated to the Bill."

Homer: "Alright. Did either of those Amendments have to do with the... with funding of the state laboratories or funding of the sanitarians in the State of Illinois?"

Hastert: "We funded the labs at the administrative level."

Homer: "Alright. So, none of those Amendments and in fact, to your knowledge, the General Assembly has not, in recent memory, refused a request by the Department of Public Health, to increase funds for its state laboratories or for the hiring of sanitarians in the State Department of Public Health. Is that correct?"

Hastert: "To the best of my knowledge, there have not been any negative votes to that aspect."

Homer: "Alright. I thought I heard on a radio report recently, and that's perhaps not the best source of information, that Dr. Turnoc, in discussing the salmonella situation, was somewhat critical of the General Assembly for not providing adequate funds and resources for these items. Are you aware of whether that is, in fact, Dr. Turnoc's position?"

Hastert: "I didn't hear that radio program."

Homer: "Alright. Did you know if that's his position?"

Hastert: "I didn't hear the program, so I'm not sure what the source is."

Let me just finally... I noticed peculiarity that differentiates this appropriation Bill from some of the others is that in the exactness or exactitude of the dollar amount requested. I think all of the others are rounded off to the nearest hundred. if not This Bill actually is broken down to thousand, dollars. the nearest penny. It's all the way down to 93 cents. was wondering if there was any significance to that."

Hastert: "Well. to answer your first question, many of the vacancies in the Department of Public Health and other departments that we've dealt with, many times the appropriation processes had removals of vacancies on side of the aisle - those initiatives - and sometimes on our side of the aisle."

Homer: "Well, as to the second... as to the question I just asked, the exactitude..."

Hastert: "I answered your first question, Representative"

Homer: "Okay, as to that second question, what is your answer?"
