Speaker McPike: "The House will come to order. The House will come to order. The Members will be... The Members will be in their seats. The Chaplain for today will be Rabbi Norman Kleinman of the Congregation B'nai Zion Synagogue of Chicago. Rabbi Kleinman is a guest of Representative Lee Preston. Will the guests in the balcony please rise and join us in the invocation?"

Rabbi Kleinman: "Oh Lord, we invoke Thy blessing upon the House of Representatives of the State of Illinois. Unfailing night follows day, which will again pierce the shadows with ever widening arcs of light. The revolutions of earth, planets, galaxies, like the infinitesimal atomic particles radiating energy in the orbits around the nucelli fill our minds with wonder. The precision and predictability tell us that we confront a reality vastly greater than any formula can contain. Oh mysterious, wise, manifoldly self-revealing God, oh life within creation and beyond it, as we contemplate and observe nature we pray for Your reign over us. We place ourselves under Your law. May the awesome, creative and ordering power, which we barely glimpse or comprehend help us become what our potential promises. May our lives acquire form, order and meaning where now endlessness, willfulness and chaos threaten. Oh Lord, in the daily rotations of this planet, we behold the... a vision of Your kingship. Speaker McPike: "Roll Call for Attendance. Take the record. 115 Members answering the Roll Call, a quorum is present. Representative Preston, you will have to sign in. Committee Reports."

Clerk O'Brien: "Representative Wolf, Chairman of the Committee on Personnel and Pensions, to which the following Bill was referred, action taken June 12, 1985, reported the same back with the following recommendation: 'Do pass' Senate Bill 966; 'do pass as amended' Senate Bill 791 and 1132."

Speaker McPike: "The Gentleman from Madison, Representative Wolf."

Wolf: "Thank you, Mr. Speaker. Mr. Speaker, with leave of the House, I would move to suspend the provisions of Rule 35 and allow Senate Bill 1132 to appear on a Supplemental Calendar. This has been cleared with the other side."

Speaker McPike: "You've heard the Gentleman's Motion. Is there any discussion? The Gentleman from Champaign, Representative Johnson."

Johnson: "This... This Motion should be considered first, and then I'd like to be recognized."

Speaker McPike: "Very well. You've heard the Gentleman's Motion. Is there any discussion? Being none, the Motion is to suspend the provisions of Rule 35 and allow Senate Bill 1132 to appear on a Supplemental Calendar. Hearing no objections, the Attendance Roll Call will be used. The Motion carries. Representative Johnson, for what reason do you rise?"

Johnson: "I guess on a point of order, simply to inquire of the Chair and the Membership as to proper procedure in... in our Committees. I have no desire to stir up a war, but I

think this is worthy of discussion. All I want to do is just factually describe what happened with respect to a Bill in our Committee today. In the course of the morning we considered and the Chairman fairly considered a whole series of Bills, including a number where the Sponsors of the Bill weren't there. They were handled by Members of the Committee and others who were in attendance. Representative Tate got to the Committee meeting even ahead of the Spokesman at 8 o'clock in the morning and was there for five or five and a half hours. He asked that a Bill, House Bill 1417, be placed on the appropriate order for consideration of that Committee. I gave that to the Committee... the Committee Clerk, the Committee staff person. Representative Levin, I believe, brought the same Bill to the attention of the Chairman, at least two and maybe three occasions. The subject matter of this important Bill, a time sharing Bill, was asked to be considered. At the end of the day with some of the Membership there and a quorum there, the Bill was considered - I think a minute or two before one thirty. Representative Tate then went to the microphone and described or started to describe what he felt was either an abuse of the Chair or improper consideration. At that point, the Chairman of the Committee recessed the Committee with nothing more and that Bill has not been heard at this time. I simply want to inquire and I think, perhaps, Representative Daniels, or Vinson or others want to inquire in a little more strong terms as to what the proper procedure is for Committees in that particular situation."

Speaker McPike: "Representative Johnson, I'm sorry to ask you to repeat, but were you making a point of order or simply a matter of discussion?"

Johnson: "I guess it's a point of order and a parliamentary

inquiry."

Speaker McPike: "State your inquiry then."

Johnson: "Inquiry is, was that matter that I just described properly handled by the Chairman of the Committee in conformance with the rules of this House?"

Speaker McPike: "Yeah, Representative Dunn, are you the Chairman of the Committee?"

Dunn: "That I am."

Speaker McPike: "Perhaps you could enlighten the Chair before we respond."

Dunn: "Well, for the enlightenment of the Members of the Committee and everyone interested in the subject matter of the Bill, which was raised momentarily ago, the first information I had as Chairman of the Committee, anyone wished the Bill called was when the lobbyist supporting the legislation mentioned the Bill to me, and I indicated to him I would try to squeeze it in. We were against the time deadline for calling. I put the Bill into rotation, which turned out to be the last Bill, at the earliest opportunity. There was an outburst. We were against the deadline to come here on the House floor. The Committee is recessed until 4 p.m. All Members are urged to be there. The Sponsor is urged to be there. The interested groups are urged to be there. We will meet at 4 and continue as long as we have good Membership to give everybody an opportunity to hear Bills. Bills were called all morning long - Democrat Bills, Republican Bills, Member... Committee Member Bills and no one ever requested that I call the Bill to which they refer, and I would have been happy to... to call. And I don't think there are any other disgruntled Members of that Committee on either side of the aisle. As a matter of fact, the Bill prior to this one, I was going around the Committee asking if any other Members

had Bills to be heard. And if the Gentleman had a Bill that he wanted heard all he had to do was ask me. That's what everybody else did, and they all got their Bills heard. We will be in Session at 4 p.m. If he wants to come back and call his Bill, he can sure do it."

Speaker McPike: "Excuse me. Representative Dunn, your Committee met at 9 a.m. and the House was postponed until..."

Dunn: "1:30."

Speaker McPike: "...1:30..."

Dunn: "...at our request."

Speaker McPike: "...at your request. So you meet for five and a half hours."

Dunn: "Five and a half hours continuously this morning. And on the only occasion I left the room, I left the room for about two minutes, and it was during that interval when I met the lobbyist who wanted the Bill called. And I put the Bill right up and called it. And the votes were there, if he... if he..."

Speaker McPike: "Thank you."

Dunn: "There's no controversy about the Bill. I think it'll be called this afternoon. So I don't know what the fuss is about."

Speaker McPike: "And the... And the Committee has been recessed until 4 p.m."

Dunn: "That is correct. And..."

Speaker McPike: "Thank you. Representative Daniels."

Daniels: "After you recognize Representative Tate on personal point of order."

Speaker McPike: "Representative Tate."

Tate: "Yes, thank you, Mr. Speaker. I had waited patiently in Committee for five and a half hours today. Several different Members... and I had put it on the list to have the Bill called. The Chairman of the Committee had allowed

other Bills, other Sponsors and... to call their Bills that were not present at the Committee, which is common practice in this chamber. And I consented as a Member of that Committee - went along with that. When I got to the Chair to hear my Bill and brought it to the attention of the Chair that I had waited five and a half hours, that several different Members had asked and I had asked the Clerk to put it on the Roll, he then had recessed the Committee when he knowingly... he did know that we had the votes to pass the Bill, and it's a noncontroversial Bill. And all I'm saying, and all... the inquiry of the Chair is, Speaker, are we going to... if we're going continue this nature of conducting business, then... then maybe we shouldn't even have Members attend meetings and let every other Sponsor handle every other Bill. And maybe that would suffice. But I object to sitting in a Committee that I serve on allowing other Members that aren't in attendance to have their Bills heard and not have the opportunity to hear my Bill because the Speaker (sic - Chairman), which, quote, unquote, told me that if I didn't shut up that he was going to recess the Committee. That's not fair. That's not right. And I resent that, and I ask the Chairman for a personal apology."

Speaker McPike: "Representative Daniels, are you seeking recognition on this point or on another point?"

Daniels: "Yes, Sir."

Speaker McPike: "Representative Daniels."

Daniels: "On this point."

Speaker McPike: "On this point. Proceed."

Daniels: "Well, Mr. Speaker, of the many, many Committees that we have in the House, this Committee, run by this Chairman, has received the most complaints of any Committee in the House. There are 33 Committees in the Illinois House of

Representatives. And over and over again, this is the one Committee that we receive more reports of abuse on. One of my assistant leaders came in this morning, totally separate from this one, to explain what he considered the abuse to have been afforded him at the hands of the Chairman. This is a man who has designs, as we understand, to become a Judge. This is a man who's now talking that he doesn't know if he's going to run for reelection because he wants to be a Judge. Well, maybe this is a kind of judicial temperament that the Gentleman would show if he exceeds or if the citizens of his area were to place him in that trusted position. I guess we'll have to see. But one thing we do know is the man that we're talking about, the Chairman of this Committee, is a man that's running it in a very shoddy fashion, that has no concern for the Members of the Committee, has no concern for the process that we're talking about. And the Bill that Mr. Tate is talking about happens to be one of great interest to the citizens of this state. And, yes, the Chairman, himself, has just told you it's relatively uncontroversial. Yes, Mr. Speaker, I do think that the Chairman owes Mr. Tate an apology, and I think it should be forthcoming immediately."

Speaker McPike: "Representative Matijevich."

Matijevich: "Mr. Speaker, Ladies and Gentlemen of the House, I think all of this is a real waste of time. The reason I say that is, I'm no different than anybody else here. I have waited in Committee this Session for four hours too. That's part of the political process. It is true that there are more complaints, I'm sure, from the Judiciary Committee than any other Committee. But what are the complaints? The complaints are about waiting. Now, I think that if you are going to be a State Representative, you can't expect to come into a... into a Committee room

and expect your Bill to be heard right away. We'd all like that to happen. If any of you have been Chairman, you know that's a difficult job. You cannot be fair to everybody. It is impossible. Also, every Judiciary Committee through the years has had similar complaints. This is not a complaint against John Dunn. John Dunn is a fair person. Many Committees also have a policy that they wait for Bills that are sponsored by the Members of the Committee, because they have to be there. That's not a bad policy. Other Committees do that too. Mr. Speaker and Ladies and Gentlemen of the House, I think we ought to go on with the business of the House. All of this discussion was unnecessary. Committees are run fairly. They're run fairly to the other side of the aisle. All you have to look at is the number of Bills sponsored and passed by Republicans in this Session, and you know that you have been treated fairly."

Speaker McPike: "The Minority Leader has spoken to this very clearly. Some Members of the Committee have spoken. The Chairman has spoken. The Chair would prefer not to recognize another six people that are seeking recognition. So to answer Representative Johnson's point that he made, I think the Chairman answered that the Committee is in recess. The Bill will be heard later this afternoon. The only comment the Chair would make is that for the most part, if you're a Member of a Committee, out of courtesy, Members who are not Members of that Committee, their Bills are heard first, because the point is a Committee Member must sit there and hear every Bill until the end of the Committee. And so, traditionally in the House, we have asked the Committee Members to wait until last to have their Bill heard. The Committee will convene then at 4 p.m. Representative Vinson, for what reason do you rise?"

Vinson: "Well, Mr. Speaker, I listened to Mr. Matijevich's comments with some interest on this, because the key thing he seemed to say was that you can't treat all people fairly. Now it seems to me that what you are saying from the podium is that you're endorsing Mr. Dunn's conduct, and I find that disturbing, because in the past the podium has conducted this chamber in a reasonable fashion. When a Bill is called and then... in a Committee and the Sponsor's there to present the Bill, and then the Chairman recesses the Committee and denies the Sponsor the chance to hear the Bill, I don't think that's right. It's not a proper temperament for the Chairman of a Committee, let alone some other office. And I don't think that you should suggest that that has the approval of the Speaker."

Speaker McPike: "Representative Cullerton."

Cullerton: "Yes, thank you, Mr. Speaker..."

Speaker McPike: "State your point."

Cullerton: "Ladies and Gentlemen of the House, in response to Mr. Vinson, I would ask that we waive the posting requirements for Senate Joint Resolution 31 for tomorrow's Judiciary II Committee meeting, and this has been cleared with the other side."

Speaker McPike: "Representative Cullerton, are you rising for a Motion?"

Cullerton: "Yes."

Speaker McPike: "Would you state the Motion again?"

Cullerton: "Yes, I'm sorry that you didn't catch it. This is a Motion to suspend the posting requirements for Senate Joint Resolution 31. This Bill... This Resolution was passed by the Rules Committee today. It's been assigned to the Judiciary II Committee for tomorrow. We need to waive the posting requirements so we can hear it."

Speaker McPike: "Have you cleared this with the Minority

Cullerton: "That's correct - who sits next to Representative Vinson."

Speaker McPike: "Is this... Who's the Sponsor of the Joint Resolution?"

Cullerton: "Representative Greiman."

Speaker McPike: "Thank you. Is there any discussion on the Motion? Representative McCracken."

McCracken: "I've been told that we're opposed to it. I was under the wrong impression when I gave my assent, and I respectfully withdraw my agreement."

Speaker McPike: "Representative Cullerton, there are objections. Leave has not been granted. Do you wish a... to move on the Motion?"

Cullerton: "Yes, I would. Perhaps I should wait until the Sponsor of the Senate Joint Resolution, Representative Greiman, is on the floor though. So I'll renew that Motion at a later date - at a later time today."

Speaker McPike: "The Gentleman withdraws his Motion. The Gentleman from Madison, Representative Wolf."

Wolf: "Thank you, Mr. Speaker. Mr. Speaker, with leave of the House, I would now move to suspend the provisions of Rule 35 to move Senate Bill 1132 from Second Reading First Legislative Day to Second Reading."

Speaker McPike: "You've heard the Gentleman's Motion. Is there any discussion? There being none, the Motion is to suspend Rule 35 to move Senate Bill 1132 from Second Reading First Legislative Day to Second Reading. Hearing no objections, the Attendance Roll Call will be used. The Motion carries. Read the Bill, Mr. Clerk."
