We shall be led in prayer today by Father Charles Kyle, Pastor of St. Francis Xavier Catholic Church in Chicago. Father Kyle is a guest of Representative Bruce Farley. Will the guests in the gallery please rise to join us in the invocation?"

Father Kyle: "In the Name of the Father, of the Son, of the Holy Spirit. Amen. Heavenly Father, we ask Your blessings today for the Leadership, the Members and the staff of the Illinois House of Representatives. Grant them wisdom so that the laws which they enact may serve the best interests of all the people of this state. Grant them courage to always base their decisions upon high principles. Fill them with compassion for the poor and the needy. Give them patience that they may be considerate of each other's feelings as the last weeks of Session become hectic. Grant them humility that they may always place the common good of the state above their personal ambitions. Lord, we ask You also to bless the families of the Representatives. Fill their families with love and understanding as the needs of the state cause them to sacrifice some of the time the family spends together for the good of the state. In faith, we ask You to pour forth Your blessings and love upon this 84th General Assembly. Amen."

Speaker Madigan: "We shall be led in the Pledge of Allegiance by Representative Ropp."

Ropp: "I pledge allegiance to the flag of the United States of America and to the Republic for which it stands, one Nation under God, indivisible, with liberty and justice for all."

Giorgi: "No, Sir. No excused absences."

Speaker Madigan: "Mr. Piel, are there any excused absences?"

Piel: "No, Mr. Speaker, there are no excused absences today."

Speaker Madigan: "Mr. Clerk, take the attendance... Representative Stern, are you recorded? Mr. Clerk, take the Attendance Roll Call. There being 118 responding to the Attendance Roll Call, there is a quorum present. Mr. Clerk, Messages from the Senate".

Clerk O'Brien: "A Message from the Senate, by Mr. Wright, Secretary. 'Mr. Speaker, I am directed to inform the House of Representatives that the Senate has concurred with the House of Representatives in passage of a Bill of the following title, to wit; Senate Bill #1604, together with Senate Amendment #1, passed the Senate as amended June 13, 1985. Kenneth Wright, Secretary.'" "

Speaker Madigan: "Ladies and Gentlemen, if I could have your attention just for a moment. If I could have your attention. Our plan today is to take Motions to discharge Committee and Motions to take from the table. There are Motions which have already been filed, and they appear on the Calendar on page 23. In addition, we will hold open the Clerk's Office until 3:30 this afternoon for the purpose of taking additional Motions to discharge Committee or to take from the table and then we will publish a Supplemental Calendar. So you have until 3:30, about 20 minutes, to file those Motions with the Clerk and then we will publish the Supplemental Calendar. Okay, and at this time we will go to the Motions which have been filed previously. On page 23 of the Calendar, Senate Bill 1. Mr. Bowman."

Bowman: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I filed this Motion to discharge a couple of weeks

I felt, at that time, what was fair for a House Bill is fair for a Senate Bill. And if we were going to move that Bill to the floor of the House, we ought to move Senate Bill 1 simultaneously. If this Motion fails, I will be happy to consider the issue in the Committee next week when we consider the other higher education budgets. But, as long as this Motion has been placed on the Calendar and is being called at this time, I'm pleased to support the efforts of the Sponsors. And I will move to discharge my own Committee on this Bill"

Speaker Madigan: "Mr. Bowman, let me interrupt you for a second. The Chair recognizes Mr. Daniels for the purpose of an announcement."

Daniels: "Well, Mr. Speaker, as discussed with you, it's my pleasure today to welcome the members of the Great American People Show which is an Illinois theatrical company that has made a name for itself with their wonderful original plays that bring to life one of our great Illinoisians, and that's Abraham Lincoln. This year is their tenth anniversary year; and, if you and your family have not been to see them perform at New Salem State Park, this summer would be a great time to do so, as would it be for all the other Members of the House. This General Assembly has been supportive of the efforts of the Great American People Show to promote Illinois and all of its great attractions. The Great American People Show certainly fits the Bill, allowing us to visit an important time in our history while enjoying Illinois' foremost historical attraction, the New Salem State Park. Speaker Brunsvold: "Thank you. And I'd just like to note this young lady right here is the pitcher. She pitched every game. Thank you, Mr. Speaker, for the time in allowing us to introduce the girls."

three or four or five brothers and sisters who are given an award - and under the provisions of the Bill the award is to be paid over their lifetime, should one of those children die, under the Bill as it is currently written, the amount of money that child would have received right now under the Bill in its current status must go to the surviving brothers and sisters rather than go to the heirs of that decedent child, in other words, to devolve as per the individuals will or to his spouse or children, whatever the case may be. What Amendment #3 does is to provide that upon the death of that beneficiary, whatever amount he would have received had he lived goes to his heirs. He can leave his share to his spouse, to his children, the same as we leave our other property instead of it going to his brothers and sisters. And that's what the Bill does. It costs... It changes the Bill as far as physicians are concerned not one iota. It doesn't increase their burden or decrease it in any way whatsoever. And I ask for your 'aye' vote."

Speaker Madigan: "Mr. Daniels?"

Daniels: "Yes, Mr. Speaker, as the Gentleman knows, there's been few Bills that have had greater discussion and efforts at compromise than the Bill before you. This is Senator Rock's Bill, and he's asked me not to have it amended any further. And, therefore, I would have to oppose this Amendment."

Speaker Madigan: "Is there any further discussion? Those in favor of the Amendment signify by saying 'aye', those opposed. The Amendment fails. Amendment fails. Are there any further Amendments?"

Clerk O'Brien: "Floor Amendment #4, offered by Representative Preston, amends Senate Bill 1200 as amended on page four by changing line five to read as follows and so forth."

So that if a physician should, for some reason, say that... denies all the allegations in a complaint and some of those allegations are found to be true and that the physician knew that those allegations were true, the other party can sue not only that physician who lied but his or her attorney. And the same would be true of a plaintiff. If the plaintiff should misstate an allegation, not only can that plaintiff be sued, but his or her attorney can be sued. The importance of that provision is... would be to require lawyers to really second guess and investigate their own clients, which is really contrary to the whole jurisprudence system in this country, since we want to have the free ability of a litigant, either plaintiff or defendant, to confide without fear in his or her attorney. All this Amendment does is say that you can sue the lawyer if the lawyer knew that there was a false admission or denial. And I'd ask for your 'aye' vote."

They indicated to me at 11:00 yesterday that they could not come to the solution that I was suggesting and that they would have to proceed with calling the Bill. I indicated to them at that time that I was in opposition to the Bill. We went to Committee immediately upon adjournment and I indicated to the Representative and to others that I would call this Bill first so that it would have a full hearing. However, Mr. Speaker and Ladies and Gentlemen of the House, the man was called away to another Committee. He did return. I indicated at that time that I would call the Bill. We finished our business with all the Bills that we had posted. Before the Committee adjourned, I called the Bill. I held the Committee. I waited for the Gentleman to come back. I gave the Gentleman who is the Sponsor of this Motion full and ample opportunity to have this Bill called. I wanted to call it first. I wanted to call it last. I wanted to call it in the middle, but the Gentleman never returned. I don't think, Mr. Speaker and

Ladies and Gentlemen of the House, that the Gentleman's Motion to discharge Committee at this time is timely and is, in fact, out of order. And I would oppose the Gentleman's Motion to discharge Committee."

Speaker Madigan: "Mr. Tuerk."

Tuerk: "Well, Mr. Speaker, Members of the House, I would beg to differ with the previous speaker on his explanation. The Gentleman that's putting this Motion was in the room on three different occasions that day ready to hear the Bill. At the time that he was ready, willing and able to hear the Bill, there were other Bills under consideration and; therefore, he took his responsibilities elsewhere where he had Bills that he had to hear before Committees. First of all, I would like to know who is passing out materials here on the floor concerning this Bill, which I understand is illegal by House rules, first of all. We're talking about a kid that's halfway out, and you say, 'Well, go find another hospital'. Now, if that's not a right to life Bill, then I don't know what is.
