Significantly, with regard to the expansion project, the General Assembly should consider measures which will provide the maximum possible assurance that this project will be completed in the most responsible, cost-efficient. expeditious manner possible. Therefore, pursuant to Article IV, Section 5(b) of the Constitution of Illinois, I hereby call and convene the 84th General Assembly in Special Session to commence on October 2, 1985, at 12:00 p.m. in order to consider: (1) Senate Bill 1454 and the Amendments thereto: any other legislation or Resolutions dealing with the authorization of additional bonds for completion of McCormick Place Expansion Project, and appropriations needed for such project, and substansive legislations or Resolutions pertaining to the financing and operation or procedure of the Authority, and; (3) House Bill amended... as amendatorily vetoed. In witness thereof, I have hereto set my hand and caused the great seal of State of Illinois to be affixed, done at the Capitol in the City of Springfield the 16th day of September in the Year of Our Lord 1985, and of the State of Illinois, James R. Thompson, Governor. **
