Representative Matijevich, Chairman of the Committee on Rules, reports the following: Rules Committee reports a Resolution, Committee Resolution, with Amendment #1 through 5 failed; Amendment #6 was withdrawn; Amendment #7 failed; Resolution was reported 'be adopted' with 11 'ayes' and 7 'nays', and none voting 'present', action taken February 3, 1987 and reported back. Introduction of House Resolution 44, offered by the Committee on Rules, and will be placed on the Speaker's Table. No further business, the House now stands adjourned until Wednesday, February 4, 1987 at 11:30 o'clock a.m. And the House is adjourned."
