It was the individual who counted in the mind and heart of Abraham Lincoln. May these men and women who lead Illinois realize that have been called, that You have called them, to be aware that the individual person is the one who counts in the State of Illinois. Remind them, dear God, that with Leadership comes responsibility. Make each one οf feel responsible for those who they represent. Flinn — et al: "I pledge allegiance to the flag of the United

States of America and to the Republic for which it stands,

one Nation under God, indivisible, with liberty and justice
for all."

Speaker McPike: "Roll Call for Attendance. Representative Piel."

Piel: "Yes, Mr. Speaker, will the records show that

Representative Klemm is excused today."

Speaker McPike: "Representative Matijevich."

Matijevich: "Yes, Mr. Speaker, let the record reflect the excused absence due to official business of Wyvetter Younge."

Speaker McPike: "Representative Huff."

Huff: "Thank you, Mr. Speaker, I rise on a point of personal privilege. I was distressed over the holiday weekend to learn that our Governor had declared, in the matter of the Sox Stadium affair, that he would bleed and die before he would let the Sox leave Illinois. He also proposed that a potential site for the Sox would be my district, which is already entertaining the idea of being the host for the

Bears stadium. I just want to speak on behalf of my constituents that we'll also bleed and die before we let that suggestion come to fruition. I just want to suggest that if the Governor is persistent in this romanesque tradition. I would like to suggest that he seek the services of smiling Senator Howard Brookins, who is a first class mortician and funeral director. Thank you."

- Speaker McPike: "Take the record, Mr. Clerk. 116 Members answered the roll, a quorum is present. Page 6 of the Calendar under Motions appears House Resolution 1365, a Motion by Representative Goforth."
- Goforth: "Thank you, Mr. Speaker, I move to bypass committee and place on the Speaker's Table for immediate considerations.

This Resolution has been distributed to the Member's desk."

- Speaker McPike: "Is there any discussion of the Gentleman's Motion? Does anyone rise in opposition to the Gentleman's Motion? Gentleman ask leave to use the Attendance Roll Call. Gentleman... The Gentleman has leave. The Attendance Roll Call will be used. The Gentleman's Motion carries. House Resolution 1365, Representative Goforth."
- Goforth: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House, as you know last year when we was in the budget Session, at the very last minute the Department of Veterans' Affairs closed 24 offices. They told us on a House floor that day, that the trucks had already been sent out and no matter what we done about it, these offices would be closed. Especially down in the southern part of the State we've got 22 counties down there right now with a lot of Representatives; Representative Rea, Representative Phelps, myself; you know we... we have to drive 200 miles to see the veterans. Well, this is Veterans' Memorial Day and I think all this, all this does is ask the department, we've got a different director of the department now, he

met with us down there several times, he wants to have these offices reinstated, rearrange them and put them back. So I ask all of you for support. Thank you."

Speaker McPike: "Representative Rea."

Rea: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House, as one of the Sponsors of the Resolution, I strongly support it. I felt it was a mistake when the offices were closed and in my portion of the State and in many other portions of the State, especially where it's a rural area, many of our veterans will have to travel quite a distance cannot do it because of financial reasons, because of the handicaps that they may have, the widows, this has really created a serious problem and it's one that we need to deal with and it's one that we need to correct due to the fact that these are the people that have made our country what it is today. And I would strongly advise an 'aye' vote on this Resolution."

Speaker McPike: "Representative Mays."

Mays: "Thank you very much, Mr. Speaker, Ladies and Gentlemen of the House. I rise in support this Resolution but I think the Members ought to know that this is going to cost probably between five hundred and seven thousand dollars it is currently being proposed to take out of the central office for the Department of Veterans' Affairs. And I know that they don't have the money then to operate the Central So really when you vote for this Resolution I would sure hope you'll put a vote up there to effect and the impact this Resolution would have if followed through. I know the Department wants to do it but they have some tough budget choices as did every Department last year that they had to make. So I would just urge the Members to know if they vote 'yes' on this that they ought to be willing to come up with the dollars to...to staff and
