Legislature. Sections 8.1. Passage of Revenue Bills. (a) would...a Bill that would result in an increase of revenue to the state may be become law only by a Three-Fifths of the Members elected by each House of the General Assembly, Paragraph (b) Each House of the General Assembly shall have a Revenue Committee. It shall be and exclusive responsibility of the Revenue Committee to consider all Bills that would result in the increase or decrease of revenue to the state. A Bill pending in Revenue Committee must be approved by a majority of Members of that committee before it is sent to the full vote. House for consideration or Paragraph (c) shall be 25 Members of the Revenue Committee in the House Representatives.
