I did get it out of that committee, but it is a pension Bill and we have that policy that they've got to go to pensions. I move to commit 190 to the Pensions Committee."

Speaker Breslin: "The Gentleman asks unanimously leave to return House Bill 190 to the Pensions Committee. The Bill is now on House floor on Second Reading. The Gentleman asks that this be recommitted to the House Pensions Committee. Is there unanimous leave? Hearing no objections there is leave. Representative Hartke for what reason do you rise?"

The simple way of putting it is that many of the counties around the State of Illinois, the pet dog owners pay a certain fee. This fee is collected by the County Health Department. It is paid out for the kill of wild animals...domestic animals as they kill livestock

Mulcahey: "We are going to have the same amount of funds going to the fund as we have right now. Based on the number of domestic dog owners in the county who pay that particular license fee. Could be more next year, I don't know could be less."

Cullerton: "Well I thought the change would have the effect of including wild dogs, coyotes, and wolves to be include as dogs and therefore they would have to be registered as well."

Mulcahey: "No that's contrary, that's what we are trying to avoid. That's what this Bill will do. Will do eliminate that confusion that we've had in some counties around the State."

Cullerton: "Oh, I see so it would limit it to only dogs only the domestic variety."

Mulcahey: "That's correct."

Cullerton: "So are these, so you are suggesting that these wolves, coyotes, and wild dogs are not being registered right now and no one is paying this fee for them right now."

Mulcahey: "No I didn't, I absolutely refused to register my coyote last year."

Cullerton: "Madam Speaker, I think that this is an appropriate Bill to be the first Bill that we pass this Session, where we are changing the definition of a dog. I am only sorry former Representative Greimin wasn't in the chair when we had this Bill up."

Speaker Breslin: "Is there any further discussion? Hearing none the question is, 'shall House Bill 105 pass'. All those in favor vote 'aye', all those opposed vote 'no', voting is open. Have all voted who wish? Have all voted who wish?"

Speaker Breslin: "Representative Matijevich."

Matijevich: "Madam Speaker. Ladies and Gentlemen of the House, this Bill came about in the November election, my aide ran for the County Board and was victorious. And so I thought I should go to the County Board for their swearing in and organizational meeting because of that. At that particular meeting Lake County happens to be a County where there are an even number of county board members. As you know the organizational meeting where you pick the county chairman and the president of the forest preserve is probably the most important meeting because you really can't conduct business until that is done. Well what happened was that one of the county board members was physically disabled, suffering from cancer and they brought her into the room to vote for the county board chairman. They had three attendants, she was on a cot, and very, very ill and very, very weak. And the members were stretching out the business that was being conducted almost as if for the purpose that that the sick member couldn't carry on. When I went back to my office, I felt that something ought to be done about it. That nobody ought to go through that suffering anymore. She was suffering enough, dying of cancer. I thought that something ought to be done. So I introduced this Bill, so that for the purposes of organization only, only for organizational purposes that a

Speaker McPike: "The Gentleman moves for the passage of House Bill 180, and on that the Gentleman from DuPage, Representative McCracken."

McCracken: "Thank you Mr. Speaker, Ladies and Gentlemen of the House. I rise in opposition to the Bill. I agree with the Sponsor that this is not a partisan issue. Obviously this could cut both ways depending on who is under a disability. But I don't think we should allow an unfortunate, even tragic situation to be compounded by the adoption of an unwise law. I respectfully submit that because the particular instances in question, organizational meetings are so crucially important that we should not, in effect sanction what I think could be used in many situations to be a mere abdication of responsibility I can envision a situation where these proxy votes are used, sometimes, in the way you often see them used in big corporations. It makes voting on organizational matters a pro forma Act. There can be a small cadre a small inside group that could control more easily because of the availability of proxy voting. You see it in corporations where its use is very persuasive. I can imagine that there are even more tempting reasons to use it in the context of governmental and official duties. Again, I do not disagree that the particular circumstance is a tragic one, but I don't think

we can allow that to become any worse than it already is. Please do not make a bad law and complicate the tragedy which the sponsor relates. I am sorry but there can not be a remedy for every perceived wrong. This is one instance where the reported remedy is worse than the problem it seeks to correct."

Speaker McPike: "Representative Klemm. Representative Keane in the chair."

Klemm: "Well, thank you Mr. Speaker. I certainly am aware of the situation that happened in Lake County. It has happened in my county also, but having been a former County Board Chairman I realize that in all instances the people have been able to make the meetings if it is that important. And I remember one particular election where not having been present at the county board meeting while they were debating and discussing various candidates would certainly leave this absentee ballot approach to be totally inappropriate because that person would be absent, wouldn't be knowing what was going on in the debate. So, I share some concerns also and don't believe that that particular incident would be worthy of us to change the law. We don't allow it to elect our Speaker even in the House, we don't allow it, that I'm aware of, any other form of government where we have absentee voting in issues such as this. Also I think we have to be concerned about the precedent setting that this Bill may do. And I know it's well intended and I can understand the problem that occurred in Lake County but I don't think it is of a monumental nature that we must change the law, and I do stand opposed."

Speaker Keane: "Representative Matijeovich to close."

Matijeovich: "Mr. Speaker and Members of the House, I think if all of you would've attended that meeting, I think you would all vote 'aye' on this Bill. And the fact of the matter

I walked back to my office and said nobody, nobody ought to suffer like that. It is suffering enough to be dying, but to add that to it? No, No. So I appreciate your vote."

It was repeal September 21, of 1989. The reason for this Bill there is a fear by many that the blood supply has been contaminated due to the AIDS epidemic. This is an attempt to insure the source of blood used for transfusion is not contaminated."

Speaker Keane: "Is there anyone that stands in opposition? If not the question is shall House Bill 286 pass, those in favor vote 'aye' those opposed vote 'no', the voting is open. Have all voted who wish? Have all voted who wish? The Clerk, will take the record. On this Bill there are 112 'ayes', none voting 'no', none voting 'present'. Two of the communities that will be impacted most greatly by this proposed affiliation. So I would urge everybody to vote in favor of House Resolution 289."

Speaker Madigan: "Chair recognizes Mr. McCracken."

McCracken: "Thank you Mr. Speaker. Inquiry of the chair. Does this require 71 votes to prevail?"

Speaker Madigan: "Yes it does."

McCracken: "Thank you. I rise in opposition to the Resolution and its immediate consideration. Since we're not considering the merits of the Resolution, let me say only this. That this is a matter which has long been considered which has had substantial publicity back in Chicago and Cook County were these concerns have been voiced and addressed. And I have many grave concerns about this merger especially since in testimony it's been brought out time and time again that Rush Presbyterian had made an offer to the U of I and there seems to be a lot of contradictions between both parties. In my estimation there are a lot of questions that remain to be answered and I don't feel that we should be very hasty in allowing this situation to go ahead unchallenged. No law, varying the compensation of the services of the Senators and Representatives, shall take effect until the election of Representatives shall have intervened."; and WHEREAS, Article V of the Constitution of the United States allows the ratification of the proposed Amendments to the United States Constitution by the General Assembly of the State of Illinois; and WHEREAS, Article V of the Constitution of the United States does not dictate a time limit on ratification of an Amendments submitted by Congress, and the First Congress specifically did not provide any time constraint for ratification of the above-quoted Amendment; and WHEREAS, The Supreme Court of the United States in 1939 ruled in the landmark case of Coleman v. Miller that Congress is the final arbiter of the question of whether too much time has elapsed between Congress' submission of a particular amendment and the most recent state legislature's ratification of same if Congress did not specify a deadline on the proposal's consideration; and WHEREAS, Section 11 of Article IV of the Constitution of the State of Illinois provides that "Changes in the salary of a member of the Illinois General Assembly shall not take effect during the term for which he has been elected."; and WHEREAS, The General Assembly of the State of Illinois finds that the proposed Amendment is still meaningful and necessary as part of the United States Constitution and that the present political, social and economic conditions are the same as or are even more demanding today than they were when the proposed Amendment was submitted for its
