Matijevich: "Well, Mr. Speaker, I...you know, I sometimes like to grandstand myself, but truth of the matter is I have not seen a copy of that Resolution. I know the politics of the issue...Representative Johnson you want some help with the U. of I. You better get with it. We want to do things responsibly, not irresponsibly. I would tend to believe that if you act this irresponsibly on this issue without letting your Members see a copy of it. You must be acting irresponsibly on the U. of I. and no wonder they get in trouble. They get Representatives like you."

Speaker McPike: "Representative McCracken."

McCracken: "It doesn't take a rocket scientist to figure out that a 14.5 percent pay raise across the board is something we don't want. You don't have to wait until Tuesday to figure it out. Why inconvenience even for a weekend any resident of the State of Illinois?"
