1986 until his current appointment, he was in charge of the Regional Development and Inward Investment Division at the government in London. From that position he came to Chicago as the Counsel General. He has agreed to join us today. He has a few remarks to offer to our Members. So, if you could give him your attention. Mr. Mengay."

Counsel General Mengay: "Mr. Speaker, Members of the House. It's an honor, a privilege and a pleasure to address this distinguished House. The symbolism of doing so in the heart of America in the Land of Lincoln and under the Constitution, is not lost on me. And the invitation is evidence of the hand of friendship which this part of America, in particular, extends to strangers. I was relieved in the preparation of this...these few remarks, to be advised that Speaker...that Colonel McCormick's prohibition on the use of English and speaking American did not apply to this occasion. I could use my own language and I'm therefore doing so. I have also had the difficulty of maintaining my concentration for these remarks, after partying or 'bipartisaning' by the lake last night and after dinner at Sam's Bar, but at least I go away from Springfield with a very wide and close appreciation of the process here. It's all of a piece with the warm welcome which I've received since arriving and my wife and I likewise in Chicago. We value the diversity and richness of the fine state in which we find ourselves living, even though it's difficult to get use to our ten year old English daughter in the back of the car singing Illinois, Illinois, in a strong Chicago accent. Colonel McCormick would have been proud of her. But within the diversity of its ethnic traditions, the links between Illinois and Britain have been and remain strong. There may have only been twelve brief years between the Indian/Franco/British

Wars of 16...1764 and the Revolution, a brief period of British governance in this area, but they do remain deep. You have not only the Montesquieu and the constitutional situation that's derived from that, but I've been impressed to learn that Blackstone, the distinguished English lawyer, is still very much imbedded in the legal tradition of this area. Our peoples have shared together the turmoils of the century and now face exciting challenges, some rather worrying perhaps, to the East and to the West in the world. Our citizens increasingly visit with each other and I'm glad to see that the air traffic between Chicago and Britain is rising, evidence that there is an appreciation of the attractions of Illinois for our citizens. Our trade has always been substantial and never more so than today. We take in Britain nearly eight percent of Illinois' exports. We take around a quarter of your exports to the European community, and of course there's a flow, almost a torrential flow of investment now. We have some sixty billion dollars worth of American investment in Britain, nearly a third of your investment in the European community and we value that. In the last few years our investment flow is increased in this direction. Of course we now have some ninety billion dollars worth of investment in the United States. That shows great confidence in your nation. We put three percent, almost three percent of our G.D.P. in your hands last year. The published sources suggest that some hundred and twenty-nine Illinois companies are operating in the U.K. My office is closer to the ground than these published sources and we reckon we have contact with some two hundred and four Illinois companies who are operating within...with in a genuine invested sense in the U.K. And of course of the nine hundred and ninety-six European companies that operate here, two hundred and

twenty-two are British in Illinois. We don't see this investment as a win/lose phenomenon. We don't see that we're exporting British jobs and we don't fear that you are going to dominate the British economy. We see as a win/win, a benefit on both sides. We see it as the interaction between two similar economic systems and it works as a pendulum, sometimes you have more, sometimes we have less. Last year for example, your U.S. trade balance moved into a positive position, we moved negative to you. In Europe, of course, when I embarked on an exciting journey to 1992 and the U.K. is committed to that journey, we intend that it should be a Europe open for business and not suffocated by regulation. We are also committed to the expansion of those benefits by sharing them with our trading partners, not least the U.S, and it's a large part of my time I spend encouraging Illinois companies to take the opportunity that's offered by 1992. That's why we're committed to the removal of impediments to trade and investments and to resistance to new measures. We want a free flow. And that's why it's a matter of regret and tragedy when sometimes there are investment regulations of one kind or another that destroy jobs. We intend, therefore, to enter the 21st century with even closer ties to the heartland and to the Land of Lincoln. As I began by saying, I will end by emphasizing that the richness of this interaction is not entirely and solely economic, important though that is. There is a cultural and intellectual exchange. It's my privilege and excitement to serve on the Committee of the Marshal Scholar selection in the midwest each year, and meet the very fine people who come forward from the colleges of this area seeking a year or so studying in Britain. It is cultural, intellectual, it's political and personal. All of these are vital links and
