And it also establishes and allows for the transfer to the State of Illinois GRF the amount the Board deems in excess reserves of the reserves funded under Public Act 82-1072 of last Session. Black: "Thank you very much Madam Speaker. An inquiry of the Chair. The Amendment does not seem to have been distributed over here. Could you have the Clerk check?"

Department of Corrections. Essentially it would set up counseling programs that require the Department of Corrections to develop sexual abuse counseling programs for both sexual individuals who are victims of sexual abuse and individuals who are sexual offenders. The Department of Corrections has no problem with this, they could use existing personnel to do this, and therefore I ask that House Bill 202 be passed."

Speaker Satterthwaite: "Representative Curran."

Curran: "Thank you Madam Speaker. Questions for the Sponsor, Madam Speaker?"

Speaker Satterthwaite: "The Gentleman indicates that he'll yield for a question."

Curran: "Representative Hoffman, on this first Bill of yours, are you aware that there's a considerable amount of controversy whenever you talk about the problem of juvenile sexual offenses?"

Hoffman: "Yes, Representative Curran, but I think that it's time that the State of Illinois and the people of the State begin to address this problem. I think this Bill does that."

Curran: "Madam Speaker, to the Bill. Representative Hoffman has placed before the General Assembly this year an extremely super-controversial piece of legislation that really affects my district. I would like you all to understand that I have started a sexual abuse program here in Sangamon County largely at the instigation of Representative McCracken a couple years ago. It's called the Children's Advocacy Center and, by golly, I'm a little bit concerned that the Children's Advocacy Center might be threatened by this legislation, and so I'd ask all Members before we really have an opportunity to look closely at this Bill to vote 'present' and maybe we'll get a chance to look at this

Bill again next year or even some year far in the future. But for a first Bill to do something this controversial, Madam Speaker and Ladies and Gentlemen of the House, I think is absolutely unconscionable."

Speaker Satterthwaite: "The Gentleman from Fulton, Representative Homer."

Homer: "Well, Madam Speaker, I have to concur with the previous Speaker. I read this Bill and it talks about sexual counseling being ordered to be done in facilities throughout the state of juveniles. And I don't know that we want to get in the business of ordering sexual counseling to juveniles. So, the Gentleman has a first Bill here but I think we should be very judicious as we vote and be very contemplative before you would want to vote a green vote on this Bill."

Speaker Satterthwaite: "The Gentleman from Vermilion, Representative Black."

Black: "Thank you very much Madam Speaker. Will the Sponsor yield?"

Speaker Satterthwaite: "He indicates he will."

Black: "Thank you. Representative, is there a parental consent aspect to this Bill? If you are going to involve juveniles in sexual abuse counseling, is there no parental consent provision in your Bill?"

Hoffman, J.: "No, there is none. It would require for individuals who have been sexually abused, or sexual offenders that the Department of Corrections offer this counseling."

Black: "So you are absolutely usurping any and all authority of the parent over this individual just because they've been committed to the Department of Corrections. Is that right?"

J. Hoffman: "Well, I don't think that we're not talking about

safe sex here we're talking about teaching sexual..."

Black: "Well, I think we could argue whether any sex is safe. But we'll save that for another day. Let me ask you another question. What's the genesis of this Bill? Where'd this Bill come from?"

Hoffman, J.: "Previously to be in the elected as a State Representative I was Director of Probation St. Clair County. As part of those duties, we ran juvenile probation as well as the detention center in St. Clair County, and that was the Department of Corrections Juvenile Division. In those...there is a void right now for addressing this type of issue and that's where it comes from."

Black: "Ah ha. Now I think we get to the root of the, perhaps, the ultimate evil of this Bill. Is this simply an attempt to transfer the cost of these programs from the county to the State Department of Corrections? Is that what you're up to?"

Hoffman, J.: "If that were the case I'd definitely be for it."

Black "Well, at least you're an honest man, I'll give you that. Madam Speaker to the Bill, I don't think the previous Speakers have been strong enough. A present vote is not advisable this early in the Session on a Bill that the Gentleman admits is probably just something to transfer costs. First of all it doesn't involve parental consent. You know, you don't give up your rights just because you're committed to the Department of Corrections. This is a bad idea, a 'no' vote would be advisable."

Speaker Satterthwaite: "Representative Woolard."

Woolard: "Yes Madam Speaker, Ladies and Gentlemen of the House. I believe that this is going to be very easy to solve. I truly believe that we've got an issue here that's not controversial, that we should just use a consistency that has been put forth by the Gentleman who's proposing this

piece of legislation. It took him a number of years to get here. He tried several times to be a legislator. This is his first piece of legislation. Let's give him the same opportunity that the people he represents gave him. Let's let it take him some 3, 4, 5 years to accomplish this task. I urge you, I urge you, to not vote for this poor piece of legislation, especially from someone who was so controversial in getting here."

Speaker Satterthwaite: "The Gentleman from Kankakee Representative Novak."

Novak: "Yes, Madam Speaker, would the Sponsor yield please?"

Speaker Satterthwaite: "He indicates he will."

Novak: "Representative Hoffman, I've been perusing this legislation of yours and I have a some very salient comments I'd like to make and I'm sure this Body would be indubitably gracious if we could hear this dispassionate discourse of what we need to know. But, besides the concerns that Representative Black indicates about the money would you be willing to take this back to Second Reading for the purposes of an Amendment?"

Speaker Satterthwaite: "Representative Hoffman."

Hoffman, J.: "Not at this point, no."

Novak: "Well, Representative Hoffman, the House Amendment you have on your specified sexual abuse counseling offered for the victims and also for the offenders but giving the social milieu in the Springfield area I just wondered if you might want to amend this Bill to allow sexual abuse counseling for Legislators and Senators."

Speaker Satterthwaite: "The Gentleman from Will, Representative Wennlund."

Wennlund: "Will the Sponsor yield?"

Speaker Satterthwaite: "He indicates he will."

Wennlund: "Will the Sponsor please answer the question why this

Hoffman, J.: "Well I think that when I was with the probation service of St. Clair County I think that there is a need. In the State of Illinois right now we're not addressing the issues. Individuals are going into the Department of Corrections Juvenile and coming out without this need being addressed. I think that in the State of Illinois, we have to address this issue and I think that this Bill does that."

Wennlund: "Doesn't the Department of Corrections already do this?"

Hoffman, J.: "Right now they offer counseling for victims of sexual abuse. This would also include sexual offenders so that they have some type of a counseling. A lot of times what happens in the Juvenile Department of Corrections is, you're sent to the Department of Corrections for a 45 day evaluation. You're then brought back to court and in court what happens is the judge makes a determination as to what is needed for that juvenile offender. I think that in that 45 days would be a good time to begin this counseling."

Wennlund: "Have you considered whether or not you might have a conflict of interest sponsoring this legislation?"

Hoffman, J.: "I no longer work for probation, I no longer work for detention, no I don't think I have a conflict of interest. Also just to point out the Department of Corrections has indicated would be an added cost, there wouldn't be an additional cost because they'd use existing employees."

Speaker Satterthwaite: "Excuse me, Gentlemen. Will the Body please give some attention to the discussion? The background noise is getting rather high."

Wennlund: "To the Bill, Madam Speaker, thank you. I urge the Members on this side of the aisle to take the caution of

Representative Homer and that this Bill is certainly not necessary. The Department of Corrections already does it and we know it's not necessary and they already do it because there's no cost associated with it. So I urge all the Members and all my colleagues to vote no on this Bill."

Speaker Satterthwaite: "Representative Matijevich."

Matijevich: "The words a first timer always likes to hear on his first Bill I move the previous question. That'll help him out."

Speaker Satterthwaite: "There appears to be only one other person seeking recognition so if you will allow us we will continue. The Gentleman from Coles, Representative Weaver."

Weaver: "Thank you very much, Madam Speaker. I really appreciate that opportunity to question the Sponsor of the Bill. Representative, I notice by the Bill that an individual for counseling has to be declared sexually dangerous. Can you give us an idea of what a sexually dangerous individual might be?"

Hoffman, J.: "I don't think that this Bill says that."

Weaver: "Excuse me? Would Legislators fall into that category just by occupation?"

Hoffman, J.: "I don't think I do, I would hope none of the other Legislators do either."

Weaver: "Thank you."

Speaker Satterthwaite: "Representative Granberg."
