There are four Amendments to House Bill 2950. first one covers House Bill 3030 which did not get out of Rules, and it was passed by a substantial majority in The second was 2949 and that was a Bill that someone else wanted to use as a vehicle in the Senate. So the Senate Sponsor and myself agreed to permit them to have the Bill and we put this on 2950. The third and fourth Amendment or fourth and fifth Amendments, rather, deal with a subject matter that the Senate decided - and I think that it considerably improved the Bill - which would...When the tax sales were made, that when you paid for the tax property you had to pay all the local liens. I think the Senate has improved the Bill substantially, and I would move for the adoption of all four Amendments: 1, 3, 4 and 5."

- Speaker Giglio: "Any discussion? The Gentleman from Vermilion, Representative Black."
- Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"
- Speaker Giglio: "Indicates he will."
- Black: "Representative, what's the fiscal impact of this Bill as amended?"
- Curran: "Two answers. First of all, considerably less than when it went to...when it went to the Senate...when we voted it out of here...out of the House. Second, zero if we pay our bills on time."
- Black: "Well, let me follow that up with another question. I certainly agree with you. I don't think we have any disagreement about paying our bills on time, but isn't it a fact that the current group insurance, for example, for state employees, is underfunded by approximately \$55 million?"
- Curran: "I think you realize that we...we just passed a supplemental. Representative, when this Bill left the House, it had a 2% interest on it. It's coming back to us with 1.5% interest. Arguing against accepting this Amendment argues in favor (as I don't think you intend to do), for higher interest penalties against this administration when they make late payments on bills to vendors."
- Black: "Well, you know...and we're...we're certainly not rising to...to dispute that with you at all, but when we know, for a fact, that we've underfunded, because of the fiscal crisis, certain line items in the budget, then obviously the interest expense becomes a significant cost because we

know those bills won't be paid on time because there aren't sufficient dollars appropriated to pay them. So it looks to me like we're in a Catch-22 here. We're kind of darned if we do, darned if we don't. I just don't know how you can impose an interest penalty that, even under the revised estimates, would cost in excess...in the millions of dollars for Public Aid and close to \$4 million for the Central Management Services program. It isn't going to guarantee that anybody gets paid on time when the money isn't there - hasn't been appropriated - to...to pay the bills."

Speaker Giglio: "Any further discussion?"

Black: "Well, Mr. Speaker, Ladies and Gentlemen of the House. the Gentleman's Motion. This is...this is not (and in all due respect to the Sponsor), this is not a philosophical difference. In fact, Representative Curran and I probably agree on 'most every issue that would come before this House. I simply stand in opposition to his Motion, for the fact that our latest fiscal impact shows that this would cost the Department of Public Aid some \$50 million at some point in the process. Not because they don't want to pay their bills on time. Not because they aren't willing to their bills on time, but because we have appropriated sufficient dollars to pay those bills on time. So we're compounding an error that I think we make, not the department. We appropriate the dollars. We know, both know, all of us know, that the dollars appropriated, in fact the dollars that are available, are not sufficient pay their bills in a timely fashion. That's wrong. We...we all know it's wrong, but I see no... I see no other course in the next few months until we get our fiscal house in order, and I don't think it helps to put our fiscal

house in order to add millions of dollars in interest costs that will eventually have to be paid. We're simply compounding our debt. Now, given that, what I consider to be a fact, I cannot support this Bill. I would urge Members on my side of the aisle to vote 'present' or 'no'. We'll continue to work on this and, Mr. Speaker, should this Motion get the requisite numbers to pass, I feel I have no choice but to ask for a verification."

Speaker Giglio: "The Gentleman from Macoupin, Representative Hanniq."

Hannig: "Yes, thank you, Mr. Speaker and Members of the House. I would rise in support of the Gentleman's Motion. The prior speaker said that maybe it's our fault sometimes that we don't appropriate this money. Well, maybe that is true, but I don't think that two wrongs make a right. right for the State of Illinois to say that simply because we didn't appropriate enough money to pay that bill, now we don't have to pay any penalties or interest to the vendor after 30, or 60, or 90, or 120 days. You know, if a small businessman tells the State of Illinois that he doesn't quite have enough money in the bank to make his sales tax payment or his income tax payments, we don't give them any kind of special situations and say, 'Well, if you don't have the money we'll just let it ride for 90 days interest free.' The first thing that we do is we assess a penalty and an interest charge to that vendor, and he has to pay that in addition to whatever he owes us. So, is really only fair, and, as Representative Curran said, if we would get our financial house in order and quit overspending here in the State of Illinois, we could pay these bills on time and there'd be no fiscal impact. It's a very simple Bill, a simple concept. It's just asking for

fairness. What is fair for the goose is fair for the gander. We assess a penalty and interest when they don't pay. We ought to pay interest when we don't pay. Sounds like it's a fair thing to me, and I'd ask for a 'yes' vote."

McCracken: "Thank you, Mr. Speaker. I rise in opposition to this Concurrence Motion, and I've had occasion to debate this with the Sponsor and with other Members of the House on previous occasions. But, you know, a new thought has occurred to me in how to illustrate the point I wish to make about this, and what this is, is the Springfield Our Constitution, unlike version of deficit spending. Congress, does not allow us to spill red ink on the chamber of this floor like the blood of so many taxpayers. instead, we promise benefits that we can't afford to pay. We pass the substantive legislation; we stand up; we credit from the press; we send out a newsletter; we send out a press release saying that we've solved the problem. But we haven't addressed the problem, because this problem has nothing to do with any substantive issue. This problem has only to do with money. Only money. The reason we don't pay our bills now is because we don't have money, and if you think, at least in the short, term if that situation is going to change, you are mistaken. And if you think, in term at least, that that situation is going to improve, you are doubly mistaken. All you do benefit on top of benefit on top of benefit. Now, I understand why this sells because there is a superficial appeal to it. If I had all the money in the world, I'd be willing to pay interest on late payments. Don't get me

wrong. No one denies the issue of fundamental fairness that this raises, but that's a false issue. The only issue is money, and the only issue is being responsible to the taxpayer and avoid the temptation to engage in the Springfield version of deficit spending."

Speaker Keane: "Representative McNamara. Representative Keane, in the Chair."

McNamara: "Thank you, Mr. Speaker. When we had money in the State of Illinois, we didn't pay our bills on time. Let's The State of Illinois suffers from poor face it. management principles. If we paid our bills on time, when we had the money, what we would have done would be to lower the cost of the products, because, let's face it, every vendor raises the price of those products to us as a state because we cannot pay our bills on time, or we don't We need management in this state that reflects what our businesses are expected to do. Let's look at another point on this. We are closing businesses in this state because we don't pay our bills on time. Ask your small pharmaceutical companies, ask many of the small businesses that cannot get the money from us that are What happens then? We not only lose the tax closing. revenue, we lose the employees; we increase the joblessness rate in this state; we destroy our economy. We are driving people out of work. We're closing businesses. If Illinois pays its bills on time, it generates more money. It's a simple, business practice. Voting against this says that you're for a higher interest rate. This lowers it to 1.5% per month. That's logical; that's realistic; that's the way to go. I urge your 'aye' vote. There's no excuse for any other vote."

Speaker Keane: "Representative...Representative Wennlund."

Wennlund: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. For one thing, the prior speaker has forgotten that it has been a long, long time since there was a Republican Comptroller or Republican Treasurer, because, in fact, it's been a Democratic Comptroller and a Democratic Treasurer who hasn't been paying their bills on time. If that's what the problem is, you better look to within, real...the real story here is the contradiction, the biq contradiction. Representative Hannig, not more than three weeks ago, told us why. Not only did he propose cutting by \$45 million services to the developmentally disabled and the mentally ill in Illinois - those that cannot take care of themselves - he wants to cut \$45 million out of their budget - and now comes back and says that really what we ought to do is...we're still gonna cut that \$45 million to the developmentally disabled and the mentally ill, but now were gonna come back and spend \$56.7 million this year in interest charges because we're unable to pay our bills on time. Think about the contradiction. Think about how that's gonna look next November. Think about how that's gonna look on the campaign trail. Ιt is totally contradictory; it is absolutely ridiculous to spending a another \$56.7 million in interest charges, but yet we refuse to help those who cannot help themselves the mentally ill and the developmentally disabled in Illinois. It is totally contradictory and ridiculous."

Speaker Keane: "Representative Klemm."

Klemm: "Oh, thank you, Mr. Speaker and Ladies and Gentlemen of the House. I've been so involved in the prompt payment Bill that, obviously, I maybe have a self-interest, because I probably represent the business community more than anyone else in the General Assembly, and as much as I

support the Bill, I really don't think that this Amendment is something that is gonna work with the Governor, to make it livable. And I think perhaps we should maybe go back to a Conference and try to make it more reasonable. And let me give you a suggestion to the Sponsor. I think the interest rates are a little bit excessive under today's conditions, and I think probably a 1% penalty would be more we're doing. Secondly, in keeping with what understand...and the business community - who has talked to me and has sponsored and supported the prompt payment Bill that I have on the calendar now - have supported the concept that let's wait, maybe one or two years, and maybe make it effective January 1st, 19...say '94 when the state does get in a better financial condition, and then allow it be made automatically so the businesses aren't cheated But what we're trying to do is reasonableness between the real life of our financial and fiscal problems of today, with our genuine, honest concern of trying to be fair with our businesses around Illinois. So, I would (almost and I have to almost reluctantly) concur that we should not agree with the Senate Amendment, so that we would have a chance, maybe, to reach that compromise between the Central Management and Governor's Office, that could be real and honest something that we would finally promise our business that we will pay our bills community, once and for all: promptly. The state has a chance to get out of know we'll do. Because very financial dilemma what we honestly, Ladies and Gentlemen, the Governor would be forced to veto this Bill. I know it, and you know it, and I don't want that to happen. We've fought the battle too long. I think today we should send it back, not to...not

to scuttle this concept (because I would not want to do that), but to make it honest and reasonable because that's what we're here to try to do. And then allow it to be automatically paid, and perhaps two years from now we won't have to fight it. We'll have the funds to do it, and we can move on to the other problems of Illinois. Speaker Keane: "Representative Curran. Representative Curran."

Curran: "Want me to close?"

Speaker Keane: "Before you close, Representative Edley."

Edley: "...Thank you, Mr. Speaker, Ladies and Gentlemen of the General Assembly. I want to make this very brief because I know we would all like to get out of here, and we've talked about this time and time again. But let me clear couple of what I think were misstatements by some of those who, on the other side of the aisle quite frankly, rose to oppose this Bill. There's a difference between authorizing spending and having money in the bank to pay the bill. Here, about three weeks ago, many of the same people who are rising opposing this legislation supported spending about \$125 million in additional GRF spending supplemental - for this year. There was no increased taxes, no increased revenue to pay for that, and it was a very easy vote because what they did was just simply increase the lapse period spending - spend out of next year's revenue. Now that is...fiscally irresponsible. with this Amendment, What we're saying, is Legislature, in conjunction with the Governor, want to continually...continue to act in a fiscally irresponsible manner, there will be a penalty. As bad as the Federal Government is, at least when they deficit spend, they pay interest. When we deficit spend, we simply stiff-arm

hospitals, nursing homes, pharmacies hundreds of millions of dollars of bills and are so irresponsible we are unwilling to even compensate them with interest. That's wrong. Speaker Keane: "Representative Jay Hoffman."

Hoffman: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. You know, it's amazing to me that every time we get here and the television cameras get on and people start turning on the television cameras and taking pictures, we have to find someone to blame. We have the Republican side of the aisle now is saying that it's the Comptroller and the Treasurer's fault. Give me a break. Do you really believe that? Give me a break. For 14 years, Governor who used sleight-of-hand budgeting. We had a Governor who didn't care what they spent. We had a Governor who carried balances over from one year to the next. And you're going to blame a Comptroller Treasurer who refuse to spend money that we don't have? I think it's time that we guit blaming each other. I it's time we work together for a solution. And we're gonna turn and we're gonna blame somebody else - the Comptroller and the Treasurer instead of who's really at fault. Let's grow up. Give me a break."

Curran: "Thank you, Mr. Speaker, Ladies and Gentlemen of the
