There are 62 votes on House Bill 889; were 63 and somebody took it...Representative Black."
- Black: "Yeah. Thank you very much, Mr. Speaker. It's my understanding that Representative Flowers is excused today, is she not?"
- Speaker Giglio: "No, she wasn't. She was here...I believe she was on the Roll Call."
- Black: "Alright, let me ask you another question then, Mr.

  Speaker. What's the effective date of this Bill?"
- Speaker Giglio: "There is none."
- Black: "There is none. Okay. Has the...a little late to ask
  you, but there seems to be some question as to whether or
  not the Bill was even printed and distributed."
- Speaker Giglio: "It was on Concurrence, Representative Black, and the record was taken."
- Black: "Well, I can appreciate that. It's just always nice to know we're allowing quick take powers, that's all."
- Speaker Giglio: "Alright, let the record indicate, Mr. Clerk,
  that Representative... ...Hoffman... would have voted
  'no'. The transcript will reflect. Representative Wait,
  up or down?"

Wait: "Down."

Speaker Giglio: "Let the record indicate Representative Wait

- Frederick: "Mr. Speaker, let the record reflect that I wish to vote 'no' on this also."
- Speaker Giglio: "The record reflect that Representative Frederick would have voted 'no'. Representative Black."
- Black: "Yeah. Thank you very much, Mr. Speaker. We've been through all these arguments before. I don't think the actual... record was taken, and the Clerk didn't turn around and give you the final number, and the board is still up there, if there are people who want to change their vote, I would think they could change their vote."
- Speaker Giglio: "No, the...the record...the record,

  Representative Black, was recorded, and the...the Chair

  read the...the vote into the record, and at that time it

  was 63 votes."
- Black: "Are the...the Clerk has such a soft voice, I didn't hear him give you the total, but I did see him turn around, but there are some people that might want to seek some recognition on this issue. Thank you, Speaker."
- Speaker Giglio: "Well, the Clerk...the Clerk gave the sermon this morning, so he's a little humble this morning.

  Representative Parcells."
- Parcells: "Thank you, Mr. Speaker, I've had my light on for some time. I wanted to do a verification if it should receive the right number of votes, and I've had my light on trying to be polite. I guess we have to scream and pound our shoes in order to get attention around here."
- Speaker Giglio: "Now, now, Representative Parcells, you know the Chair's been fair, and there was no lights on when I was reading the tally from the Clerk, when I asked the Clerk to take the record, and when the Clerk locked the machine, I read the record off."

- Parcells: "My light was on, Sir. You must have had a piece of paper over it. I'd like to verify the Roll Call."
- Speaker Giglio: "Representative Parcells, your Motion is not timely. The Bill was declared passed, and the Clerk locked it. House Bill 907. Alright. Representative Sieben."
- Sieben: "Mr. Speaker, I voted on the prevailing side on that

  Bill, and on the concurrence Motion, and I would move, Mr.

  Speaker, to reconsider the vote on...what was the number...889. My Motion is to reconsider the vote."

Speaker Giglio: "Representative McNamara."

McNamara: "I move that Motion lie on the table."

Speaker Giglio: "All in favor say 'aye'...alright, all those in favor signify by voting 'aye', all those opposed vote 'no'.

On the Motion to table...the Motion to table, Representative McNamara moves to lie that Motion on the table. All those in favor of tabling the Motion, signify by voting 'aye'...Representative Hultgren."

Hultgren: "Frank."

Speaker Giglio: "Representative Hultgren."

- Hultgren: "Thank you. Thank you, Mr. Speaker. You might want to adjust your elbow just a bit there. If this would receive the requisite number of votes, I'd like to verify the votes on this Motion to table."
- Speaker Giglio: "Open...all those in favor signify by voting 'aye'...to table, all those...favor...vote 'no'. An 'aye' vote is a Motion to table. Have all voted who wish? Have all voted who wish? Representative Black."
- Black: "I think Representative Hultgren...made a...someone made a inquiry of the Chair that we would verify this should it get the requisite number of votes, and it's right on the button."

Speaker Giglio: "The Chair...has been informed that it will take

a simple majority of those voting, Representative Black.

HAve all voted who wish? Have all voted who wish?

Representative Black. Is he on? You're on.

- Black: "Turn me on. Thank you very much, Thank you. Speaker, inquiry of the Chair. Under Rule 73 (c) Motion to reconsider is made pursuant to this rule, and the Motion is later tabled, the question shall not be further reconsidered, however, this subsection can be suspended. upon an affirmative vote of 71 Members. I would ask for you to invoke rule 73 (c). I would like to take that the table. I don't think there is 71 people here who want to vote on quick take authority when half of them don't even know where the quick take is. Quick take is a very. very dangerous situation to put governmental bodies in. think a lot of 'em voted on something that they had no idea what they were voting on. I would ask for you to invoke 73 We can suspend this subsection by an affirmative vote 71 Members. I want to take this off the table and have another Roll Call vote on this Bill."
- Speaker Giglio: "Reoresentative Black, we're in the middle of a Roll Call. The Motion takes a majority of those voting, and there are 58 voting 'yes', and 47 voting 'no', and the Motion to table carries. Representative Black."
- Black: "Speaker, a simple majority. I don't expect to be able to knock off that many votes on a simple majority, so I have a inquiry of the Chair to invoke Rule, I believe it's 73 (c). Let's just take it back off the table by an affirmative vote of 71 Members. There's an awful lot of folks recorded on a vote for quick take, and I don't think some of 'em even know where the quick take provisions are. I don't think you want to go home on the Fourth of July and discover that some governmental entity just used their quick take power and took over your parade route."

- Speaker Giglio: "Representative Black moves that Section 73 (c) be suspended, so another Motion to reconsider can be made at a later date. On this question, there are 49 'yes' and 47 'no', and the Gentleman's Motion fails. Senate Bill 907, Representative Bugielski, 907. Senate Bill 907, Representative. Mr. Clerk. Representative Black, for what purpose do you arise?"
- Black: "An inquiry of the Chair, Mr. Speaker. Is House Bill 889 a committee Bill? It wasn't a Conference Committee Report, so I assume that it was a committee Bill."
- Speaker Giglio: "It was a Concurrence Motion. Page 4 of the Regular Calendar."
- Black: "Well, why don't we look at...I wanna have the Parliamentarian look at Rule 75(b): 'A Motion to table a committee Bill may be adopted only by a vote of 60 Members, not a simple majority'."
- Speaker Giglio: "The Bill, Representative Black, was sponsored by Representative Roman."

Black: "Representative Ronan."

Speaker Giglio: "Representative Roman sponsored that Bill."

Black: "And he usually only sponsors outstanding Bills."

- Ronan: "Yeah, and it was not a committee Bill. We passed the
  Bill out of committee directly. In fact we passed
  unanimously with all of the Republicans on it, as I
  remember."
- Black: "Well, I think Senate Amendment #1 might have changed the intent just a little bit. Well, then try 2. Try 2. Don't get yourself all worked up over there. Senate Amendment 1 or 2 or whatever it was changed the Bill a little bit; some of you guys are out there on a very bad vote. We may have

This Conference Committee Report...has been on our desks less than one hour, and I believe the House Rules require that this be on our desks for one hour, so I would object to handling this Conference Committee Report at this time. Hultgren: "Okay, Thank you,"

- Speaker Giglio: "Representative Matijevich moves for the adoption of the Agreed Resolutions. All those in favor signify by saying 'aye', opposed 'nay'. In the opinion of the Chair, the 'ayes' have it. The resolutions are adopted. Representative Obrzut."
- Obrzut: "Thank you, Mr. Speaker. For purposes of an announcement, I'd like to announce that the House Issues...Democratic Issues staff beat the Research staff 5

very short conference in Room 118 immediately upon
adjournment. It will be brief, but we would ask folks to
meet us in Room 118."

Clerk Leone: "Senate Joint Resolution 73, offered by Representative Hartke."

Speaker Giglio: "Committee on Assignments. Death Resolutions."

Clerk Leone: "House Joint Resolution 887, offered by Representative Currie, in respect to the memory of Irene M. Smith, and House Resolution...House Joint Resolution 74, offered by Representative Trotter - et al, in respect to Yvonne Daniels."

Speaker Giglio: "Representative Matijevich moves for the adoption of the Death Resolutions. All those in favor say 'nay'. In the opinion of the Chair, the 'ayes' have it. The Death Resolutions are adopted. Alright. The House...Representative Matijevich now moves that the House Regular Session stand adjourned until 4 p.m. tomorrow. First Special Session will now come to order. Attendance Roll Call for the General Session will be used for the Special Session.
