- Speaker McPike: "Representative Matijevich."
- Matijevich: "Mr. Speaker, on this side of the aisle, excused absence is Mary Flowers."
- Speaker McPike: "Clerk, take the record. One hundred-fifteen

 Members answering Roll Call, a quorum is present.

 Representative Hultgren."
- Hultgren: "Thank you, Mr. Speaker. I...really was looking for a little guidance. Reading the newspapers I understand that last weekend Speaker Madigan spent some time with his family and Governor Edgar spent some time with his family and...frankly, while the work we do here is important, I think we would all agree that the obligations that we have to our family are...are more important, so, I would commend

Representative Keane. Representative Cur...Representative Currie, on 2510. House Bill 2510? The Lady from Cook, Representative Currie."

Currie: "Thank you, Mr. Speaker, Members of the House. This is a proposal from the Department of Public Aid amending the State Finance Act, so that they can make child care payments in a timely fashion. Apparently, there were some policy changes required by the Federal Family Support Act of 1988, and this Amendment will mean that we can pay people directly and meet the requirements of that federal Act without requiring people to go through the Court of Claims. So, I'd be happy to try to answer your questions and would appreciate your support for the Conference Committee Report."

Speaker Giglio: "Representative Black."

Black: "Thank you very much, Mr. Speaker. It's my understanding that...if I might ask a question of the Sponsor, that this is a Department of Public Aid language and it's needed to reimburse daycare providers, something near and dear to my heart, and, if we don't pass this then people who are trying to get off of the public welfare rolls, who will not
