The...Illinois Environmental Protection Agency is...conducting long-range tests on the carbon monoxide levels that are...being emitted through verbal human communication. Now the agency has used GRF tax dollars to implement a devise at each microphone on the House floor to gauge the levels of carbon monoxide that are being emitted. The Members are asked for their cooperation and asked to speak within a quarter of an inch of their microphone on the House floor to insure accurate readings, and the EPA and all of us would certainly appreciate your cooperation. Amendment 2 removes some of those...who have contracts, I guess with the state or other places, from being a part of this Act. ...Those who are compensated for their performance... and there is a requirement of the prevailing wage. We just ask that you accept this Amendment."

Speaker Giglio: "Any discussion on the Amendment? The Gentleman from Vermilion, Representative Black."

Black: "Yeah, thank you very much, Mr. Speaker. Will the Sponsor yield?"

Speaker Giglio: "She indicates she will."

Black: "Representative, the only people that you are excluding under this Amendment would be... Privatization would not then apply to any contract that a...whose compensation requires the Prevailing Wage Act be enforced. Is that correct?"

Davis: "That is correct. ...This was at the request of the Illinois Department of Transportation."

Black: "All right. But...but anything else that the state would do, we could enter into a contract with a private entity, rather than having that work done by state employees. Is that correct?"

Davis: "Yes, Sir, you could."

Black: "So it's... This really should be titled perhaps the 'Privatization Amendment'?"

Davis: "Well, what is it titled?"

Black: "Oh... Well, then, I was right on target. Okay. Thank you very much Representative. Mr. Speaker and Ladies and Gentlemen of the House,...the Amendment may remove some opposition to this Bill but...I would suggest you look very carefully at...at the Amendment because you going to then face the question on privatization. I would suggest,

perhaps, this Amendment might be defeated, which then might make the Bill more easily defeated. In all due respect to the Sponsor, I urge a 'no' vote."

Speaker Giglio: "Further discussion? The Lady from Cook, Representative Davis. Excuse me, Representative Stephens."

Stephens: "Thank you. If the Lady will yield for a question?"

Speaker Giglio: "She indicates she will."

Stephens: "Are we talking about...letting contracts, private contracts for snow removal, mowing, things like that?"

Davis: "This is what the Amendment would do. The Amendment on this Act is the Privatization Act, and what this Amendment would do is to remove from the Bill those services that are usually always contracted out. For example, the work done by your Transportation Department is usually...it's usually contracted out. Snow removal, I would imagine, is usually contracted out. I don't know."

Stephens: "No." Snow removal is not usually contracted out. That's why I'm asking the questions."

Davis: "Well, then it wouldn't affect them, would it?"

Stephens: "If it has ever been contacted out, would it be affected?"

Davis: "You're sayin' if... Would it be affected by this Amendment? No, it would not. No, it would not."

Stephens: "Well, I'm not sure that we understand the...the substance of this Amendment, and I would have to rise in opposition."

Davis: "You want me to read it to you? I will. I'll read it to you. What this Amendment, says Representative, is that this Act does not include any contract performed by individuals whose compensation for the performance of the contract is subject to the requirements of the Prevailing Wage Act."

Stephens: "And how does that affect the original Bill?"

Davis: "It amends it to take out those who work under the
Prevailing Wage Act."

Stephens: "Thank you."

Speaker Giglio: "Representative Wennlund."

Wennlund: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Giglio: "She indicates she will."

Wennlund: "Representative Davis, as I understand, the Bill, as
amended, then, providing for privatization, that would mean
that all employees that (sic -who) were hired by the
private contractor would not be covered by the Rutan
decision?"

Davis: "Pardon? I don't think I understood you."

Wennlund: "The question is, is that, add... The Bill adds... If
this Amendment were to go on in the original Bill, all of
the employees of the private contractor would be exempt and
not covered by the Rutan decision, the Supreme Court's
Rutan decision, with respect to political hirings."

Davis: "What is the 'Ruth Ann' decision?"

Wennlund: "Well, the Rutan decision, was a decision by the United
States Supreme Court filed by three employees who alleged
that they were...being discriminated against because of
politics, and the United States Supreme Court says the
state can no longer do that. So by saying that we're gonna
use private contractors to do this work, none of those
employees would be covered by the Rutan decision, which is
currently the law of the land."

Davis: "...Representative, I do understand your question. I
believe your question actually should be reserved for the
Bill. This is the Amendment to the Bill. The Amendment is
simply taking out of the Bill those workers who work under
the Prevailing Wage Act. Now, once we put this Amendment

on, remove those who work under the Prevailing Wage Act, hopefully, we can debate the Bill when it's on Second Reading after this Amendment, or Third Reading after this Amendment has been accepted, and I certainly appreciate your interest, and I hope we can count on your vote."

Wennlund: "Well, hopefully, that you'll have some...an opportunity to do some research on that issue,...because it appears that it would be doing away with Rutan as far as state employment is concerned with privatization..."

Davis: "But, Representative, you do understand what the Amendment does?"

Wennlund: "Yes, I do."

Davis: "So it merely takes out a group of workers who now work under prevailing wage. Now once we get to the Privatization Bill, you may want to bring your question up. Is that okay?"

Wennlund: "It... Thank you very much."

Davis: "You're welcome."

Wennlund: "Mr. Speaker, I have the feeling that this Bill with this Amendment will have some serious consequence with respect to the Supreme Court's decision, and that the reason I'm going to ask for a Roll Call Vote on the Amendment. Mr. Speaker, I'm asking for a...requesting a Roll Call Vote on the Amendment, and urge a 'no vote.'"

Speaker Giglio: "The Gentleman asks for a Roll Call Vote. Do (sic - are) you joined by six others? I see hands. Further discussion on the Amendment? Hearing none, Representative Davis, to close. Excuse me, Representative Saltsman."

Saltsman: "Yes, thank you, Mr. Speaker. On this Bill,...I'm urging the people to vote for the Amendment...and..and to adopt the Amendment, and also this Bill. This is taking

I would just urge you to kindly give us a favorable vote on this Amendment. Thank you."
